(57) **CLAIM**

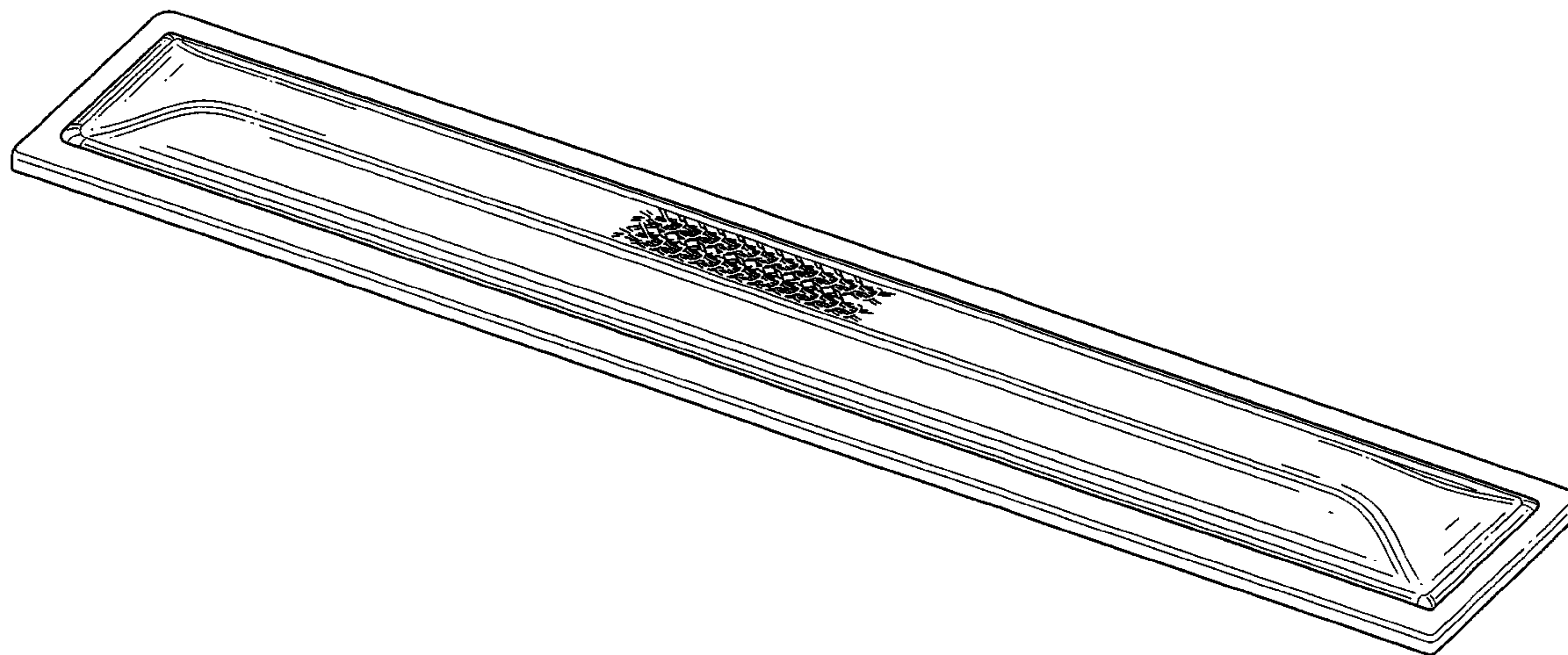
The ornamental design for a substantially rectangular burner membrane, as shown and described.

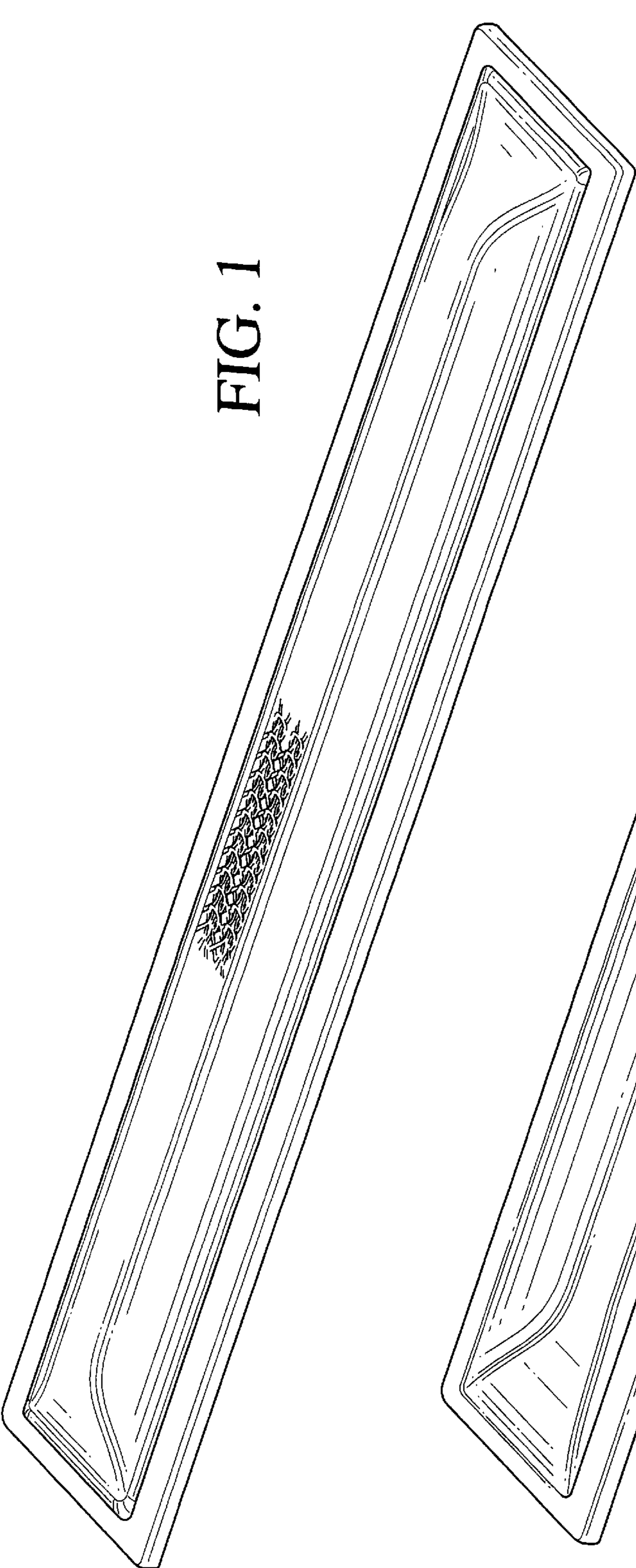

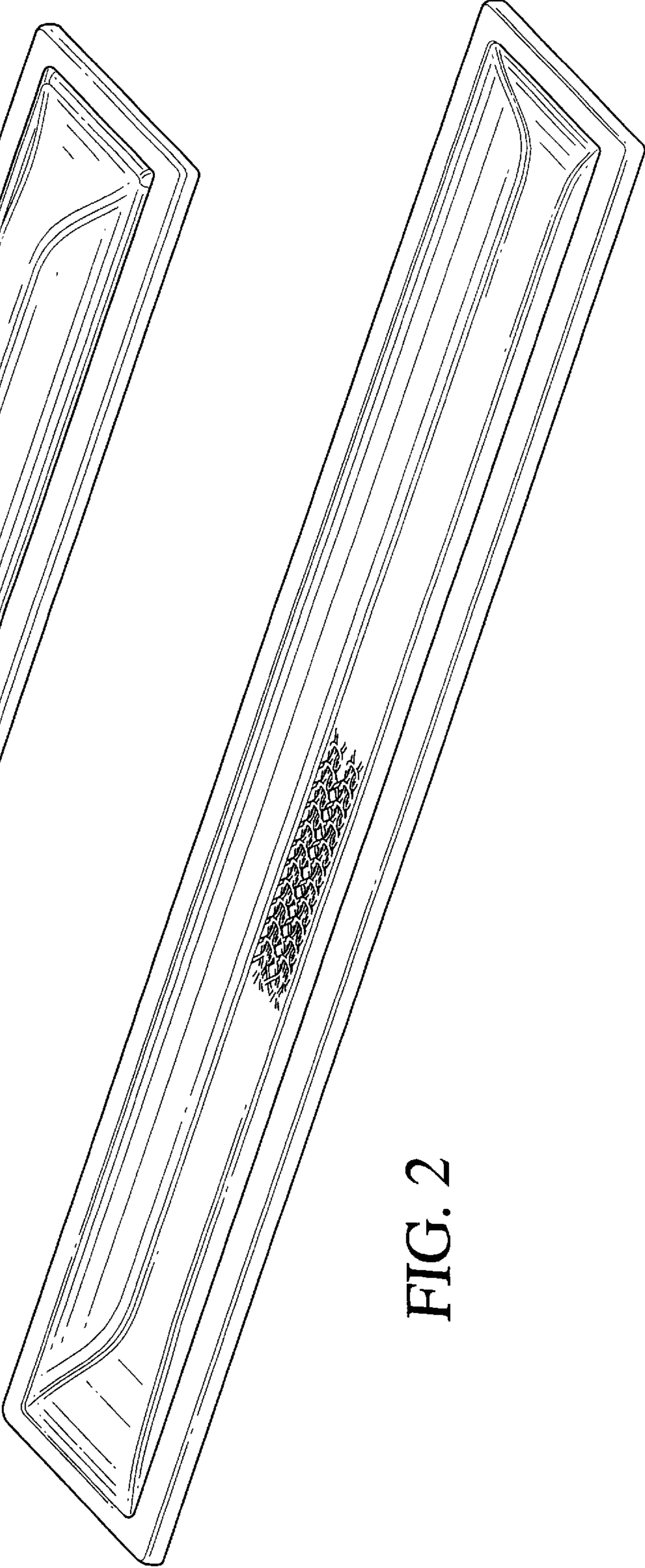
