(57) **CLAIM**

I claim the ornamental design for a massage roller ball, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a massage roller ball showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 4 is a side elevational view thereof;

FIG. 5 is a perspective view thereof;

FIG. 7 is a front elevational view the second embodiment of FIG. 6;

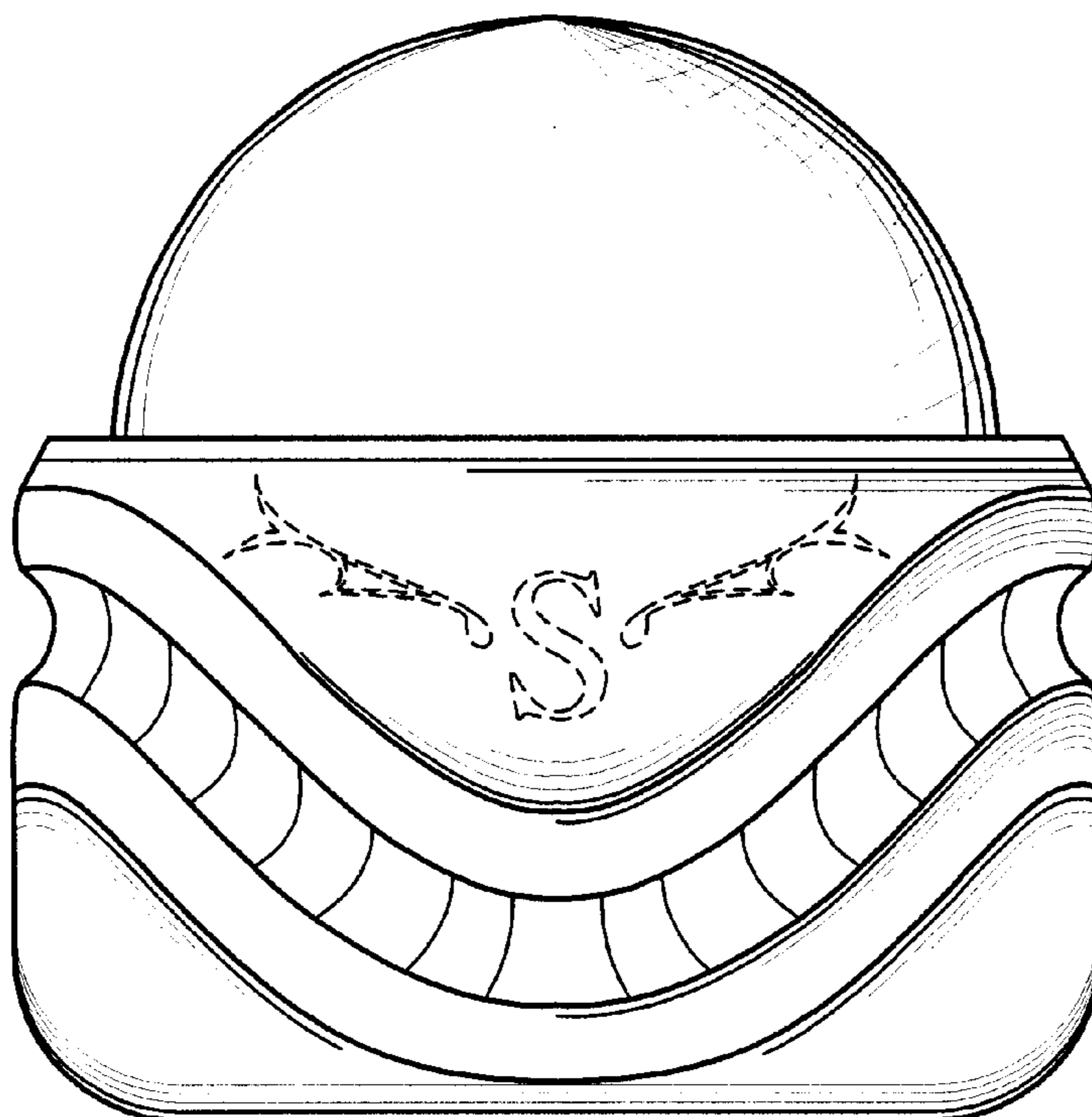
FIG. 8 is a top plan view of the second embodiment FIG. 6;

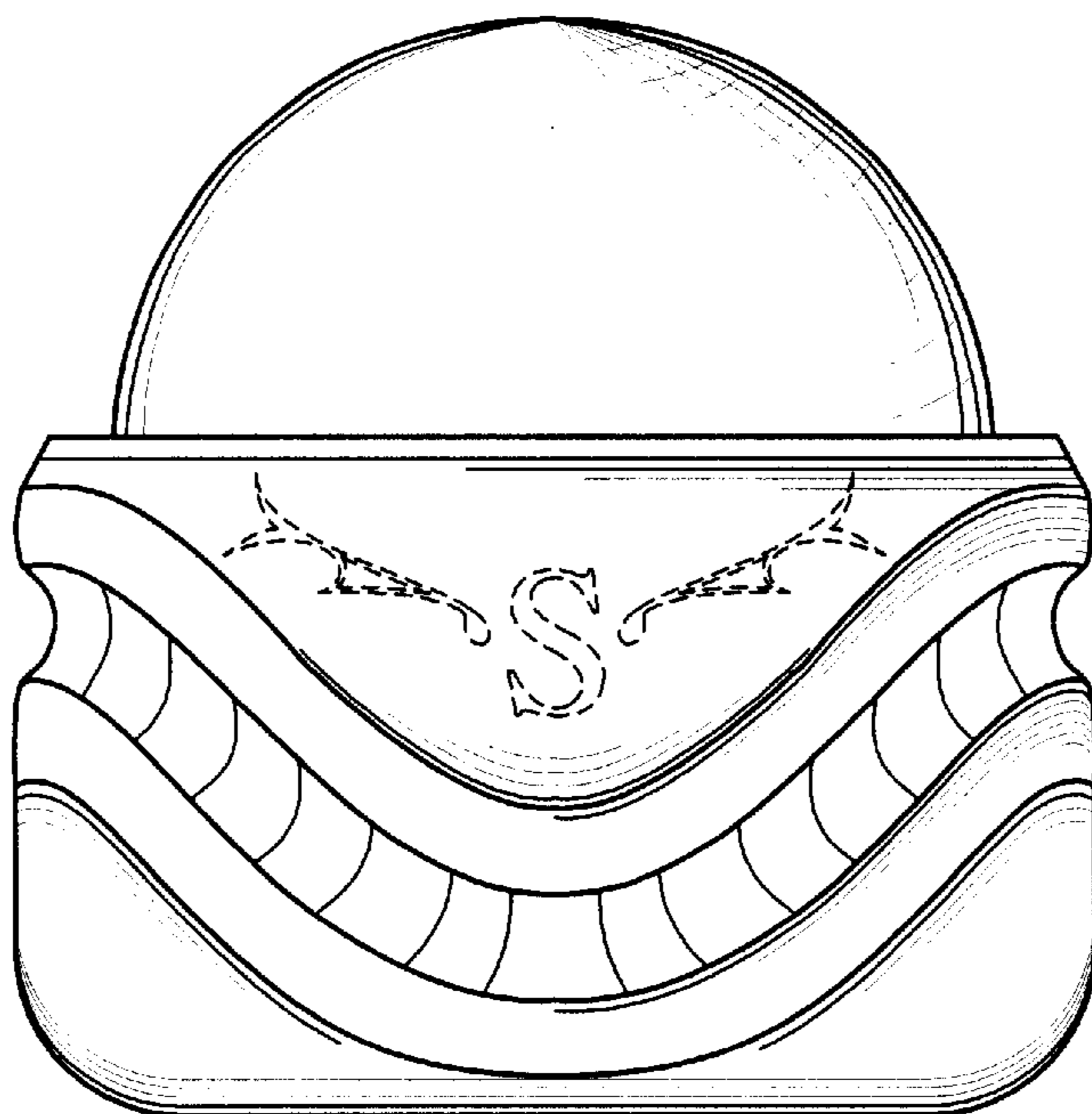

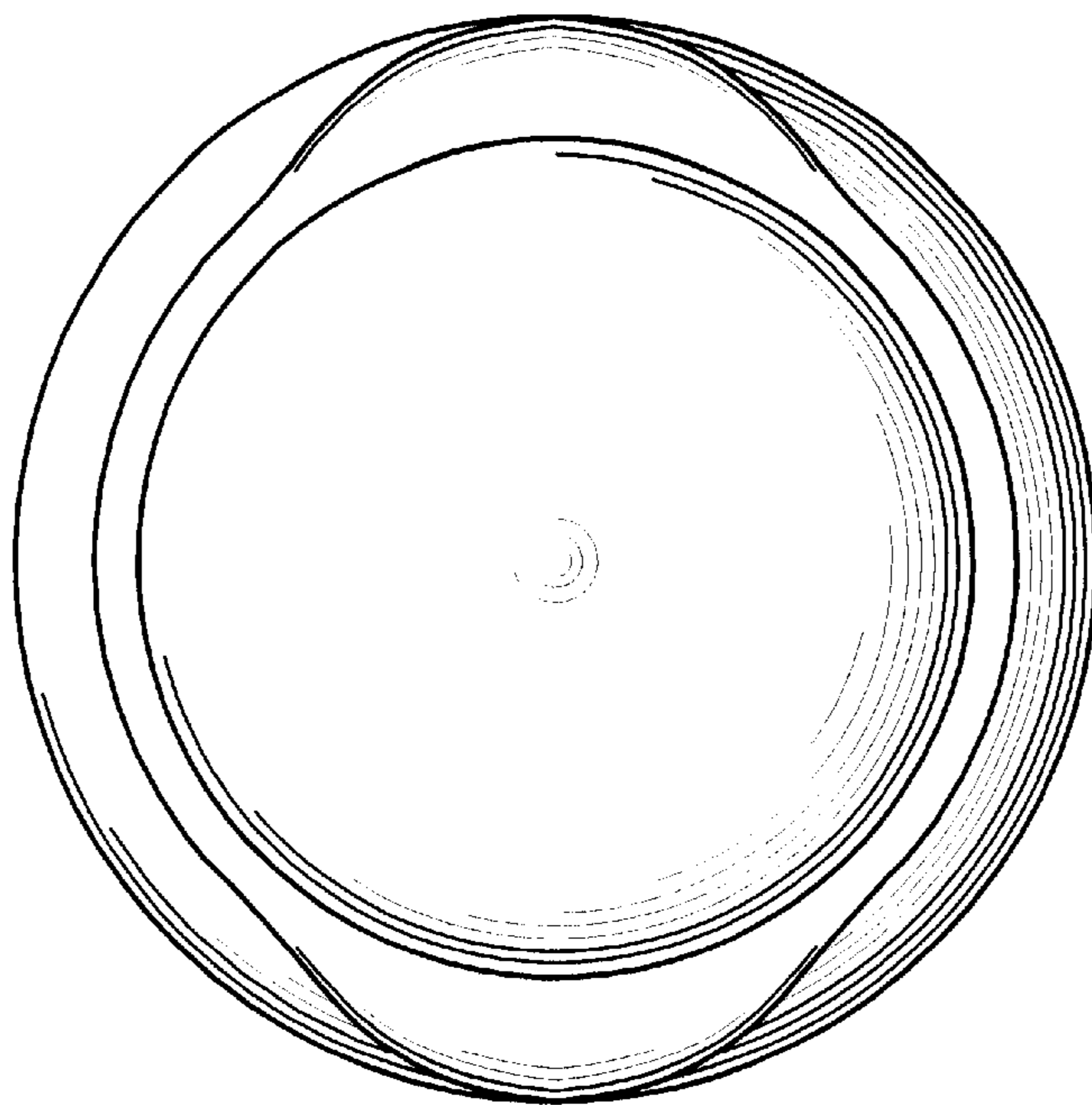

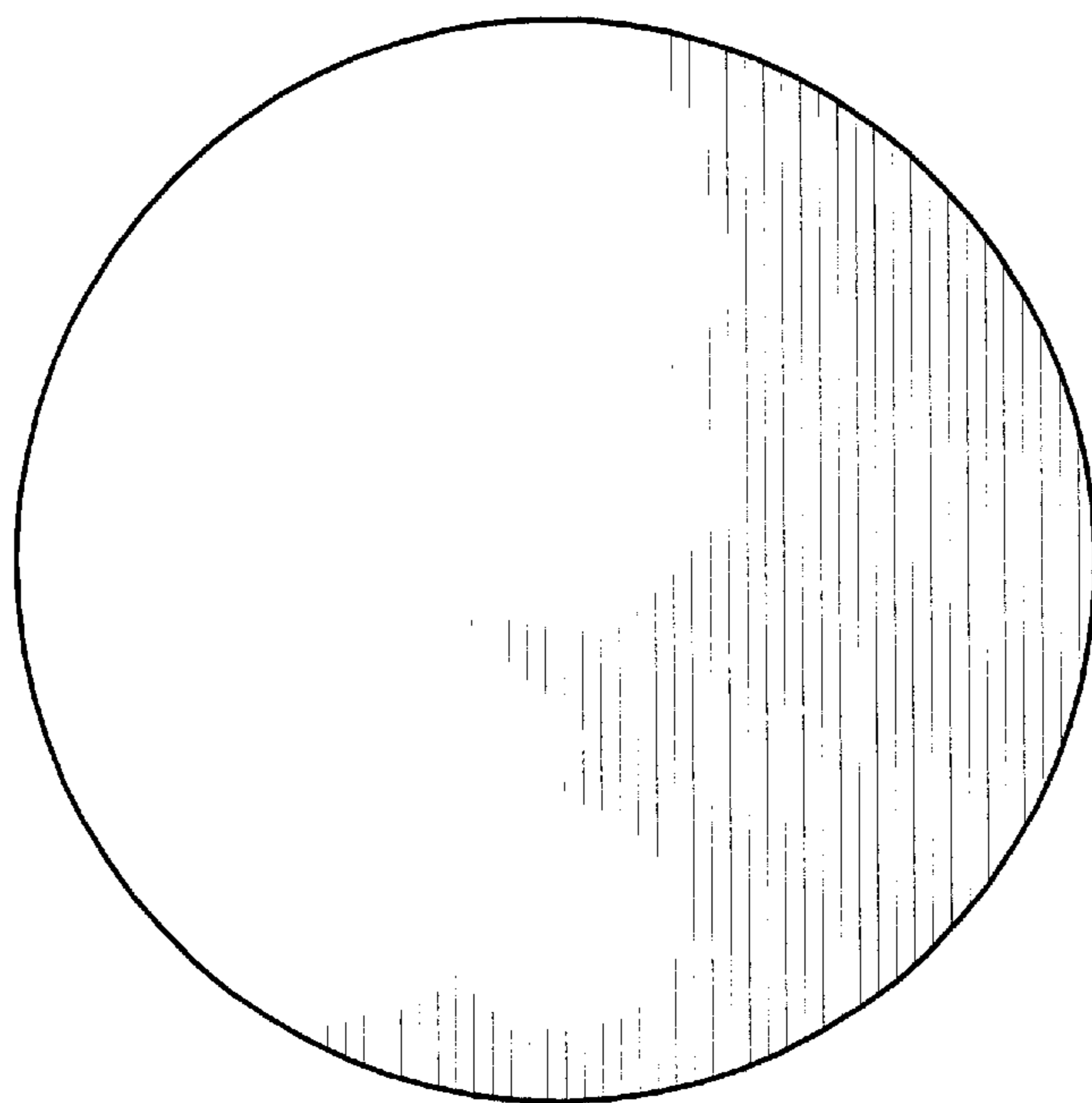

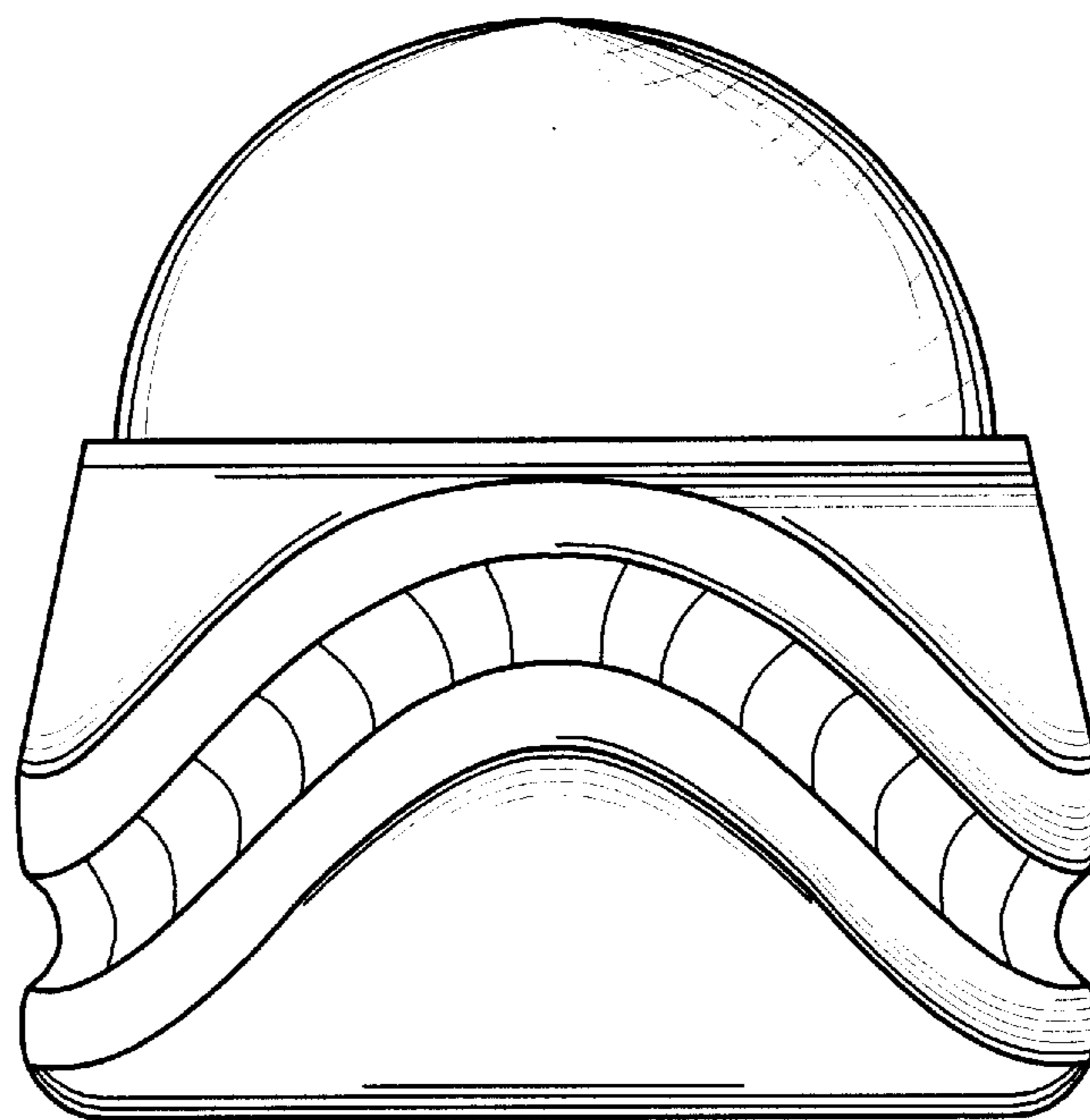

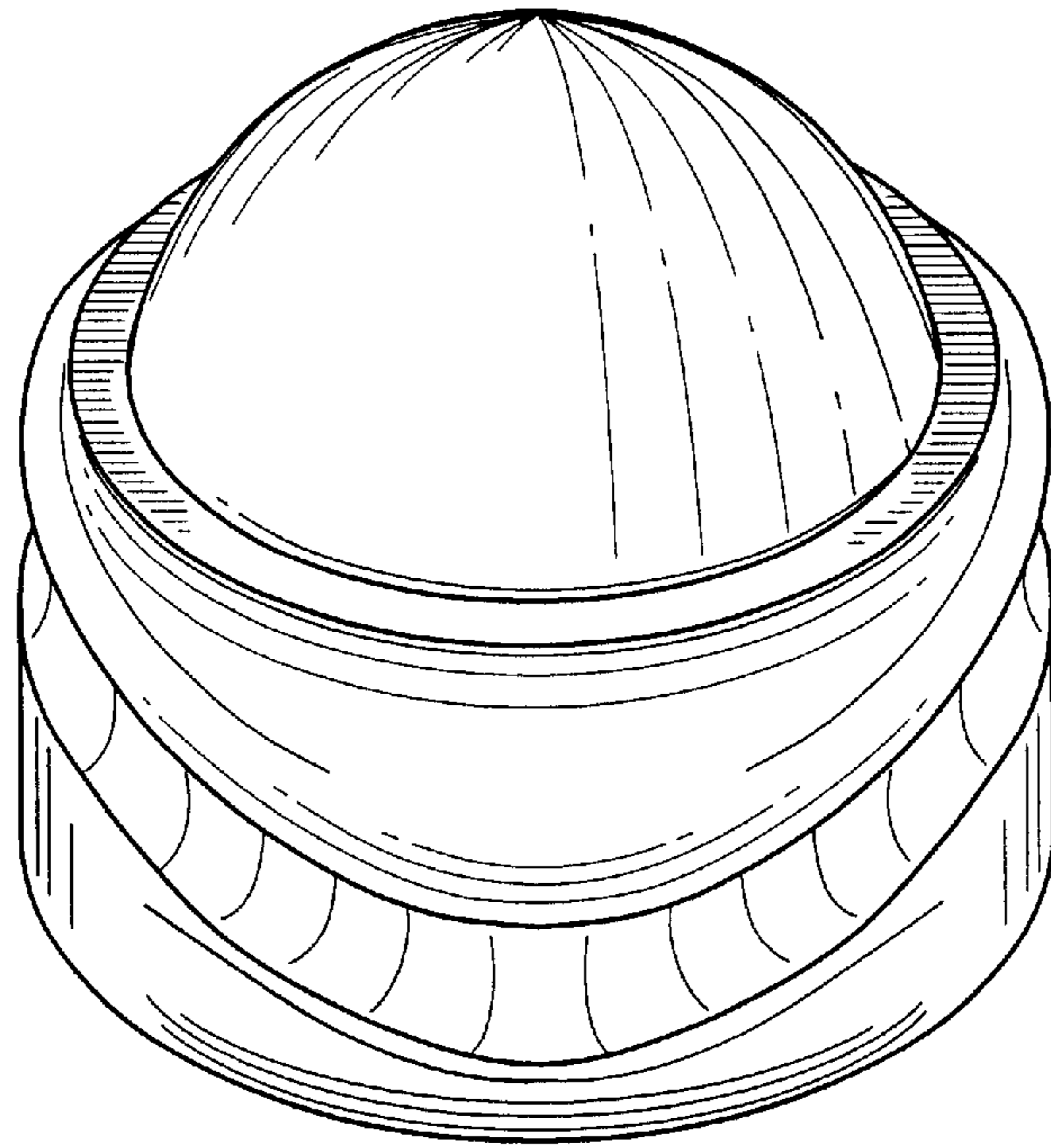

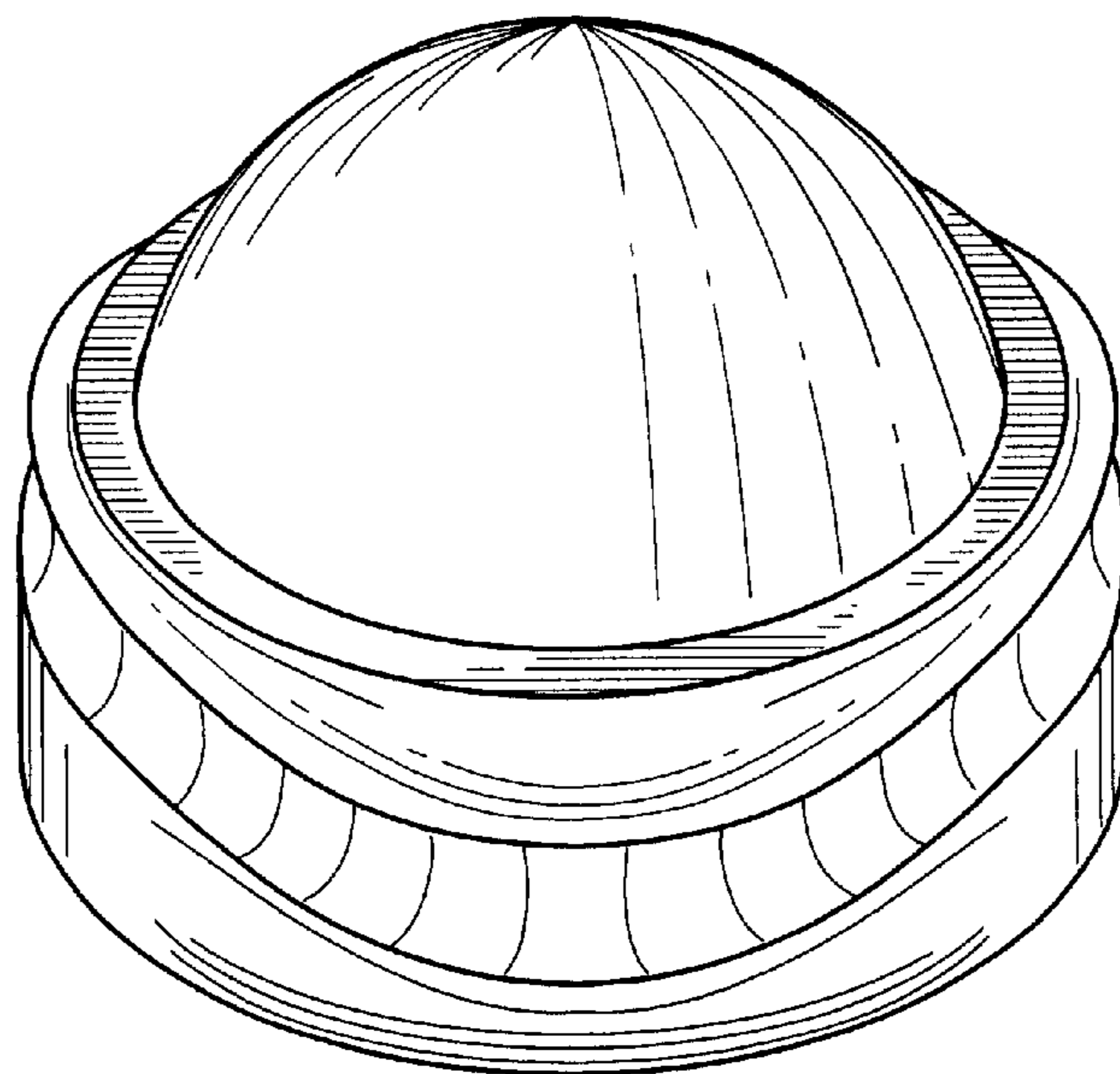

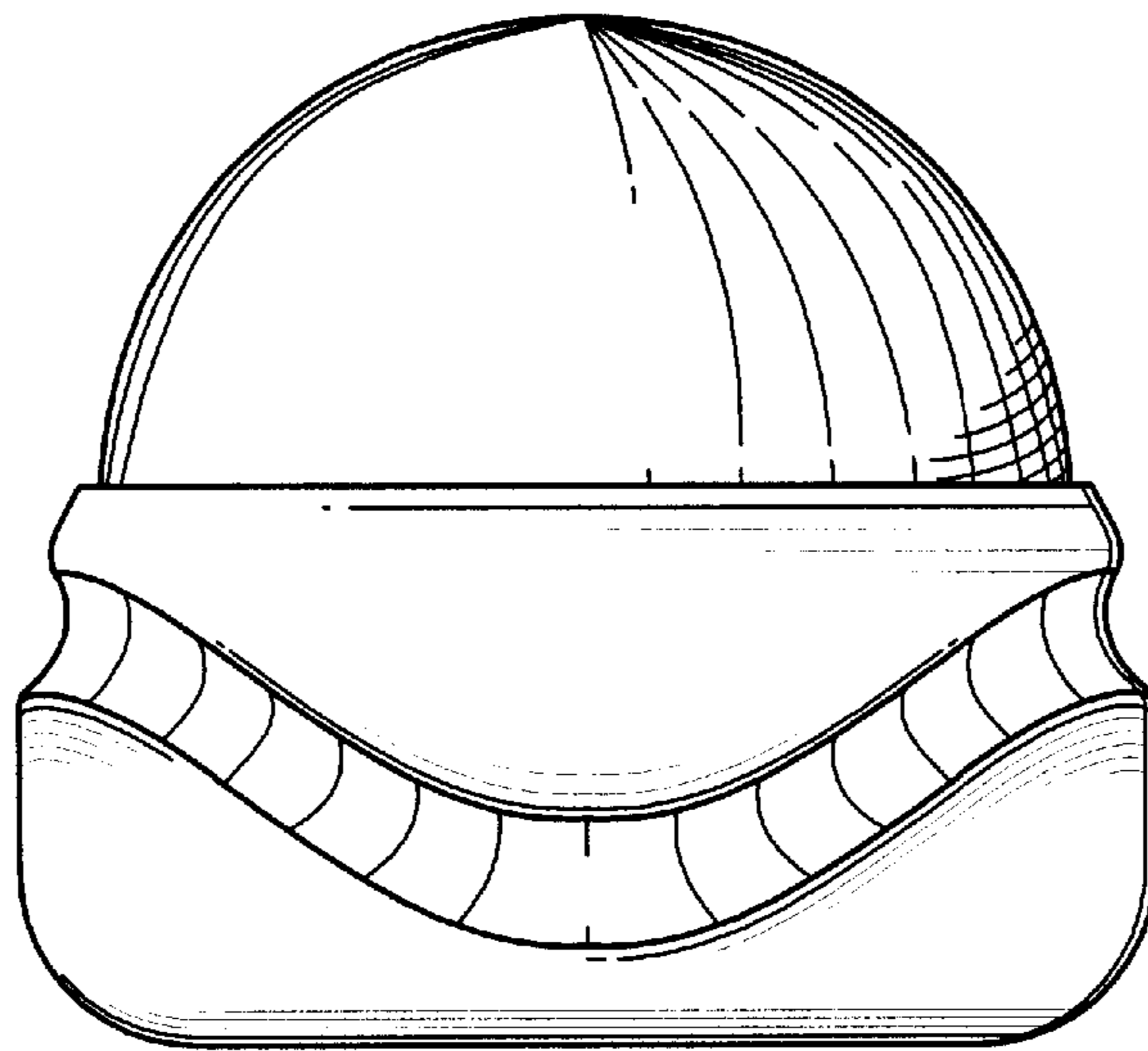

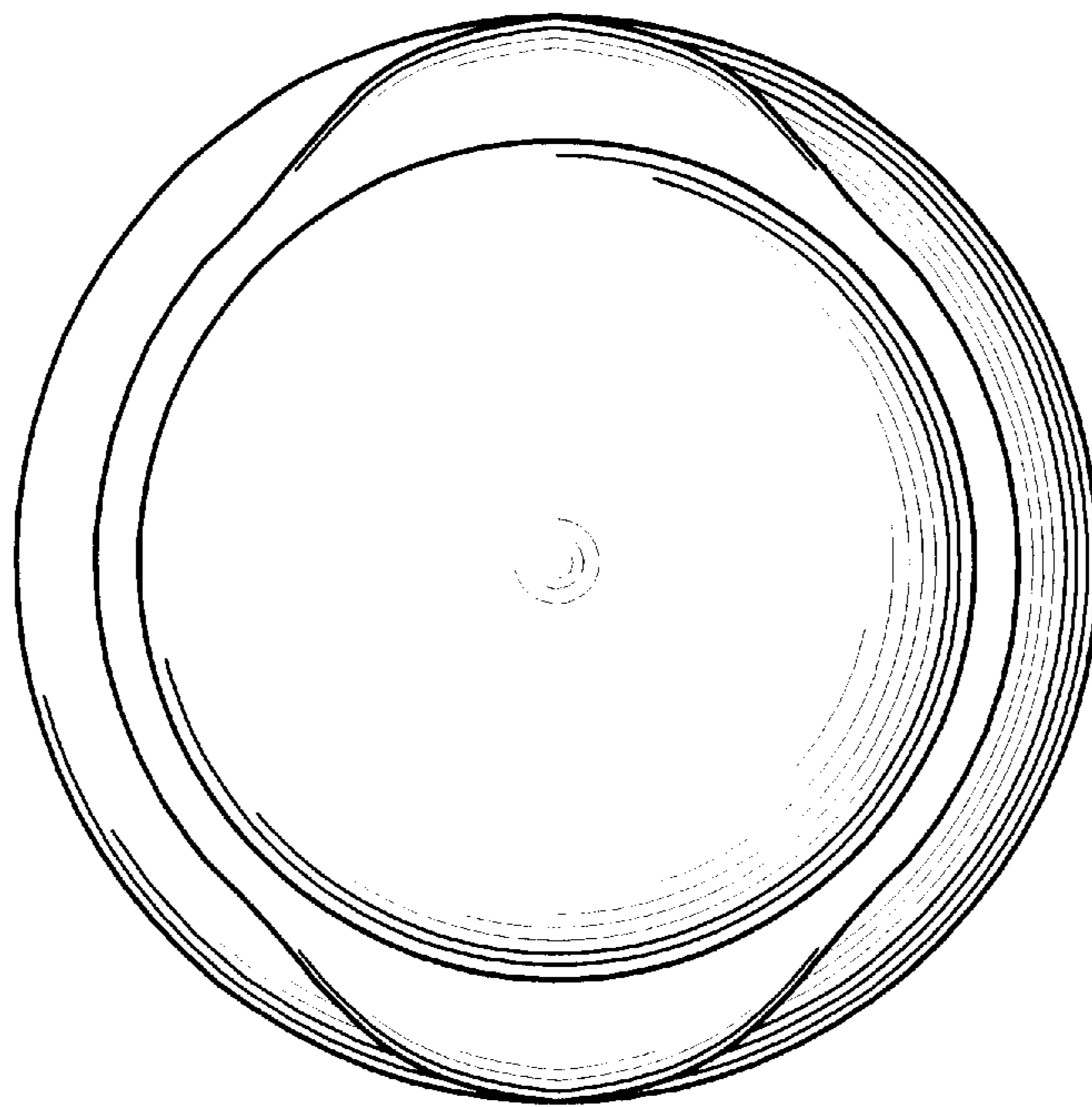

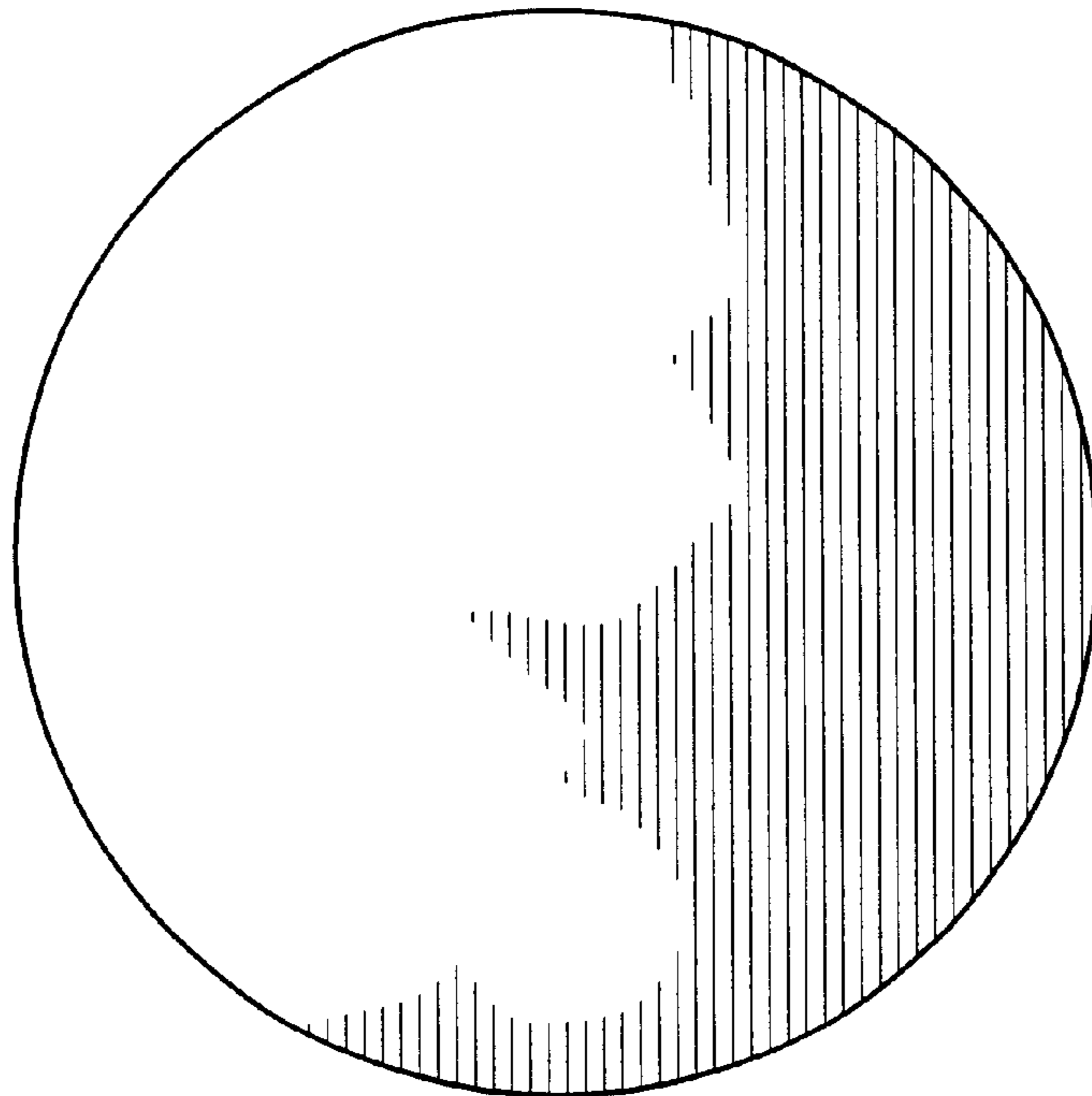

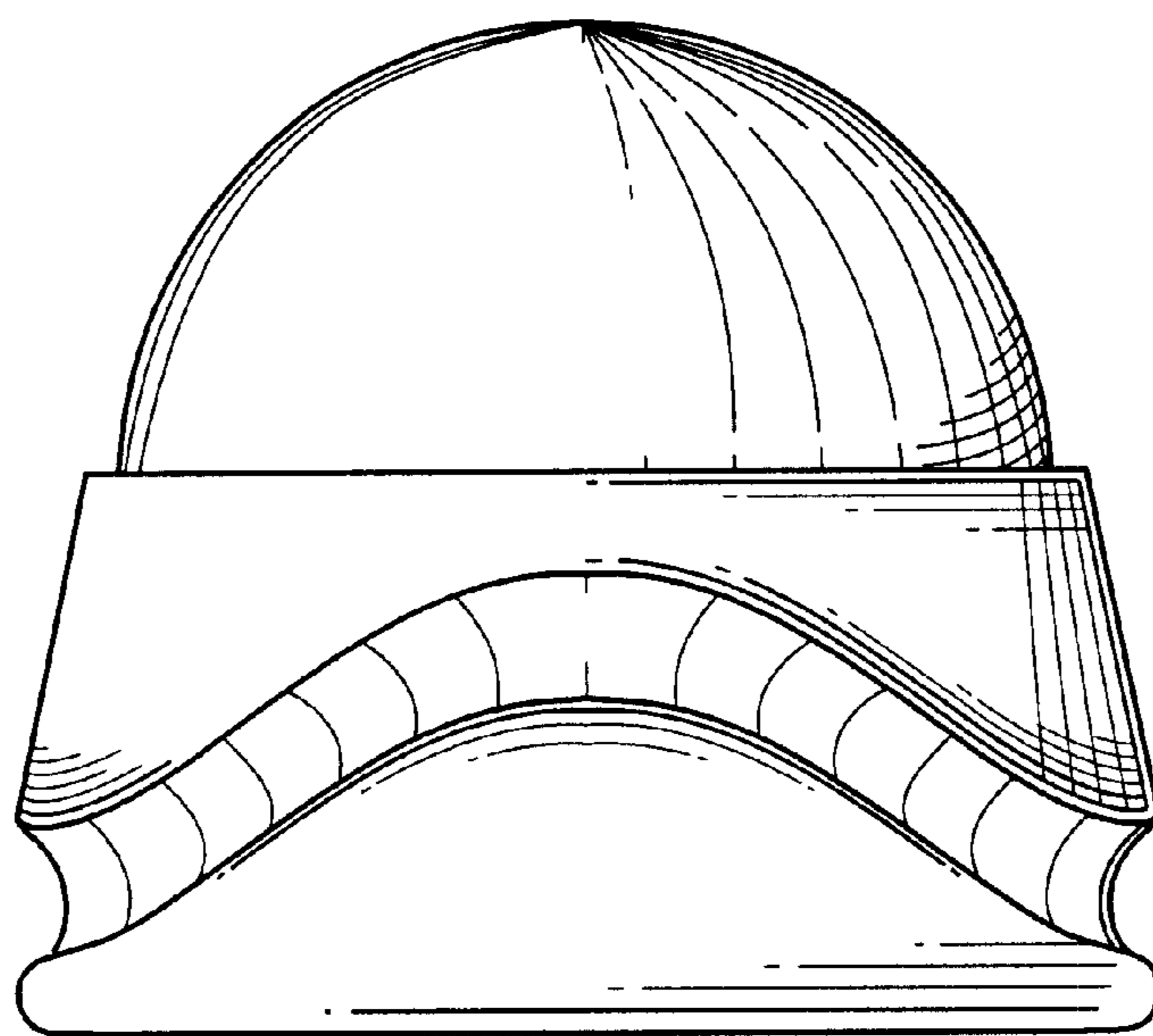
