FIG. 1 is a left side elevation view of a building structure for a carwash showing my new design.

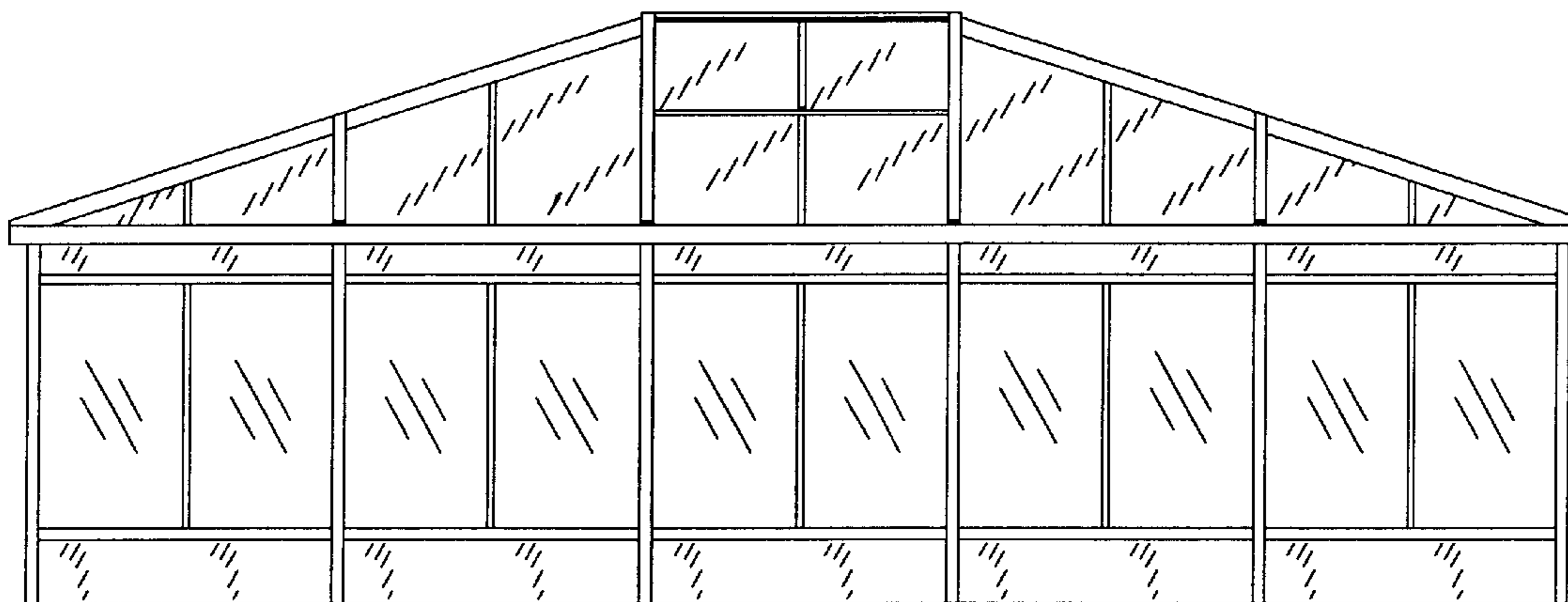
FIG. 2 is a right side elevation view thereof, generally showing the inside of the building structure as viewed from the right side.

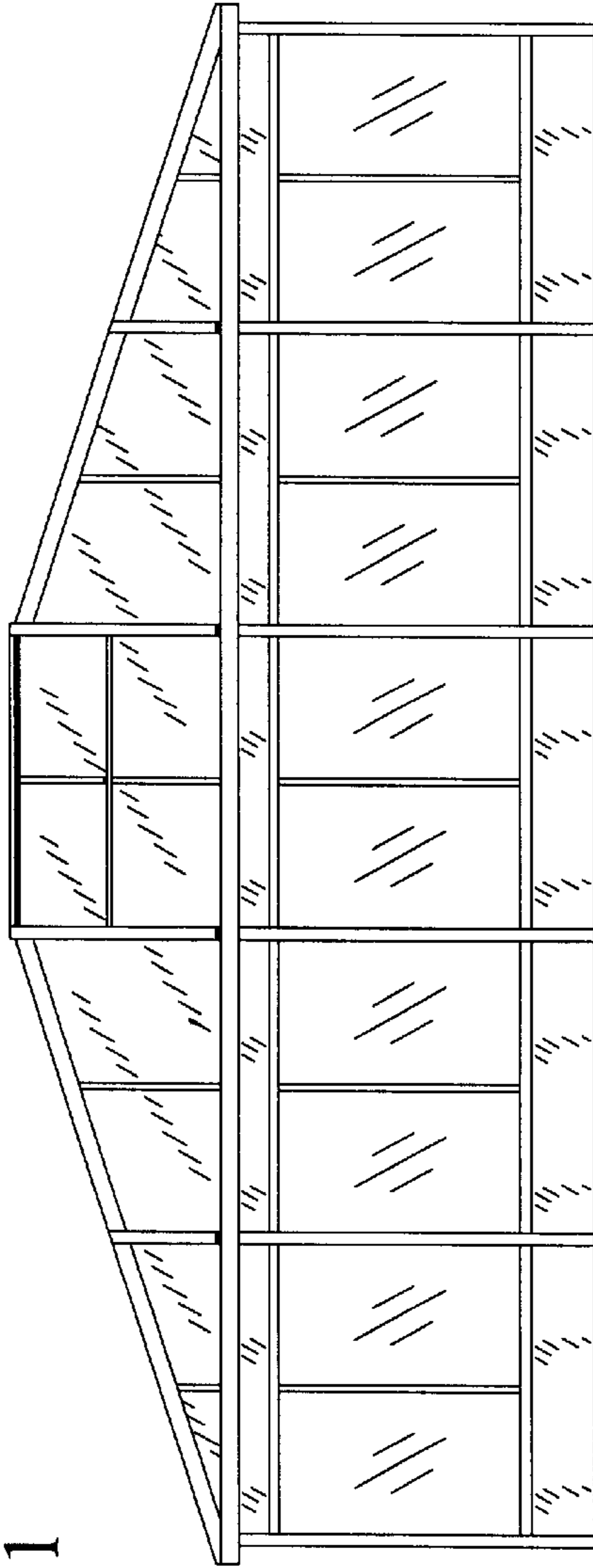

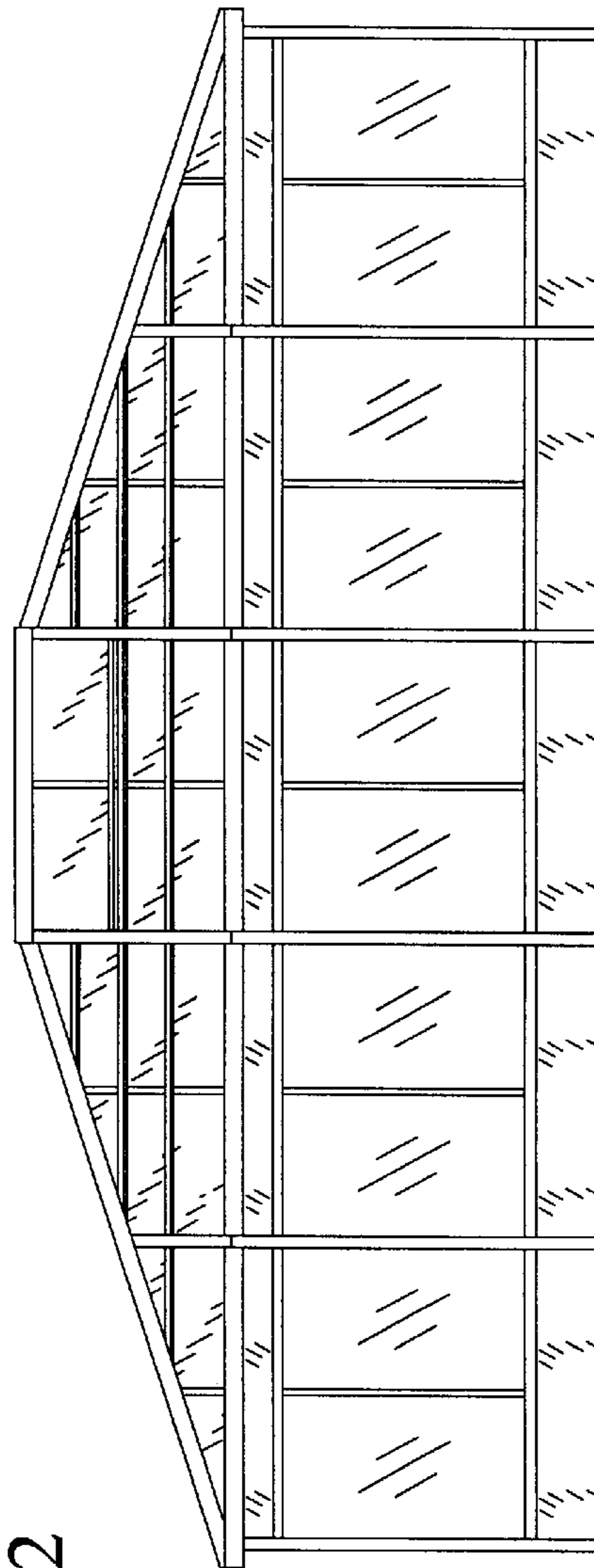

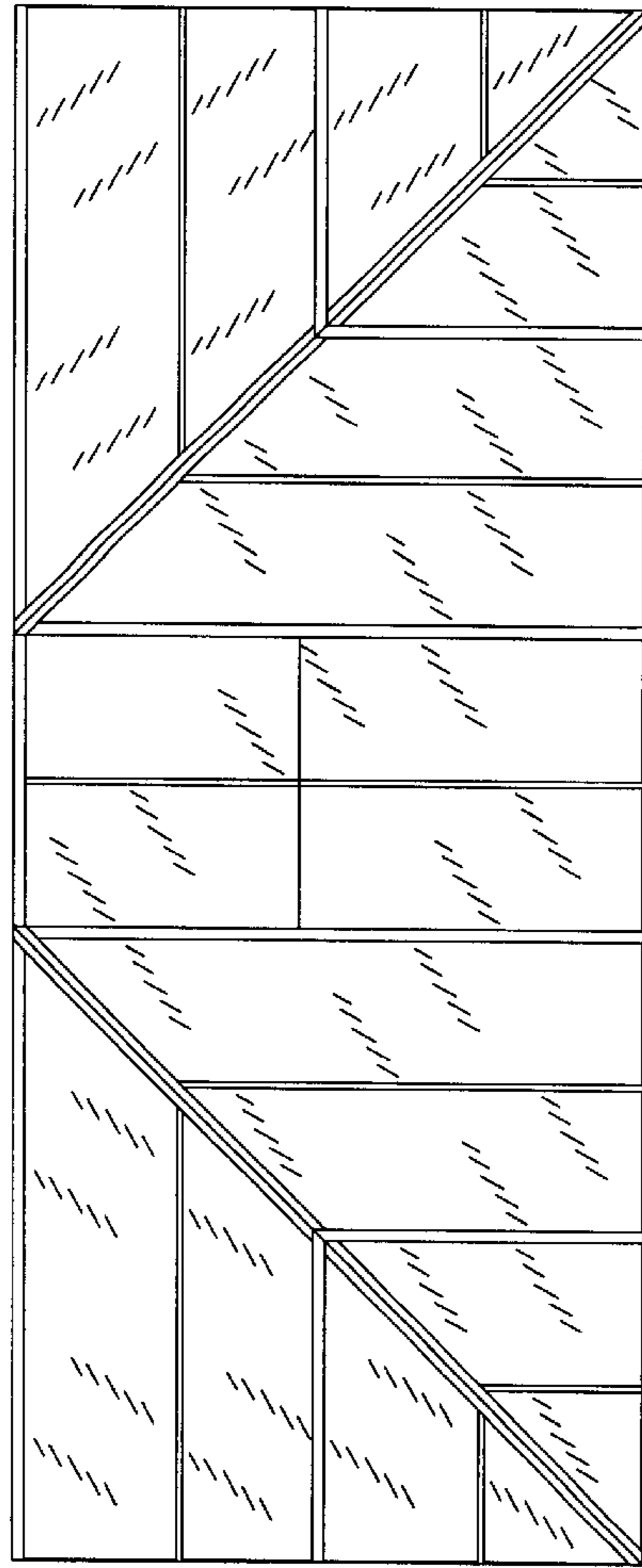

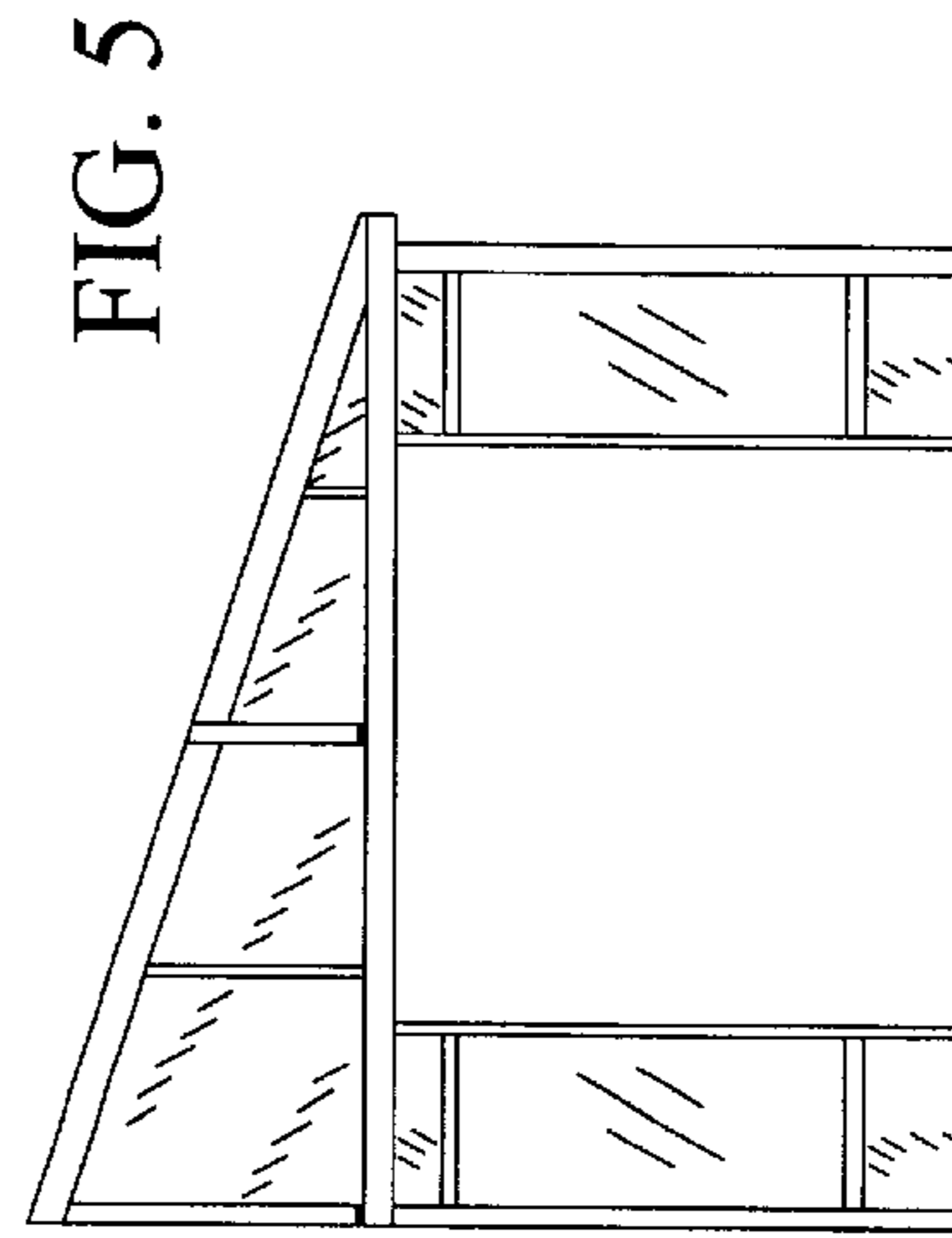

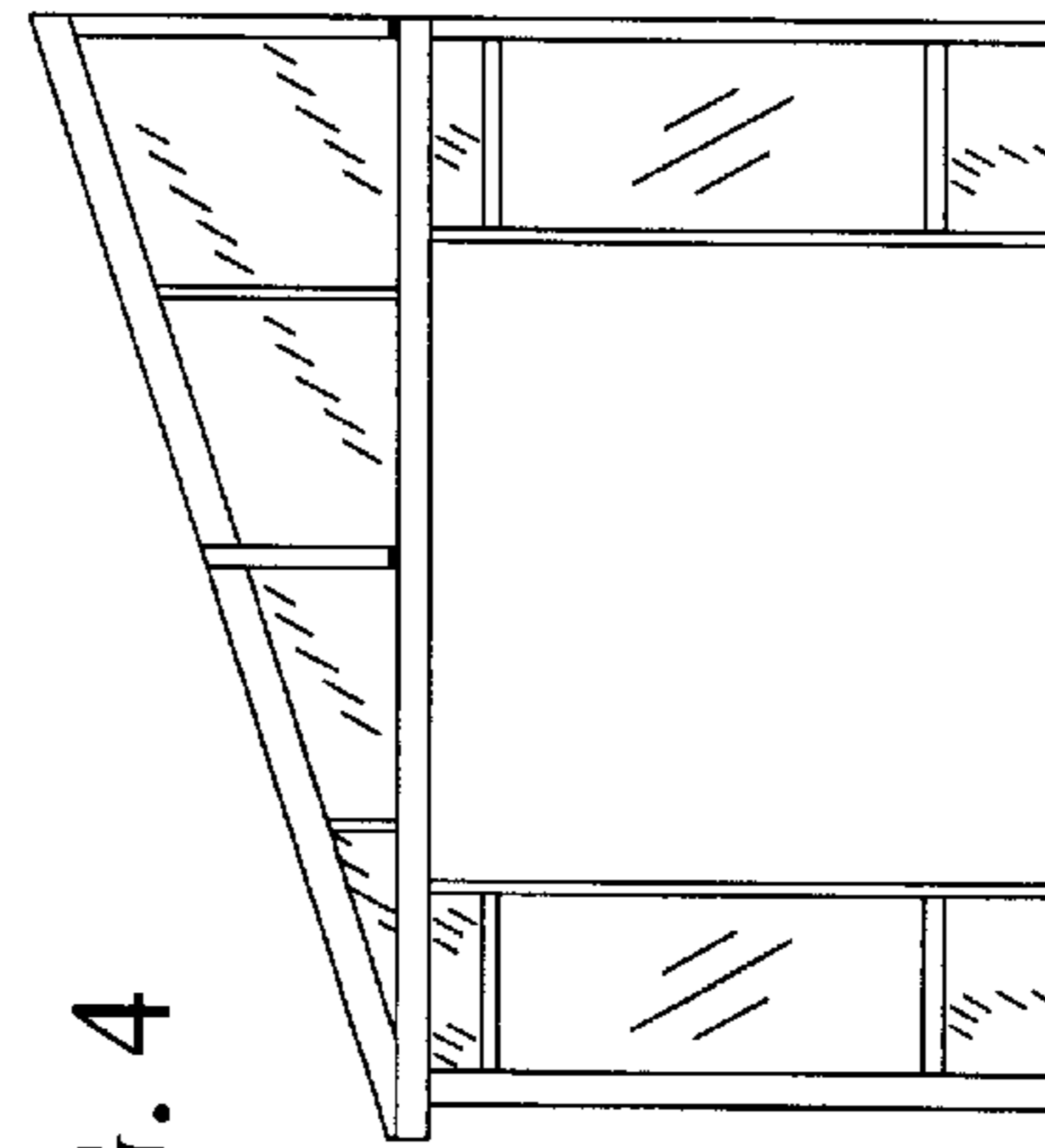
