We claim the ornamental design for a basketball basket container, as shown herein.

DESCRIPTION

FIG. 1 is a perspective view of a basketball basket container showing our new design;

FIG. 2 is a front view of the container of FIG. 1,

FIG. 3 is a side view of the container of FIG. 1,

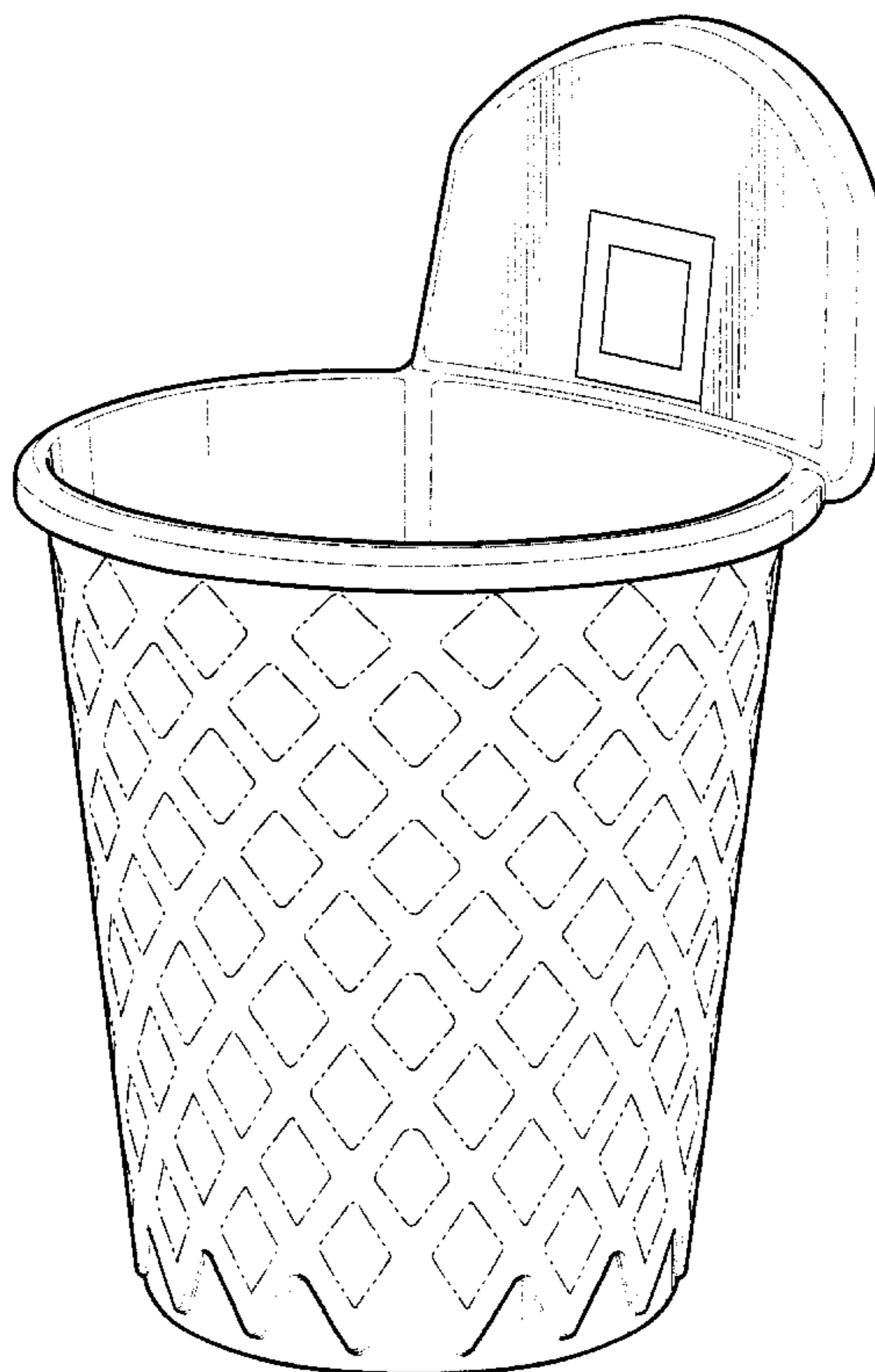
FIG. 4 is a rear view of the container of FIG. 1,

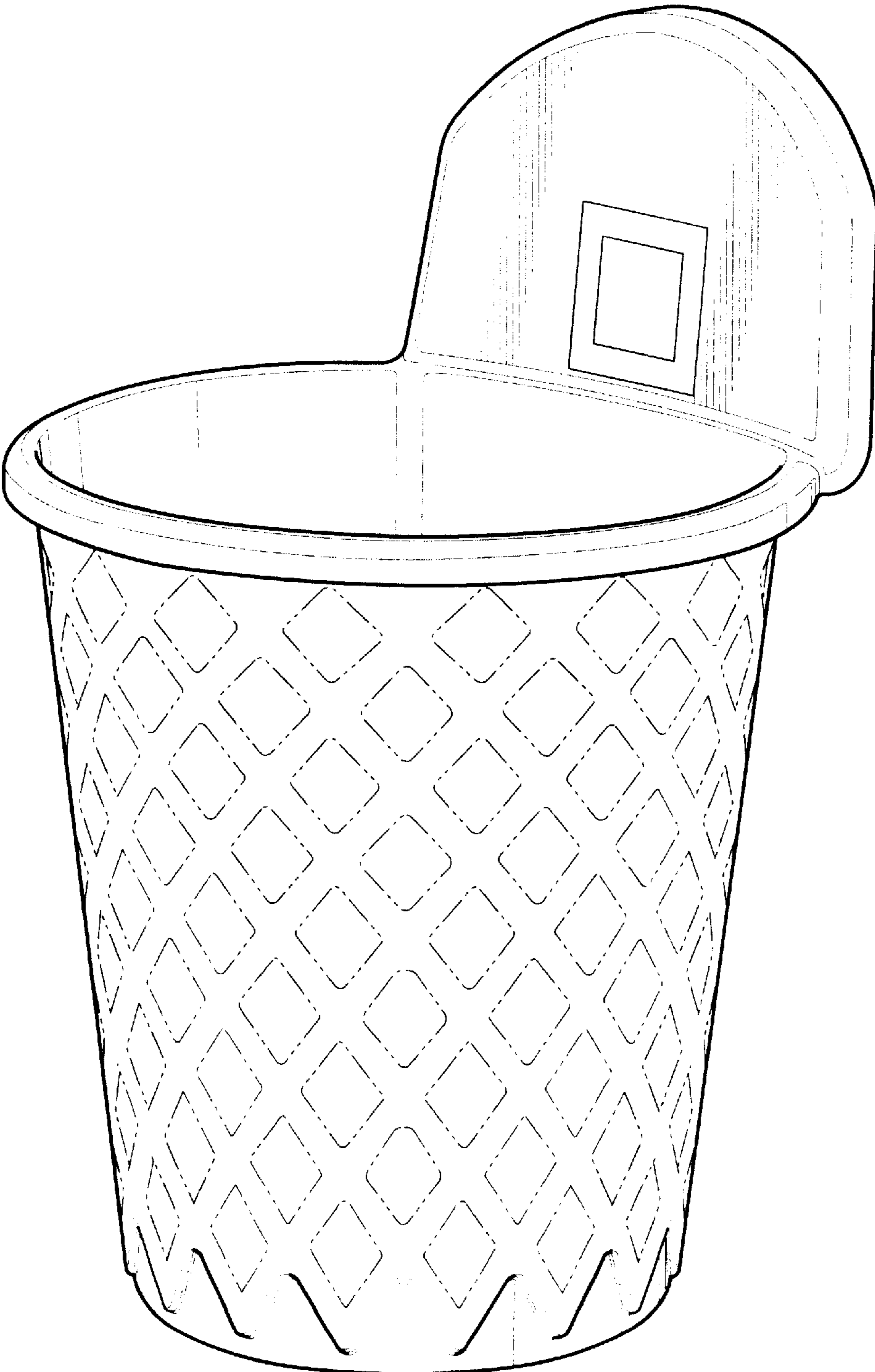

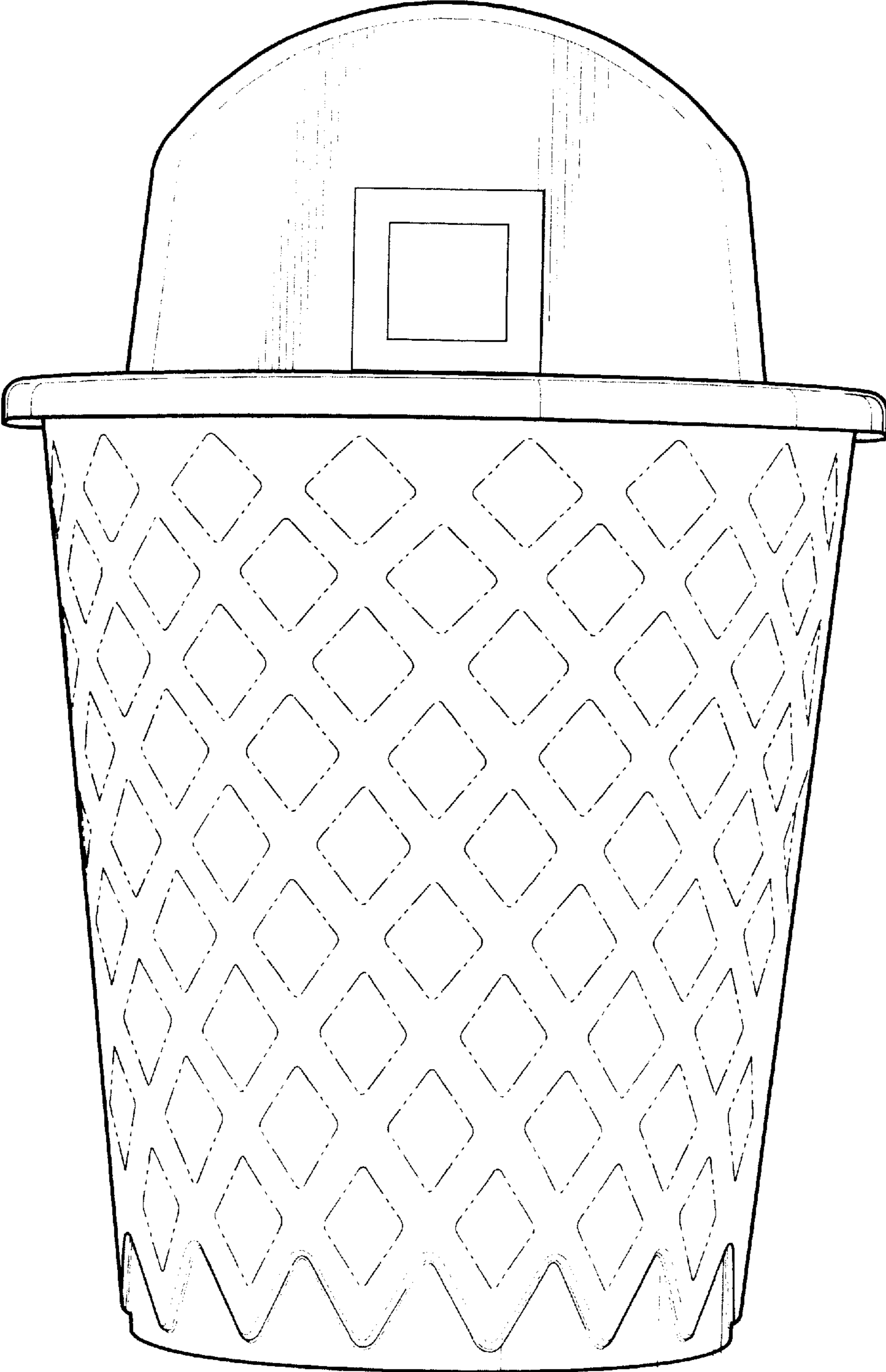

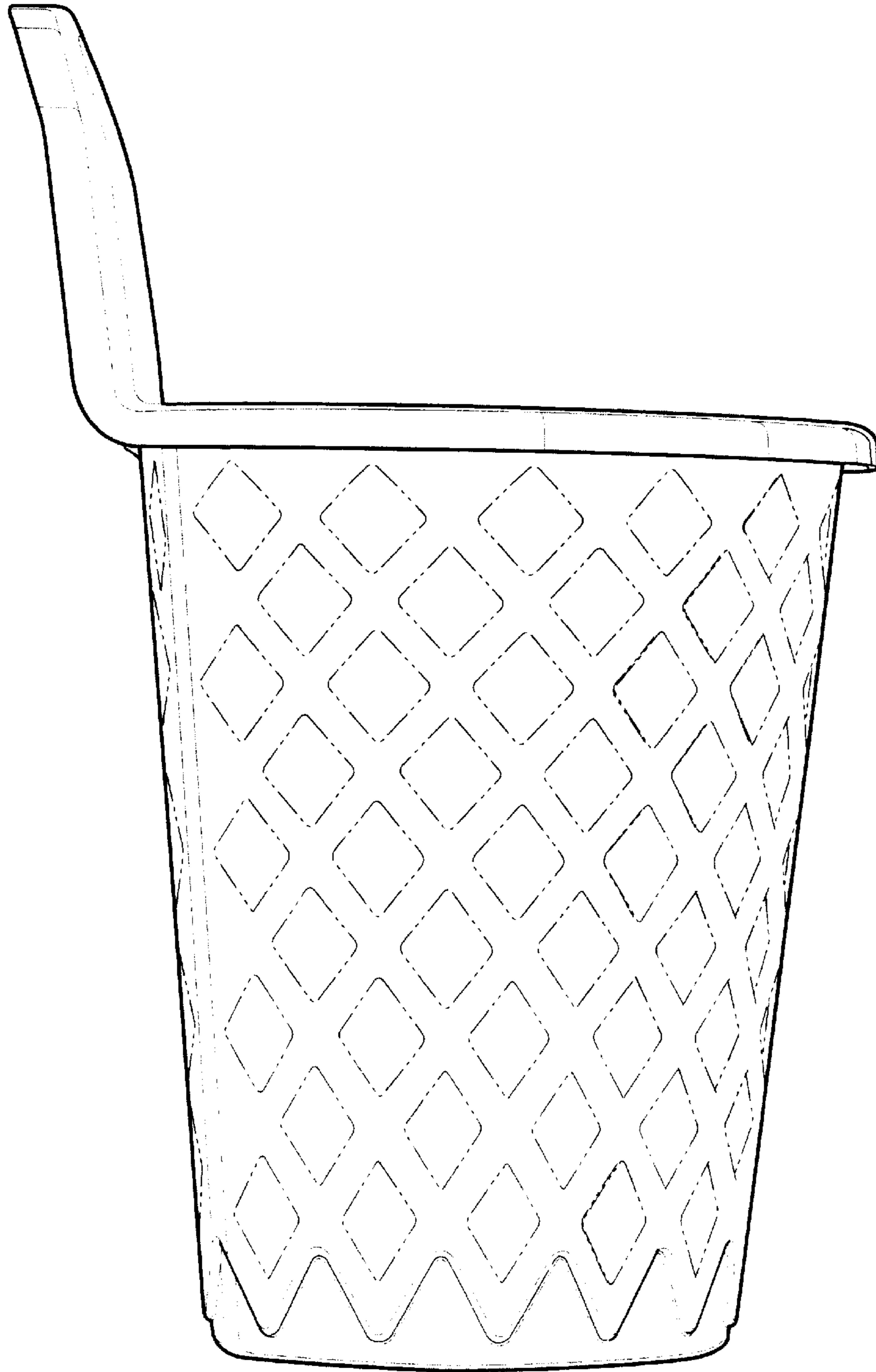

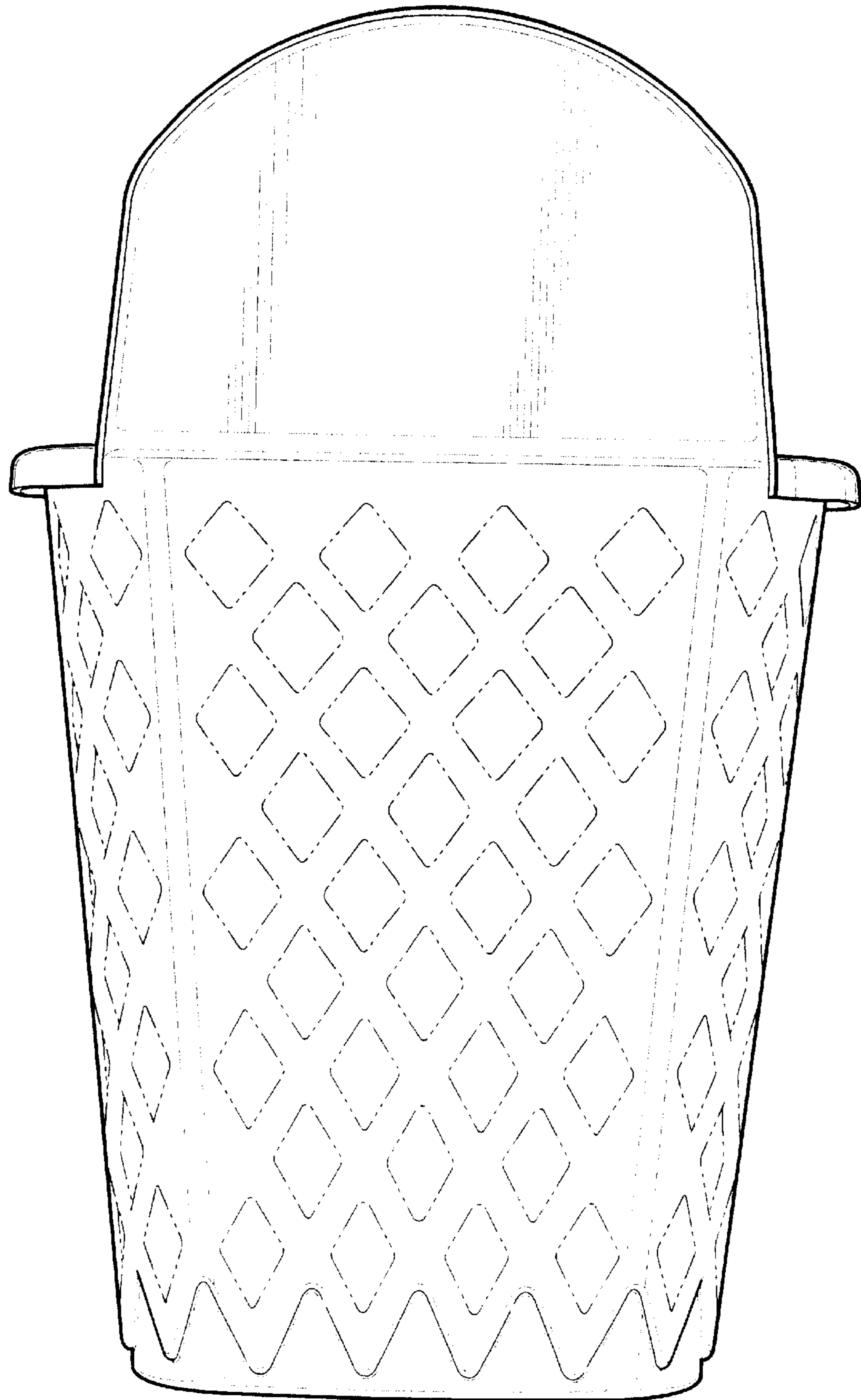

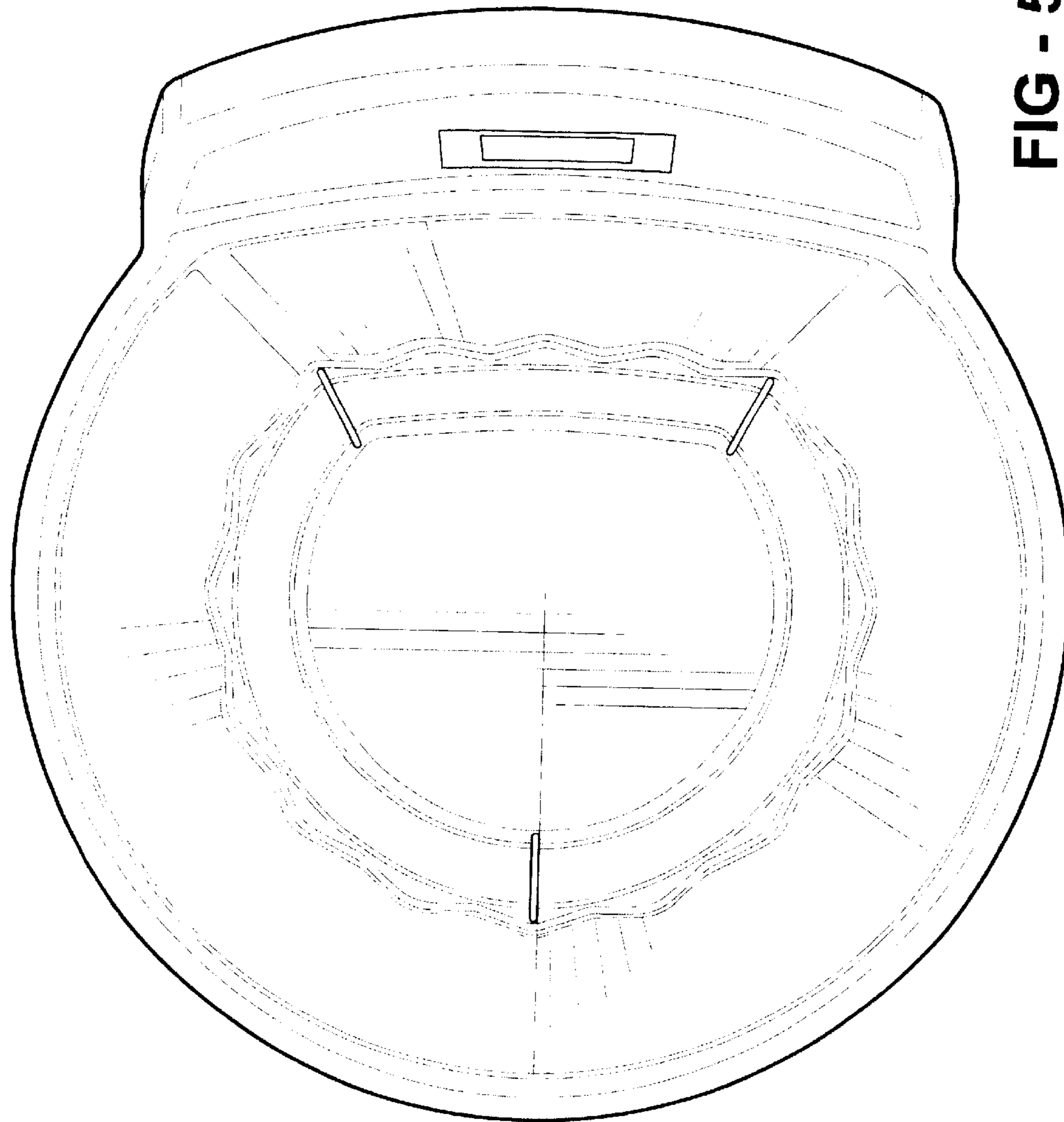

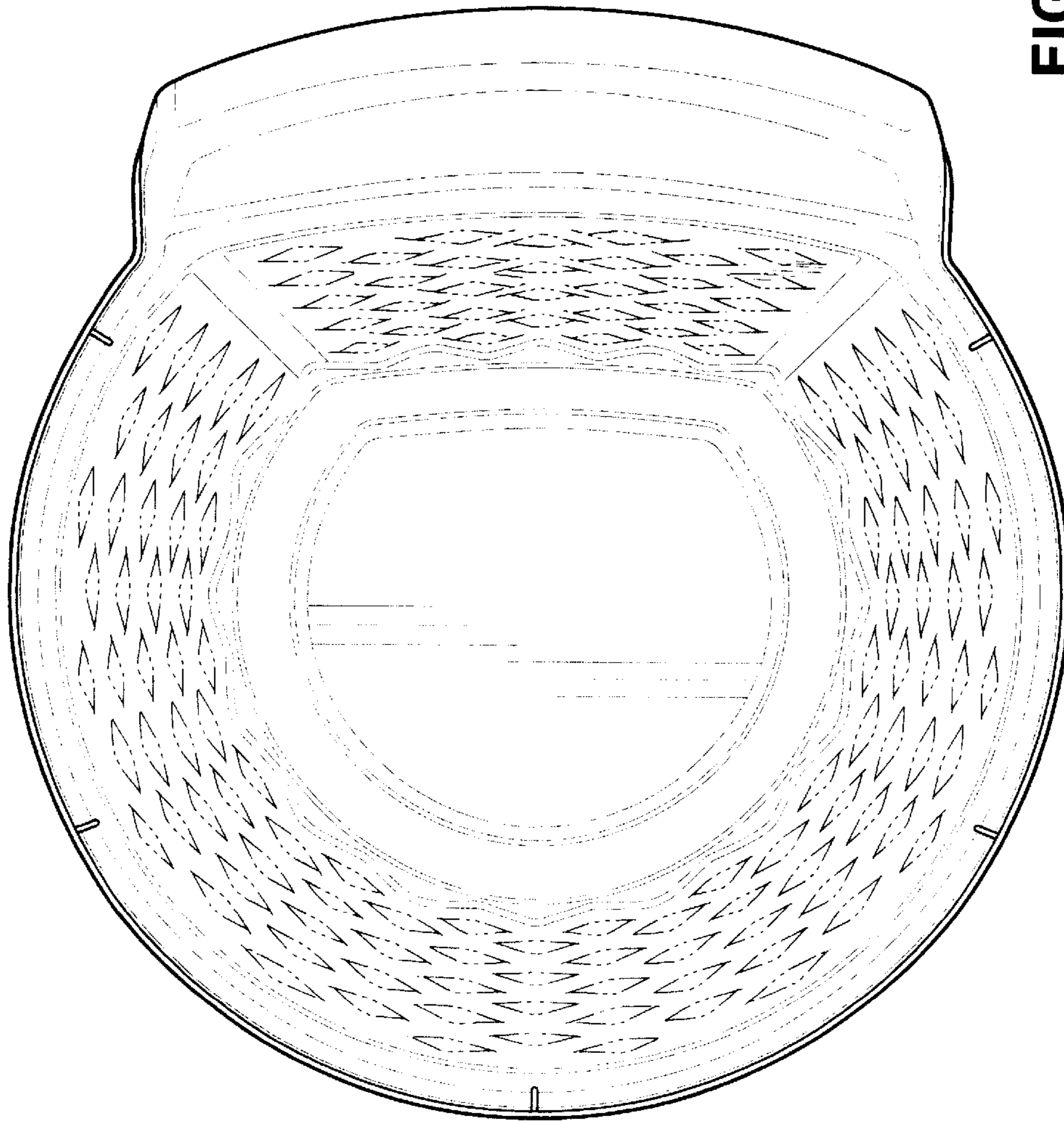
