FIG. 1 is a front perspective view of a brassiere in the open condition, showing my new design;

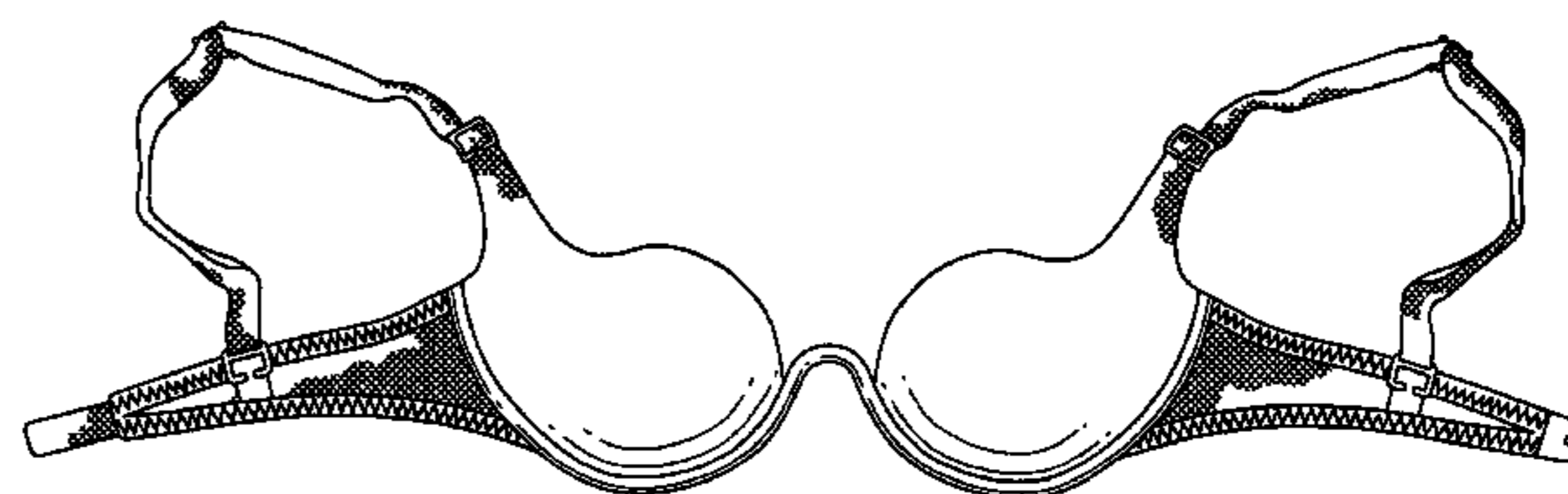
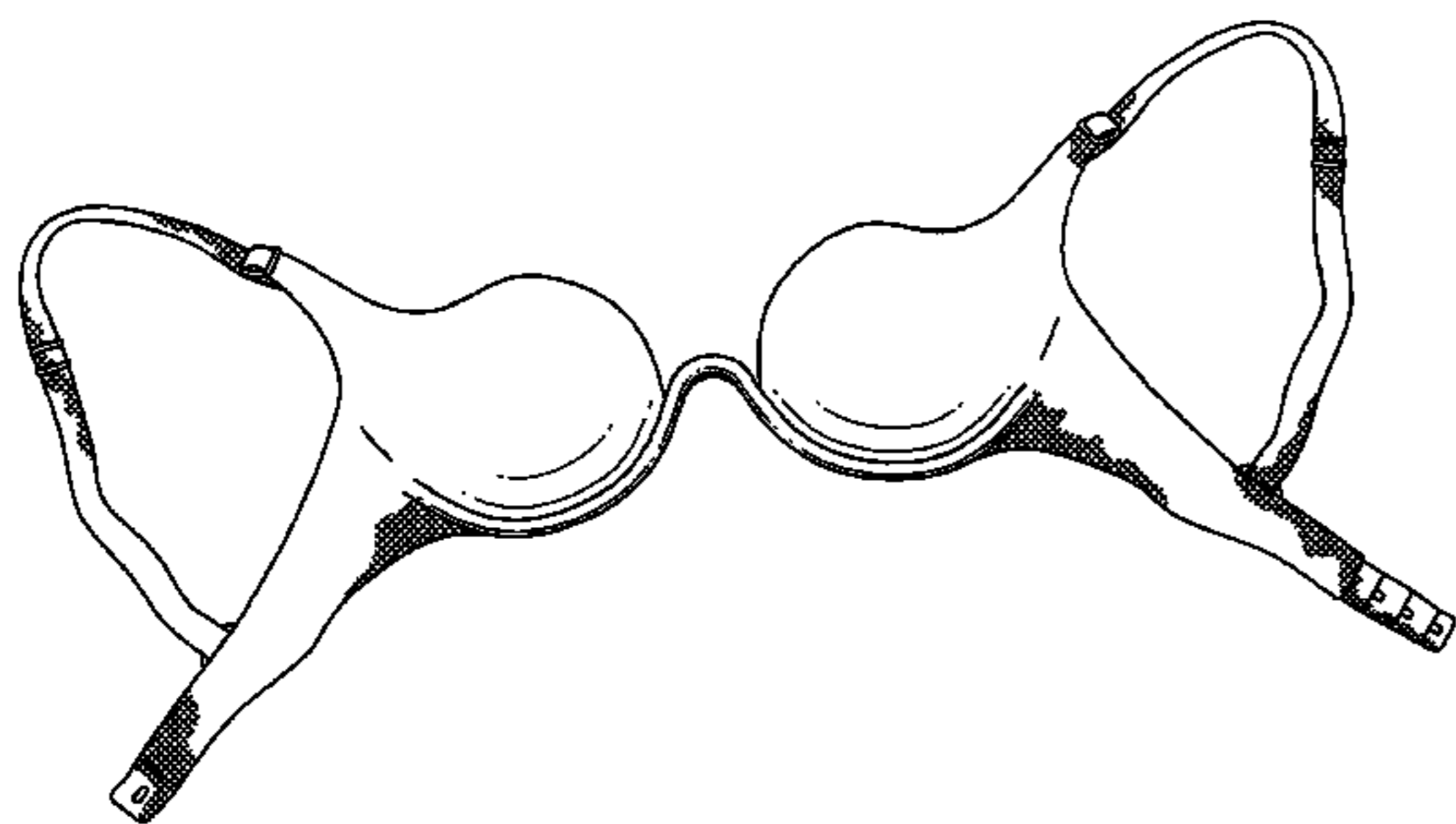
FIG. 2 is a front elevational view thereof, shown in the open condition;

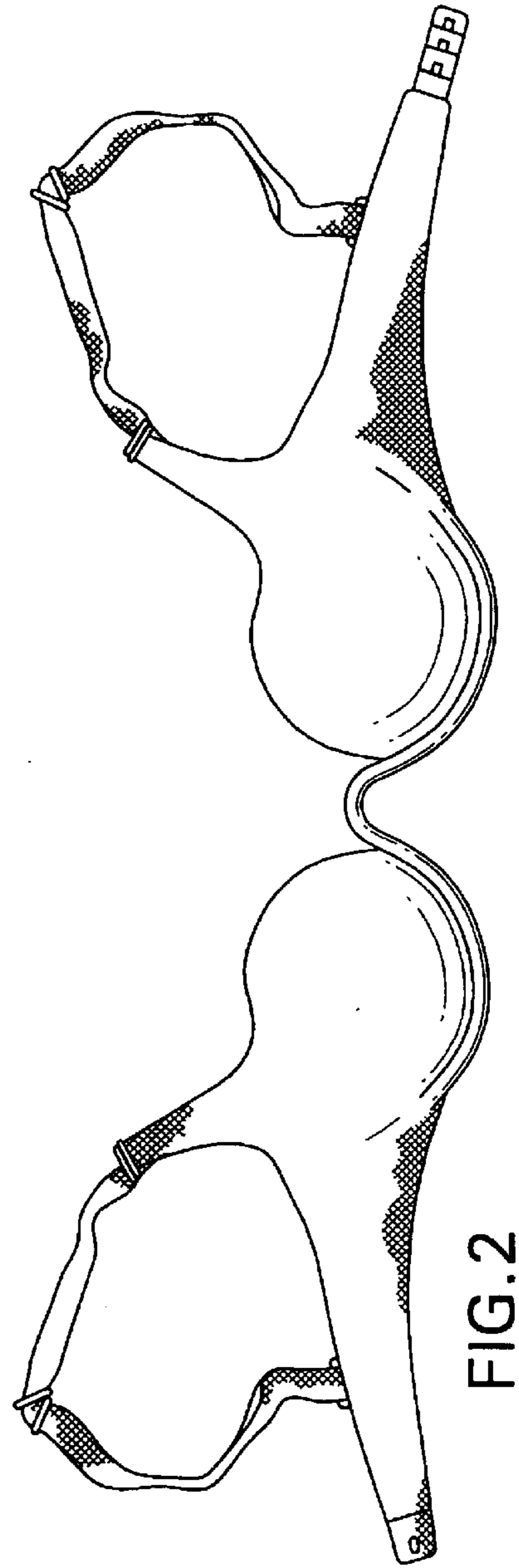
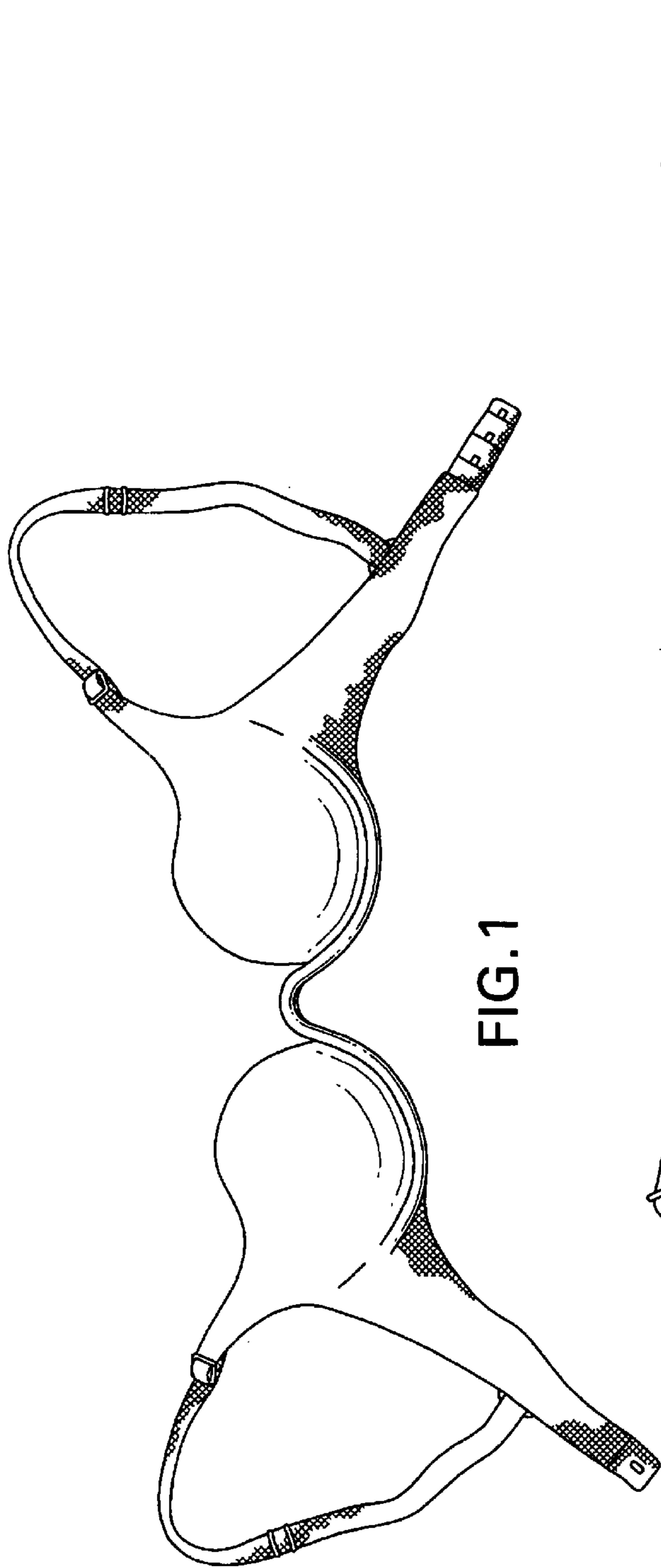
FIG. 3 is a front elevational view thereof, shown in the setup condition;

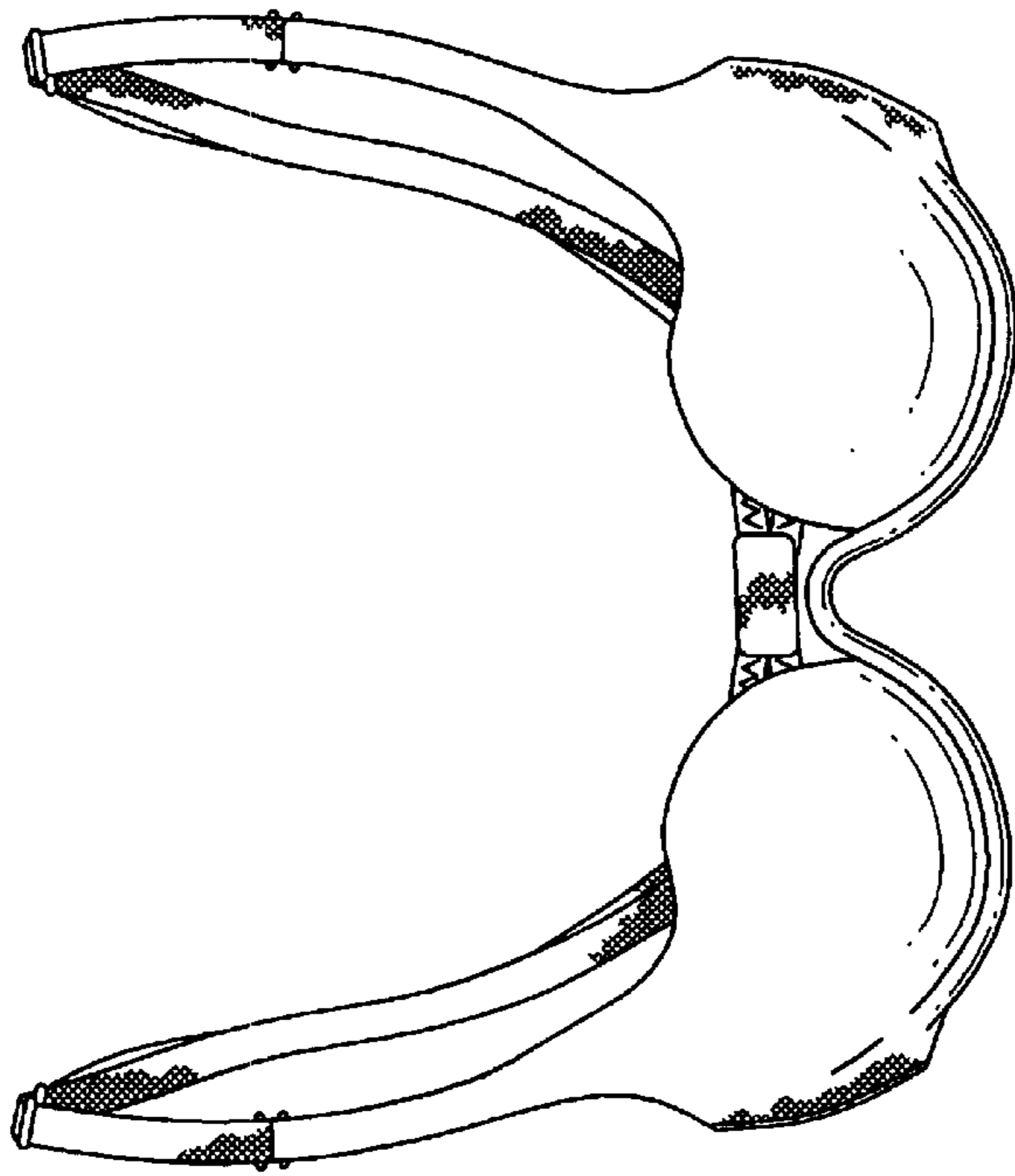

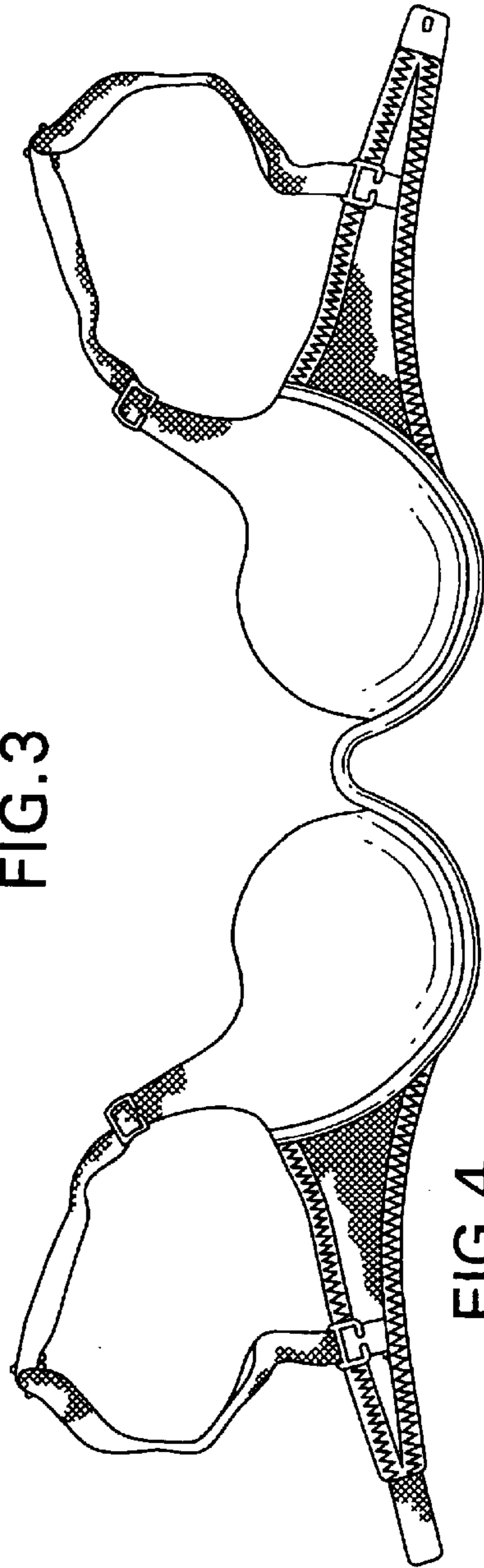

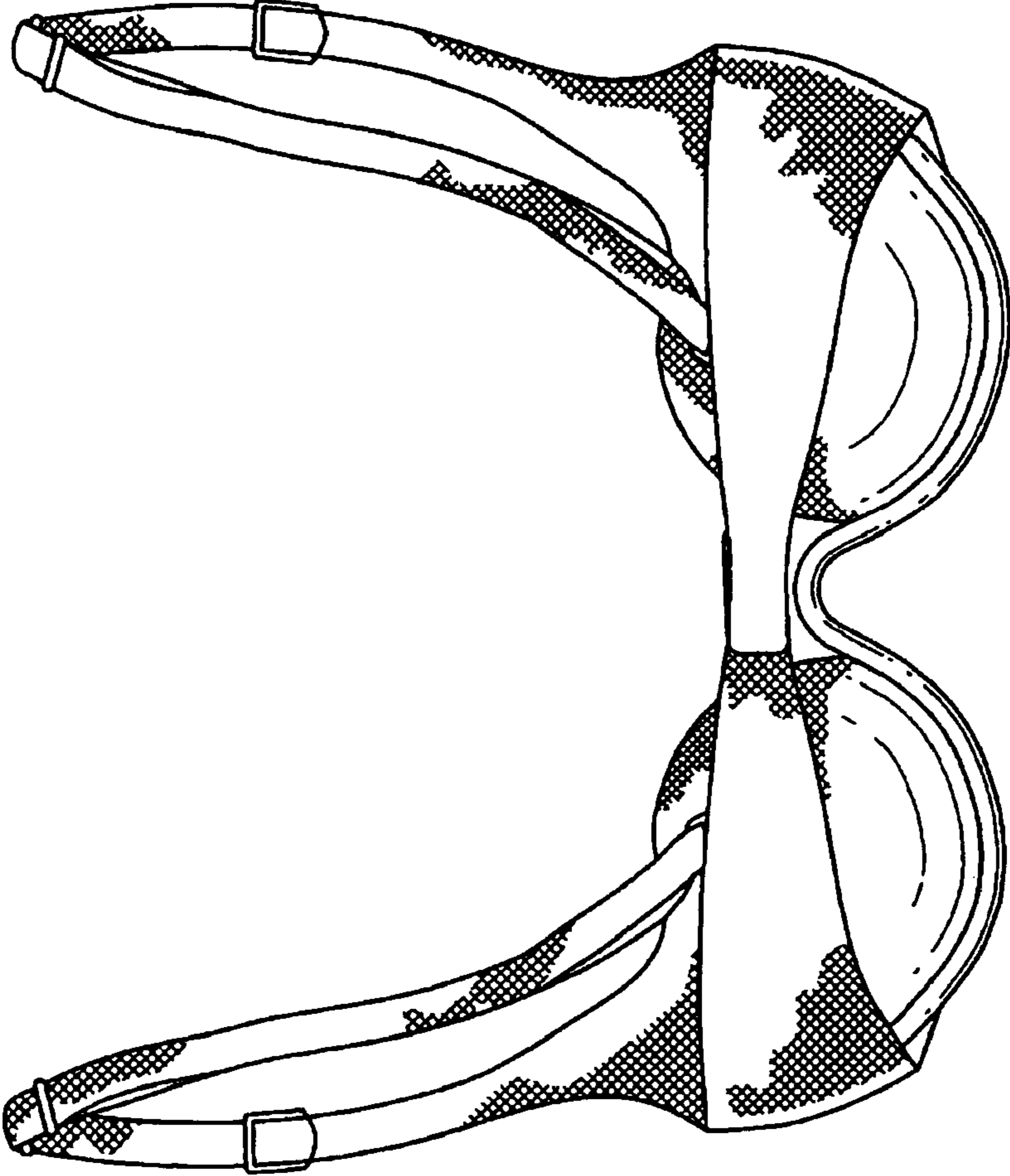
