(57) **CLAIM**

The ornamental design for a wheel element for a footwear upper, as shown and described.

DESCRIPTION

FIG. 1 is a side perspective view of a wheel element for a footwear upper showing our new design; FIG. 2 is a back view thereof; FIG. 3 is a top plan view thereof; and, FIG. 4 is a rear elevational view thereof. The broken line showing of the shoe is for illustrative purposes only and forms no part of the claimed design.

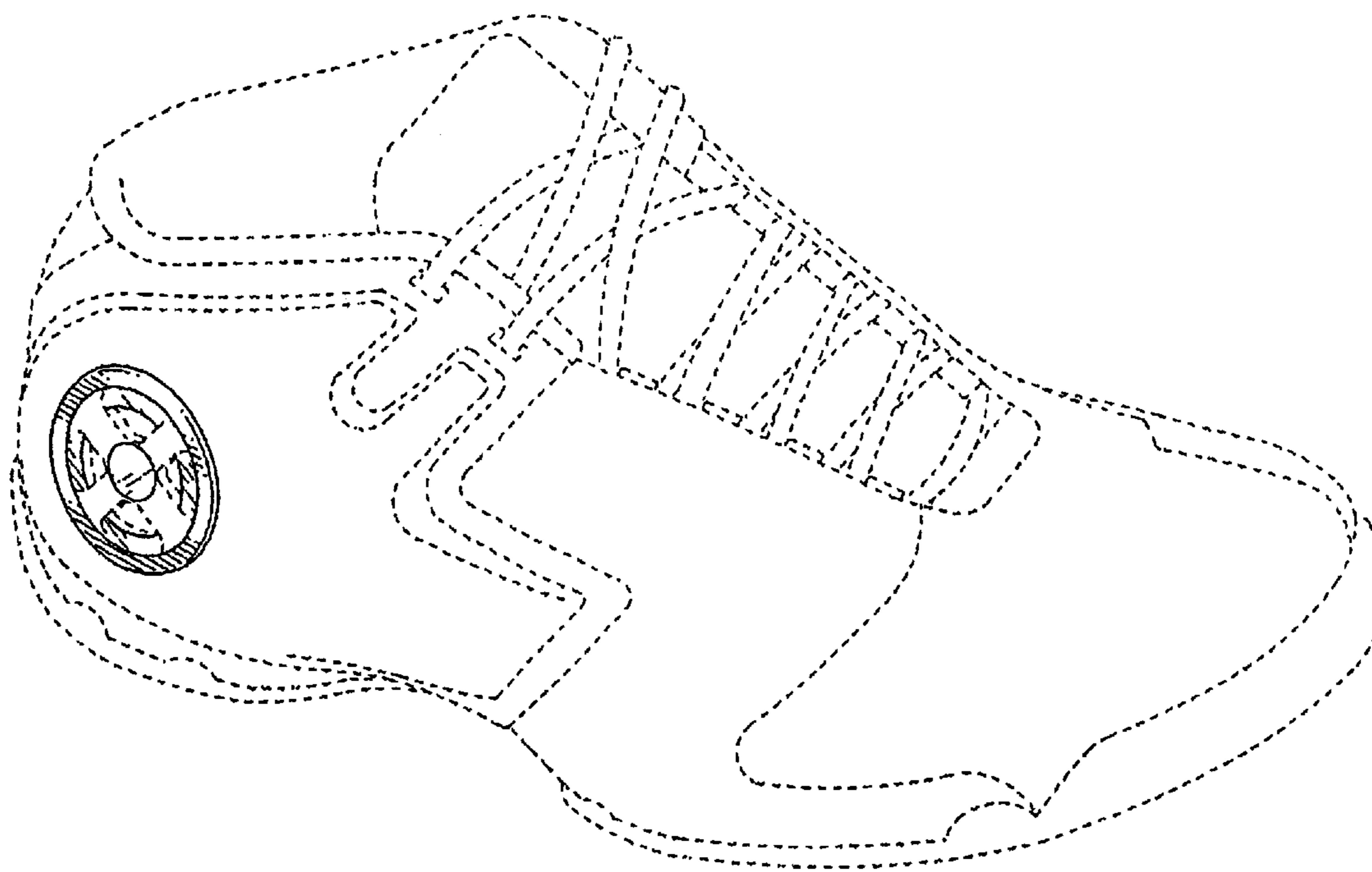
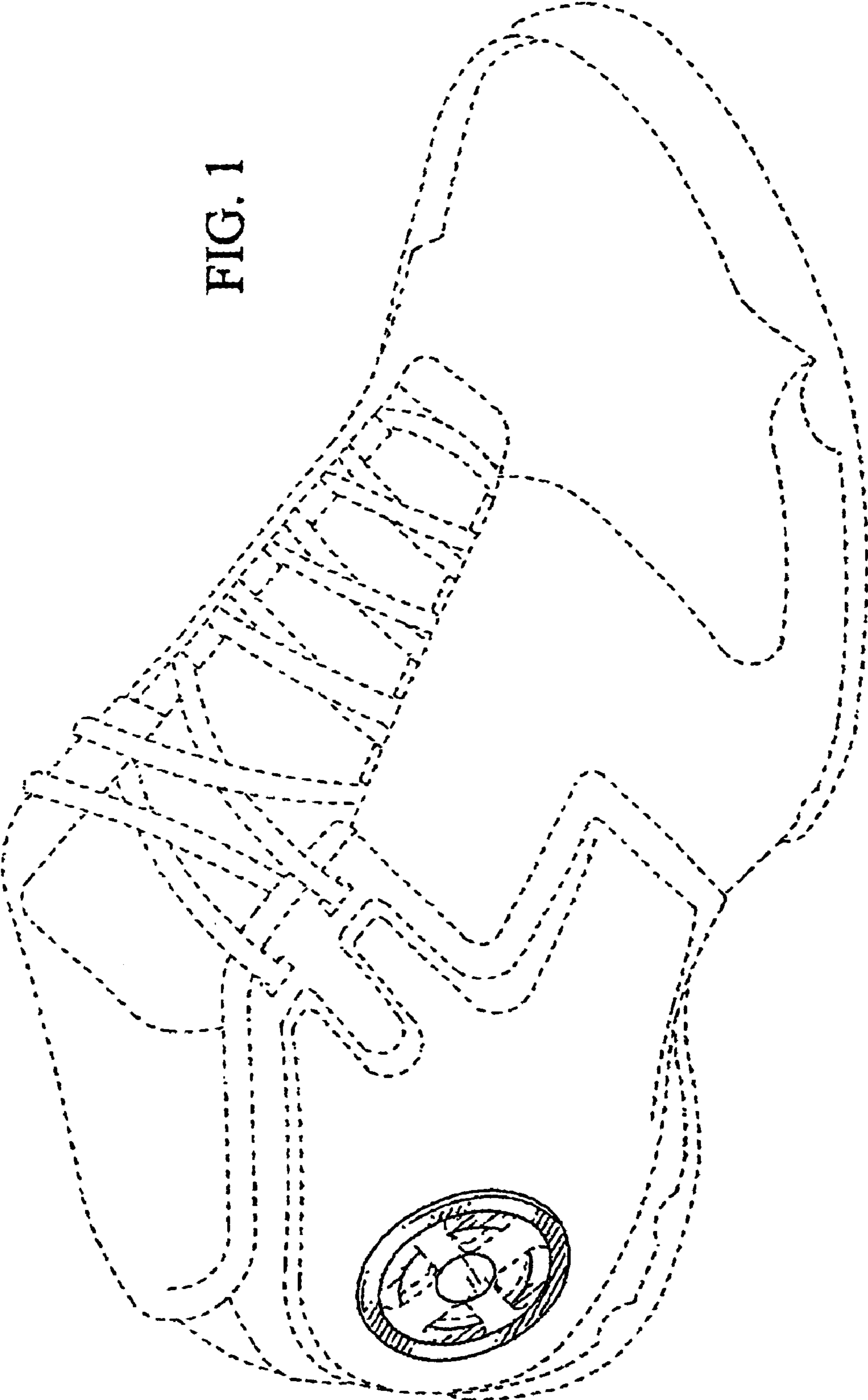

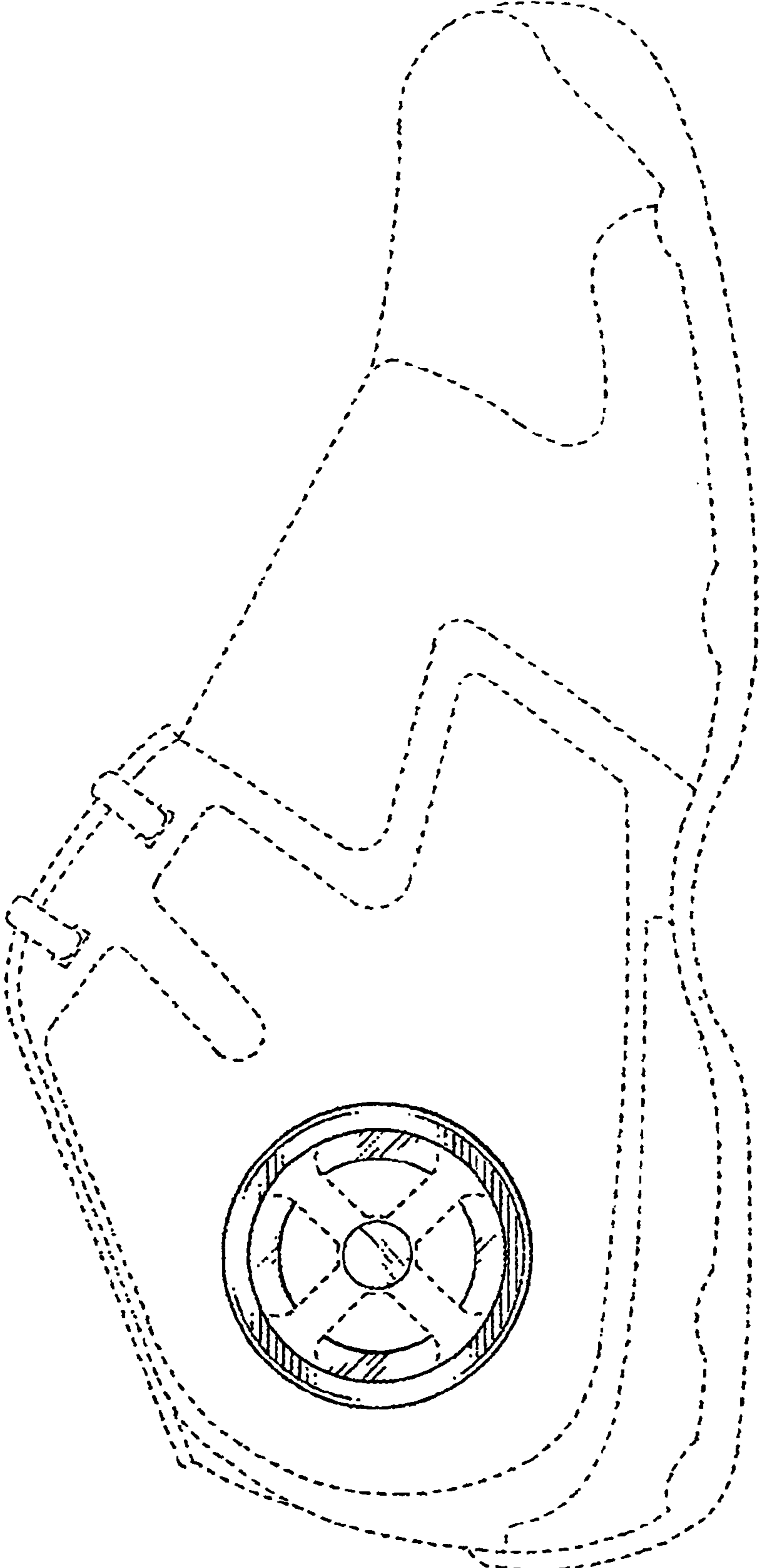

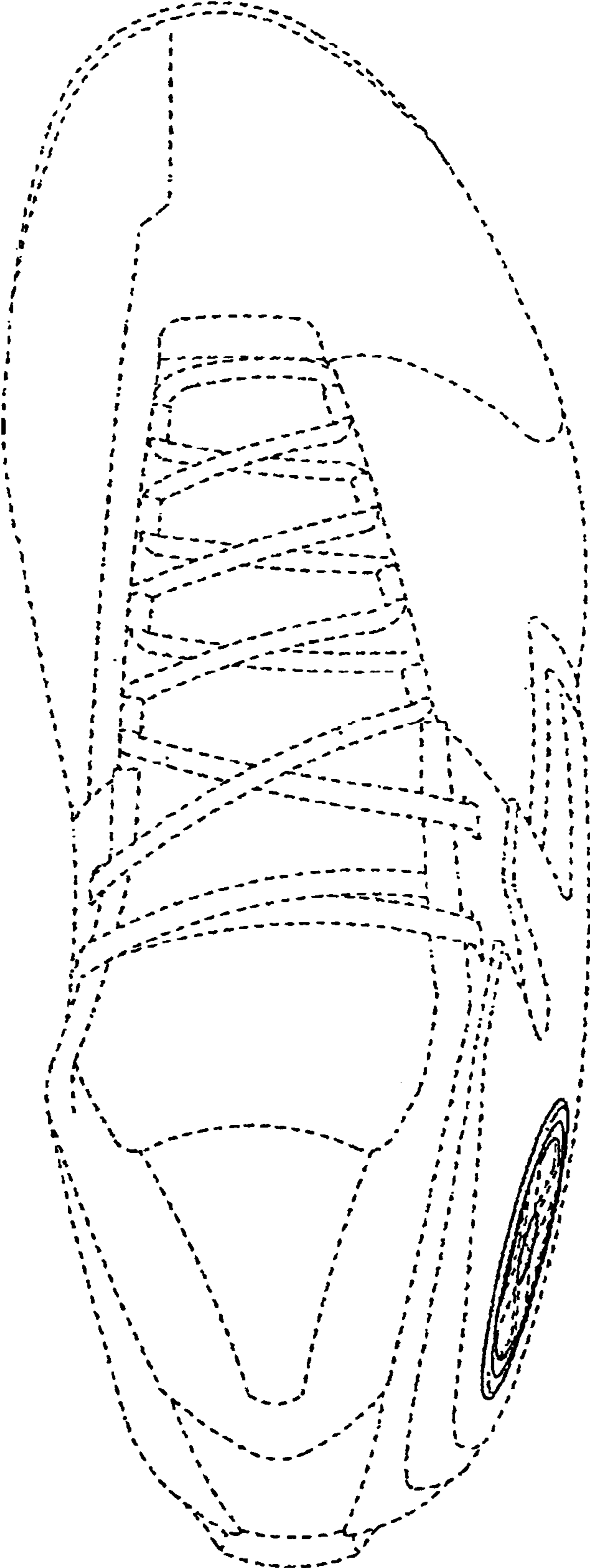

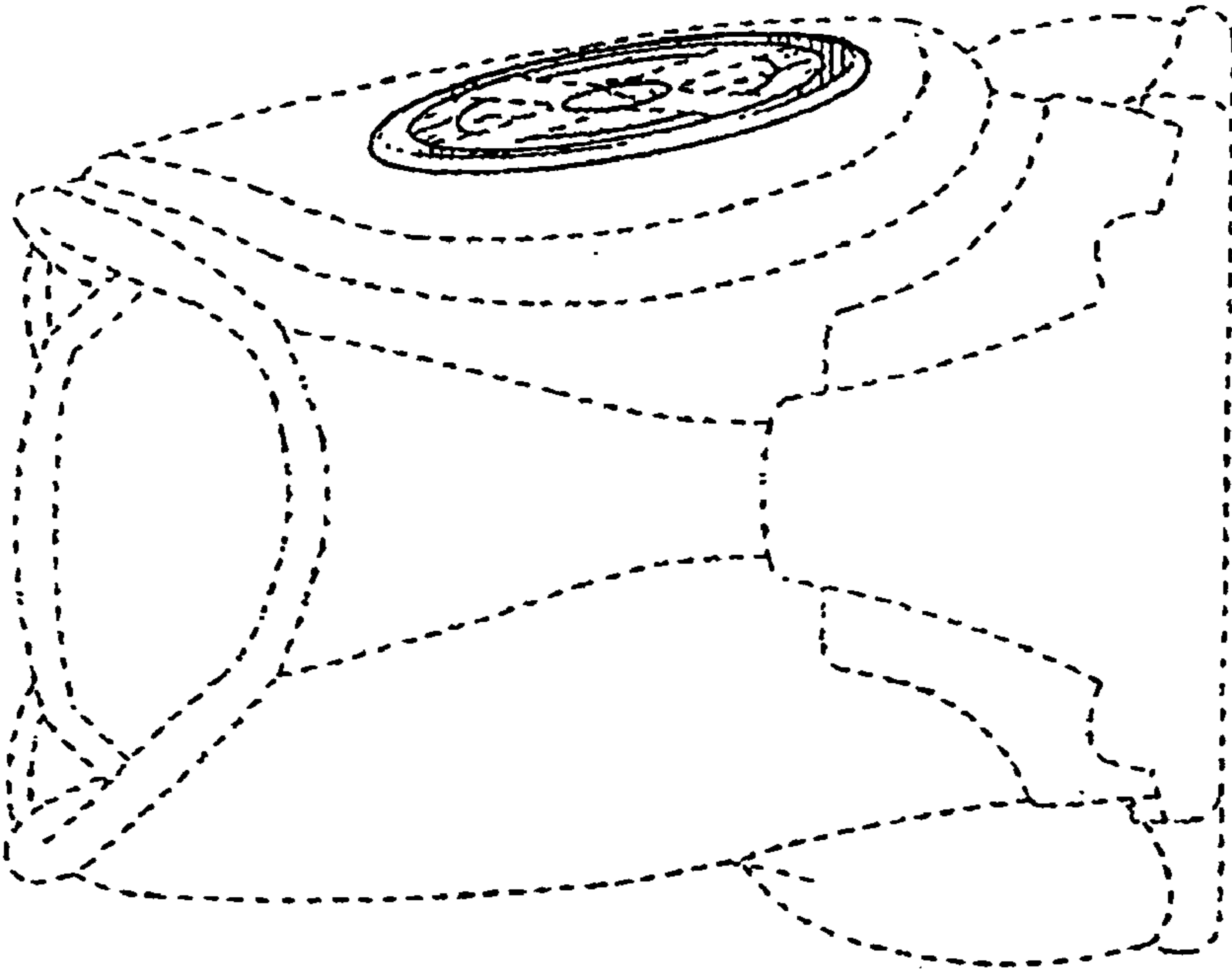
