DESCRIPTION

FIG. 10 is a bottom view of the alternative embodiment;

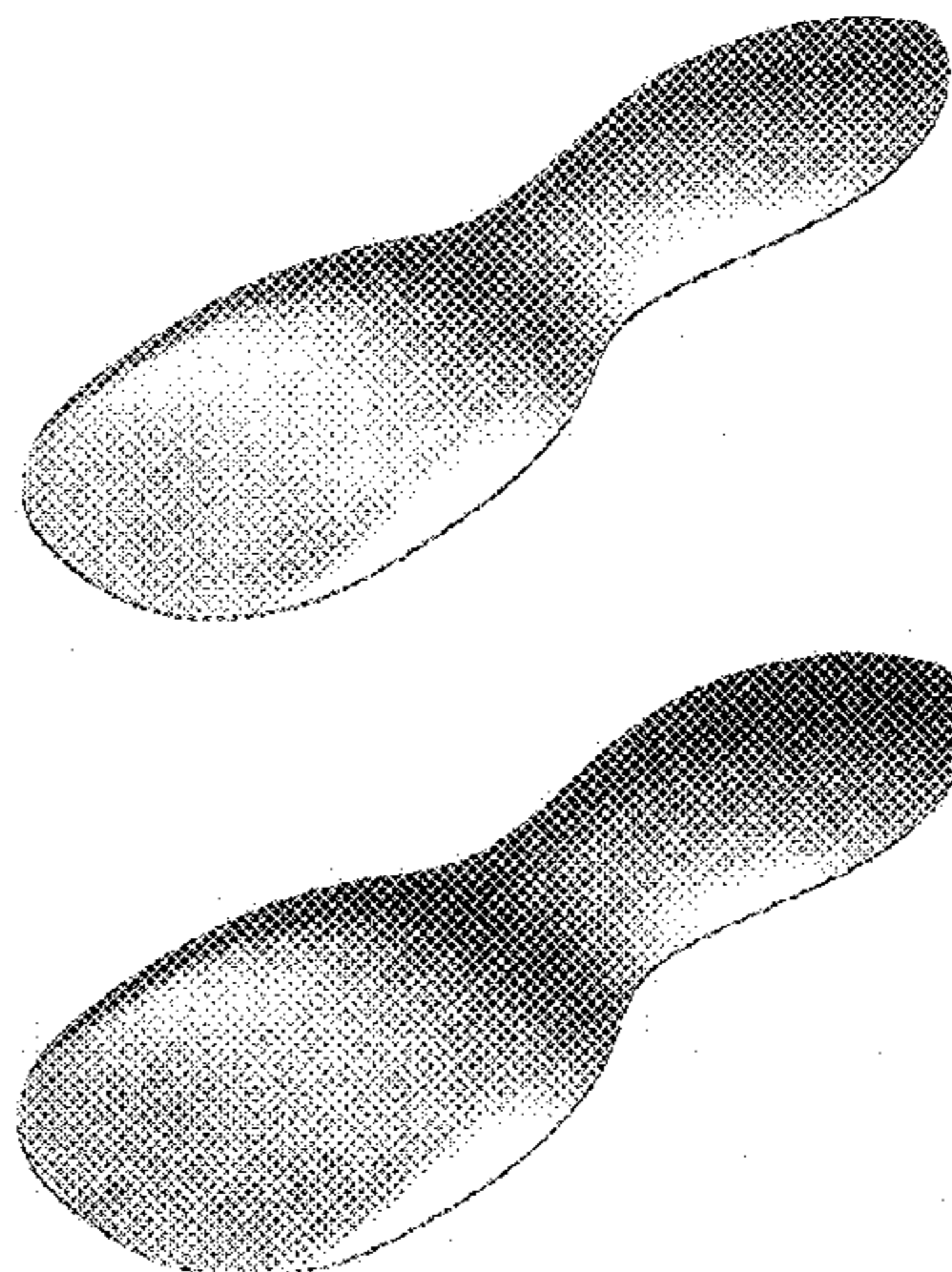
FIG. 11 is a right side elevational view of the alternative embodiment;

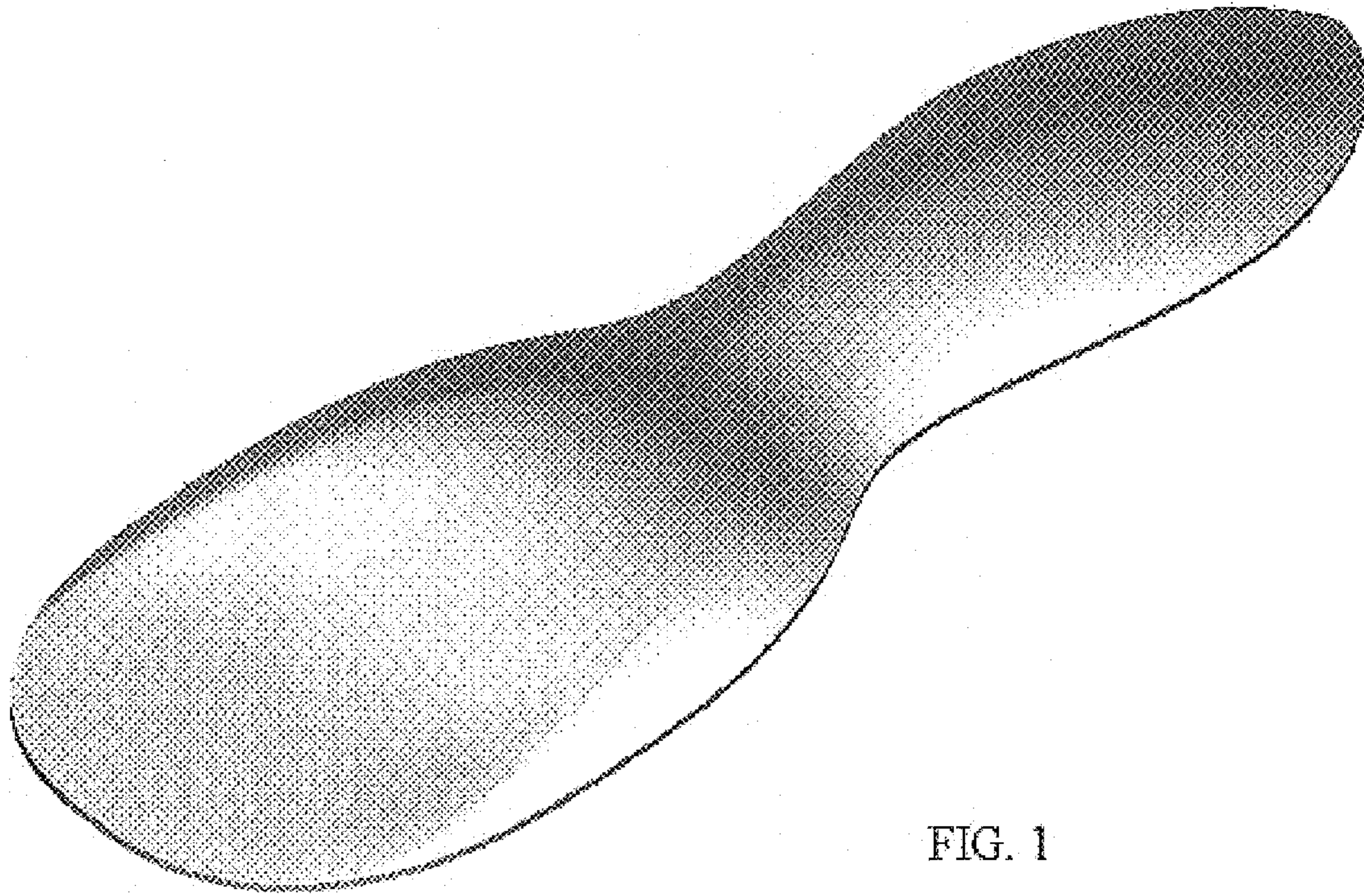

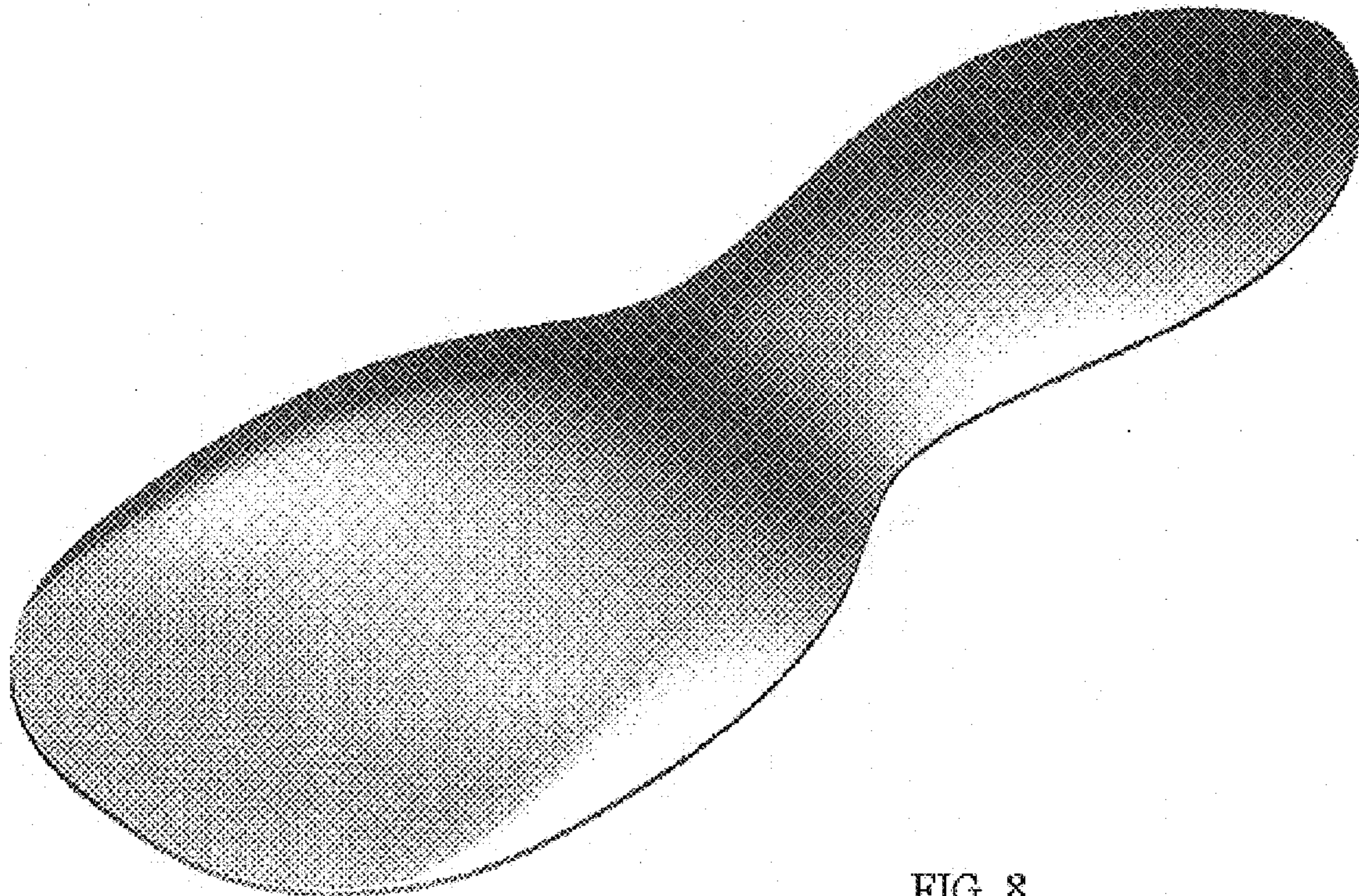

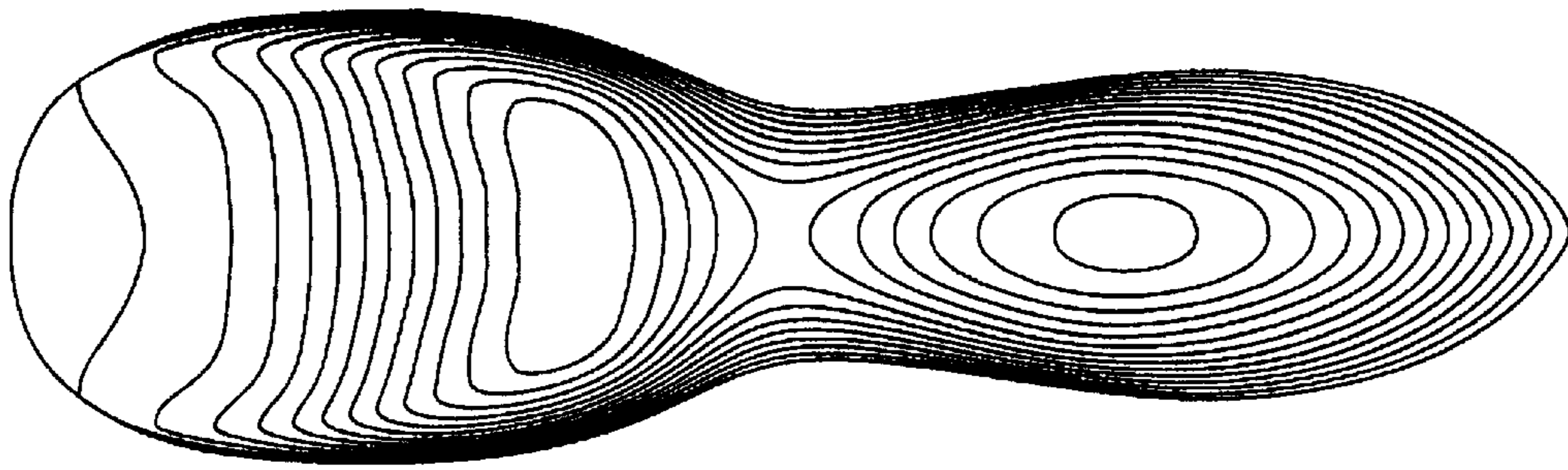

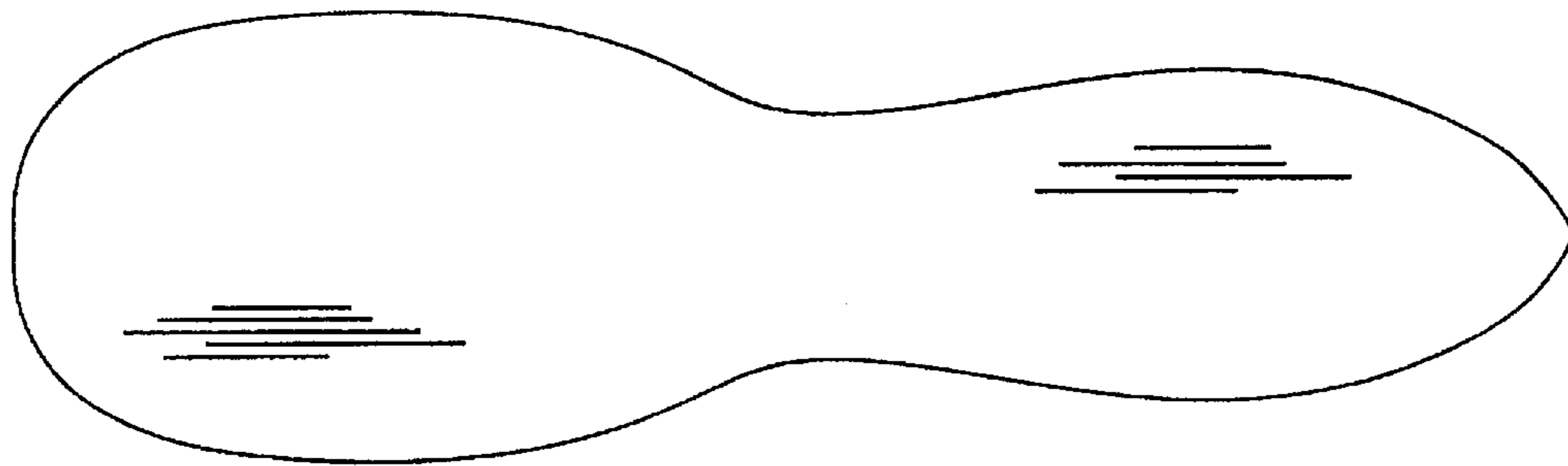

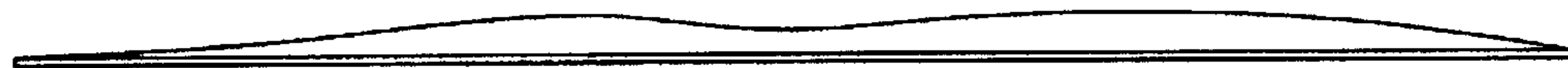

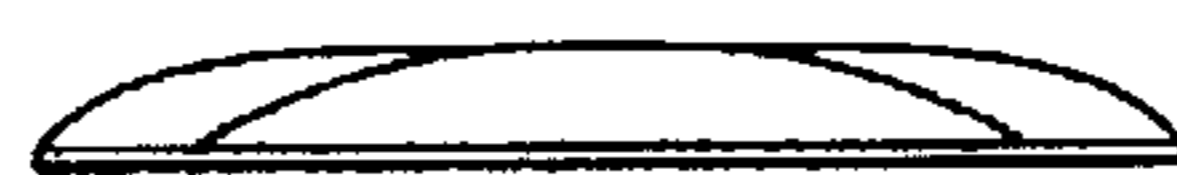

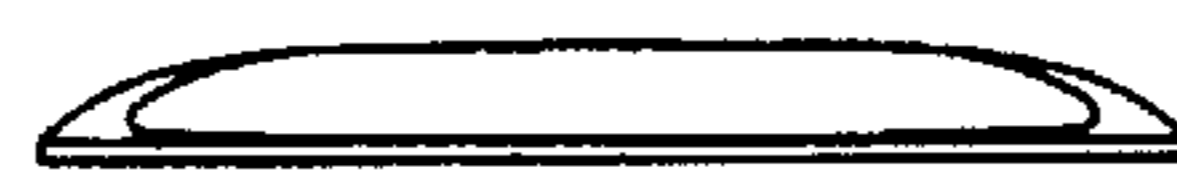

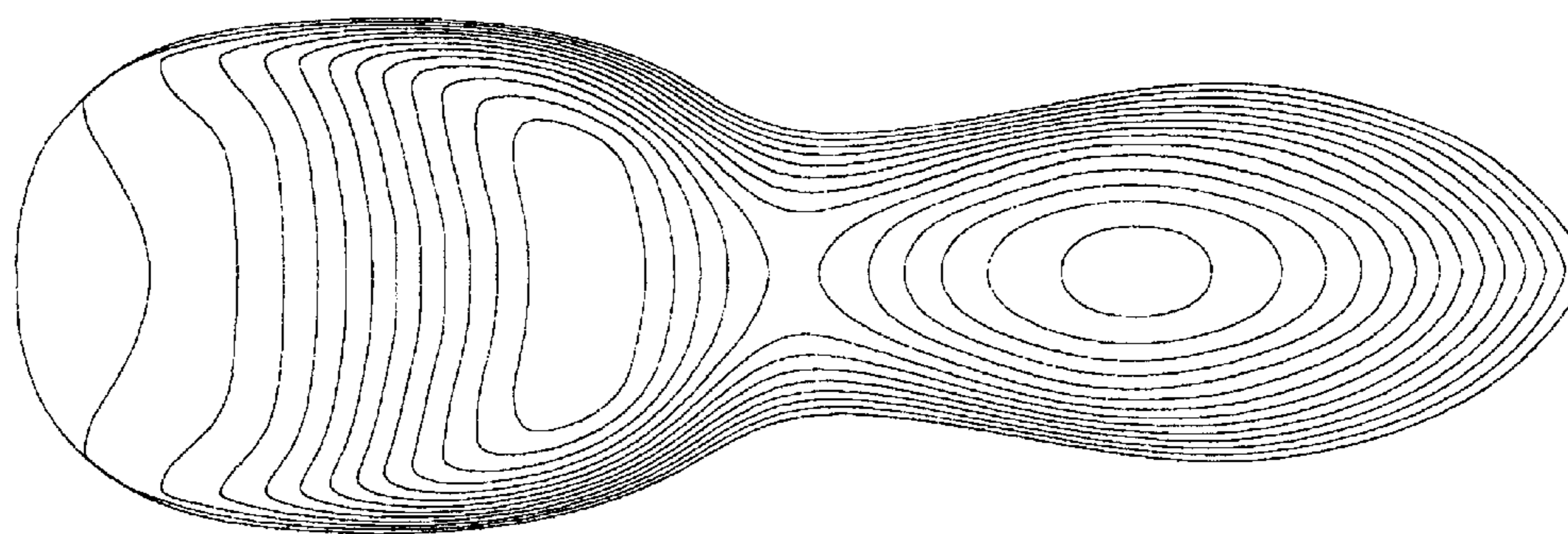

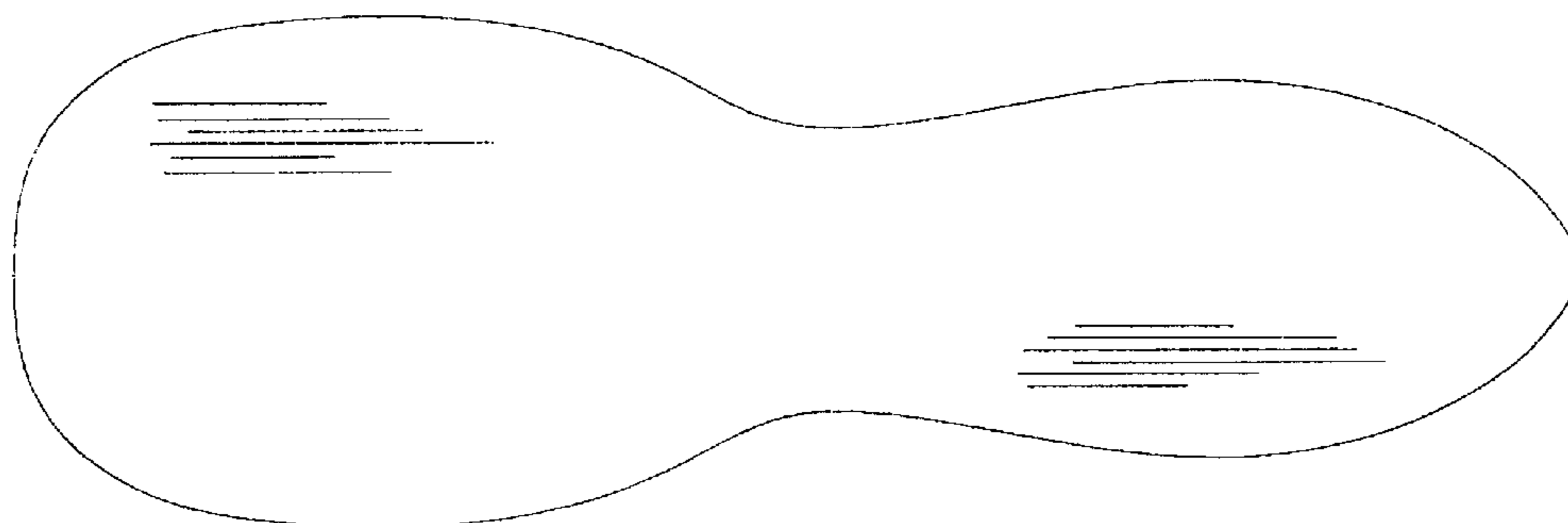

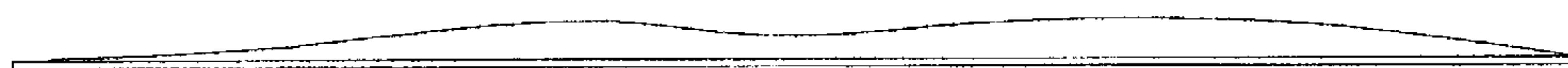

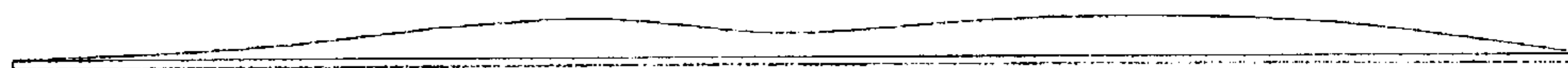

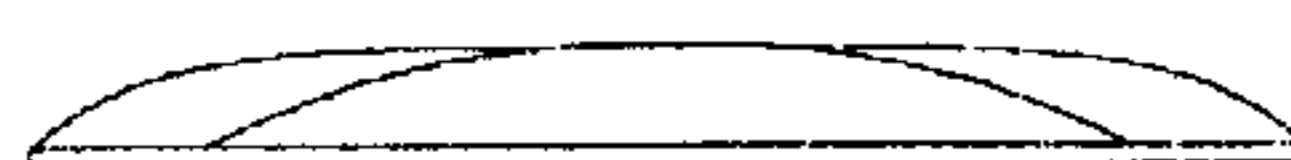
