(57) **CLAIM**

The ornamental design for a handbag (torquay hand stitch), as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a handbag (torquay hand stitch) showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a right side elevational view, the left side being a mirror image thereof; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof.

The broken line showing of the bag stands on the bottom of the handbag is for illustrative purposes only and forms no part of the claimed design.

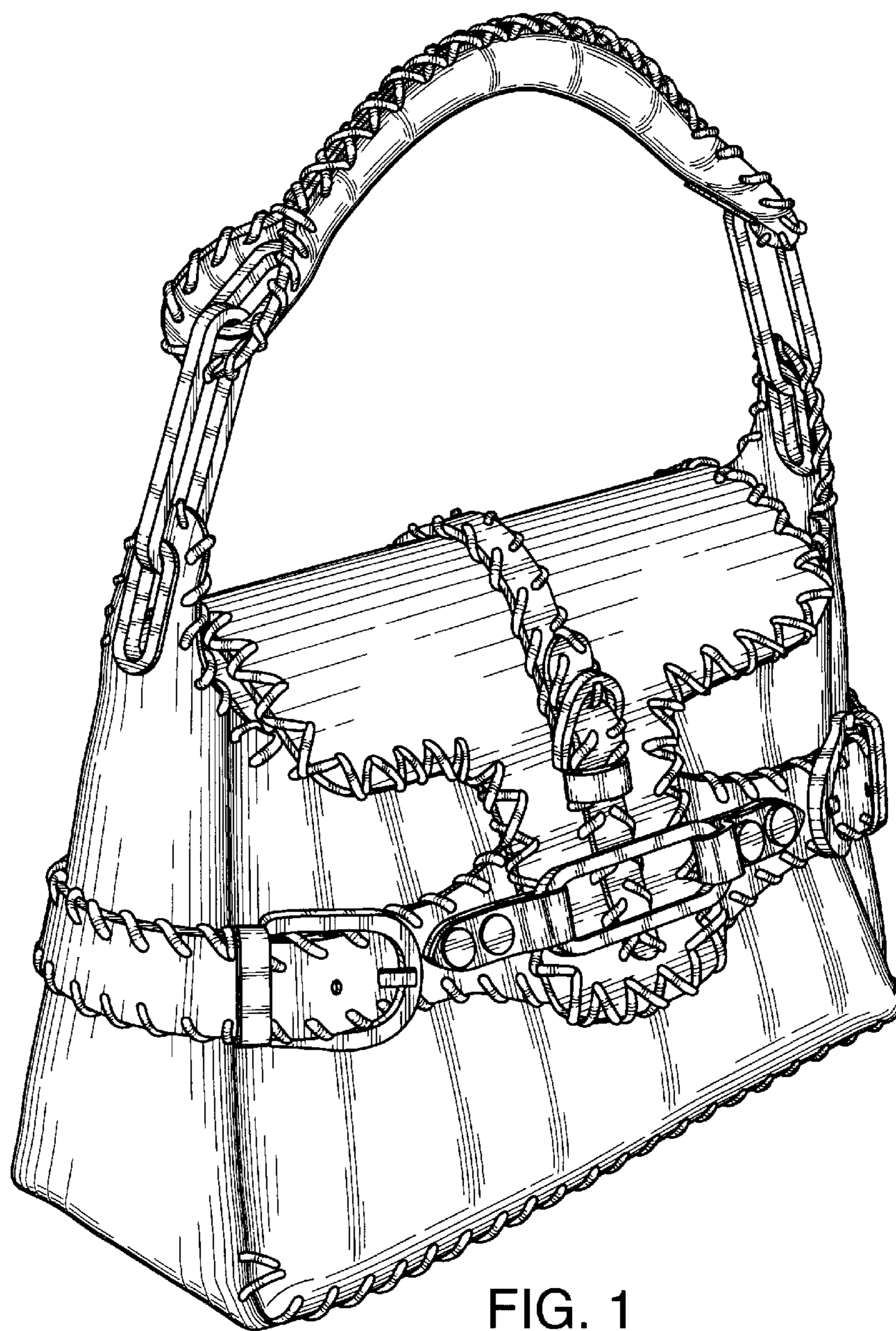

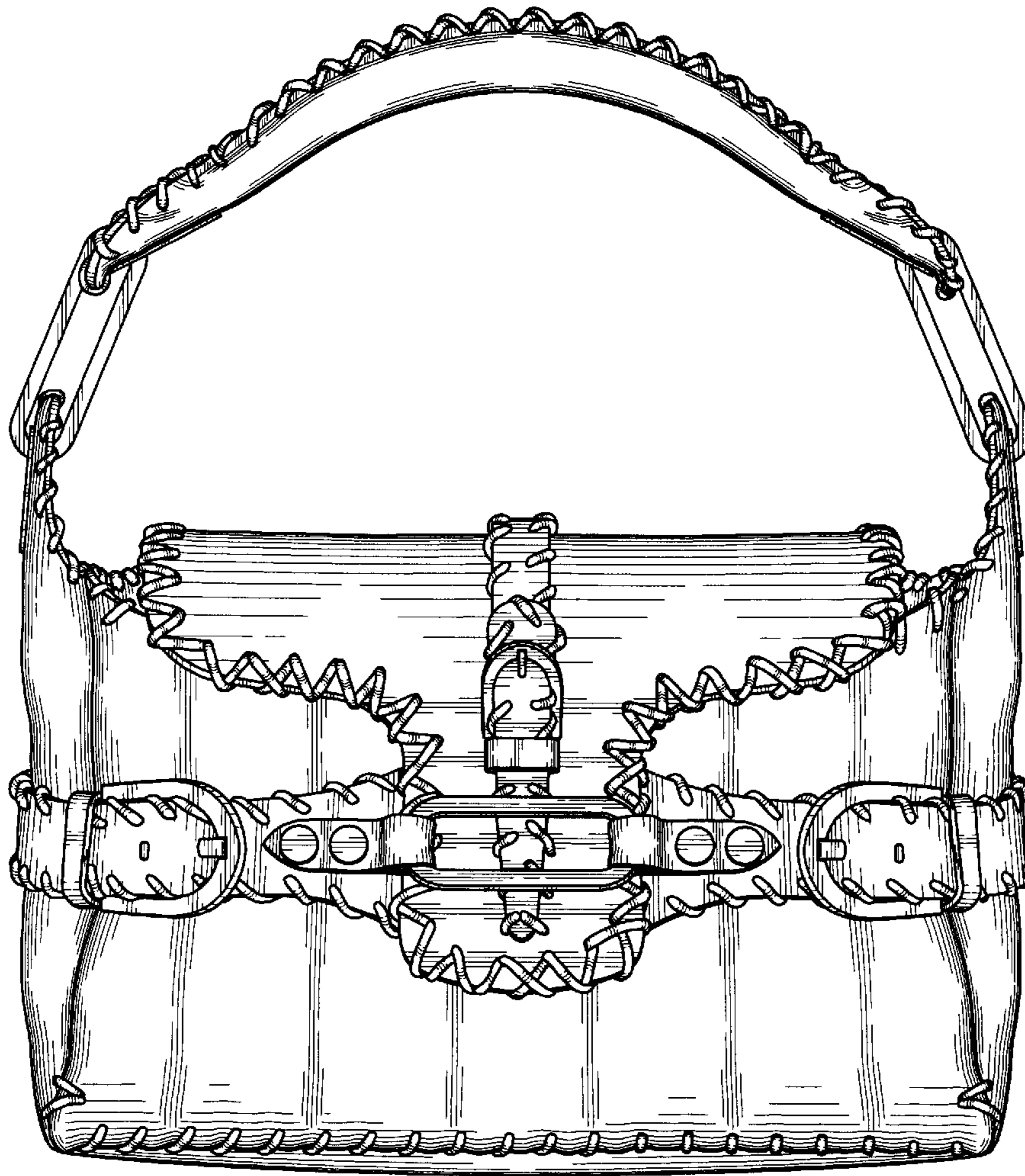

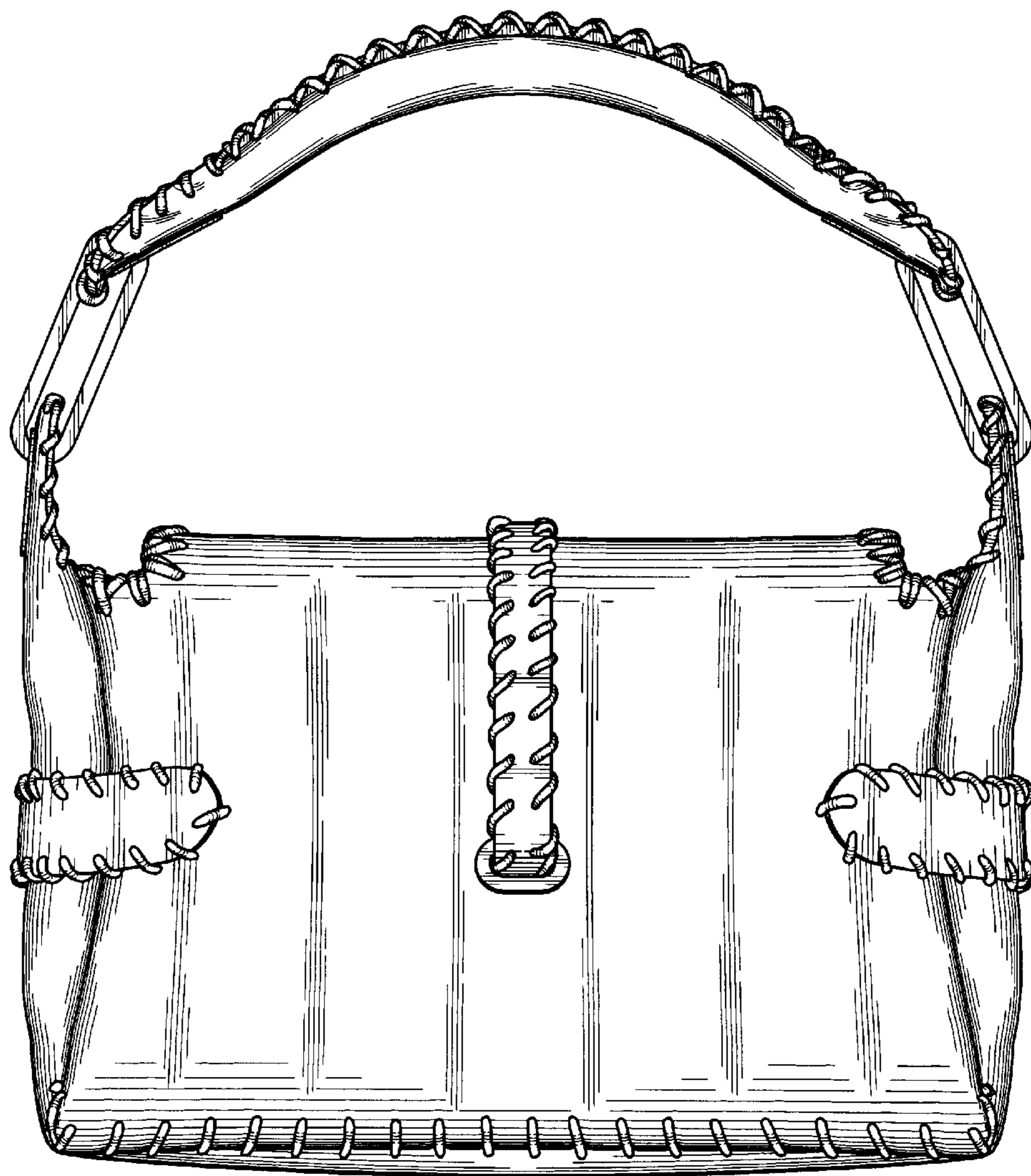

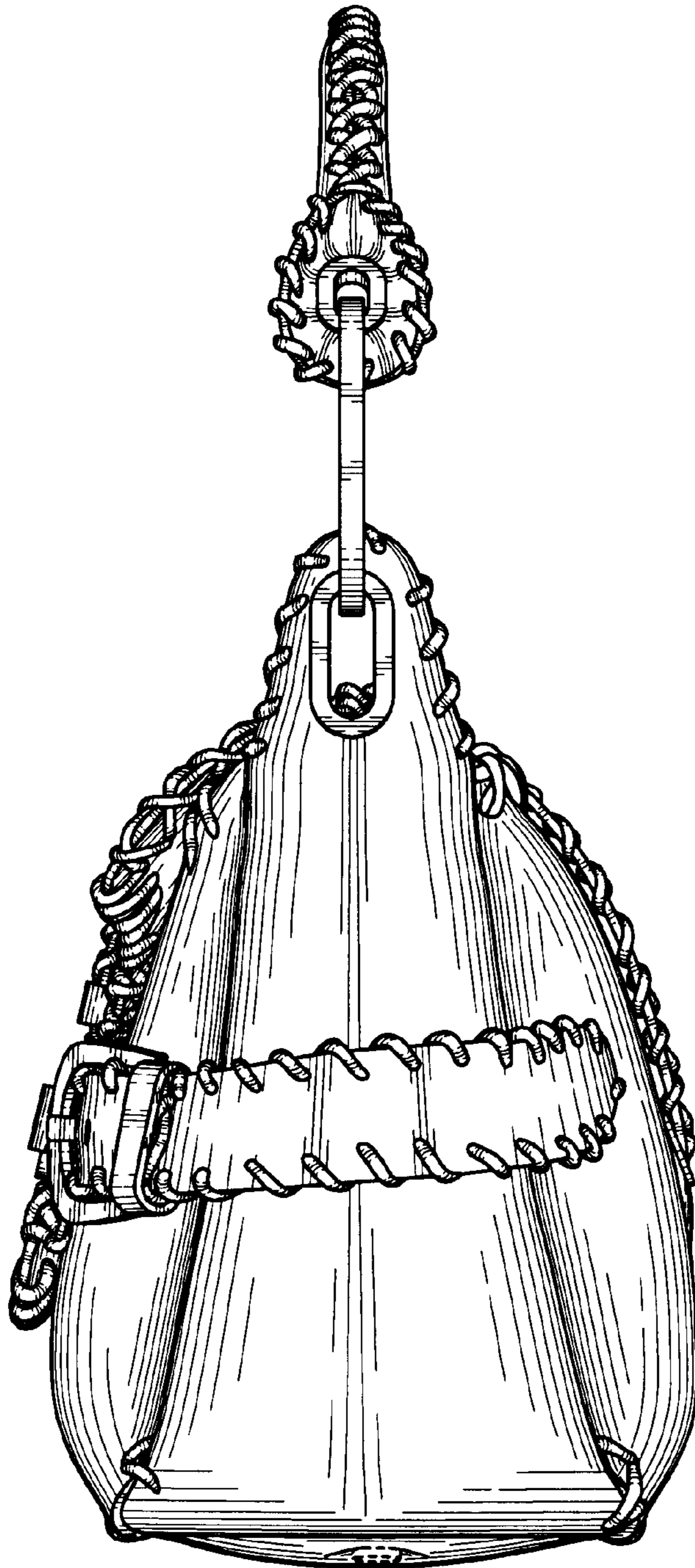

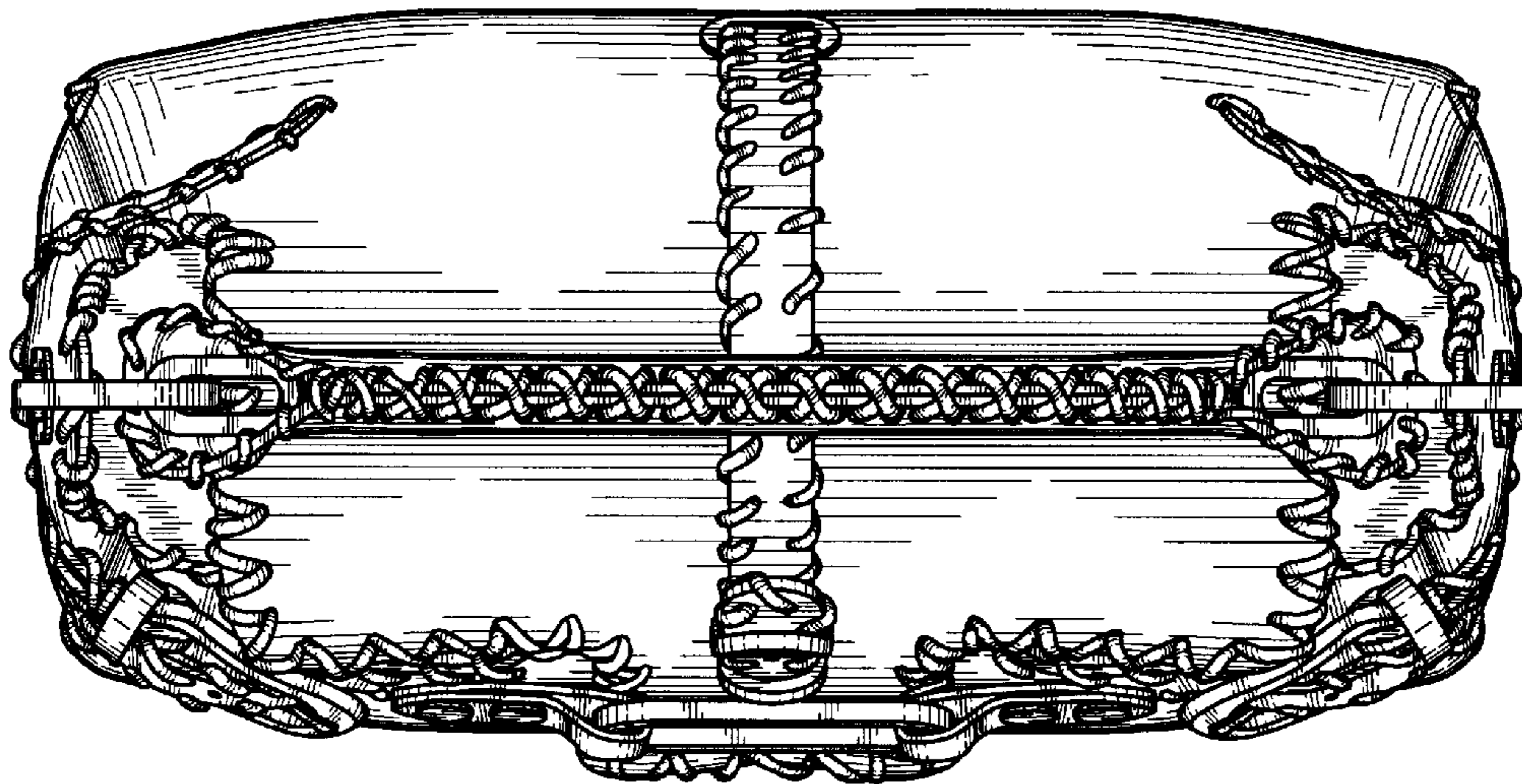

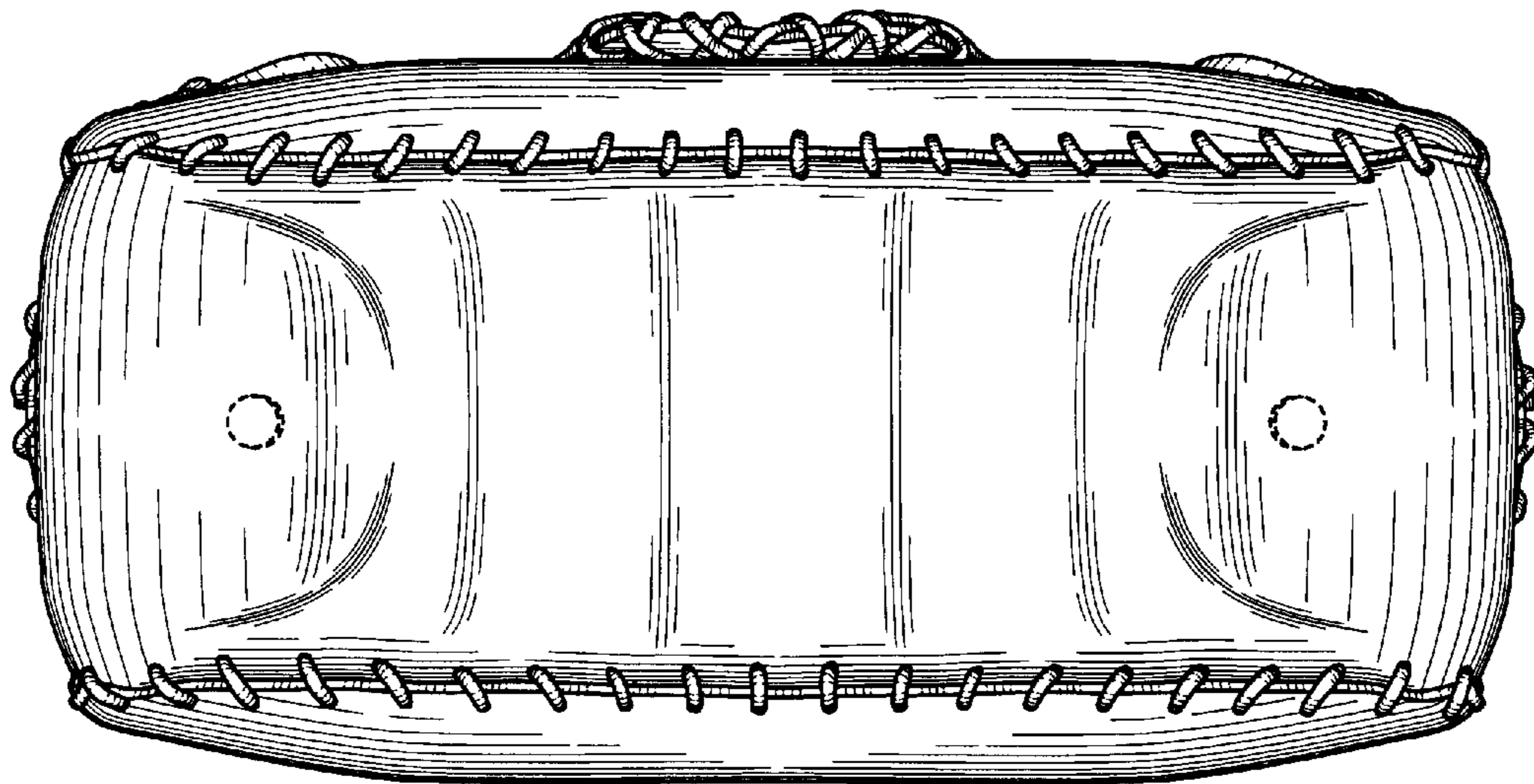
