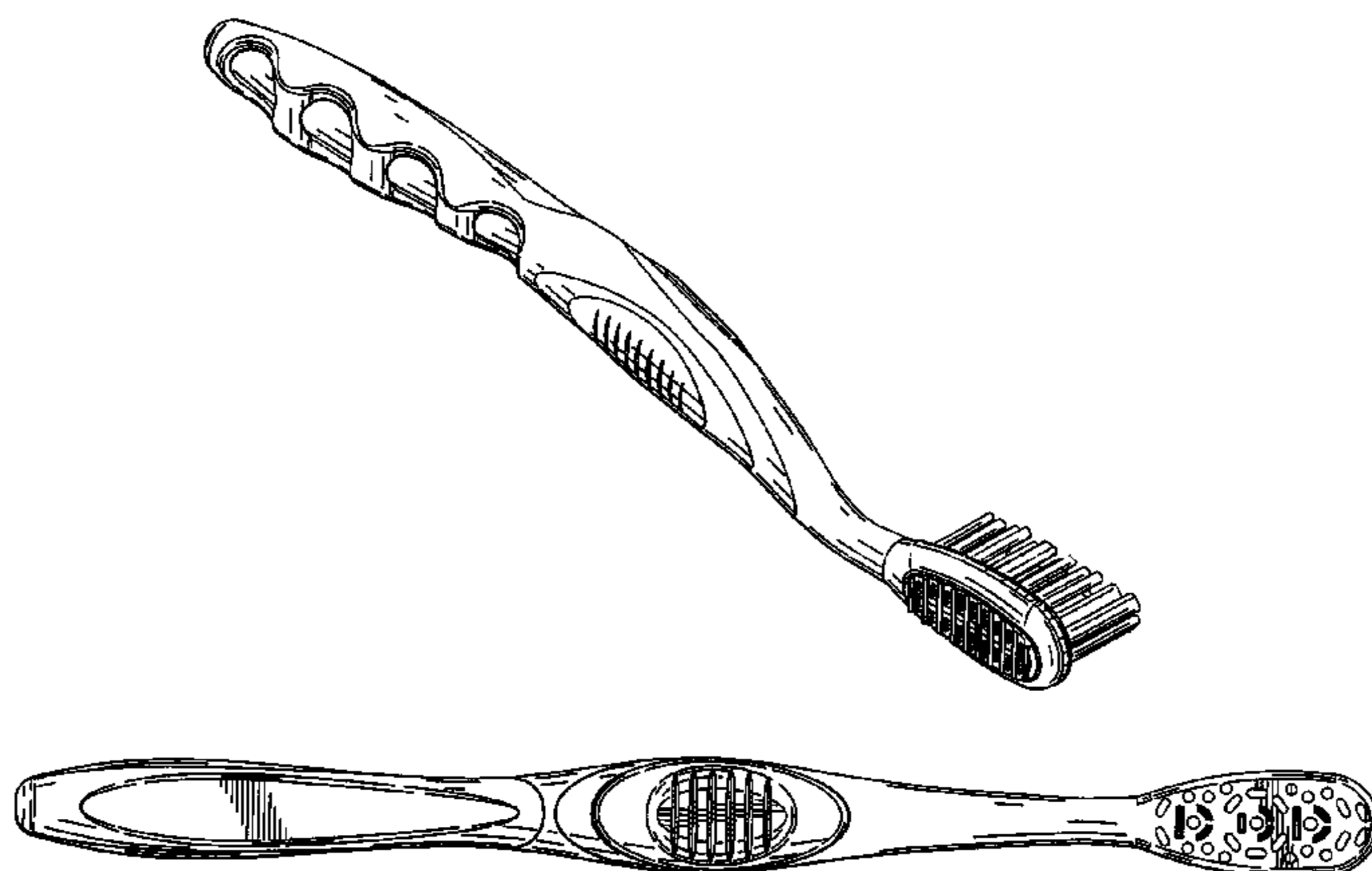
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a bottom perspective view of the toothbrush embodying the new design;

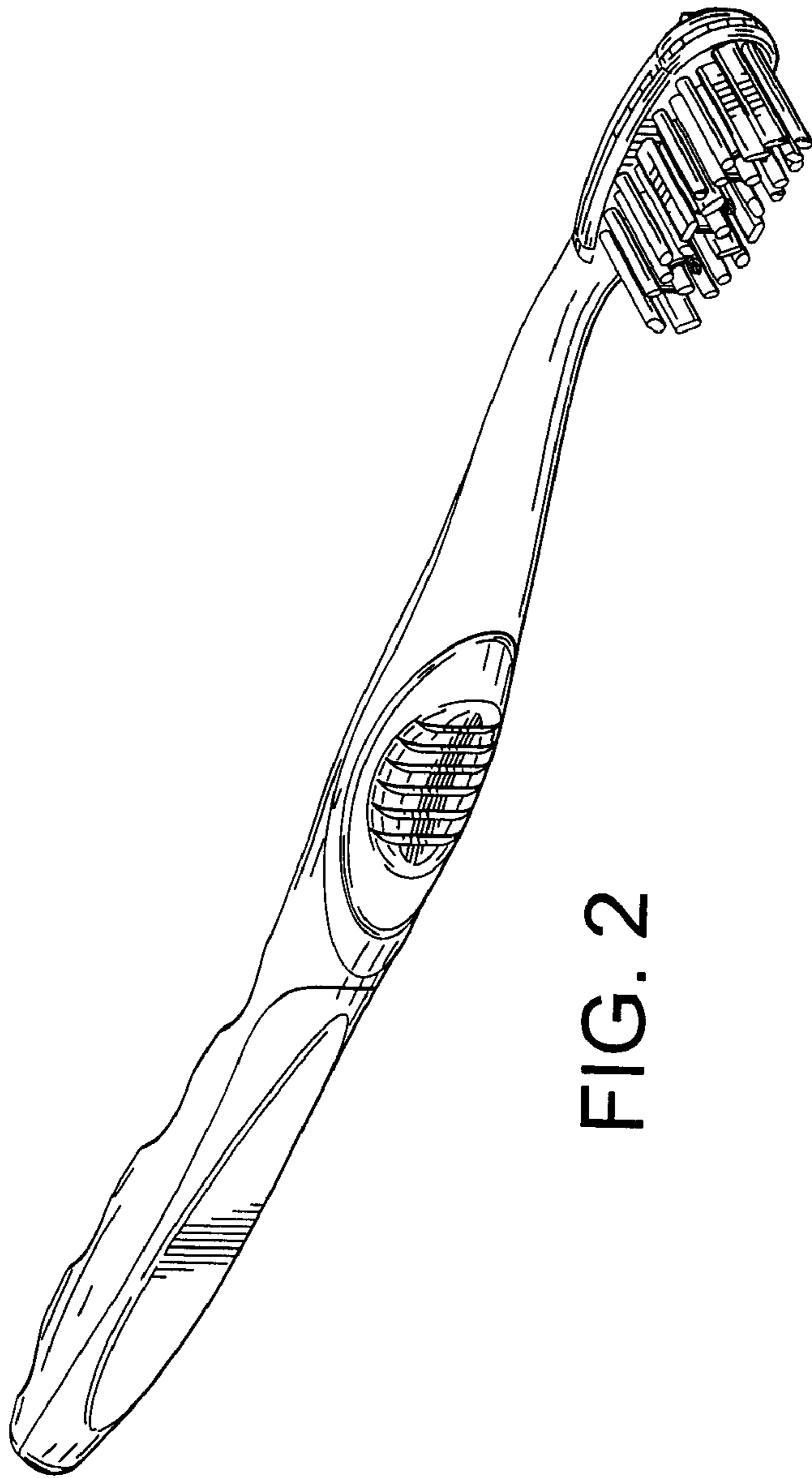

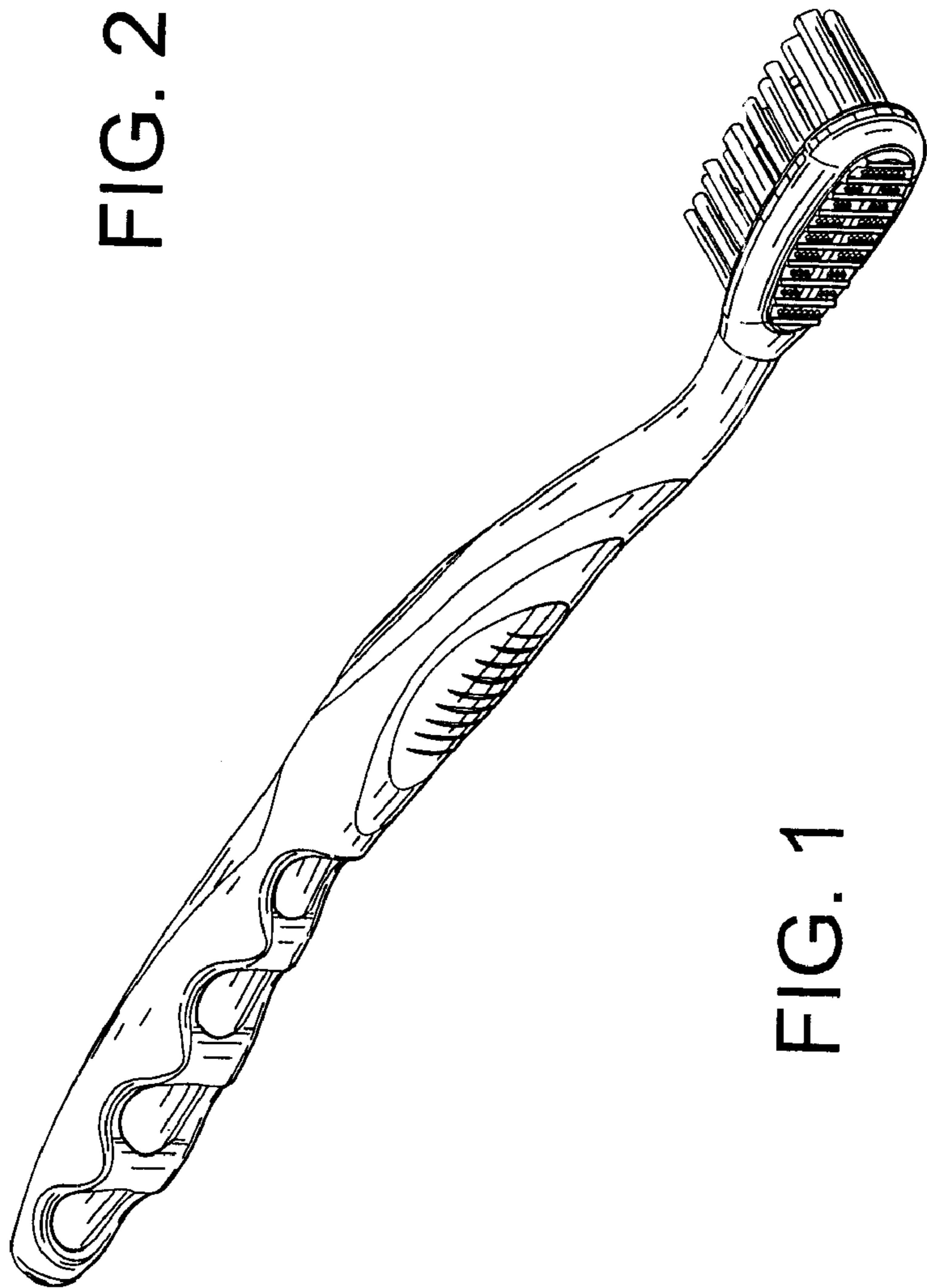

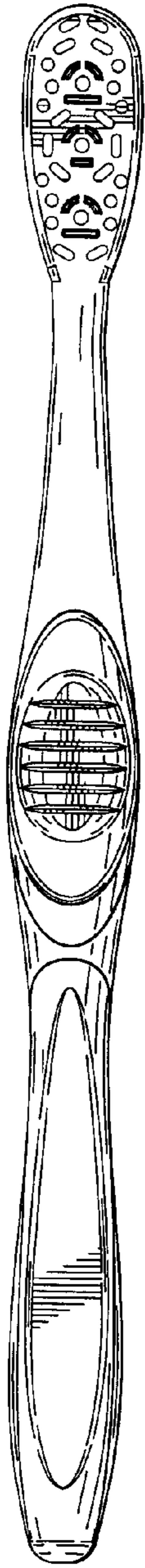

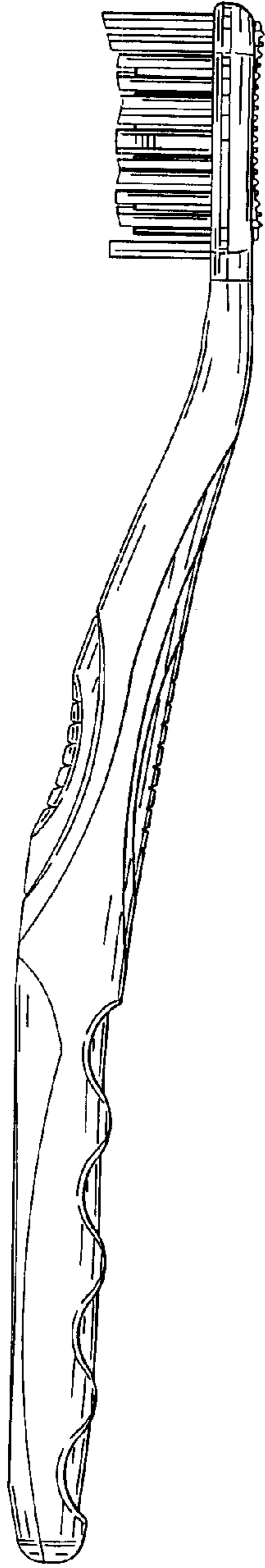

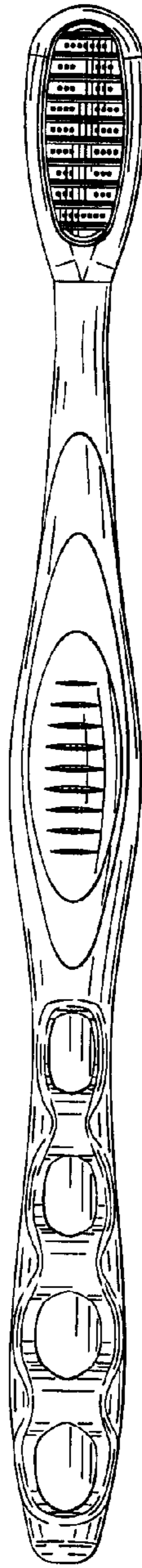

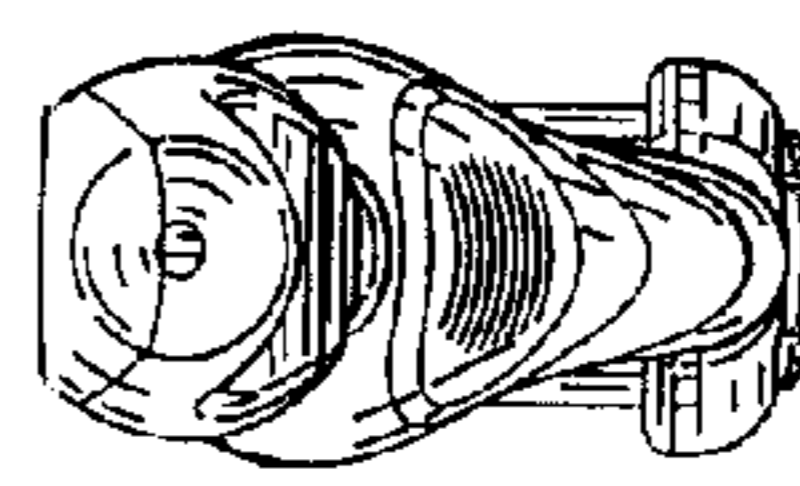

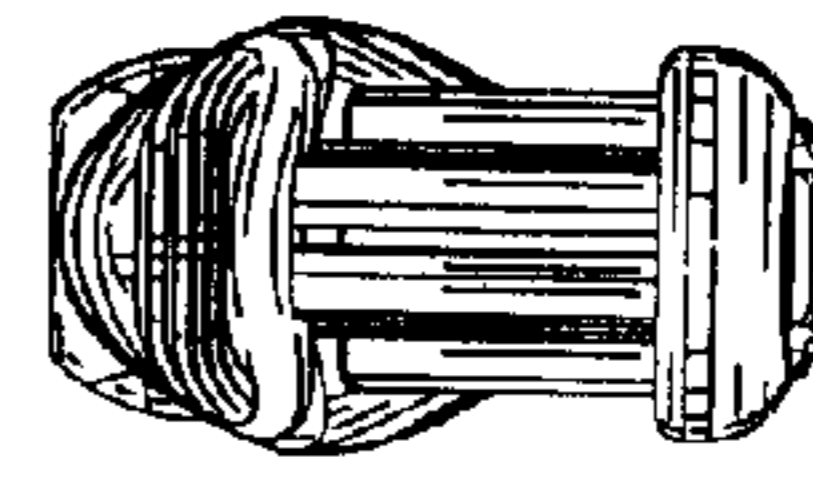
