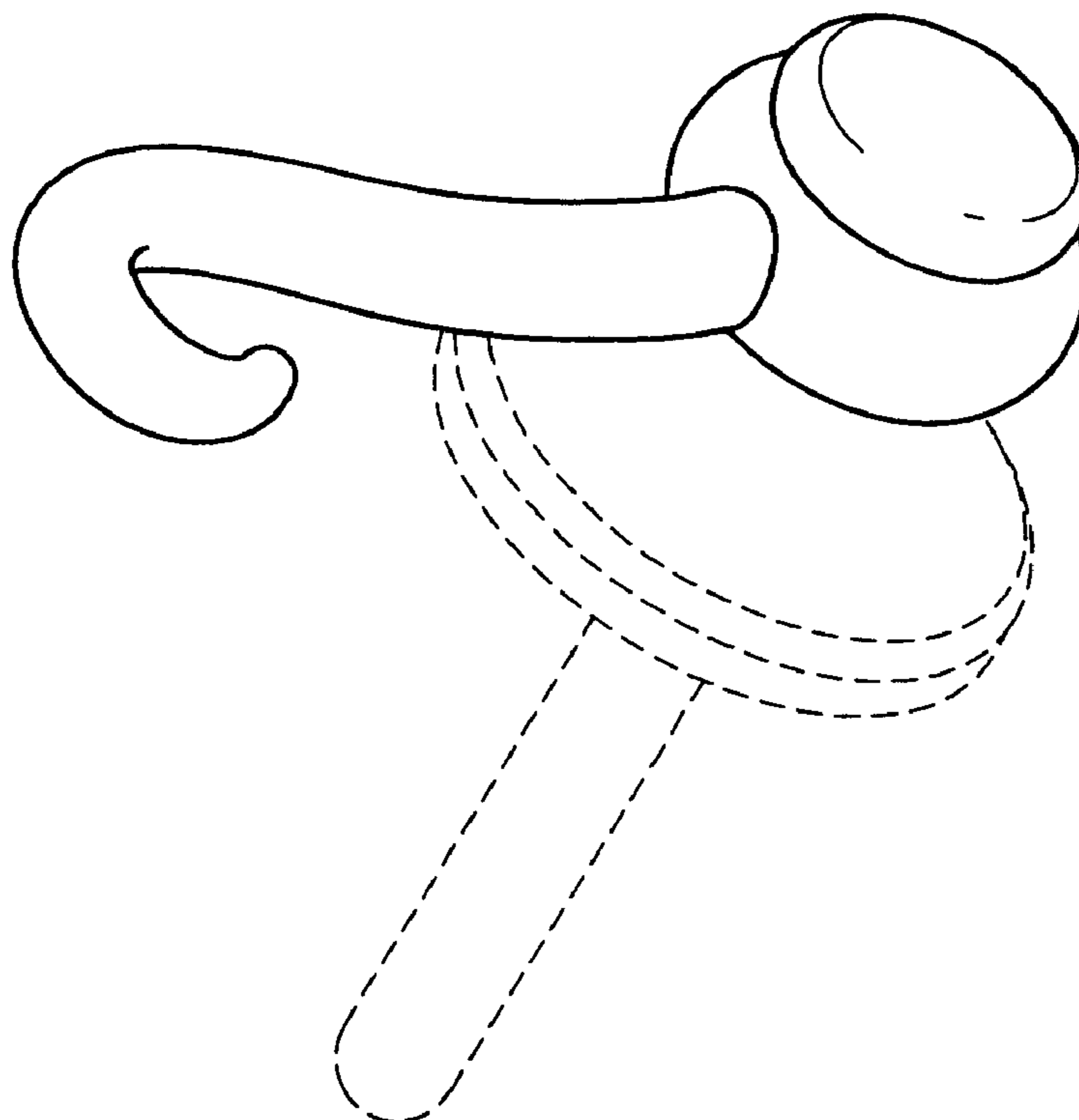
(57) **CLAIM**

The ornamental design for a lever, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a lever of the new design; FIG. 2 is a front elevational view of the lever of FIG. 1; FIG. 3 is a right side elevational view of the lever of FIG. 1; FIG. 4 is a bottom plan view of the lever of FIG. 1; FIG. 5 is a top plan view of the lever of FIG. 1; FIG. 6 is a rear elevational view of the lever of FIG. 1; and, FIG. 7 is a left side elevational view of the lever of FIG. 1. The portions of the Figures shown in broken lines are not part of the claimed design but are for illustration only.

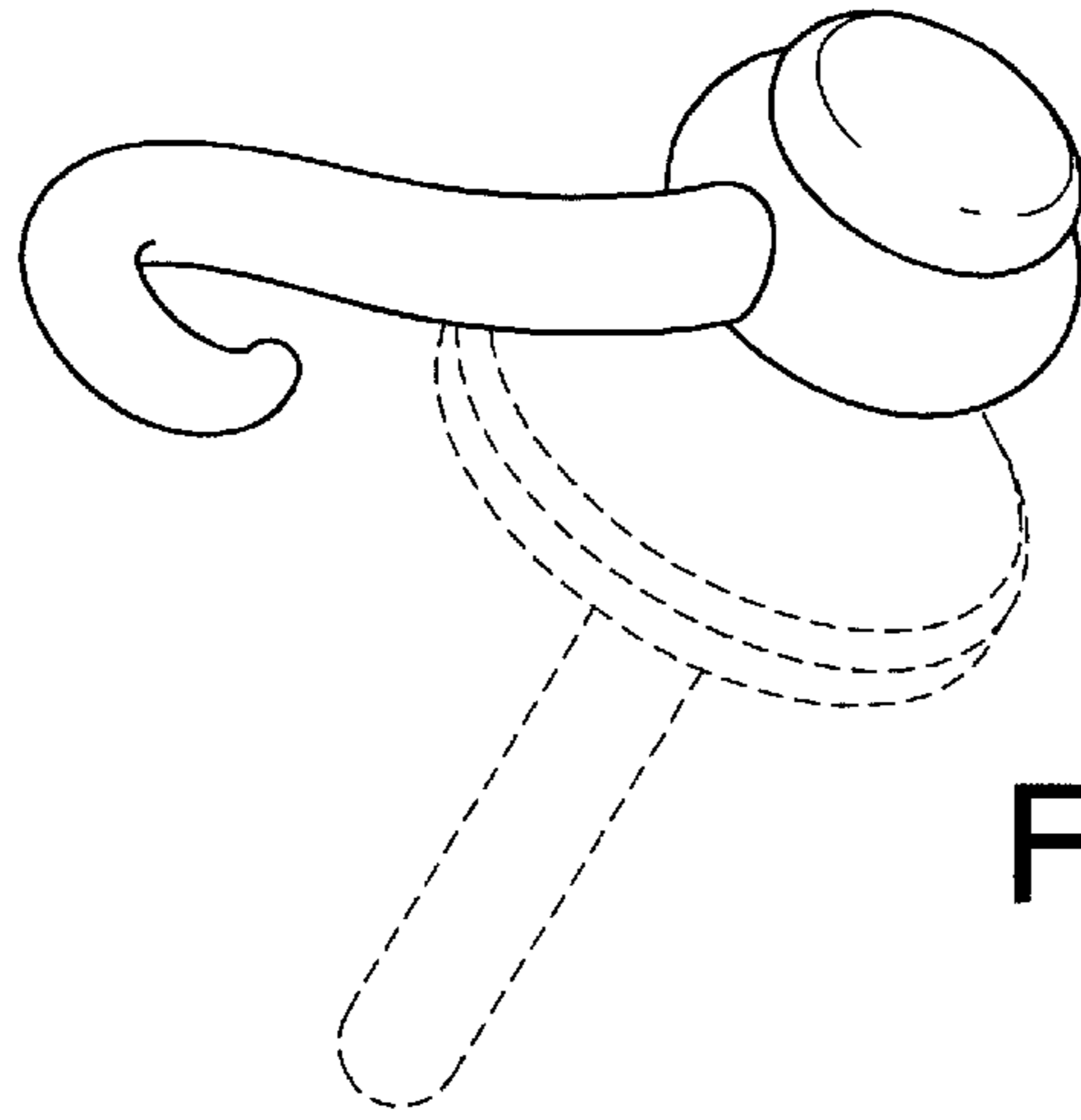

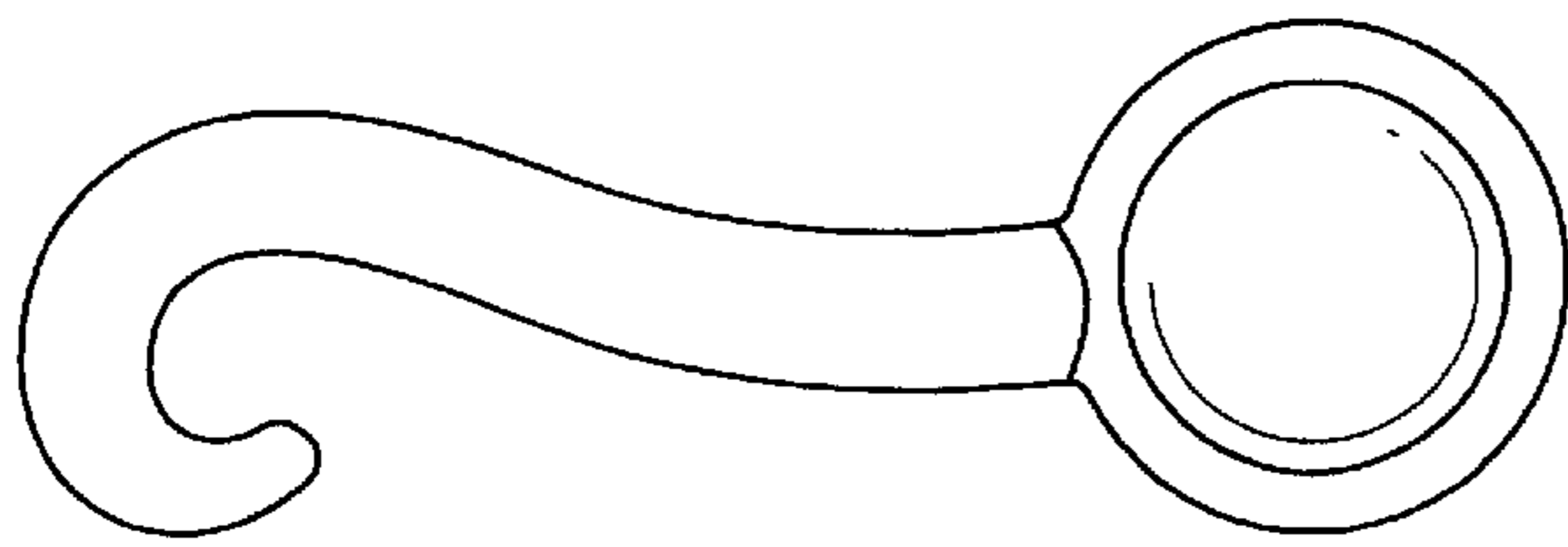

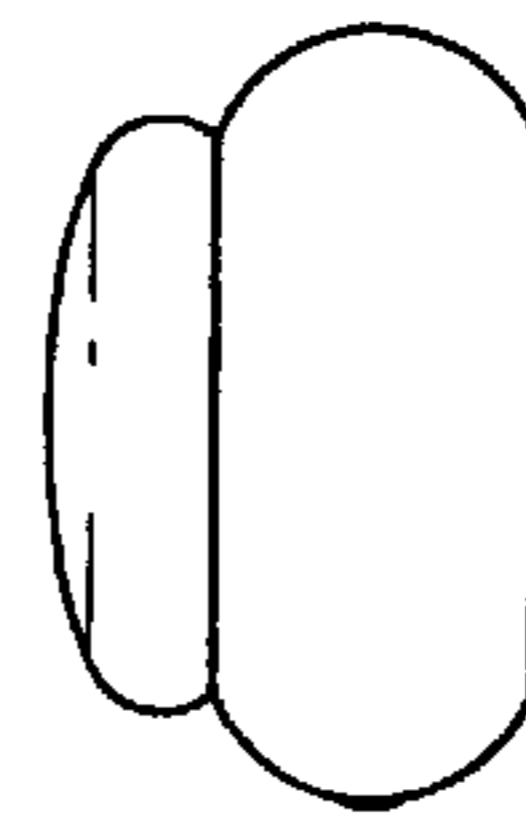

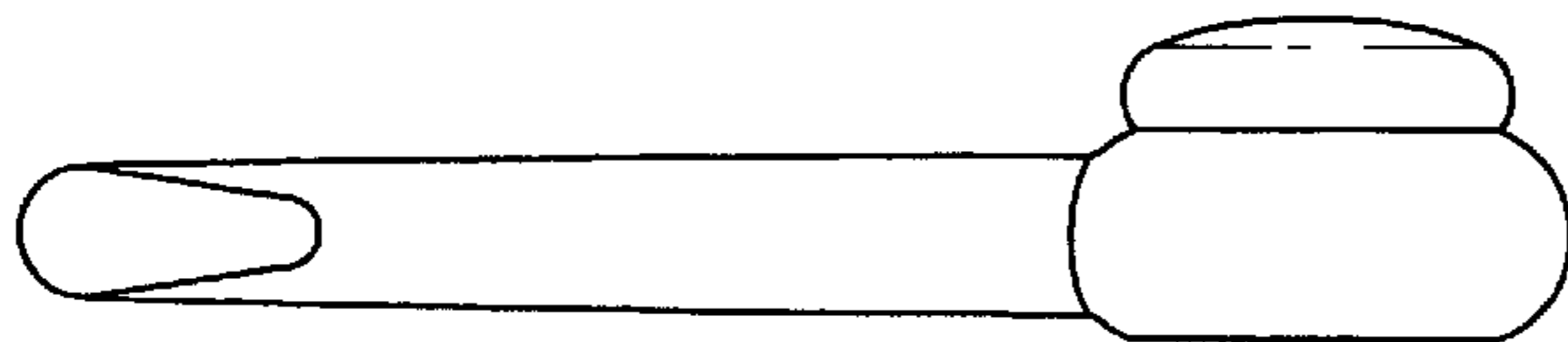

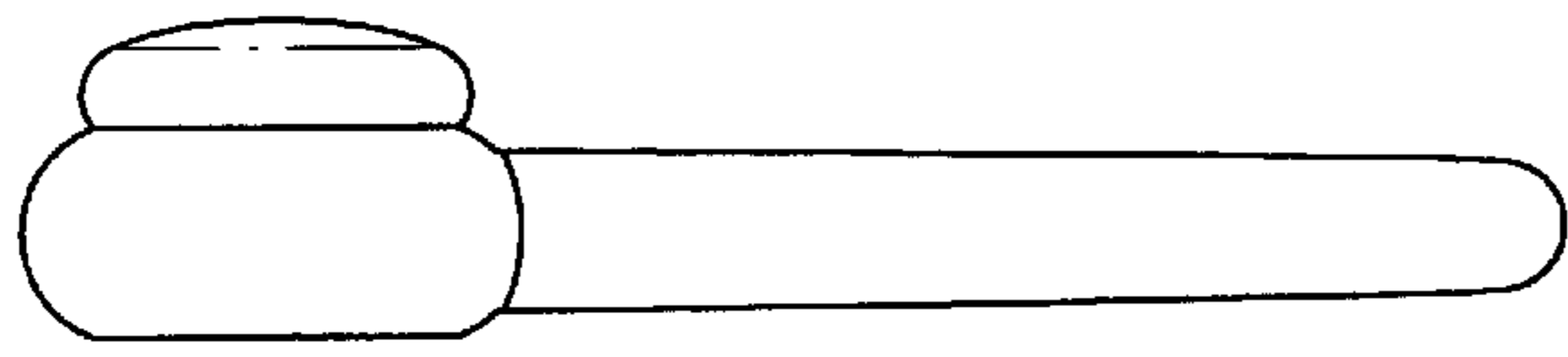

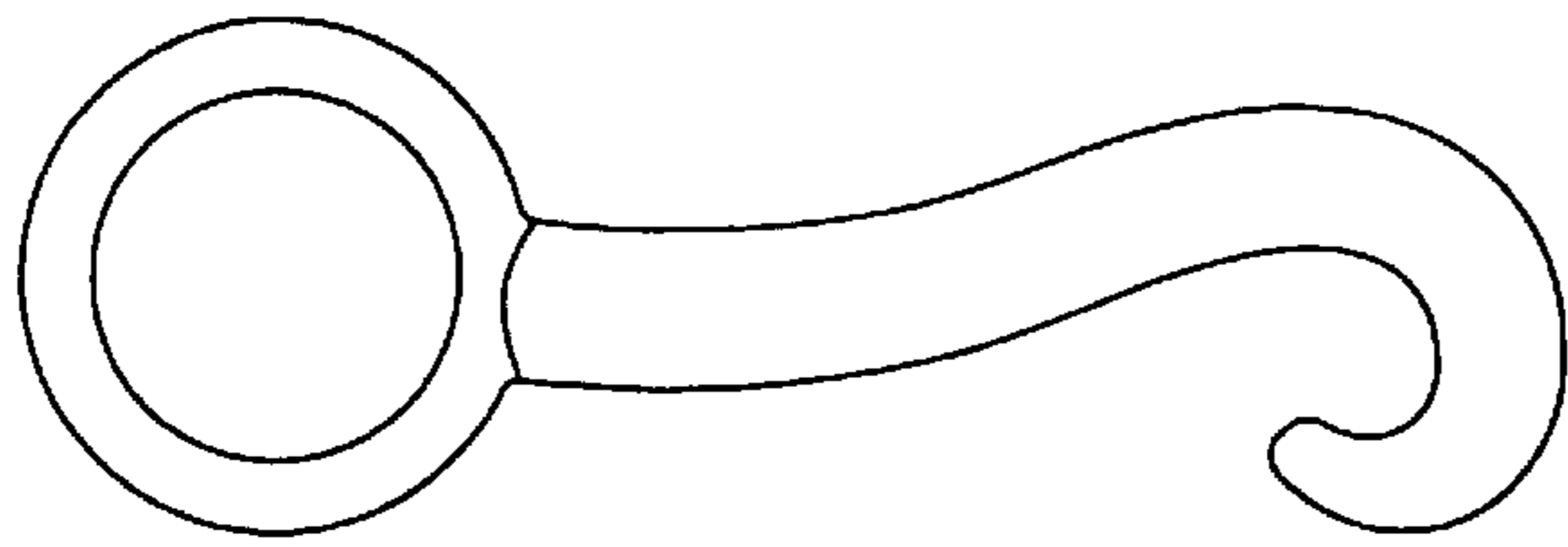

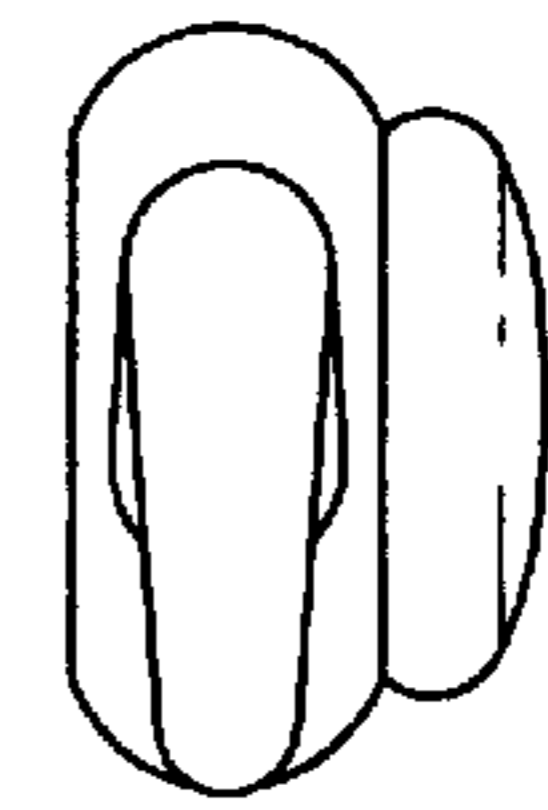
