DESCRIPTION

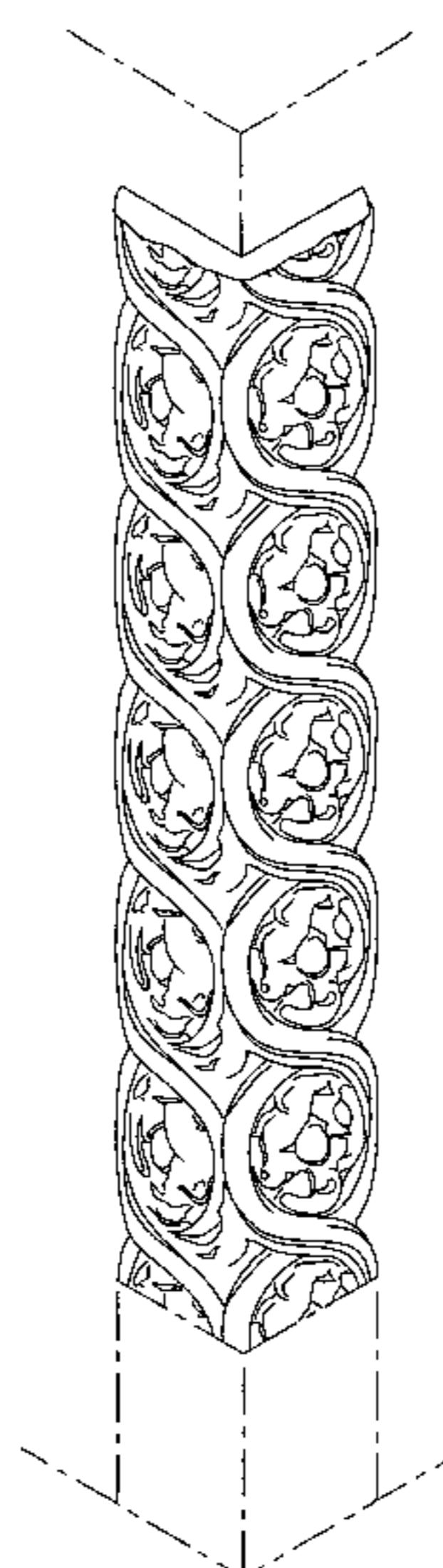
This application is related to U.S. Provisional patent application Ser. No. 60/664,174, entitled "Decorative Corner Guard," filed on Mar. 23, 2005.

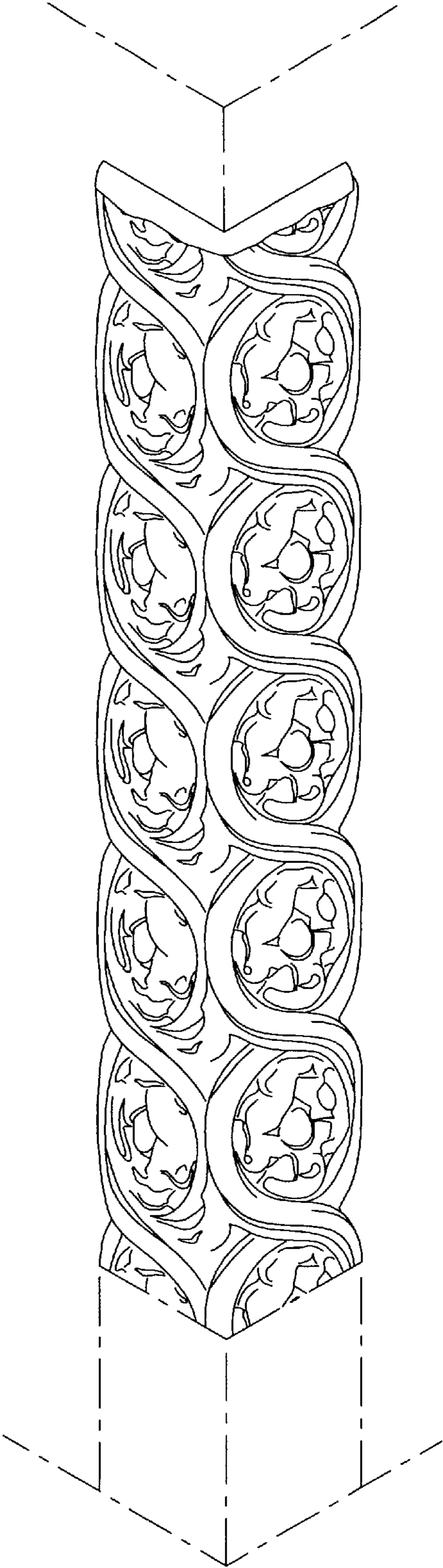

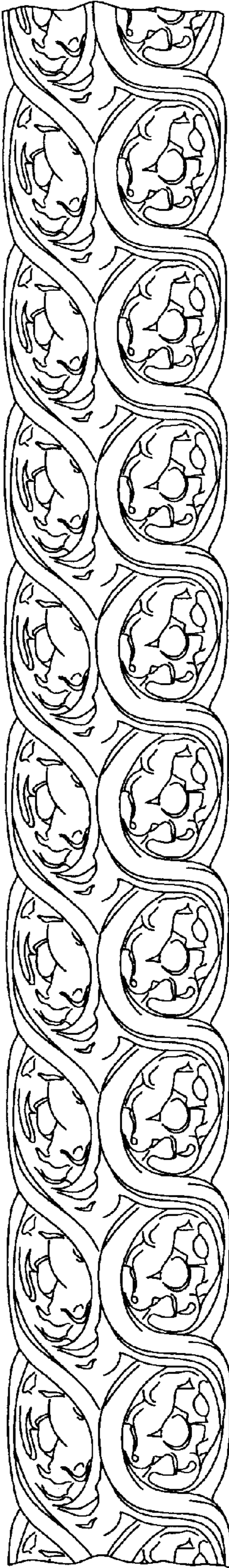
