(57) **CLAIM**

The ornamental design for surface ornamentation for containers, as shown and described.

DESCRIPTION

FIG. 1 is a plan view of the surface ornamentation of the design applied to the surfaces of a first box container;

FIG. 2 is a plan view of the surface ornamentation of the design applied to the surfaces of a second box container;

FIG. 3 is a plan view of the surface ornamentation of the design applied to the surfaces of a third box container;

FIG. 4 is a plan view of the surface ornamentation of the design applied to the surfaces of a box cover container;

FIG. 5 is a plan view of the surface ornamentation of the design applied to the surfaces of a tube container;

FIG. 6 is an elevational view of the surface ornamentation of the design applied to the surfaces of a first bottle container;

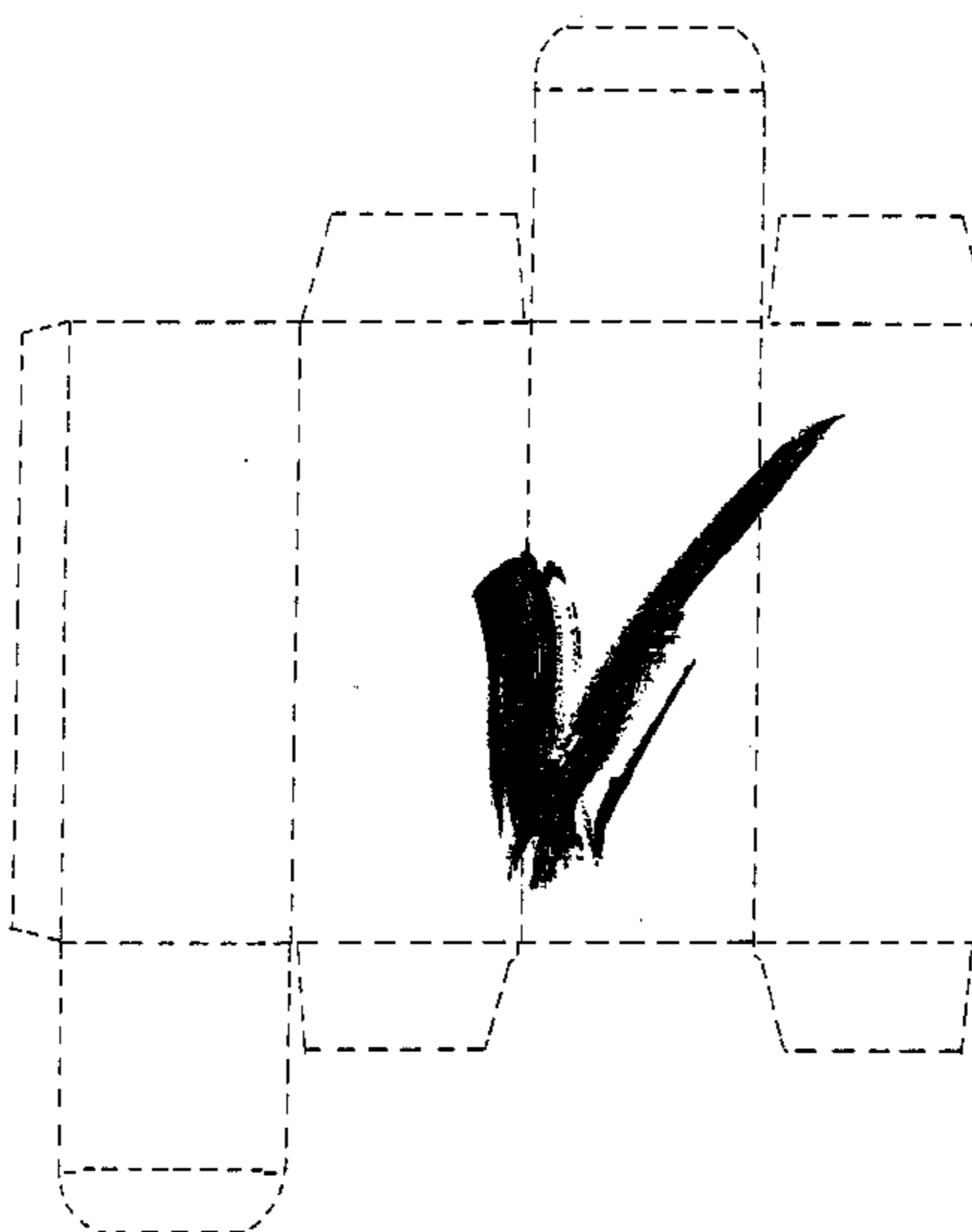
FIG. 7 is an elevational view of the surface ornamentation of the design applied to the surfaces of a second bottle container;

FIG. 8 is an elevational view of the surface ornamentation of the design applied to the surfaces of a third bottle container; and,

FIG. 9 is an elevational view of the surface ornamentation of the design applied to the surfaces of a spray container.

The containers are shown in broken lines for illustrative purposes only and form no part of the claimed design.

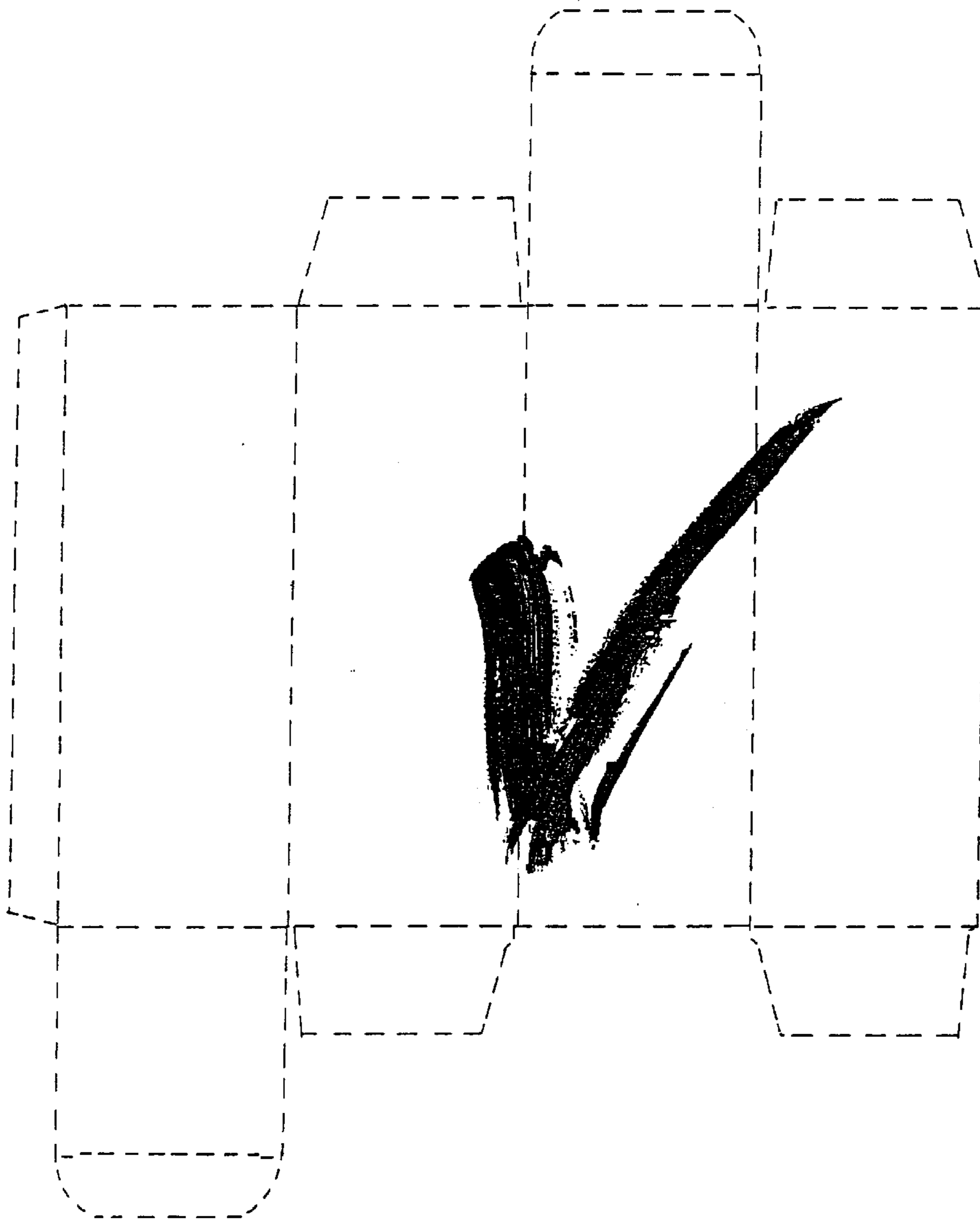

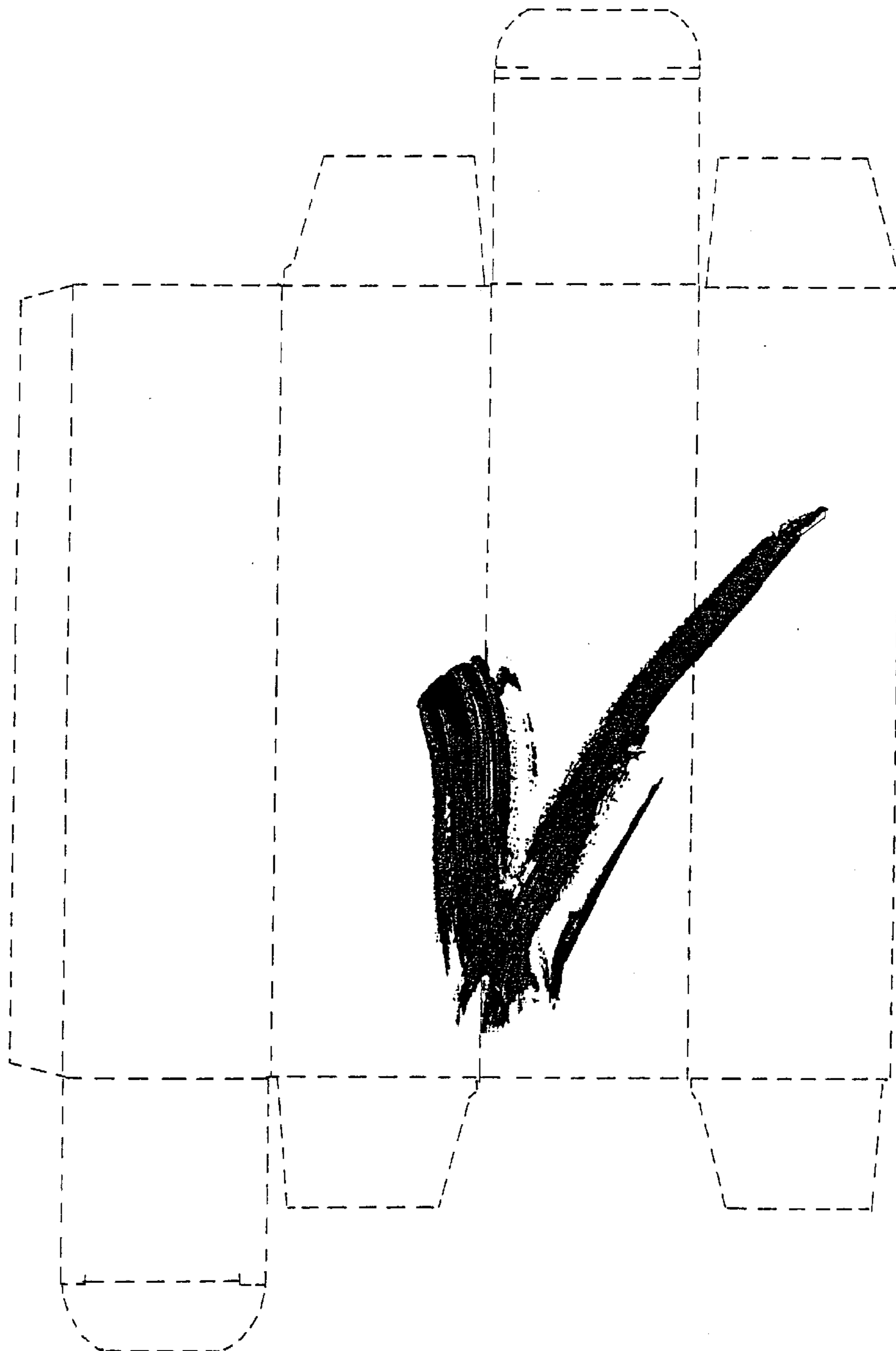

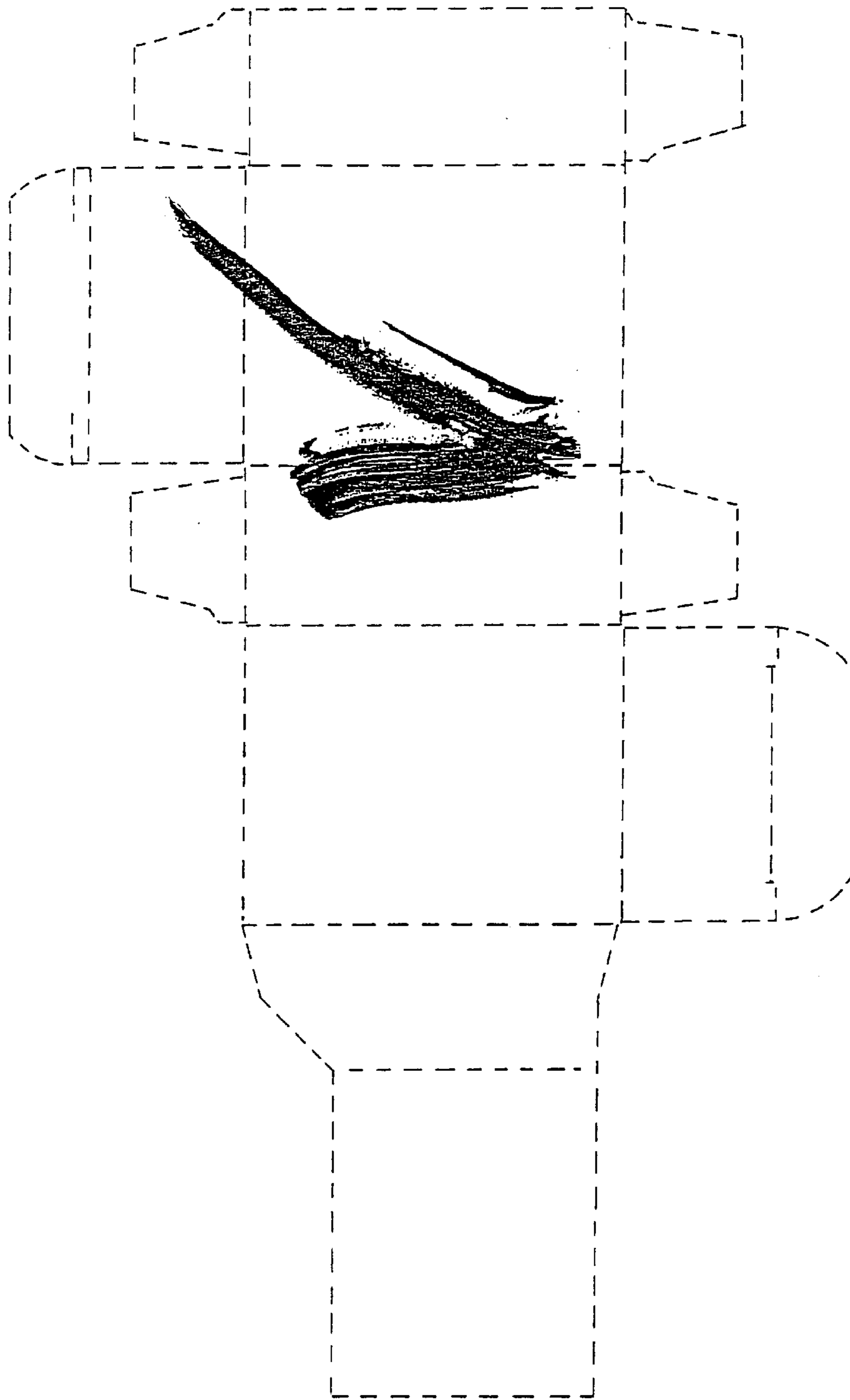

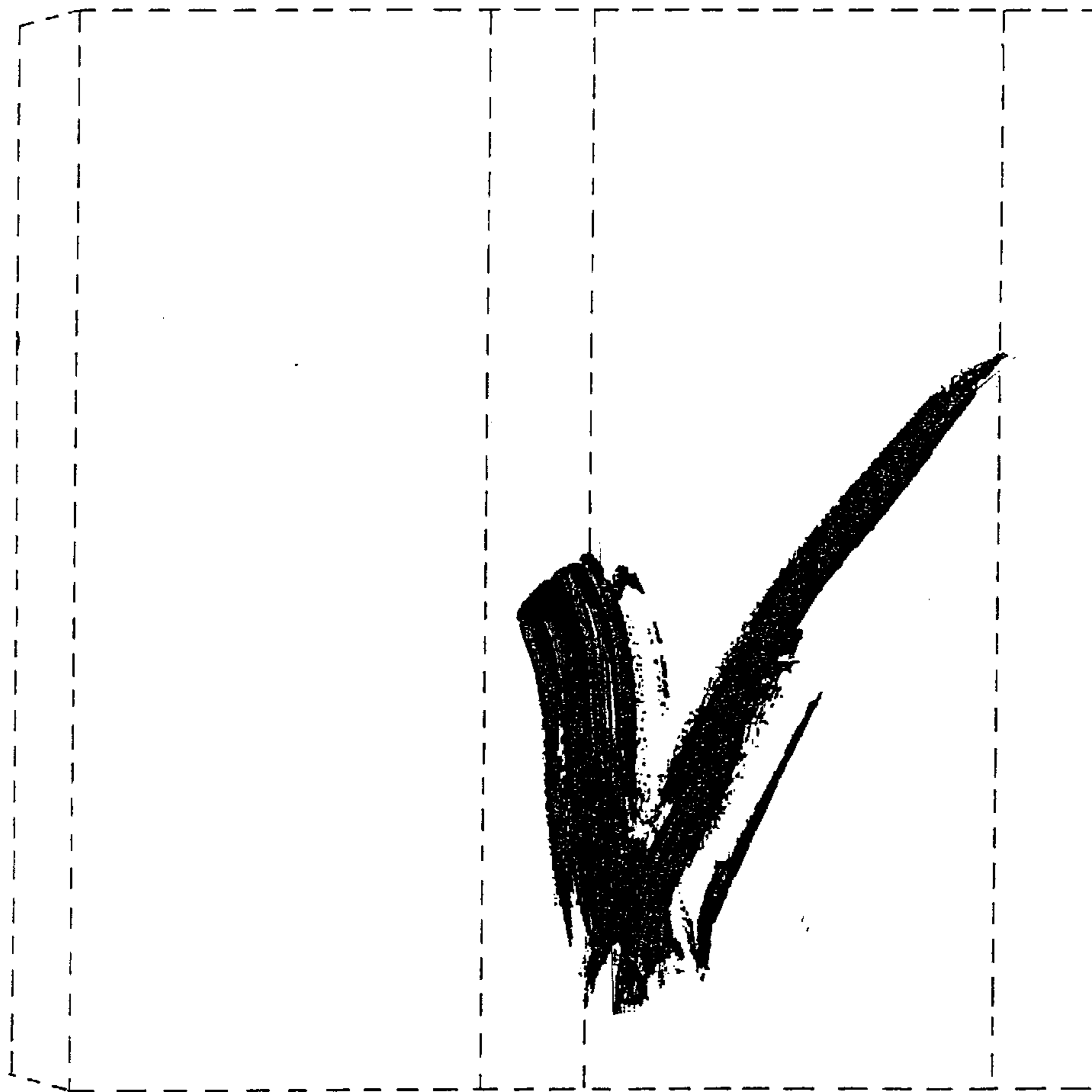

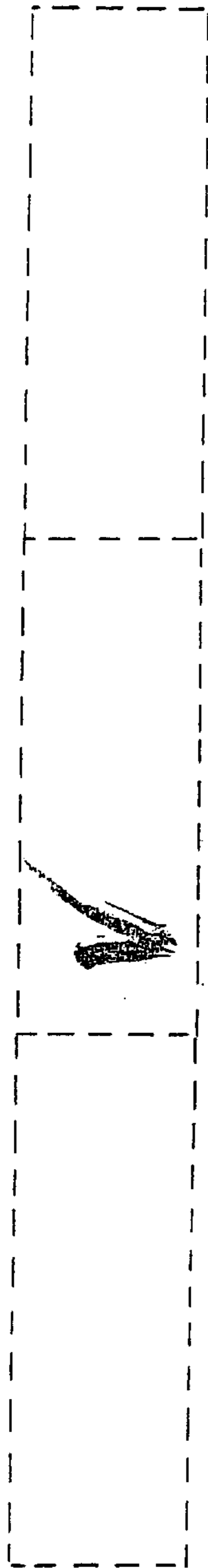

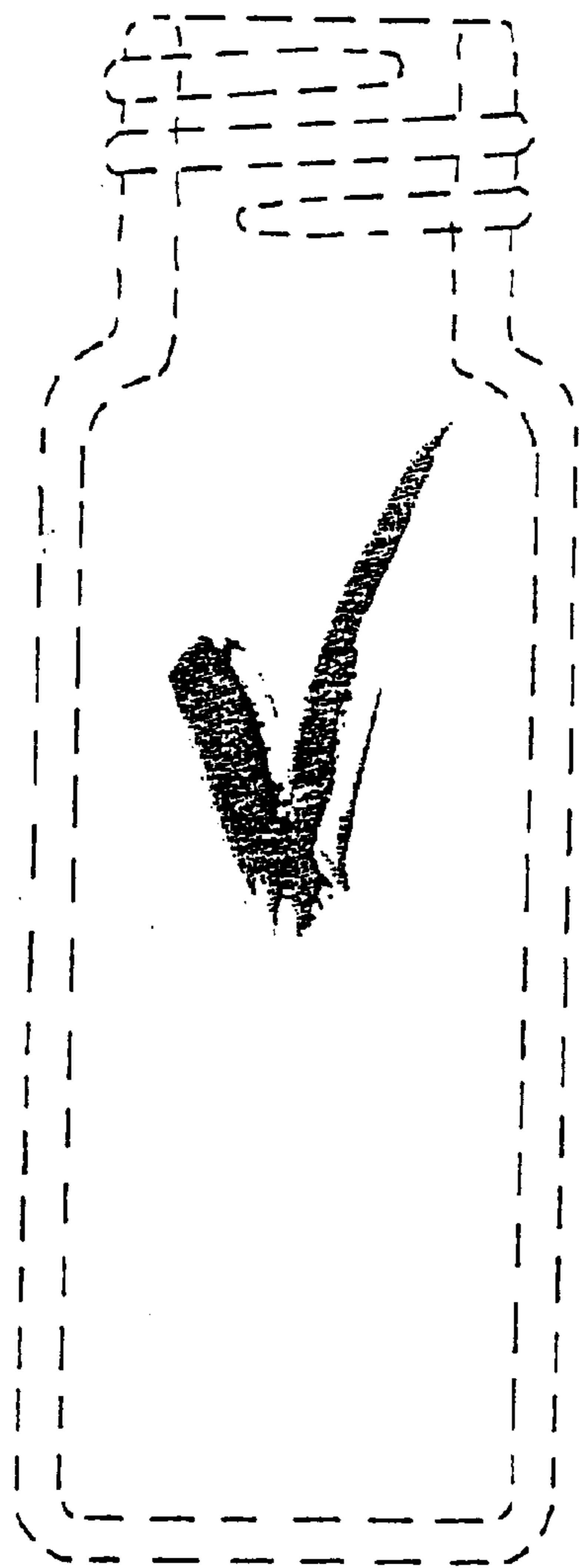

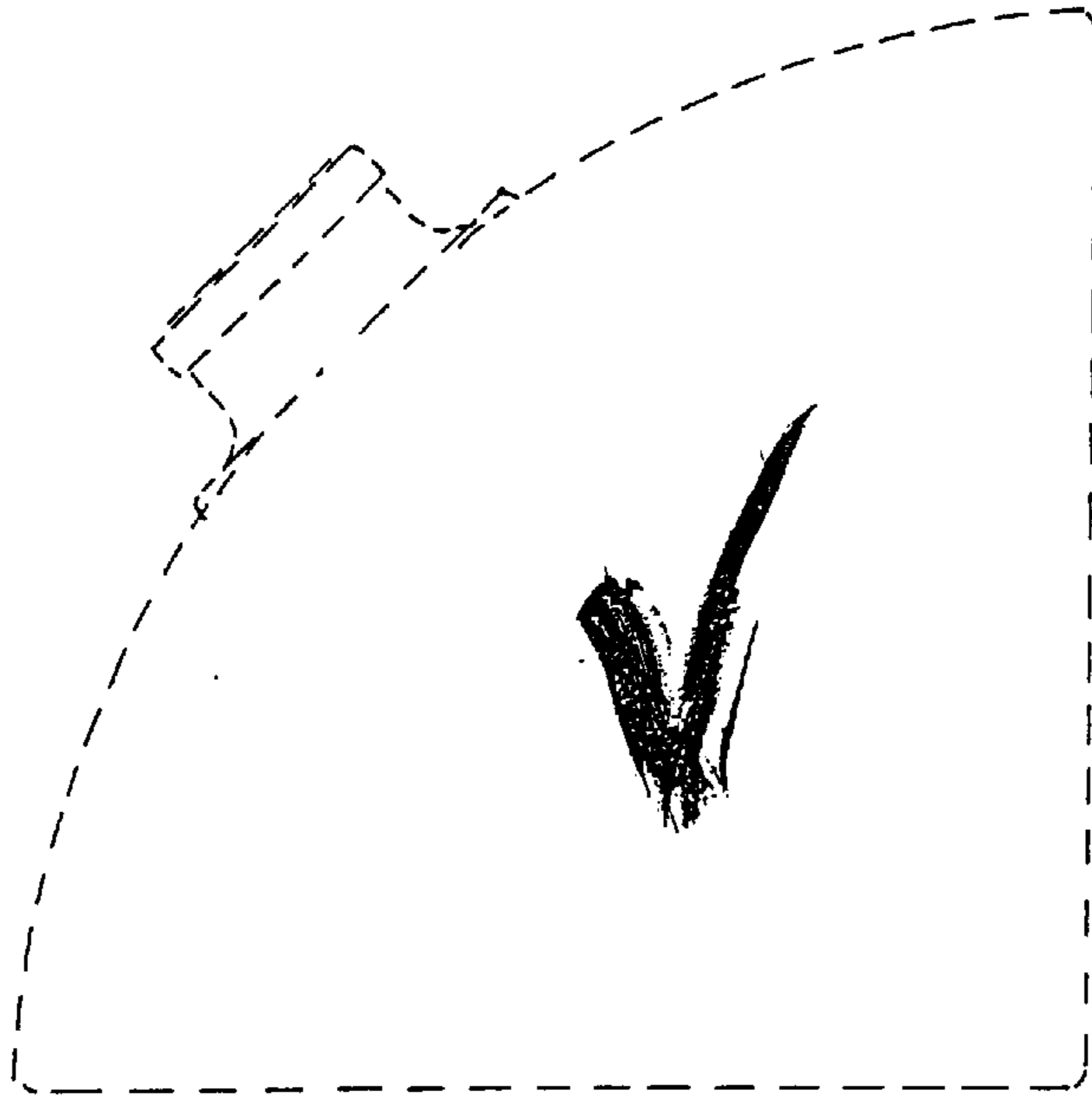

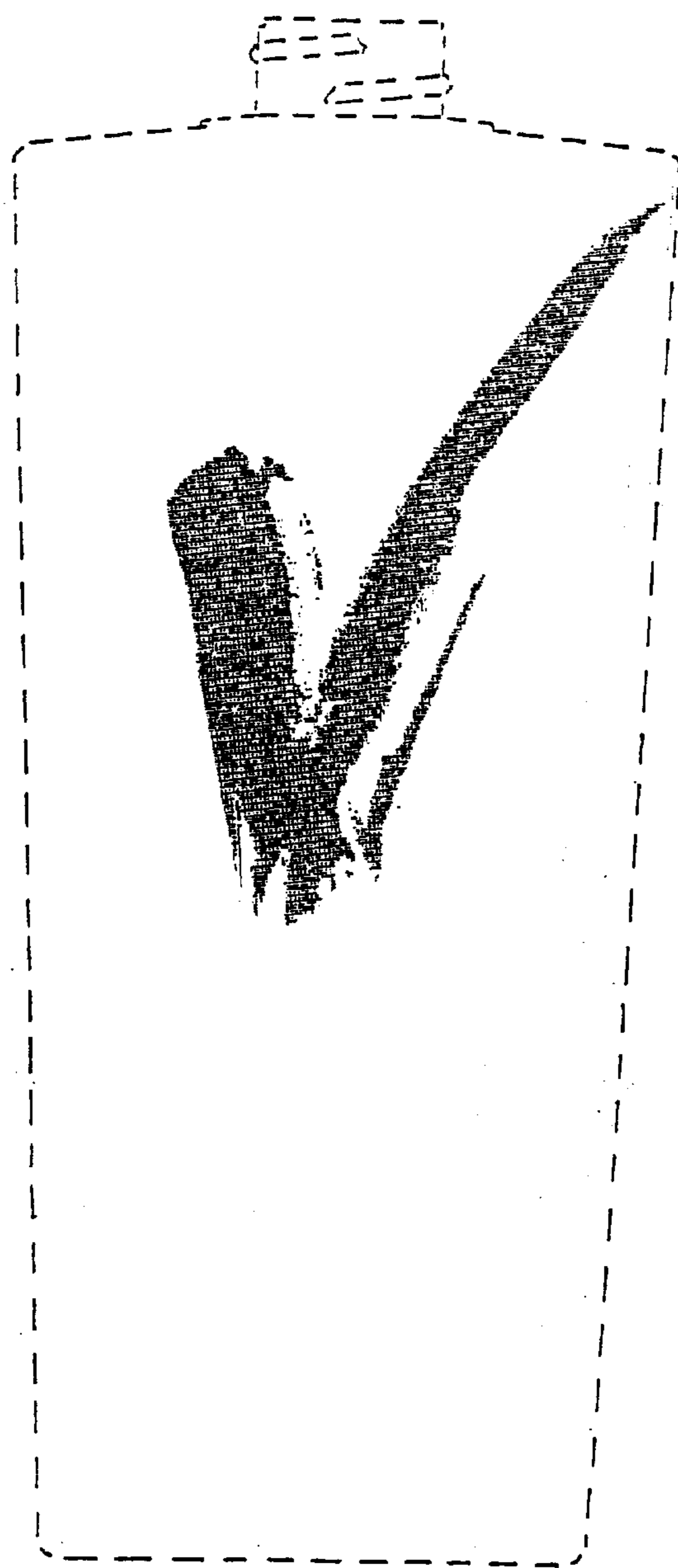

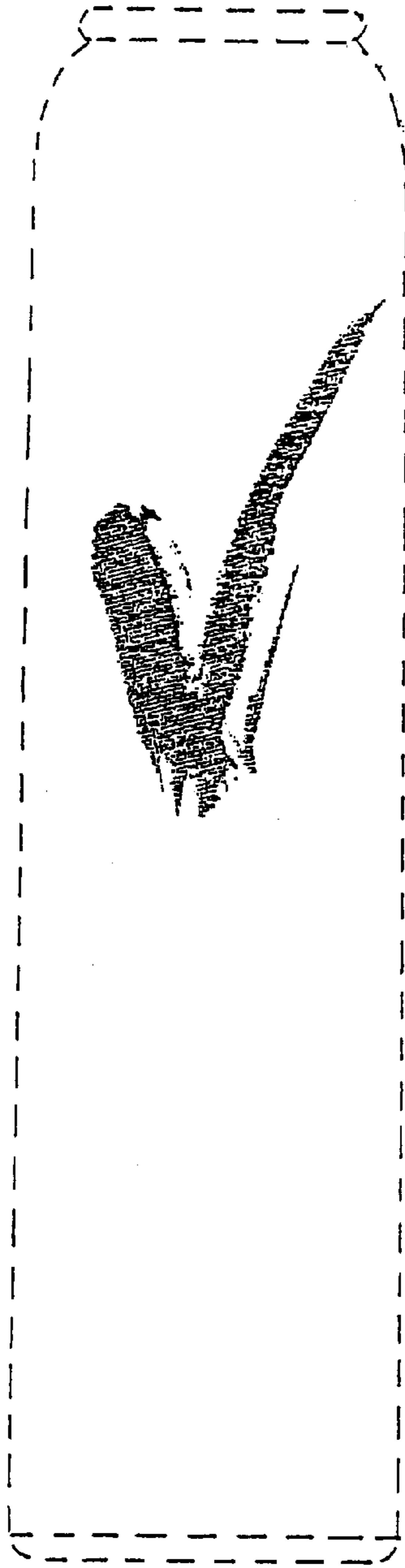
