(57) **CLAIM**

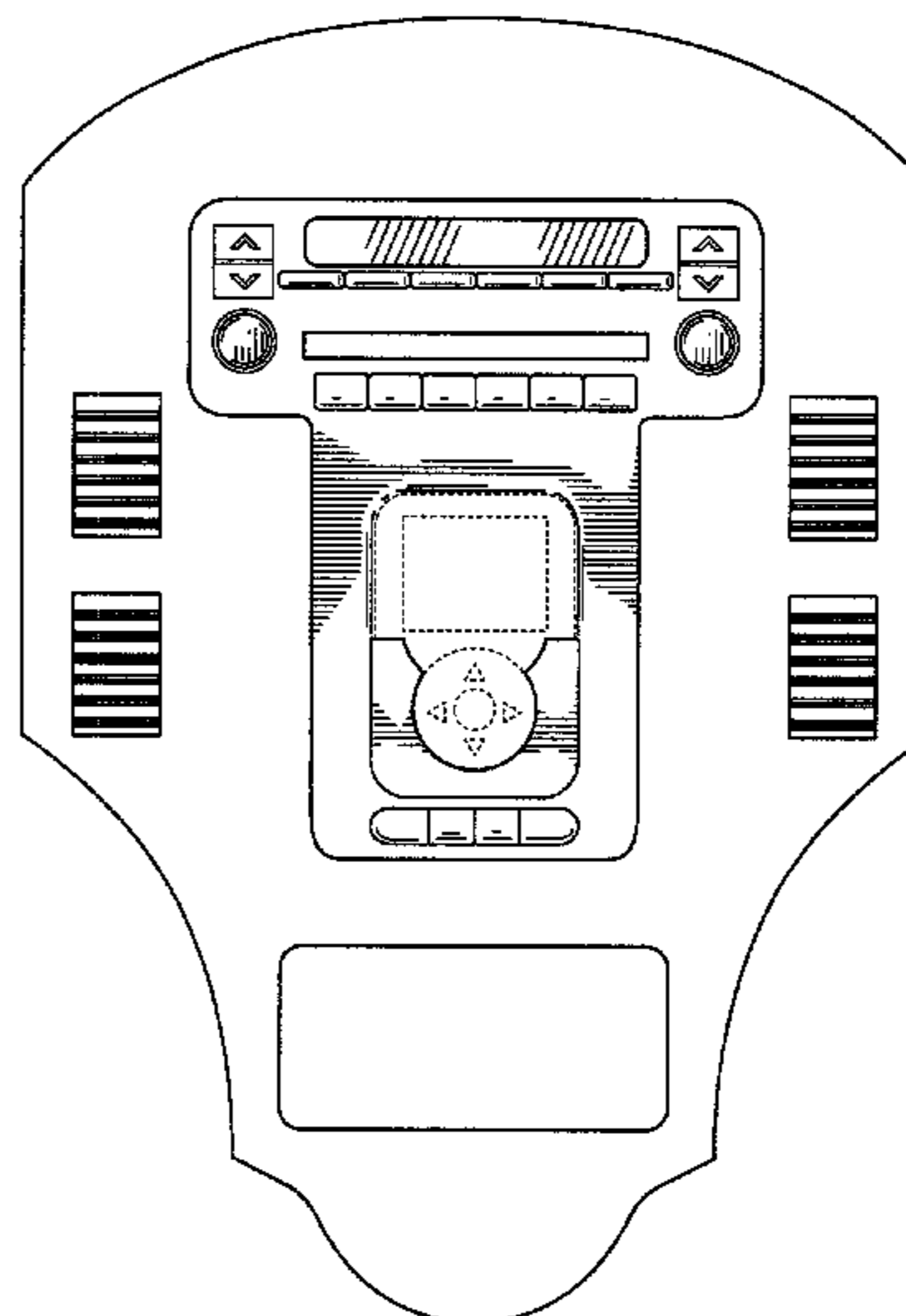
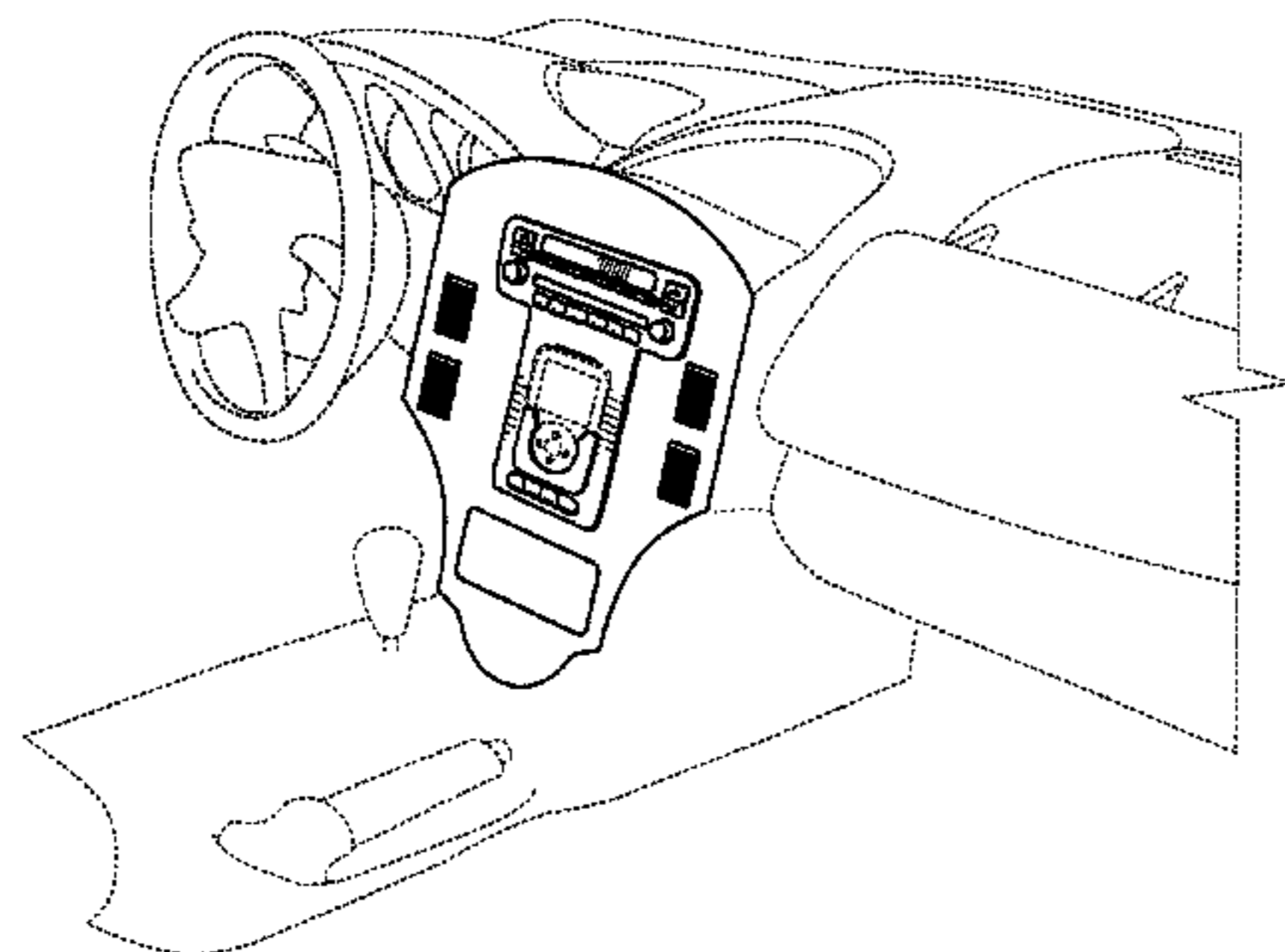
The ornamental design for a vehicle center console, as shown and described.

**DESCRIPTION**

FIG. 1 is a right perspective view of a vehicle center console showing our novel design;  
FIG. 2 is a front view thereof with broken lines illustrating an environmental structure;  
FIG. 3 is a front elevation view thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a right side elevation thereof; and,  
FIG. 6 is a bottom plan view thereof.  
The broken lines are for illustrative purposes and form no part of the claimed design.  
The vehicle center console is shown on an enlarged scale in FIGS. 2-6.

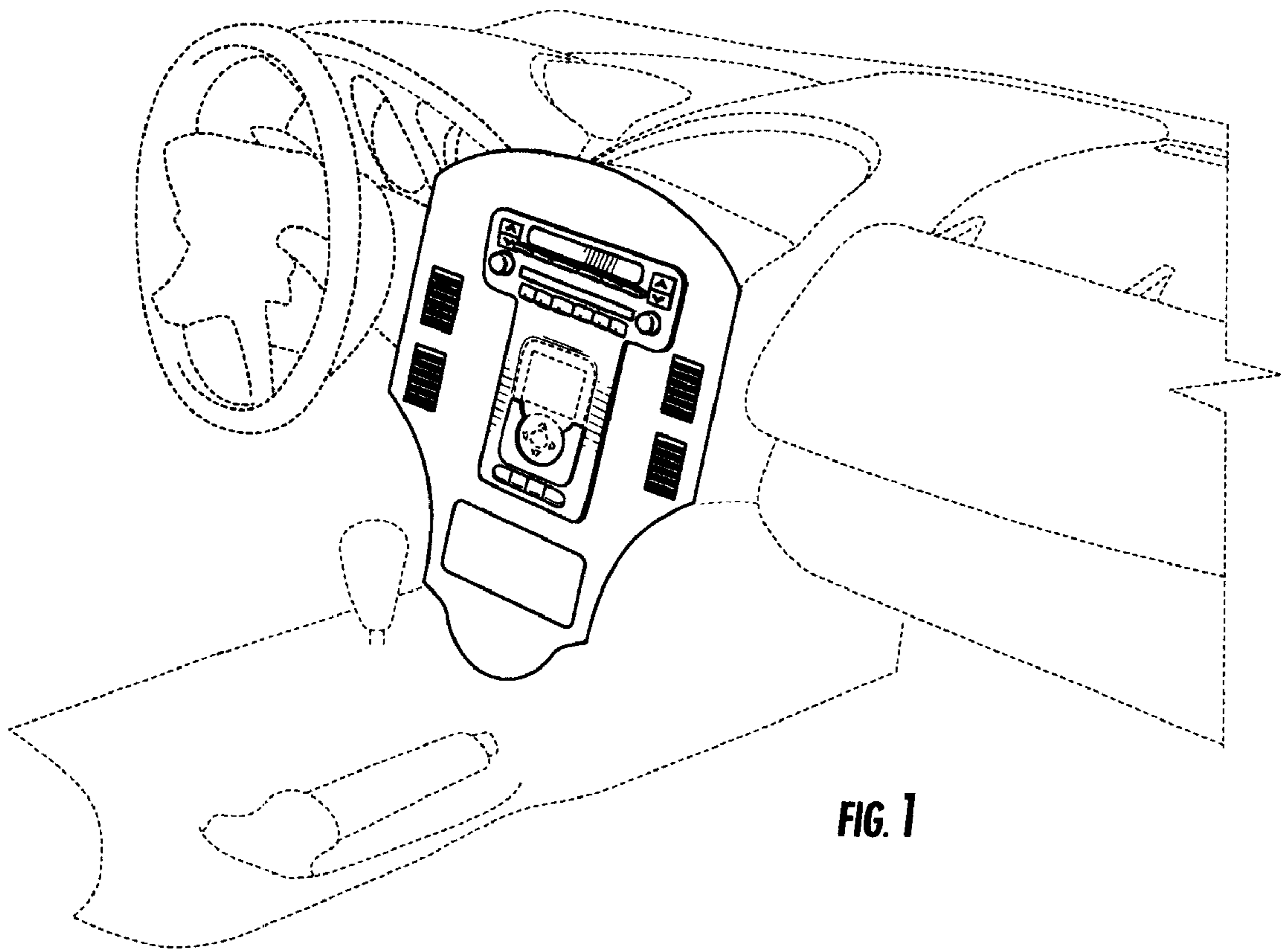

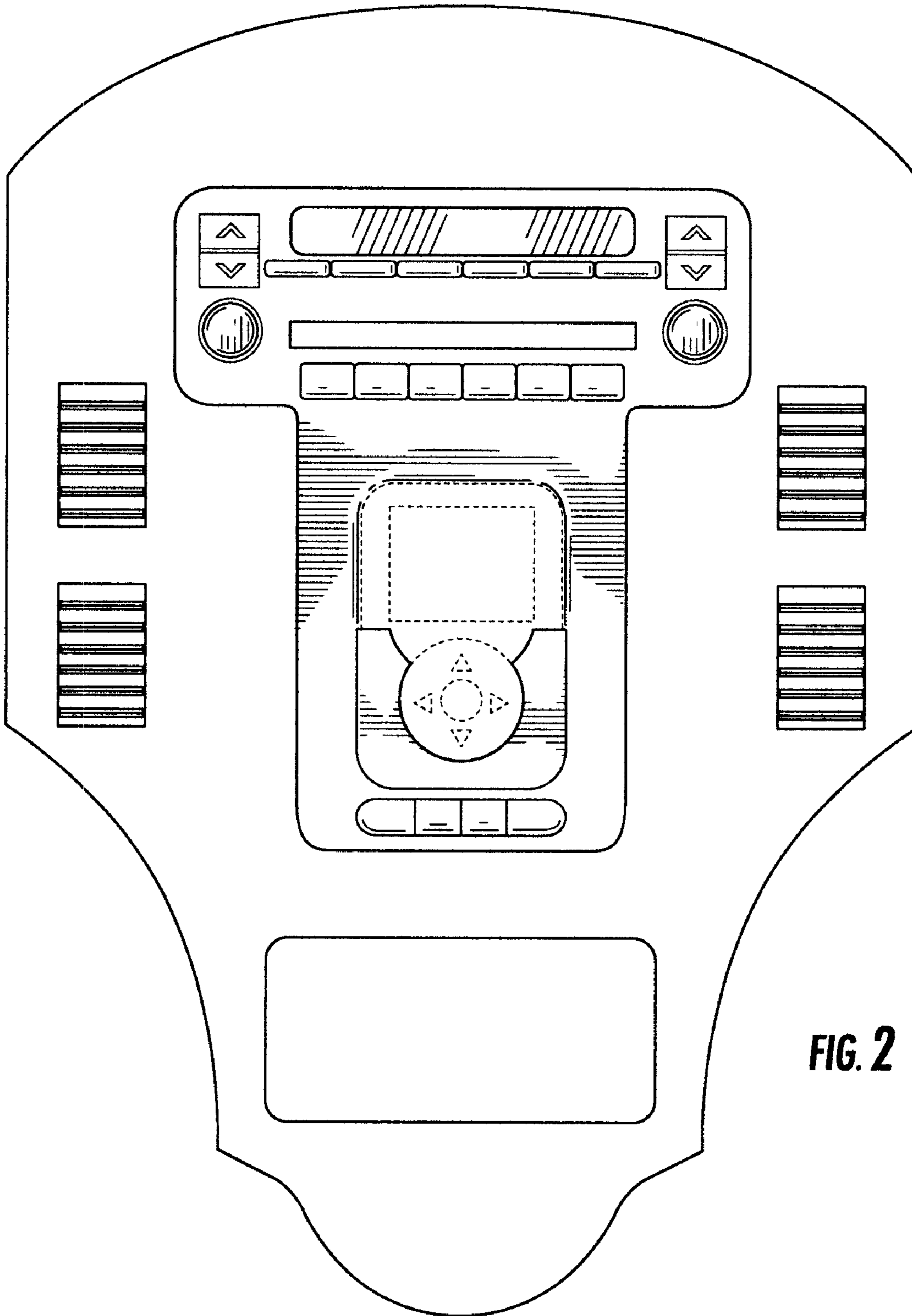
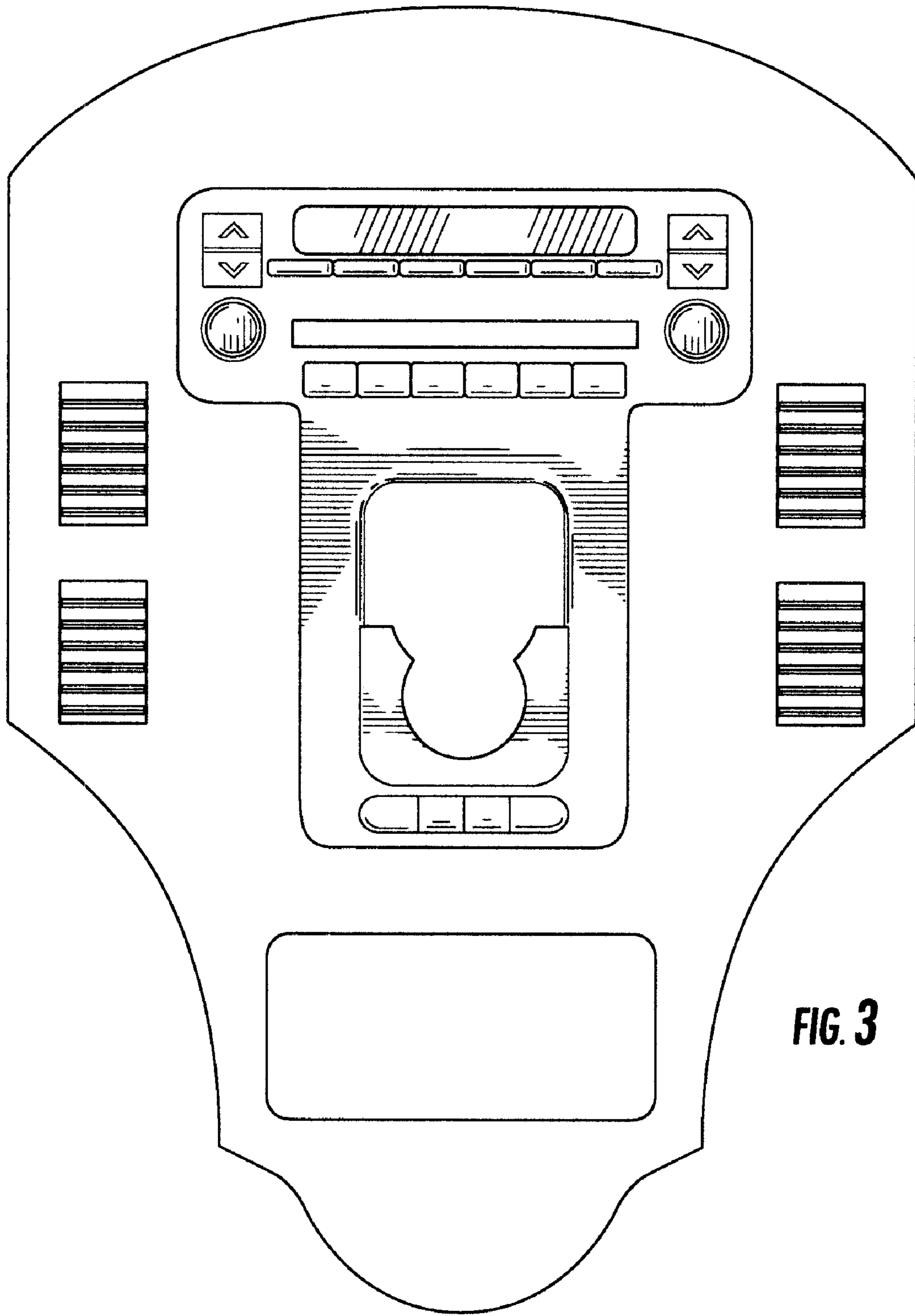
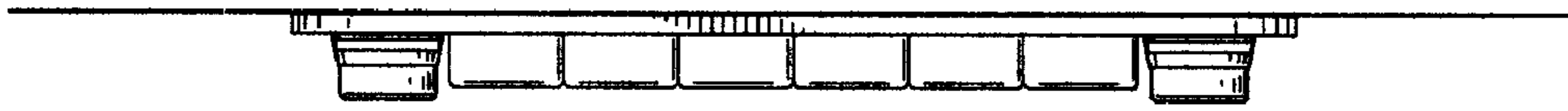
