(57) **CLAIM**

I claim the ornamental design for nested kit for replacing a larger battery with a smaller battery, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a nested kit for replacing a larger battery with a smaller battery showing my new design;

FIG. 2 is a side elevational view thereof, all other side elevational views being identical thereto;

FIG. 3 is a top plan view thereof;

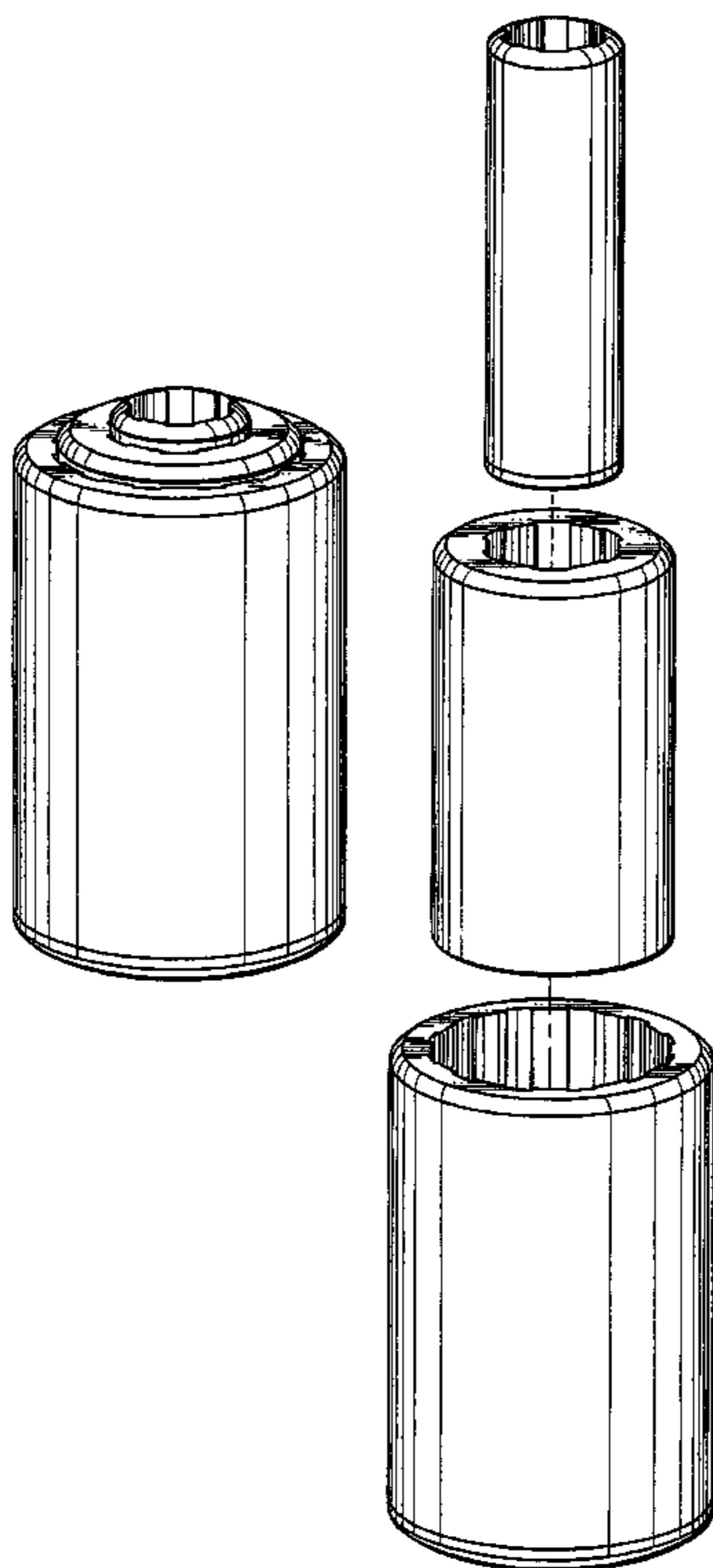
FIG. 4 is a bottom plan view thereof;

FIG. 5 is a cross-sectional view thereof, taken along line 5—5 of FIG. 3;

FIG. 6 is an exploded perspective view thereof; and,

FIG. 7 is a perspective view showing the nested kit for replacing a larger battery with a smaller battery in use; the broken lines depict environmental structure for illustrative purposes only and form no part of the claimed design.

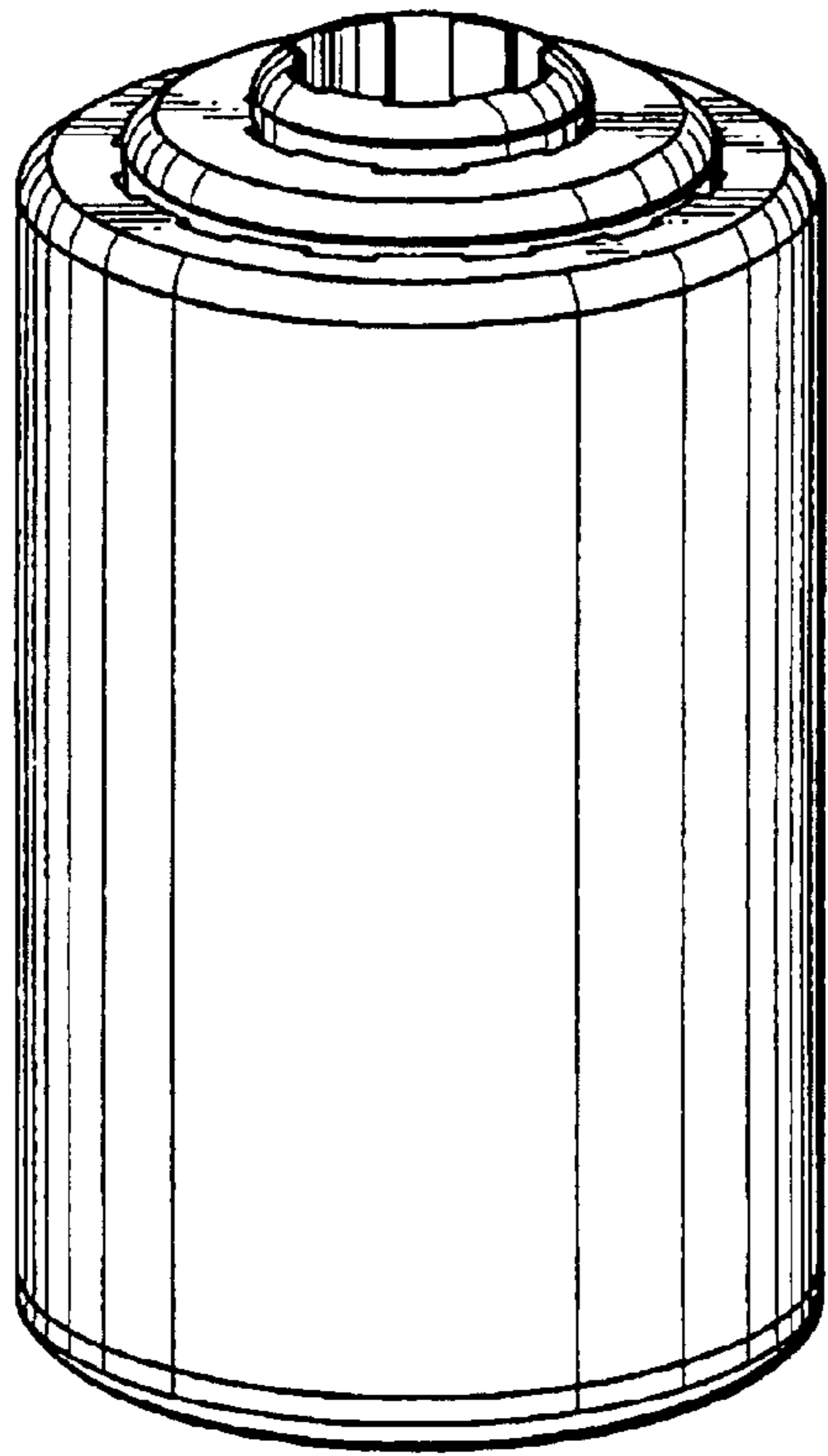

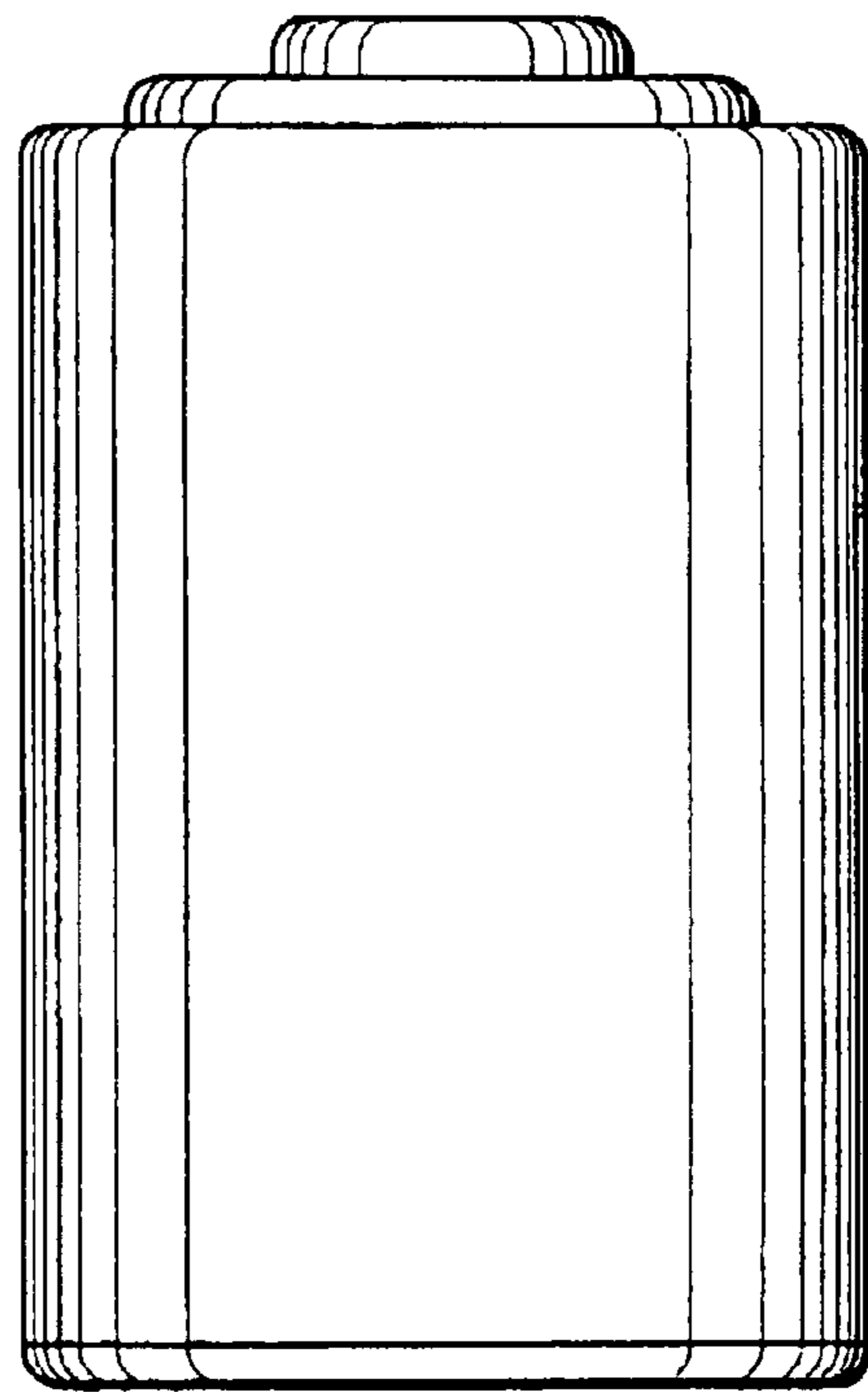

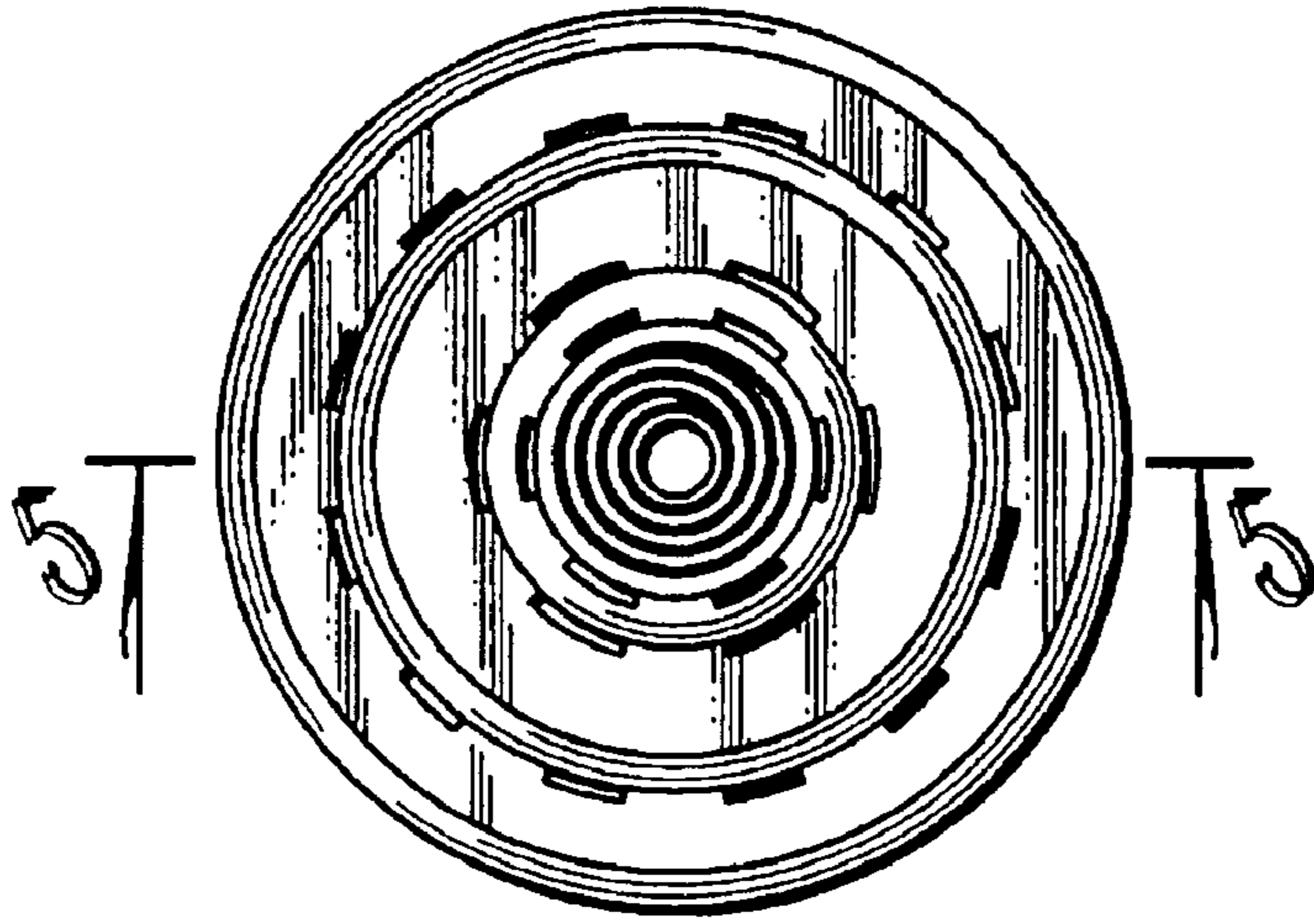

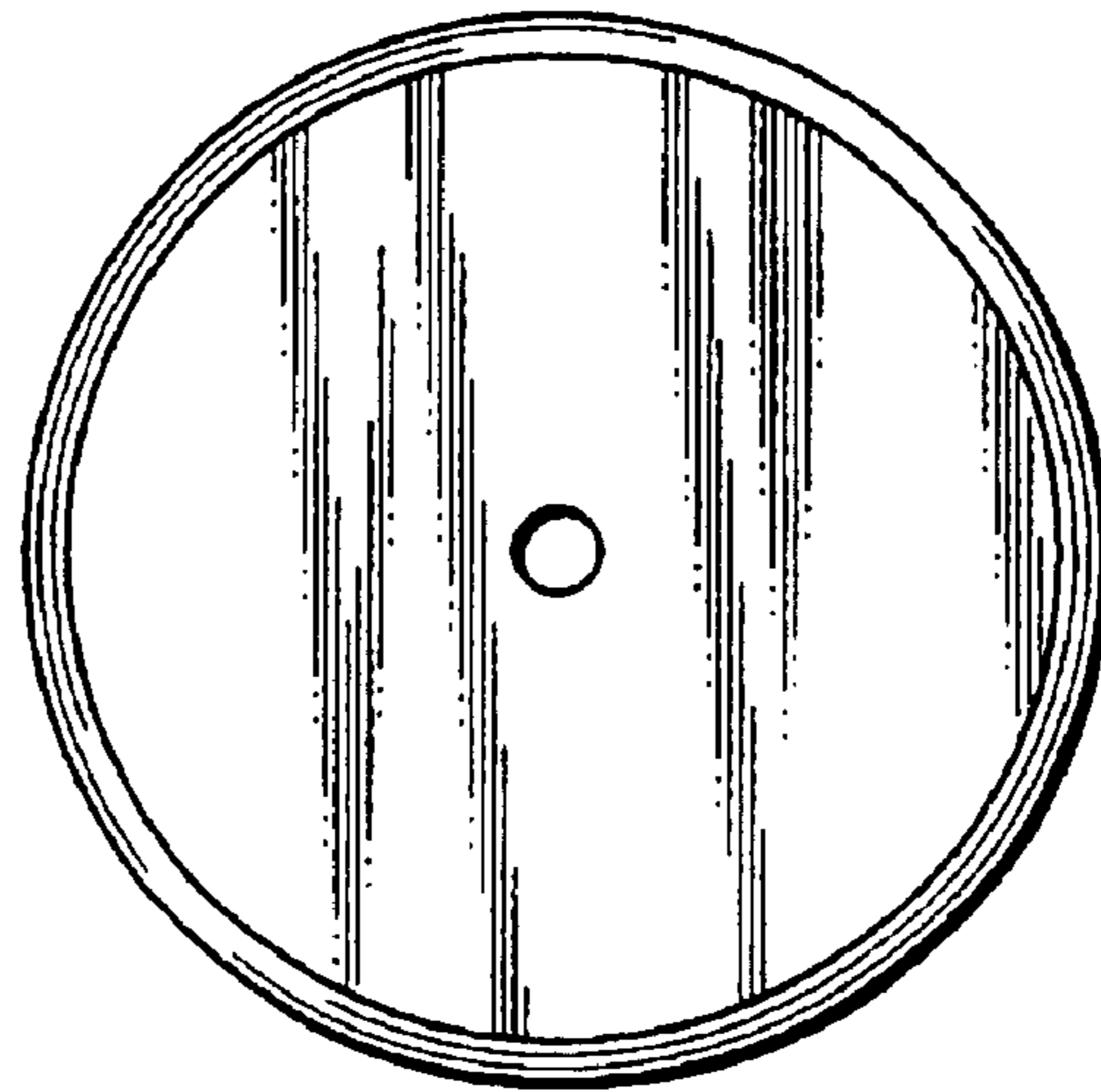

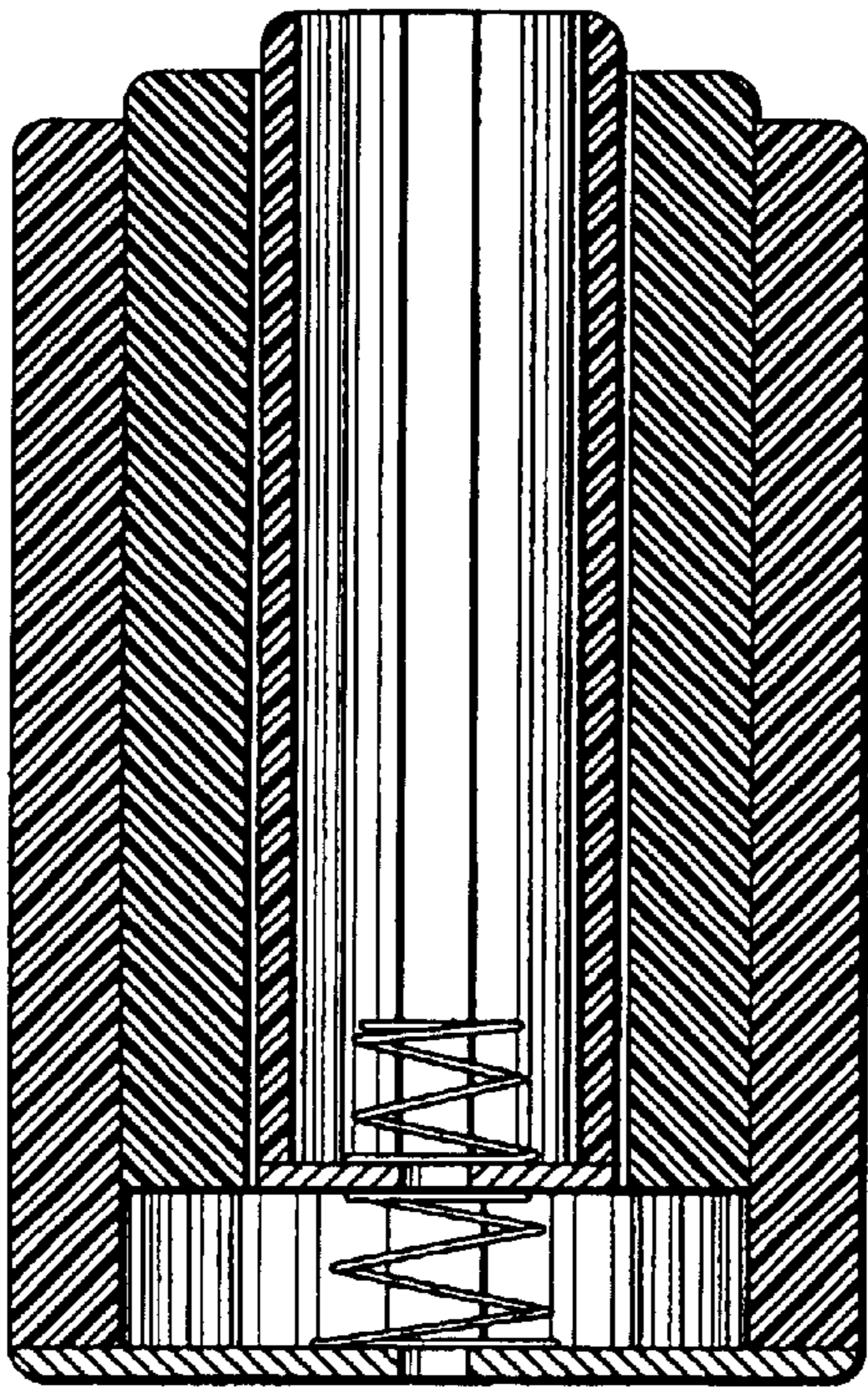

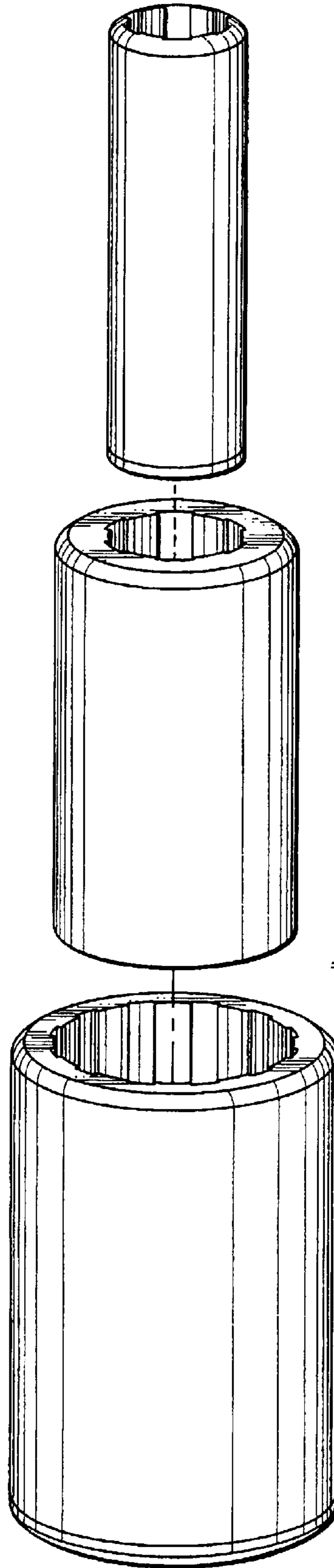

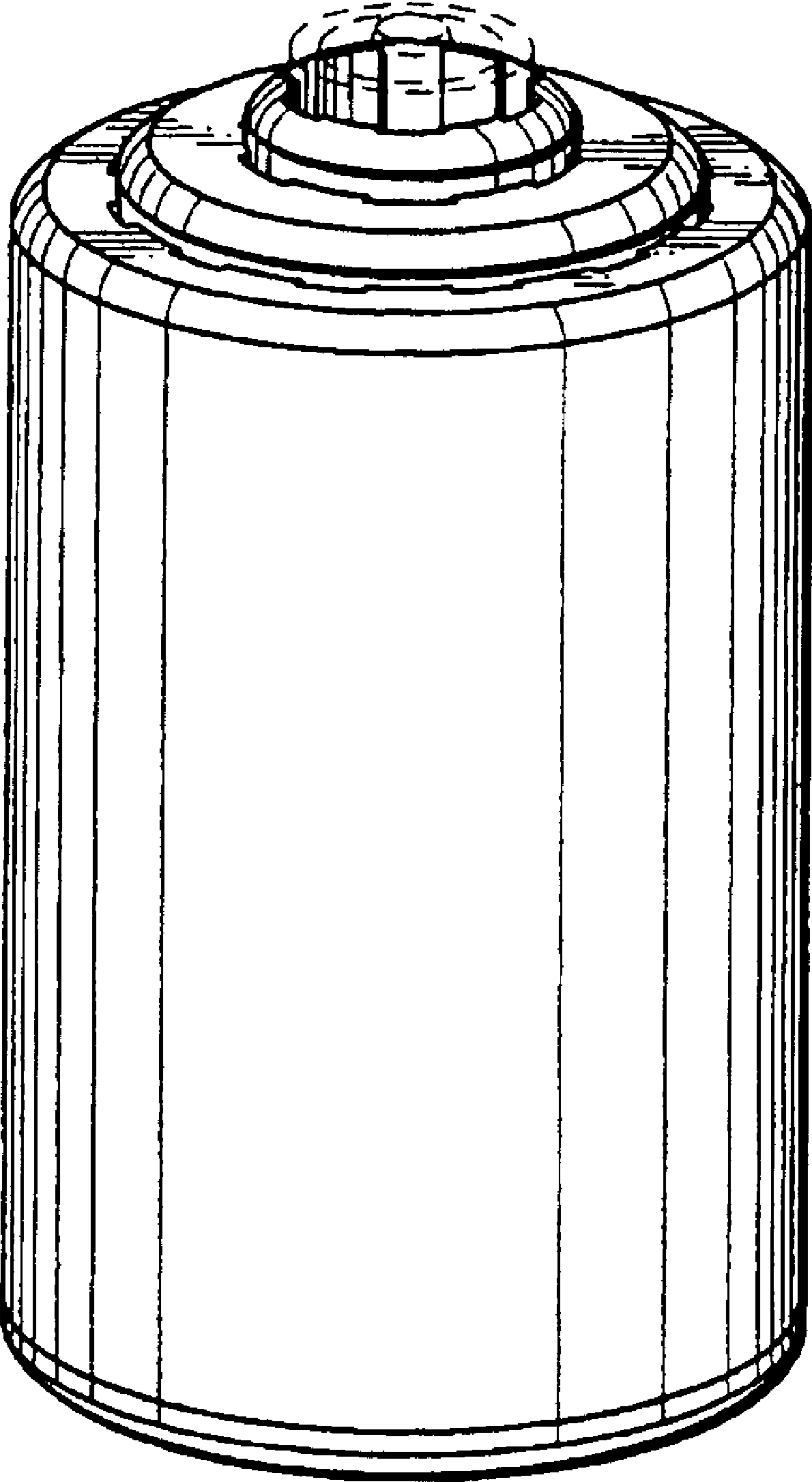
