The ornamental design for an electrical connector, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of an electrical connector, showing our new design;

FIG. 2 is a back elevation view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a left side elevation view thereof;

FIG. 6 is a right side elevation view thereof;

FIG. 7 is a cross-sectional view thereof, taken along line 7—7 in FIG. 1;

FIG. 8 is a cross-sectional view thereof, taken along line 8—8 in FIG. 1; and,

FIG. 9 is a top, front perspective view thereof.

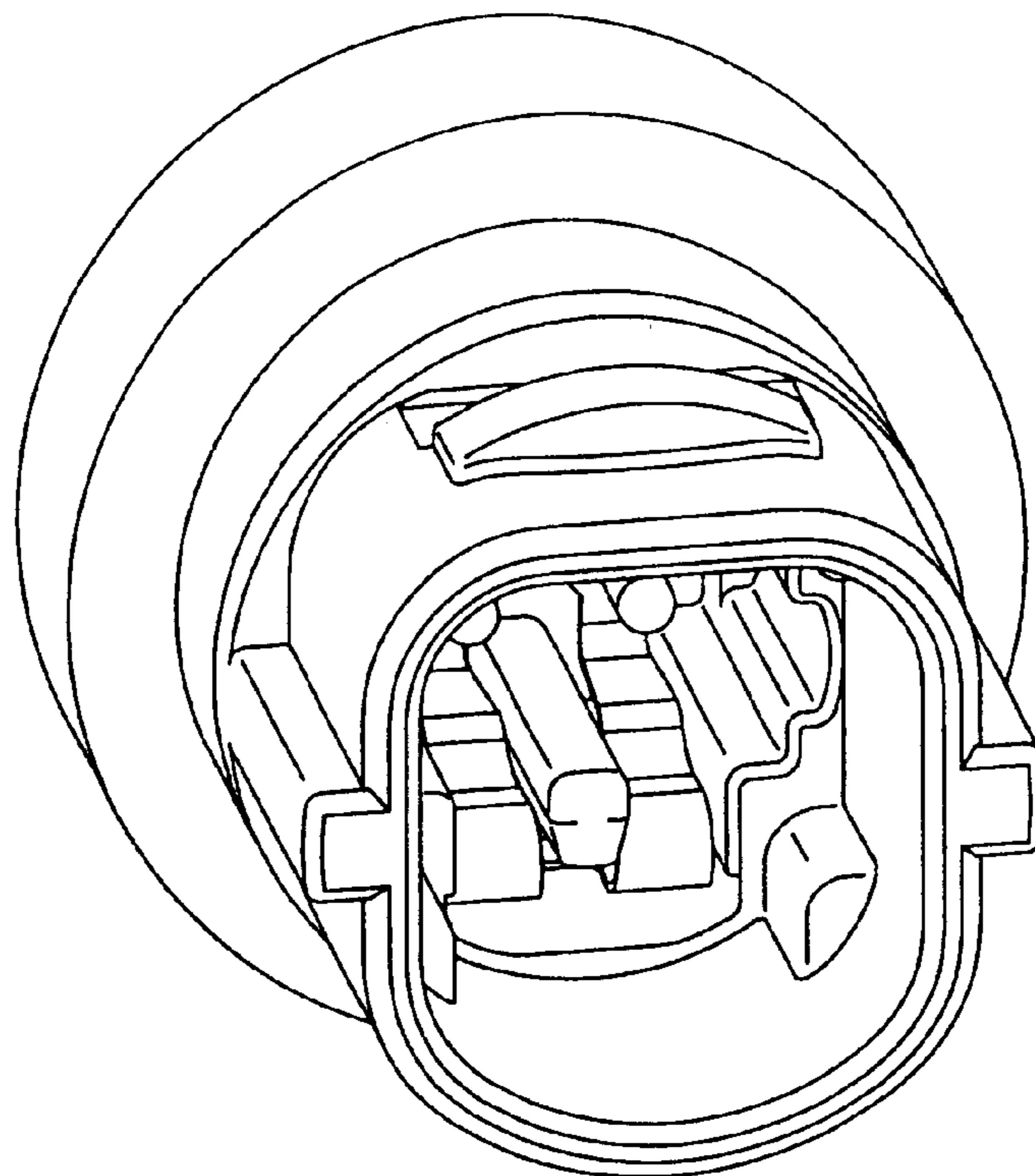

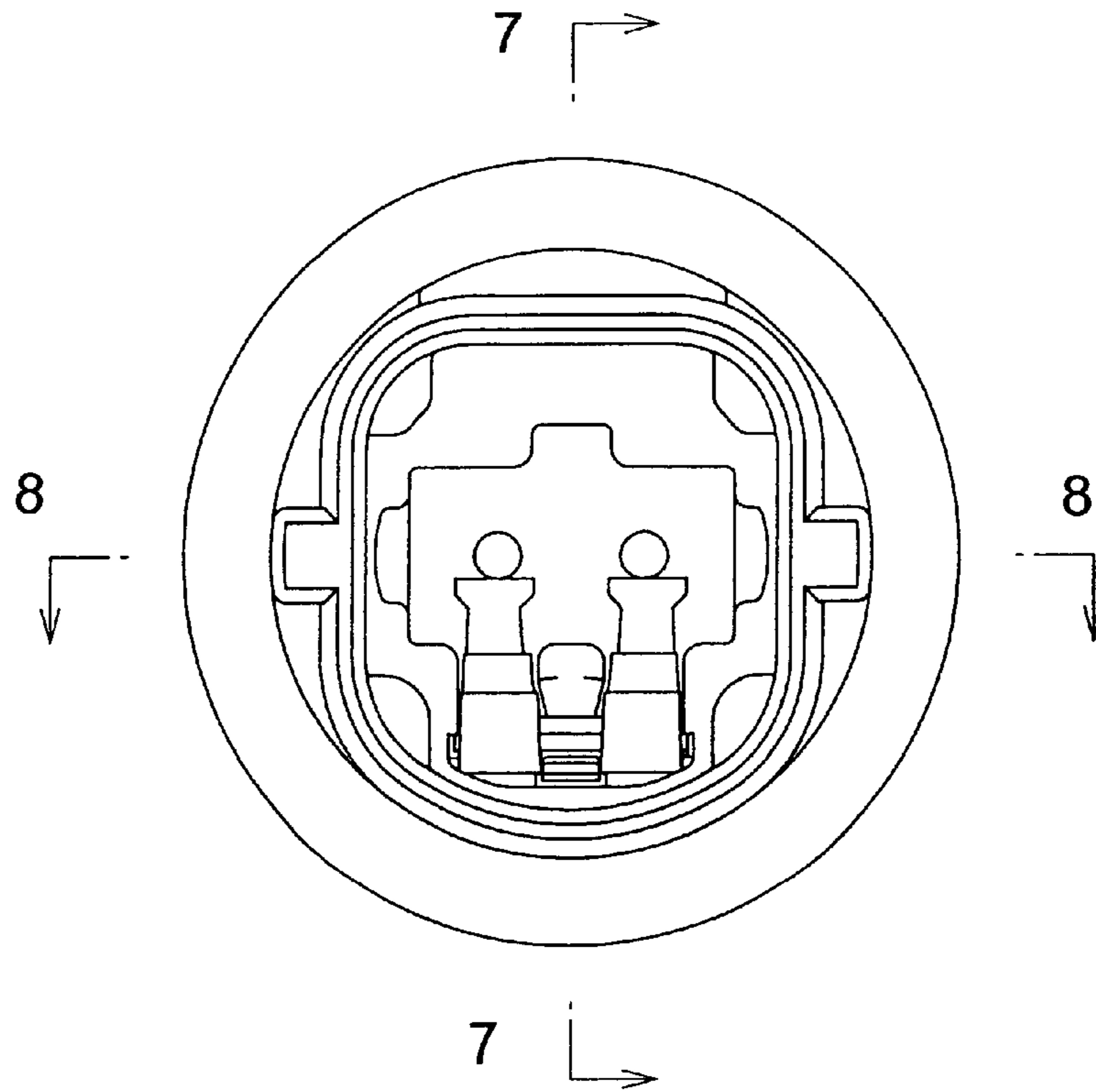

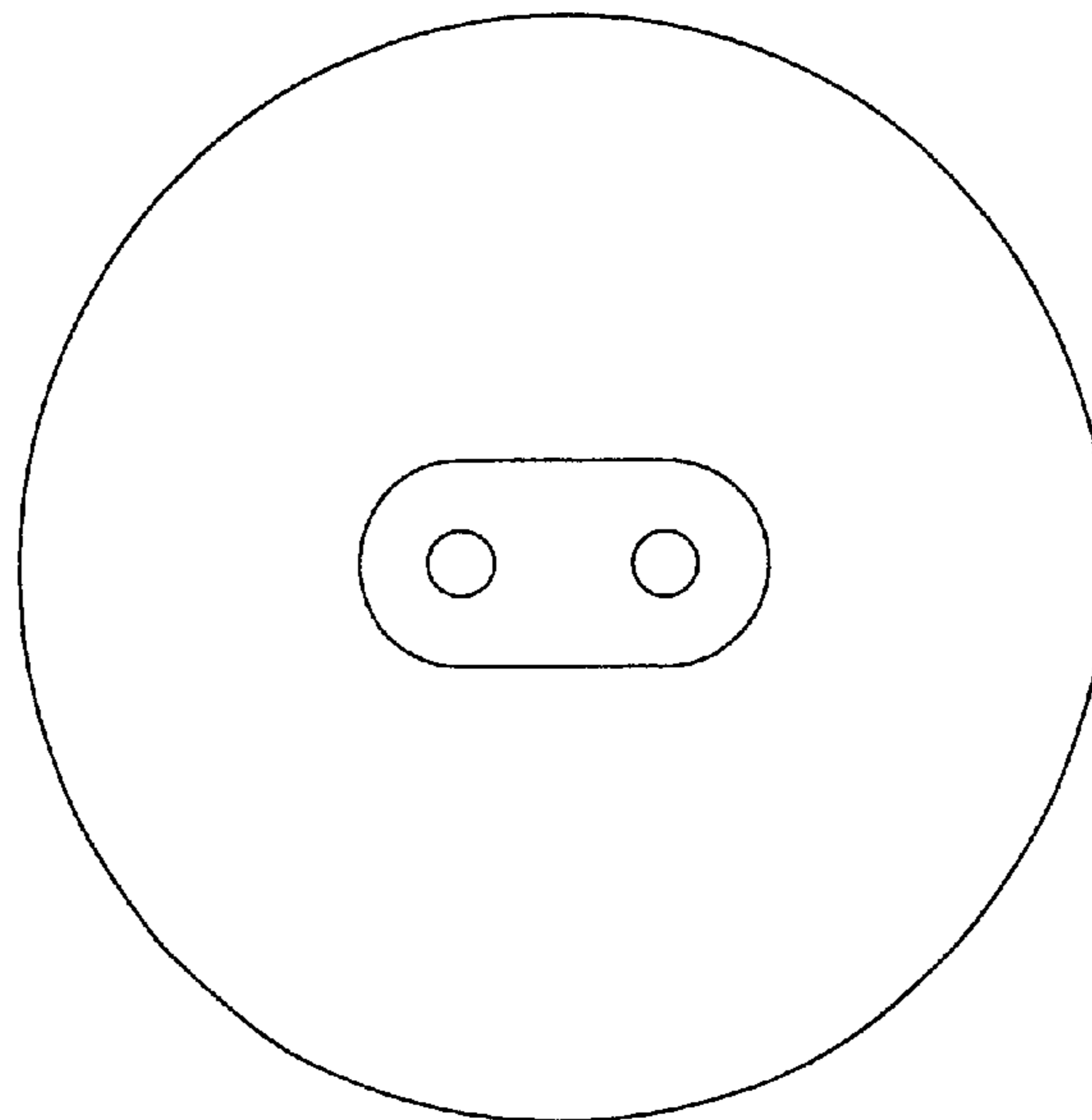

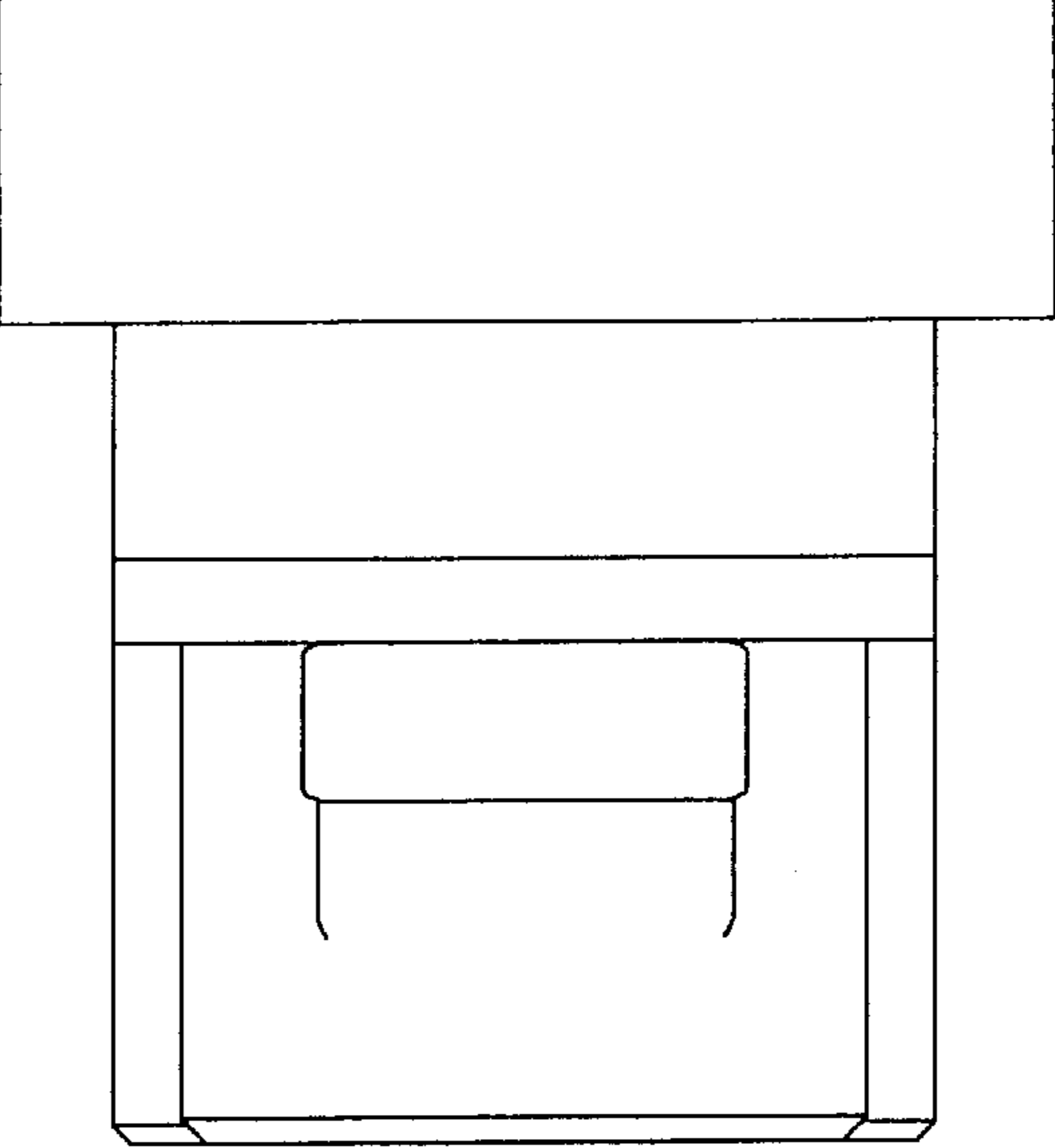

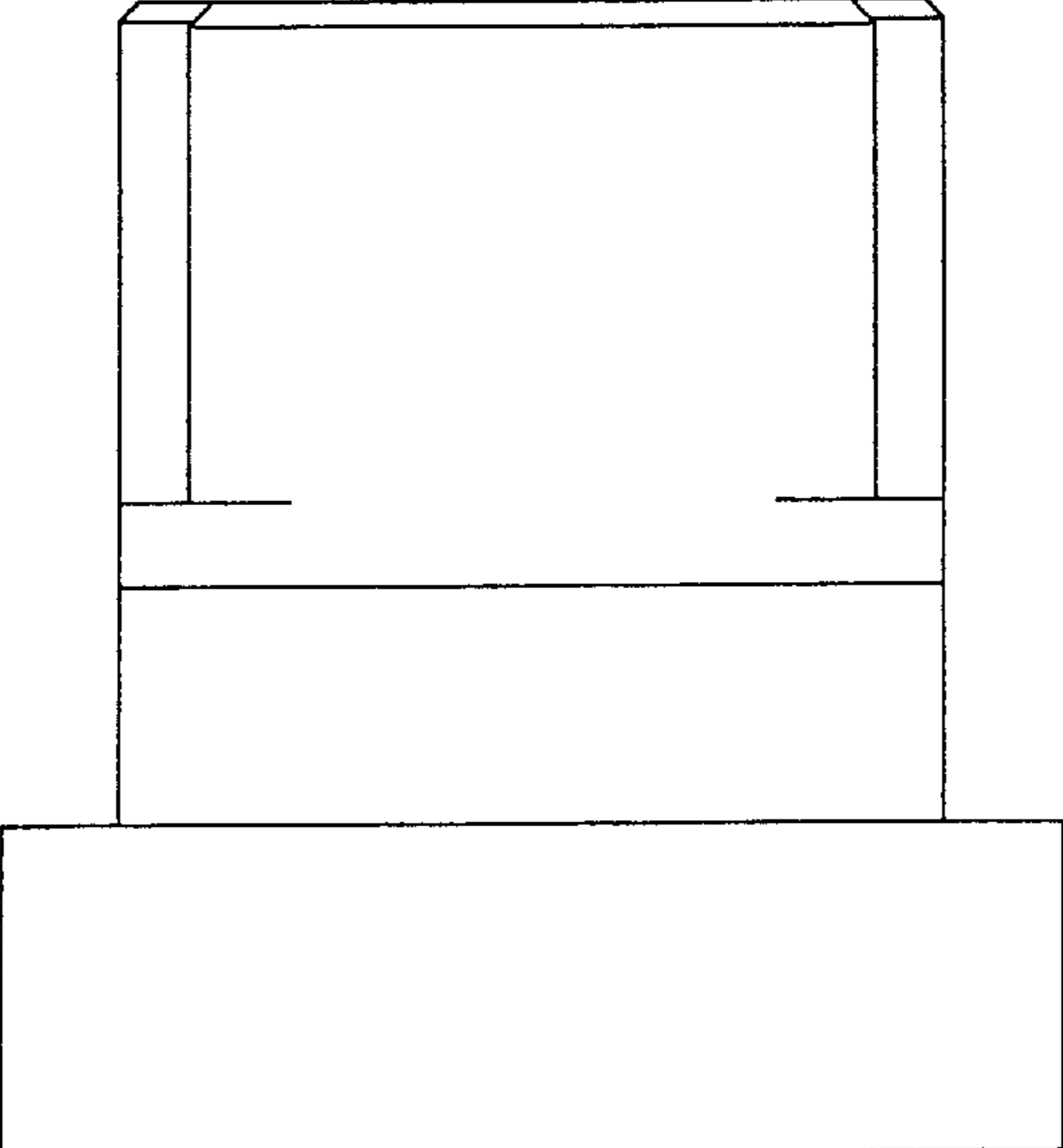

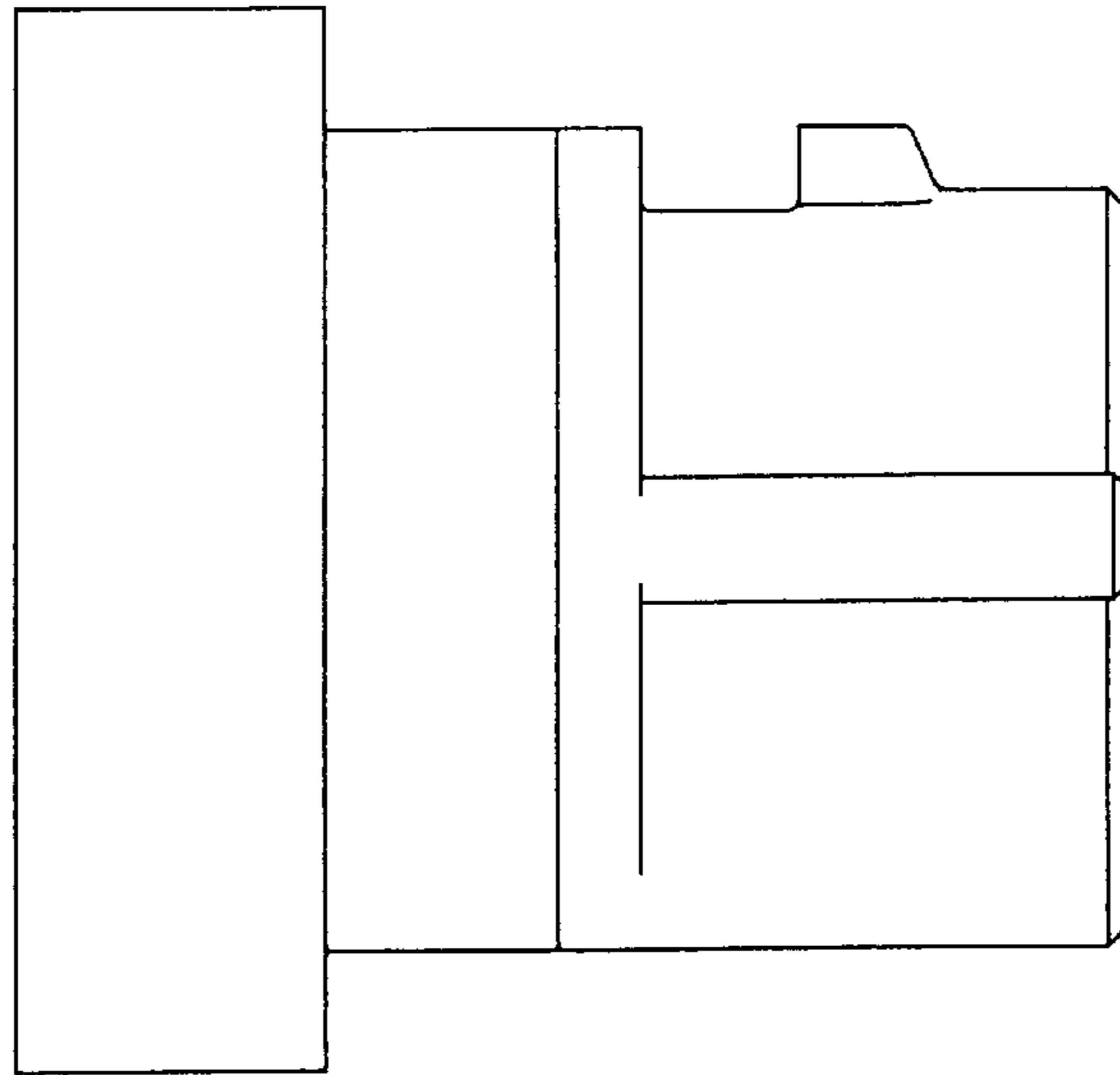

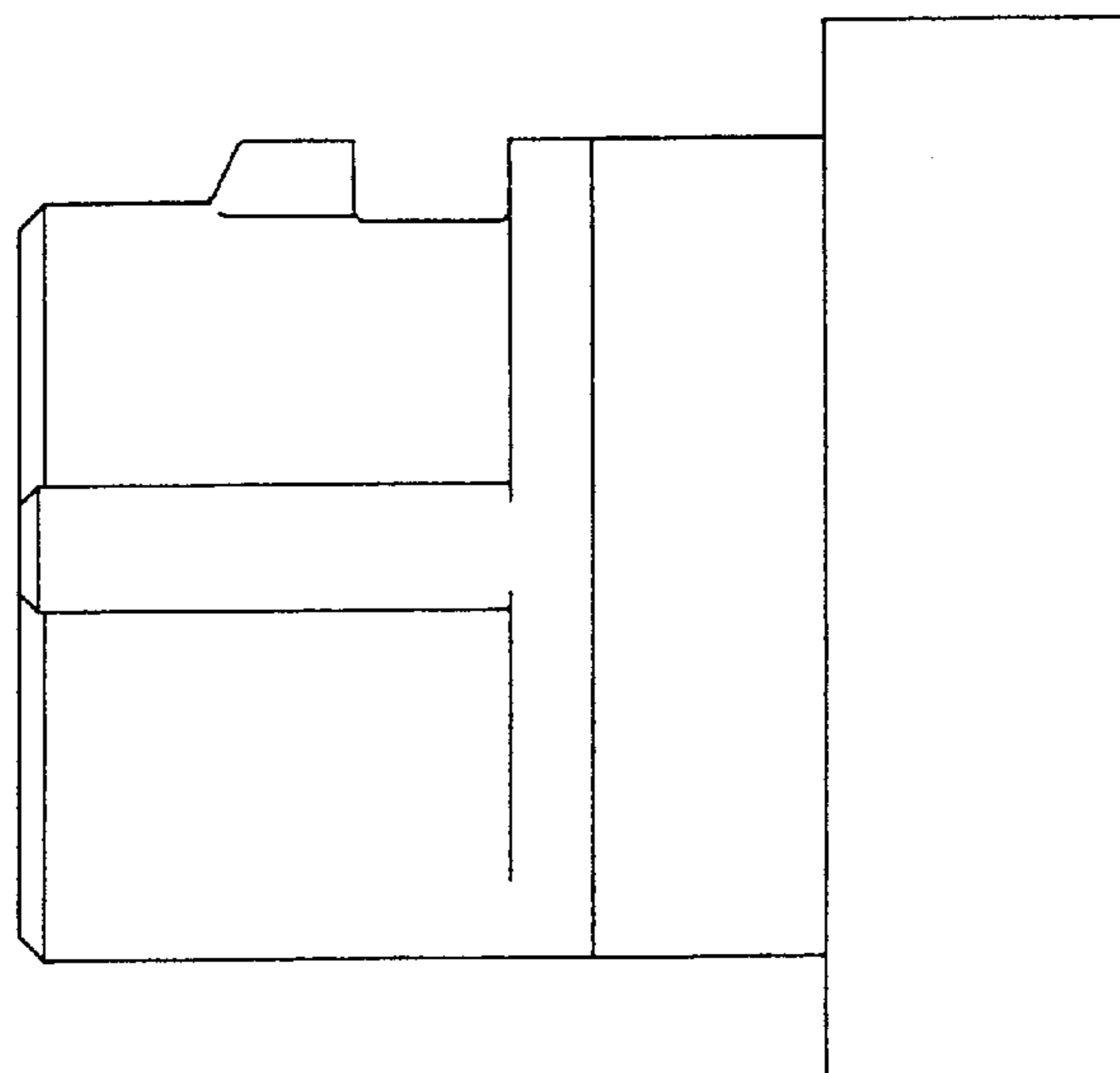

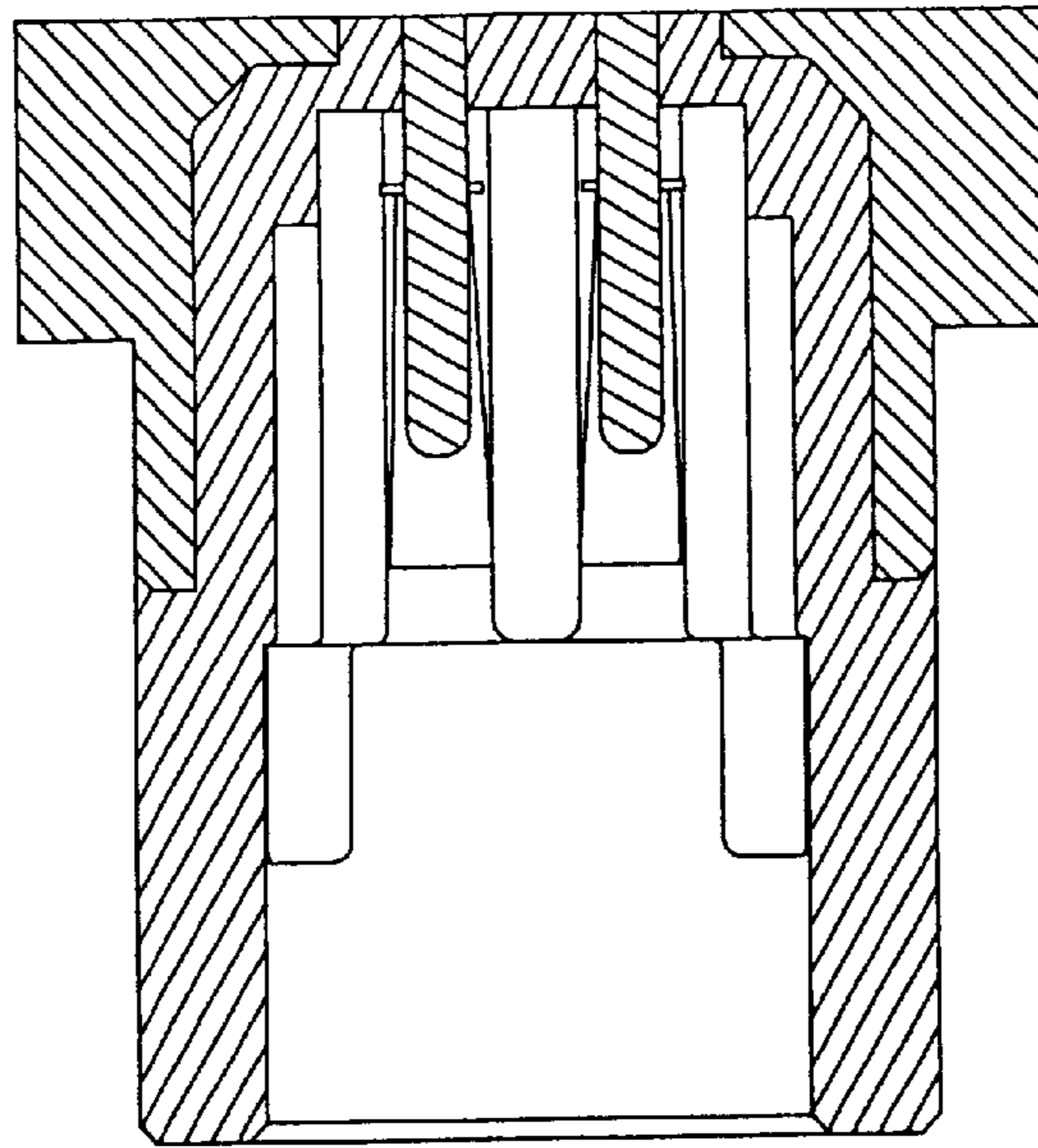

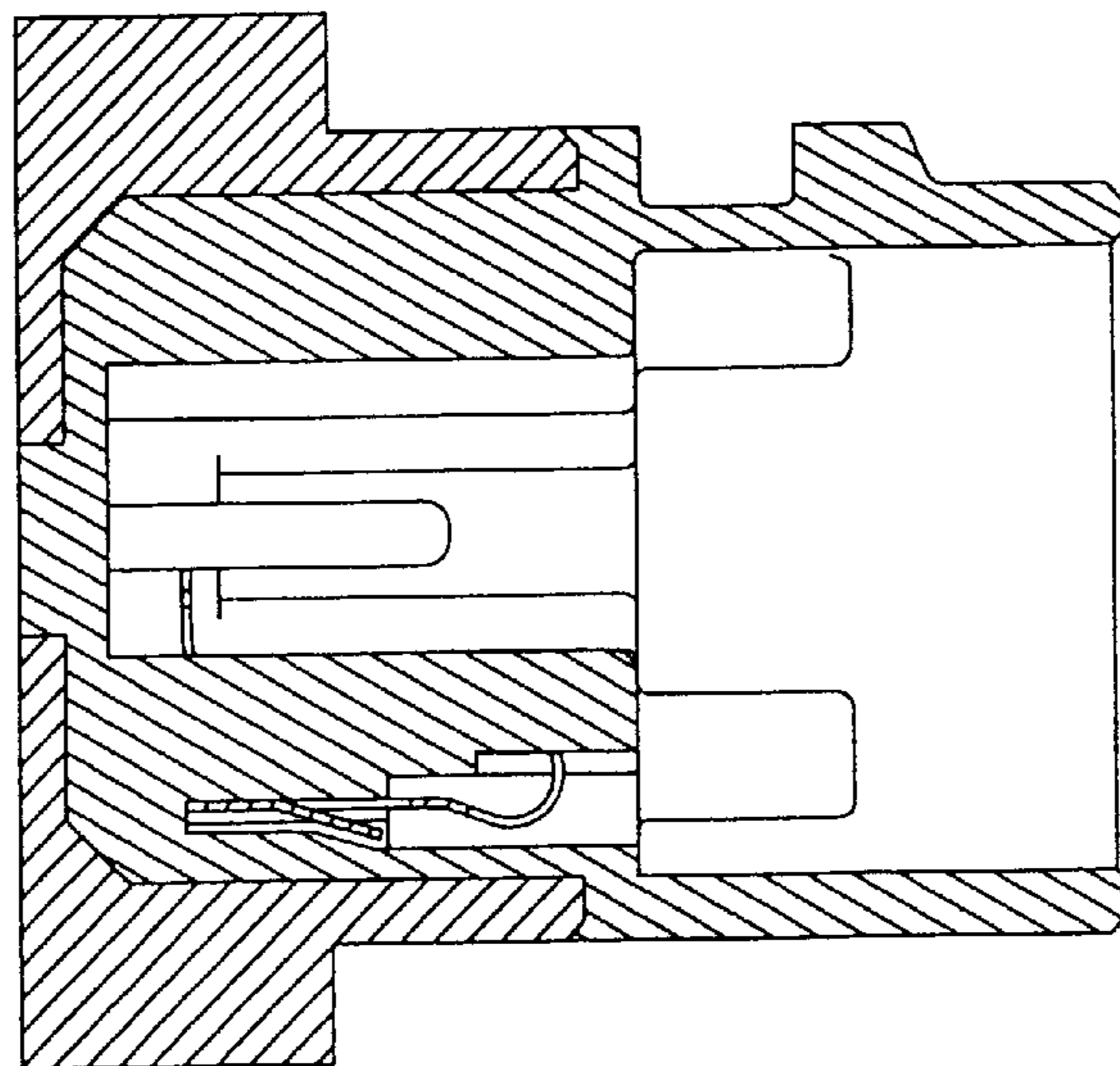
