(57) **CLAIM**

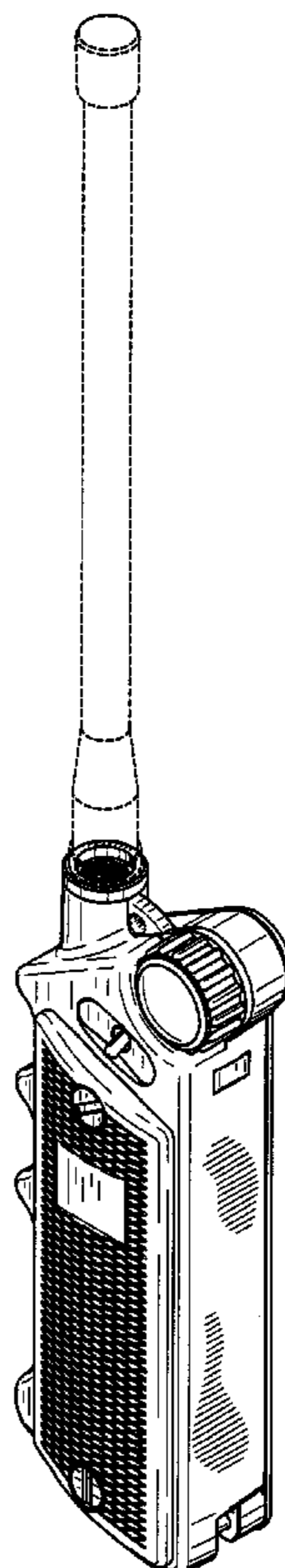
We claim the ornamental design for a pistol grip handheld transmitter, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the pistol grip handheld transmitter showing features of the present invention; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

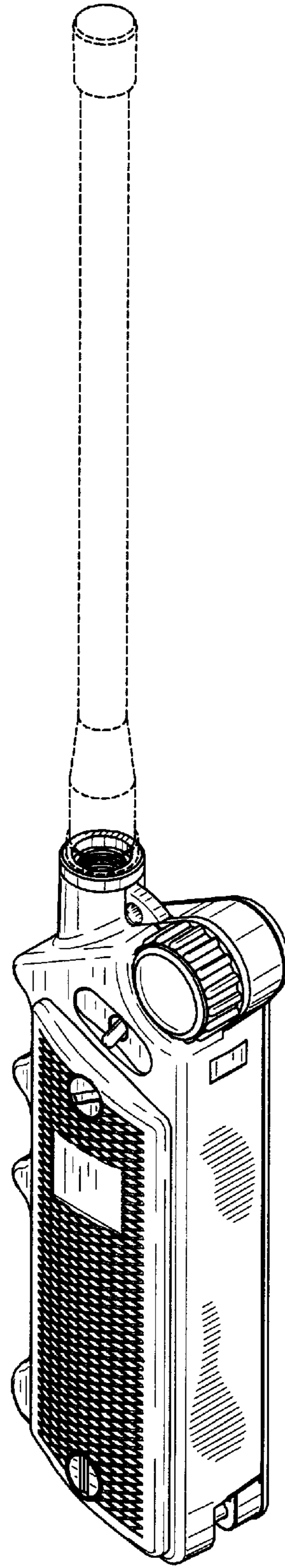

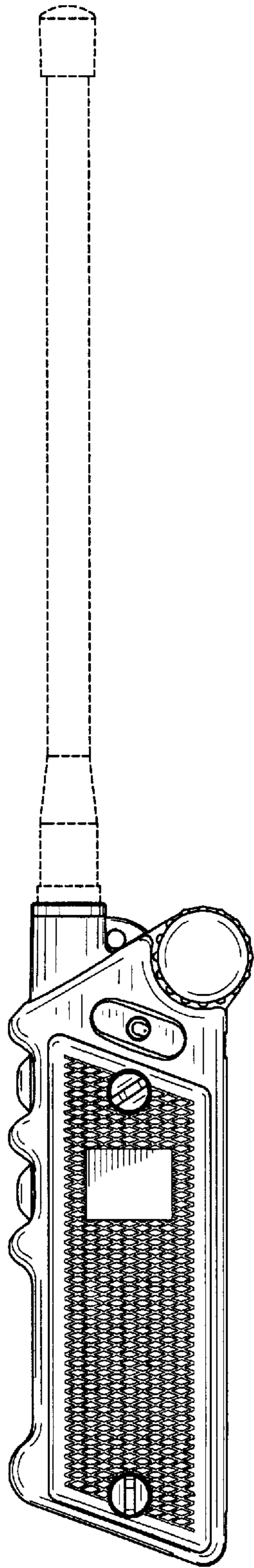

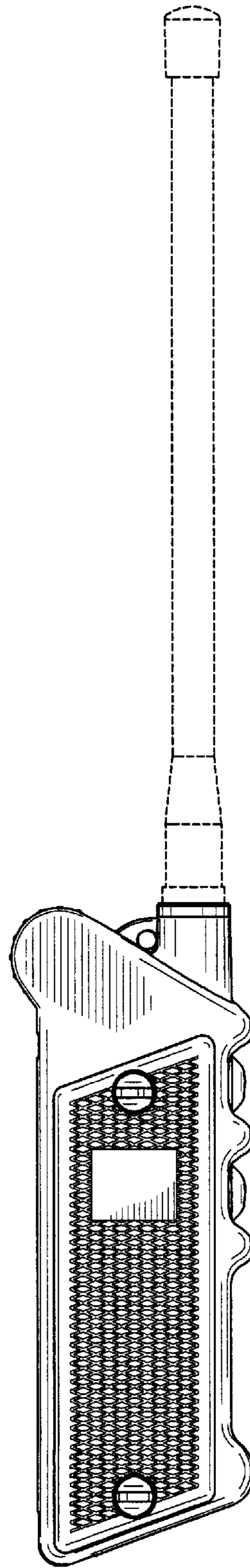

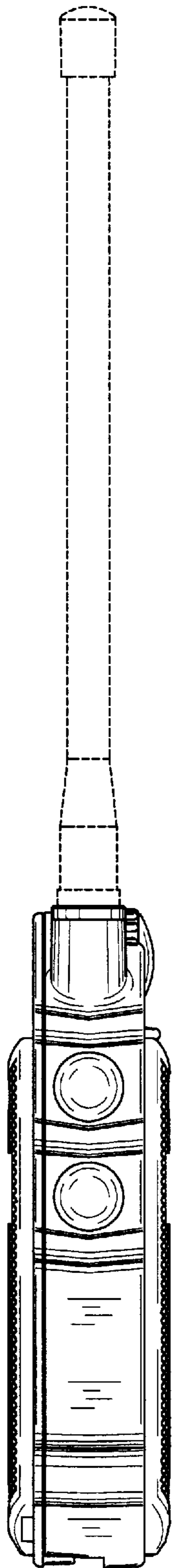

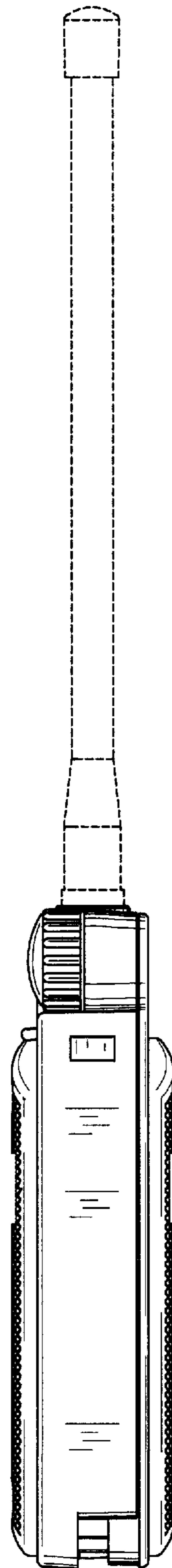

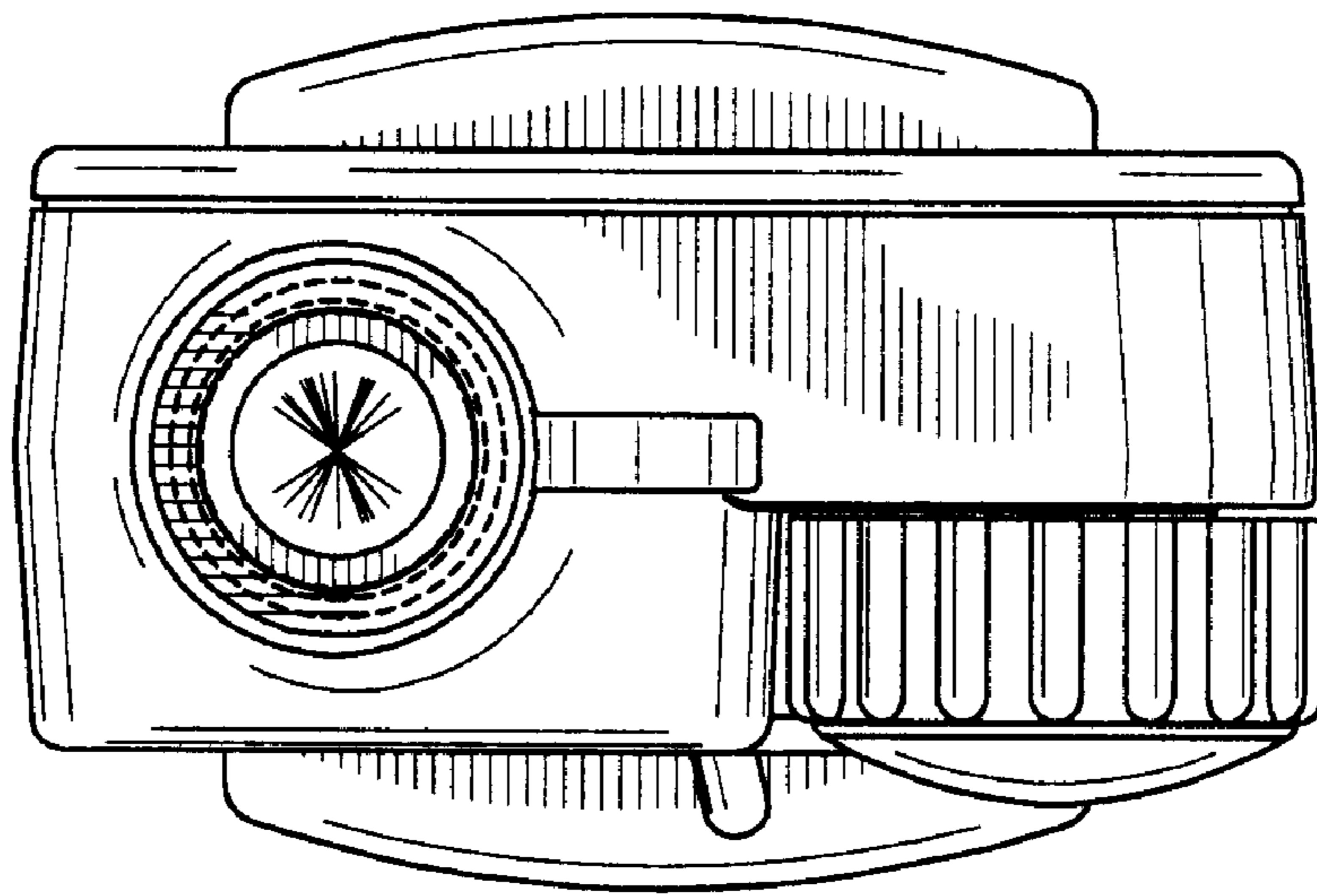

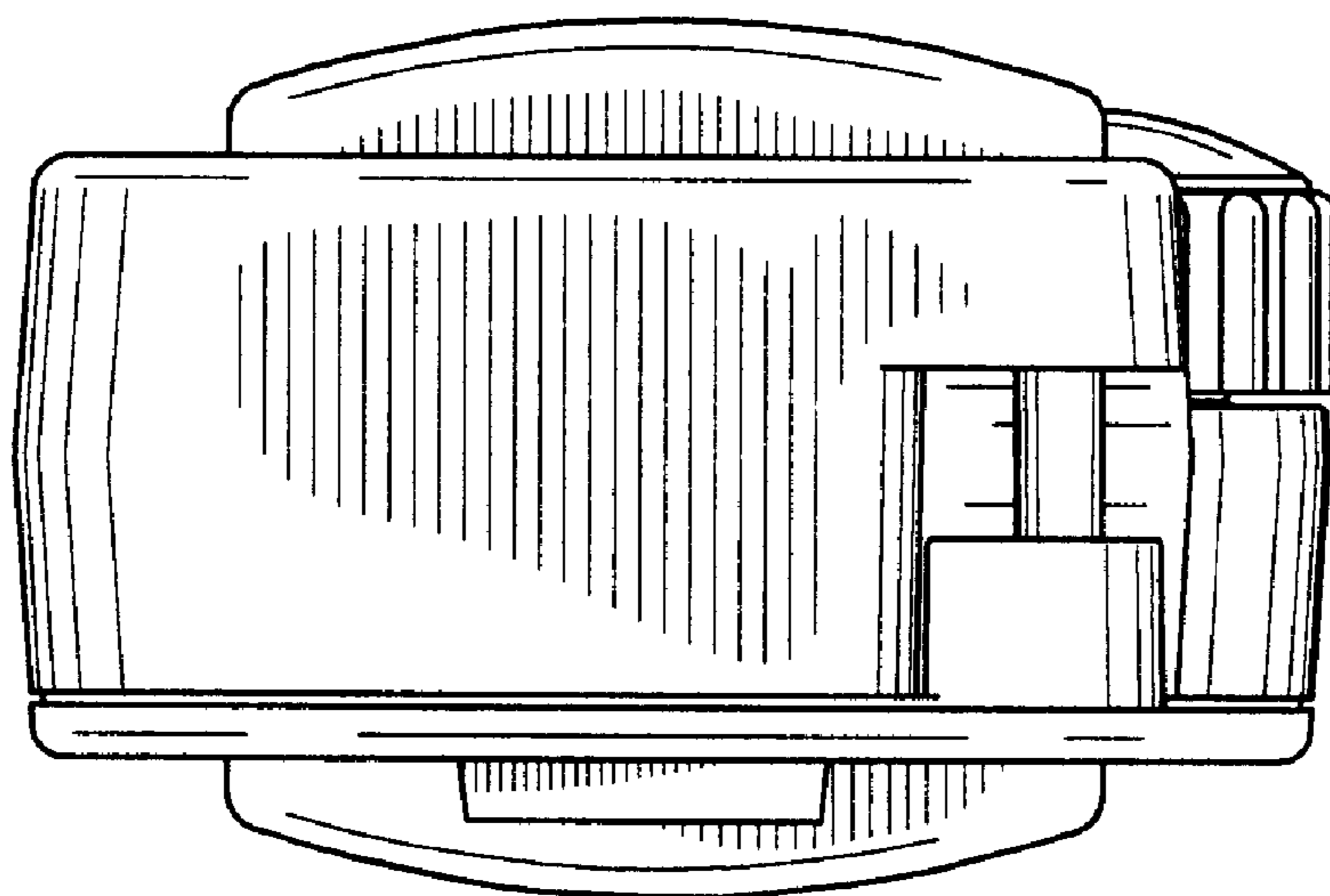
