(57) **CLAIM**

The ornamental design for a microphone boom for a communications headset, as shown and described.

DESCRIPTION

This application is related to U.S. design patent application serial numbers (not yet known) both filed concurrently herewith.

FIG. 1 is an upper left front perspective view of a microphone boom for a communications headset showing our new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a right side elevation view thereof; and,

FIG. 7 is a left side elevation view thereof.

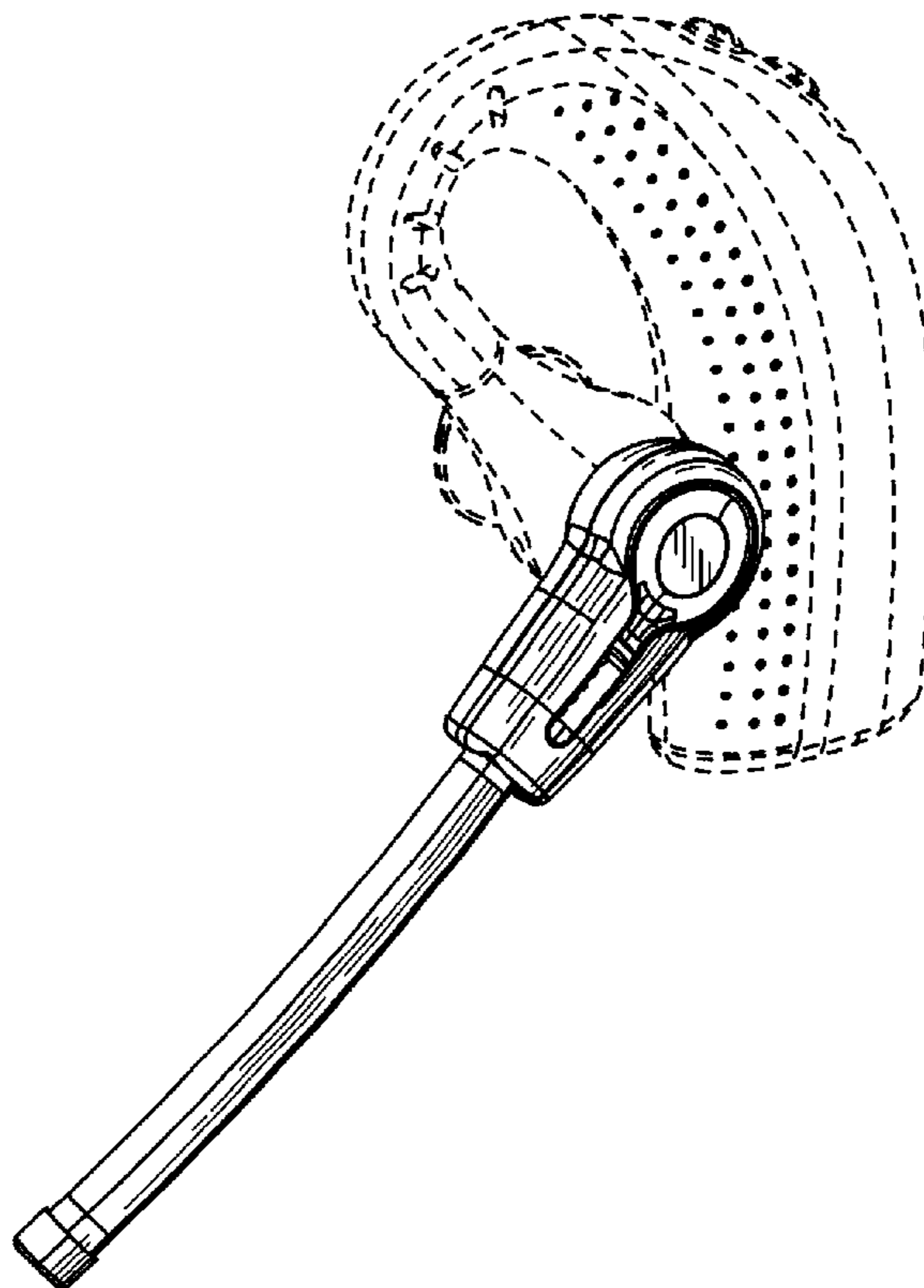

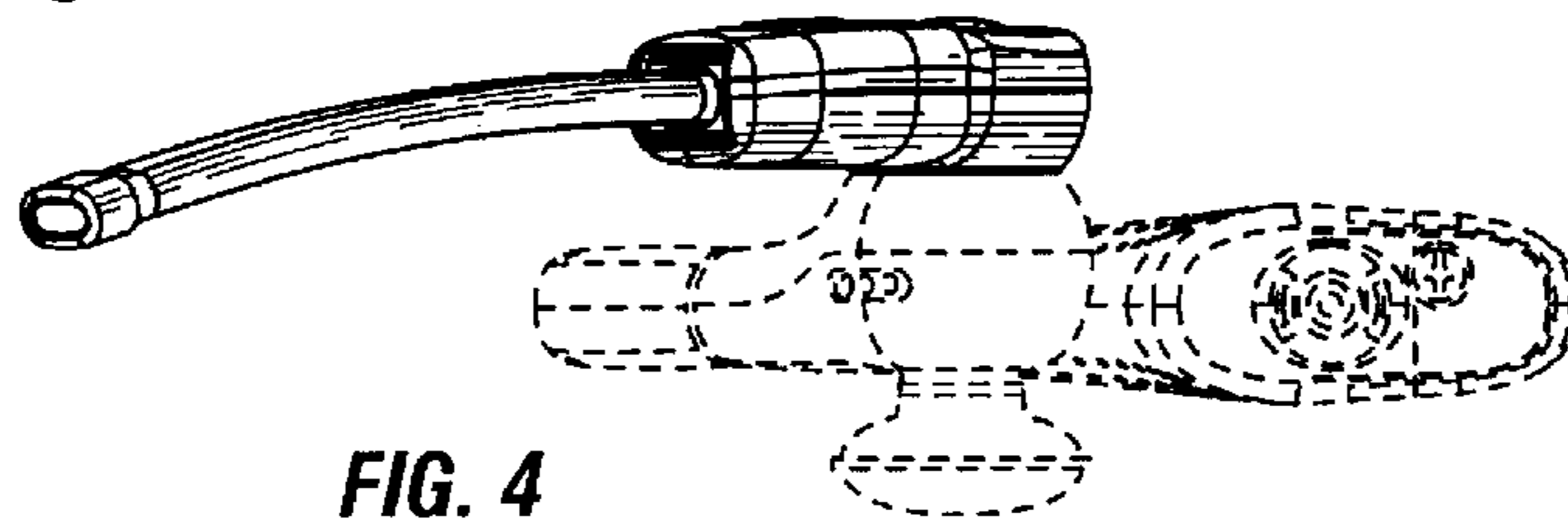
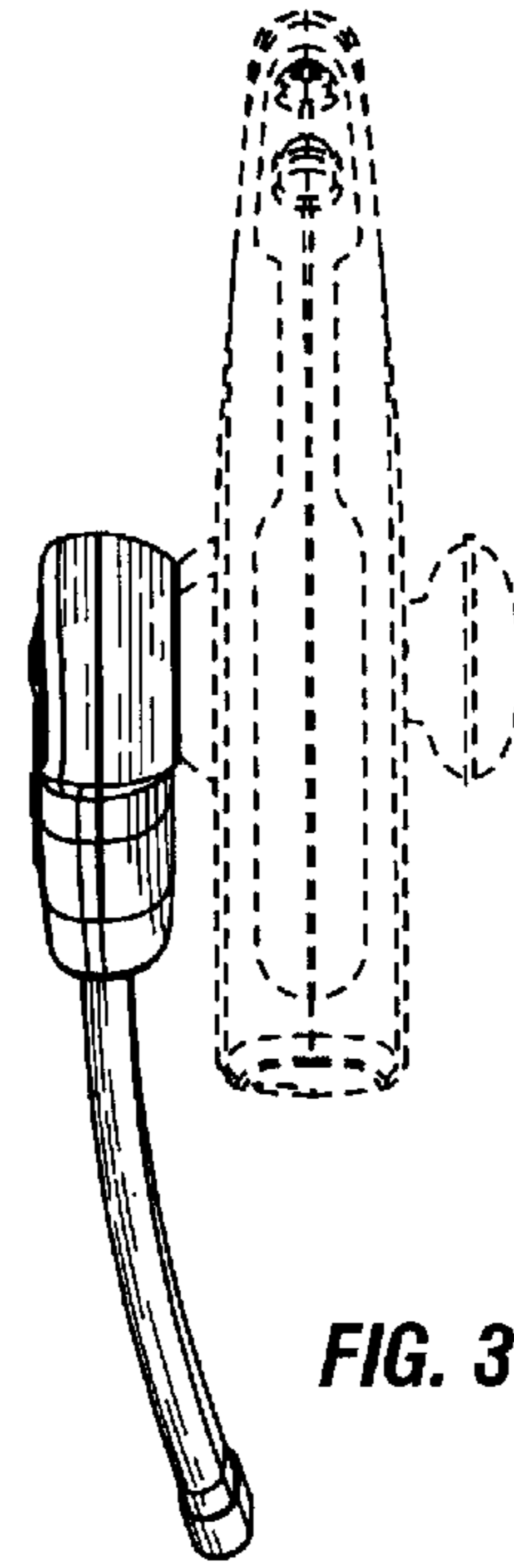
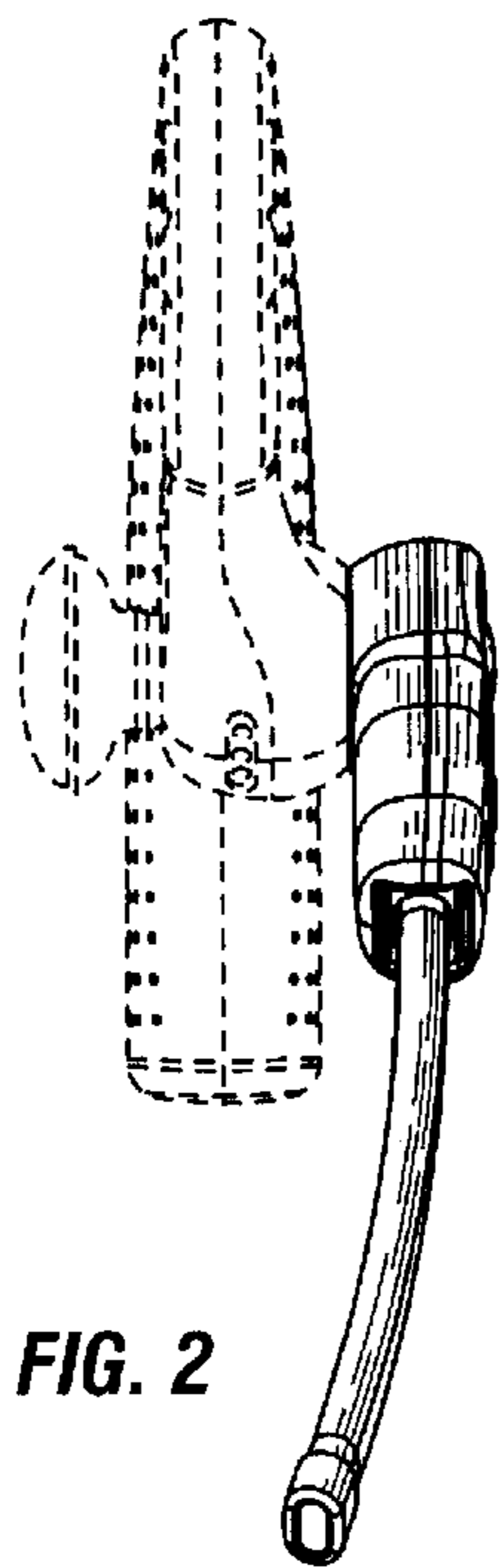
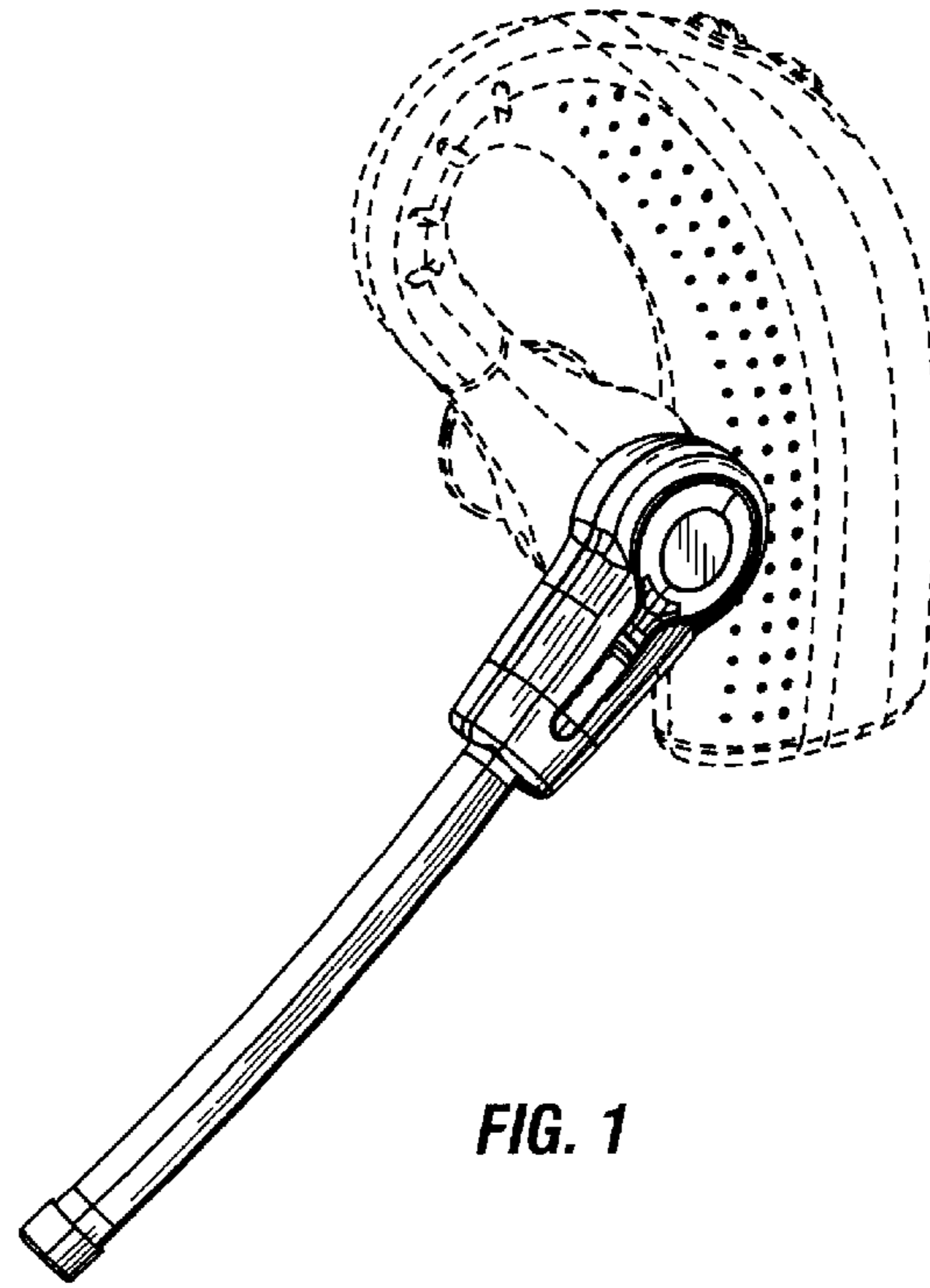

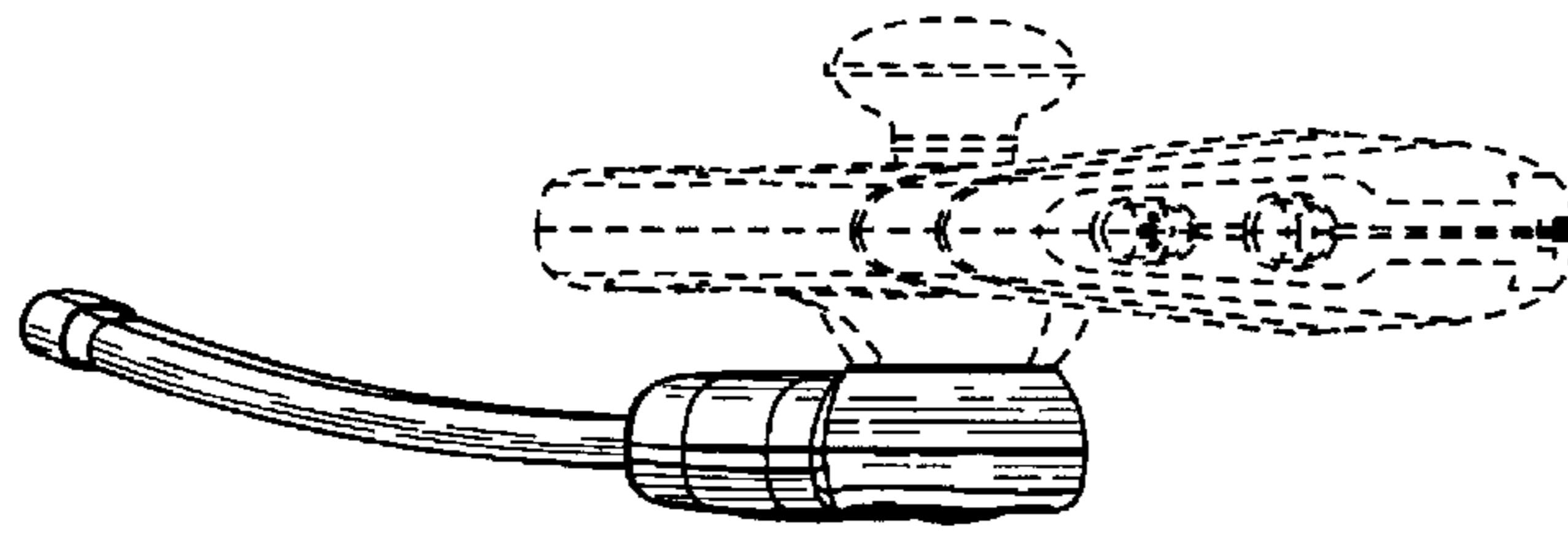

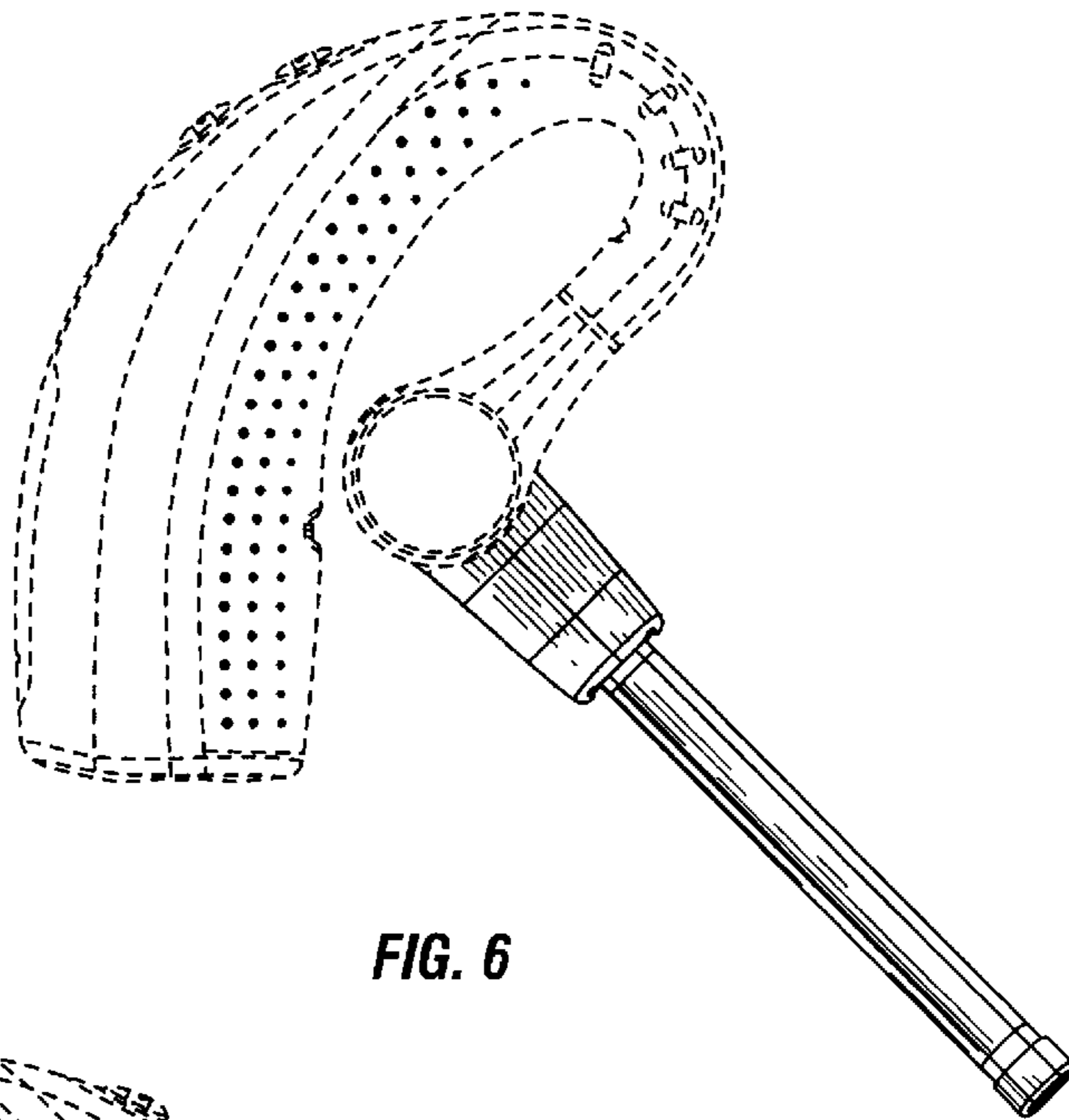

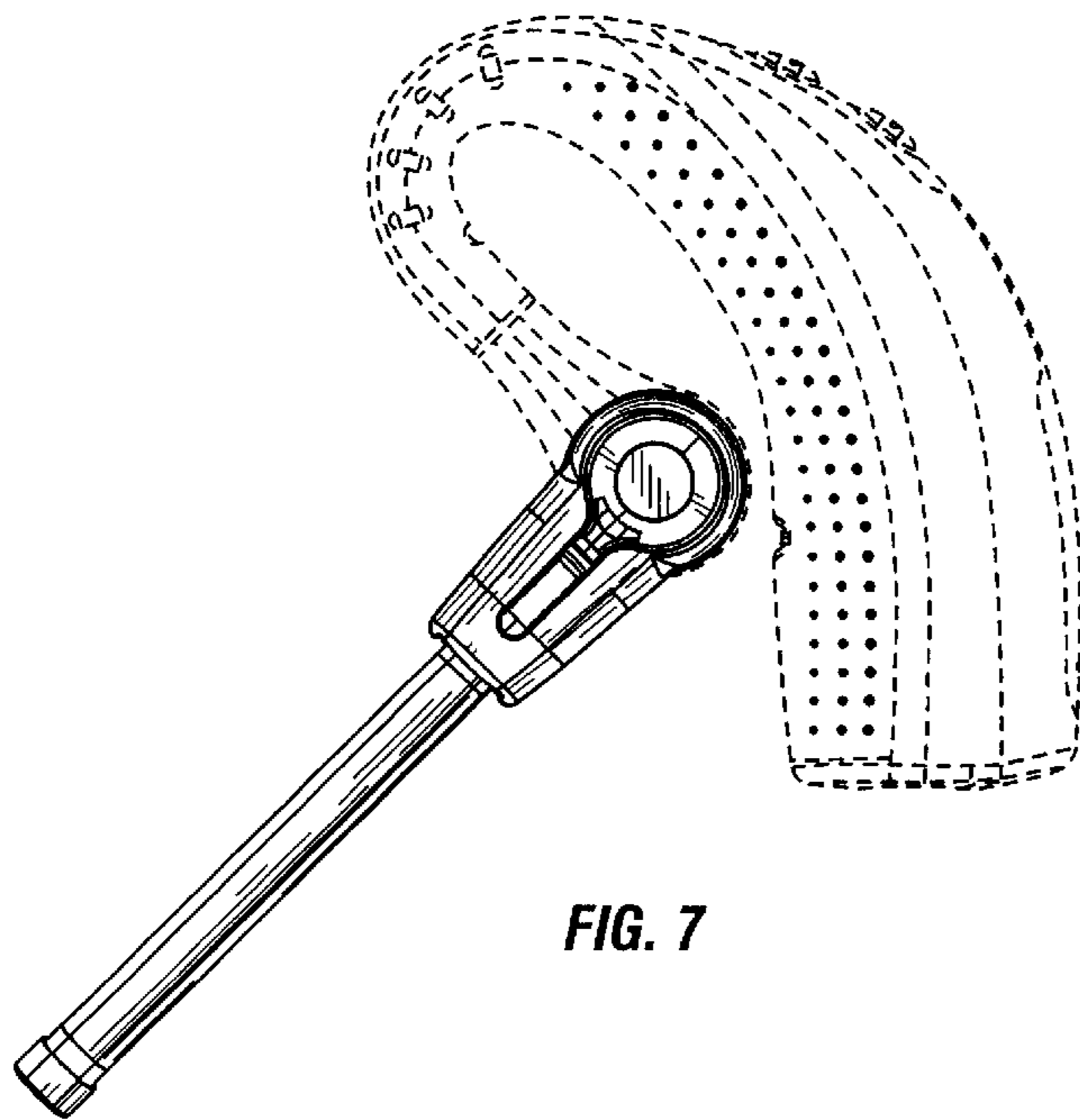
