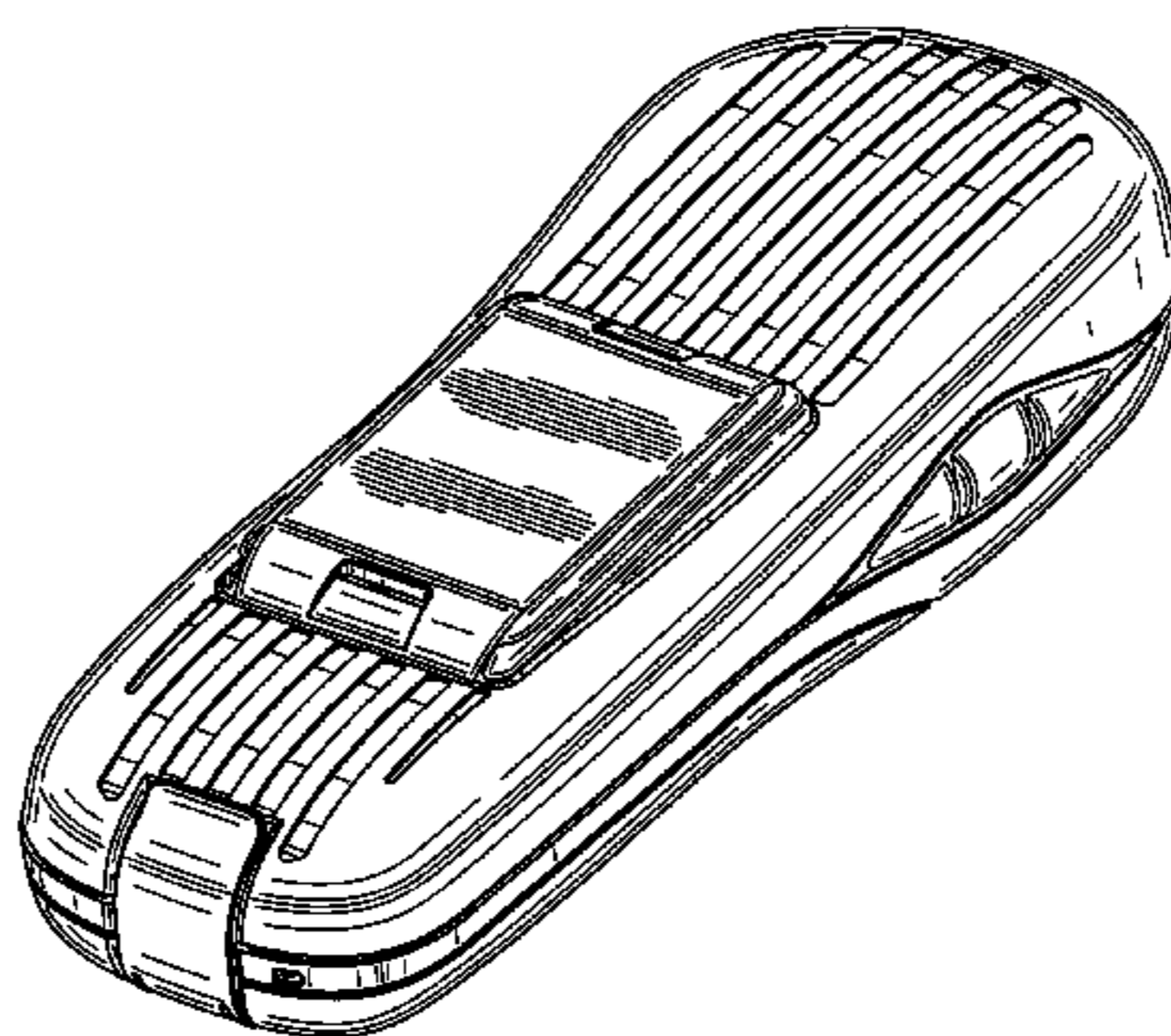
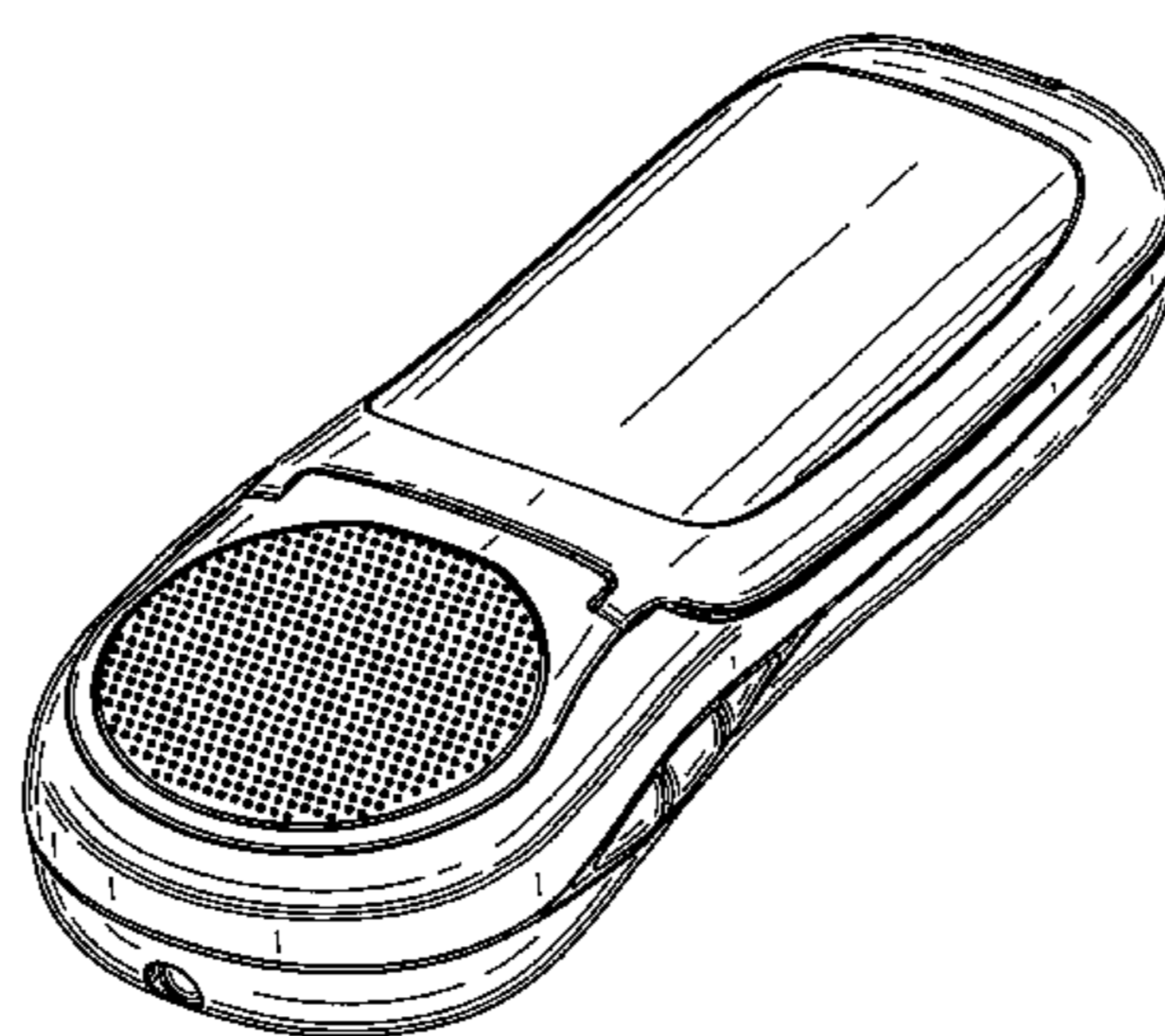
(57) **CLAIM**

The ornamental design for a handsfree carrying case for a handset, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a handsfree carrying case for a handset showing our new design;
FIG. 2 is a rear view thereof;
FIG. 3 is a right side view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a perspective front view thereof;
FIG. 8 is a perspective rear view thereof;
FIG. 9 is a perspective front view thereof with a cover portion shown in an open position; and,
FIG. 10 is a perspective view thereof the opposite direction with a cover portion shown in an open position.

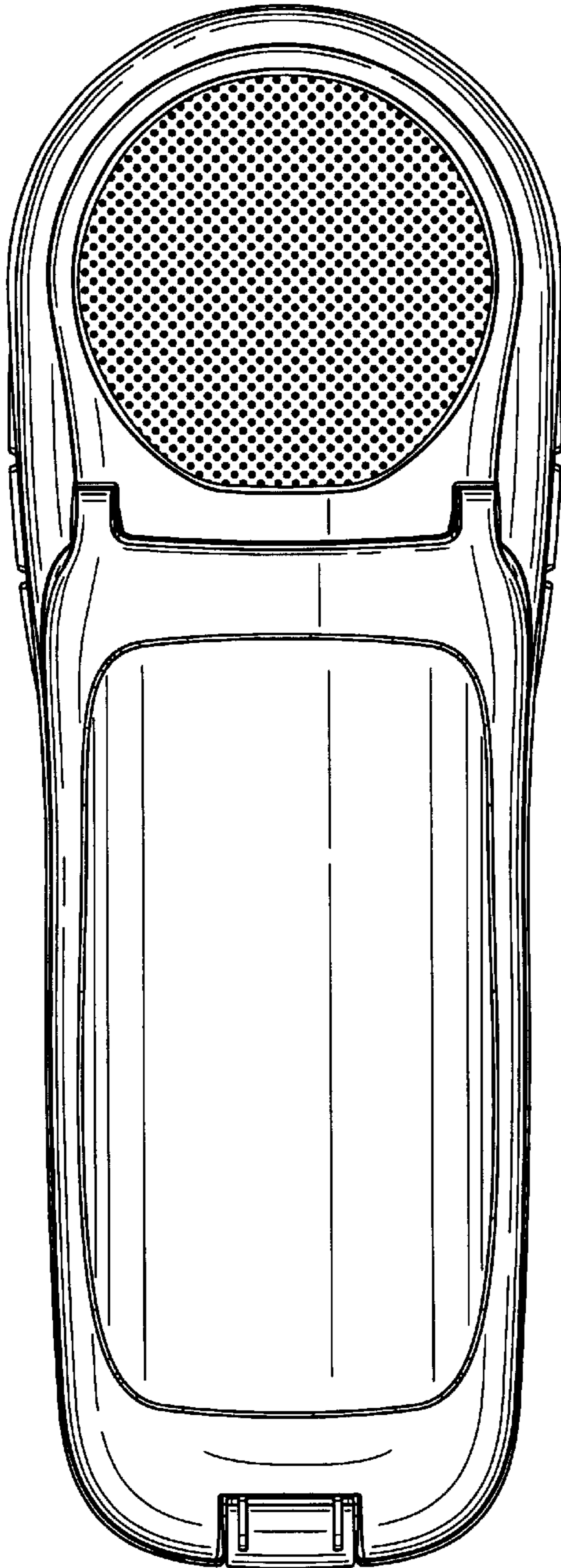

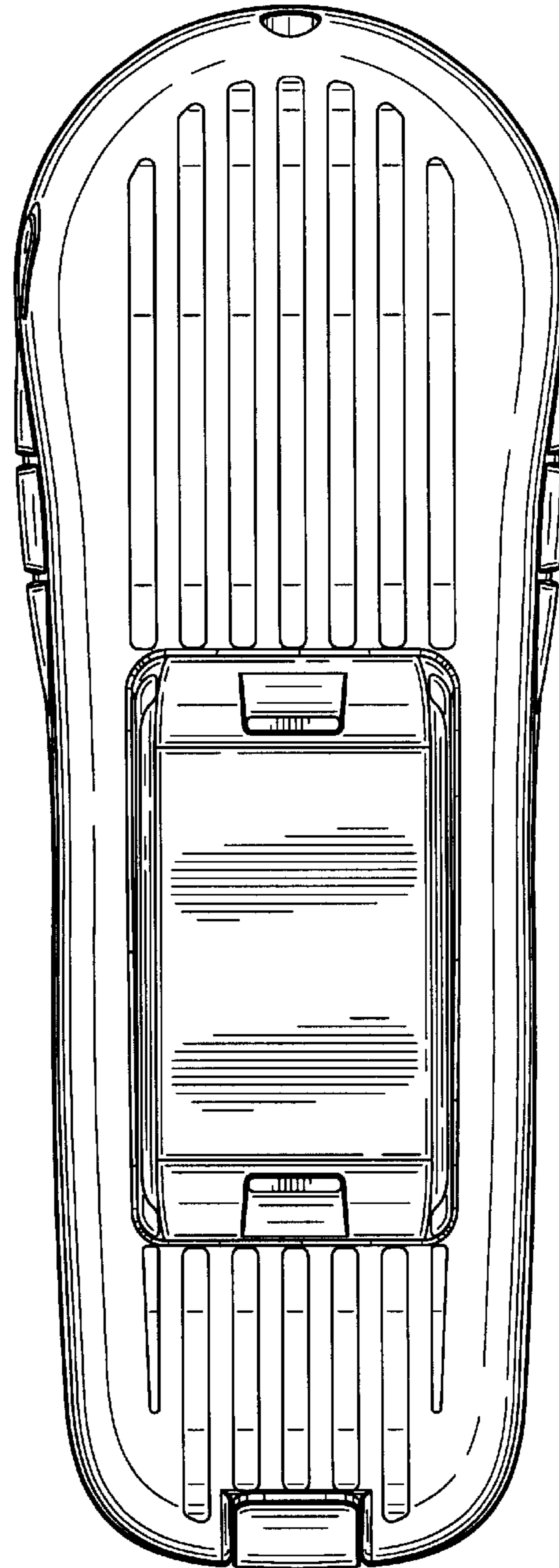

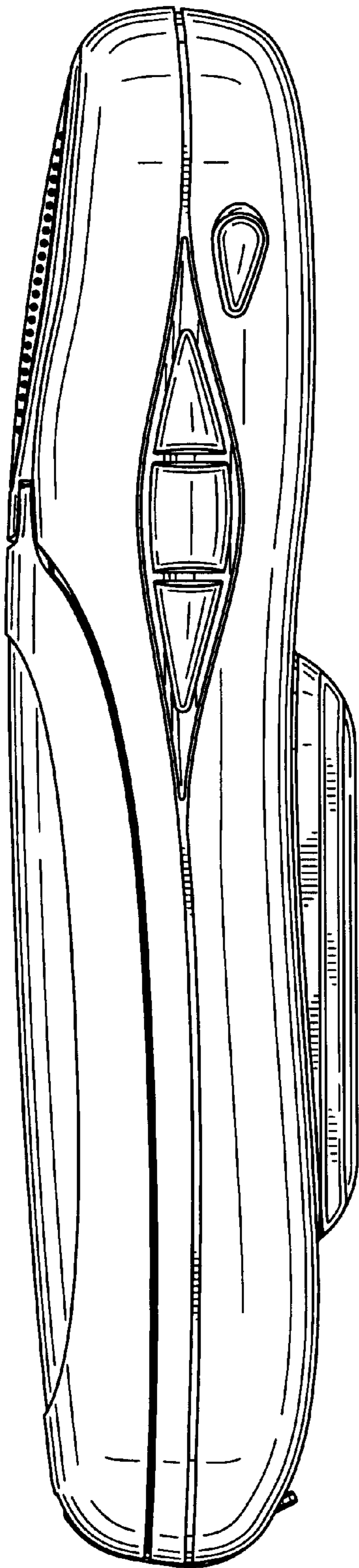

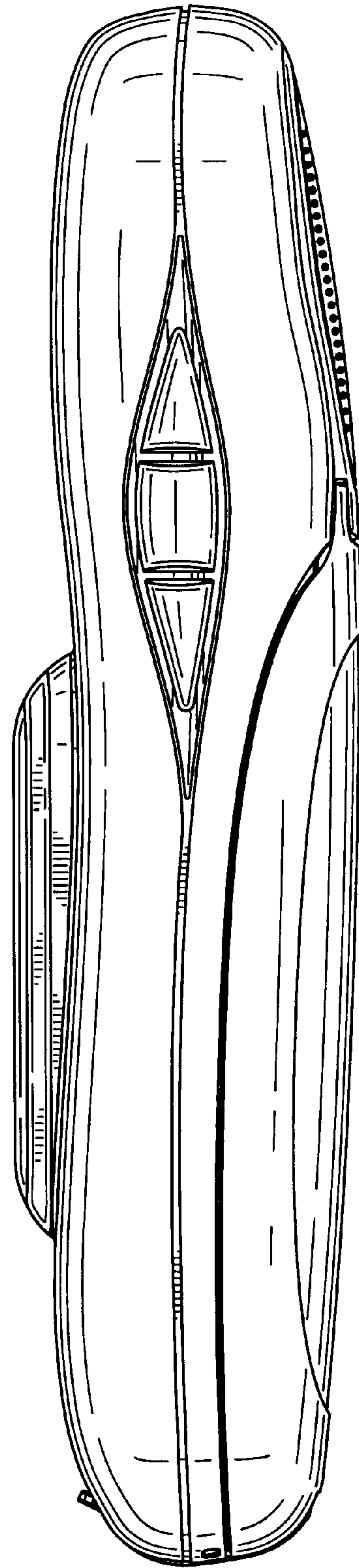

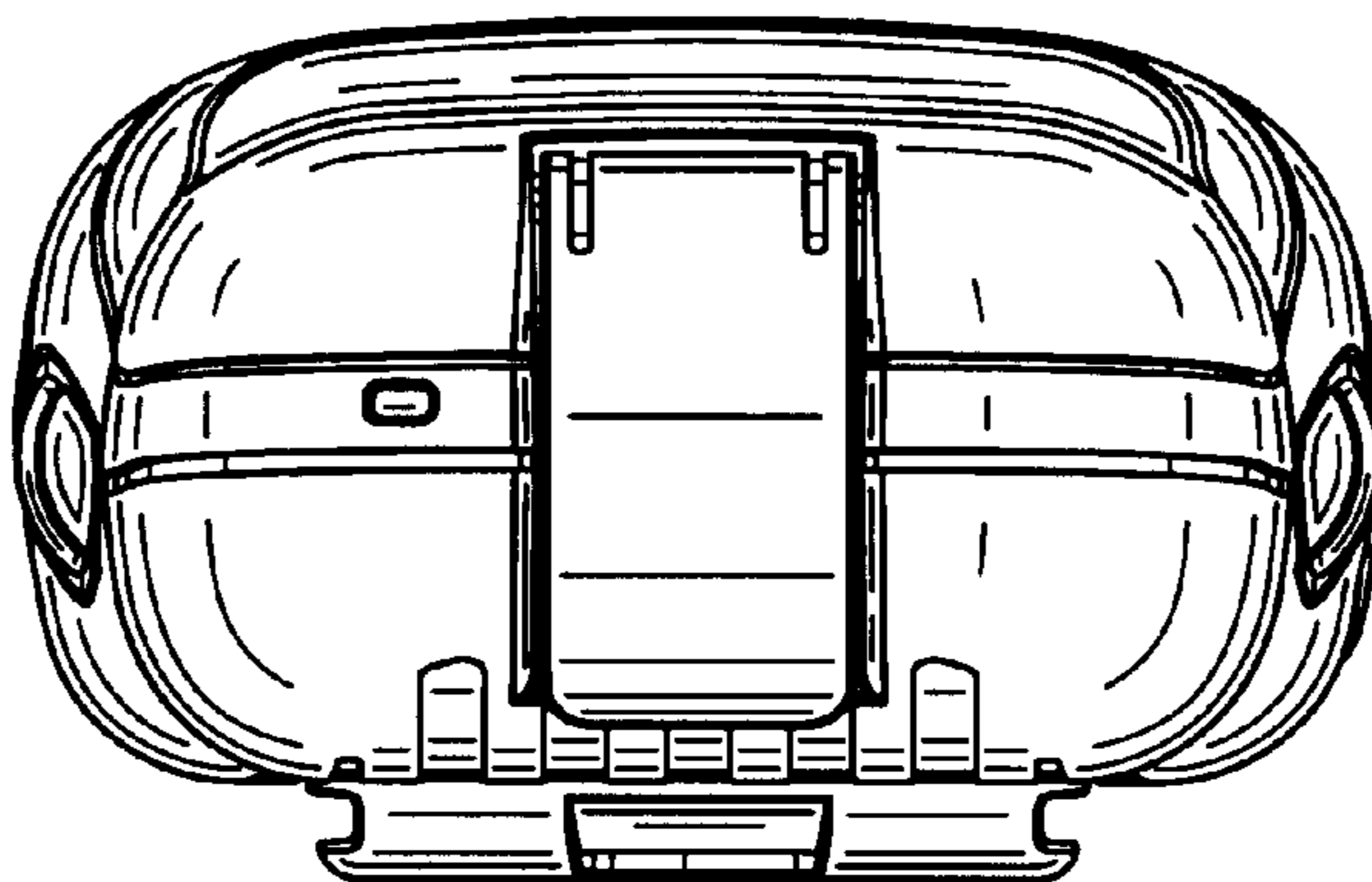

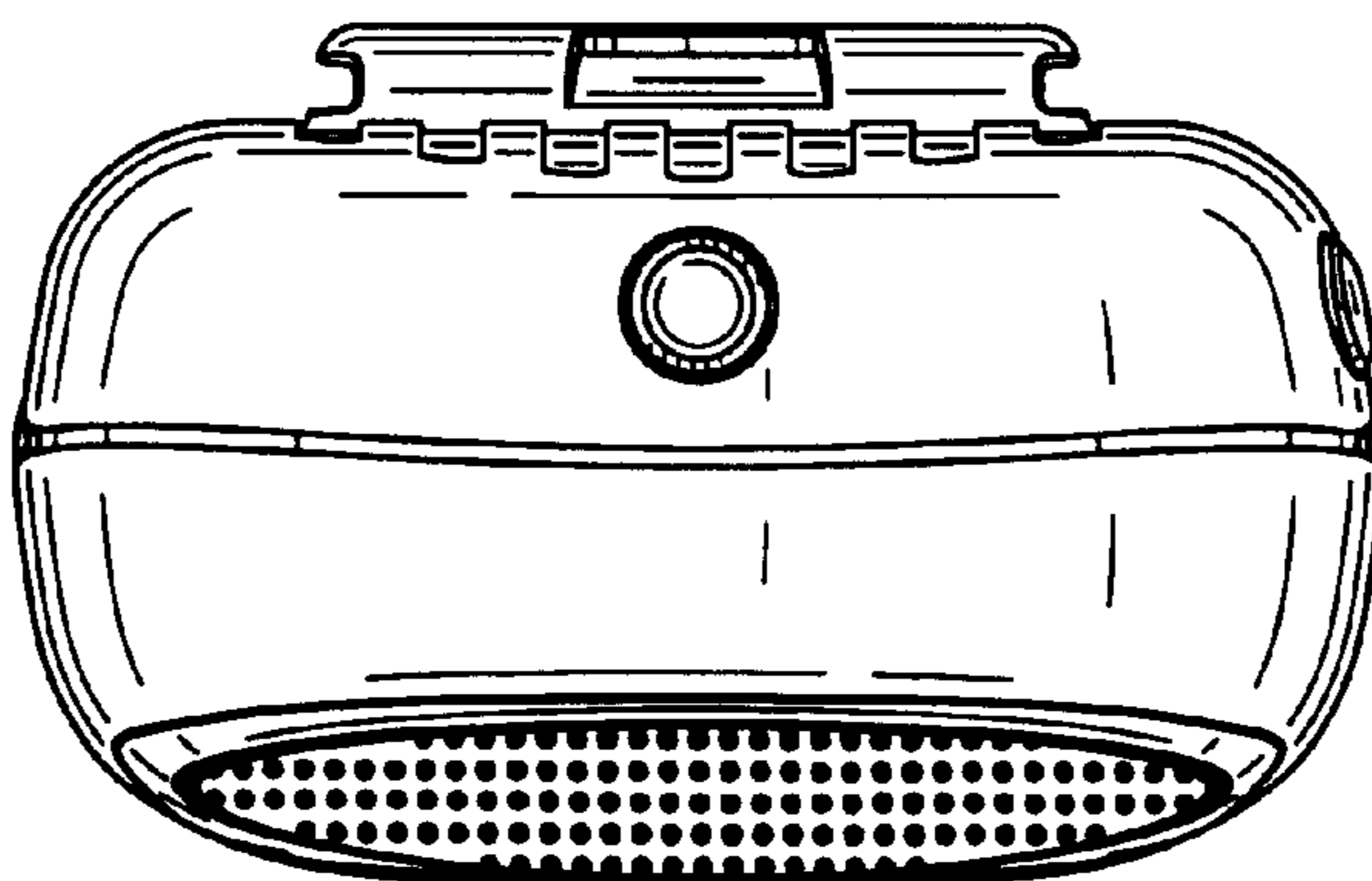

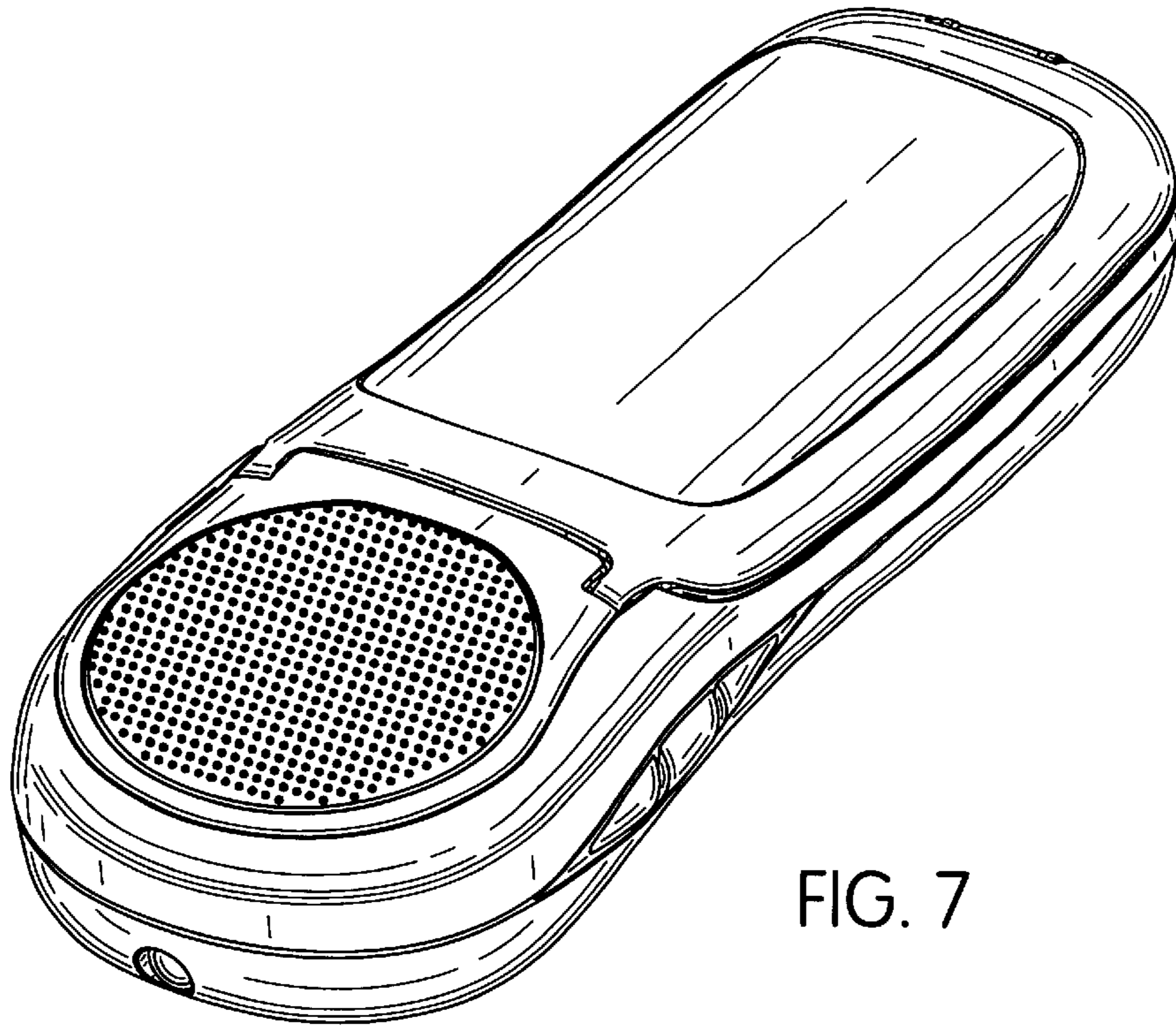

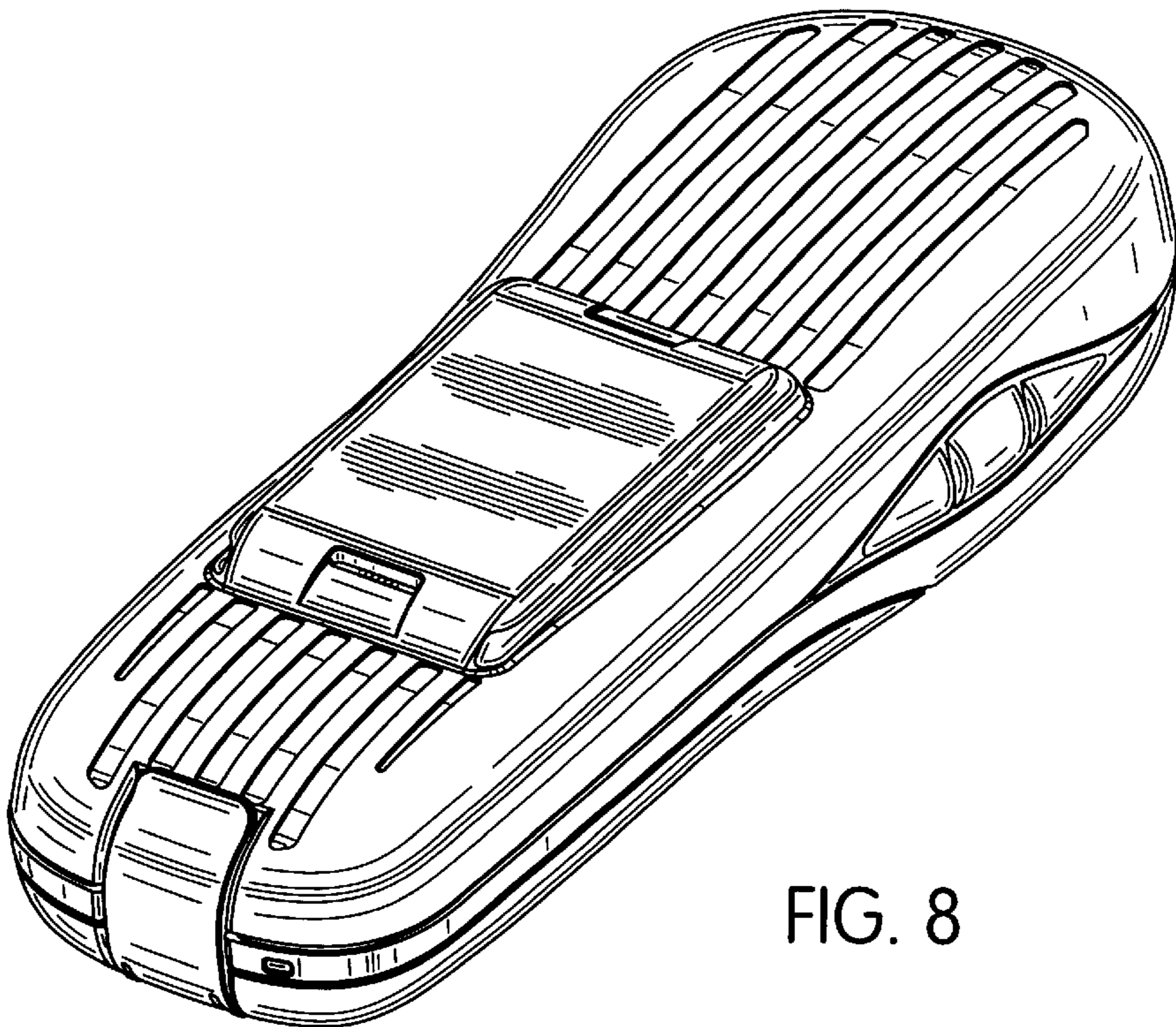

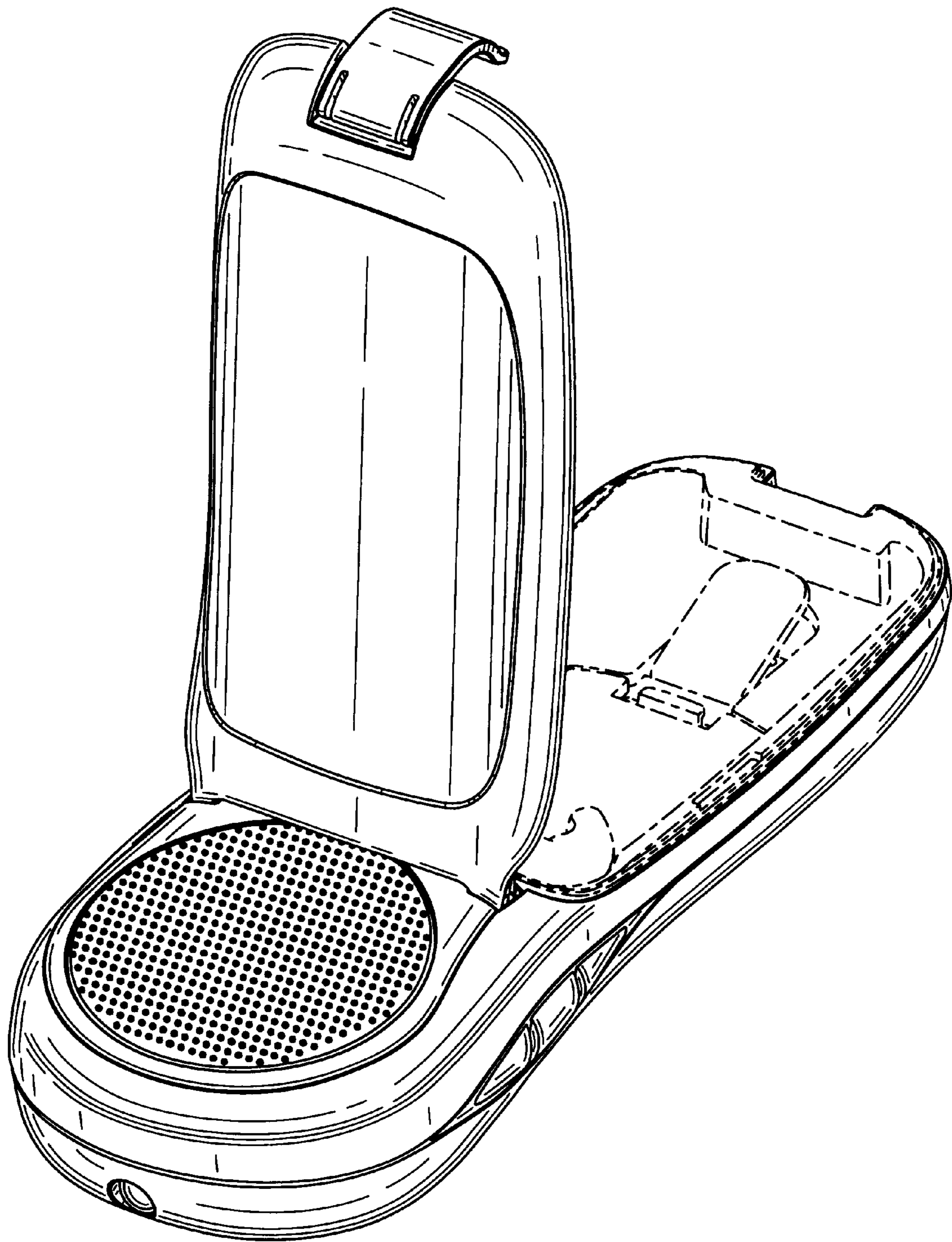

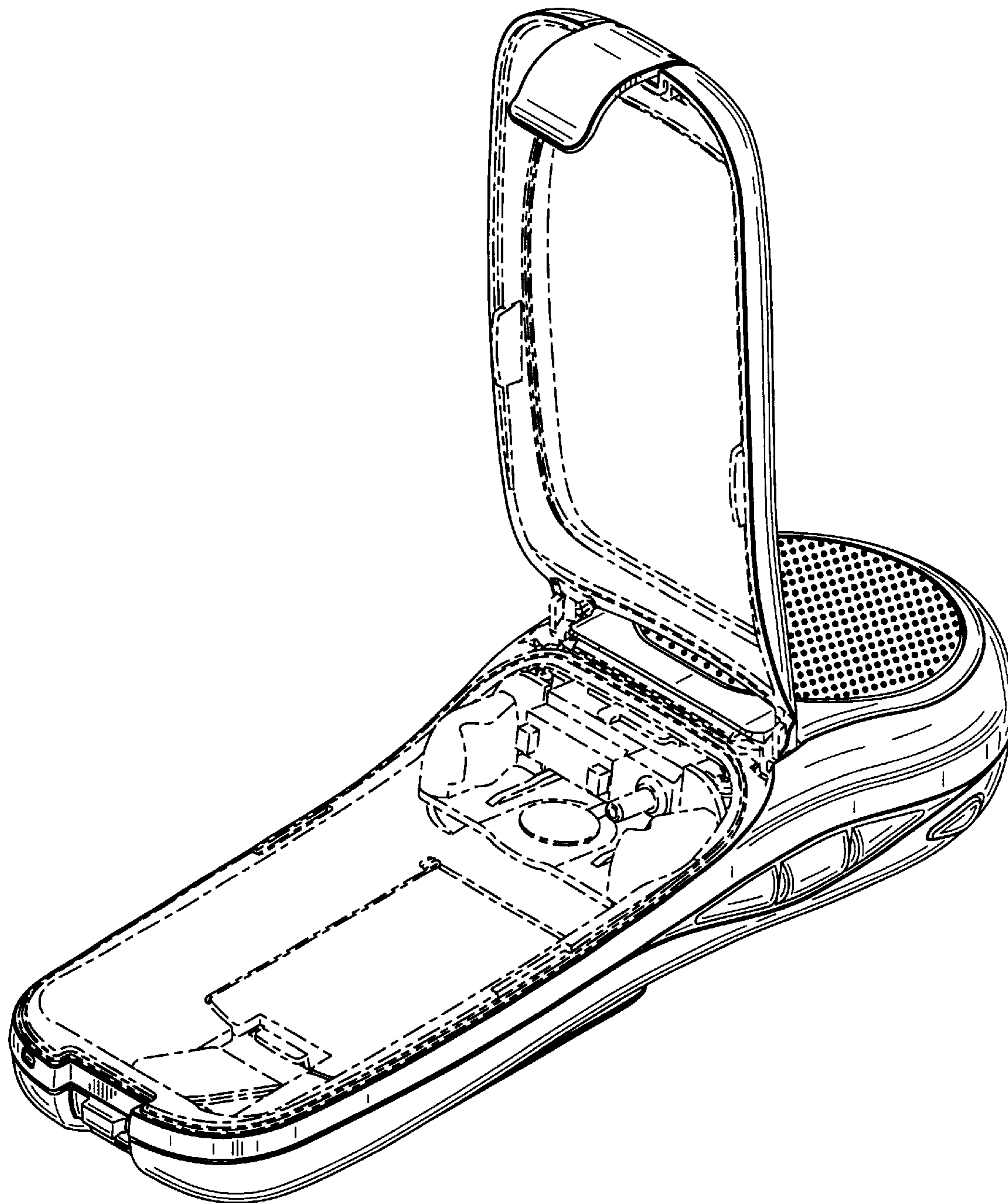
