(57) **CLAIM**

The ornamental design for a video call stand for a handset, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a video call stand for a headset, showing our new design shown in an open position;

FIG. 2 is another perspective view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a front elevational view thereof, shown in closed position;

FIG. 5 is a rear elevational view thereof;

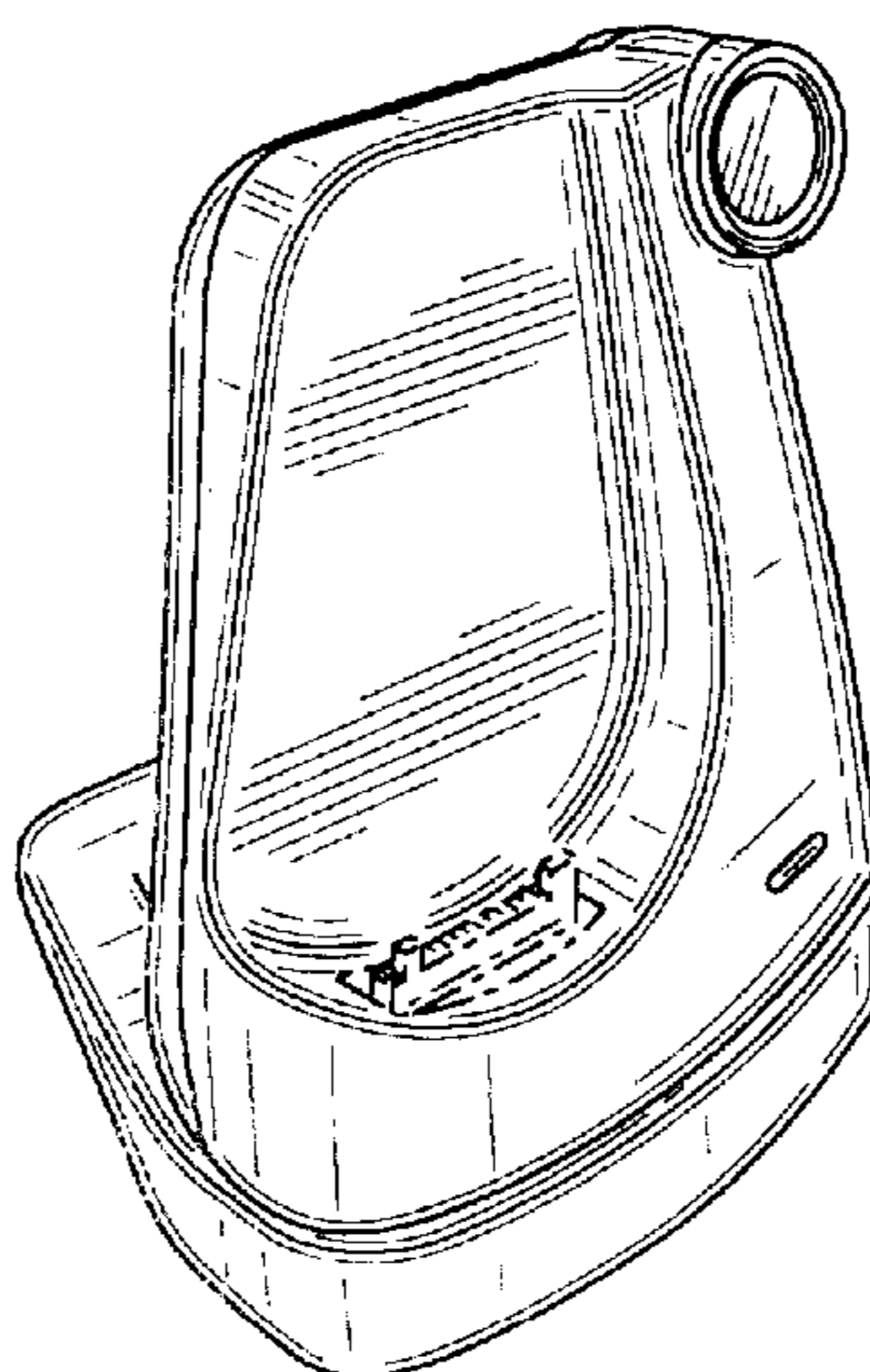
FIG. 6 is a right side elevational view thereof;

FIG. 7 is a left side elevational view thereof; and,

FIG. 8 is a top plan view thereof.

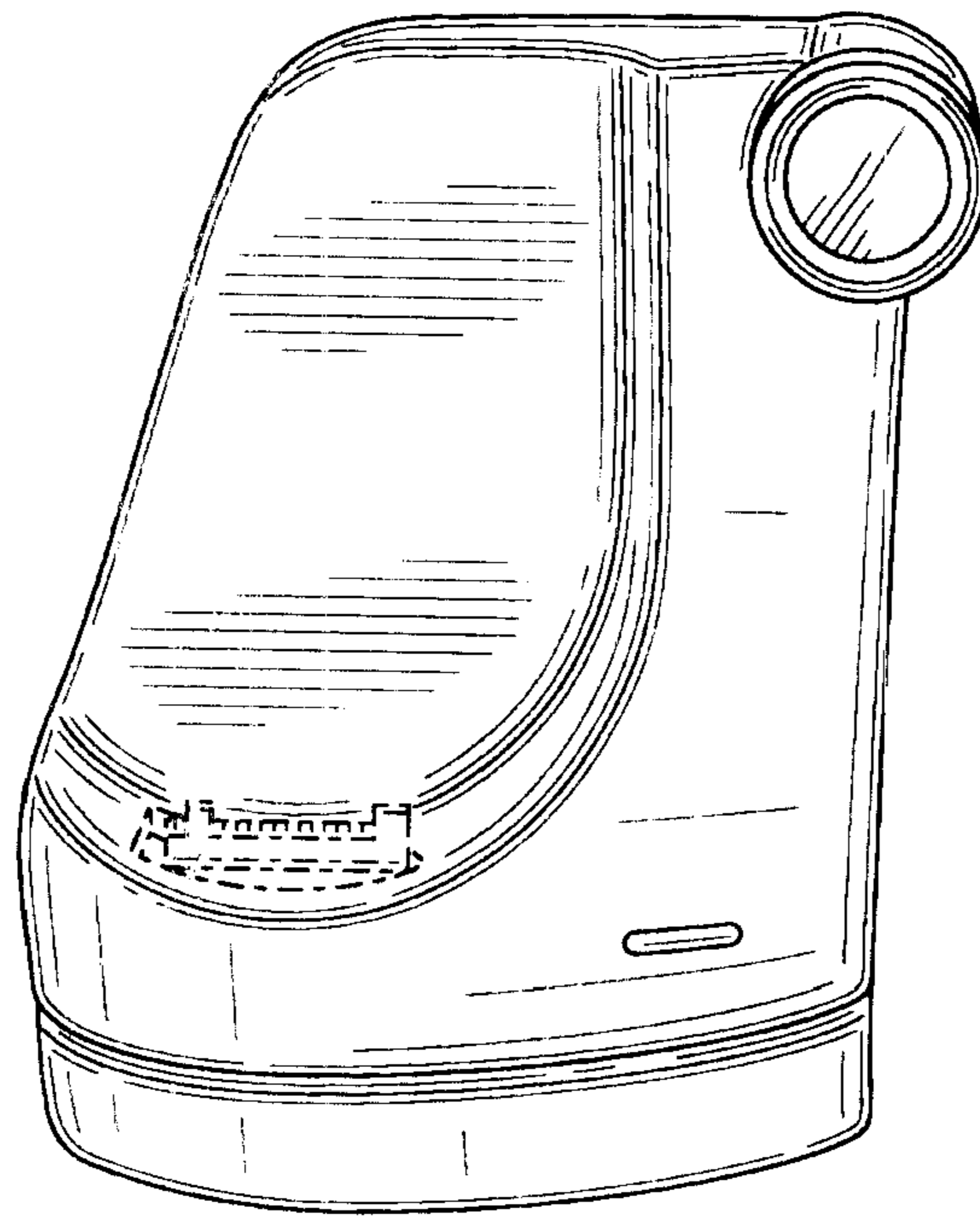

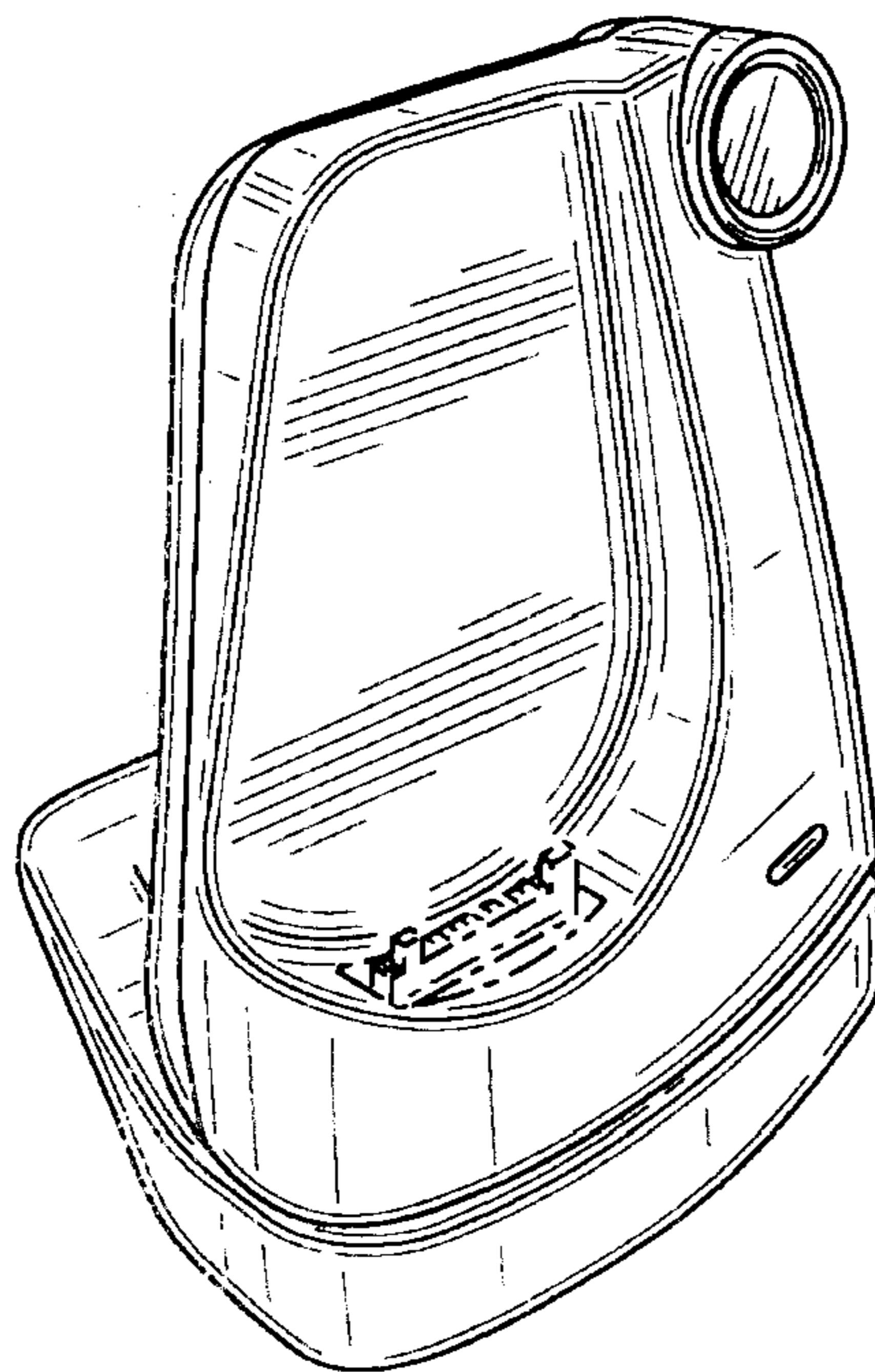

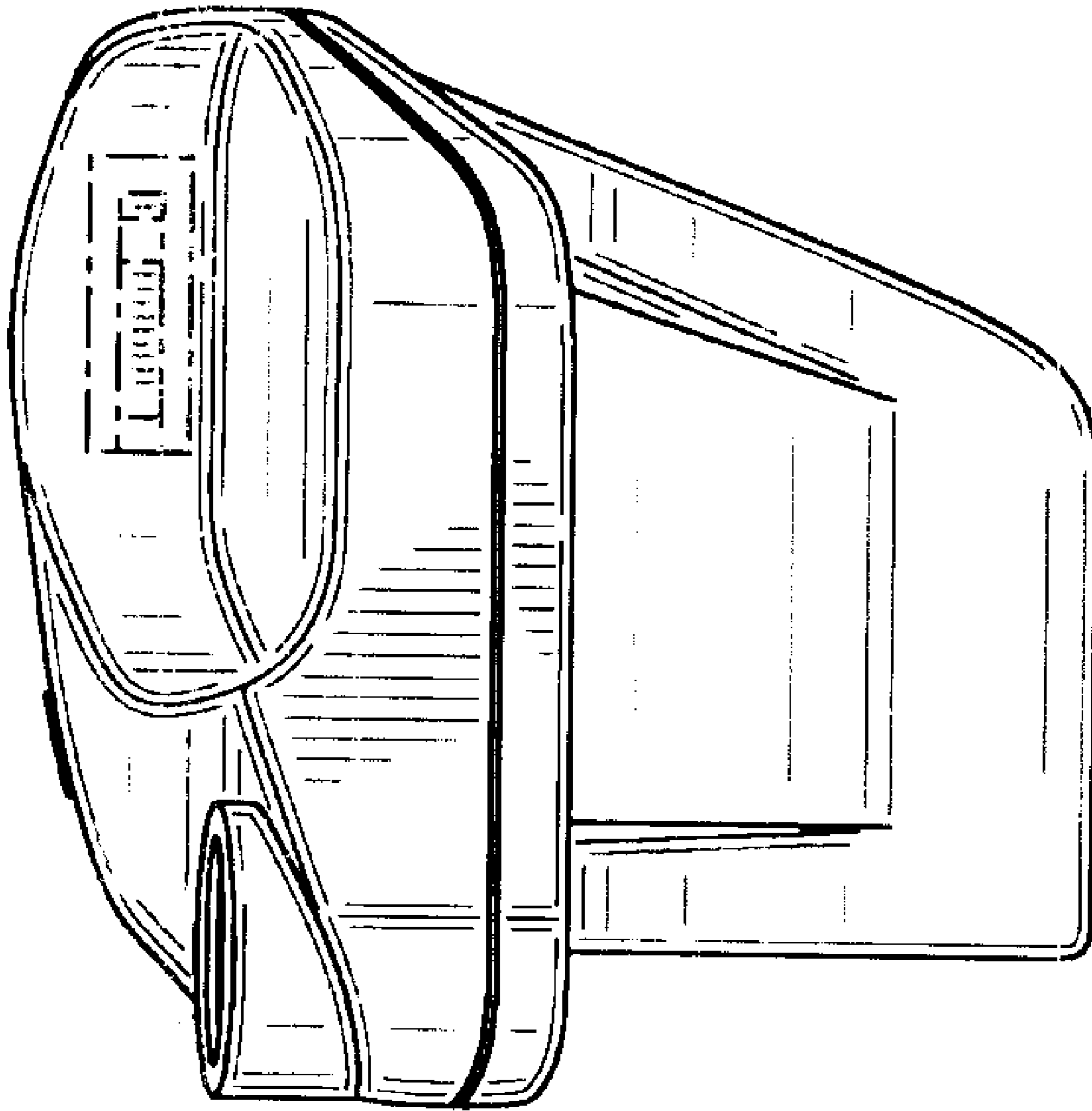

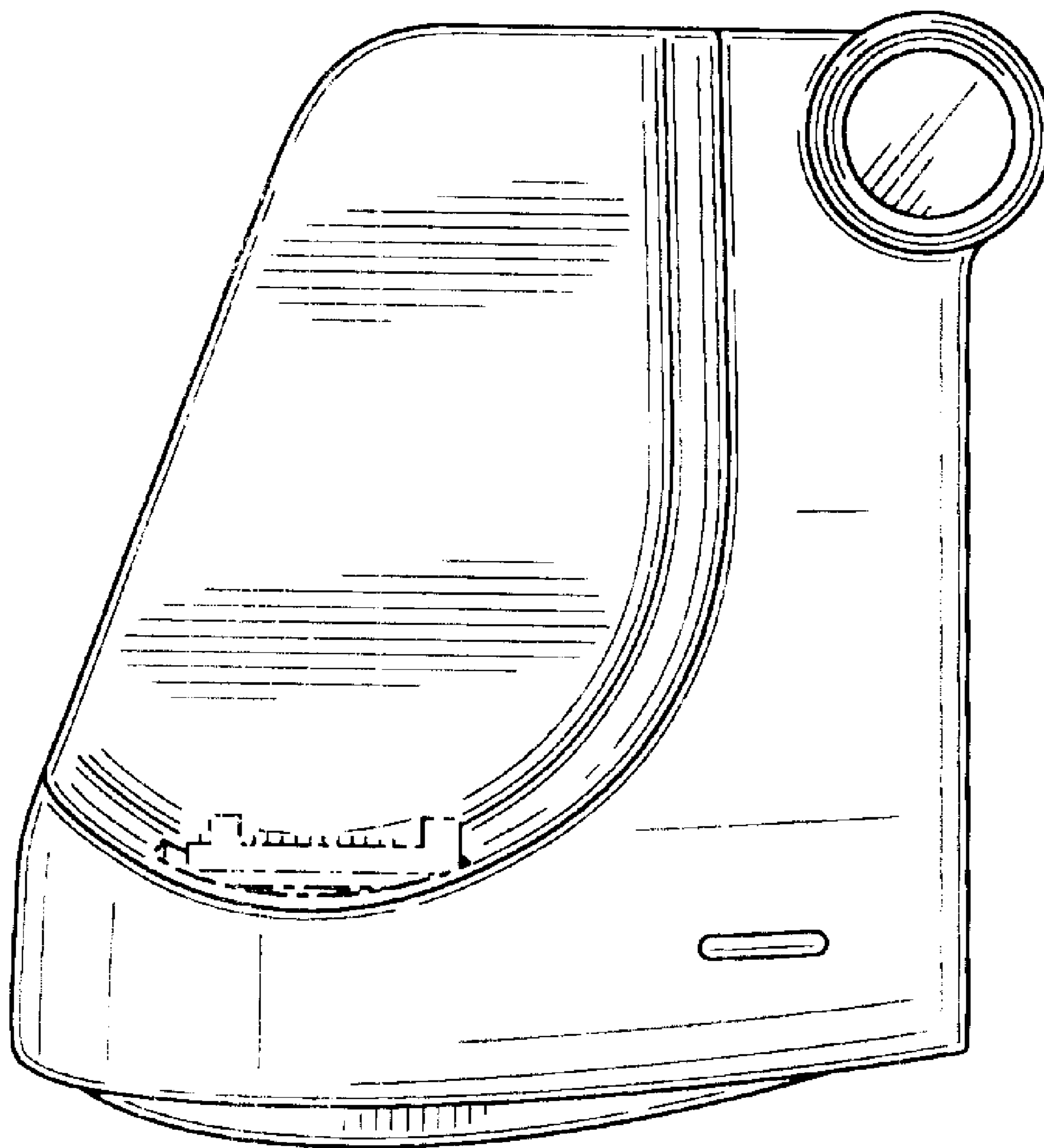

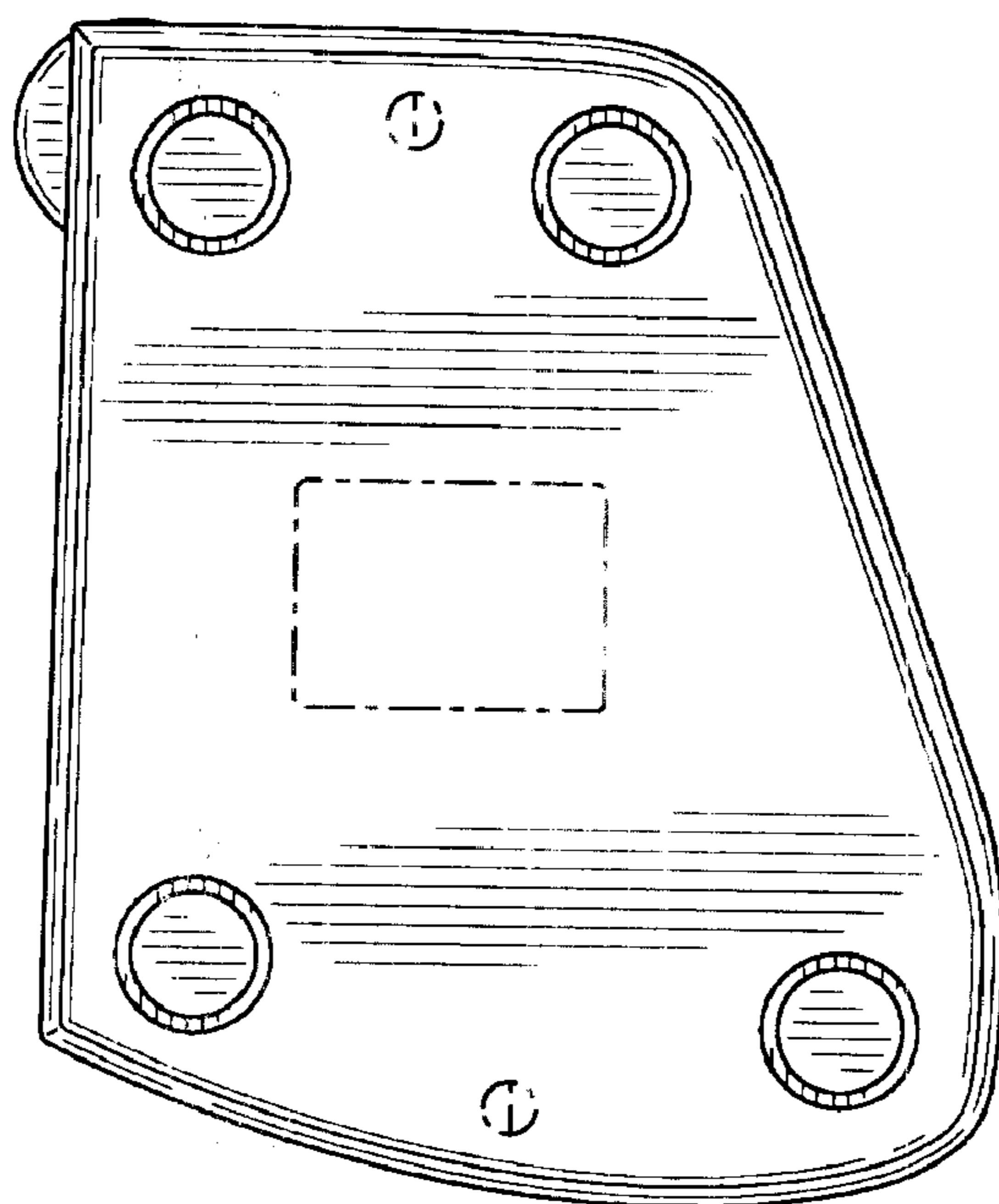

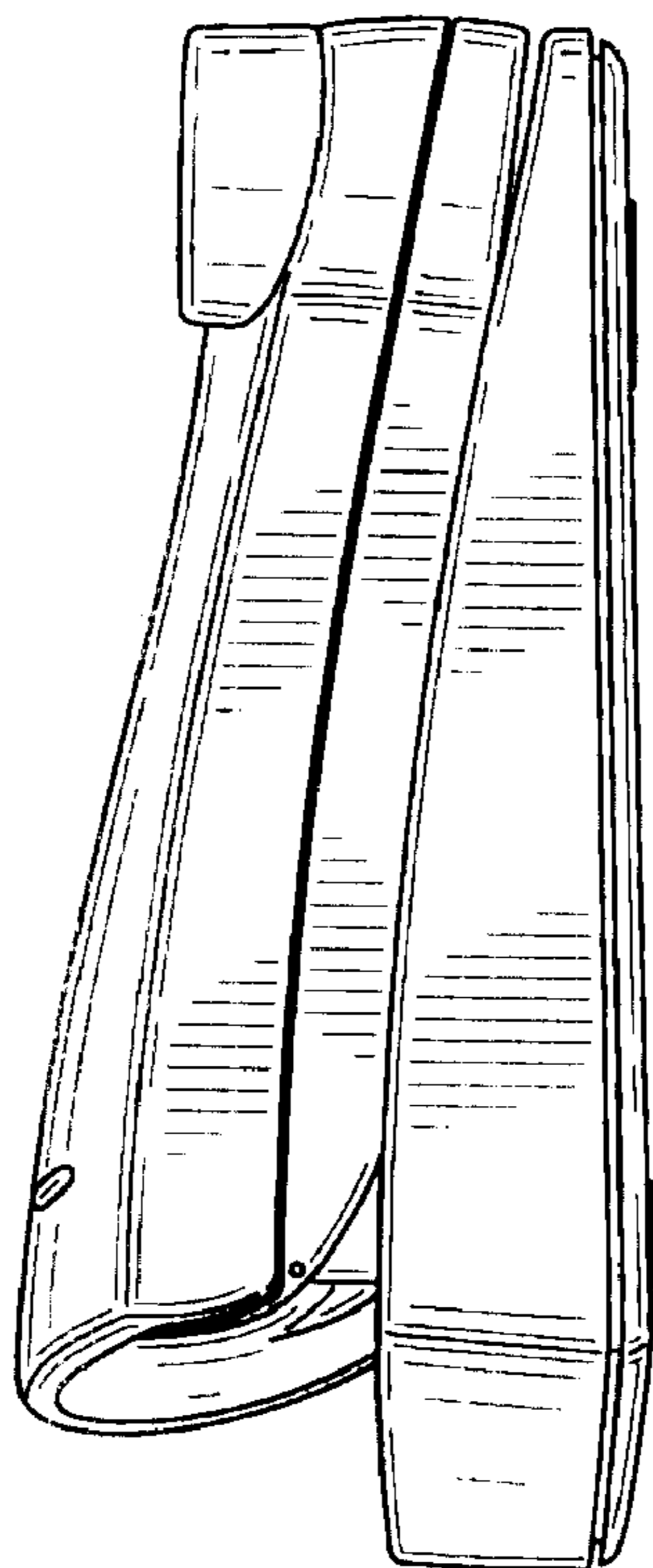

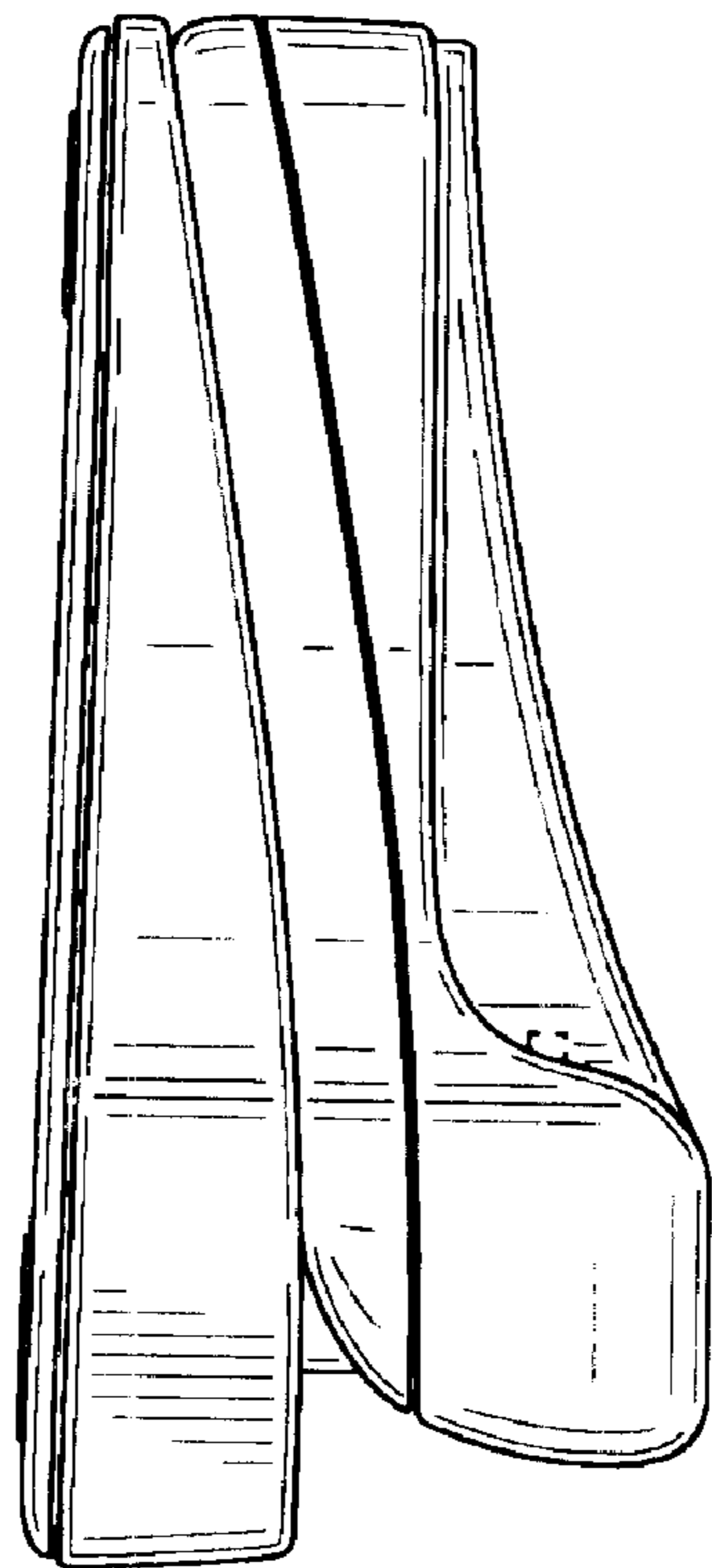

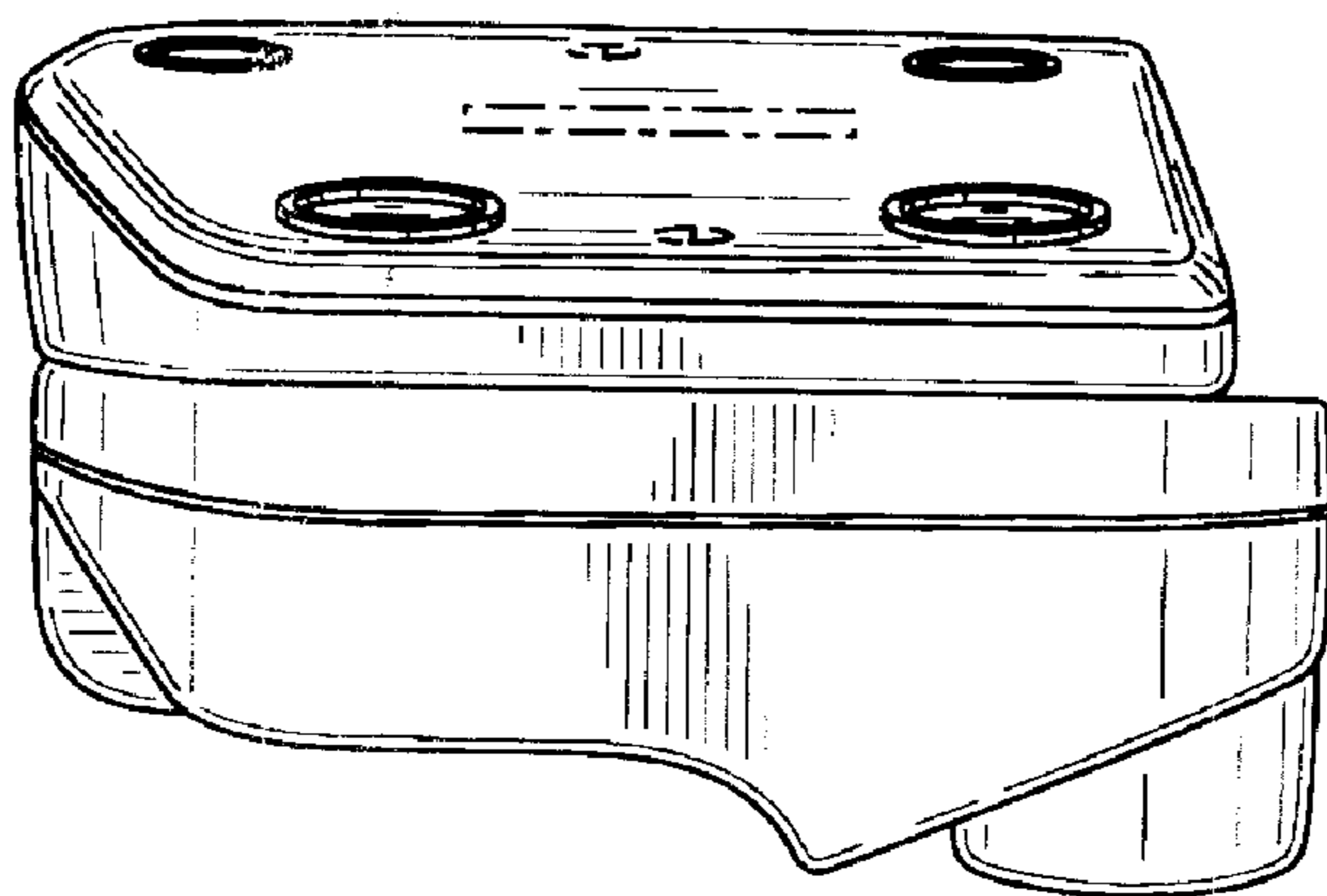
