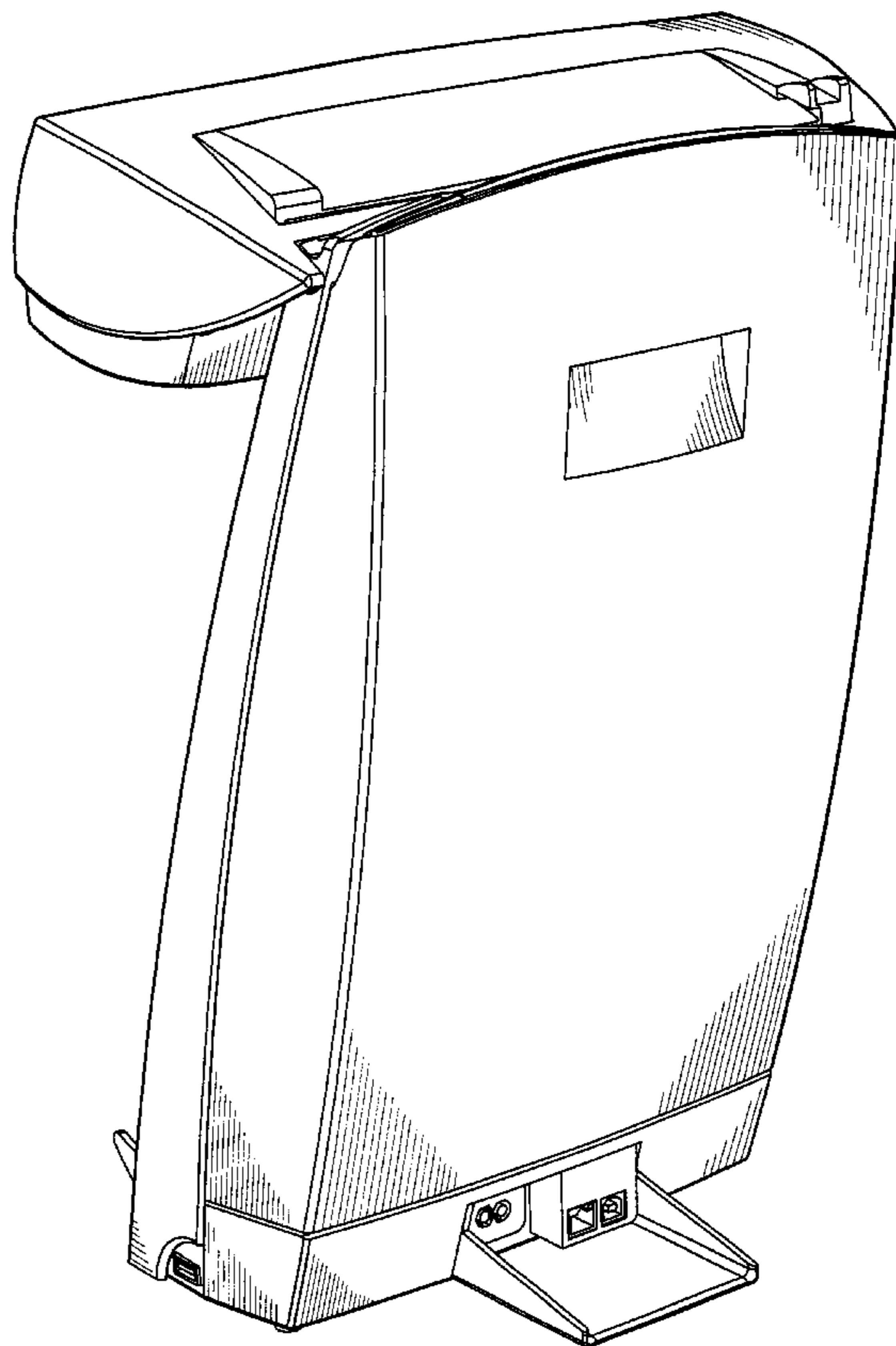
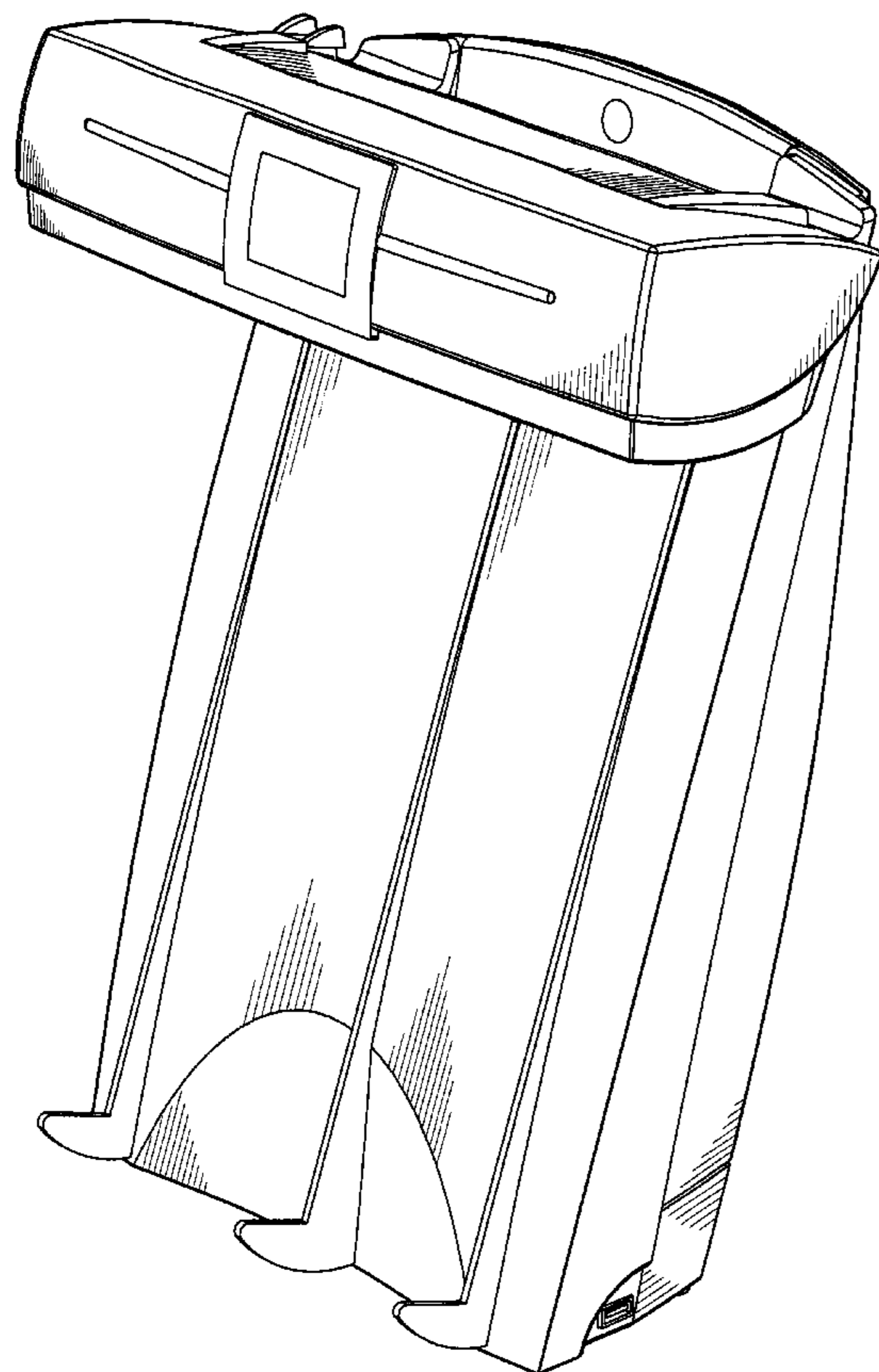
(57) **CLAIM**

The ornamental design for a vertically oriented printer, as shown.

DESCRIPTION

FIG. 1 is a front and right side perspective view of a first embodiment of a printer, showing our new design; FIG. 2 is a rear and right side perspective view thereof; FIG. 3 is a rear and right side perspective view thereof with the rear socket cover removed; FIG. 4 is a front elevation view thereof; FIG. 5 is a plan view thereof; FIG. 6 is a rear elevation view thereof; FIG. 7 is a right elevation view thereof; FIG. 8 is a left elevation view thereof; and, FIG. 9 is a bottom view thereof.

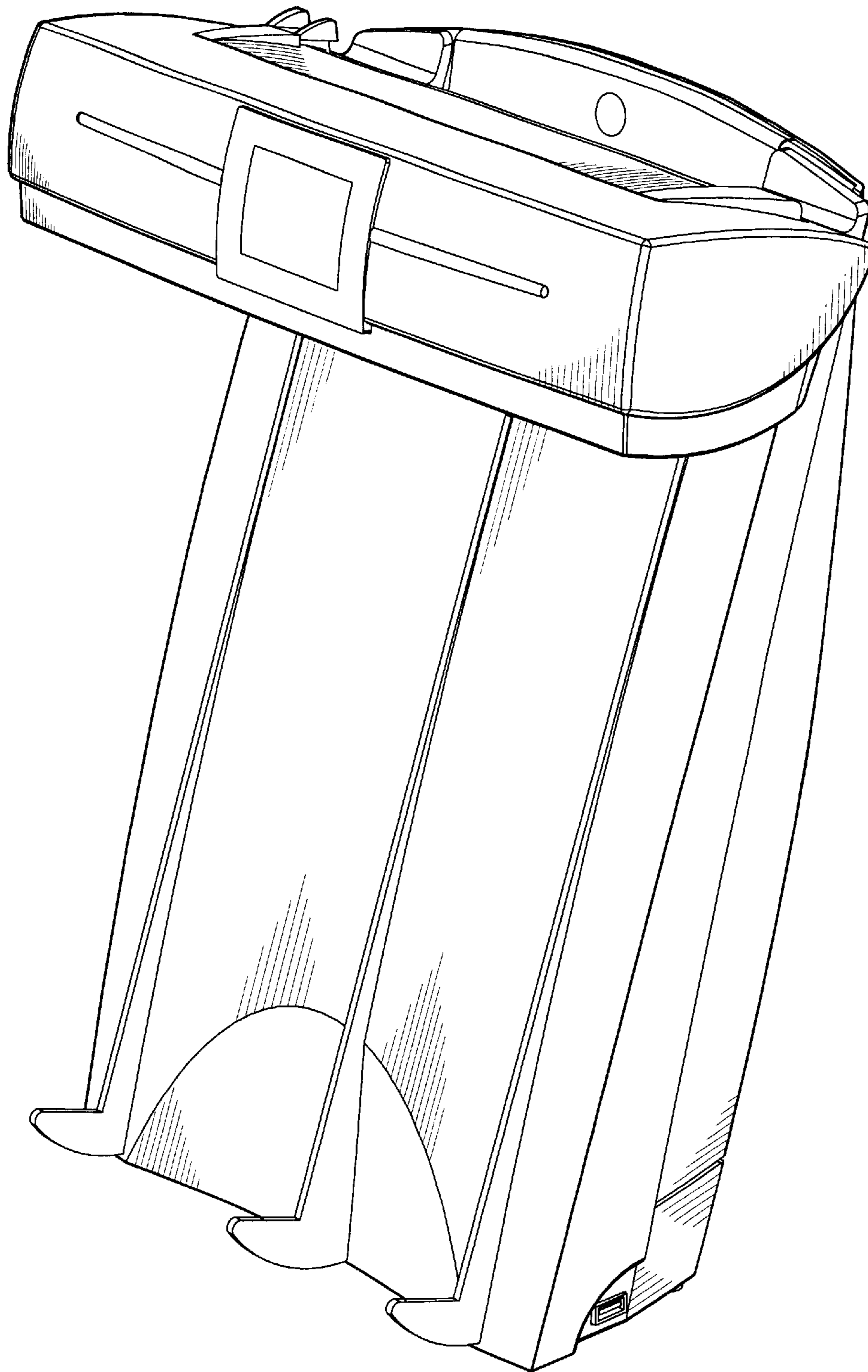

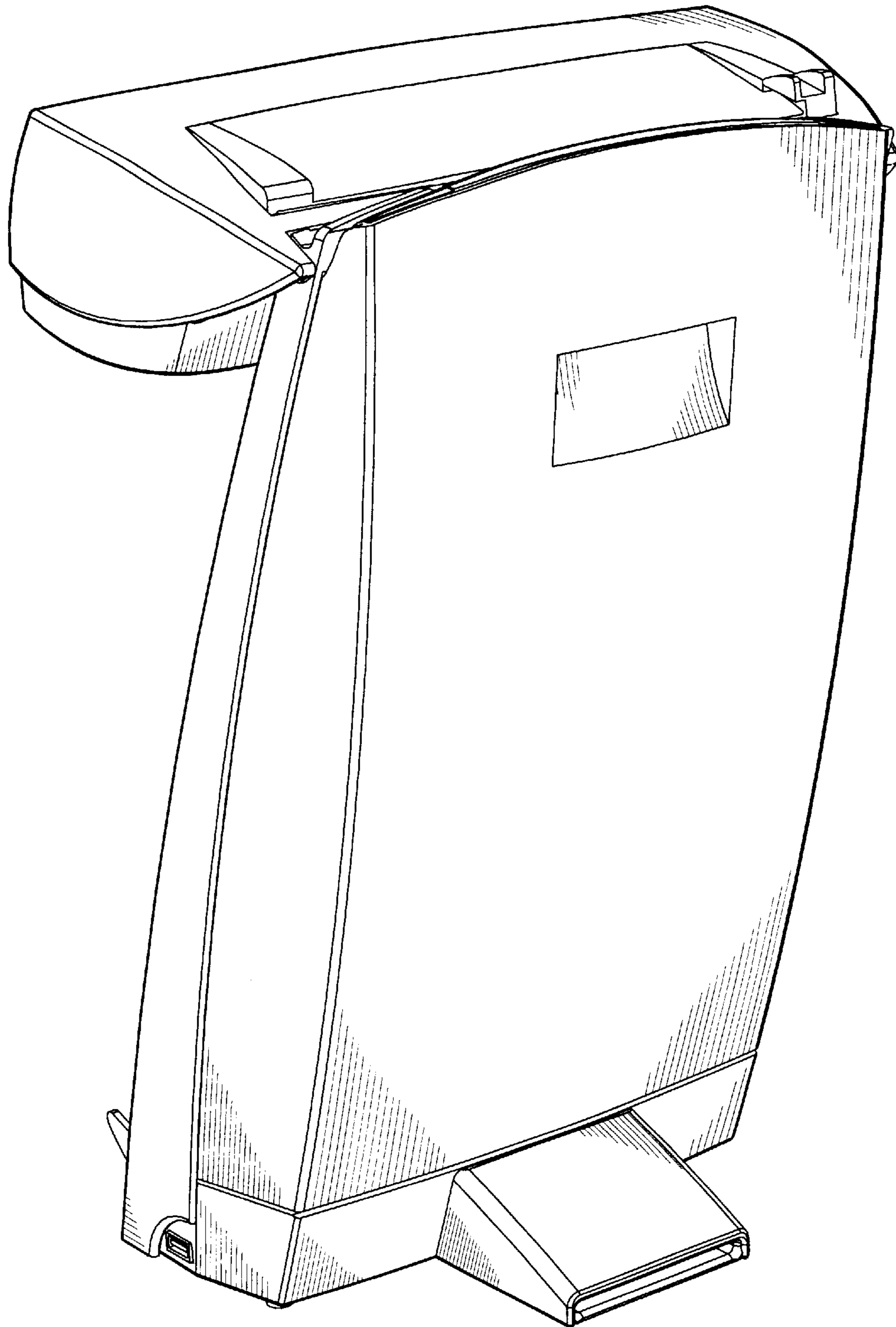

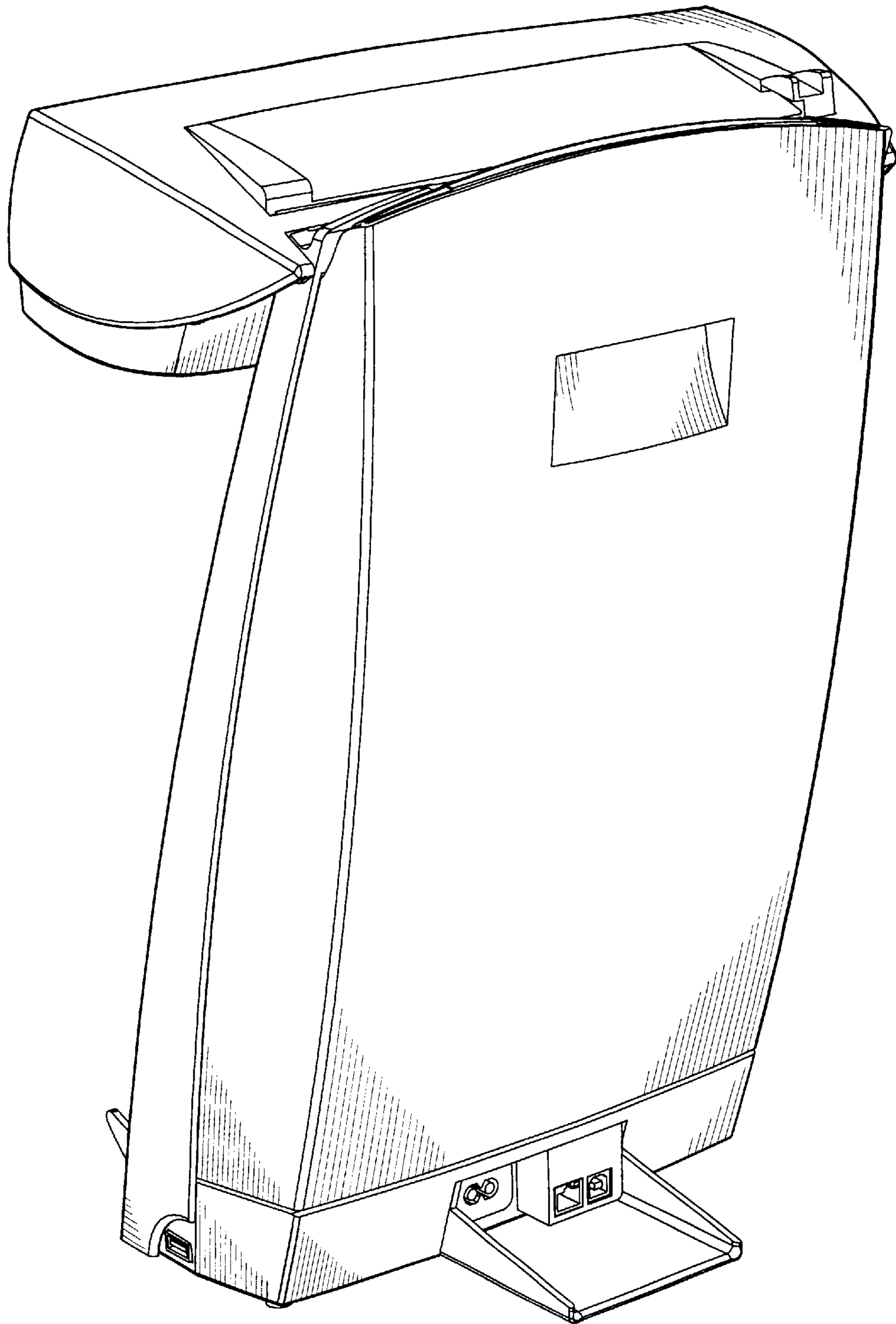

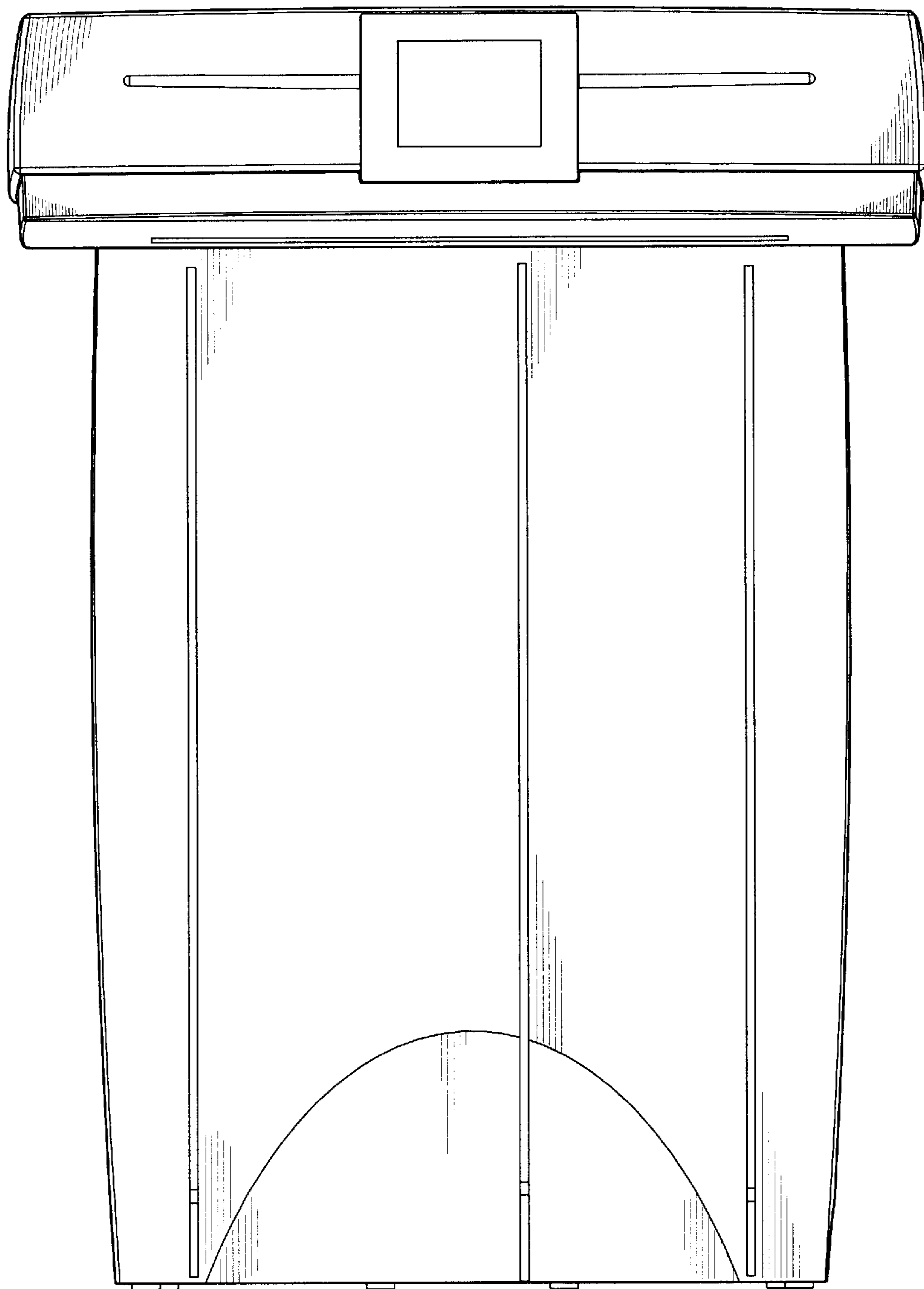

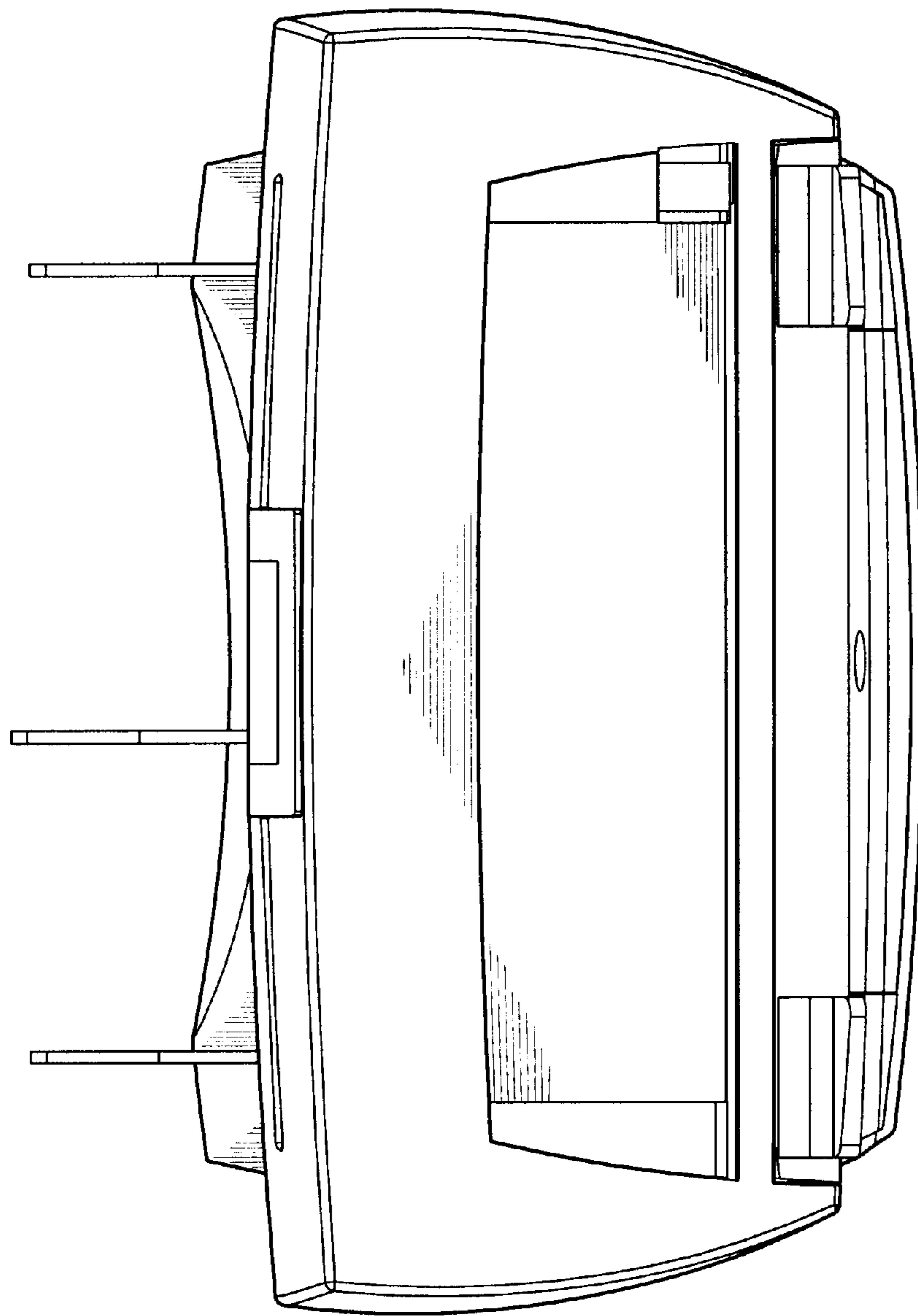

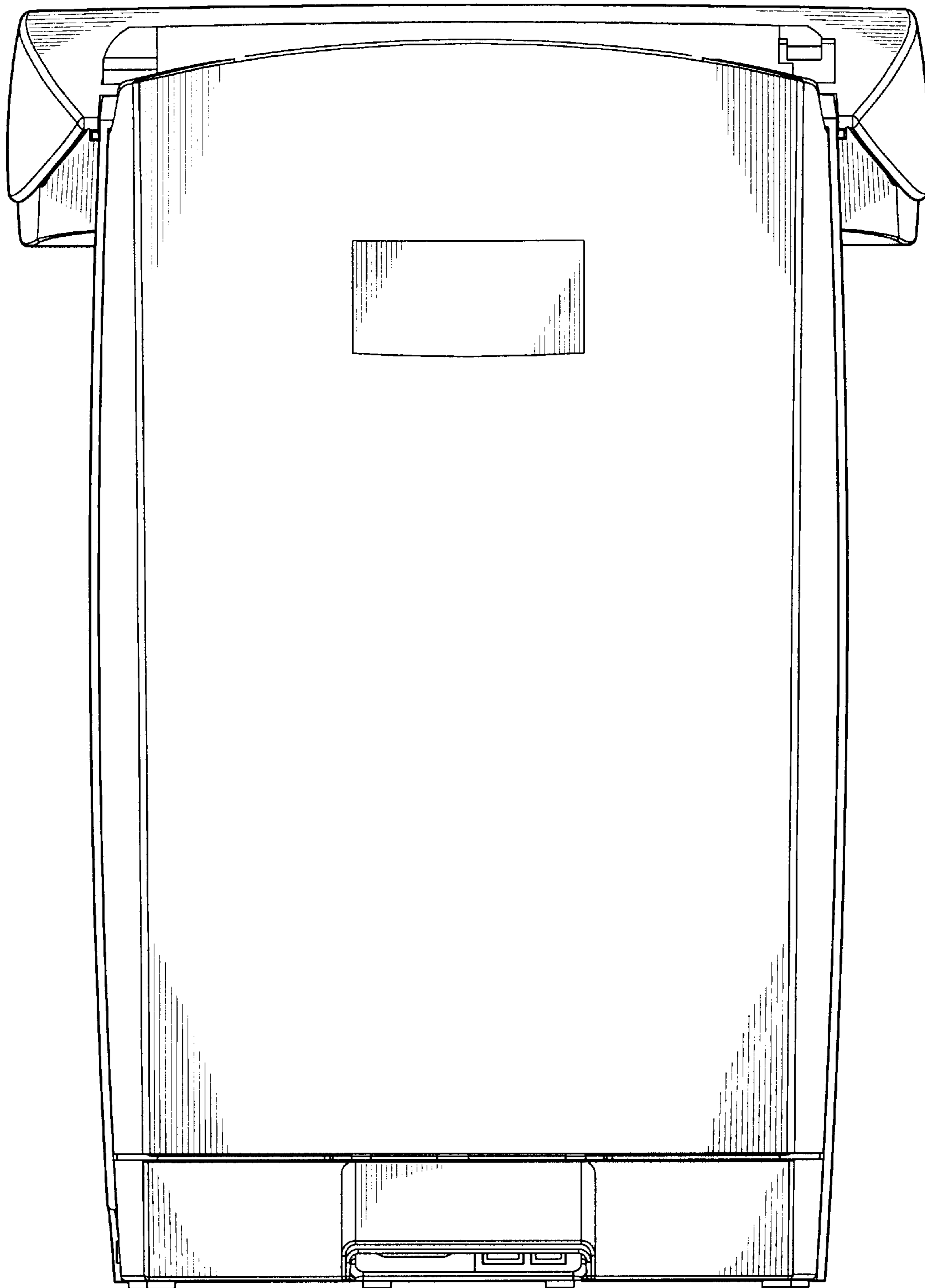

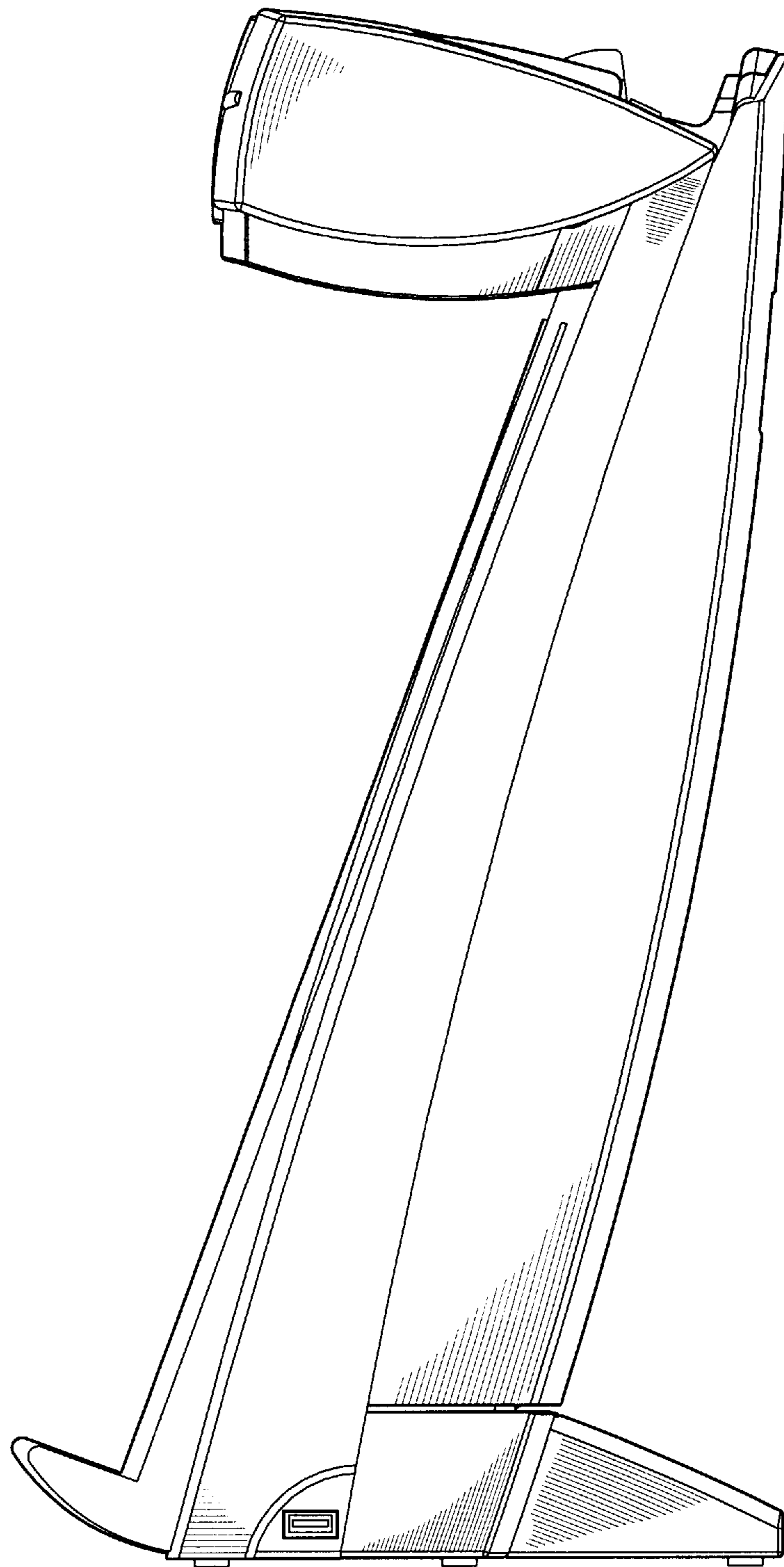

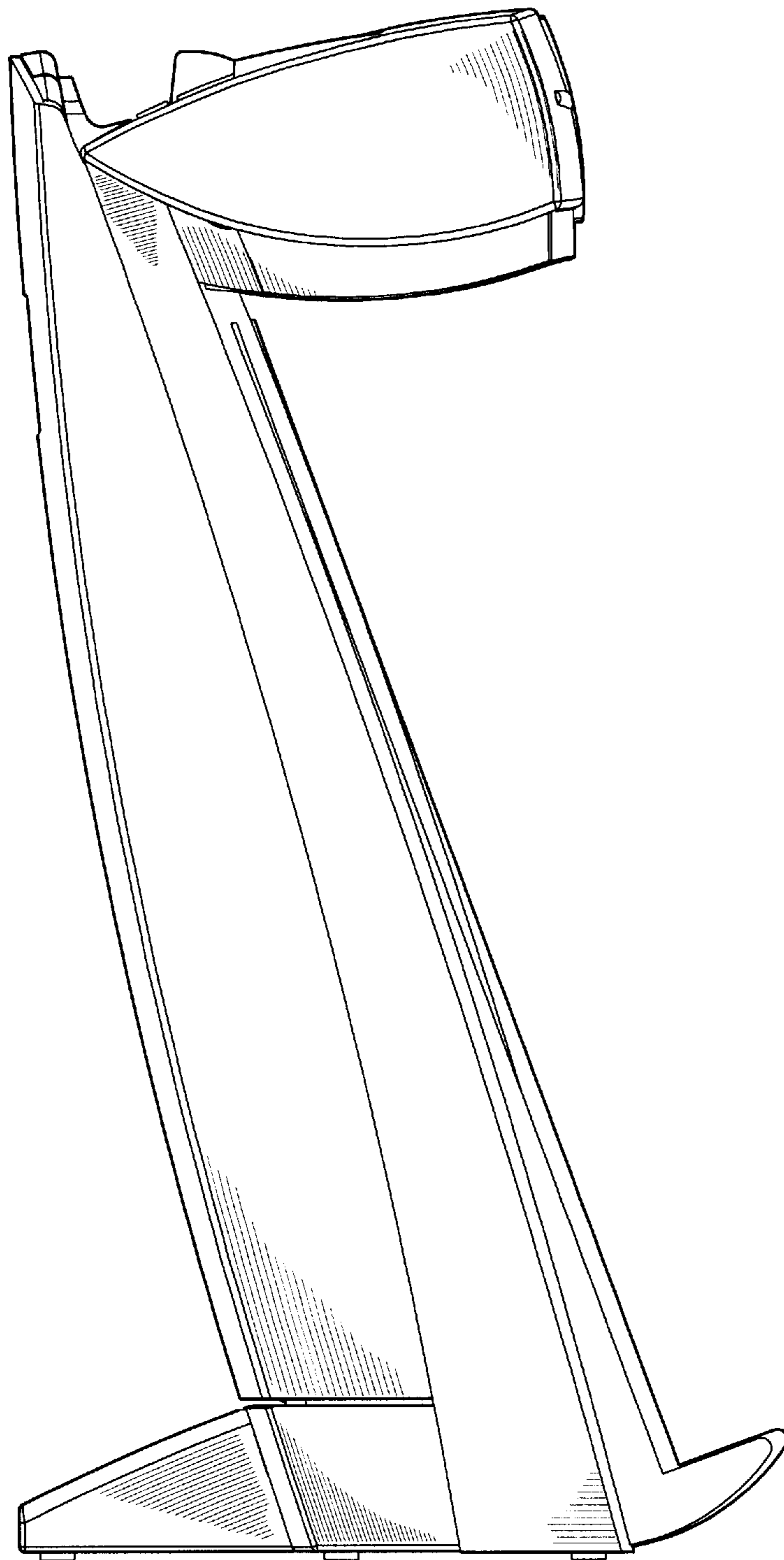

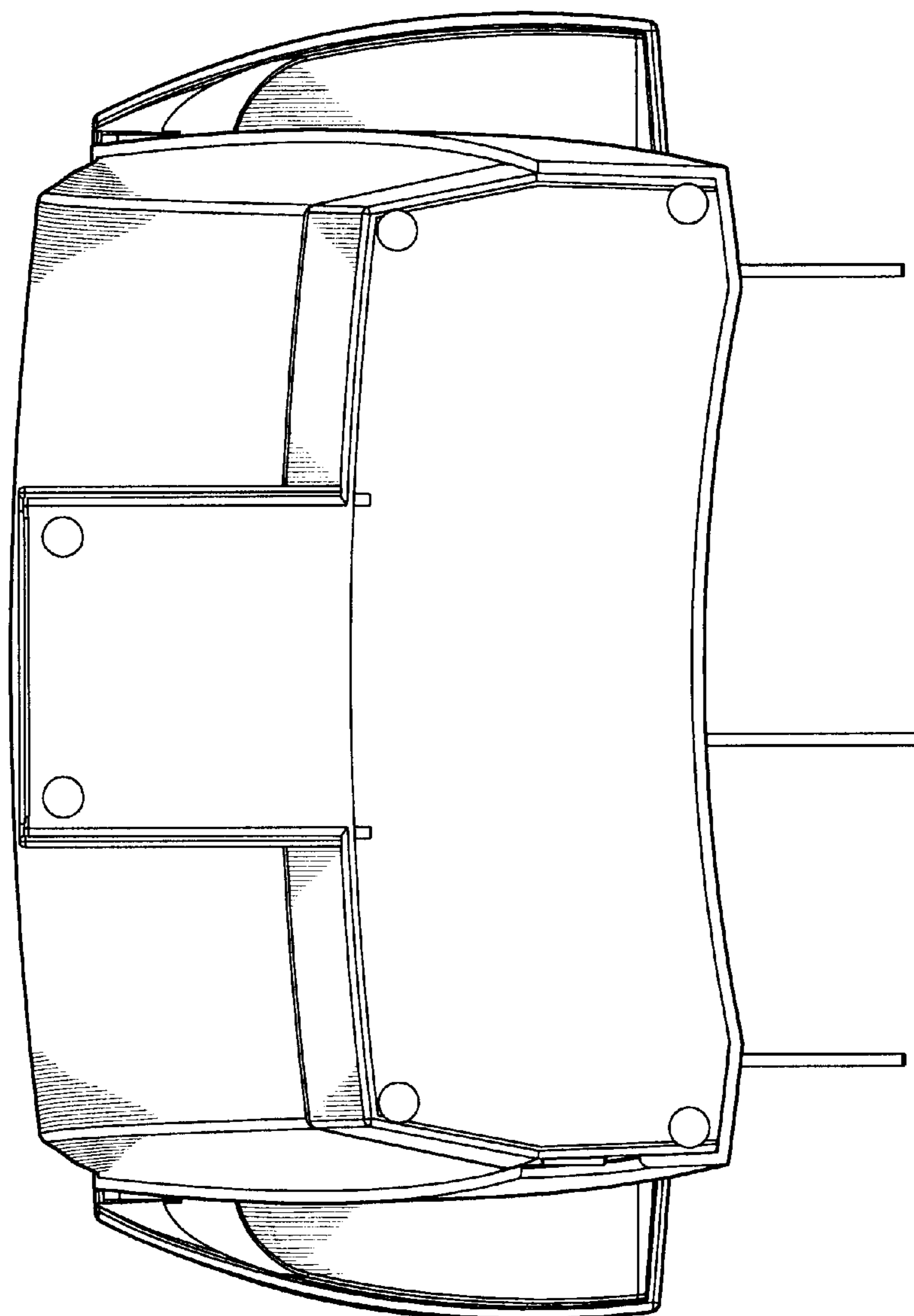
