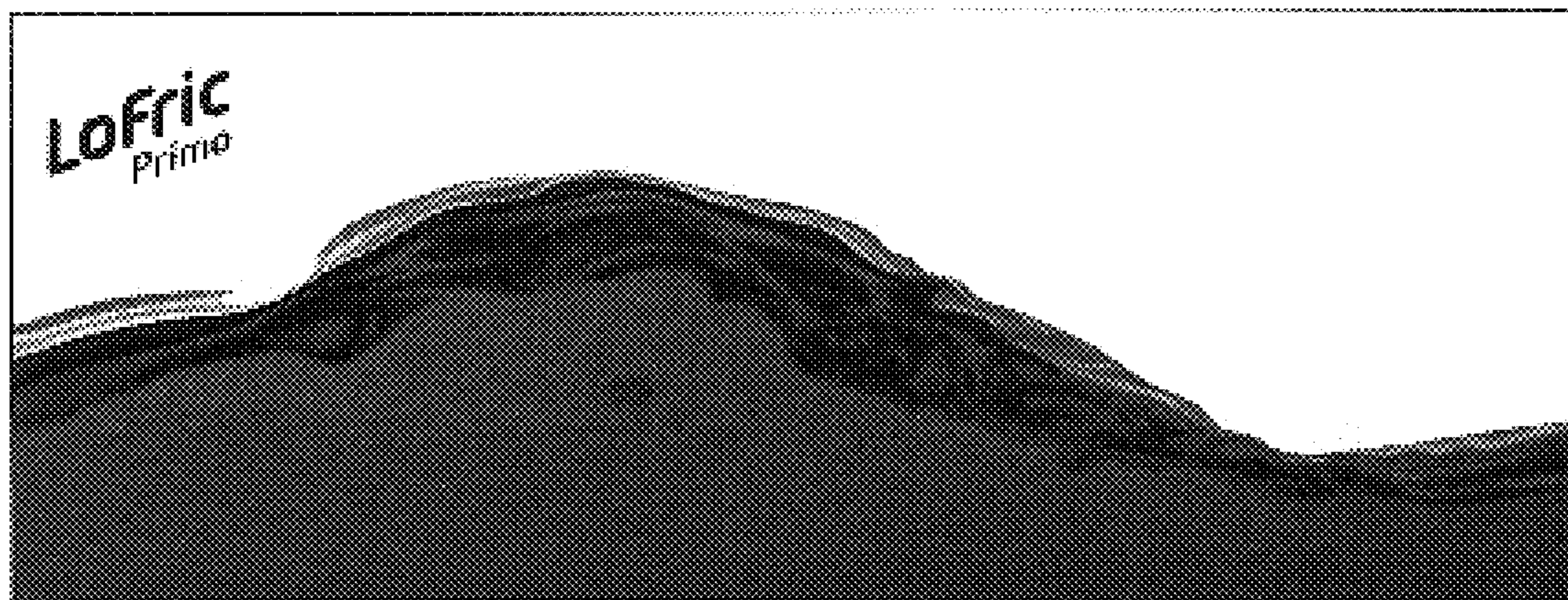
FIG. 5 is a front view of a third embodiment of a label for packaging showing our new design; and,

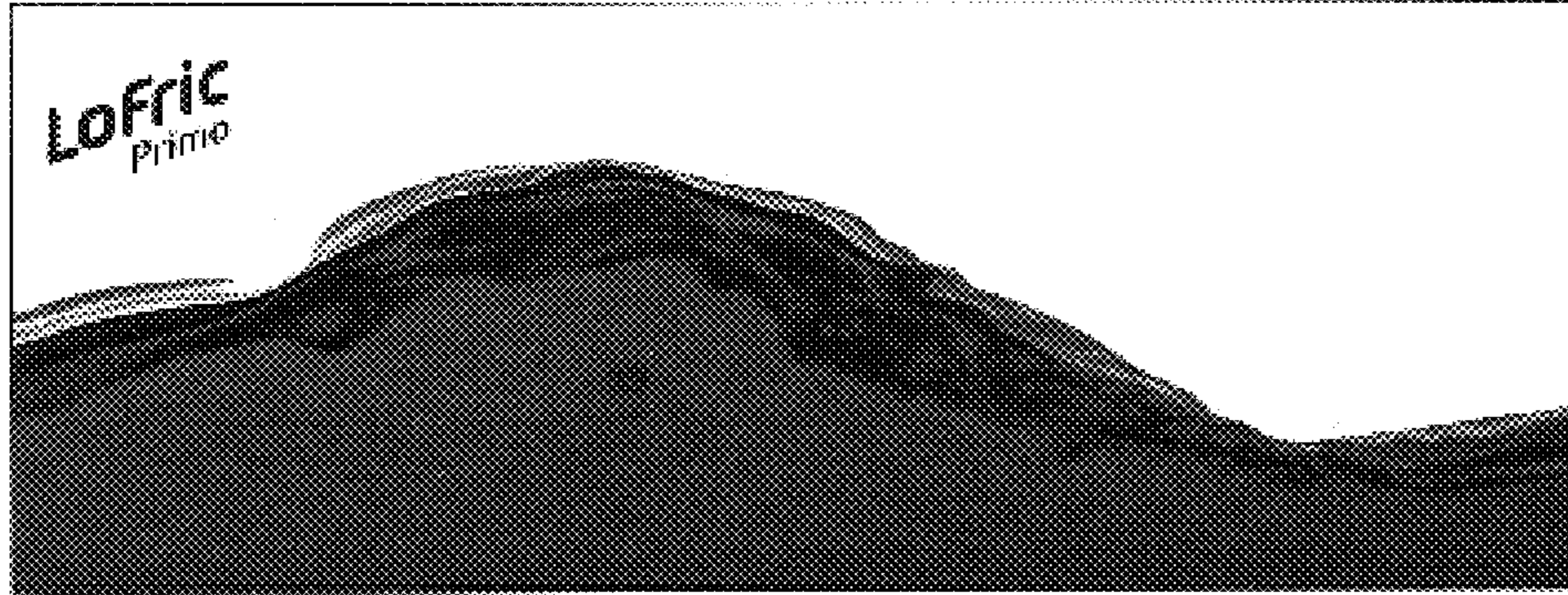

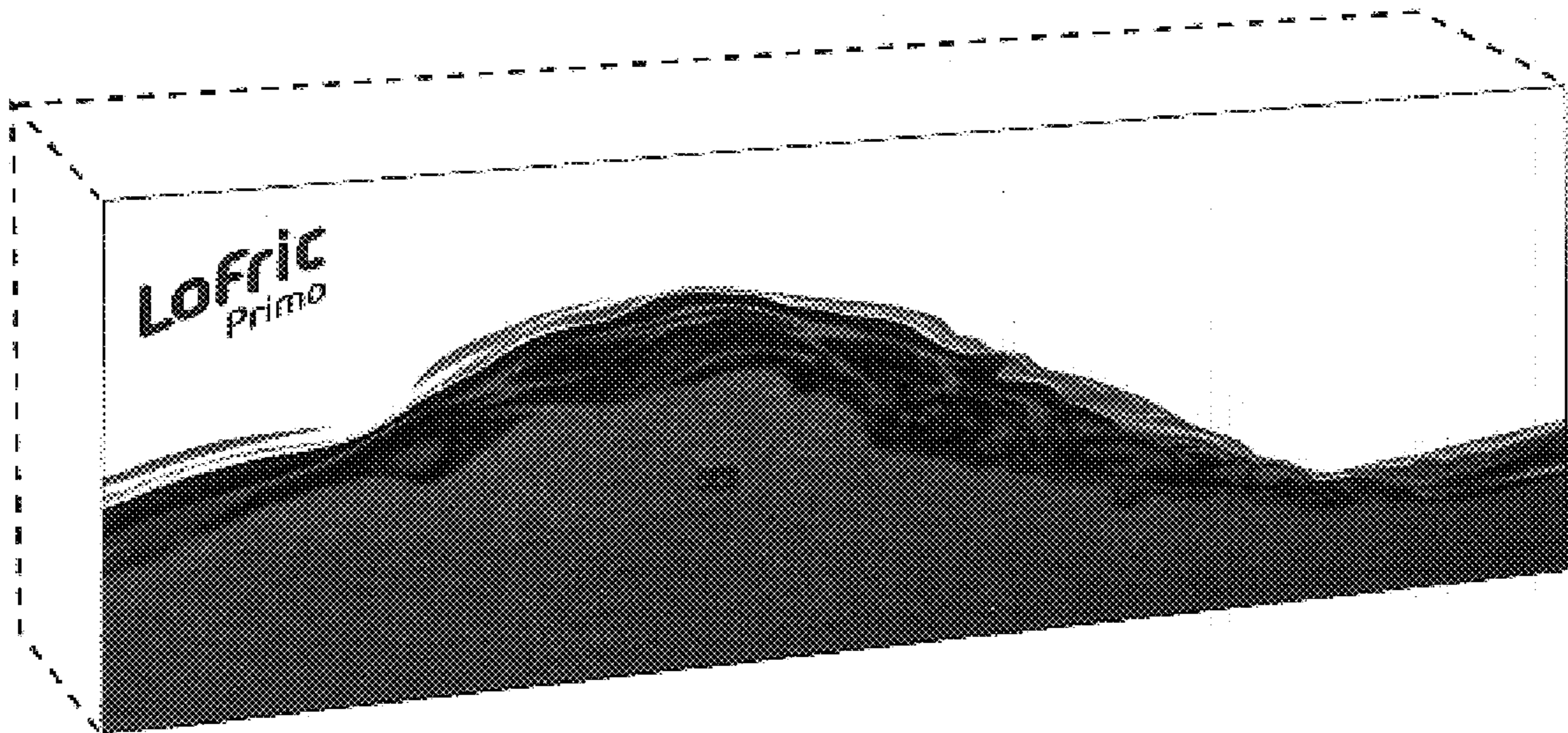

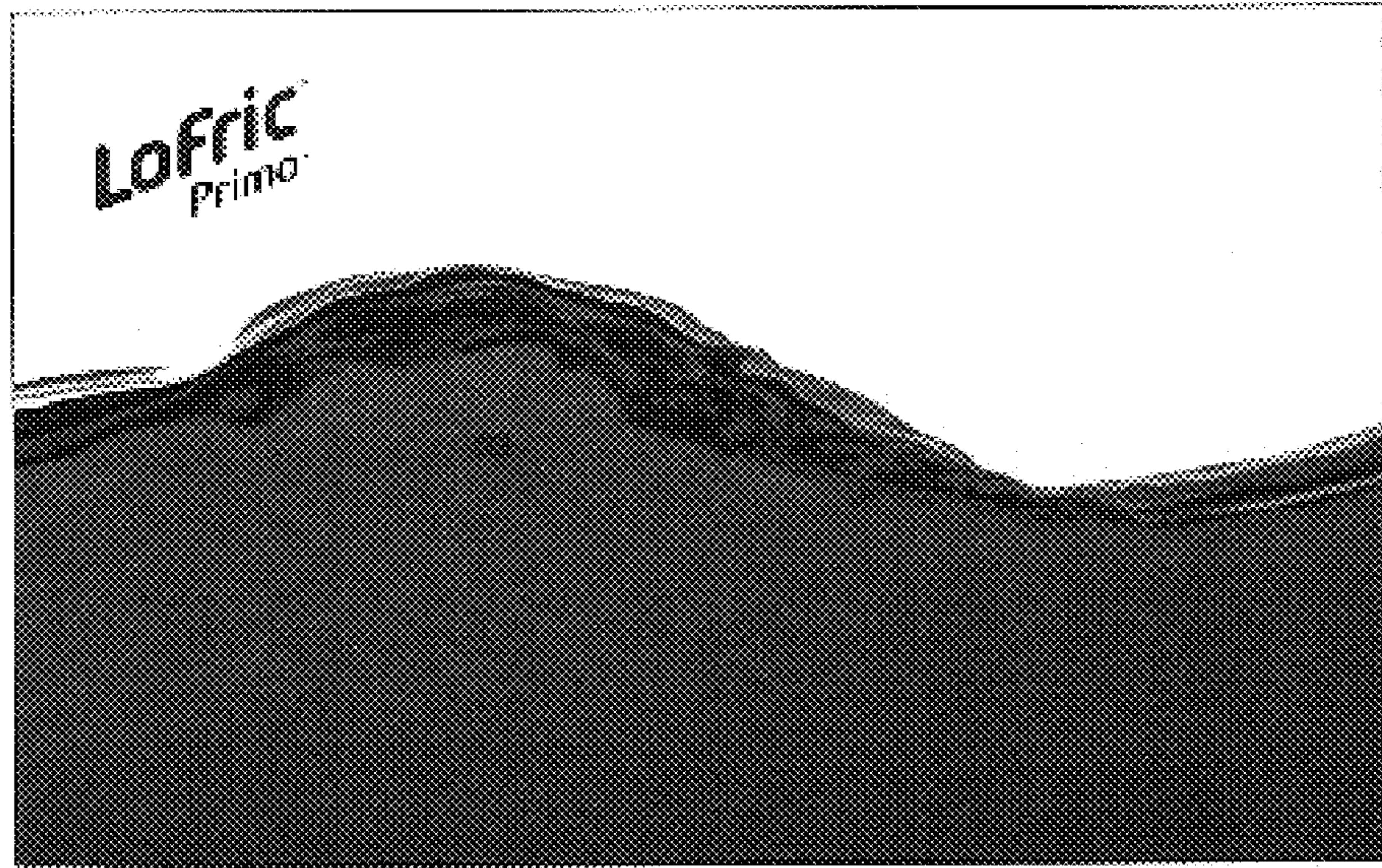

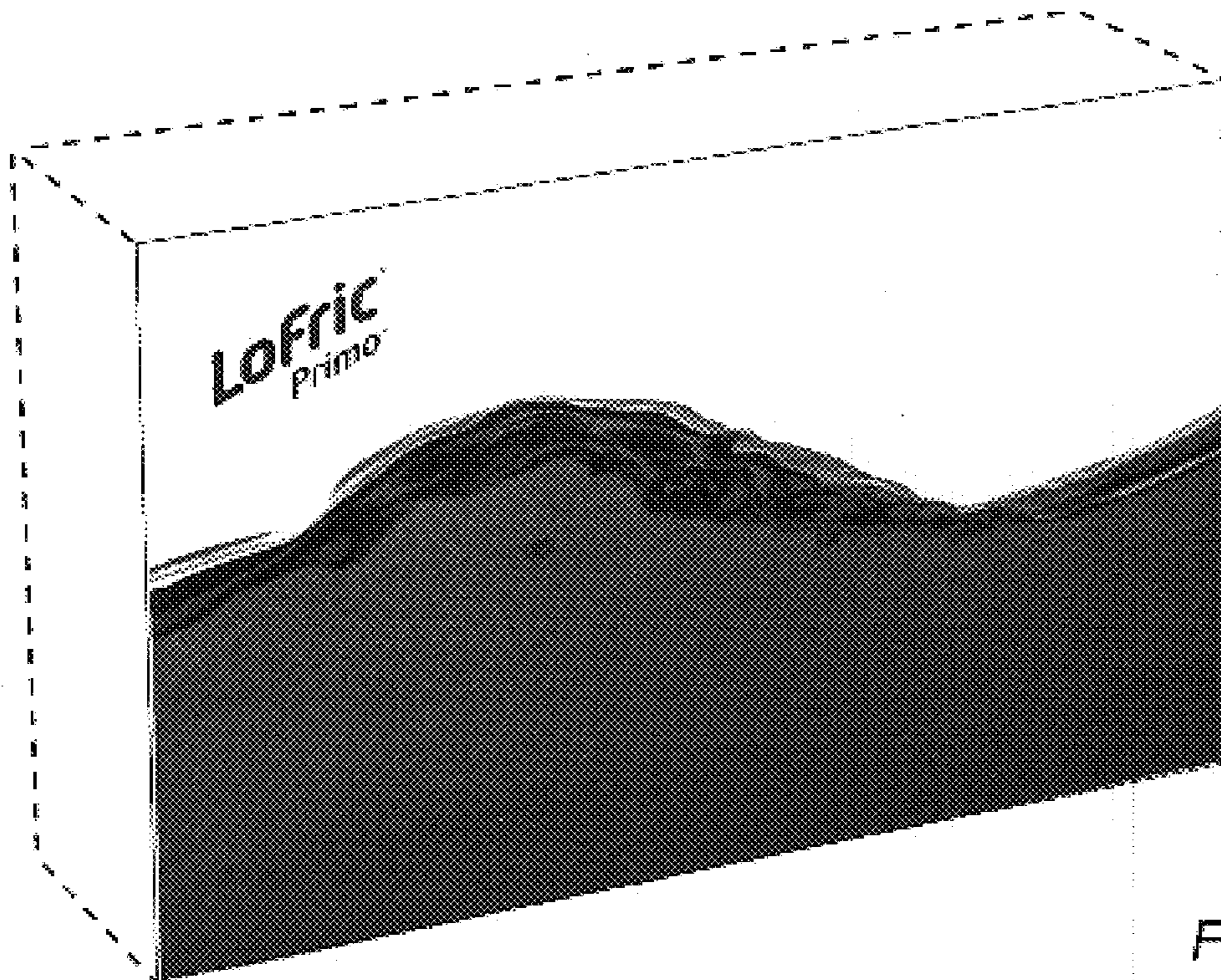

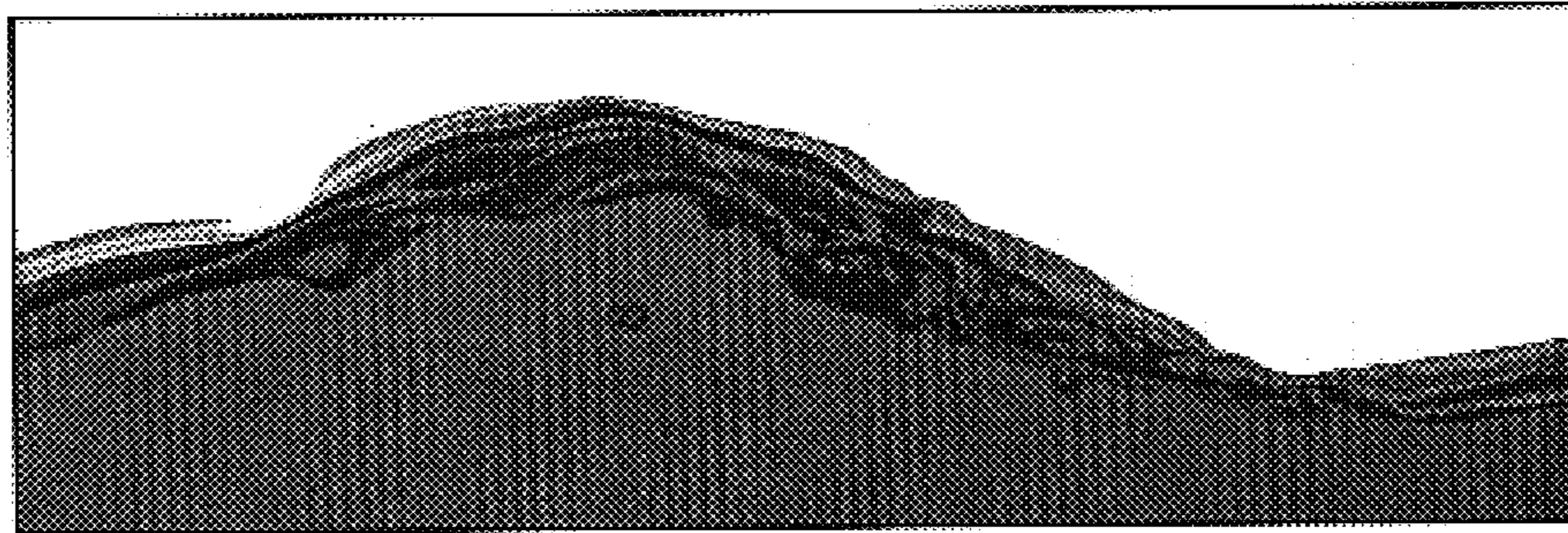

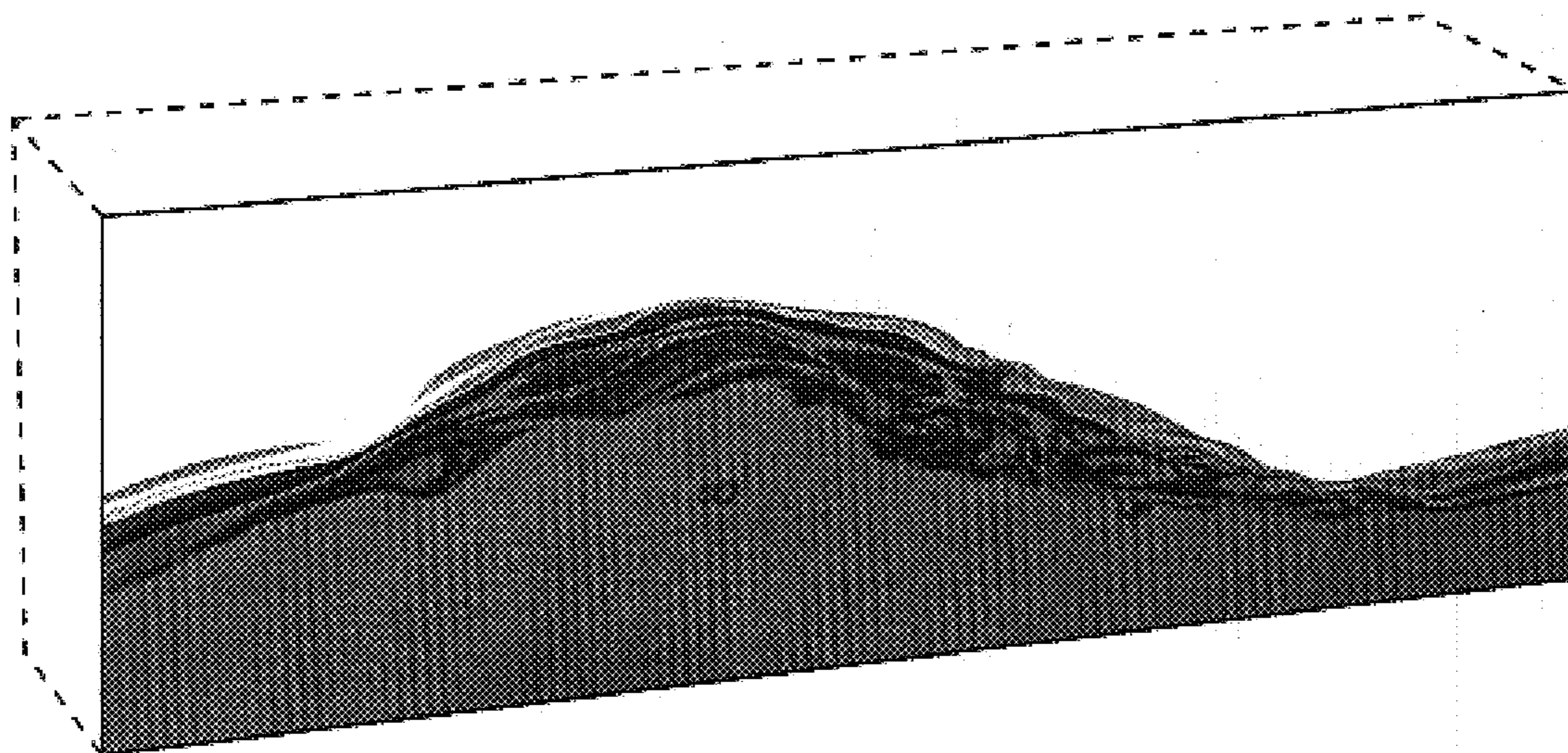
