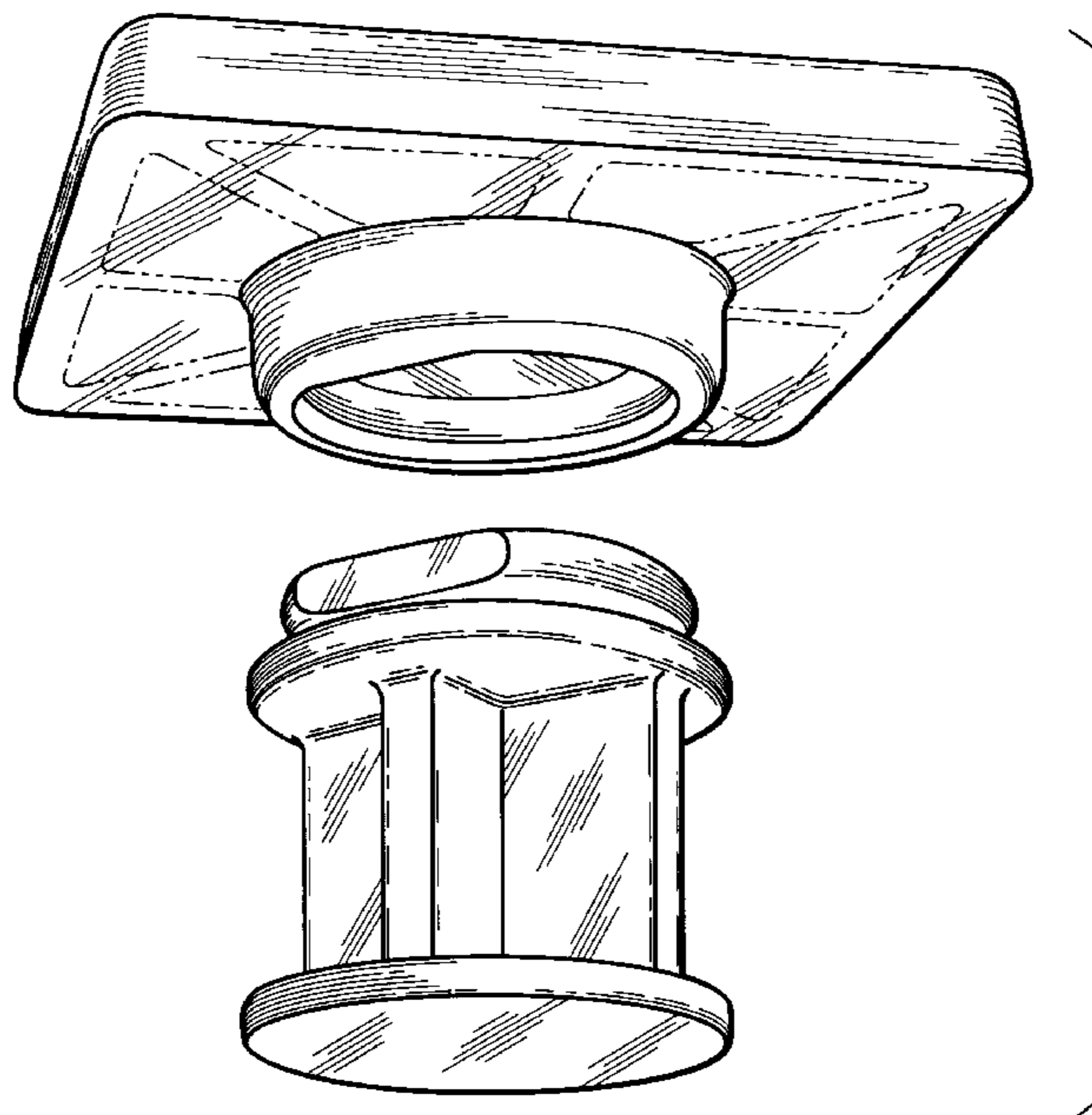
(57) **CLAIM**

The ornamental design for a combined detachable baseball base and support unit, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective exploded view of a combined detachable baseball base and support unit of the present invention;  
 FIG. 2 is a perspective view of the assembled design;  
 FIG. 3 is an elevational view of the rear and side of FIG. 1;  
 FIG. 4 is an elevational view of the front of FIG. 1;  
 FIG. 5 is a top view thereof; and,

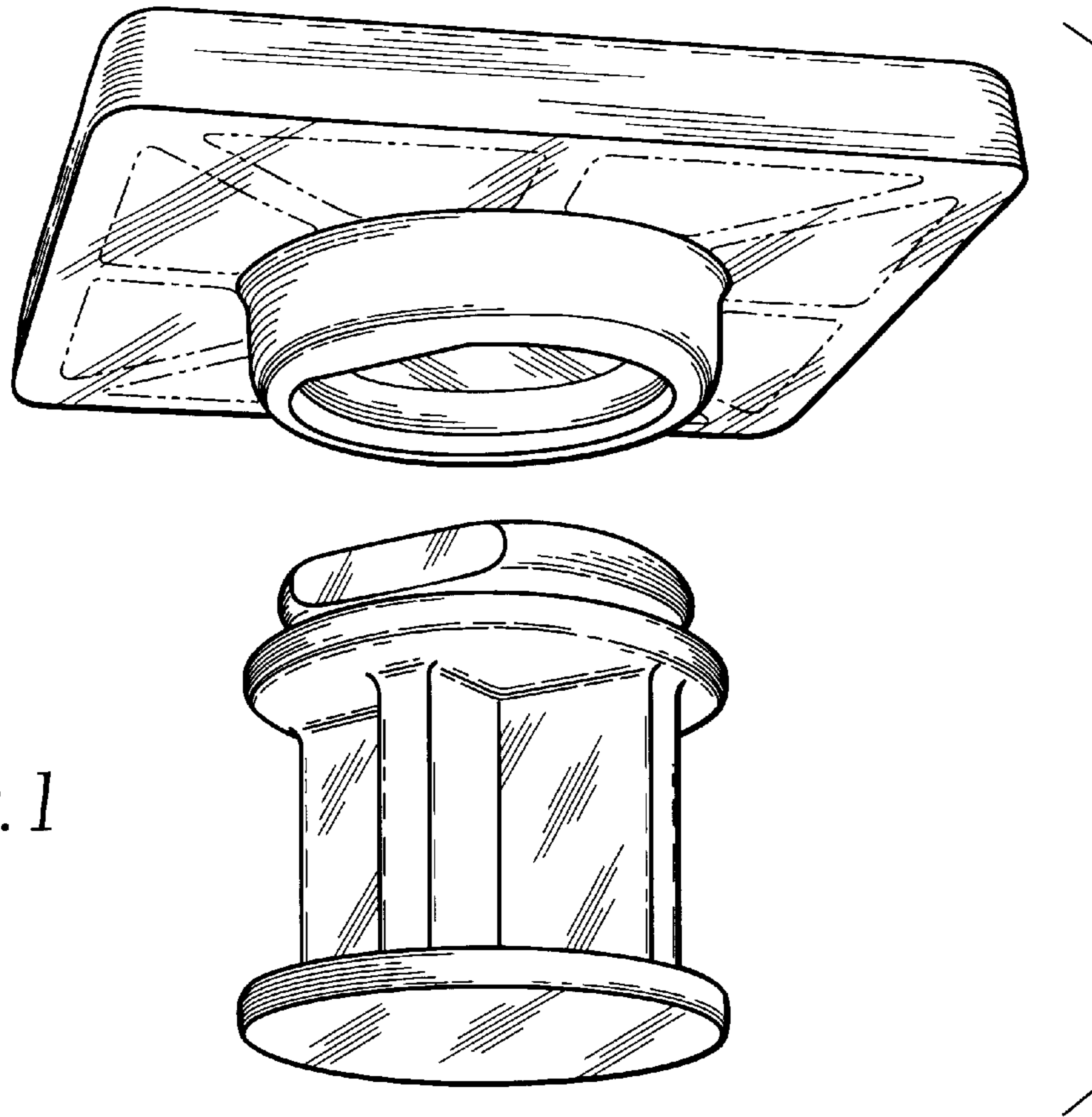

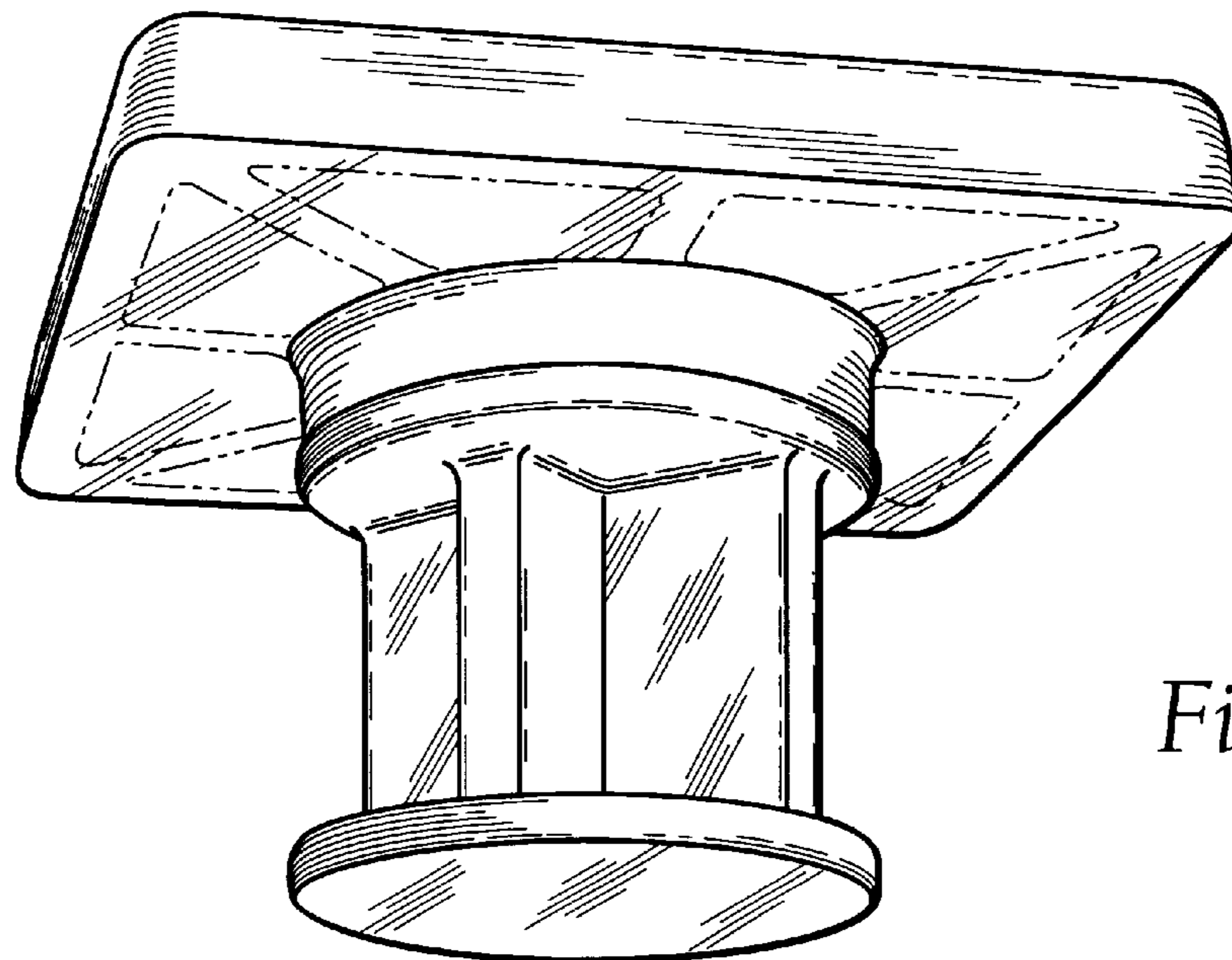
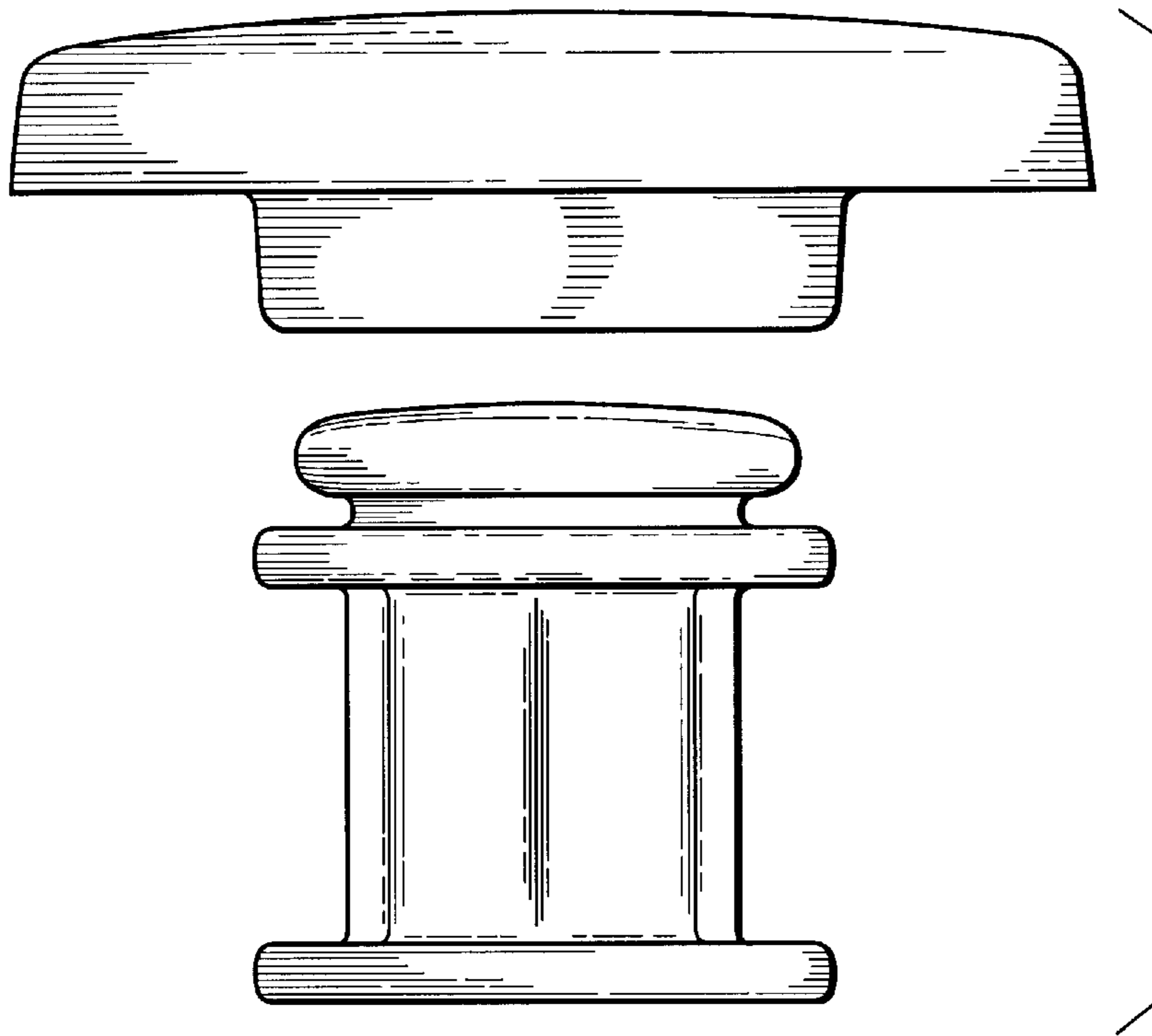
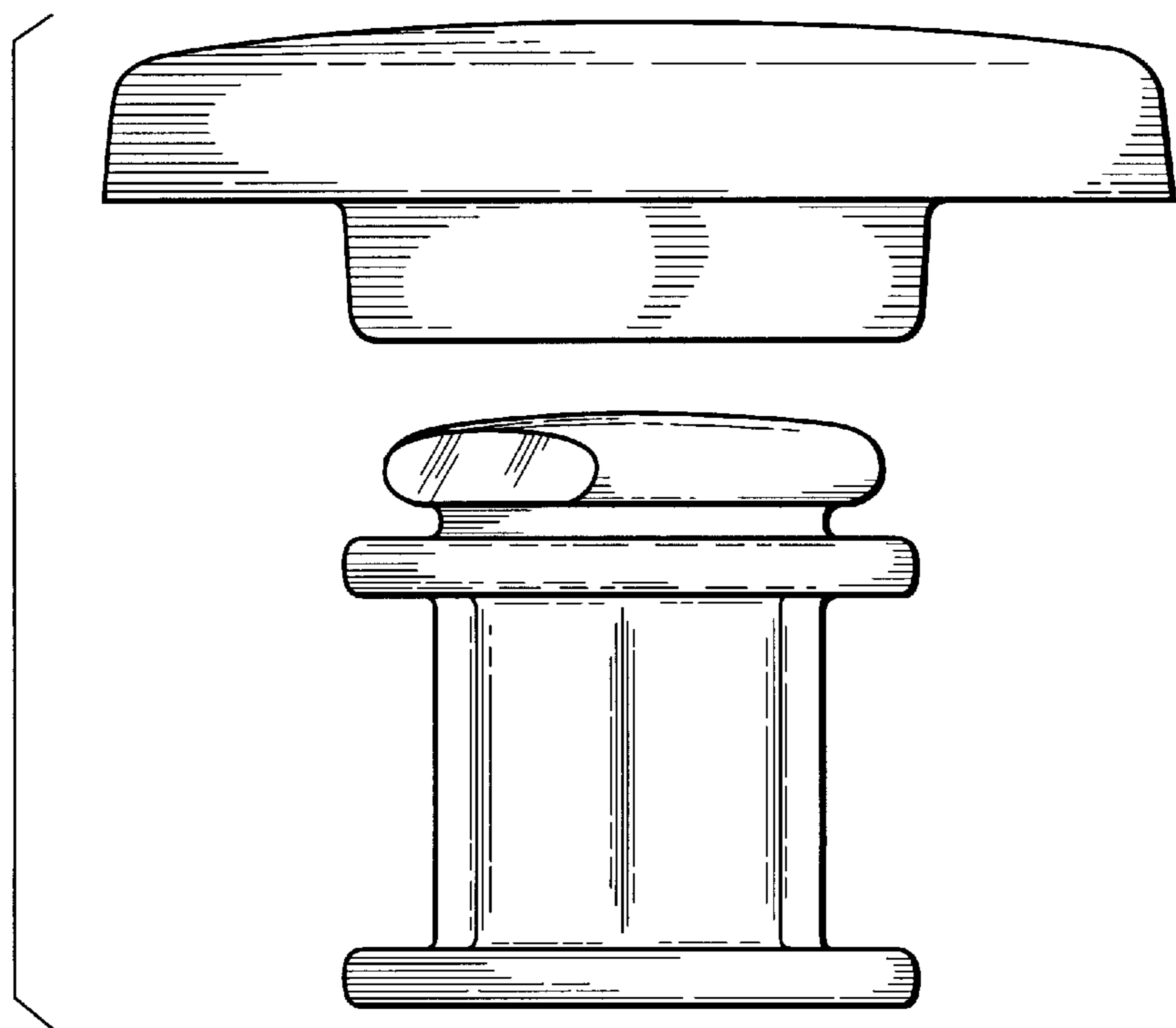

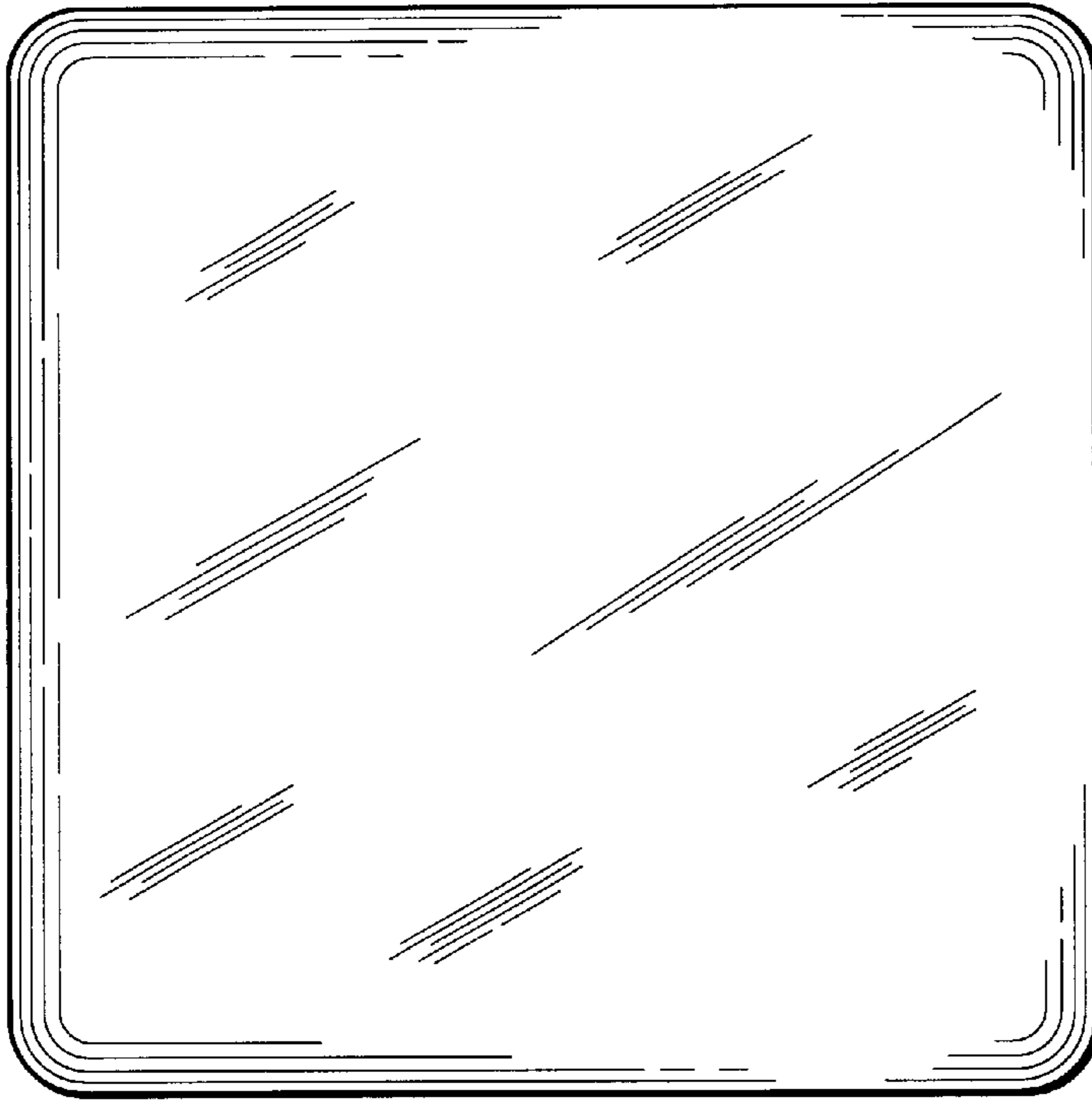

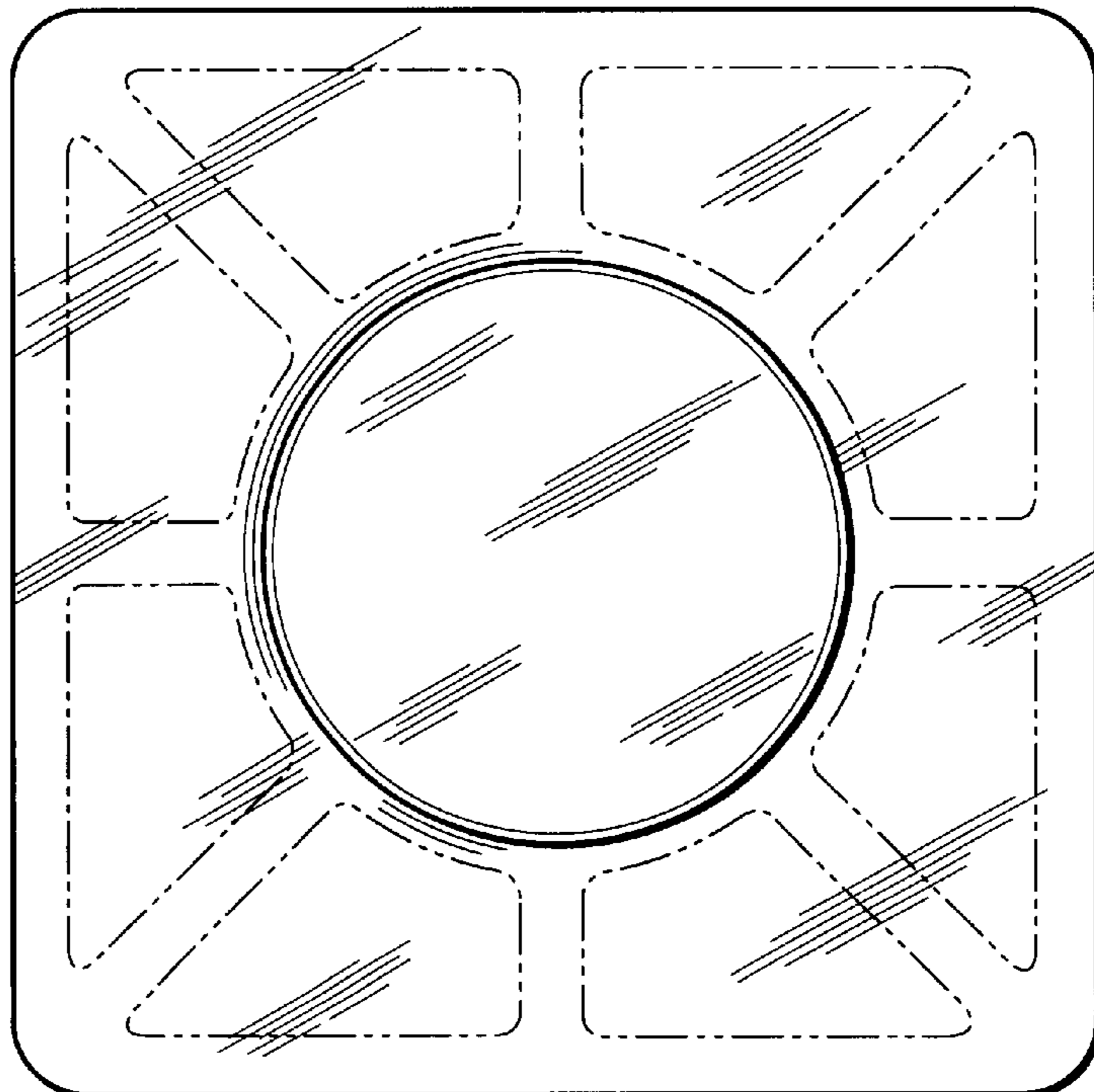
