(57) **CLAIM**

The ornamental design for an outdoor lantern, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of outdoor lantern showing my new design;

FIG. 2 is a side elevational view thereof, the opposite side elevational view being a mirror image;

FIG. 3 is a bottom plan view thereof,

FIG. 4 is a perspective view of a second embodiment thereof;

FIG. 5 is a side elevational view of a second embodiment thereof, the opposite side elevational view being a mirror image;

FIG. 6 is a bottom plan view of a second embodiment thereof;

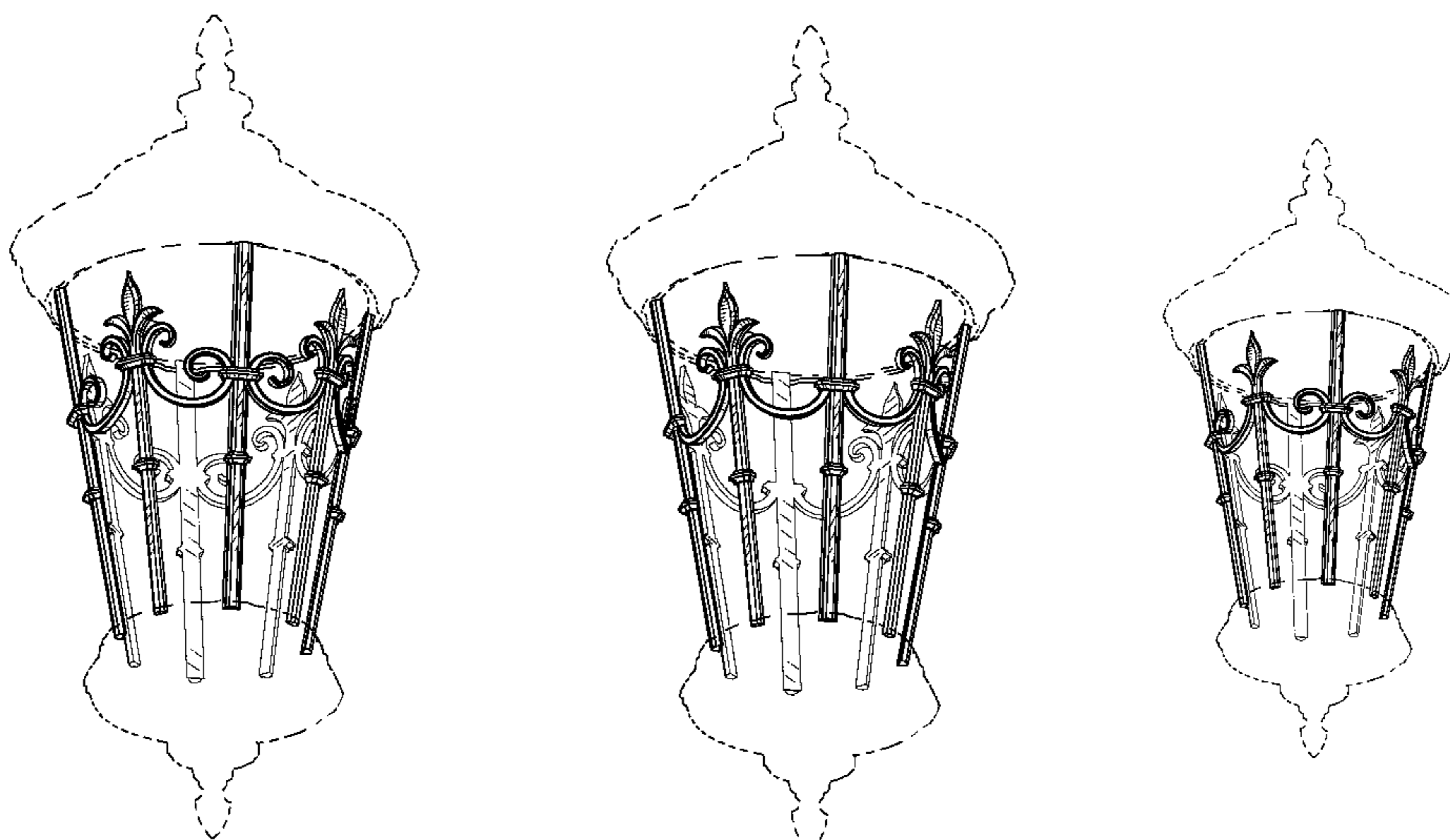
FIG. 7 is a perspective view of a third embodiment thereof;

FIG. 8 is a side elevational view of a third embodiment thereof, the opposite side elevational view being a mirror image; and,

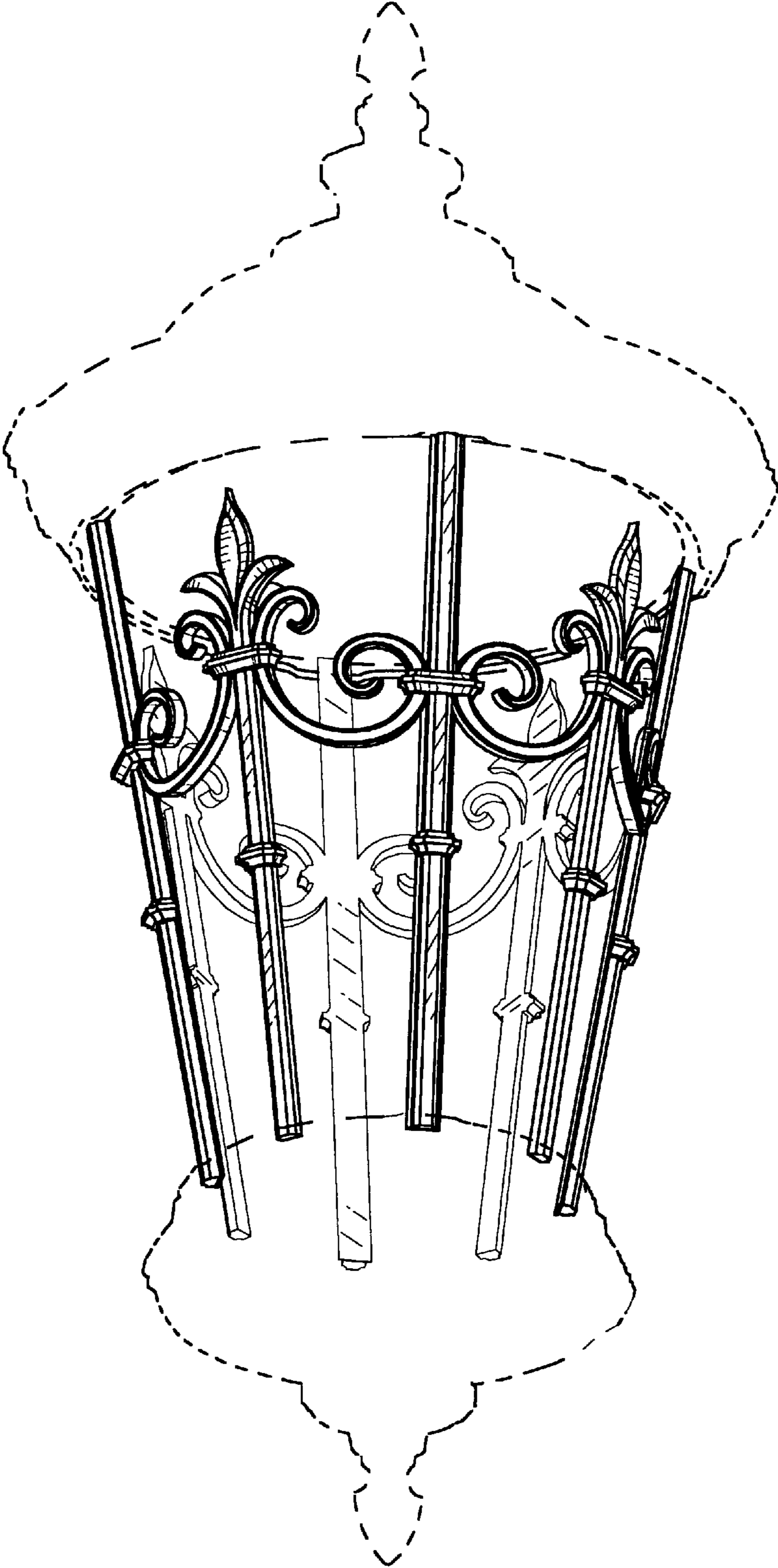

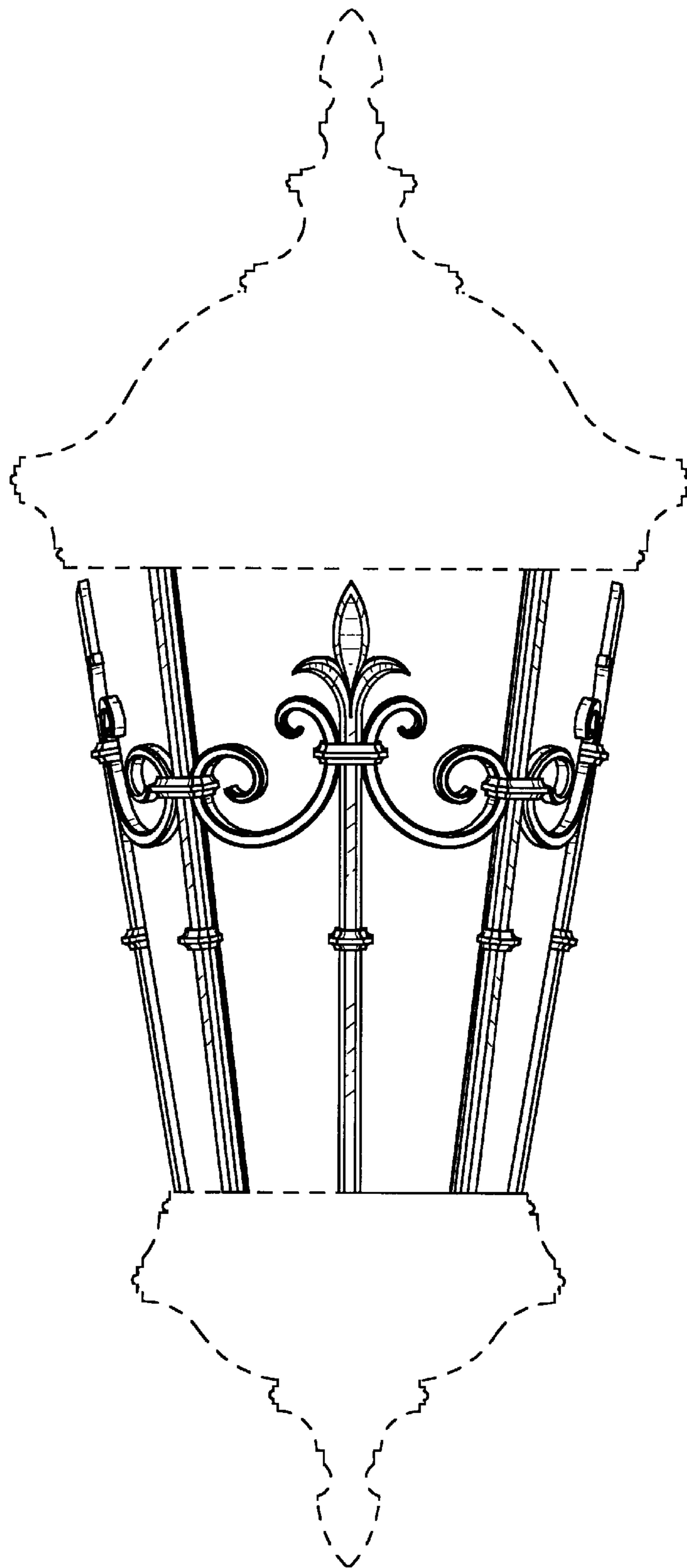

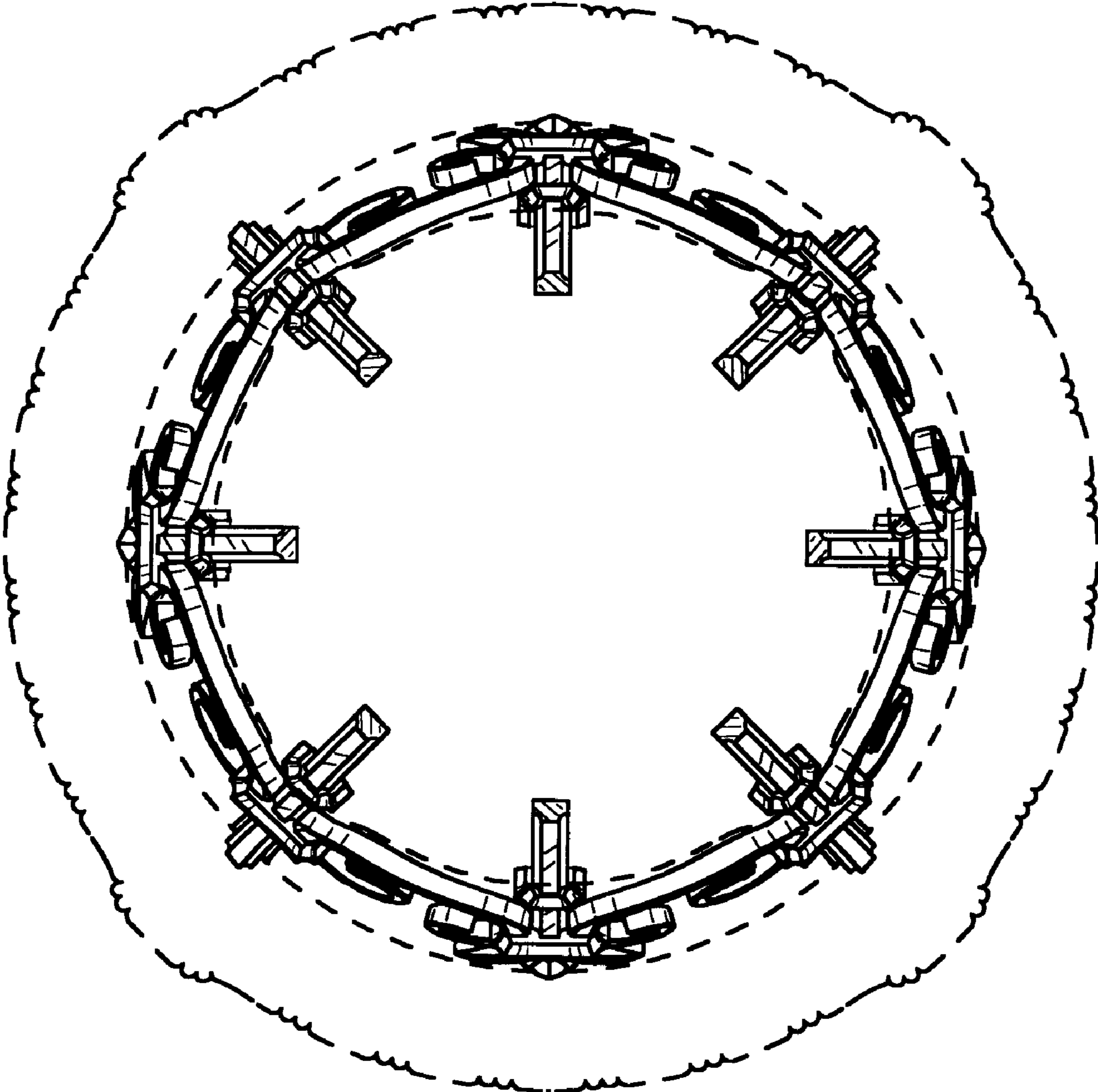

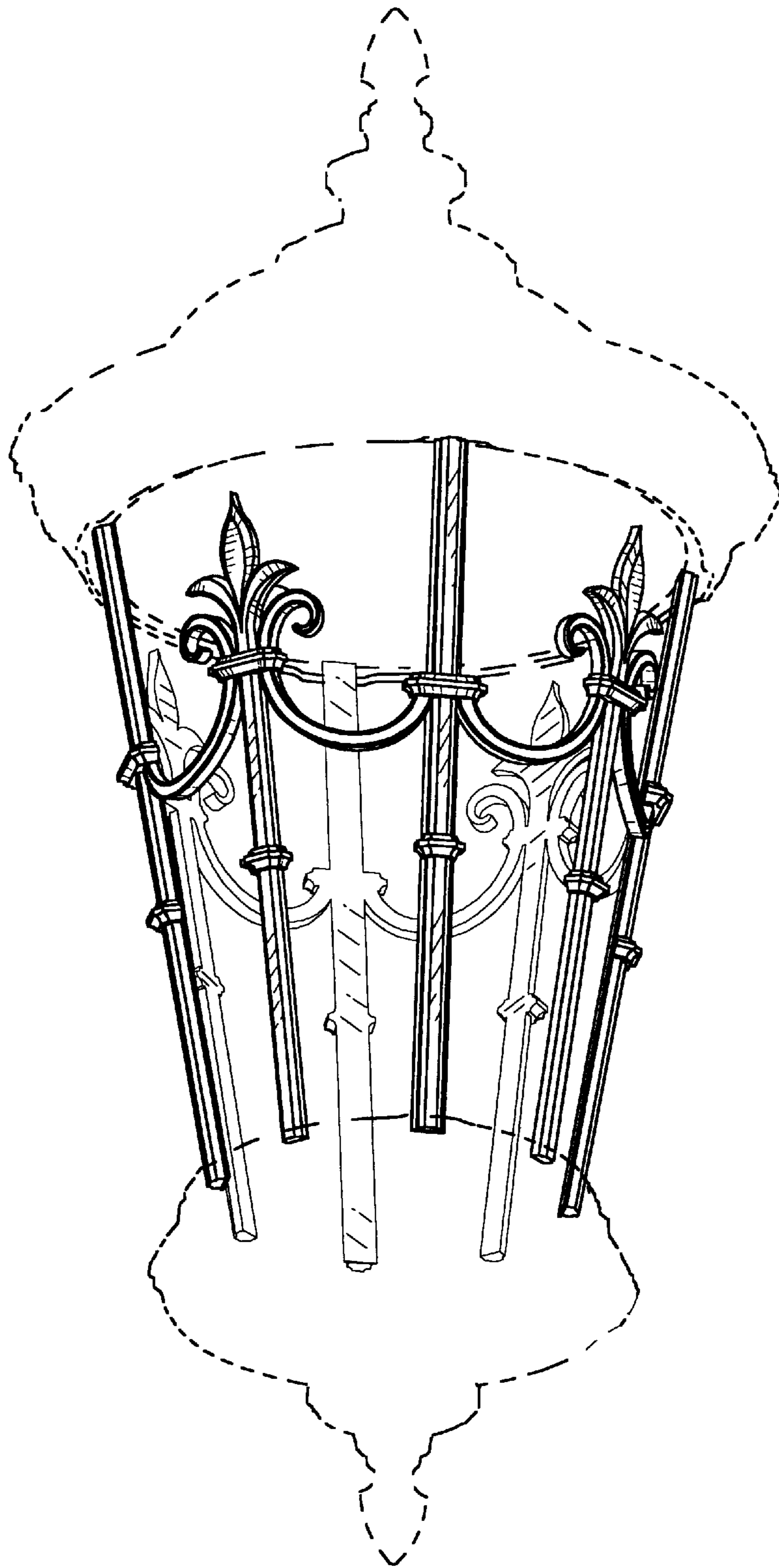

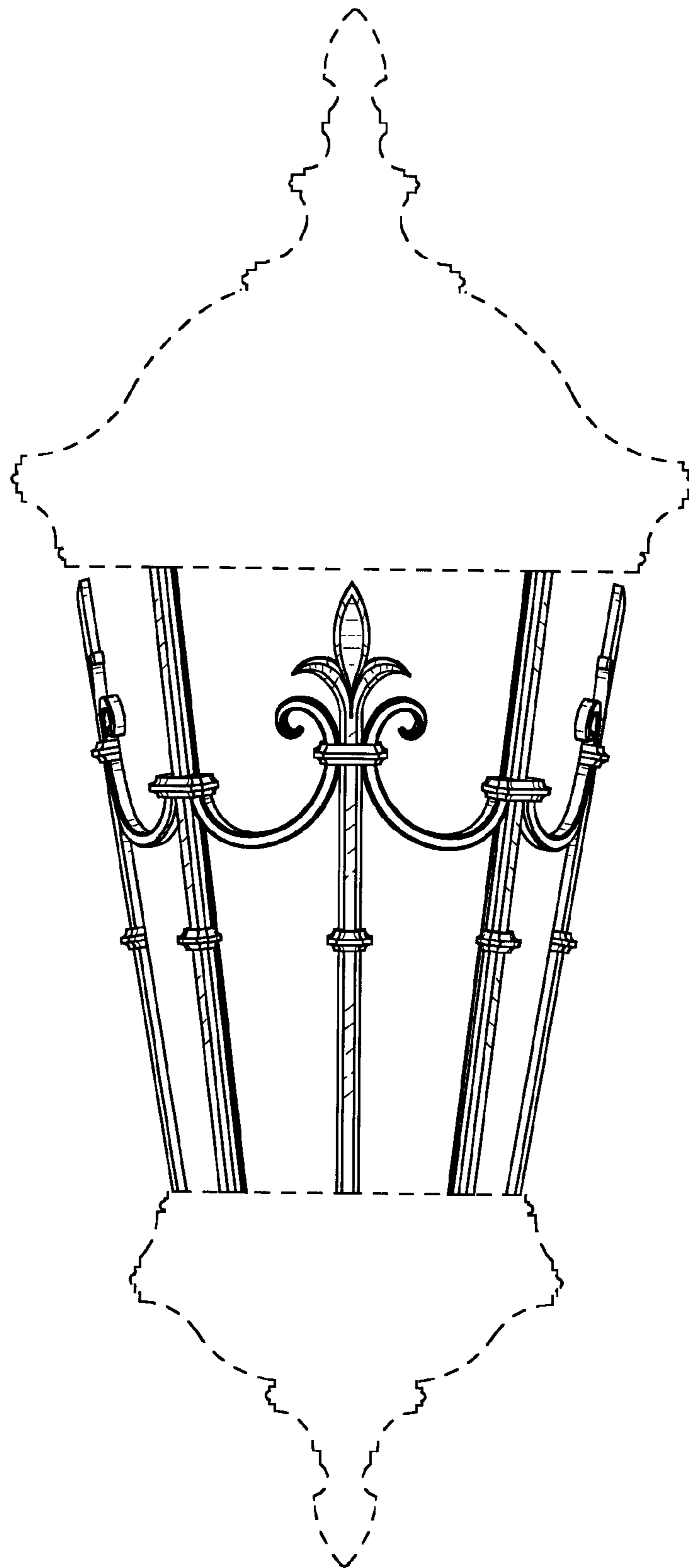

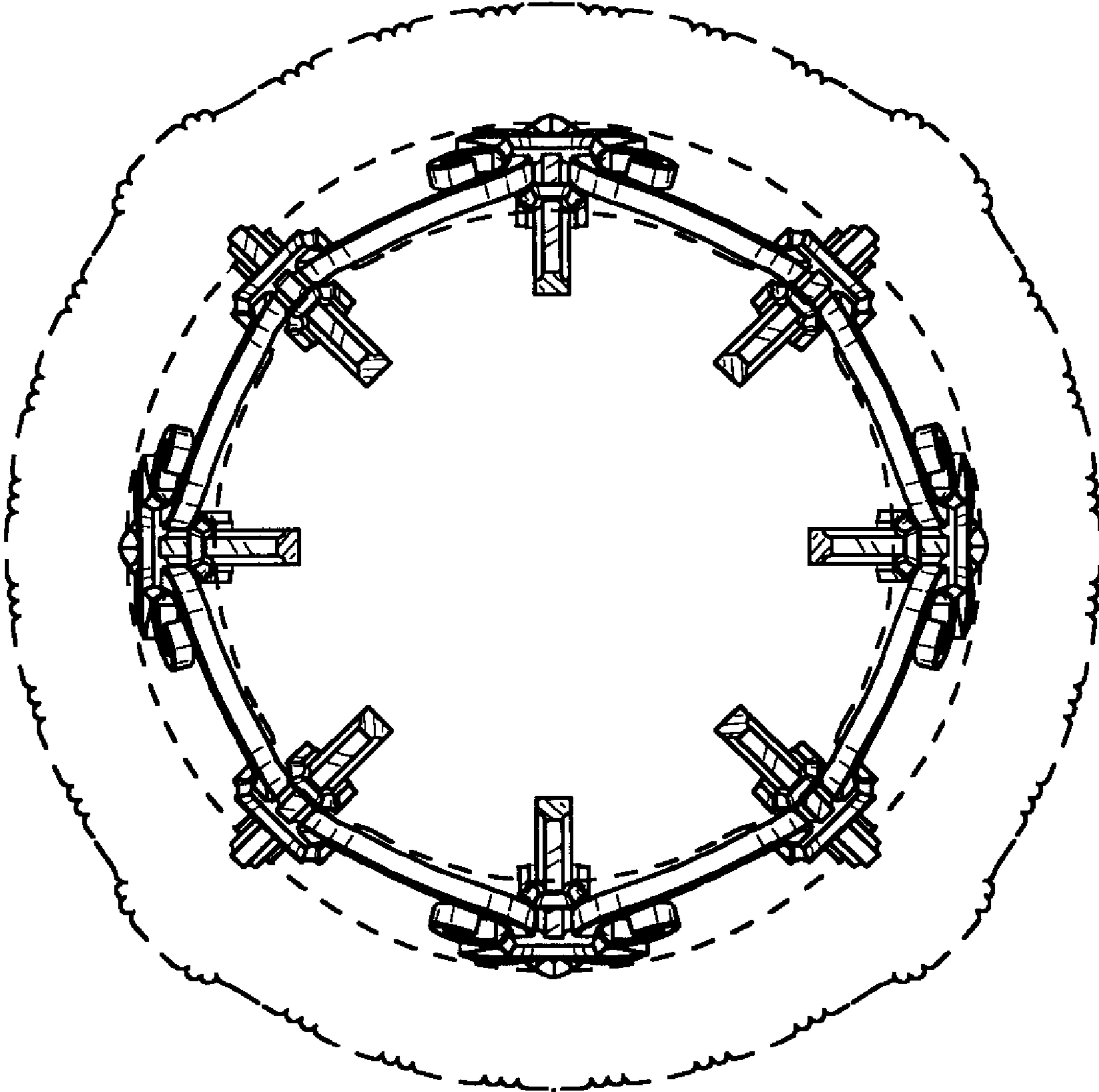

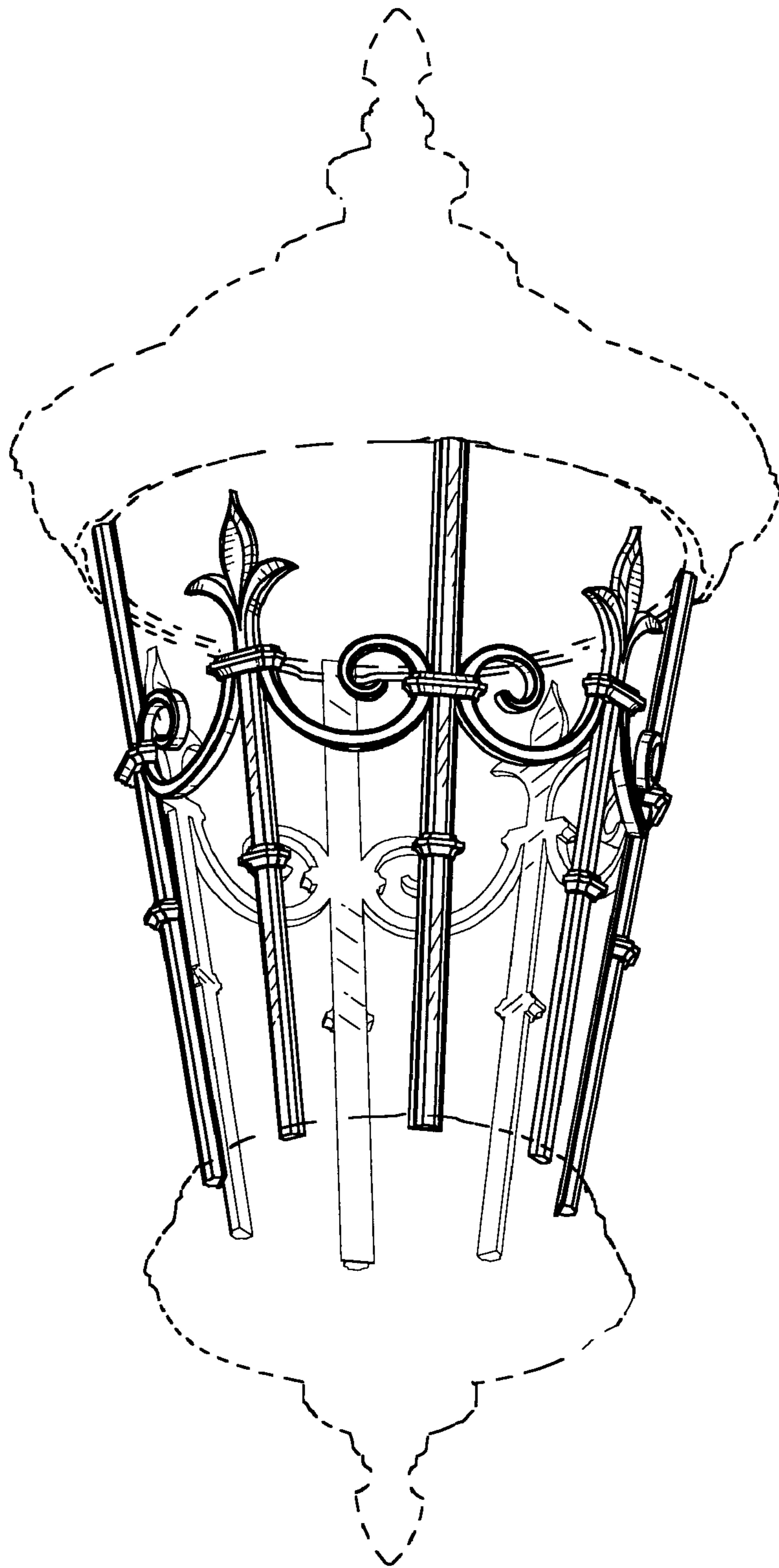

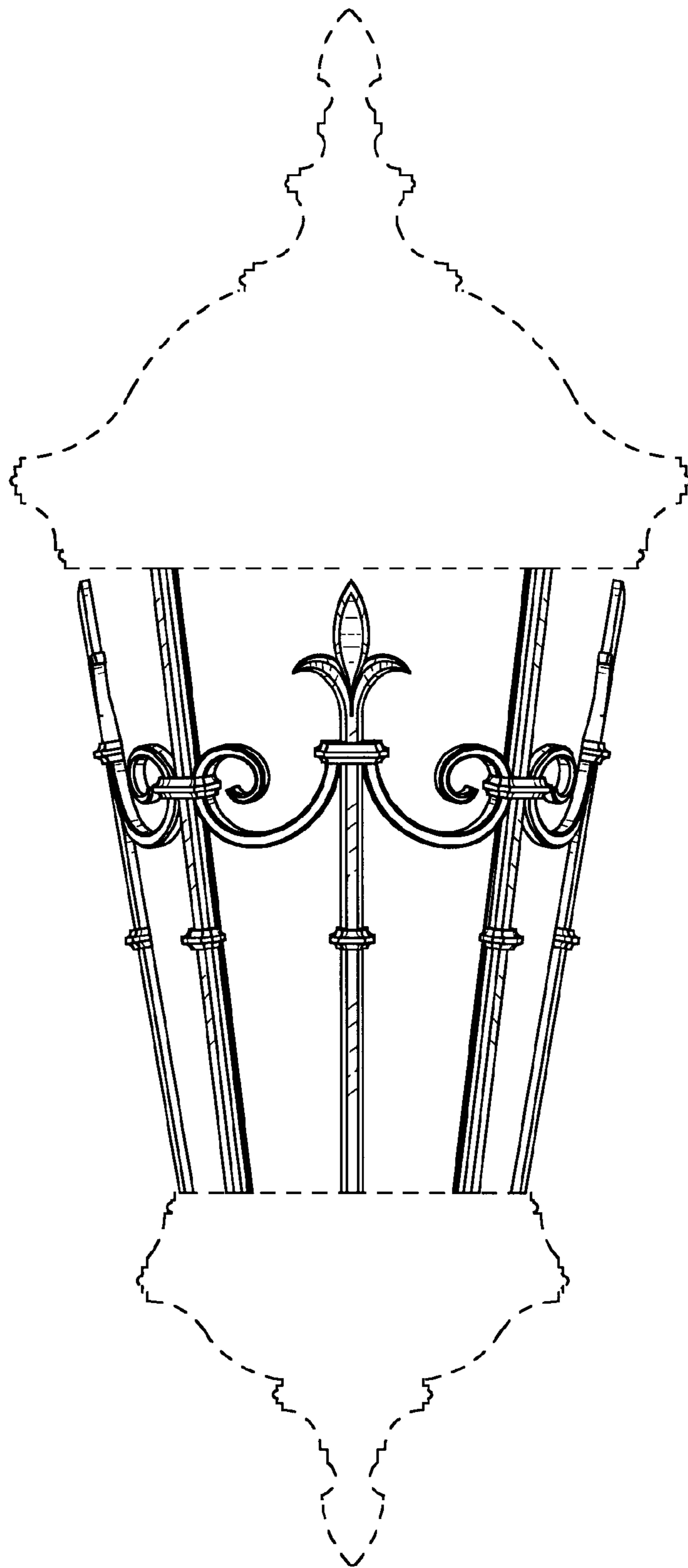

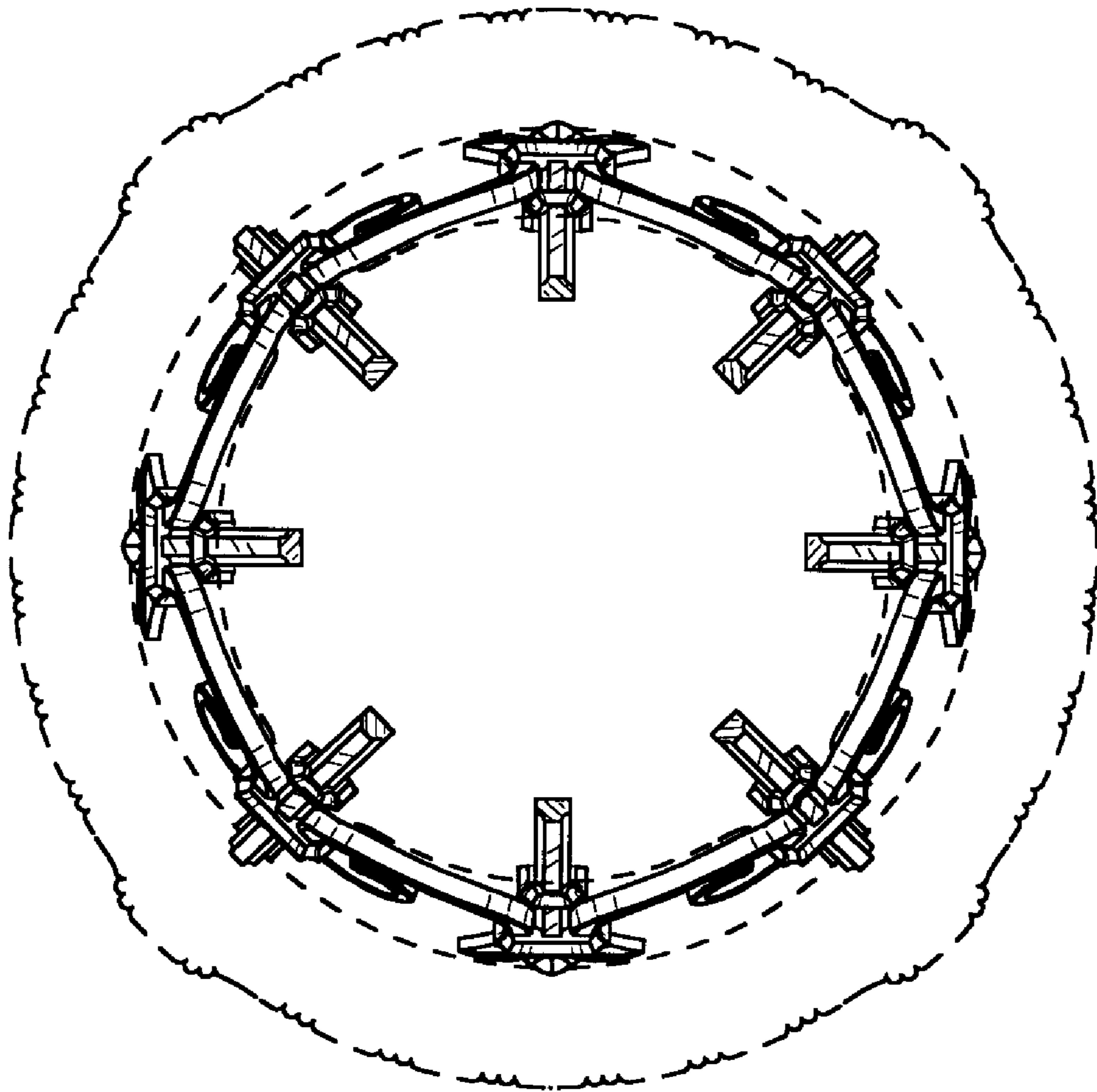
