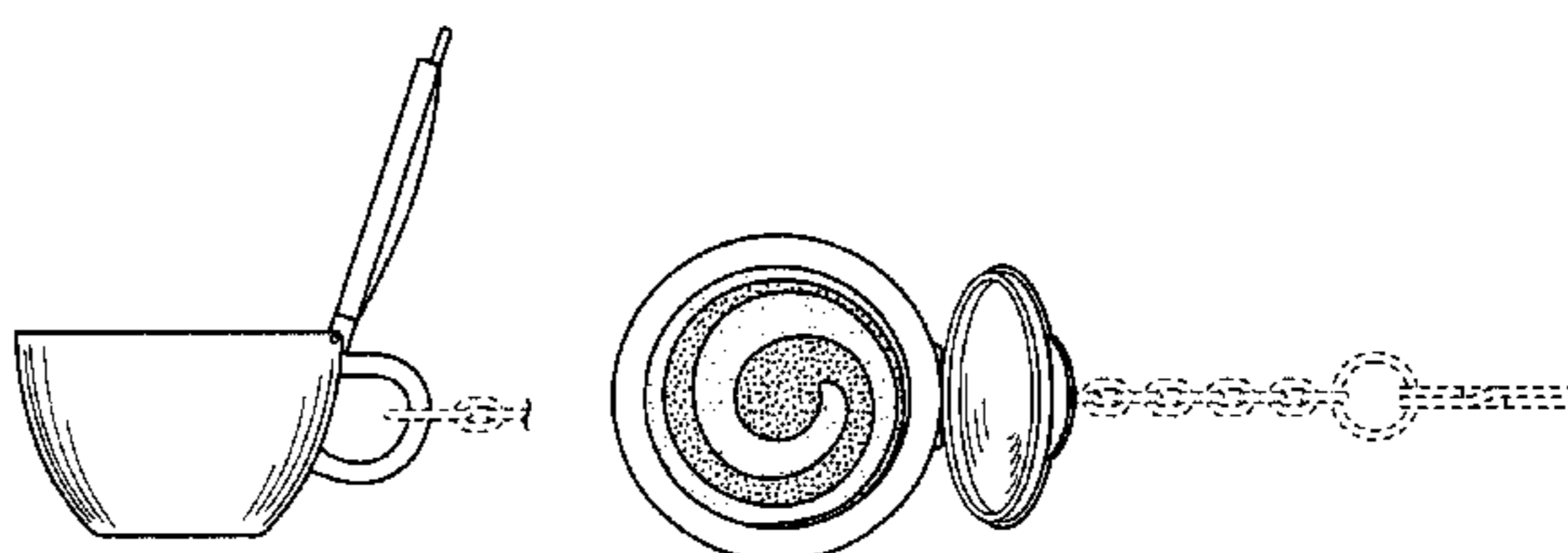
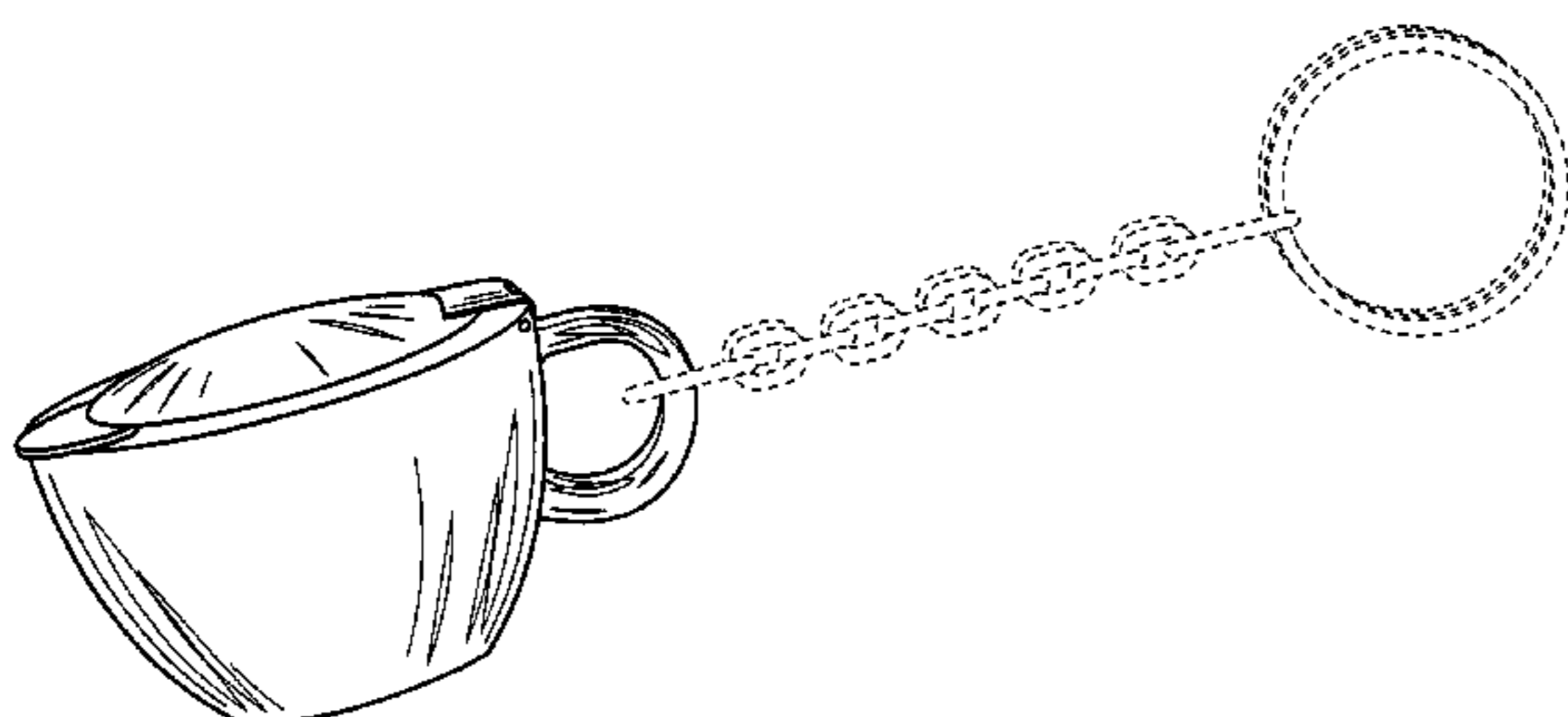
(57) **CLAIM**

I claim the ornamental design for the cosmetics package, as shown and described.

DESCRIPTION

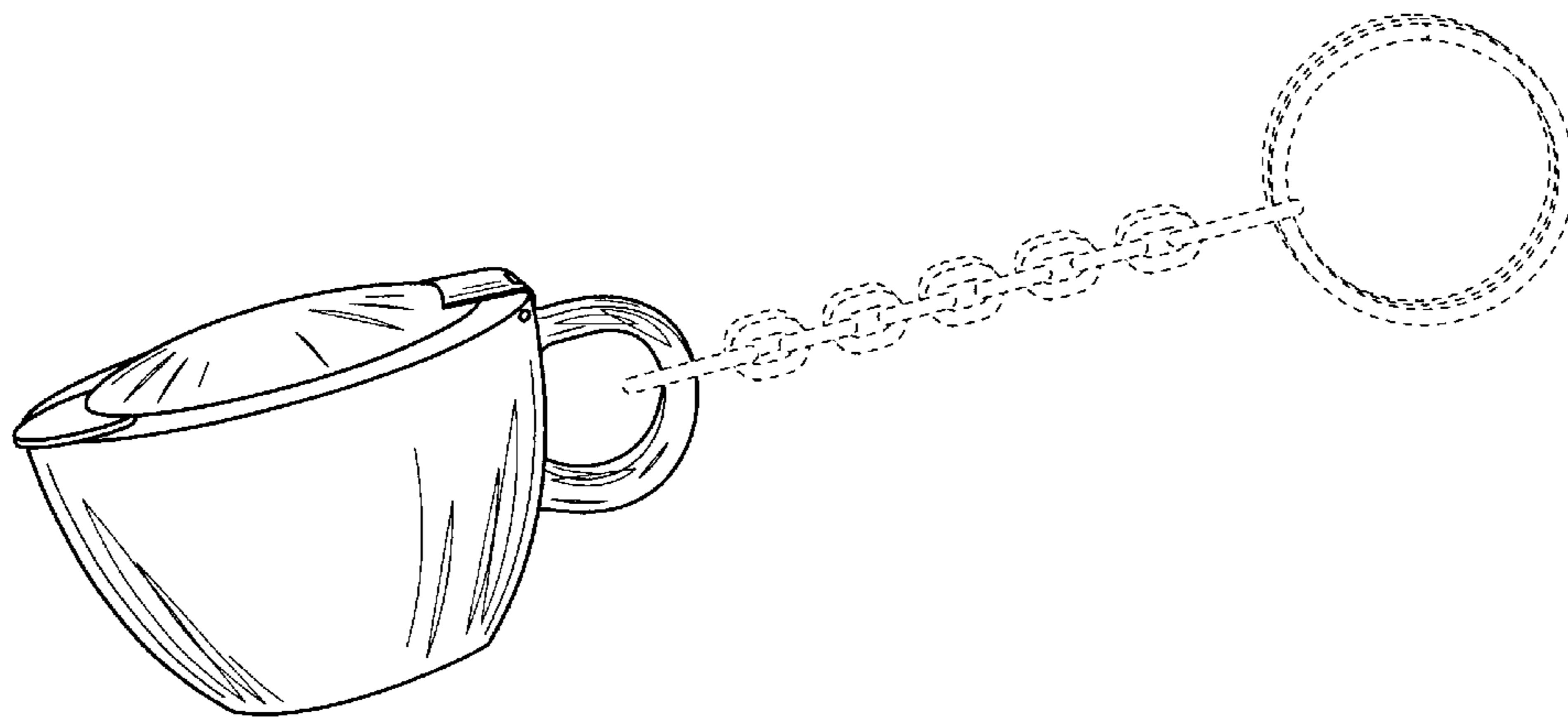

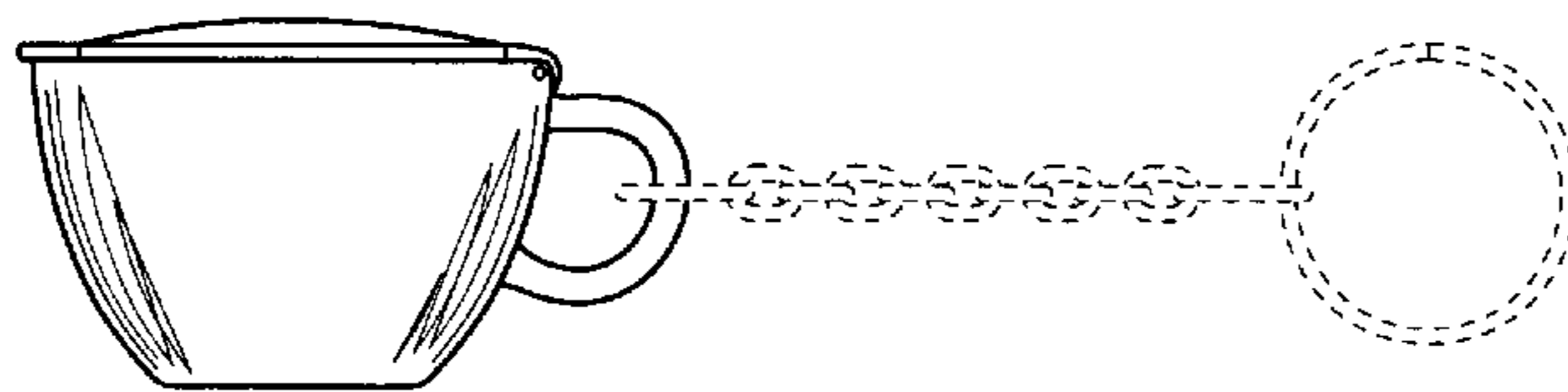

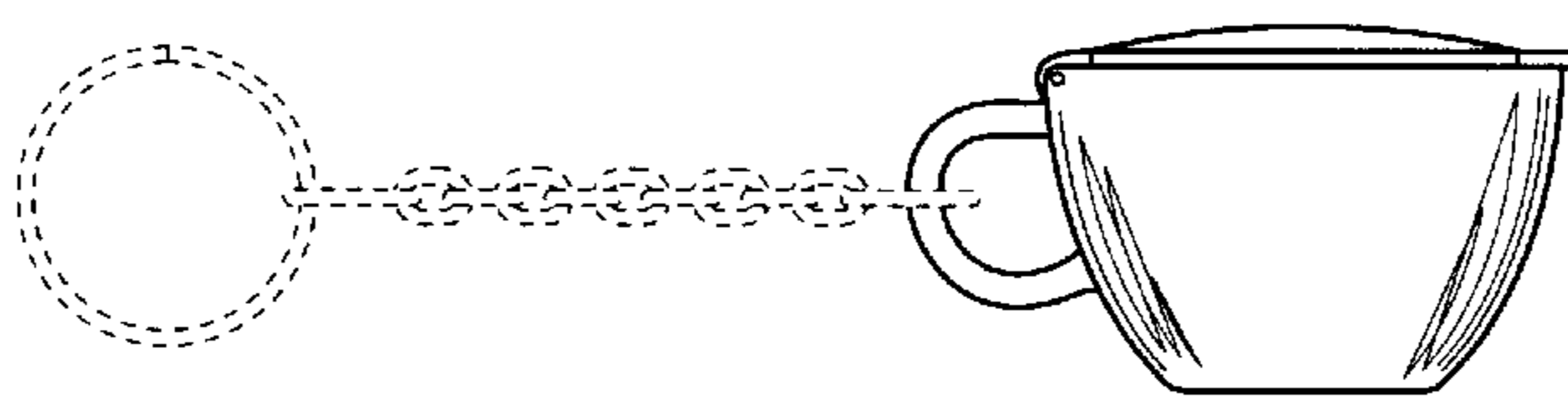

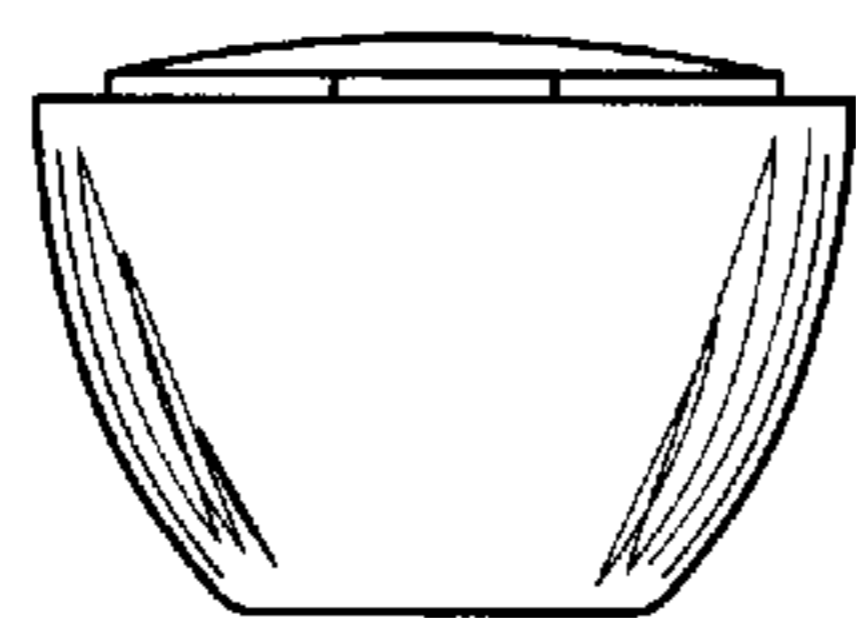

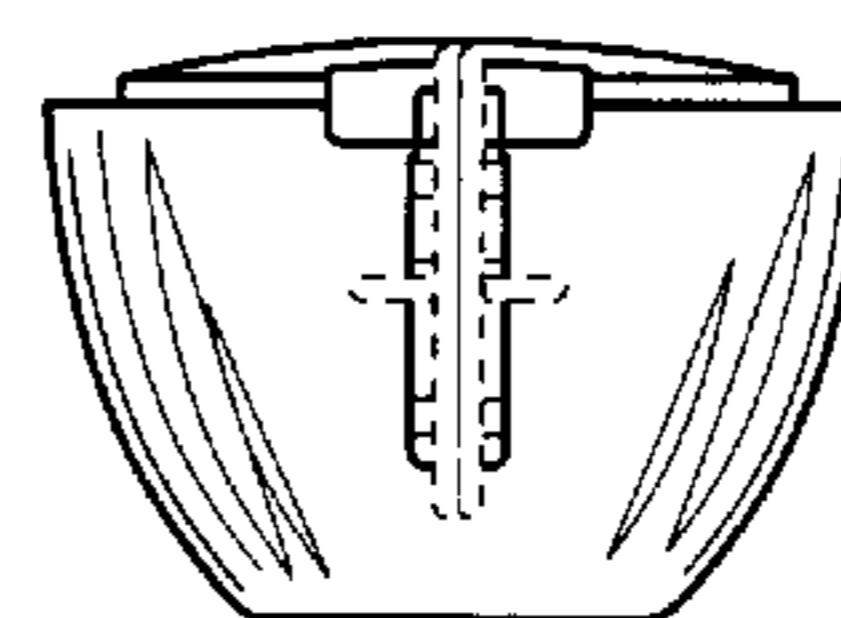

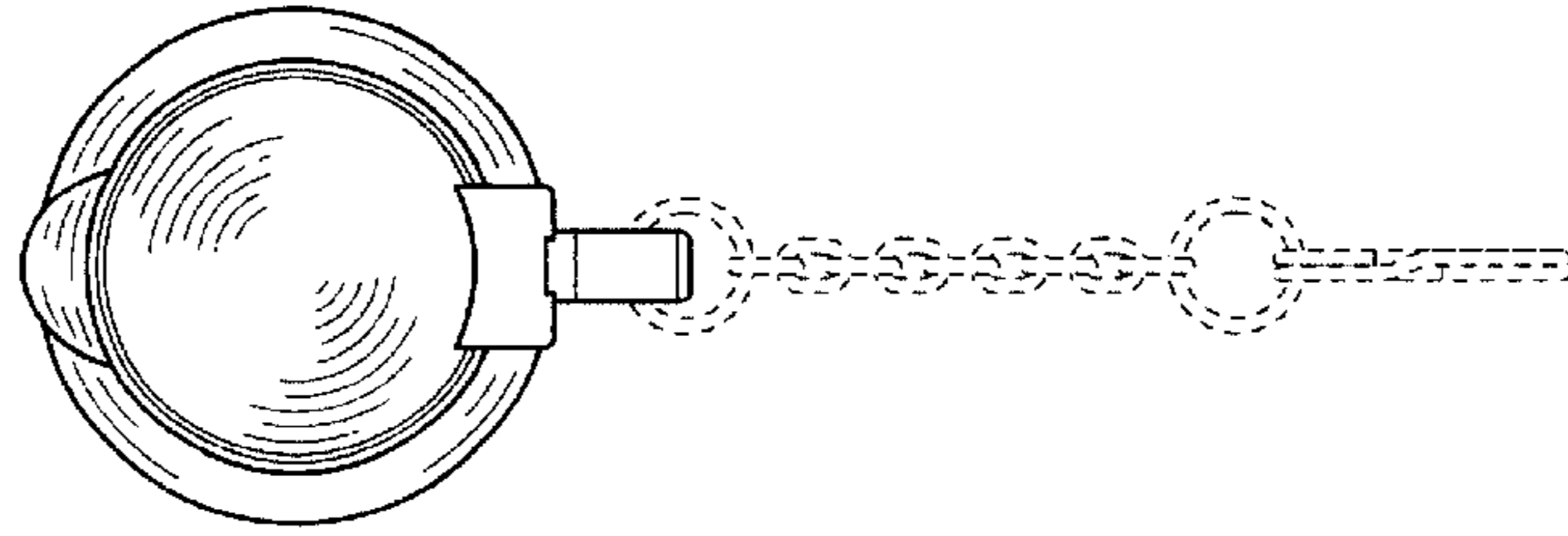

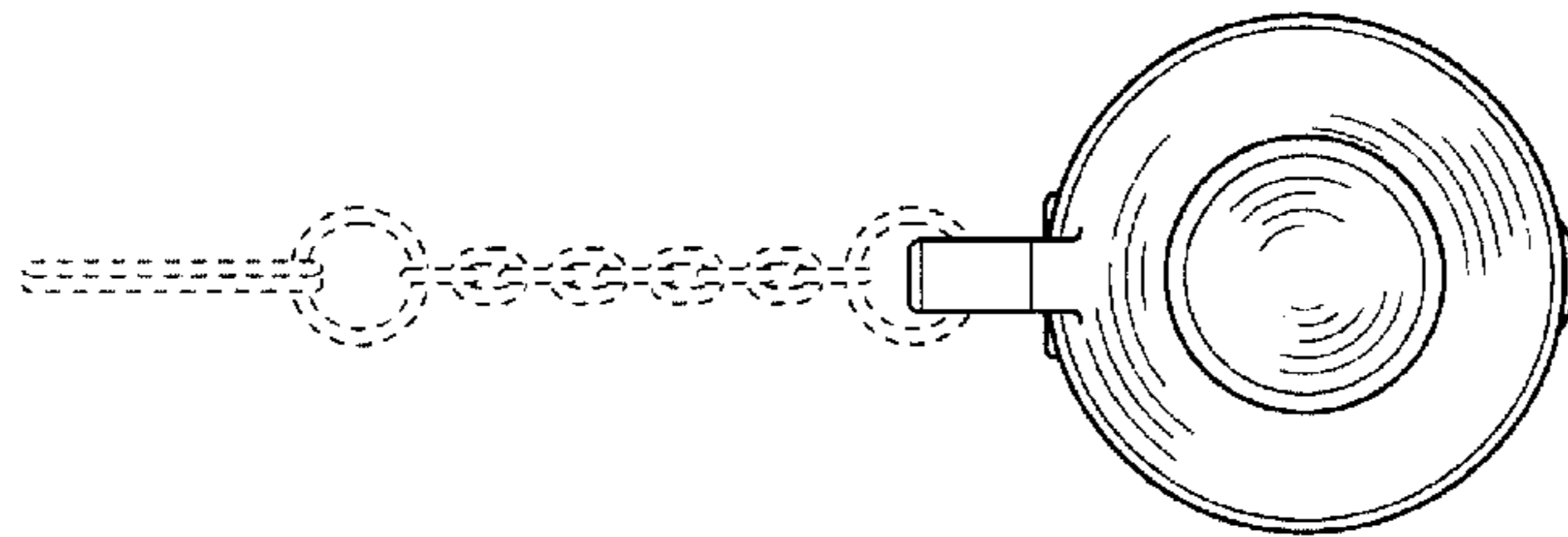

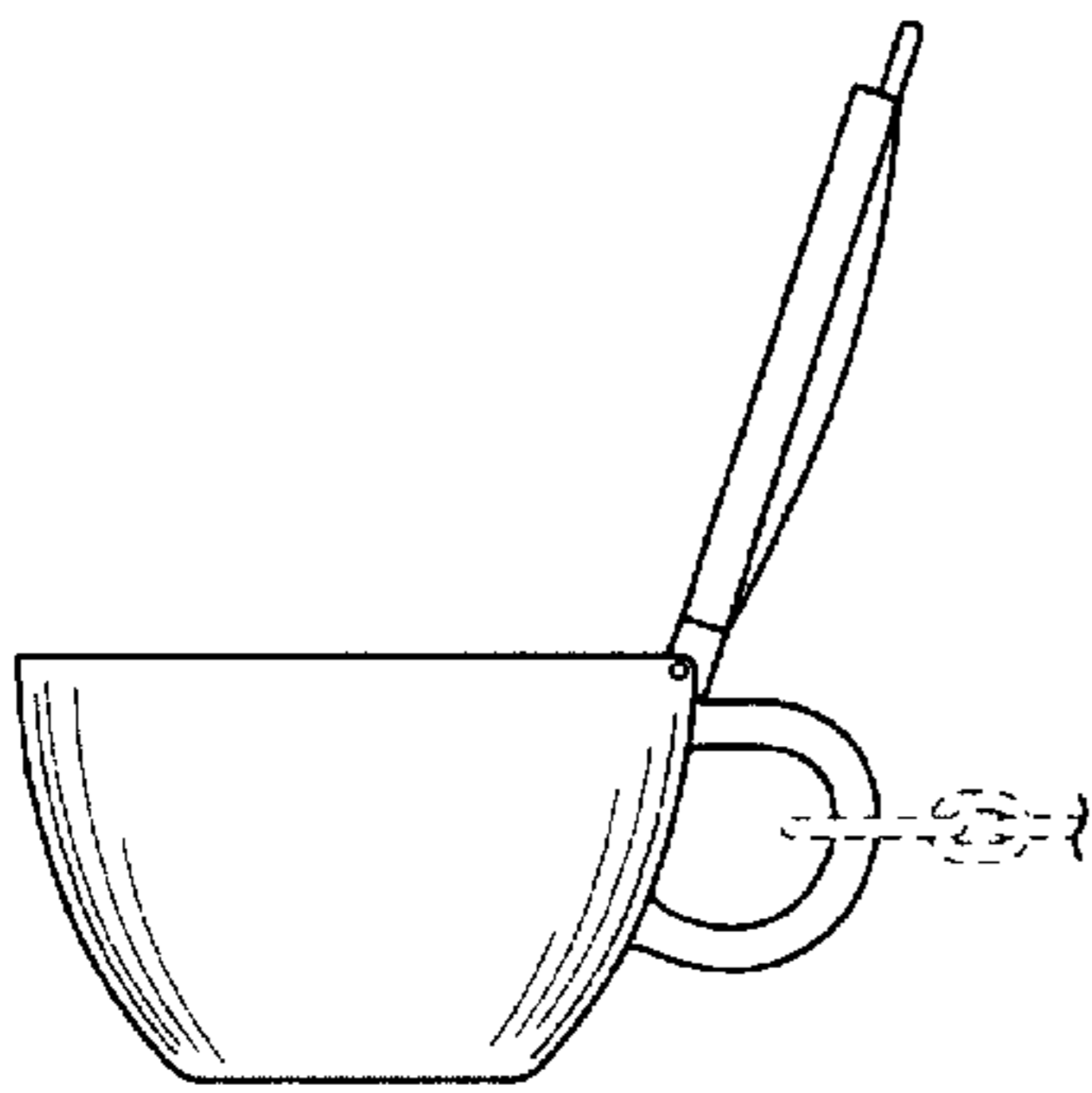

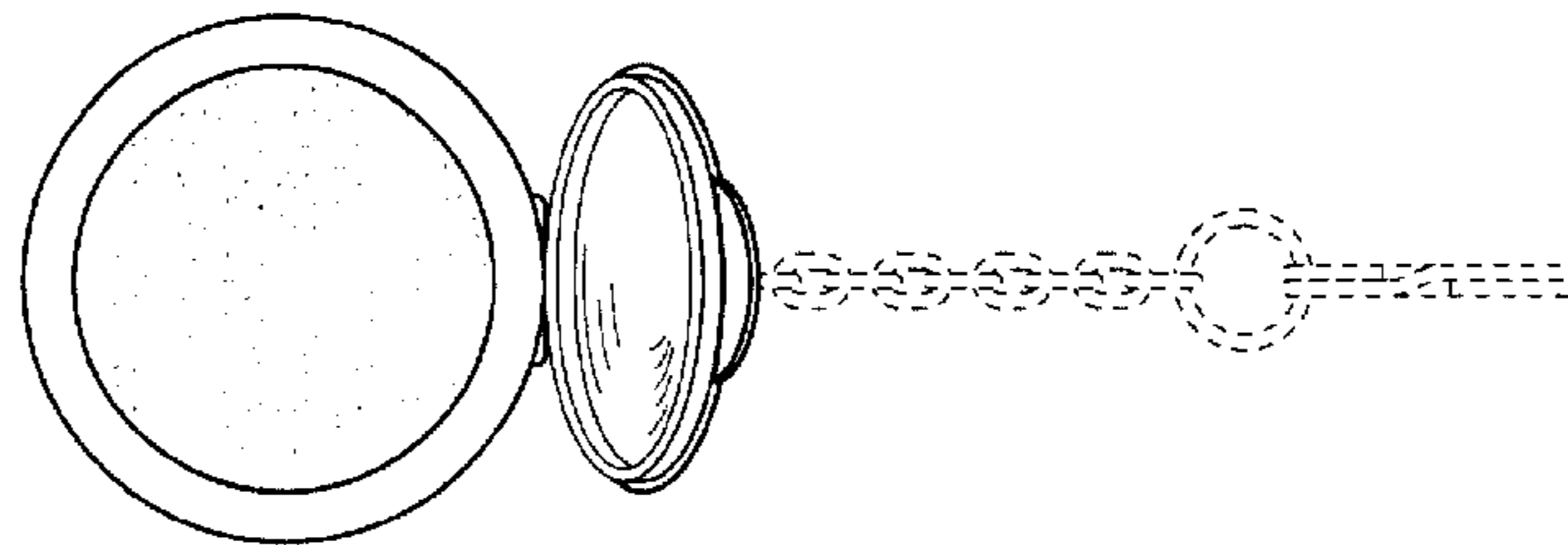

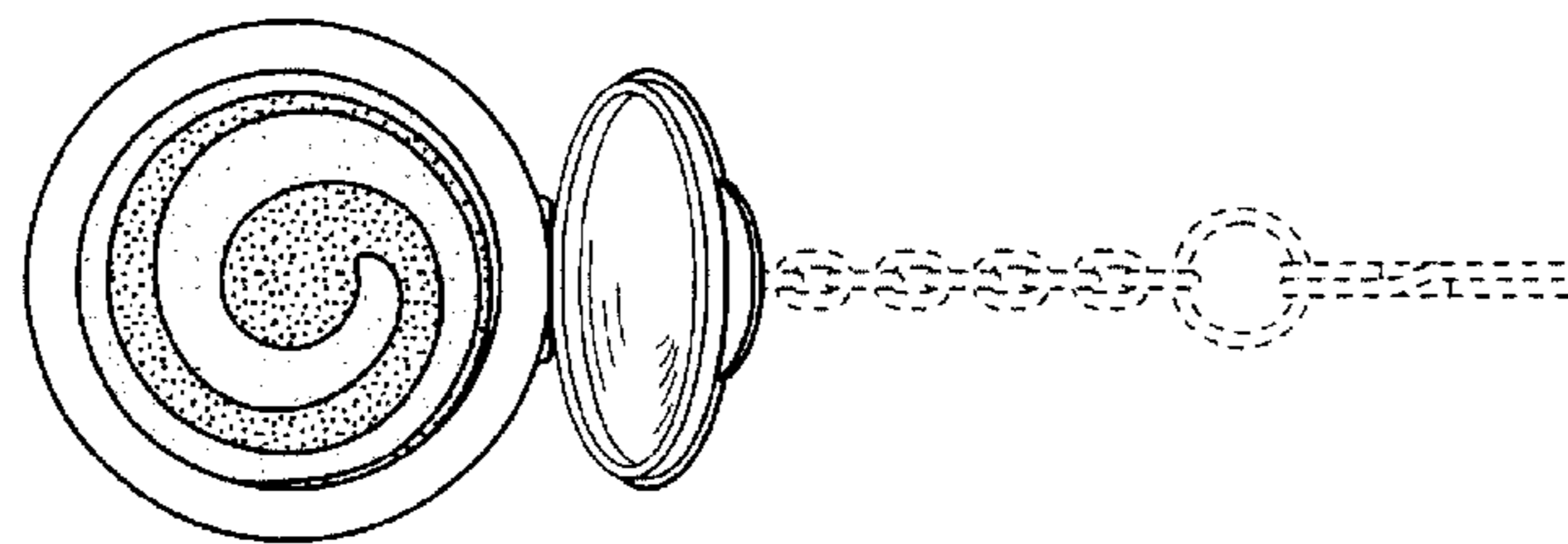

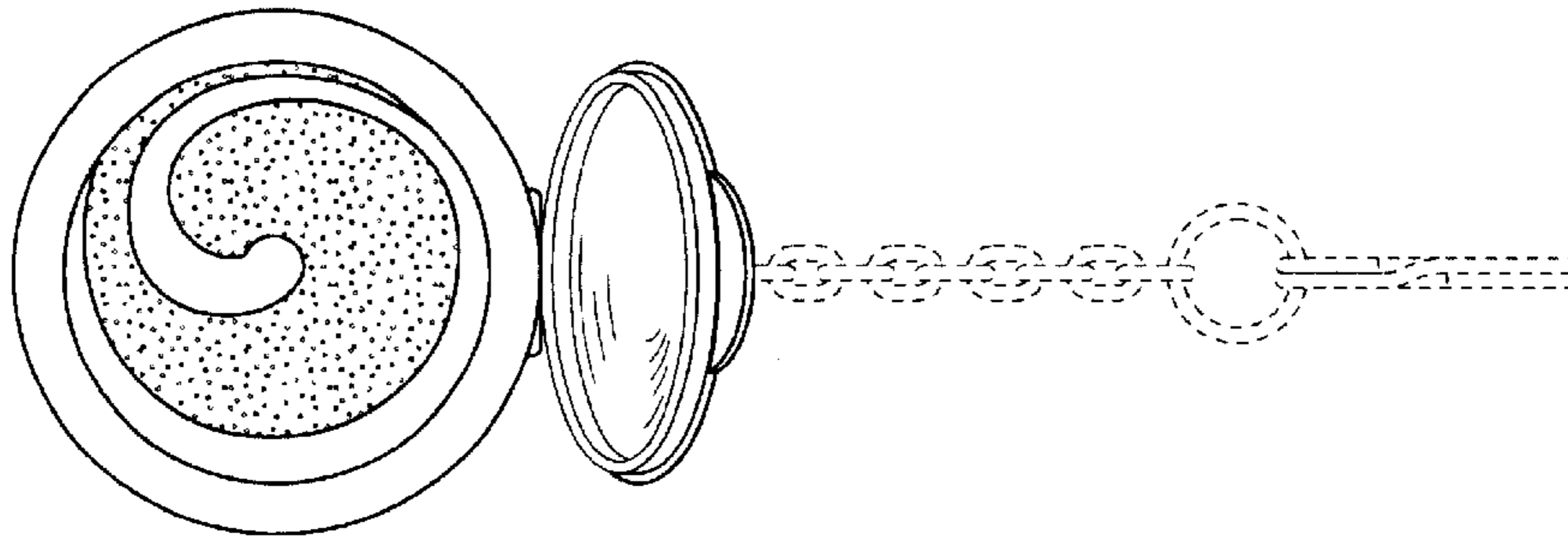

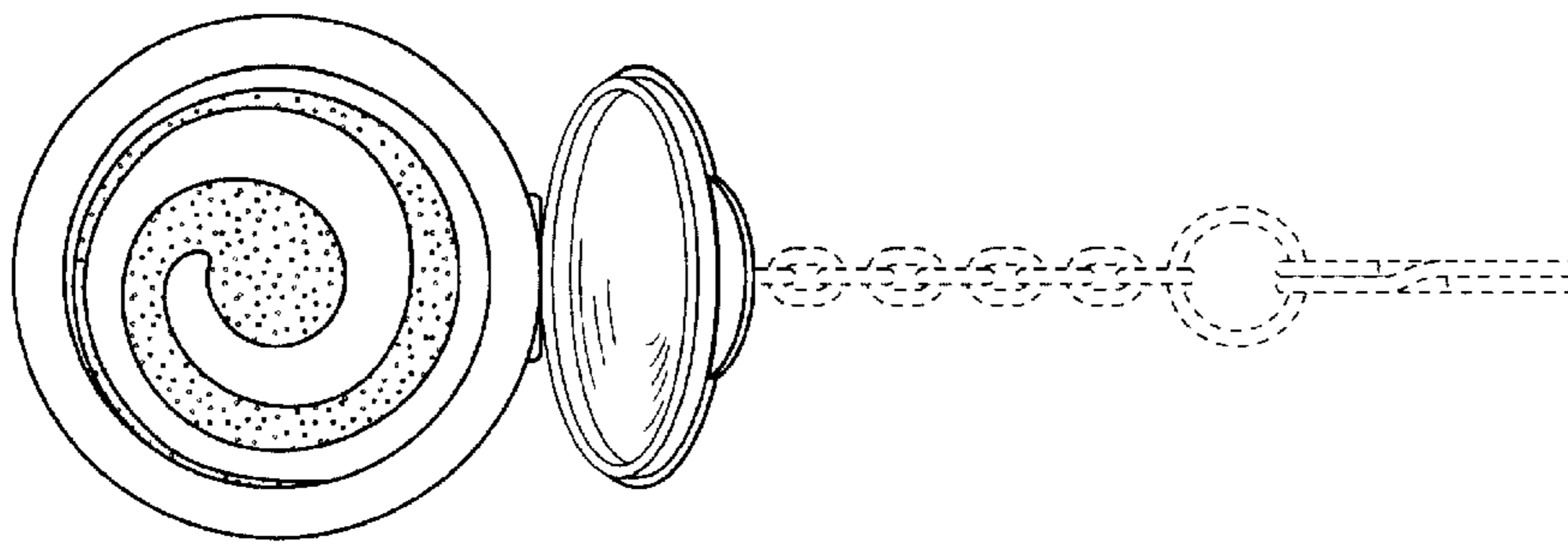

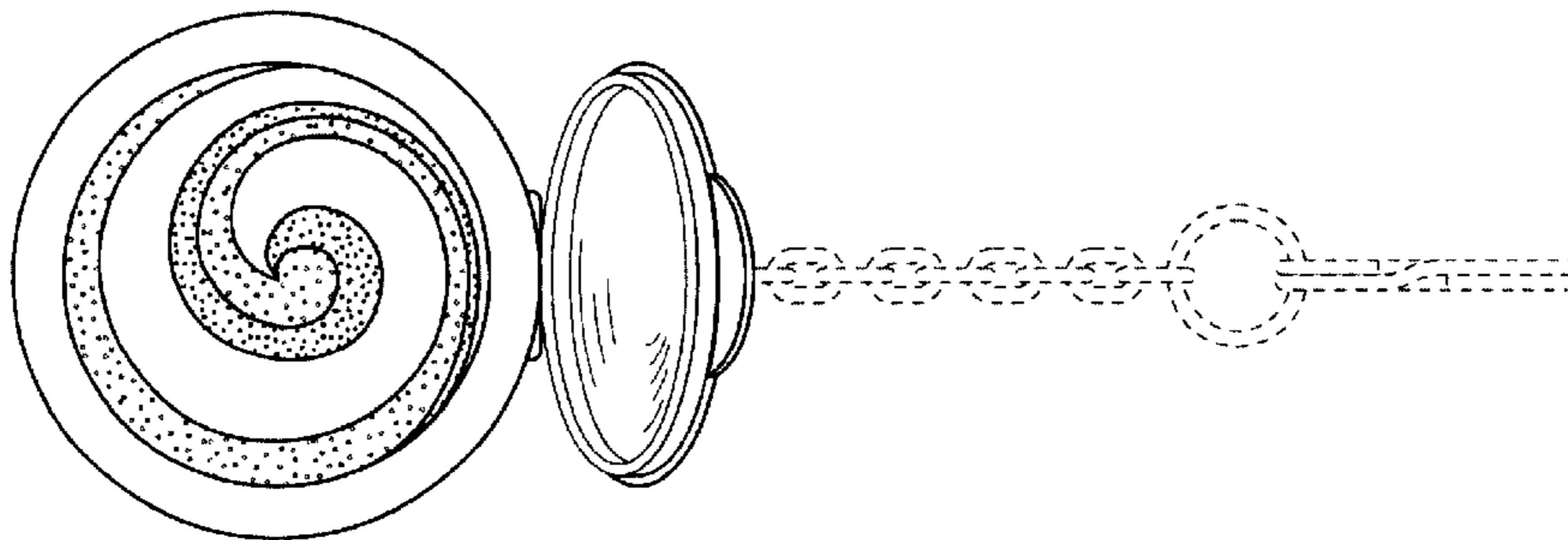

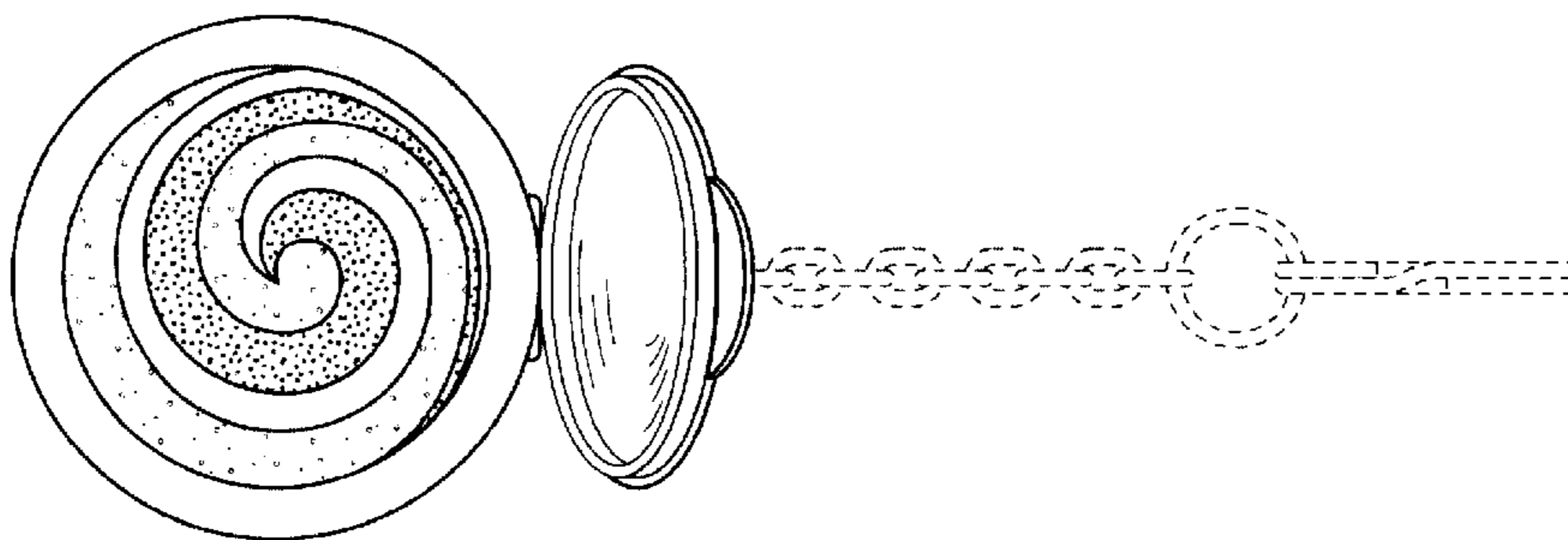

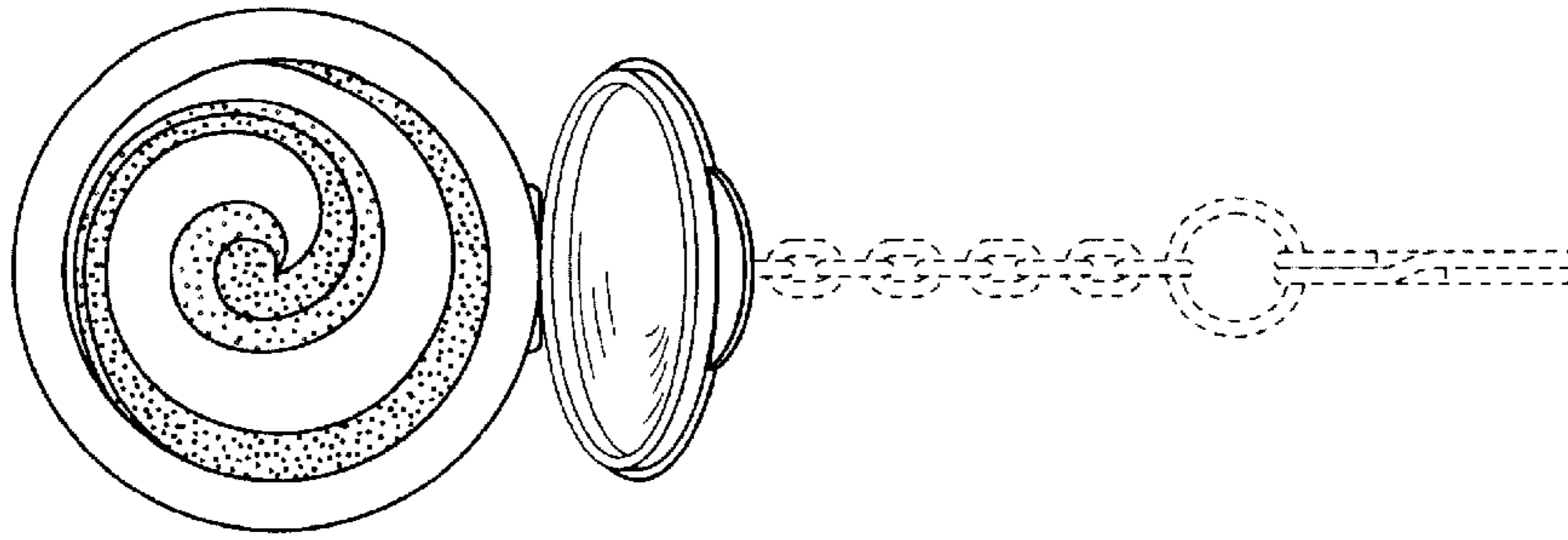

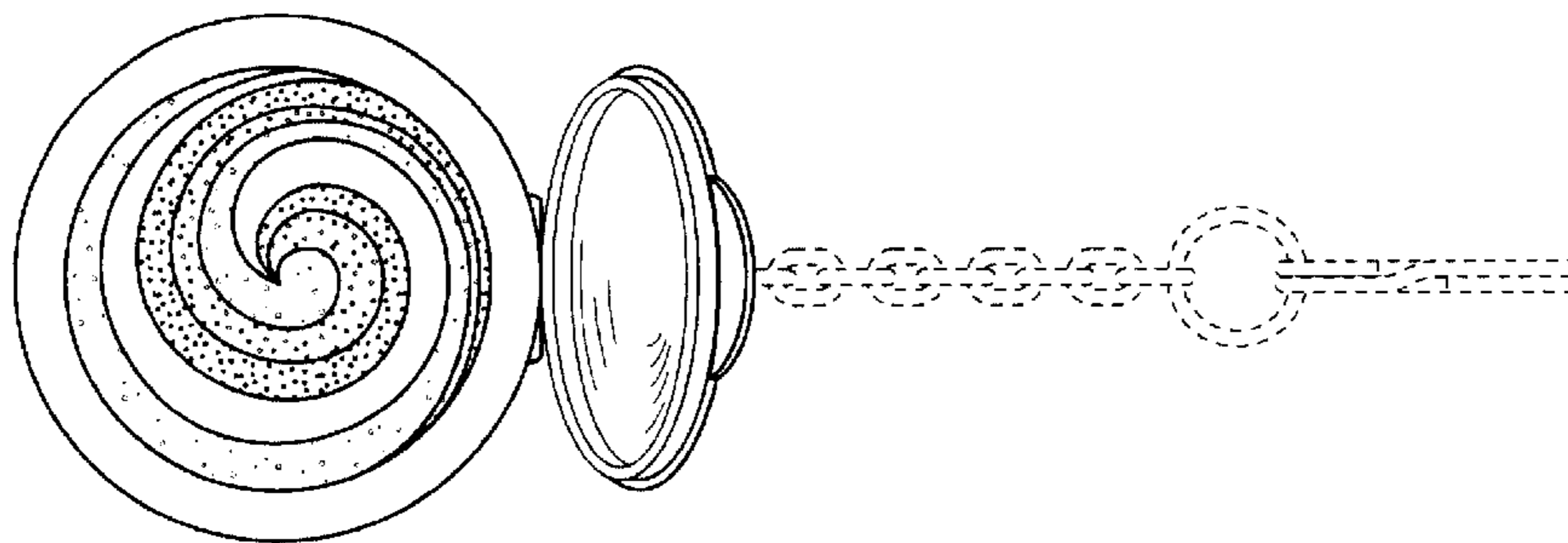

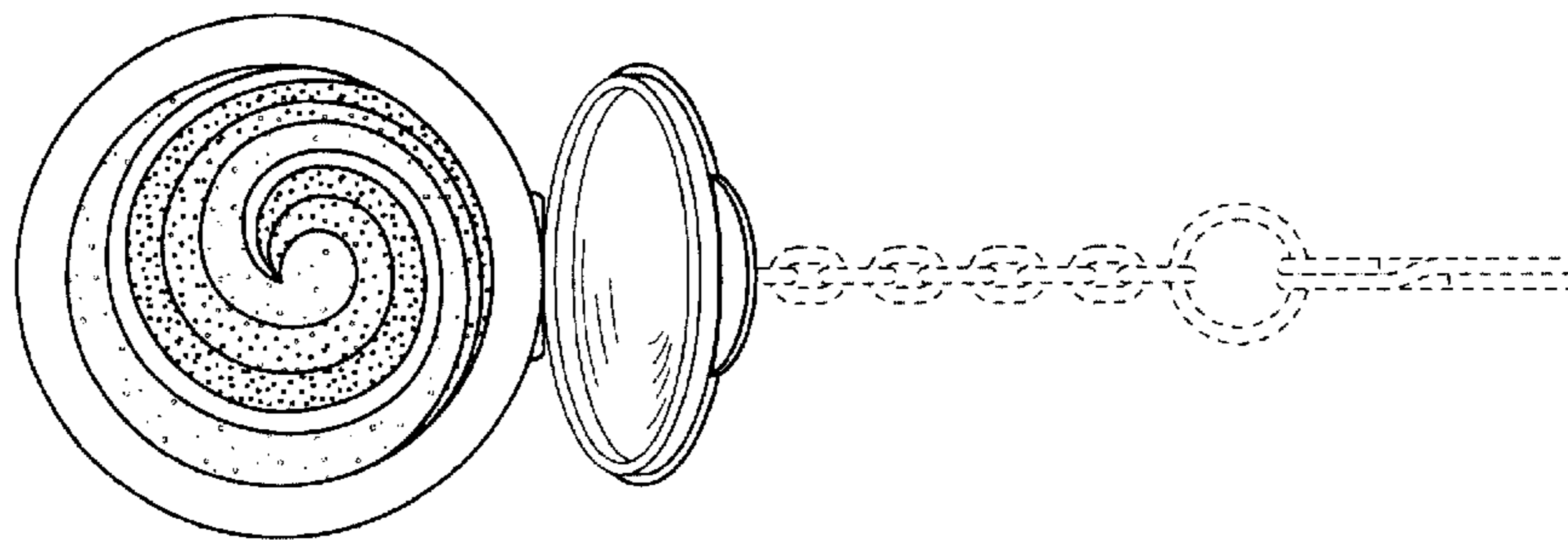

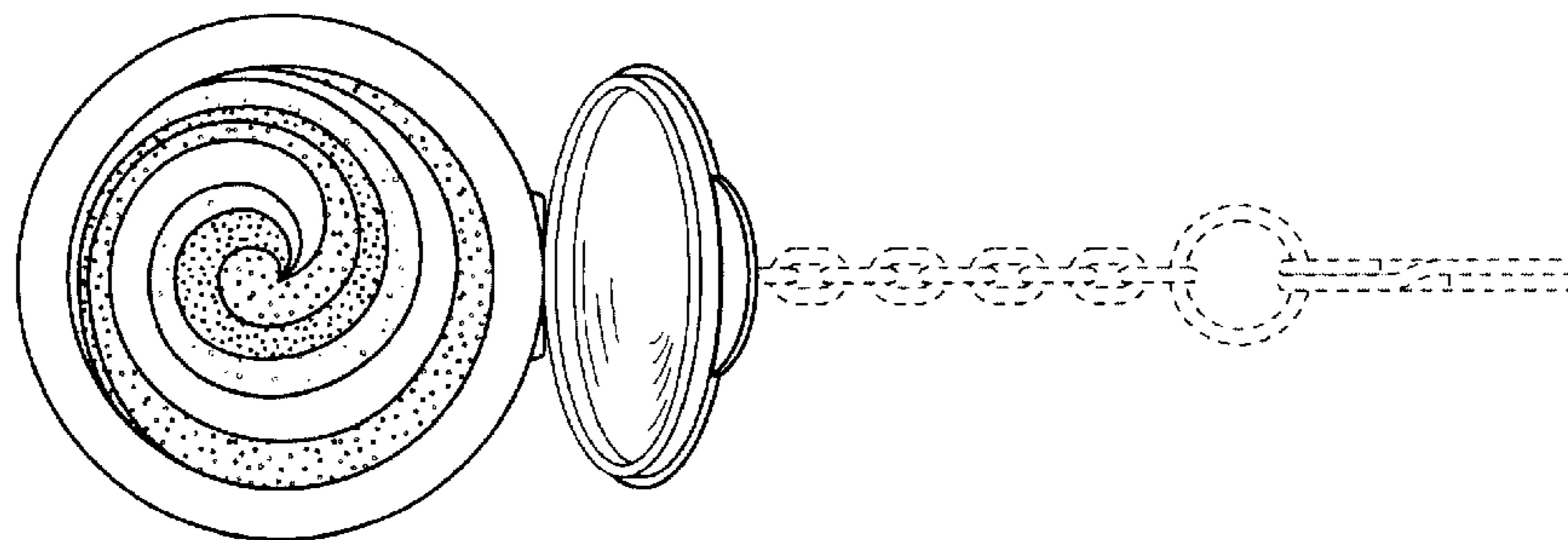
