FIG. 1 is a perspective view of a foot pedal of the present invention;

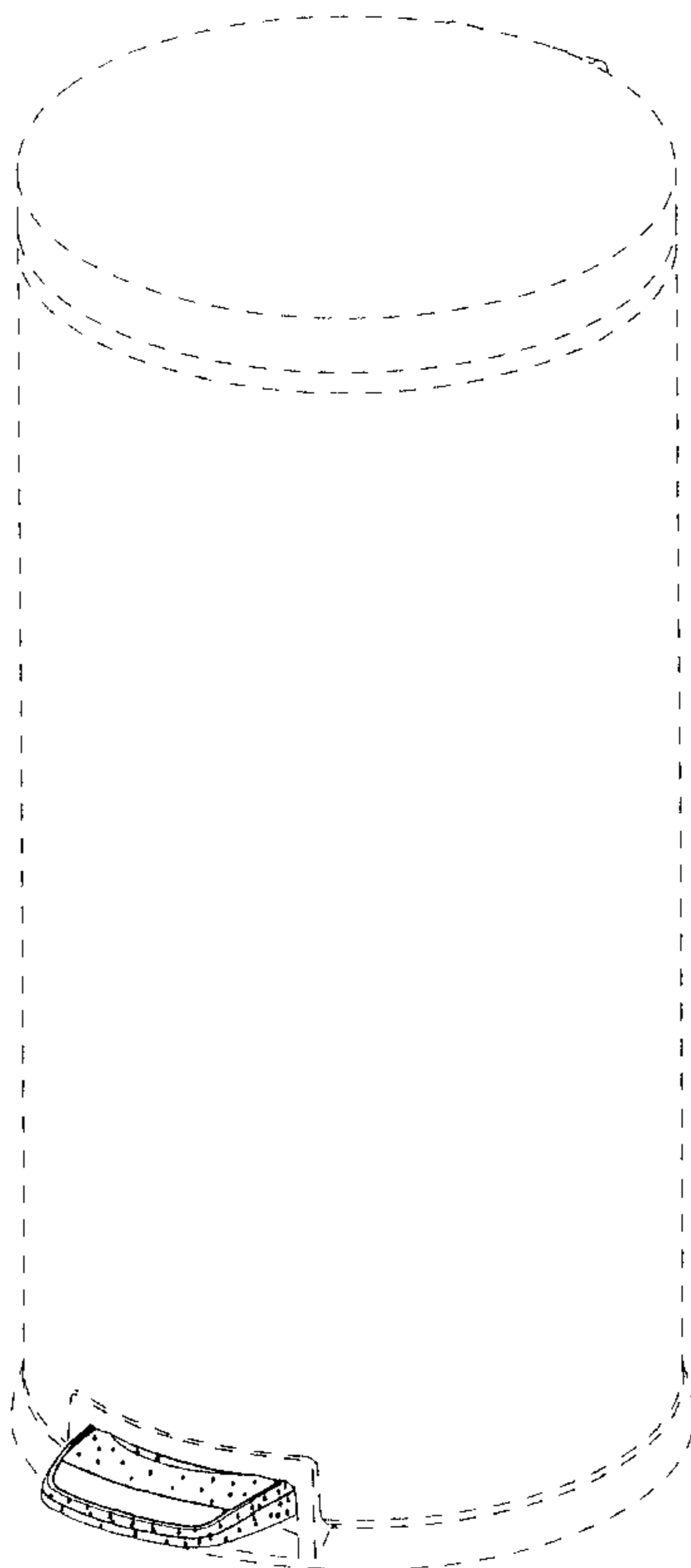
FIG. 2 is a front view of the foot pedal of FIG. 1;

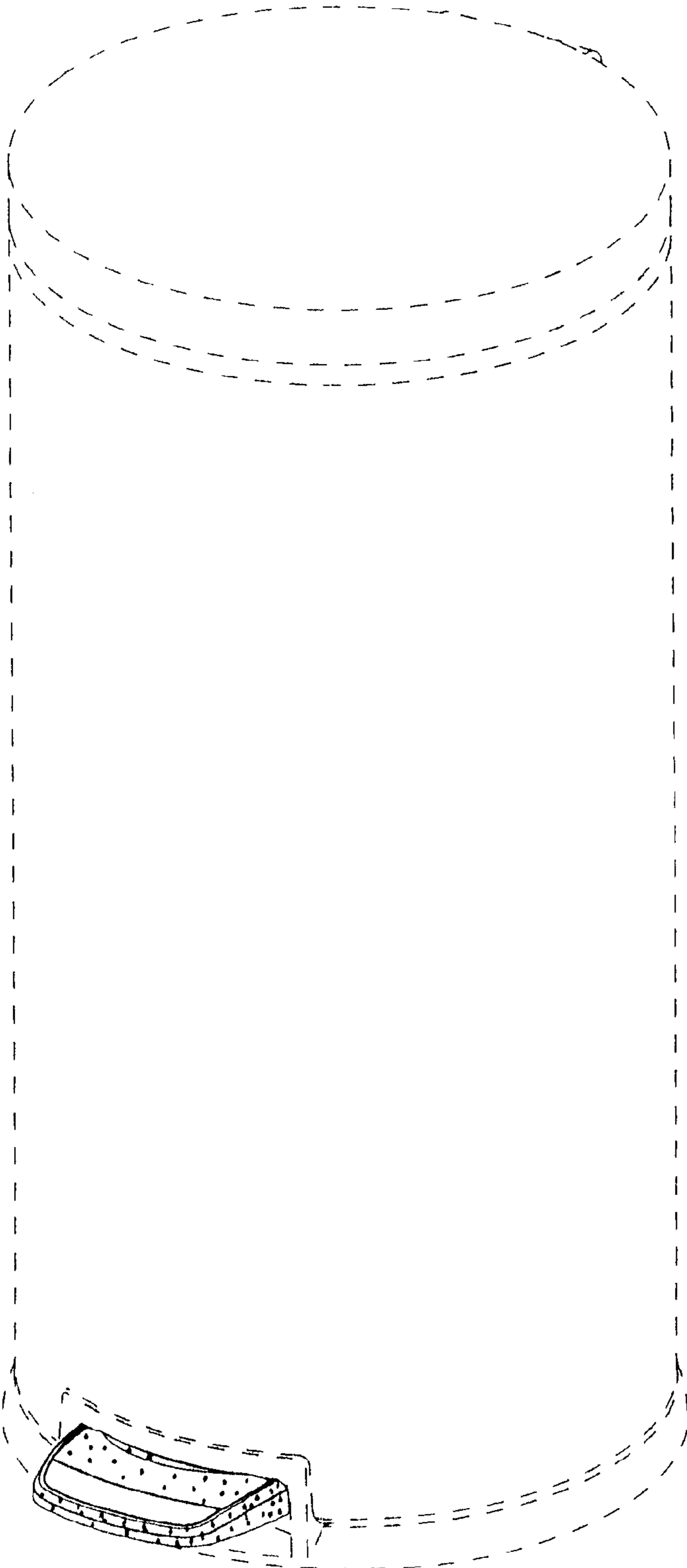

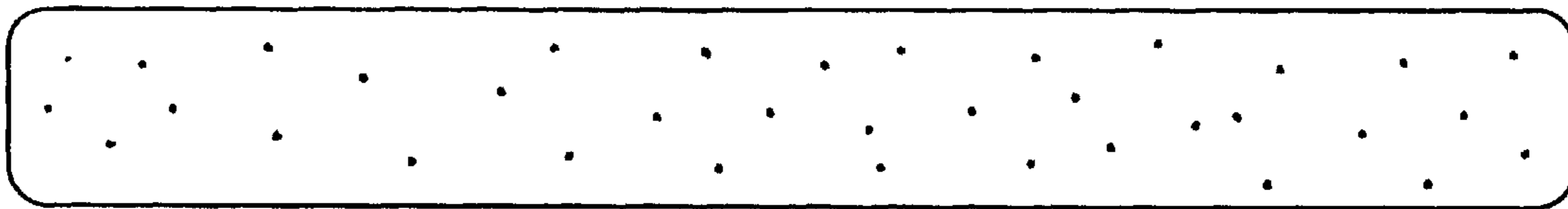

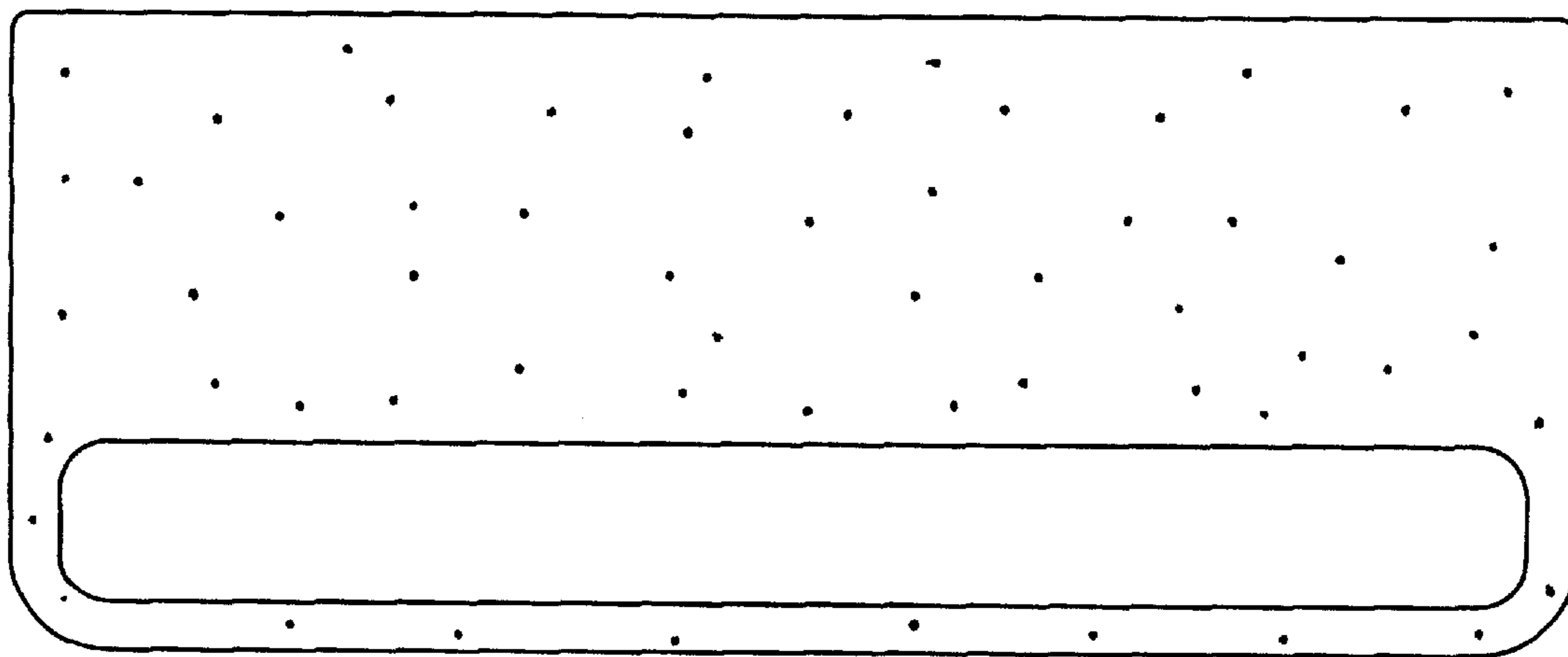

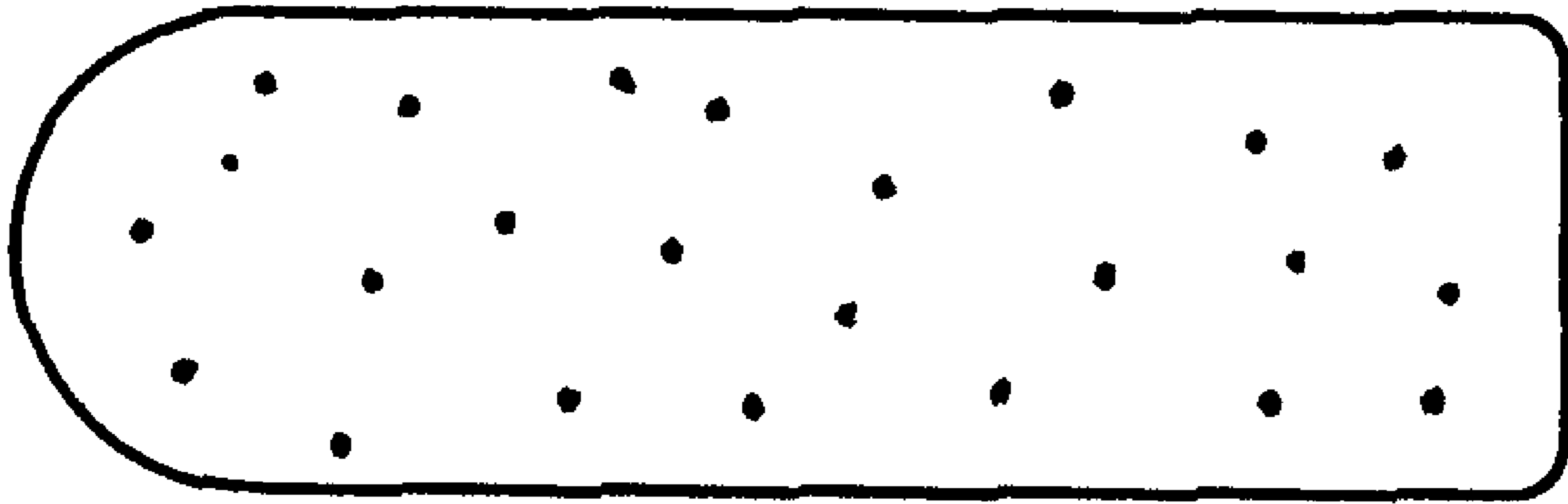

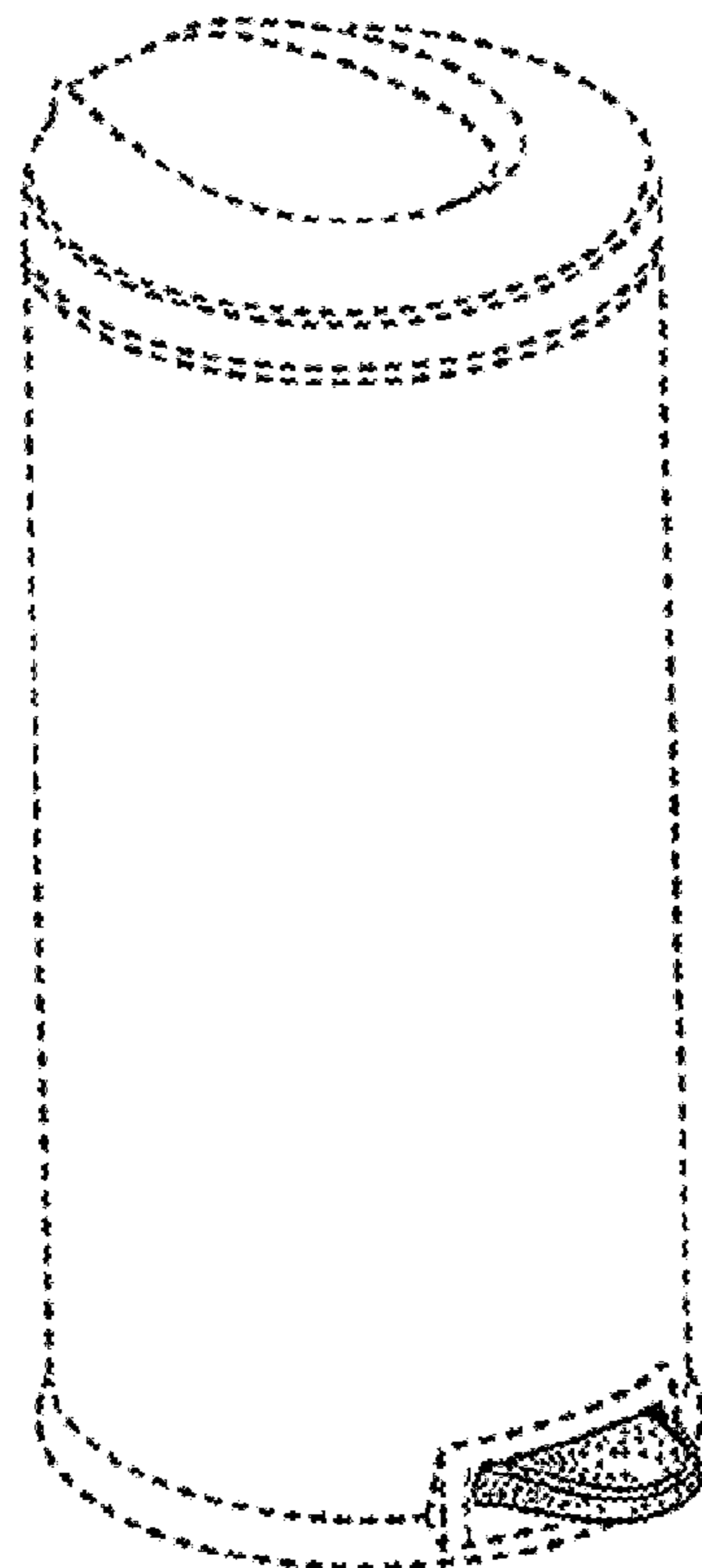
FIG. 1 is a perspective view of a foot pedal of the present invention;

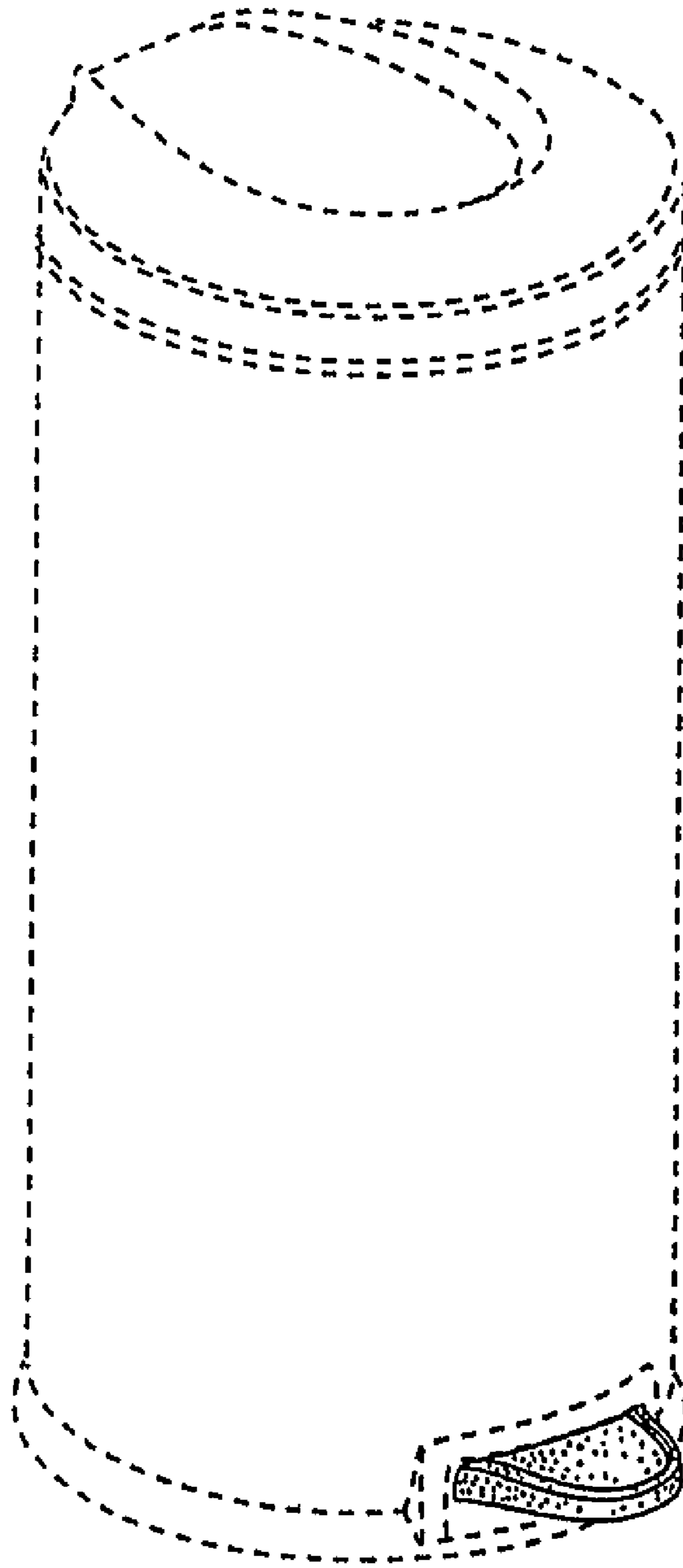

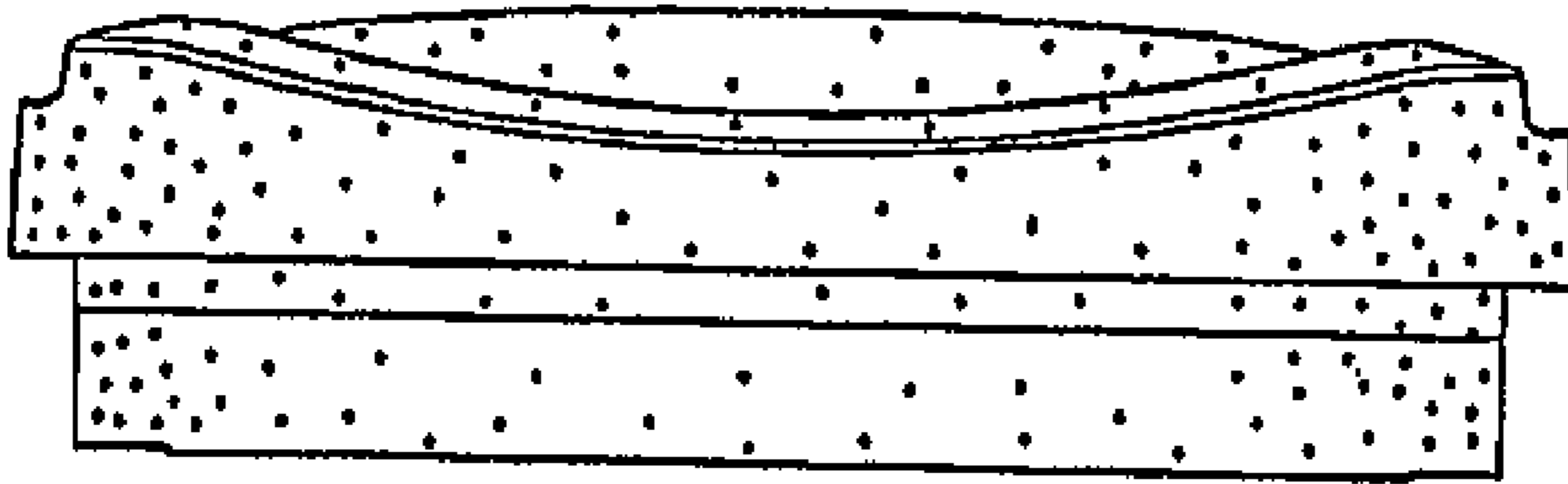

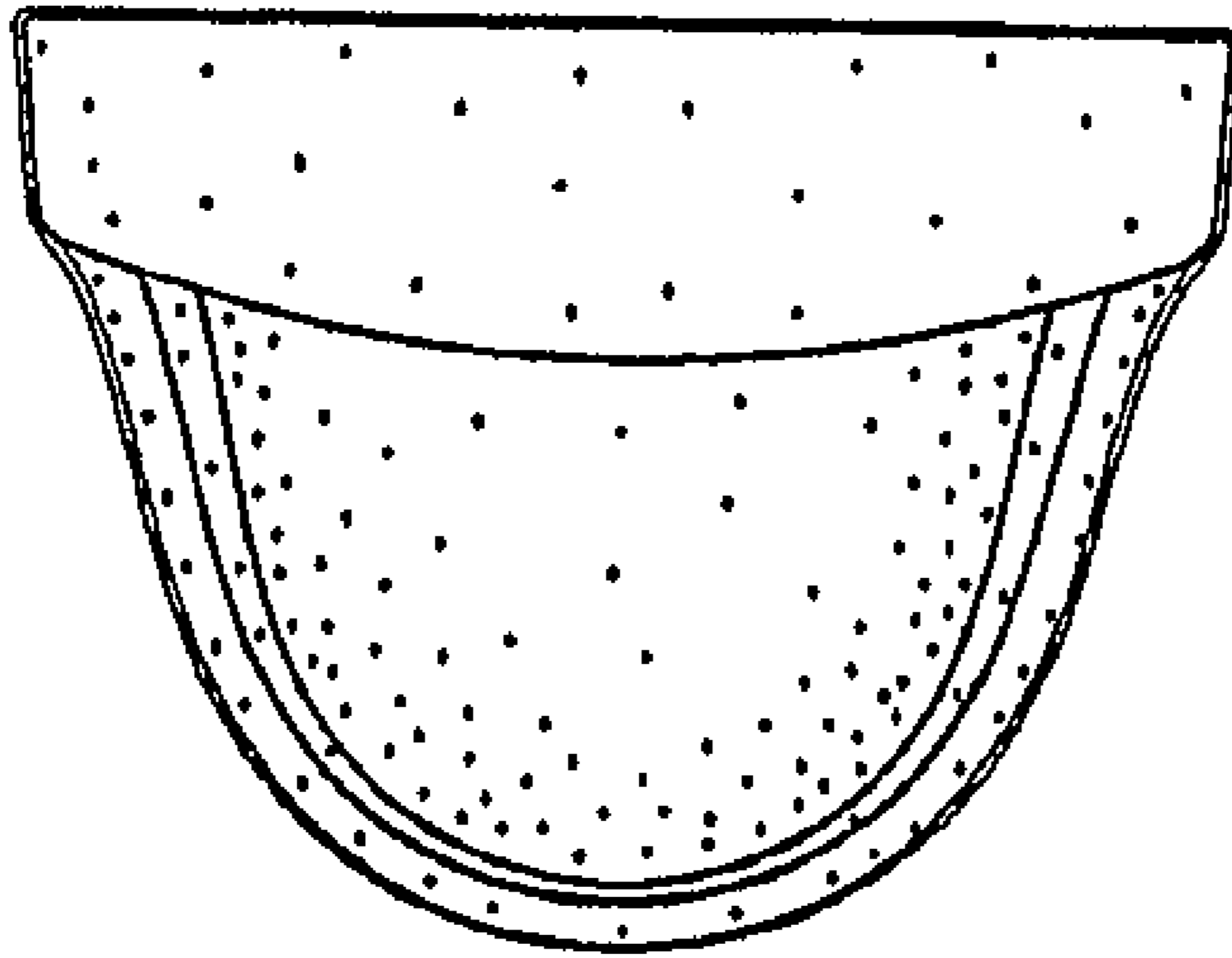

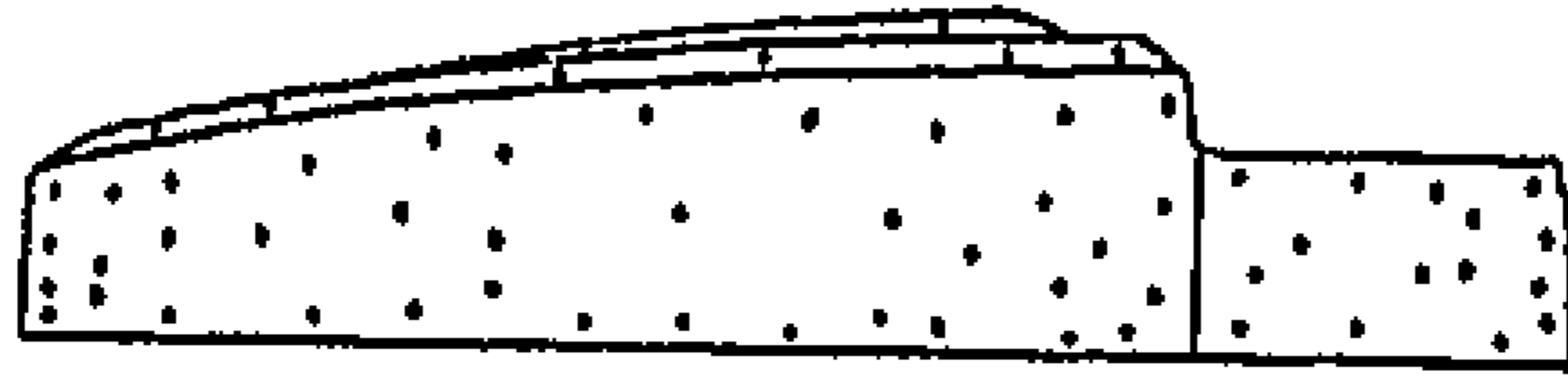
