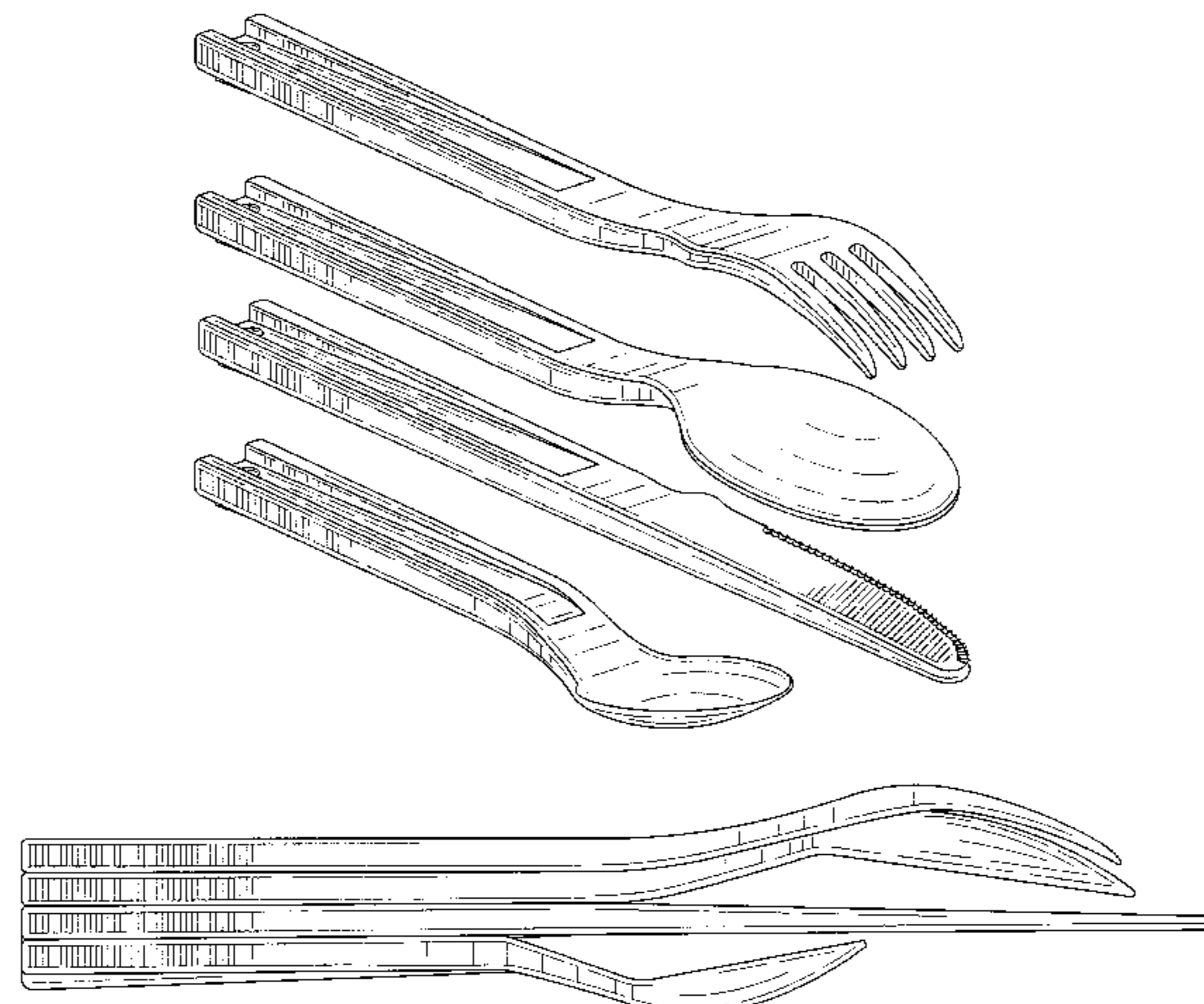

(57) **CLAIM**

The ornamental design for a knife, fork and spoons set, as shown and described.

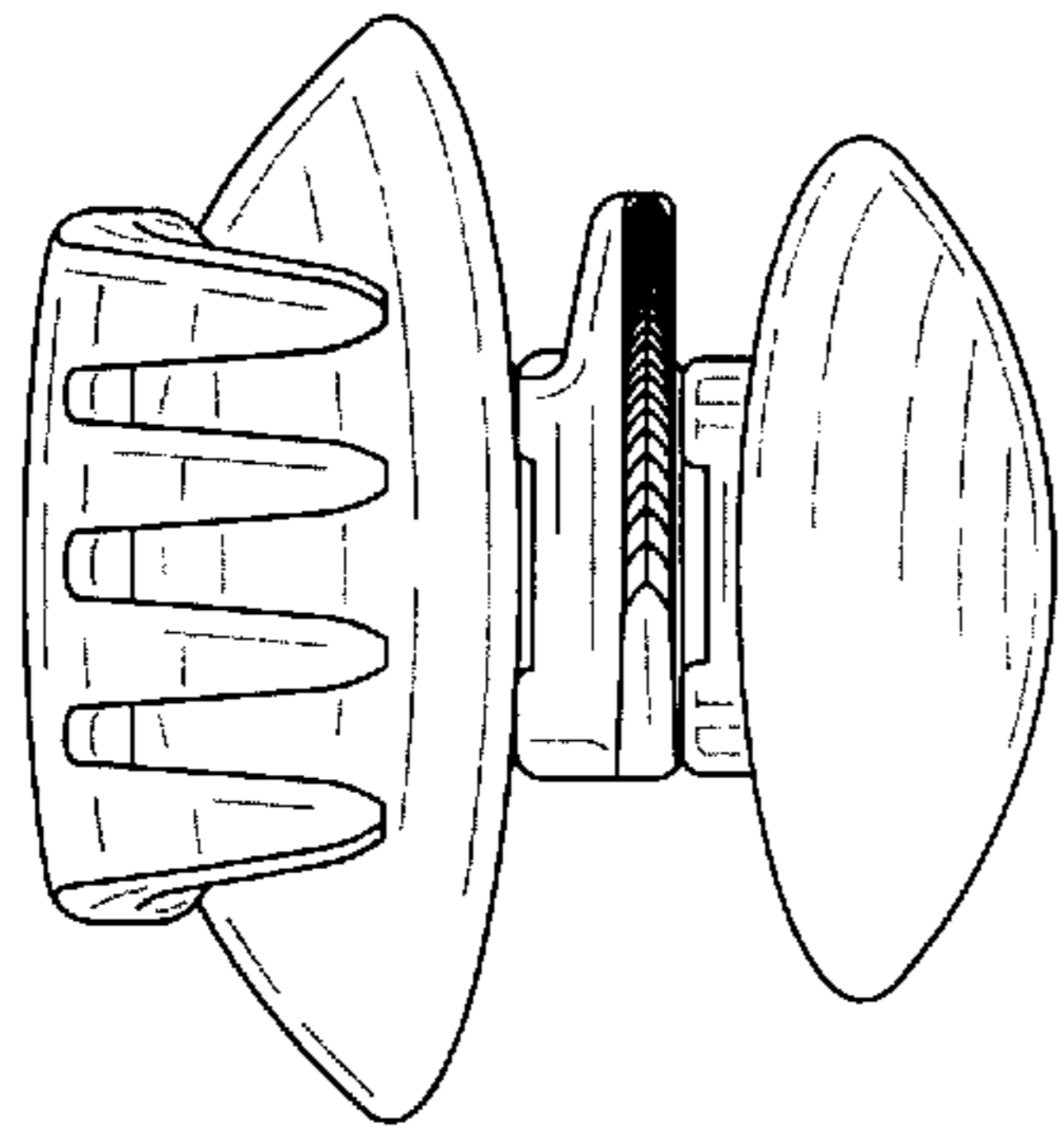

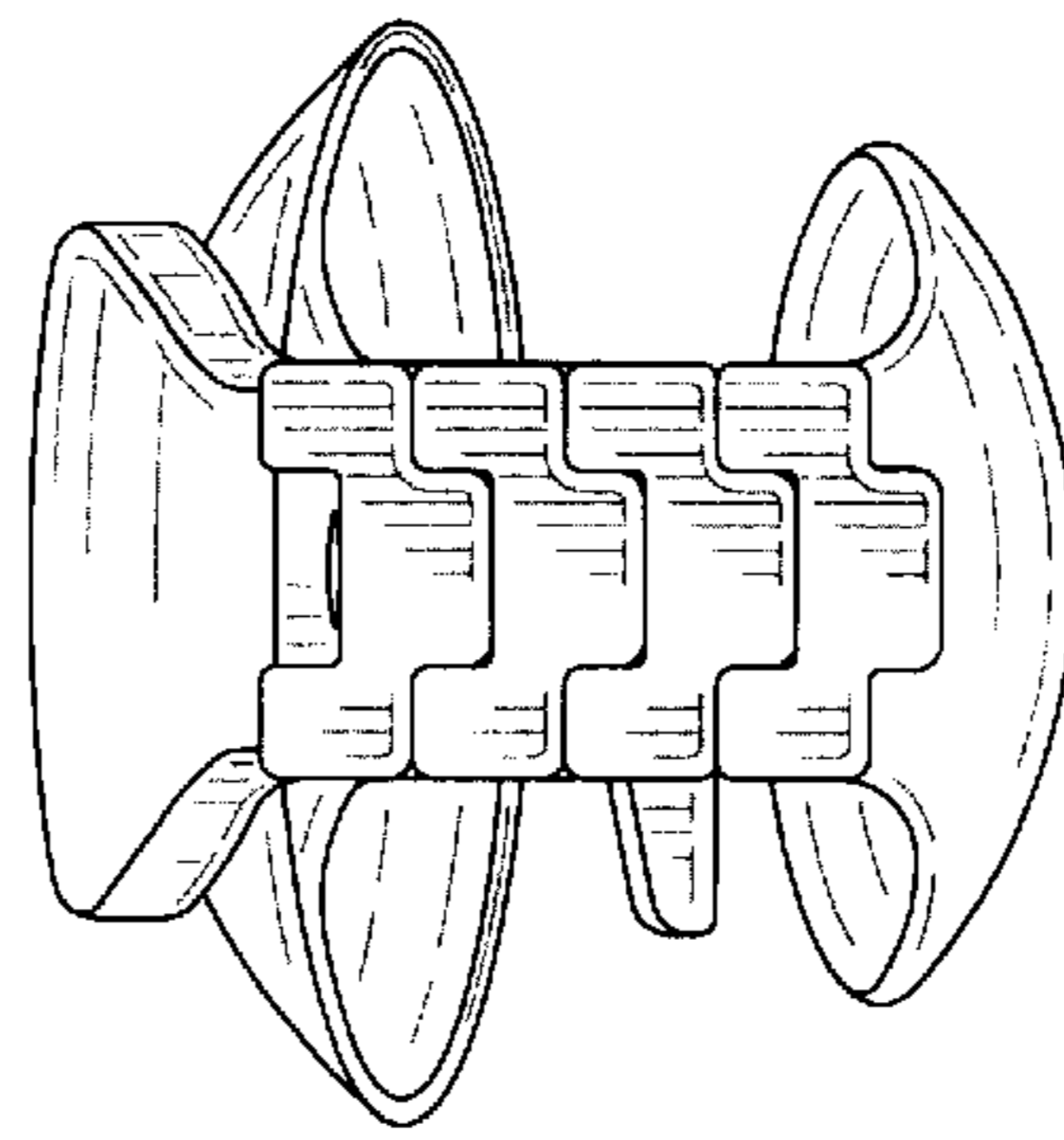

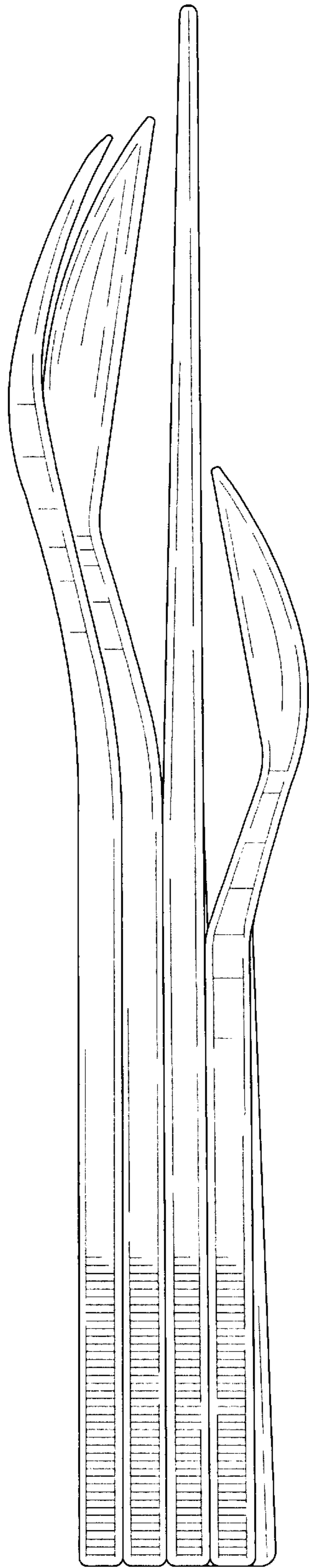

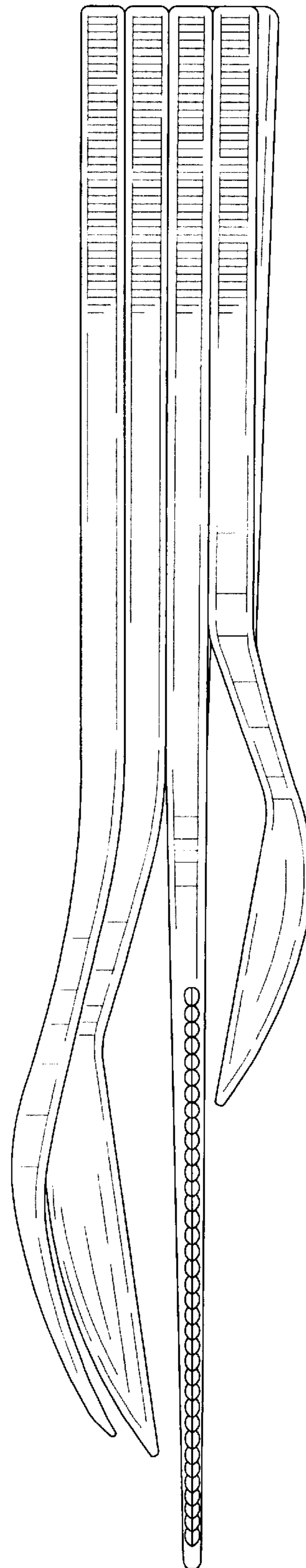

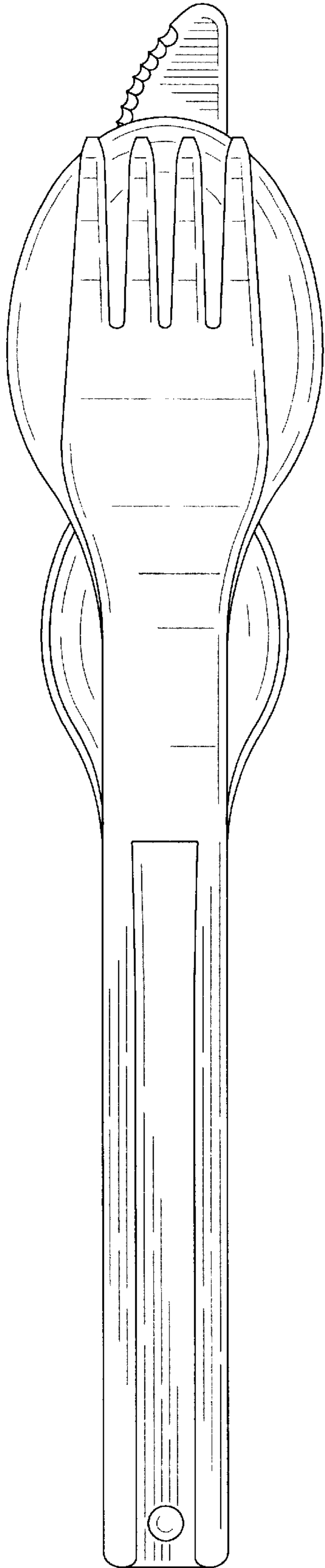

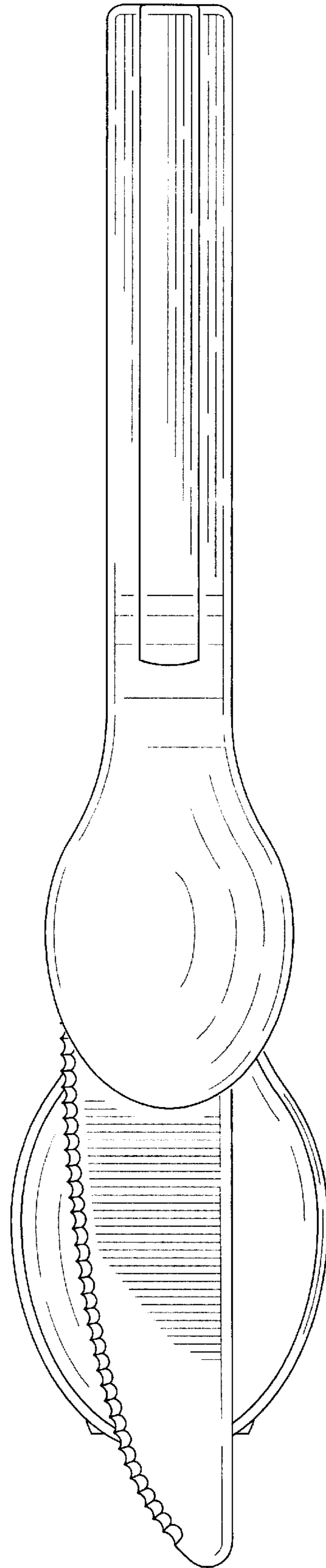

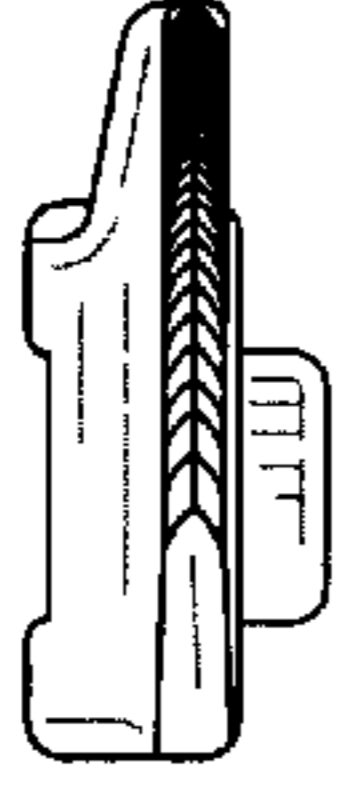

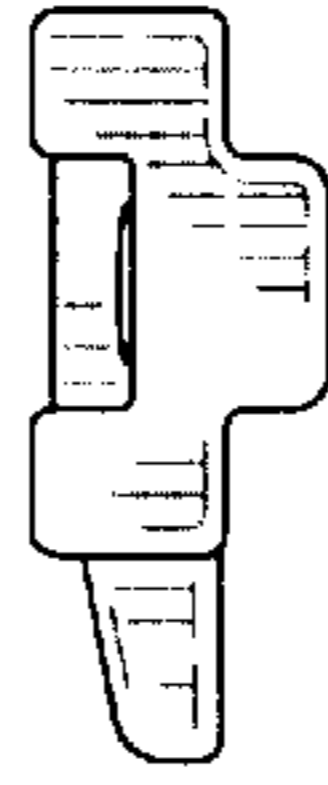

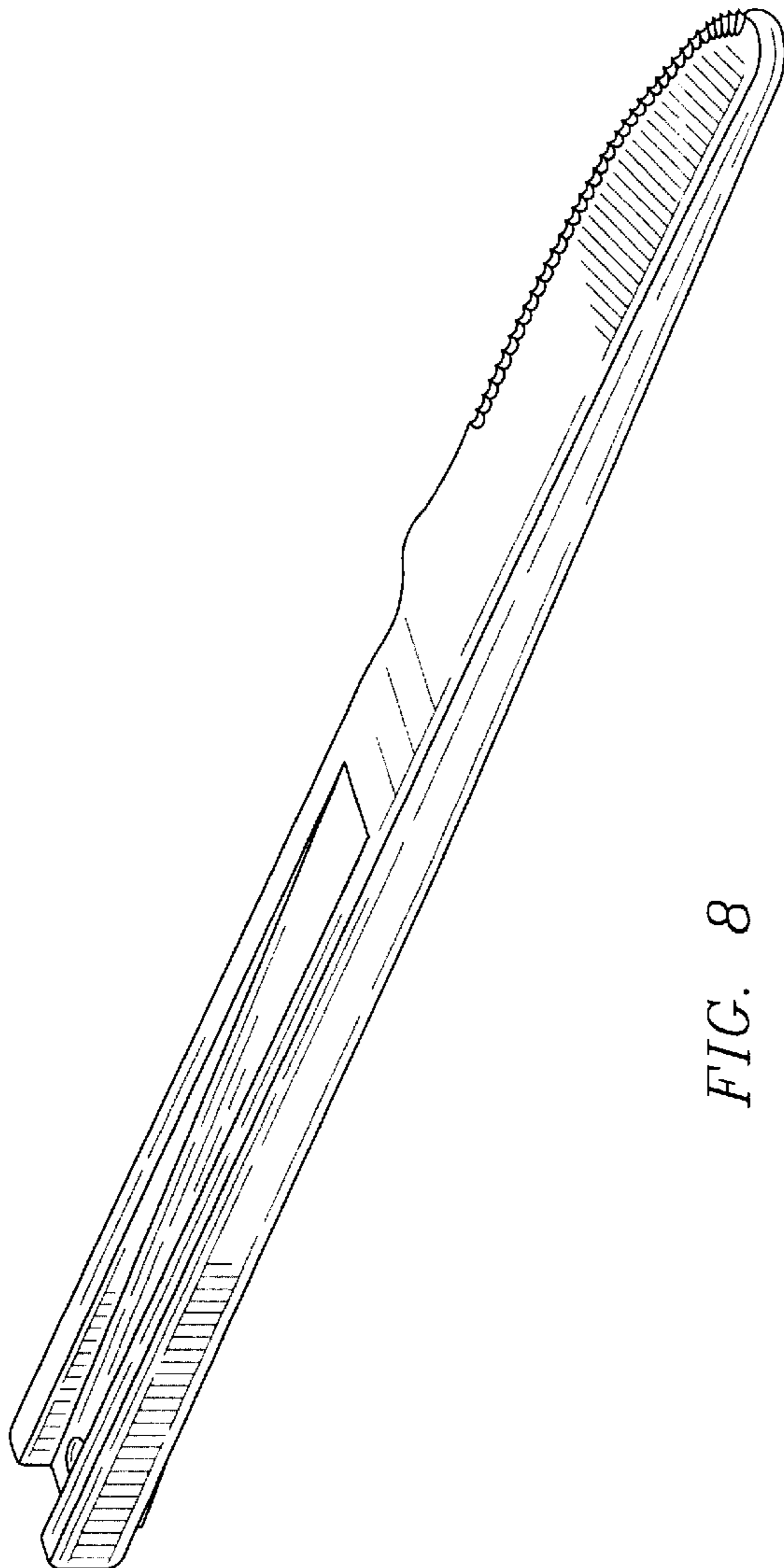

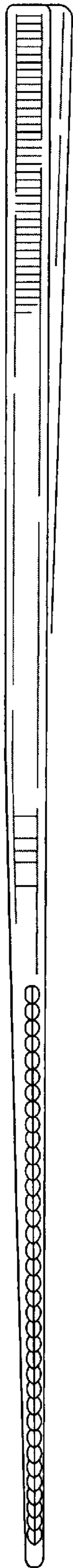

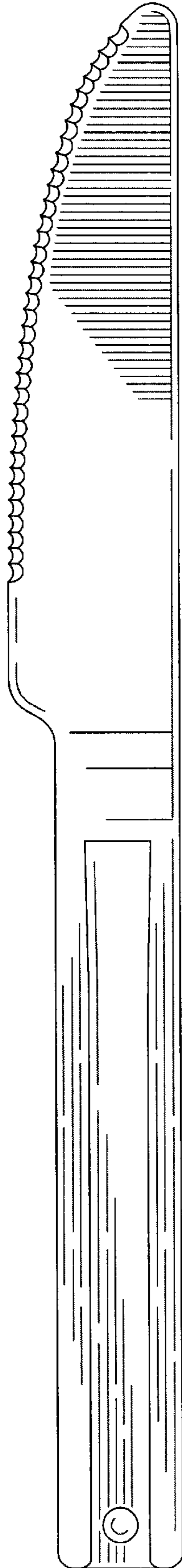

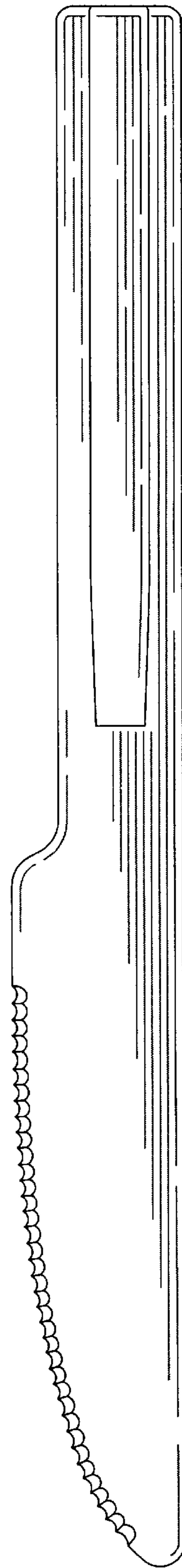

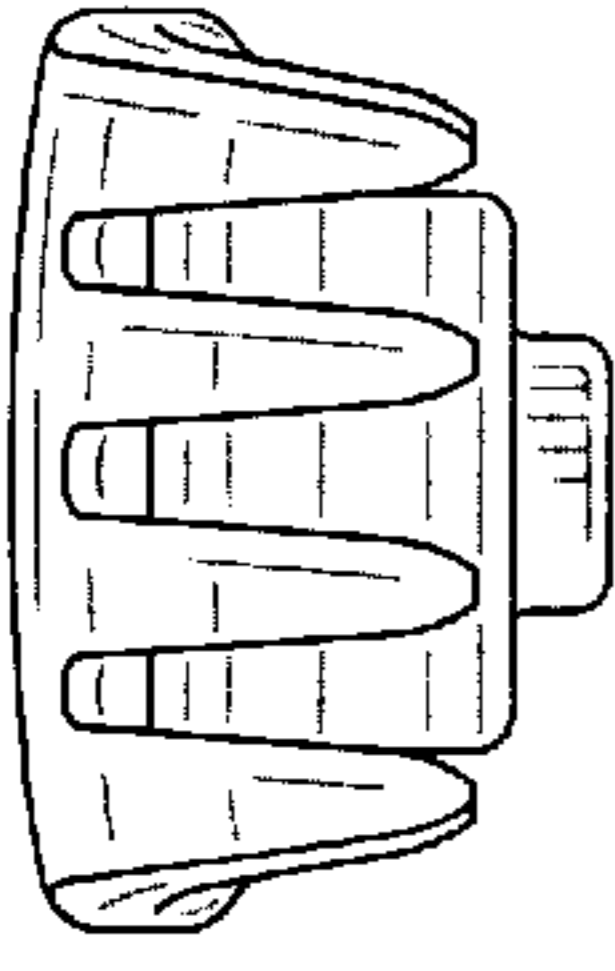

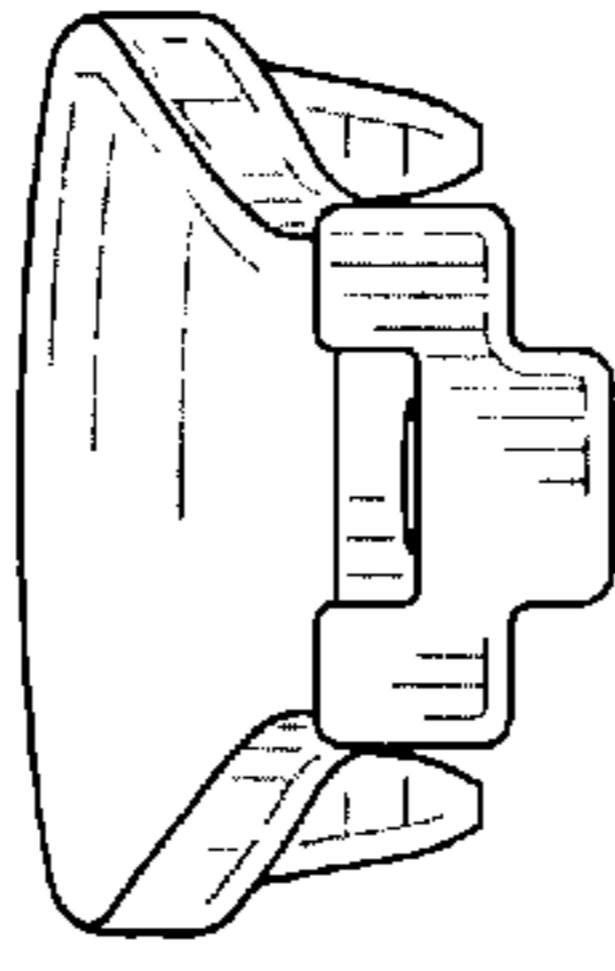

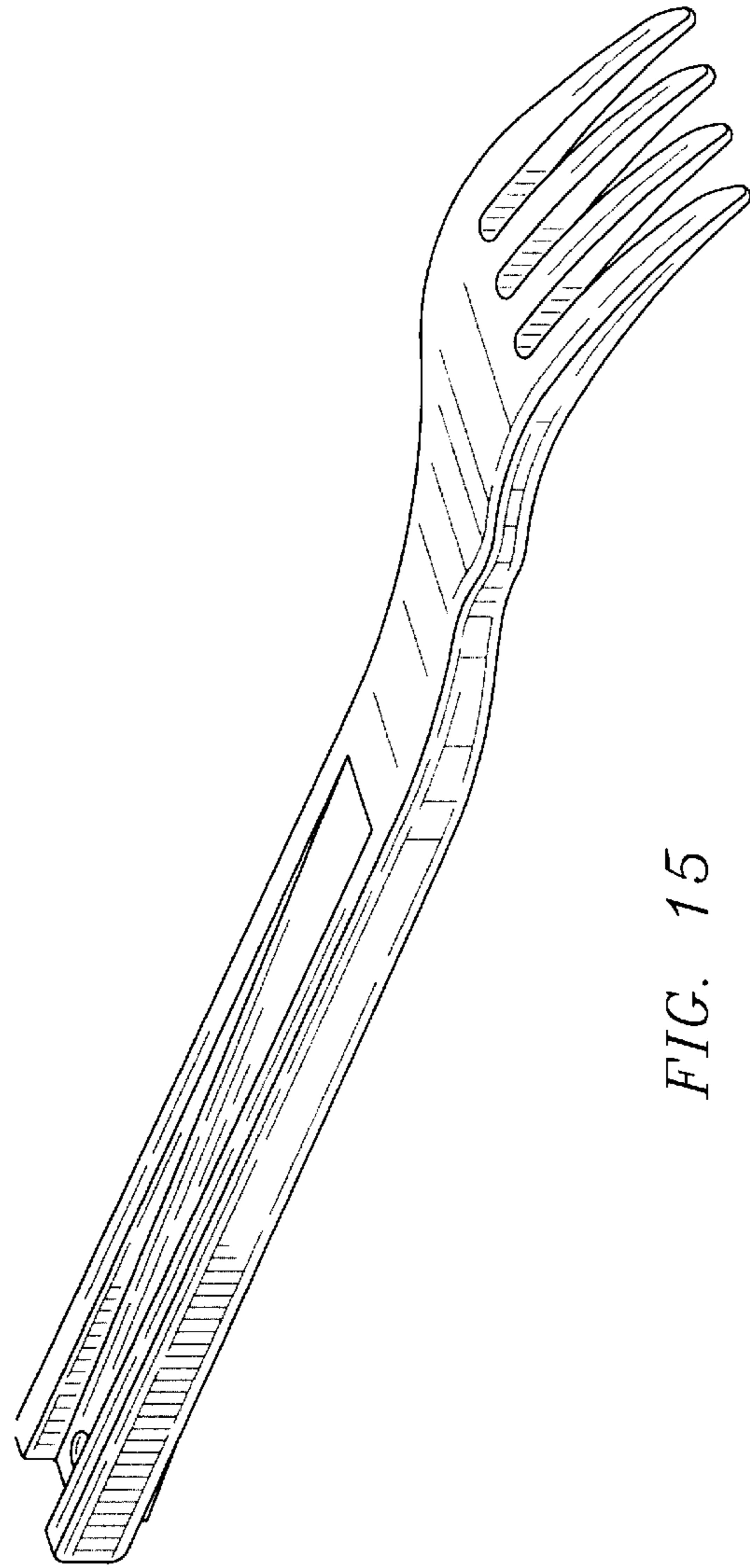

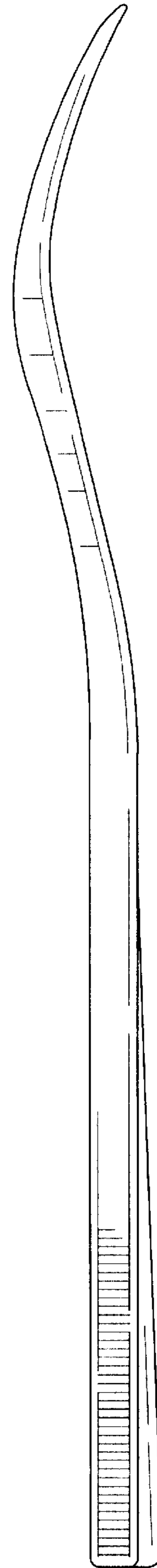

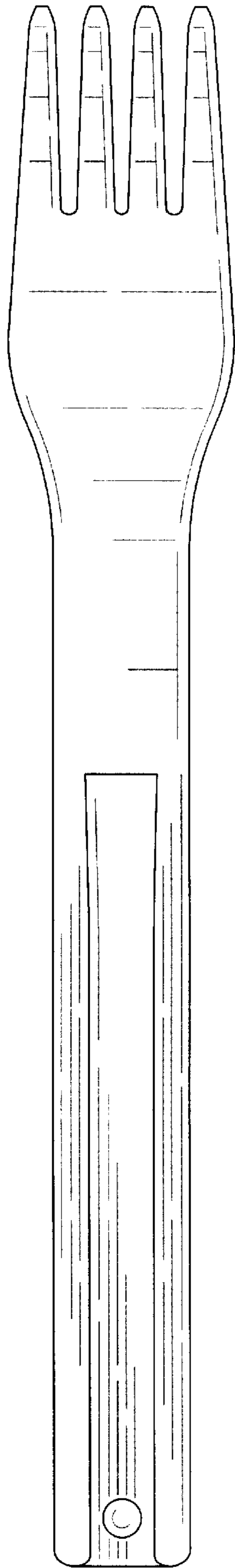

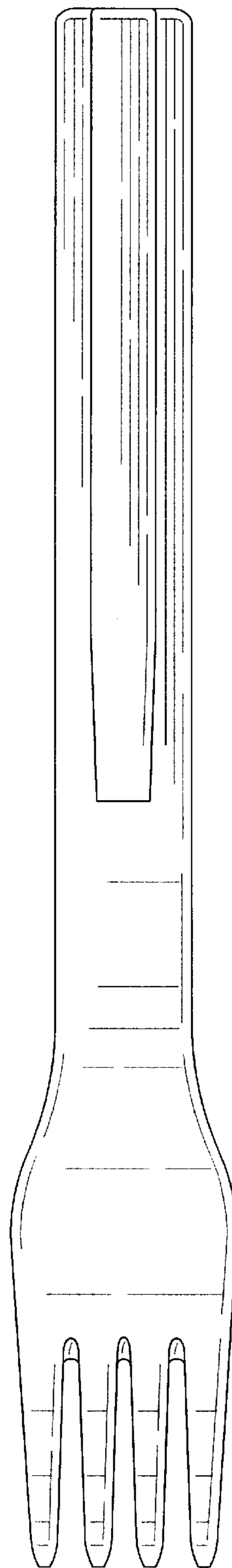

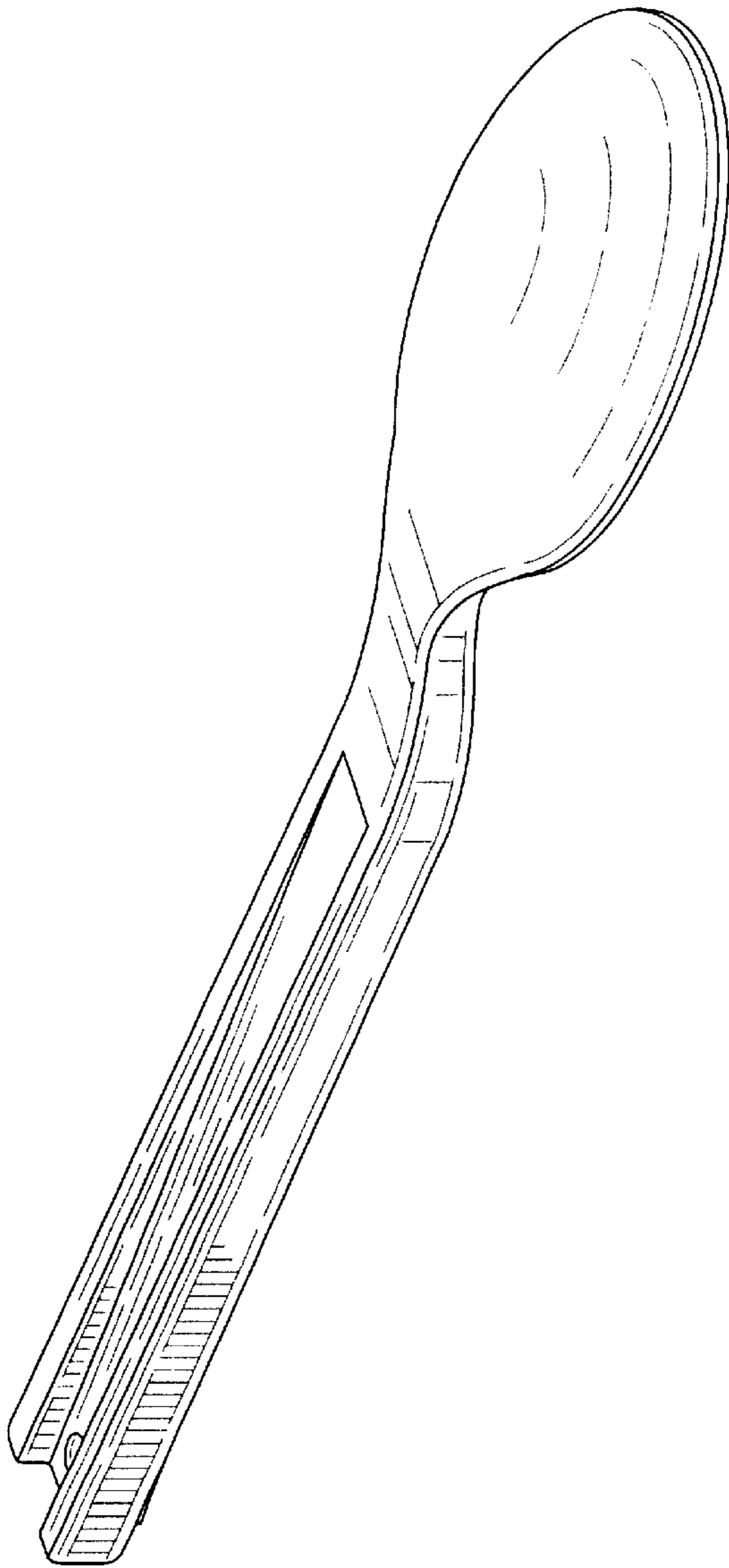

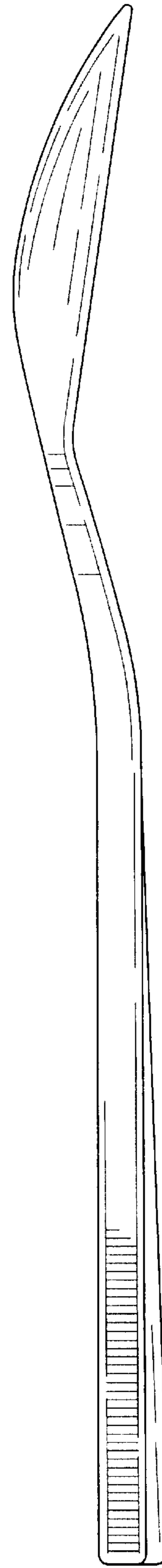

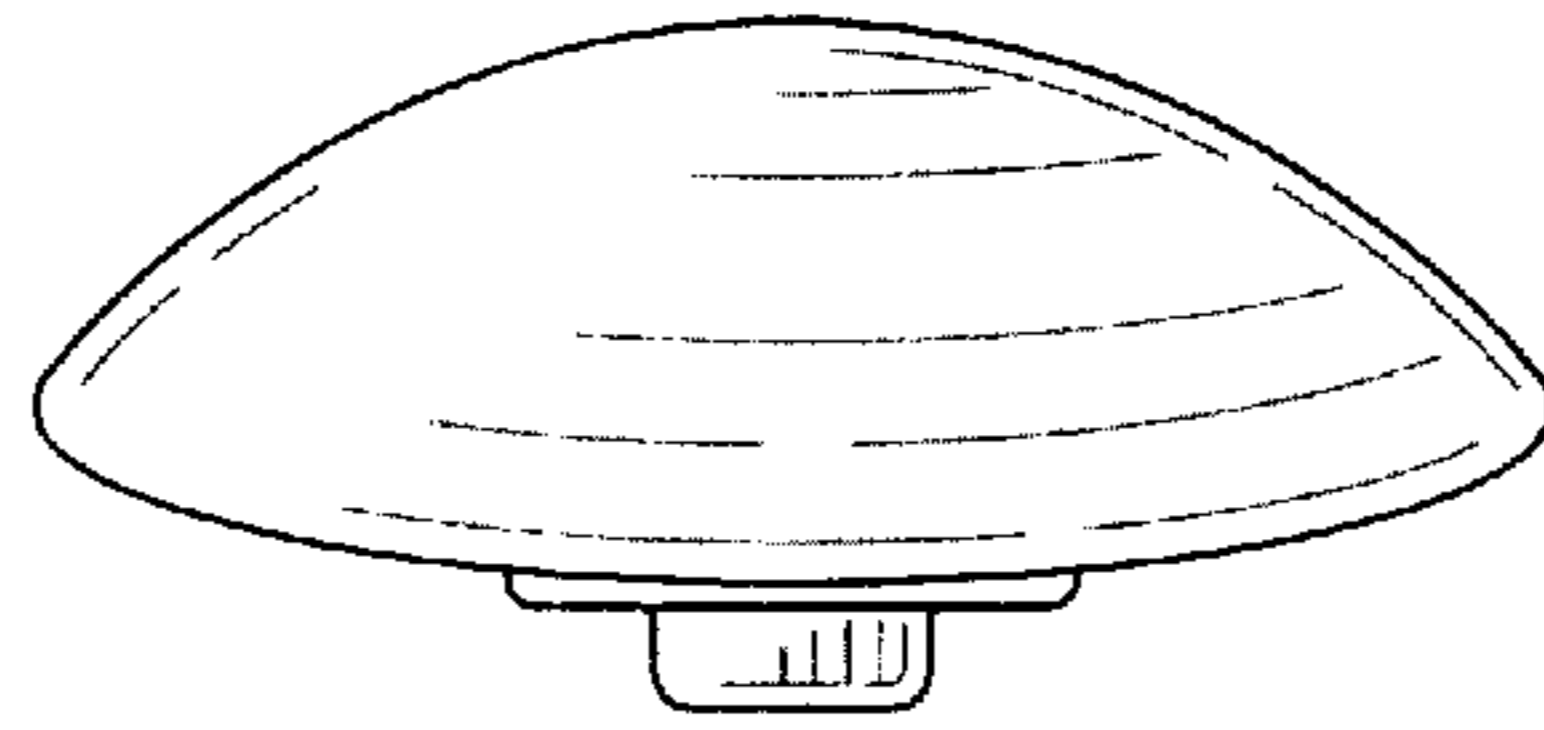

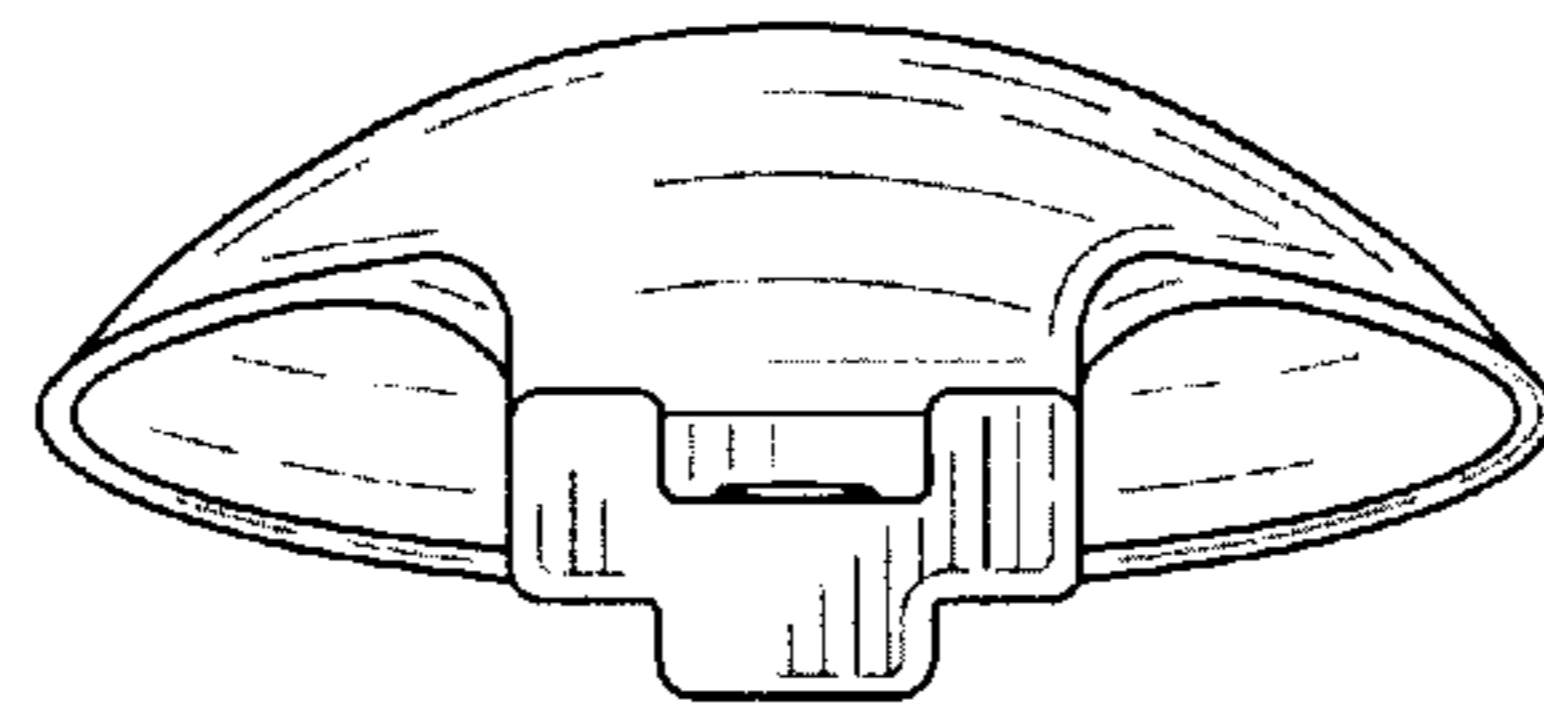

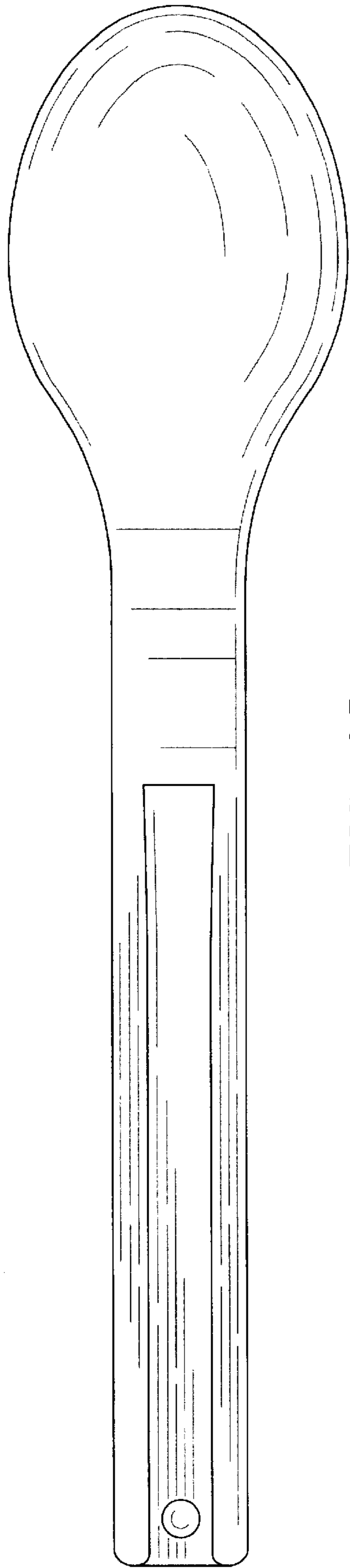

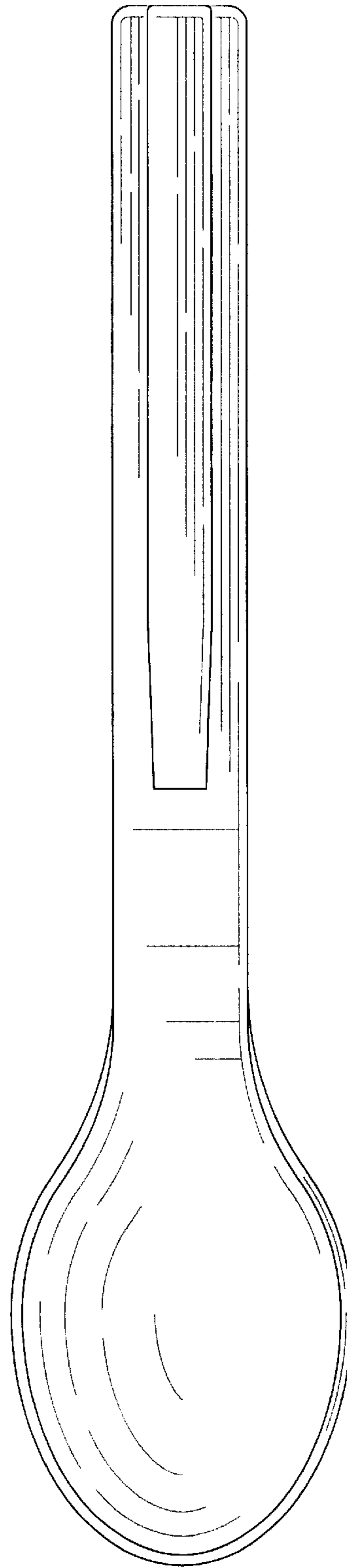

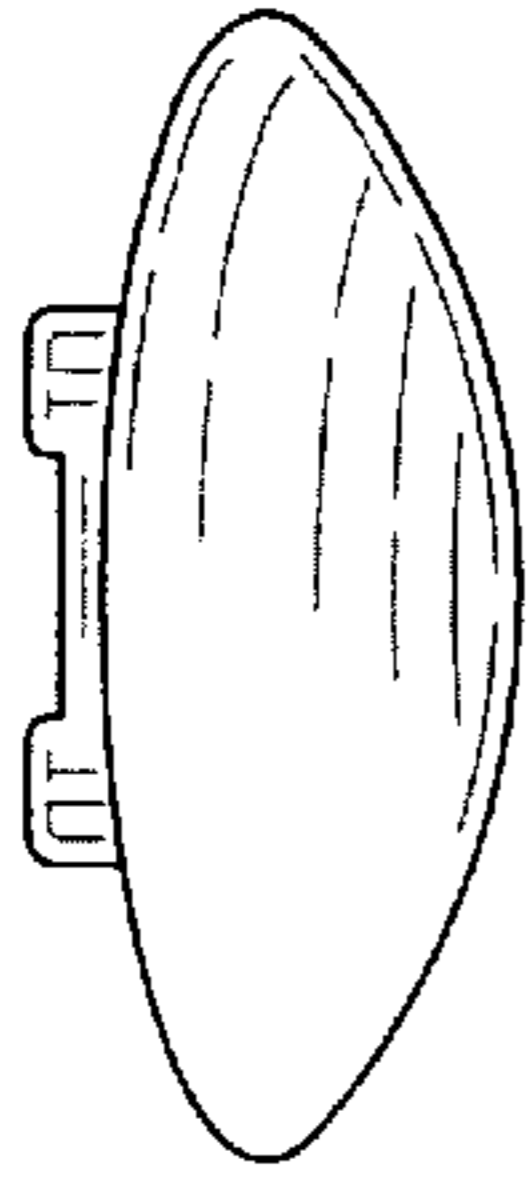

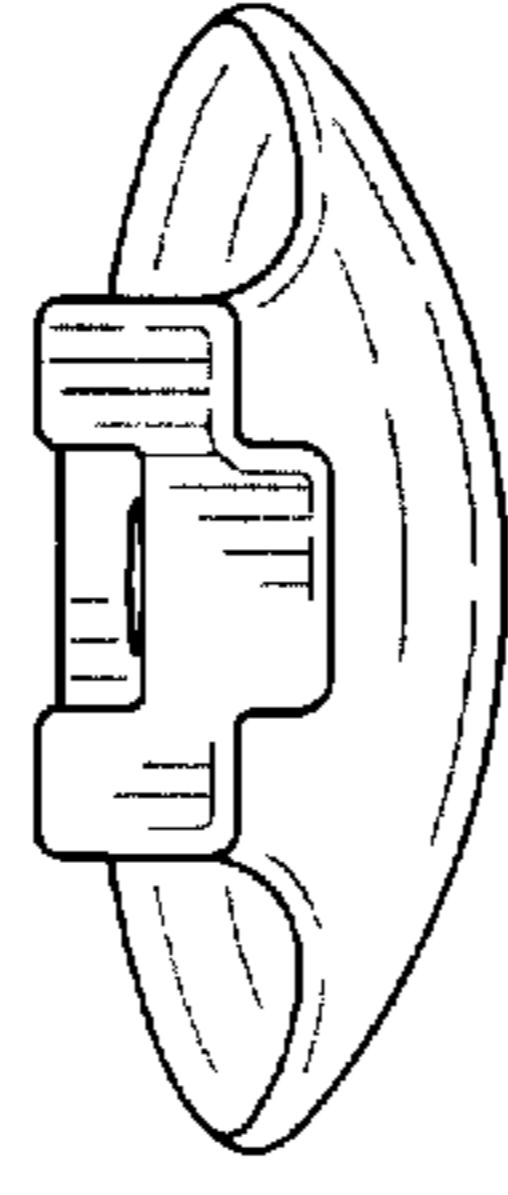

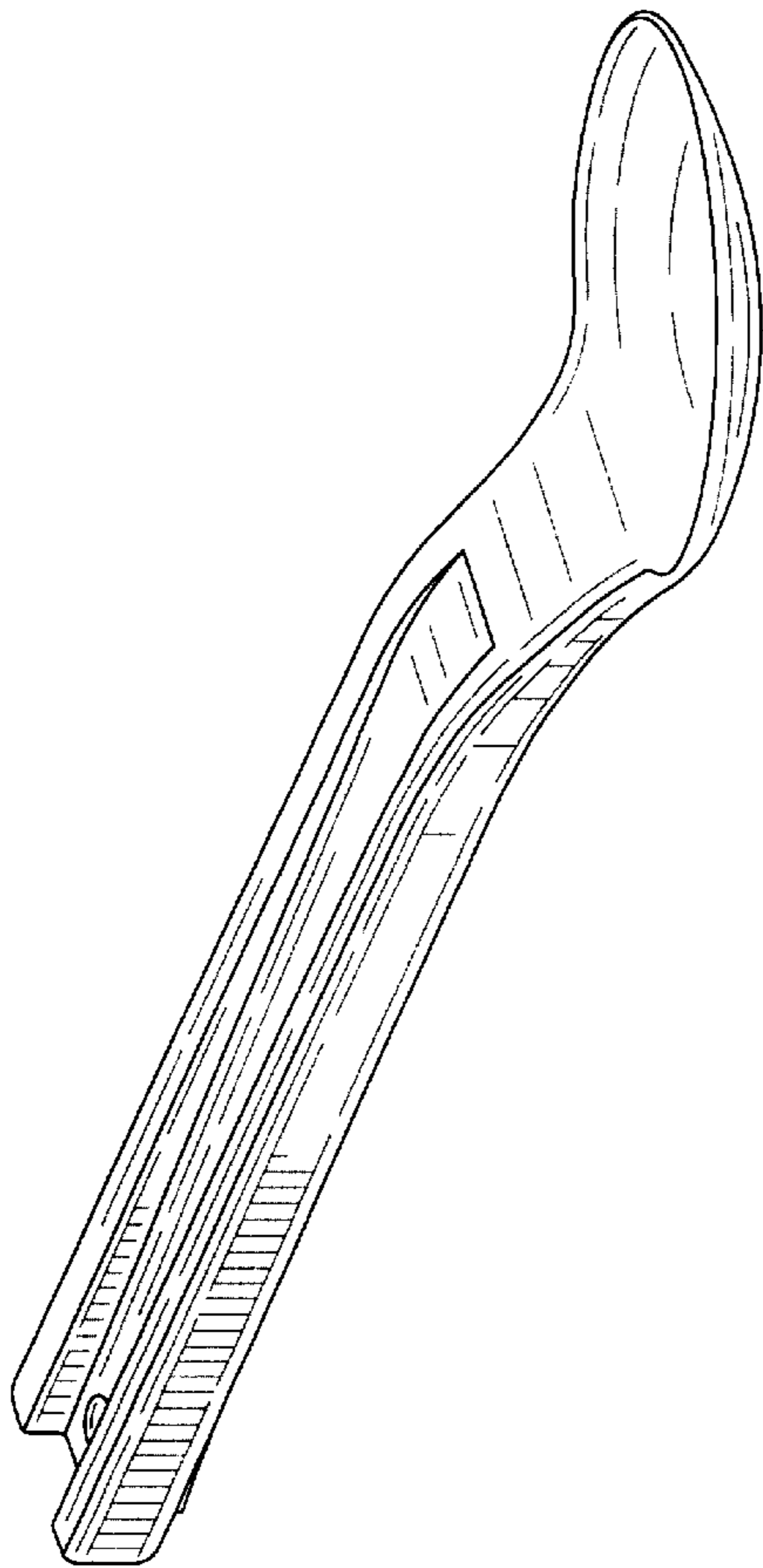

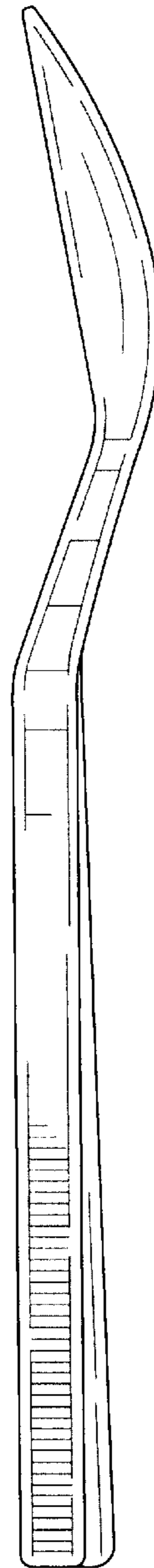

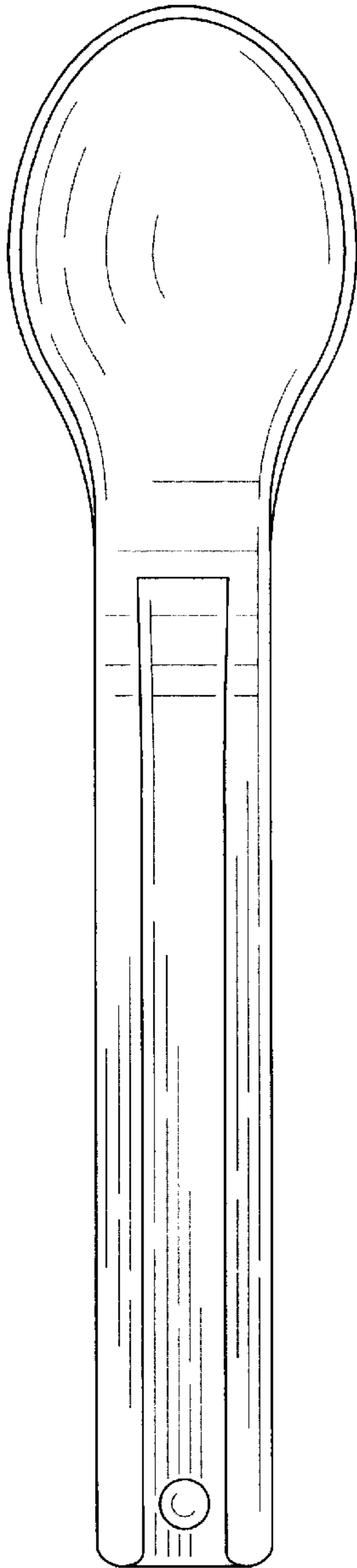

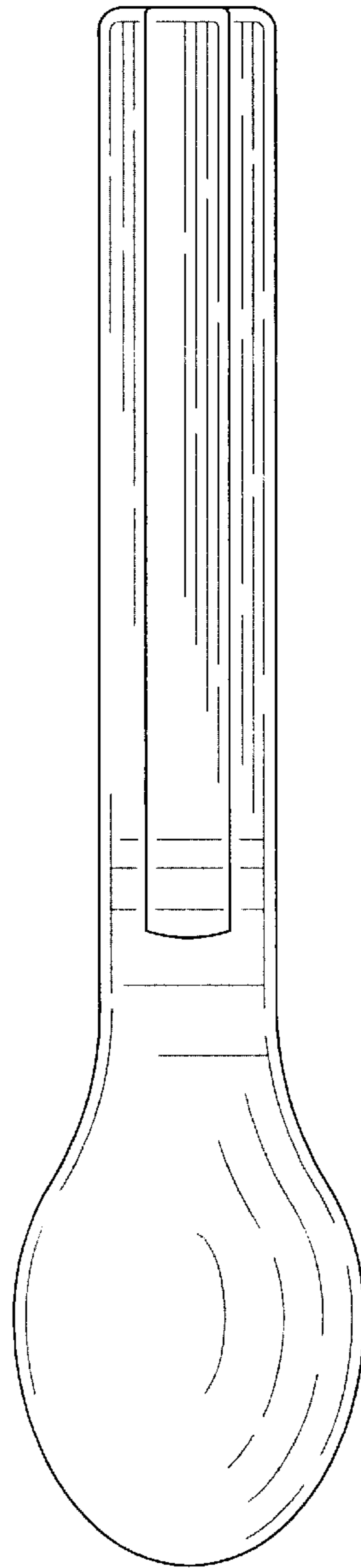
