CLAIM (57)

I claim the ornamental design for a screw for jewelry components, as shown and described.

DESCRIPTION

Another design patent application also filed on Mar. 6, 2006, entitled: "Combined Jewelry Component and Cap".

FIG. 1 is an exploded perspective view of the screw, according to the present invention;


FIG. 2 is the front view of the screw, right, left and rear view is identical to the front view;

FIG. 3 is the top view of the screw; and,

FIG. 4 is the bottom view of the screw.

The ornamental design of the present invention as shown in FIGS. 1–4 is a metal screw, consisting of a flat round head with an insert hole, and a barrel style shank.








