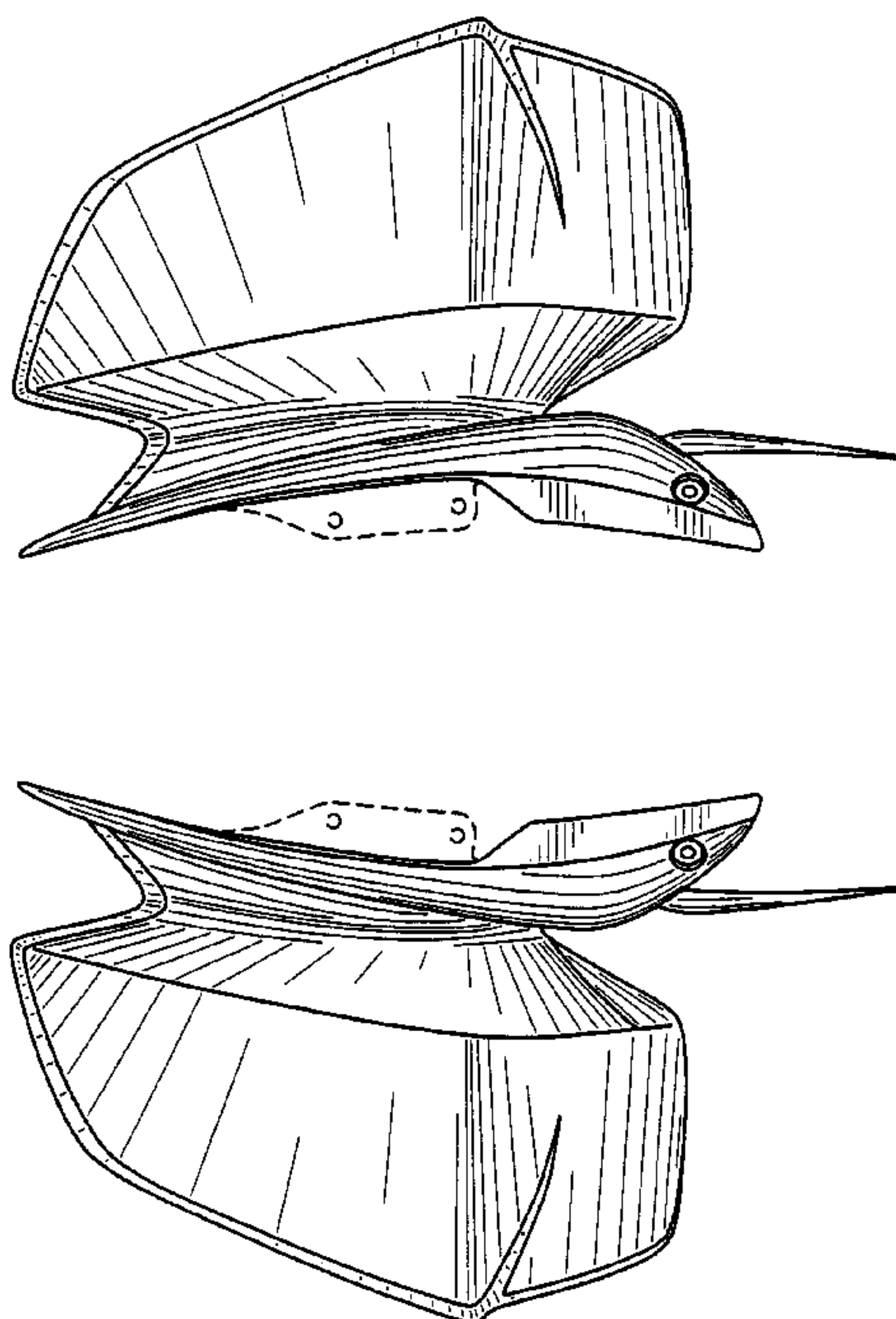
(57) **CLAIM**

The ornamental design for a pair of front fenders, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a pair of front fenders; FIG. 2 is a left side elevational view of the left front fender of the pair of front fenders of FIG. 1; FIG. 3 is a right side elevational view of the right front fender of the pair of front fenders of FIG. 1; FIG. 4 is a left front perspective view of the pair of front fenders of FIG. 1 provided upon an exemplary four wheeled vehicle; FIG. 5 is a left rear perspective view of the pair of front fenders of FIG. 1 provided upon the exemplary four wheeled vehicle; FIG. 6 is a rear perspective view of the pair of front fenders of FIG. 1 provided upon the exemplary four wheeled vehicle; FIG. 7 is a front perspective view of the pair of front fenders of FIG. 1 provided upon the exemplary four wheeled vehicle; FIG. 8 is a left side perspective view of the left front fender of the pair of front fenders of FIG. 1 provided upon the exemplary four wheeled vehicle; FIG. 9 is a right side perspective view of the right front fender of the pair of front fenders of FIG. 1 provided upon the exemplary four wheeled vehicle; and, FIG. 10 is a top perspective view of the pair of front fenders of FIG. 1 provided upon the exemplary four wheeled vehicle.

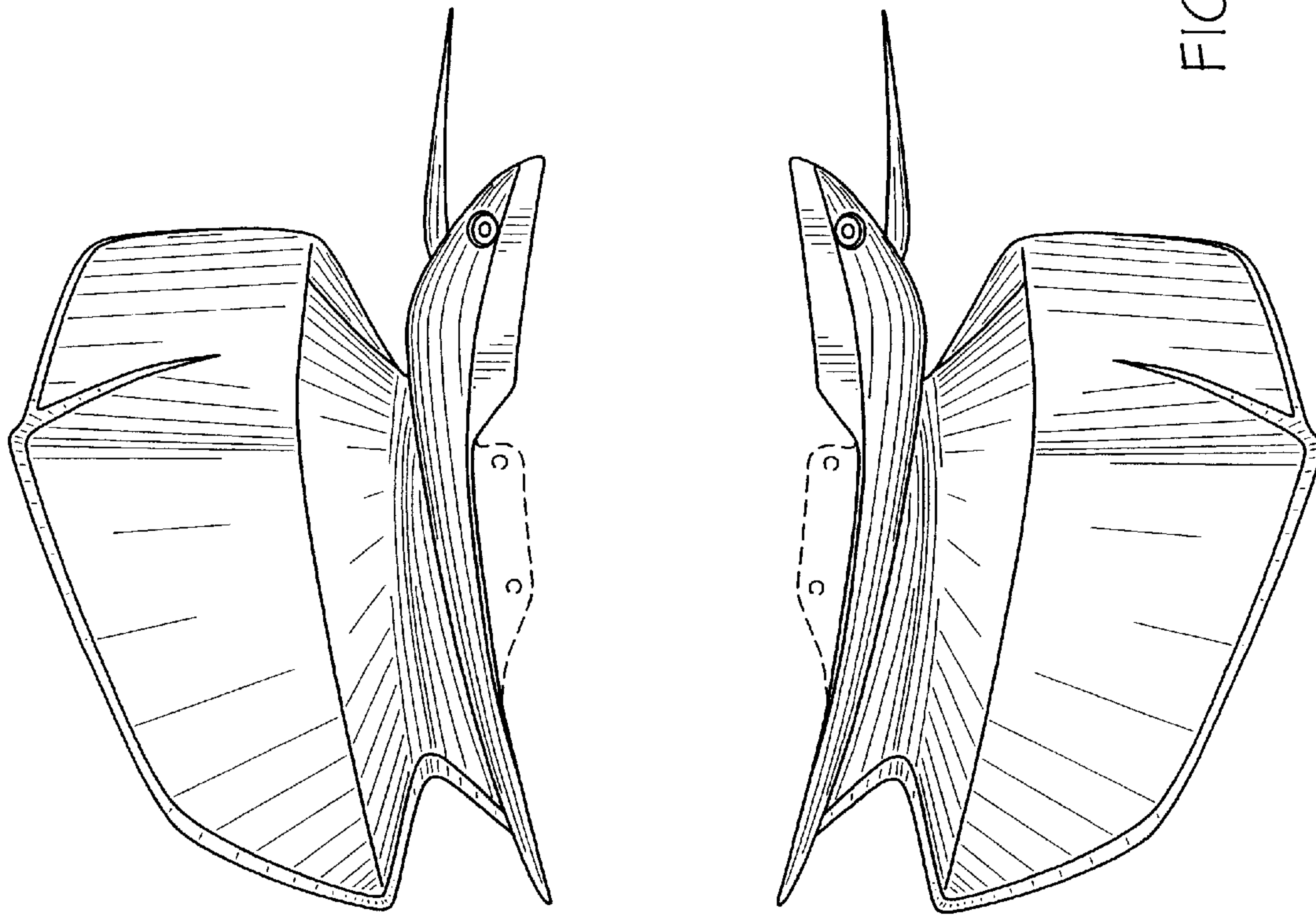

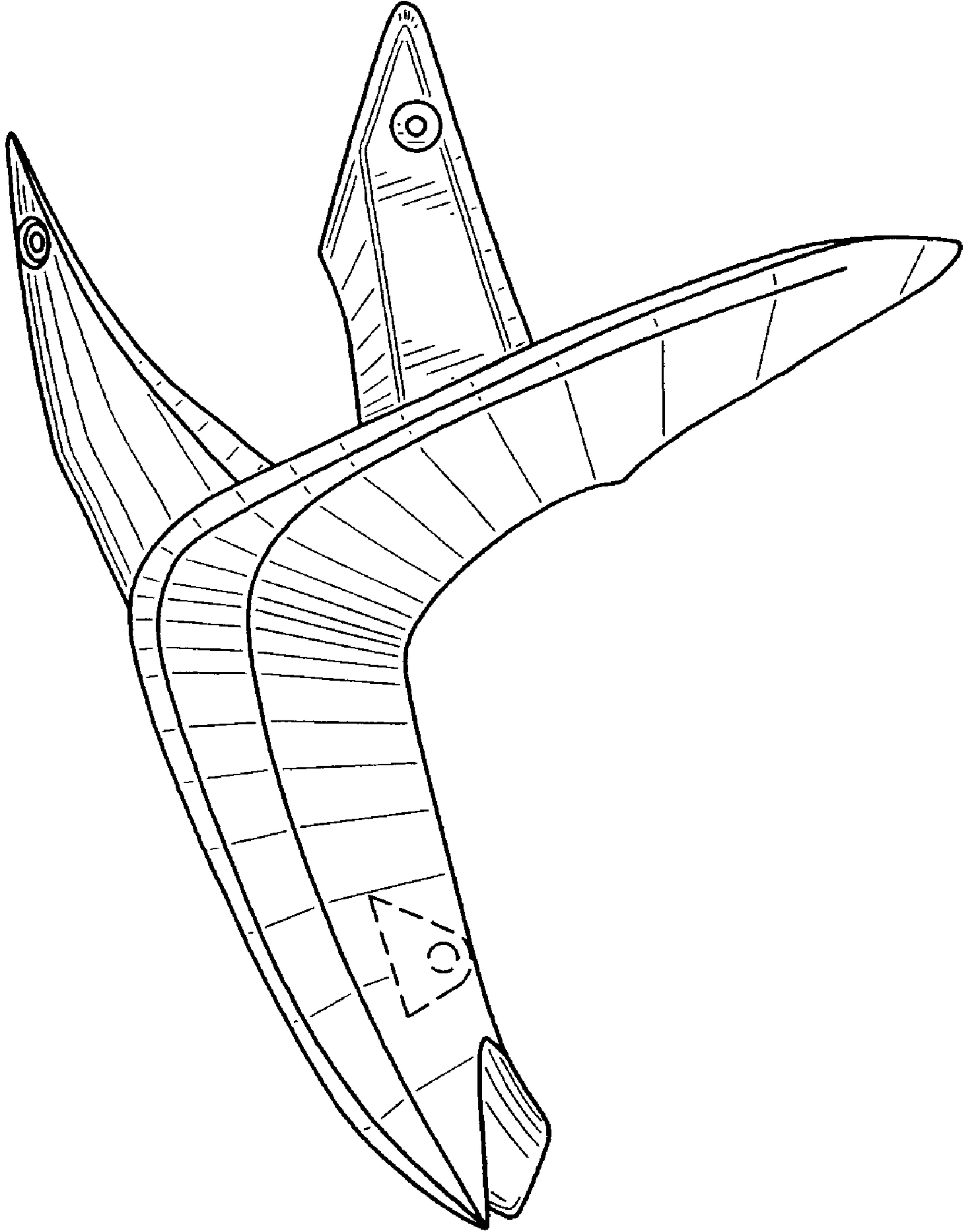

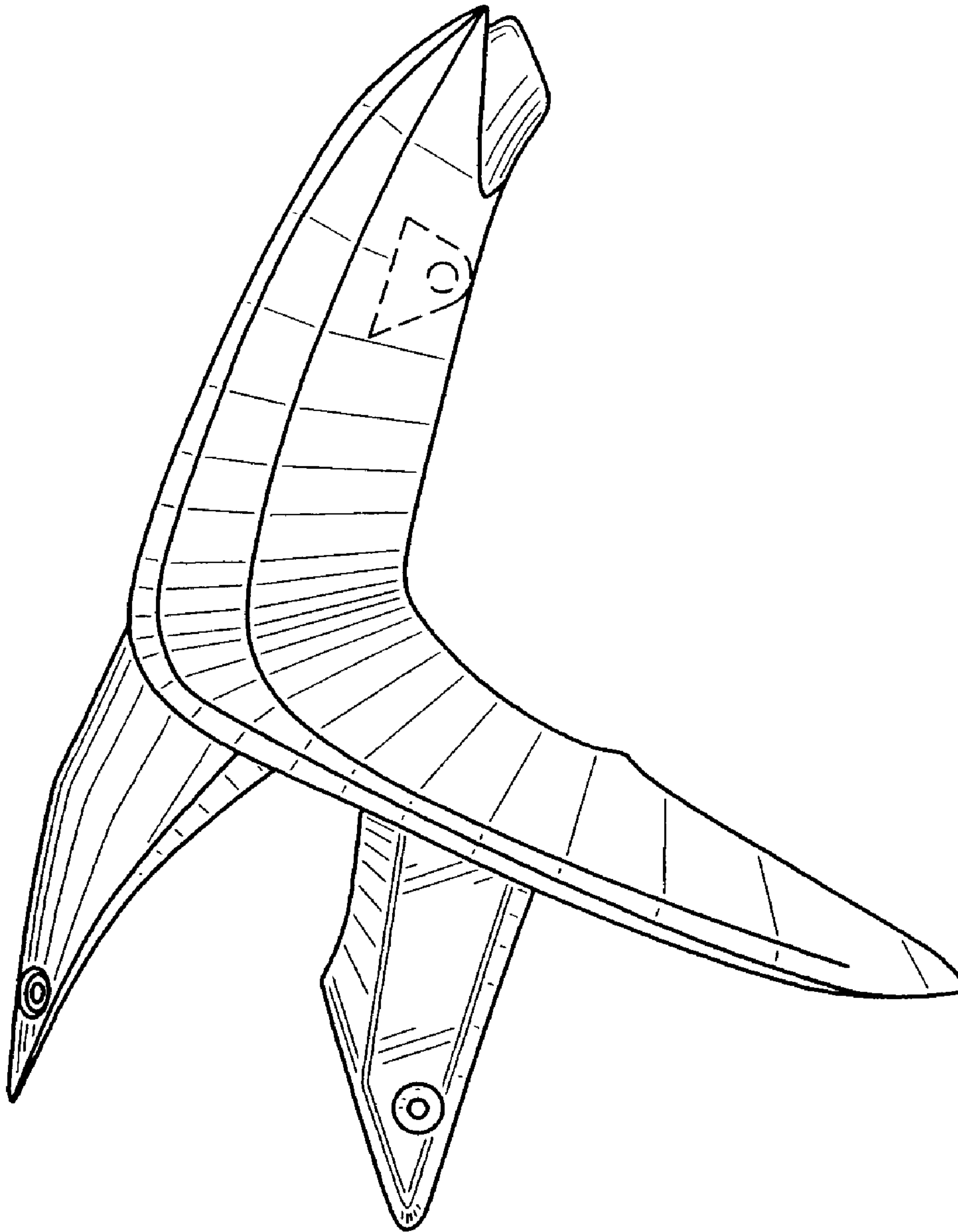

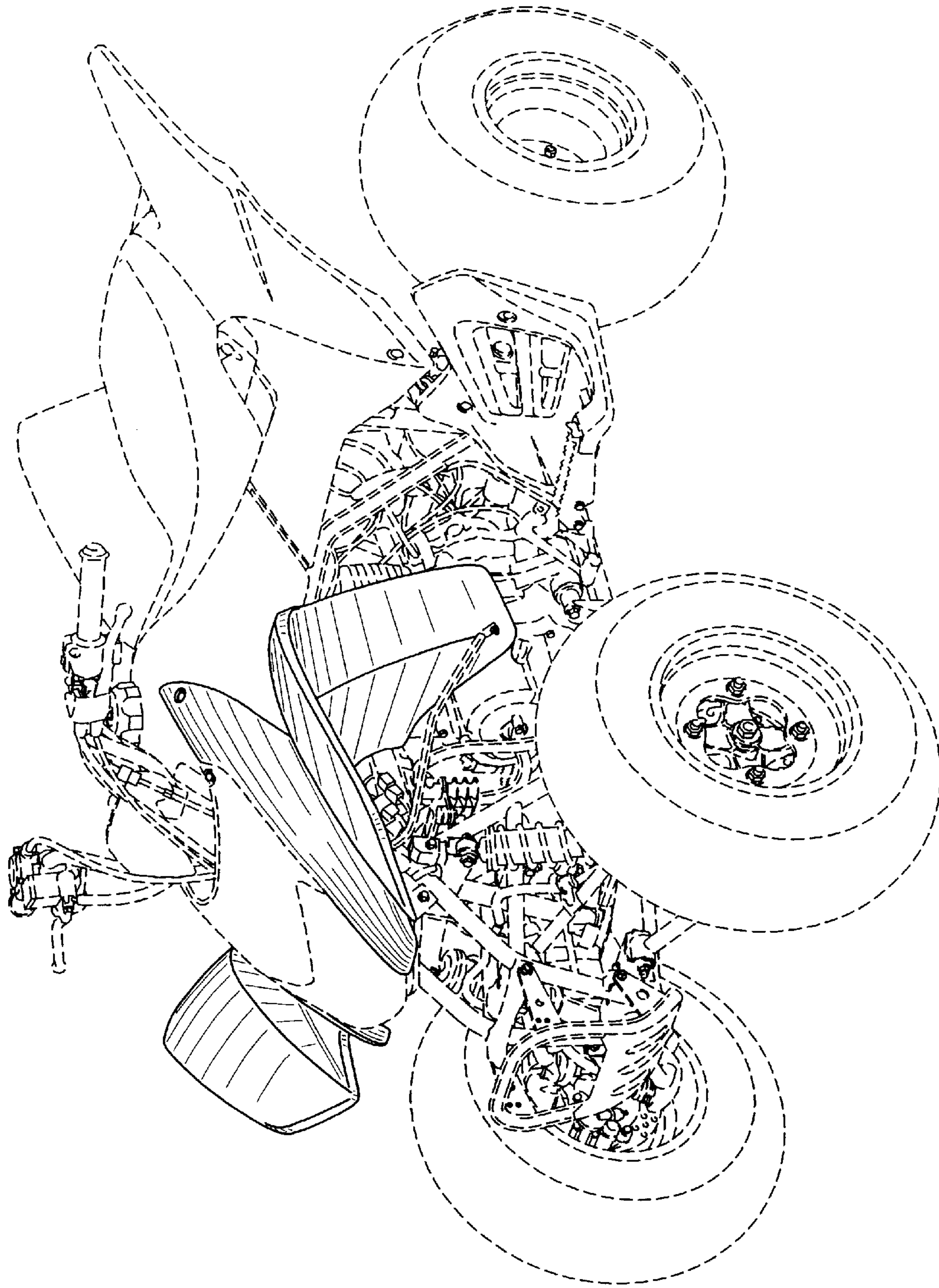

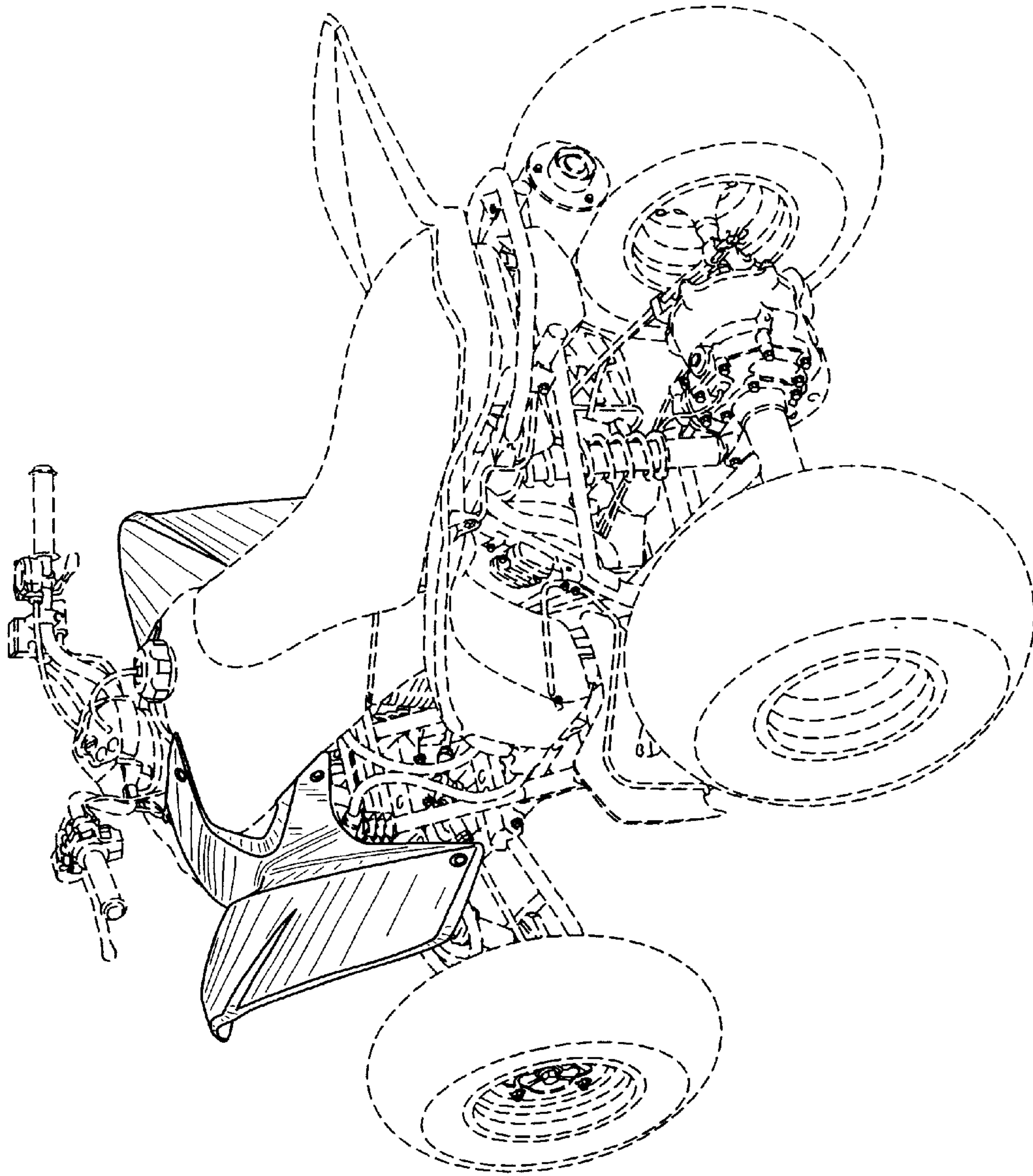

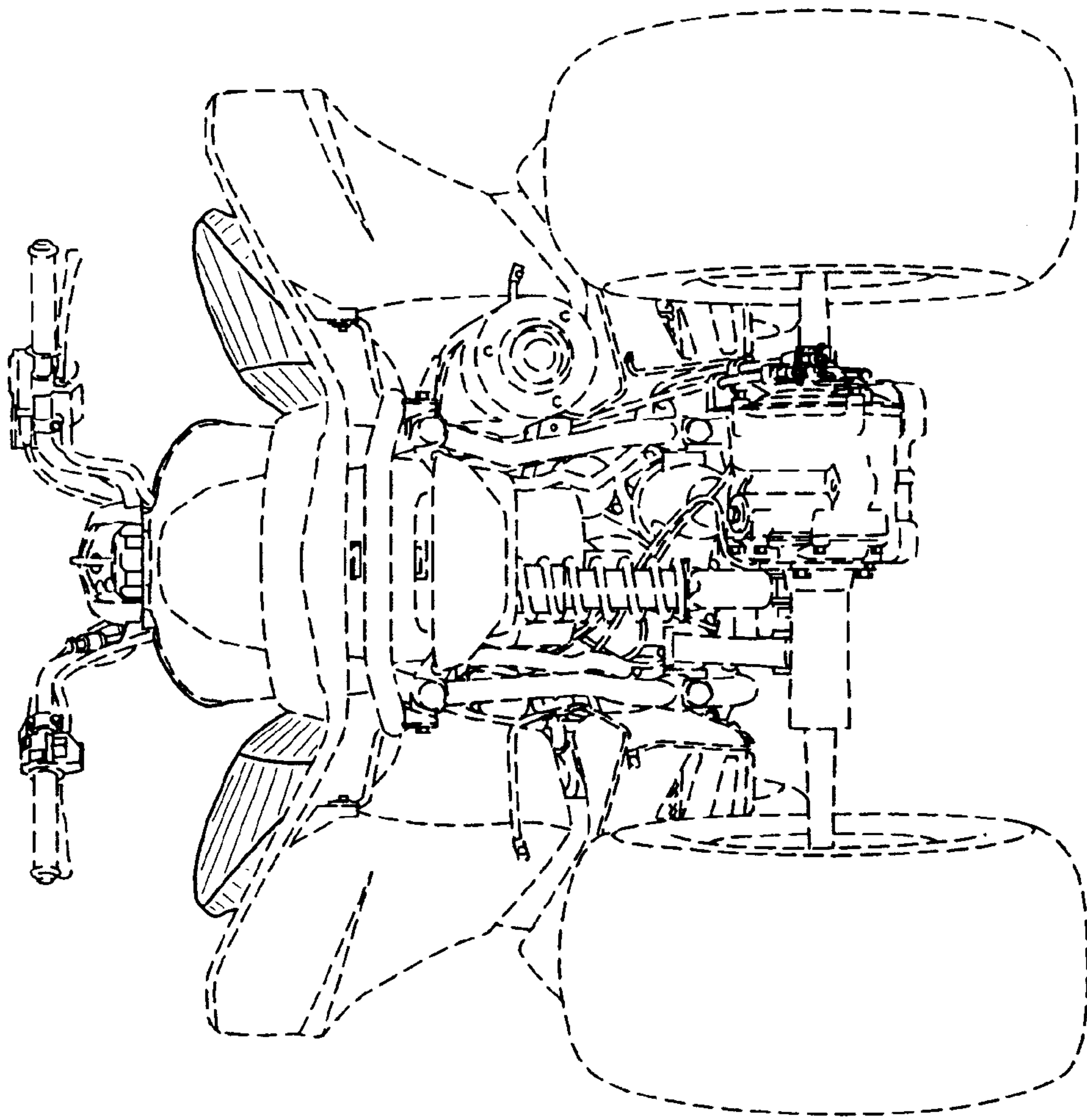

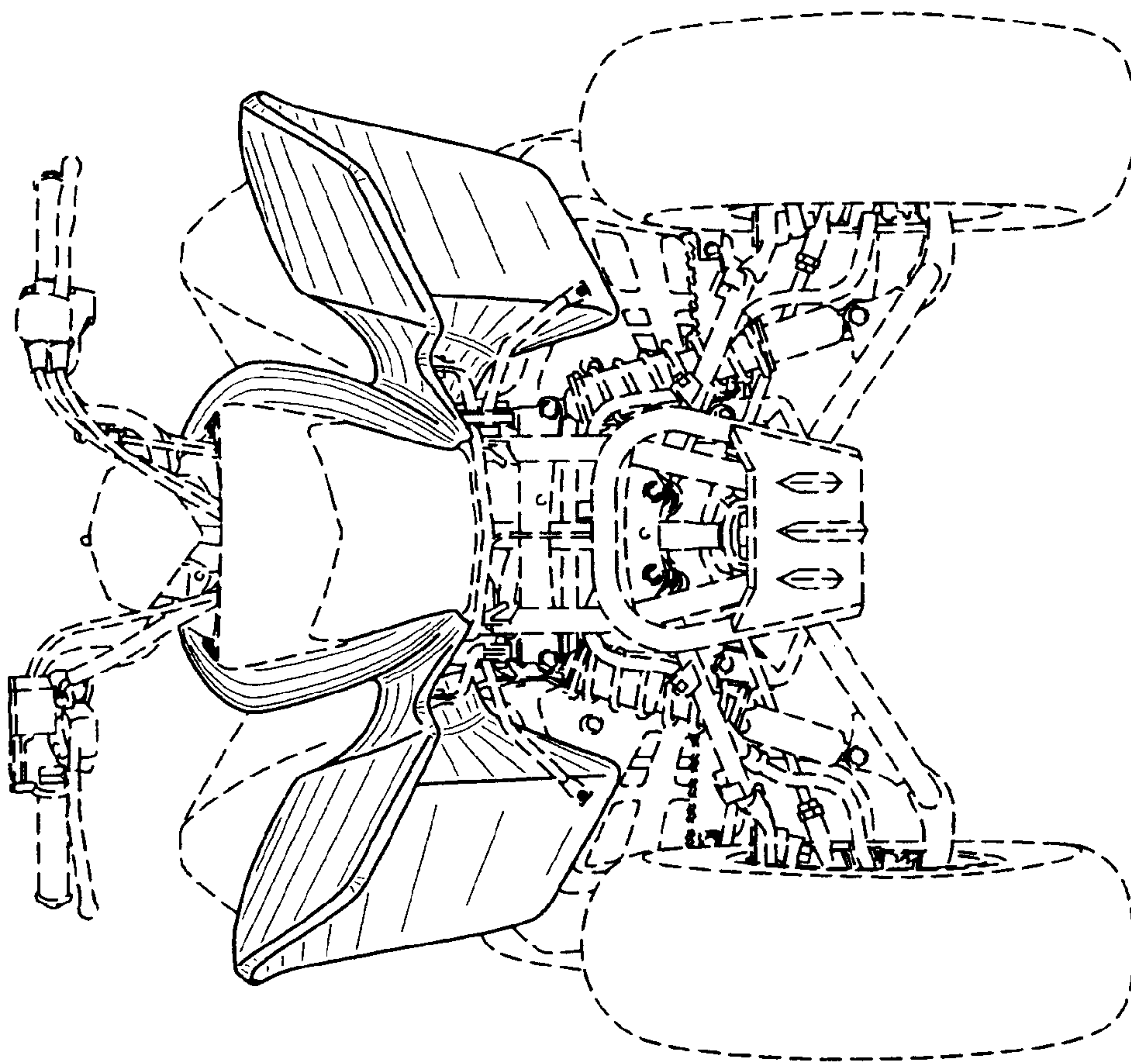

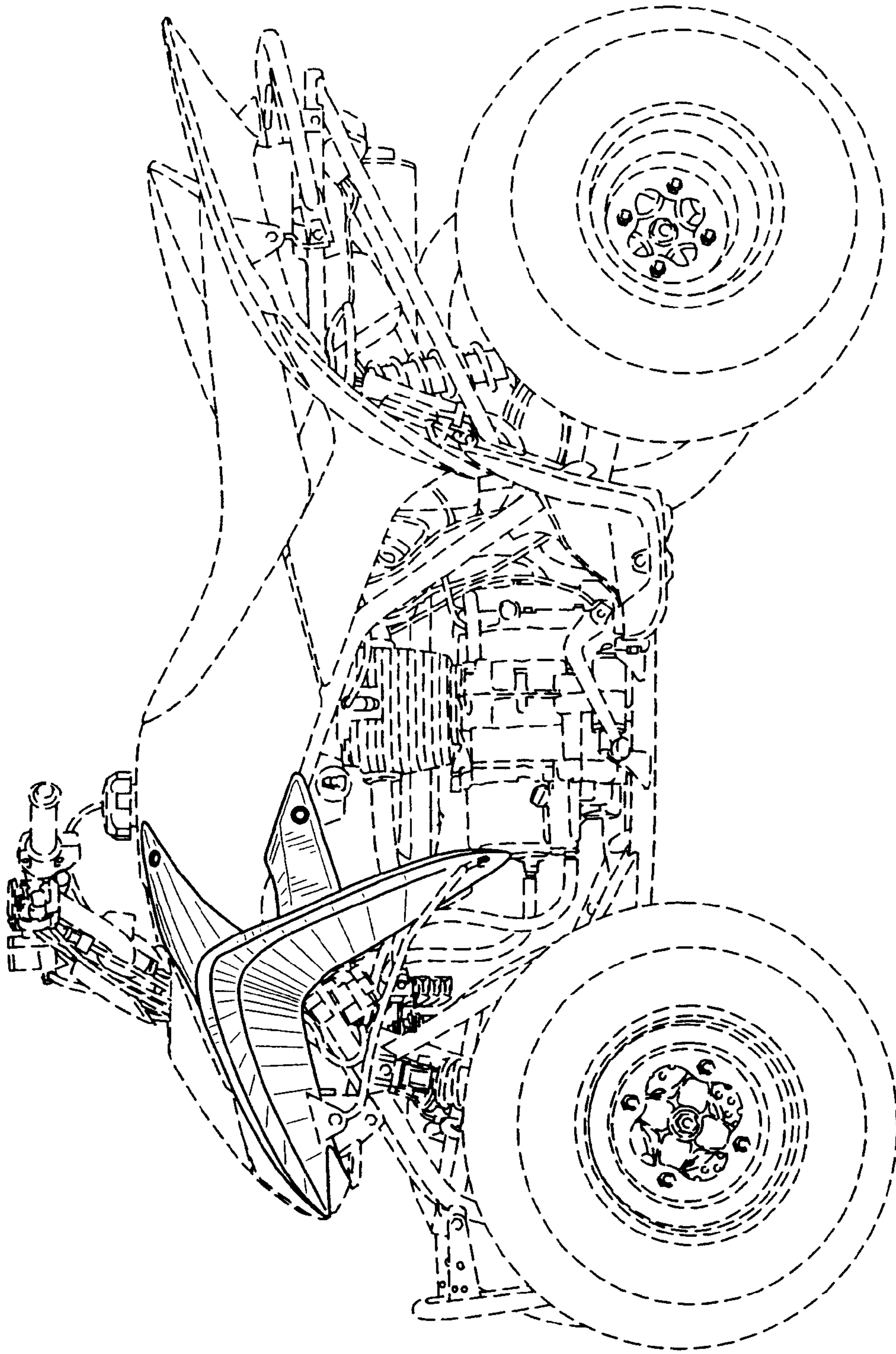

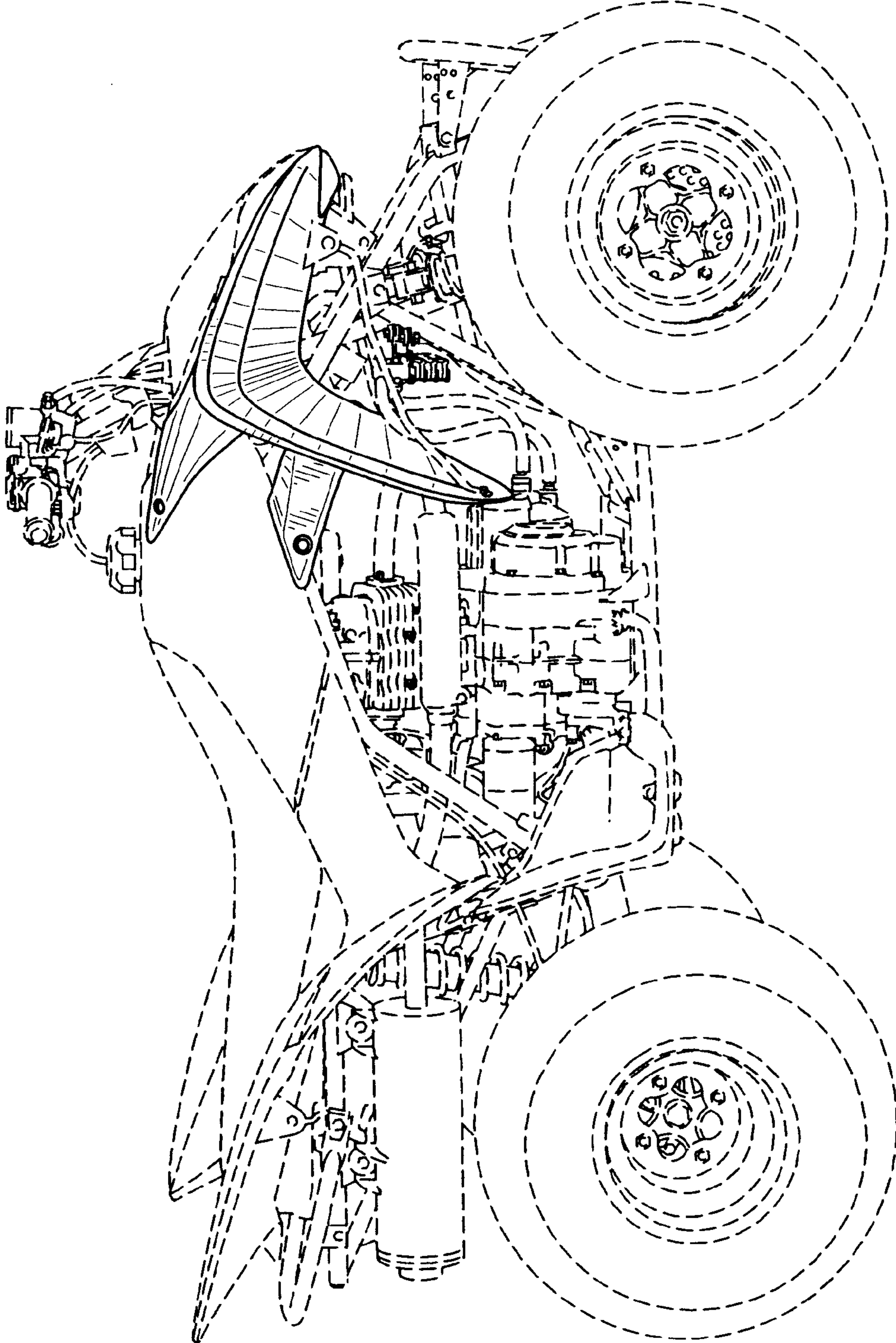

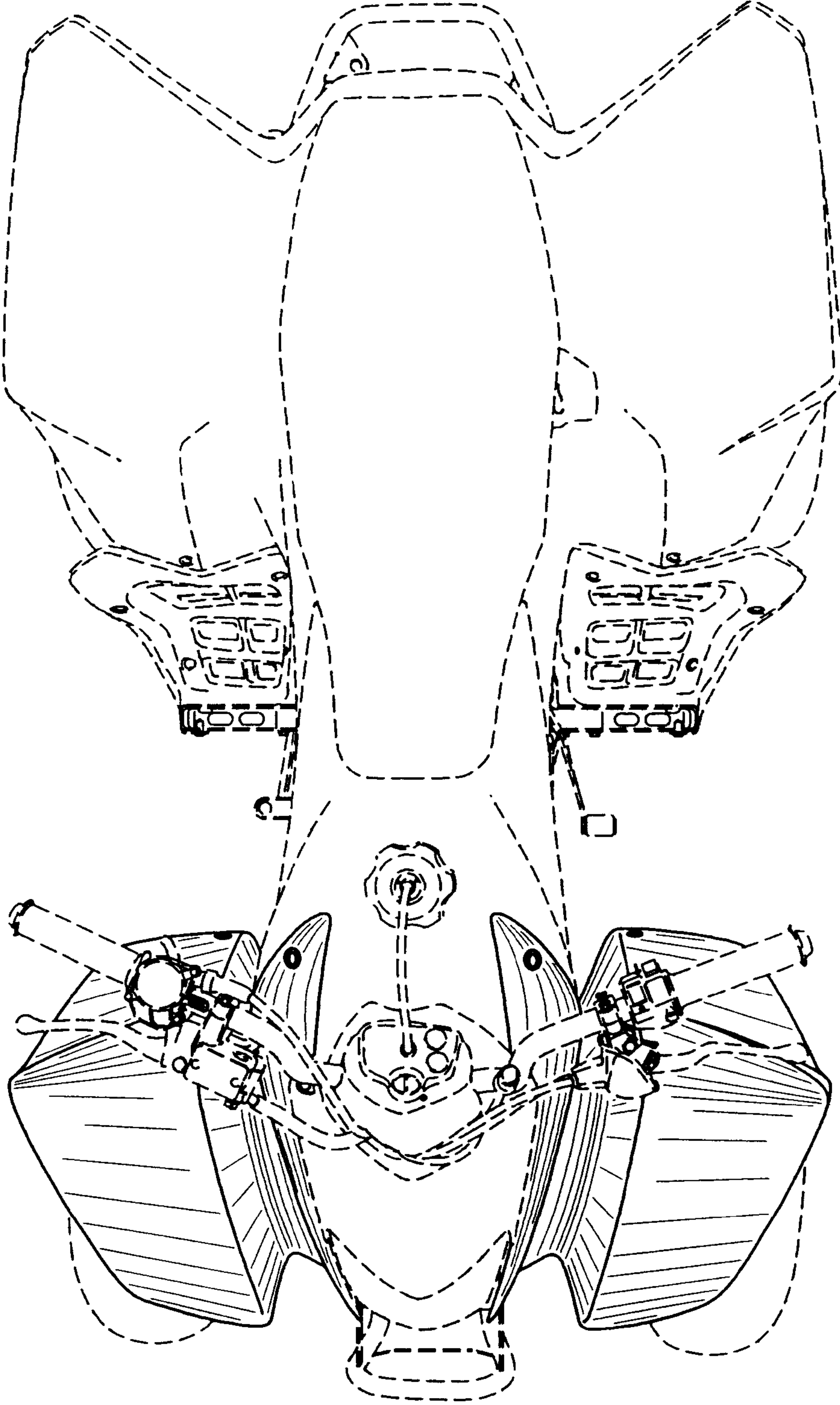
