**DESCRIPTION**

FIG. 11 is a top plan view when closed;

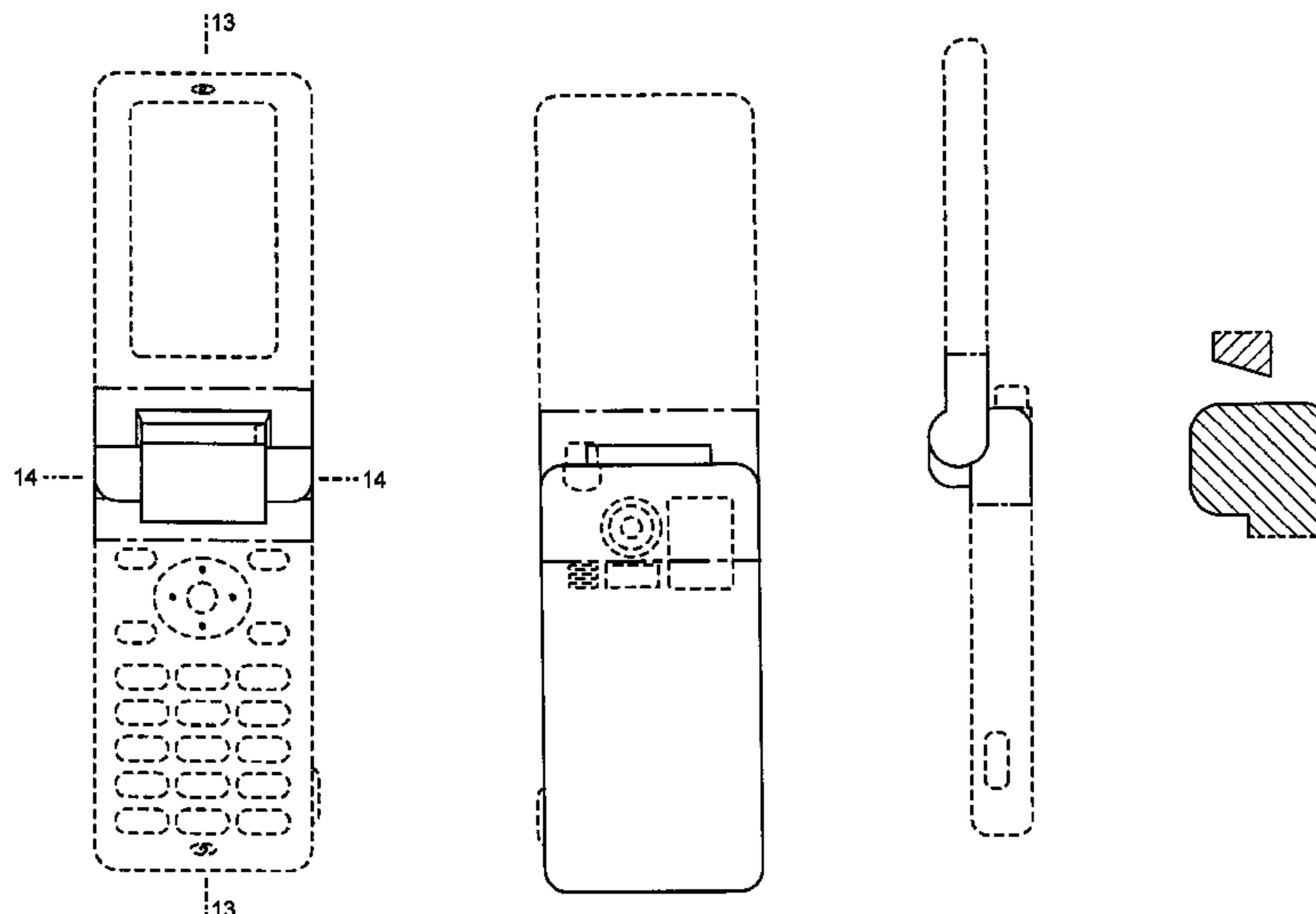
FIG. 12 is a bottom view when closed;

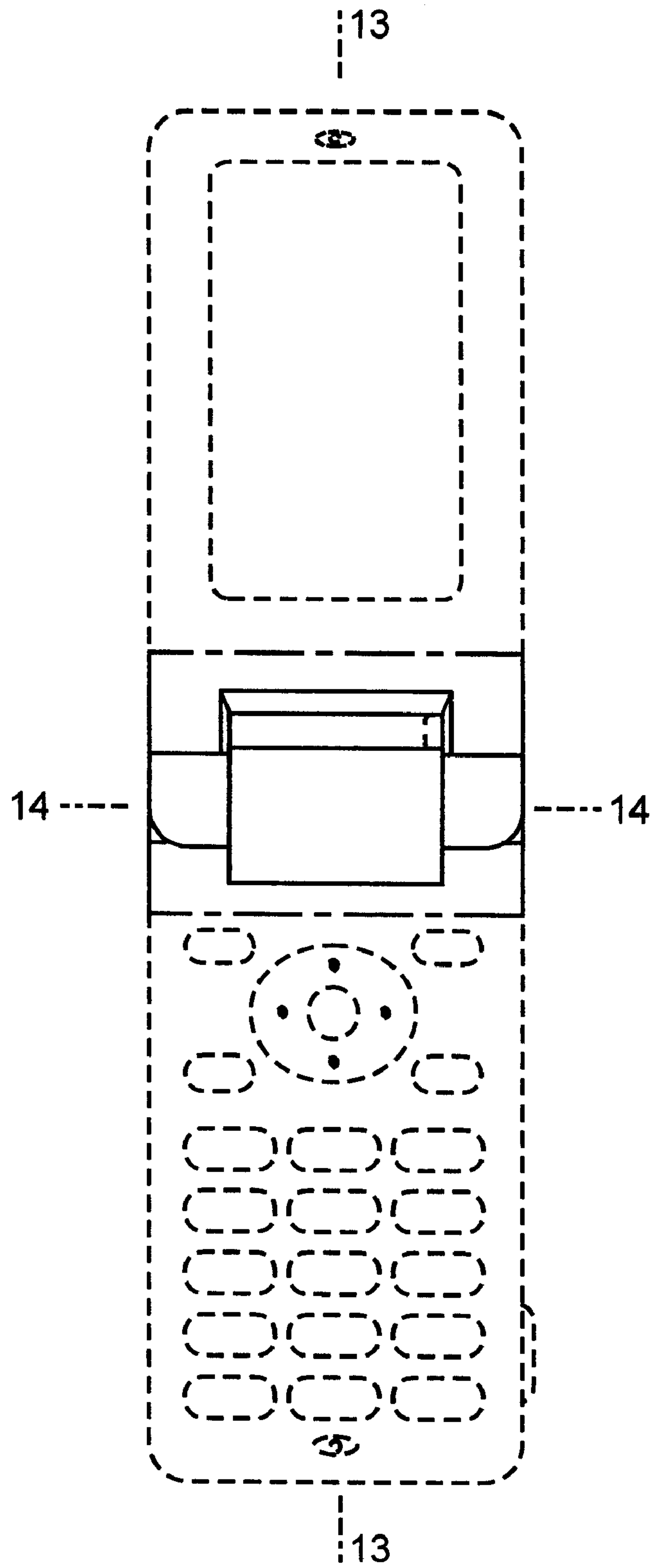

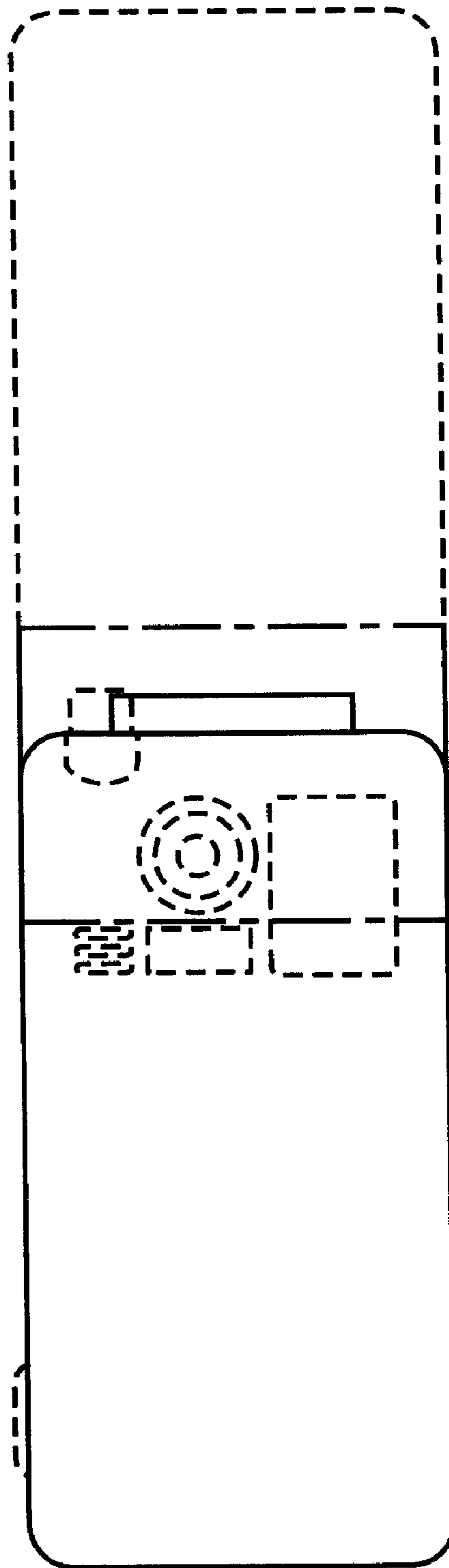

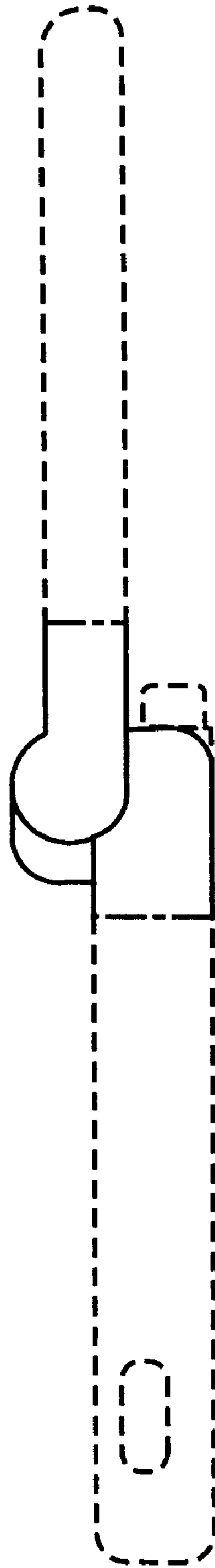

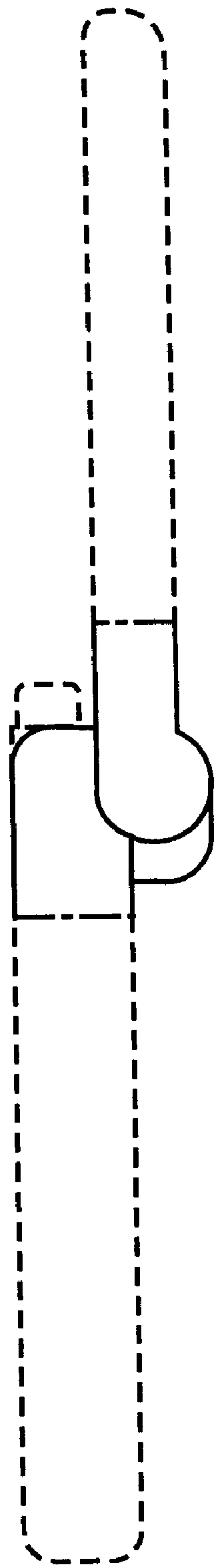

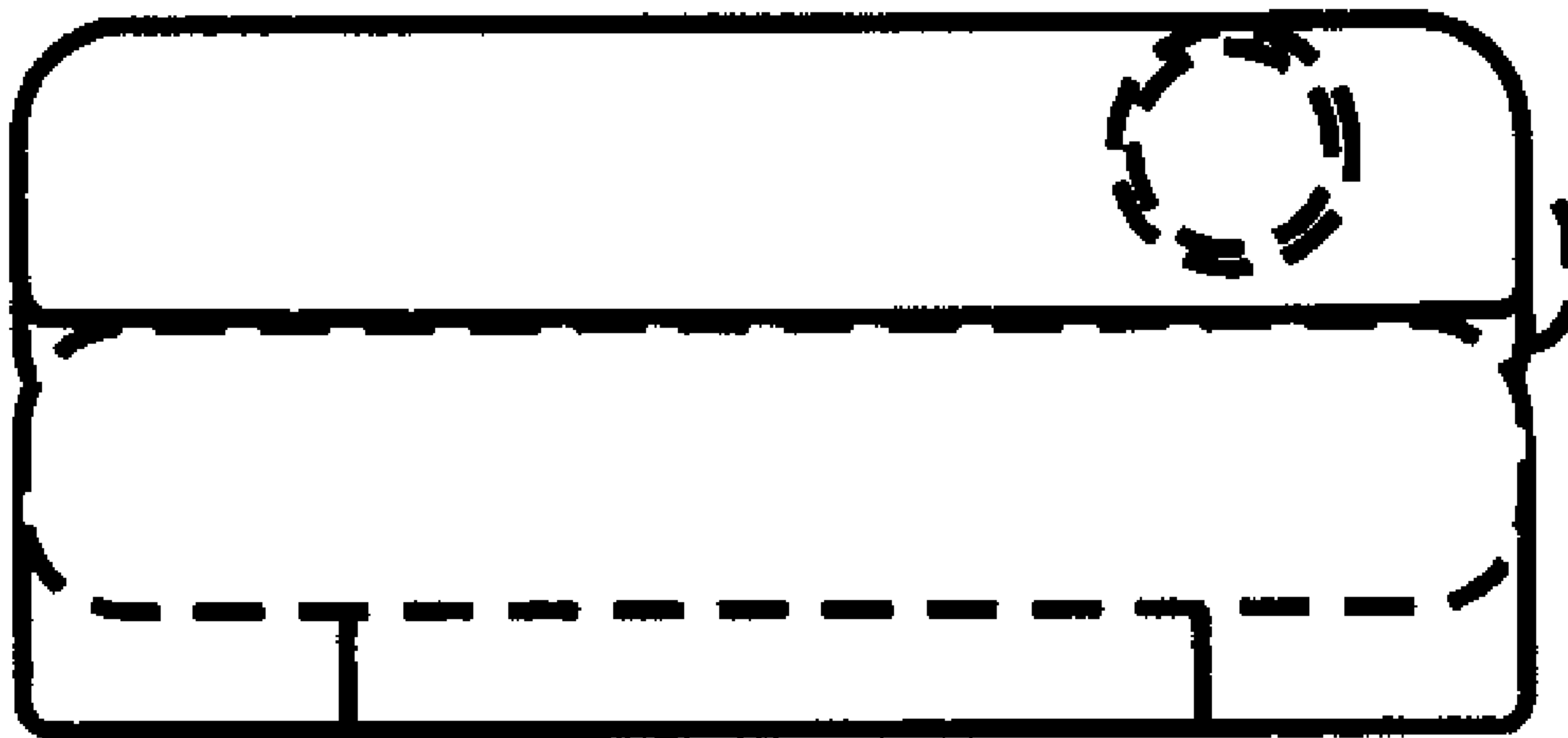

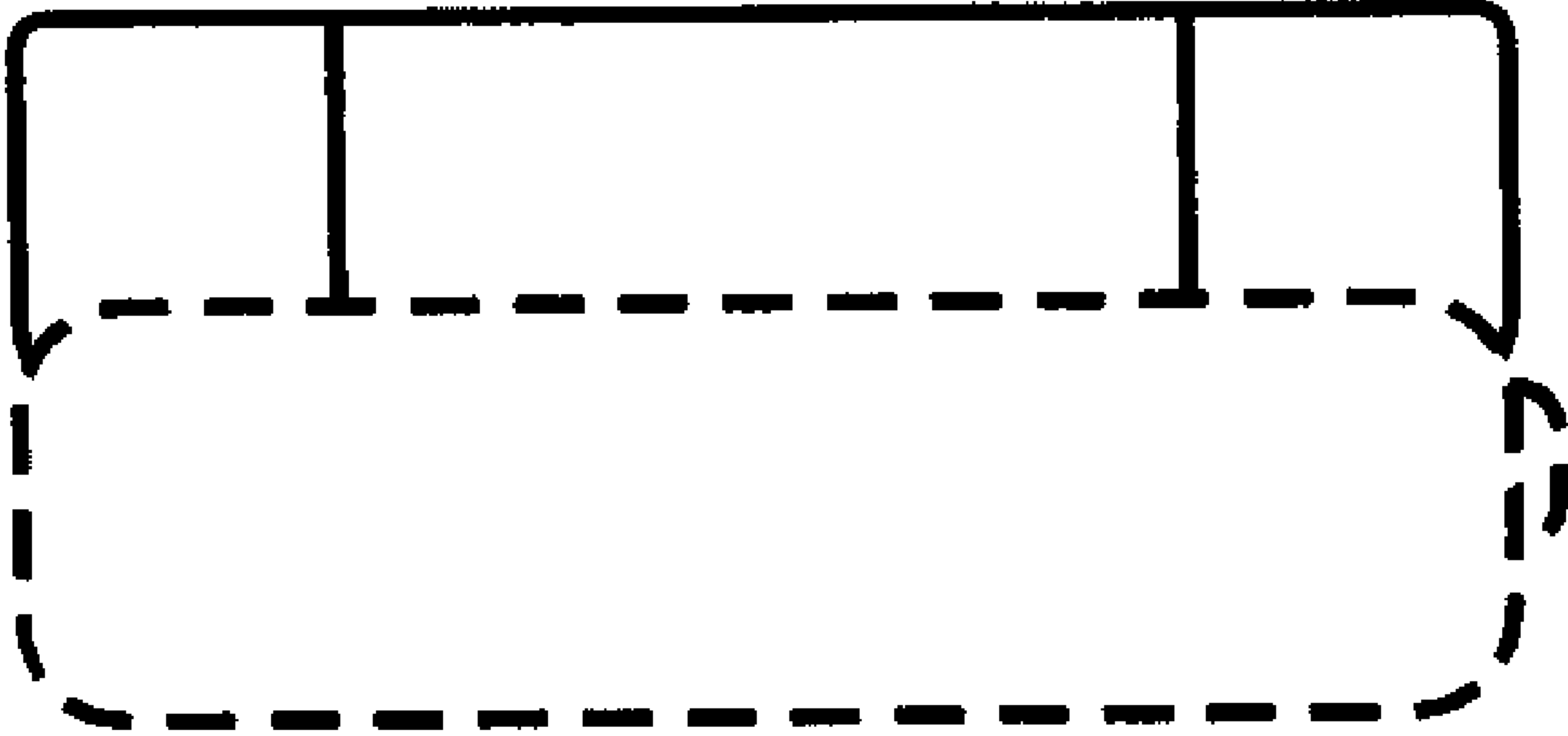

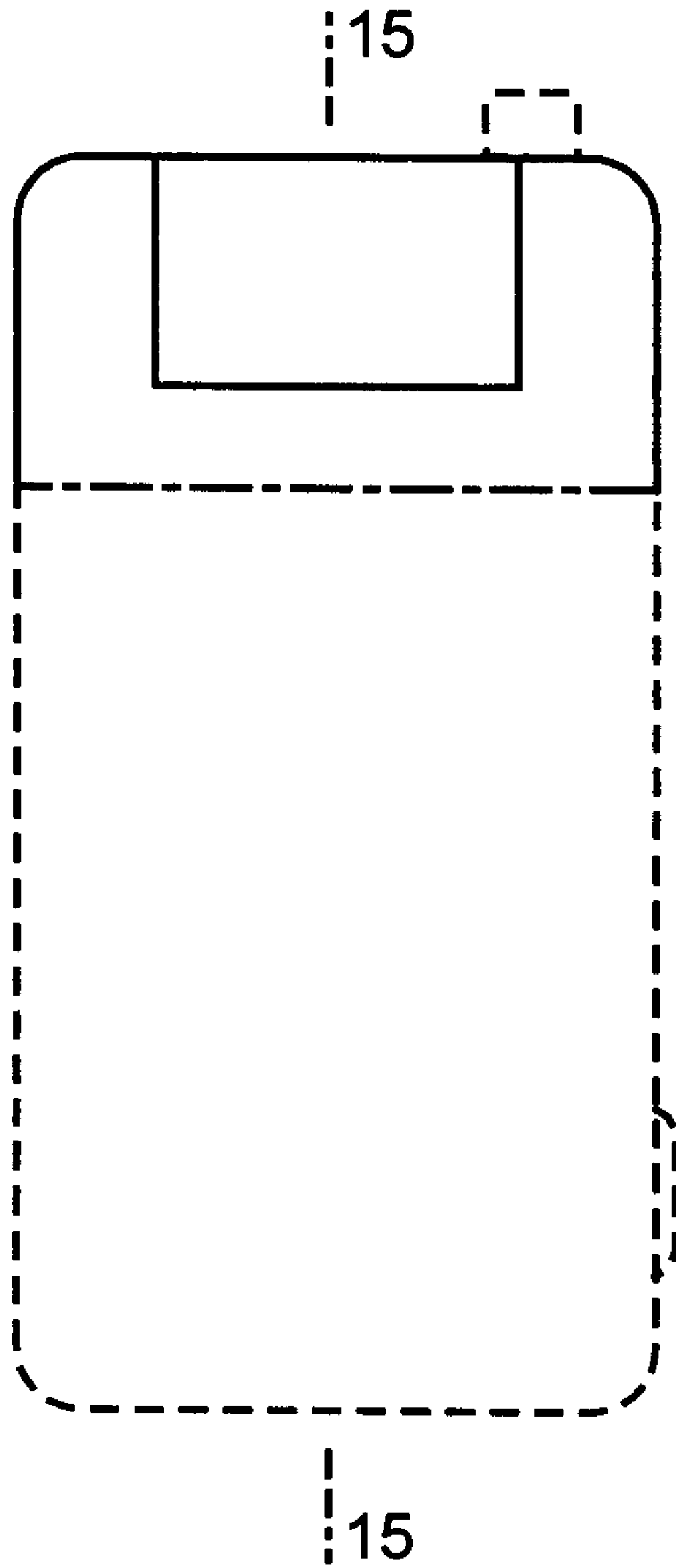

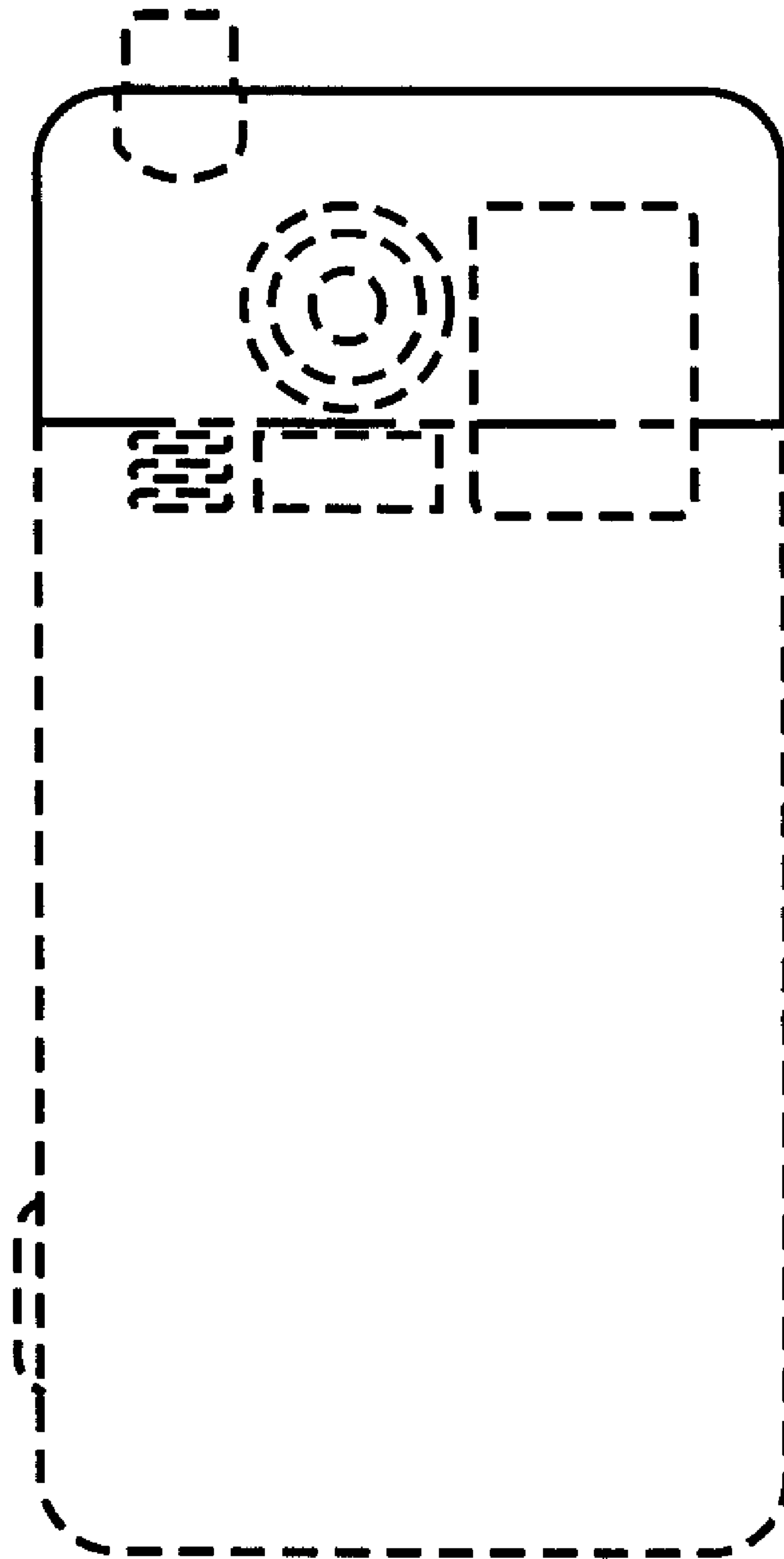

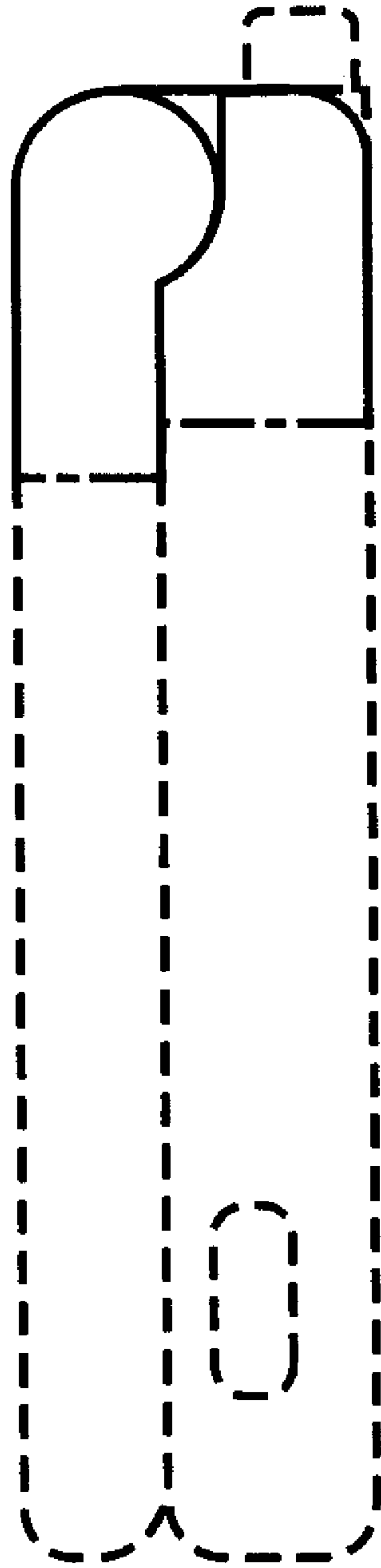

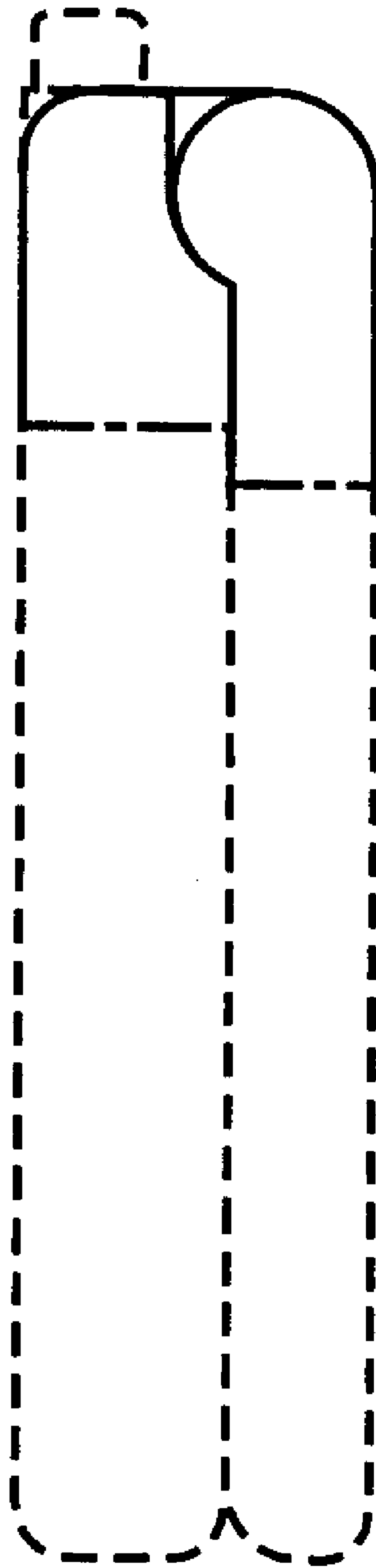

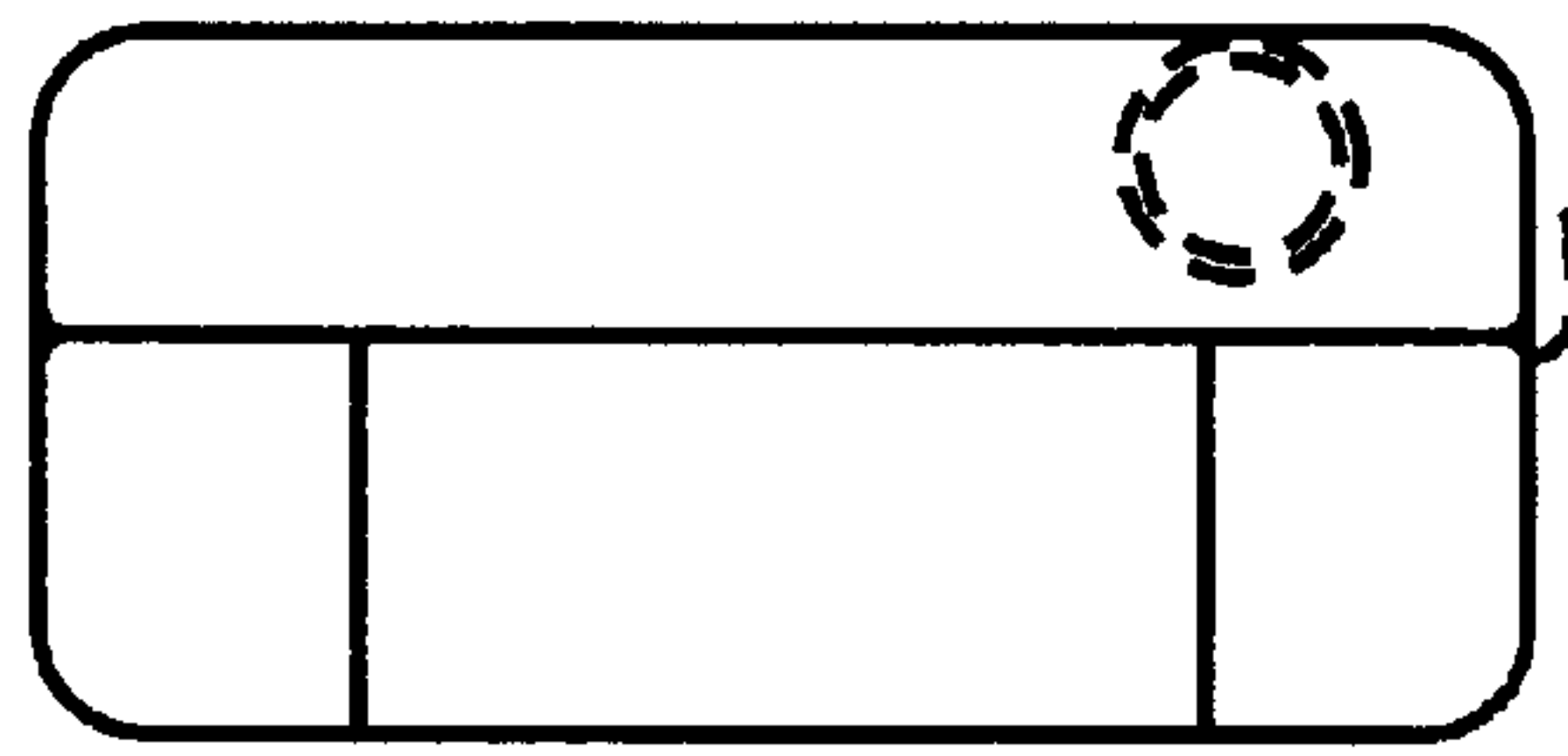

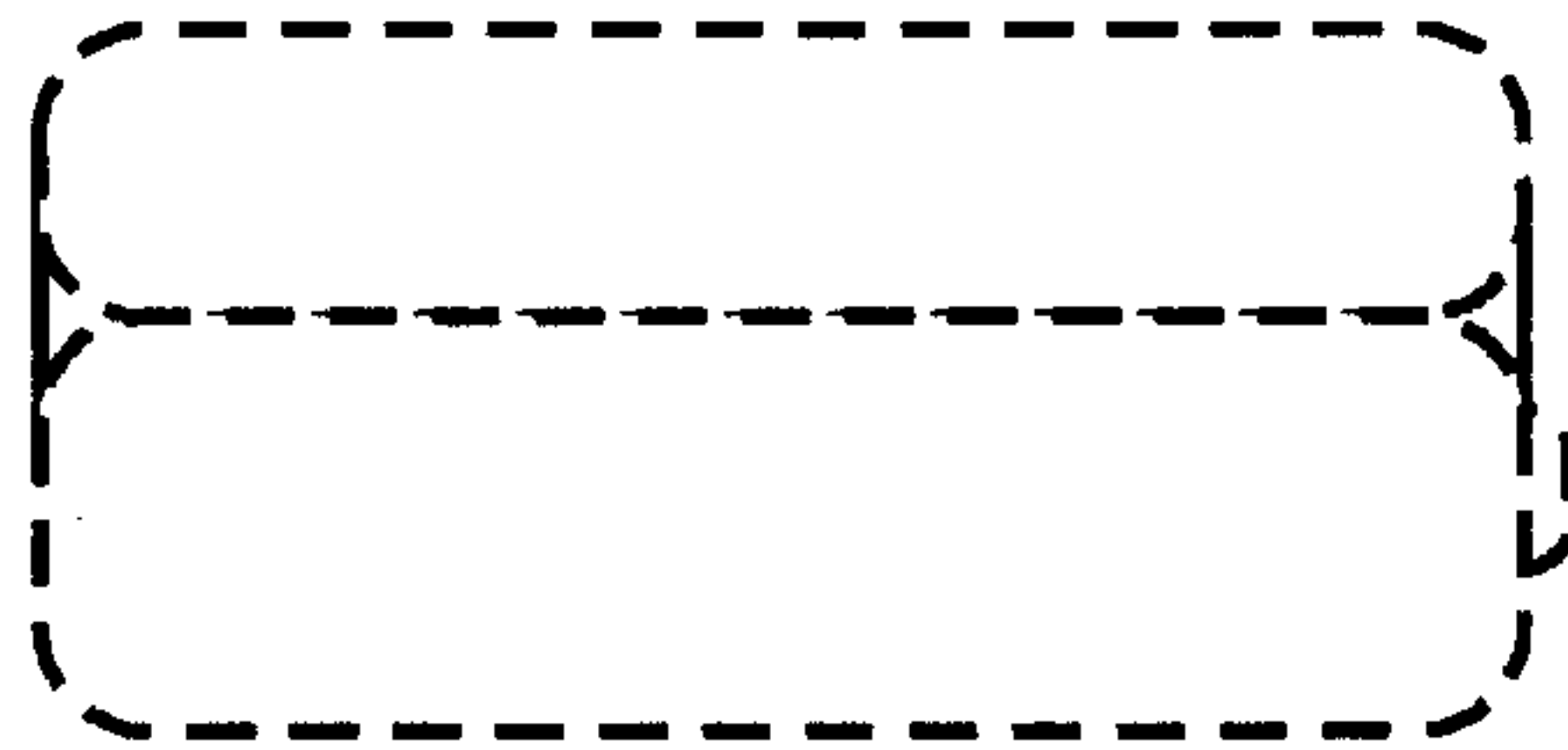

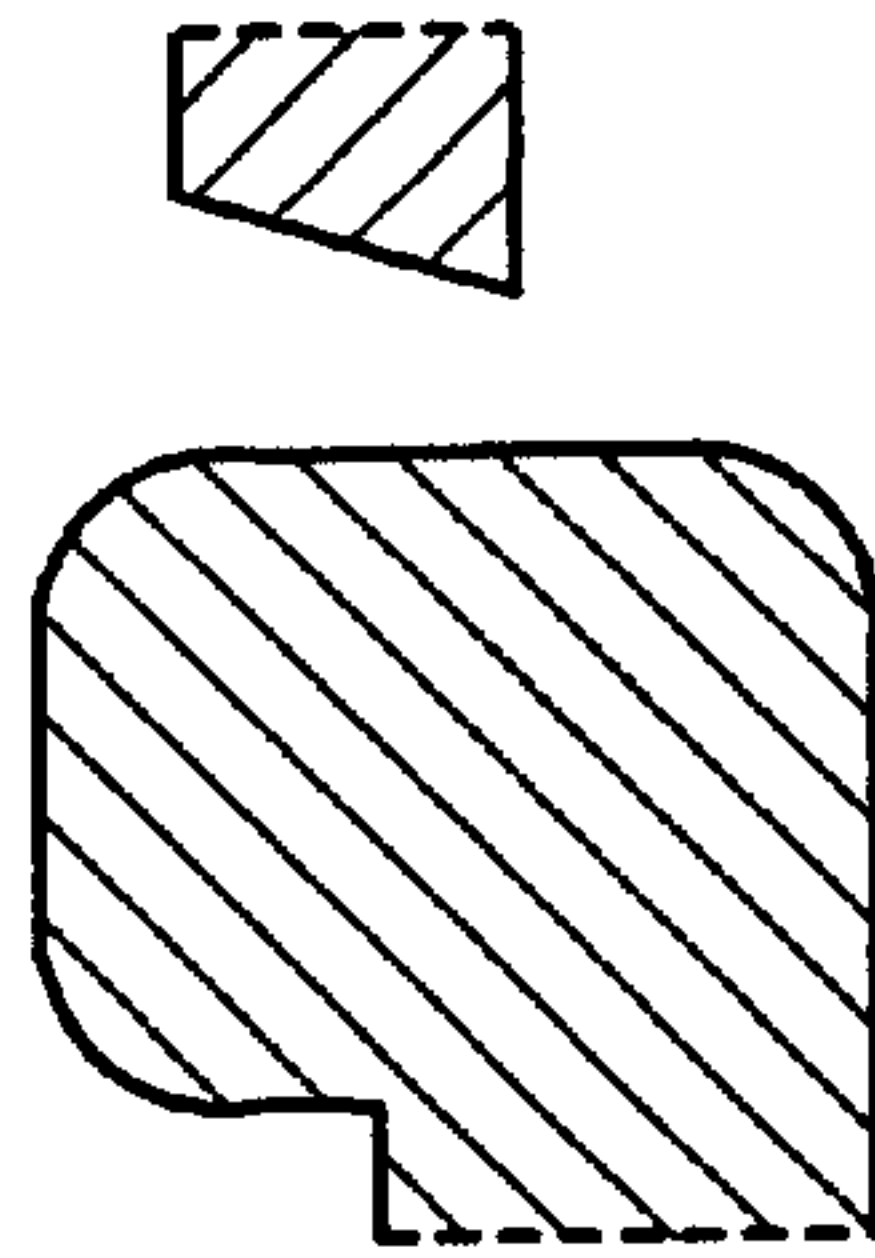

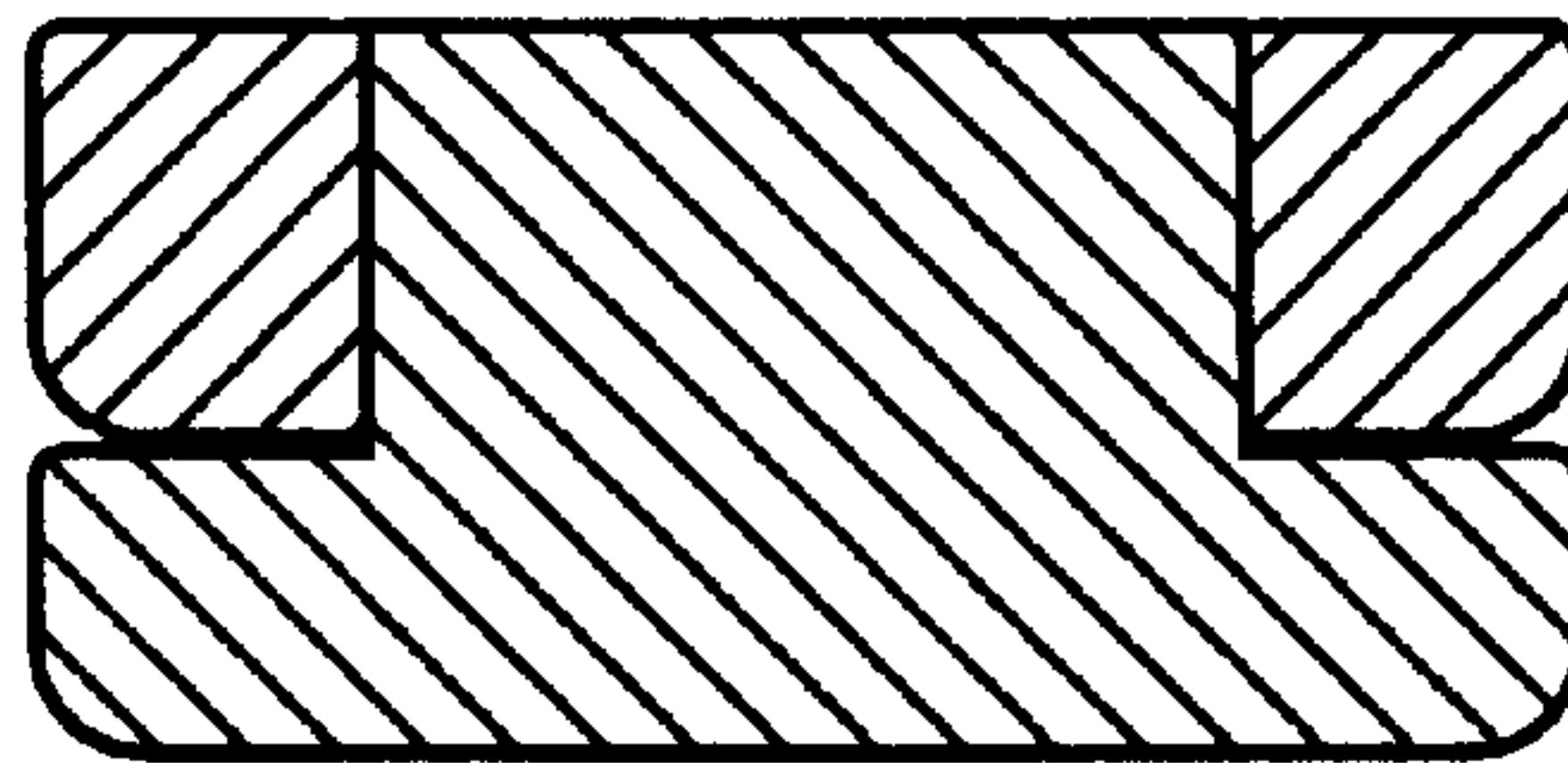
