DESCRIPTION

FIG. 20 is a front view of the second image thereof, on an enlarged scale, the image is shown separately for illustration;

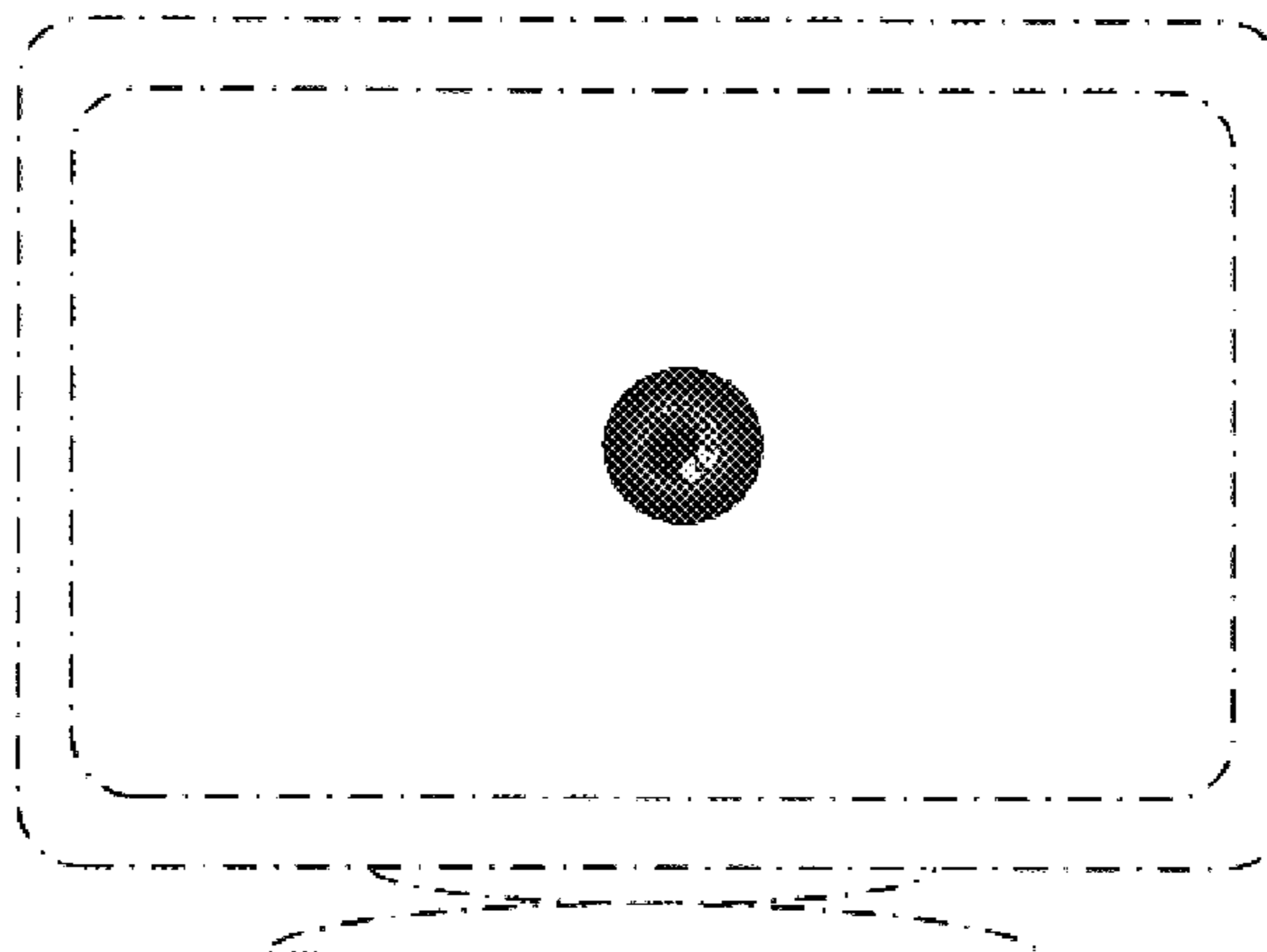


FIG. 21 is a front view of the third image thereof, on an enlarged scale, the image is shown separately for clarity of illustration;

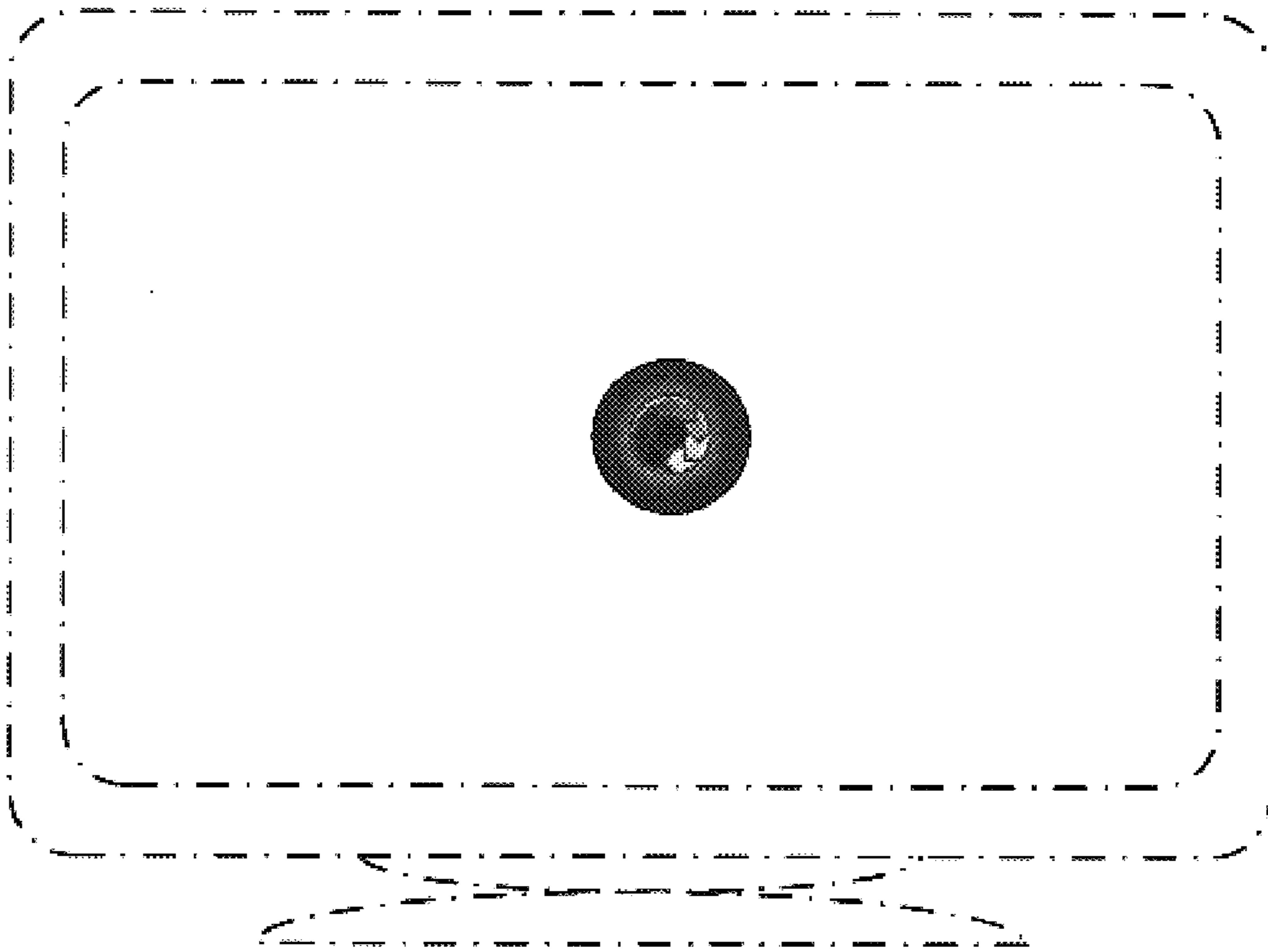

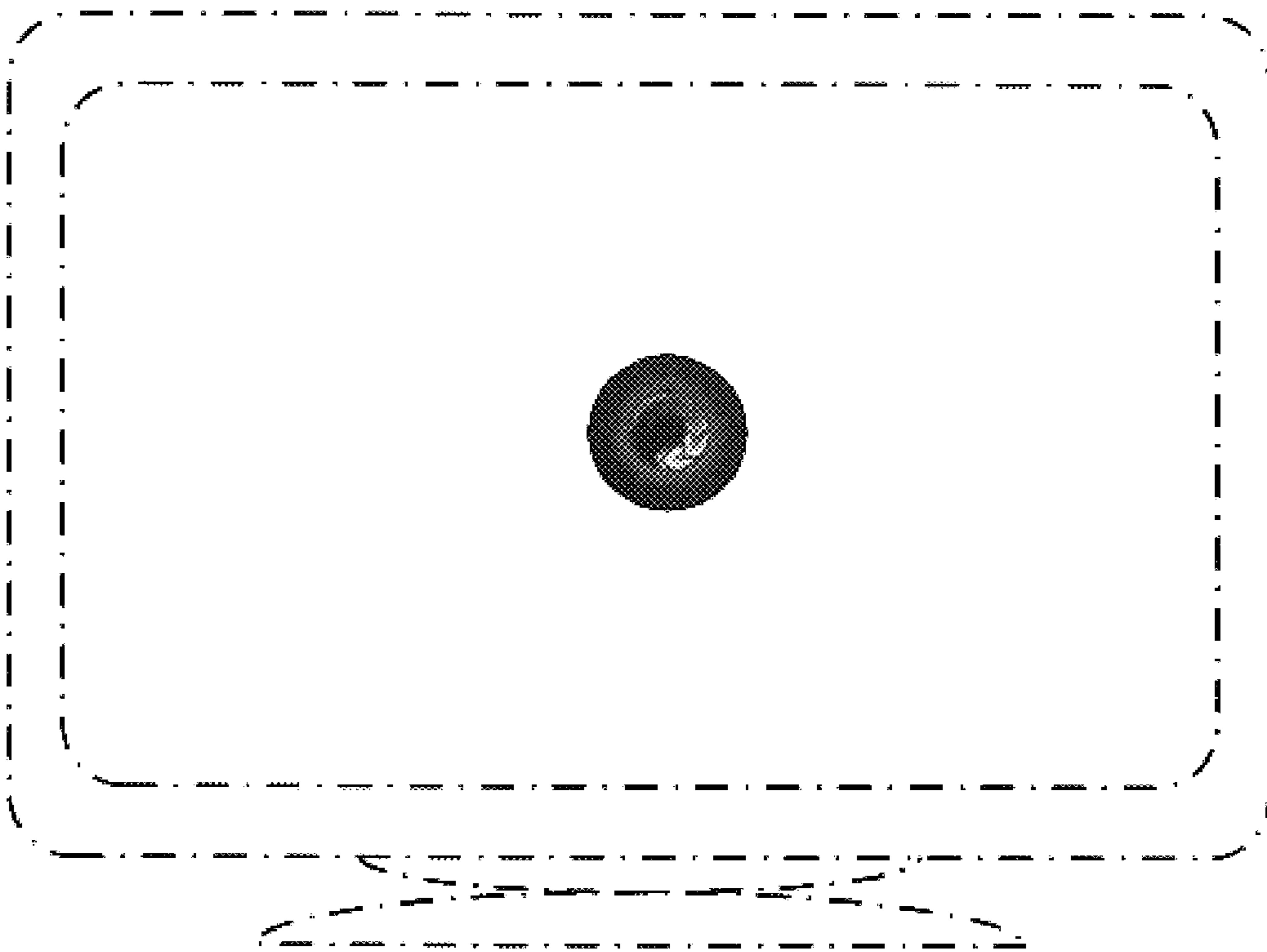

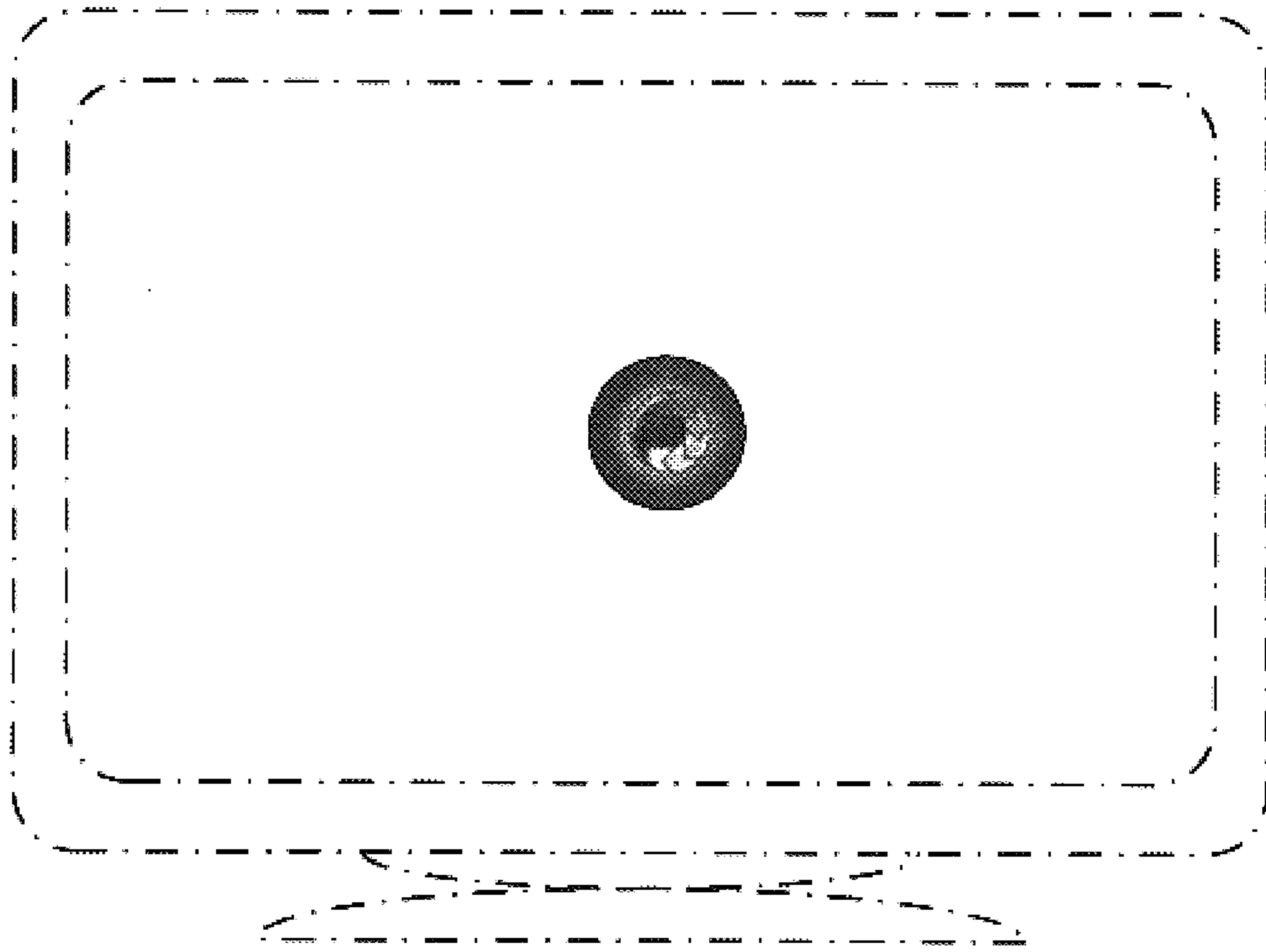

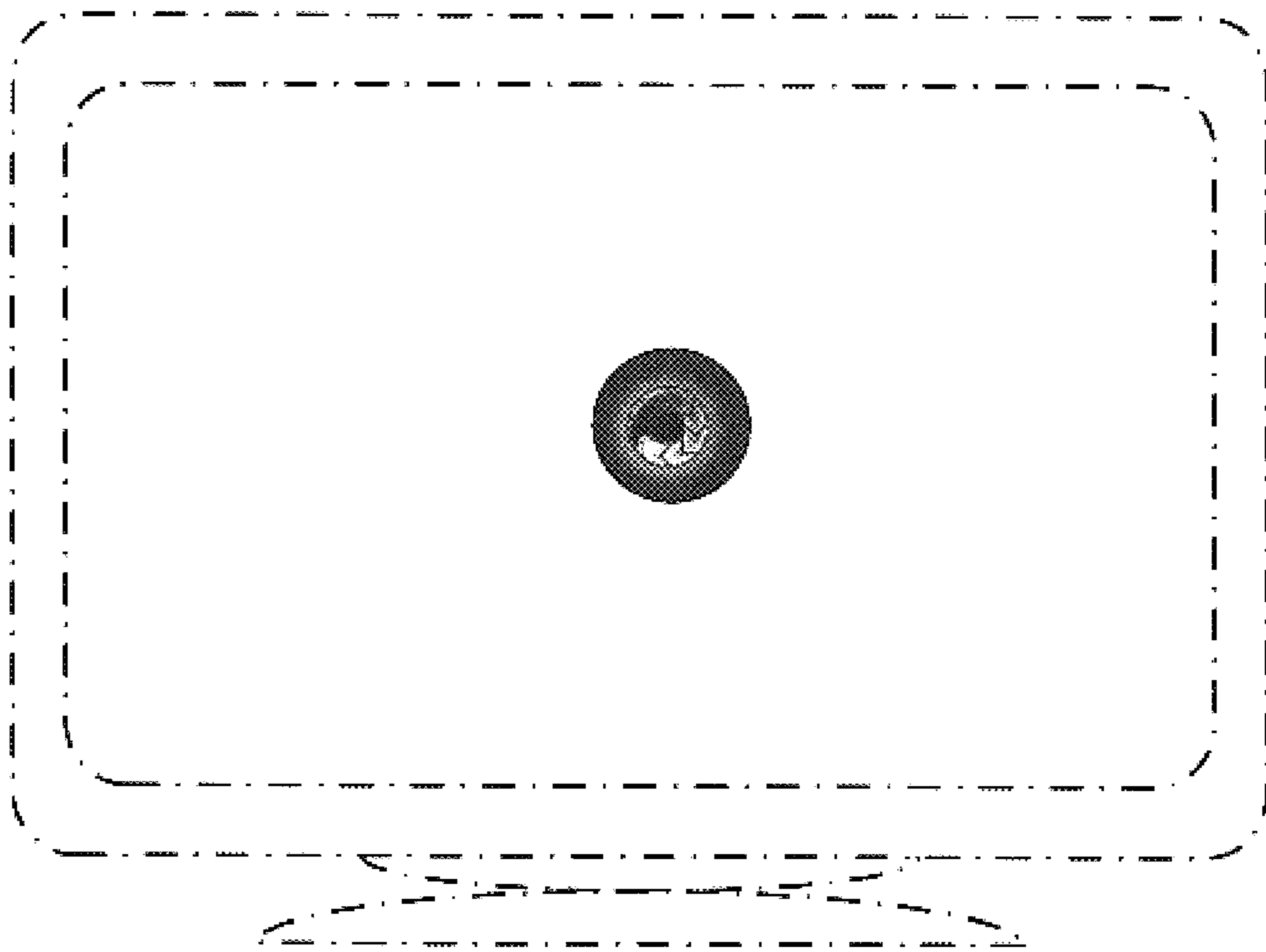

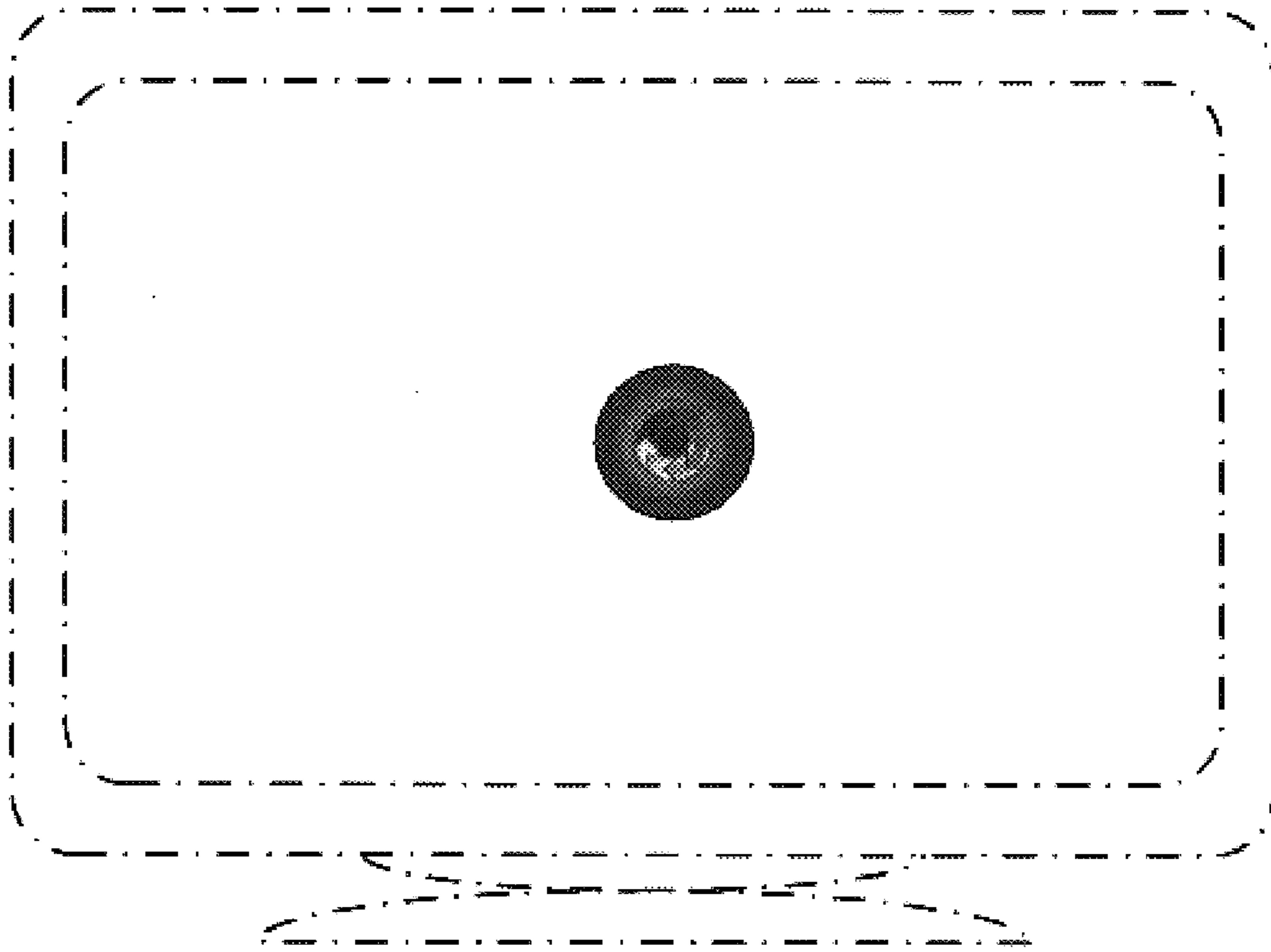

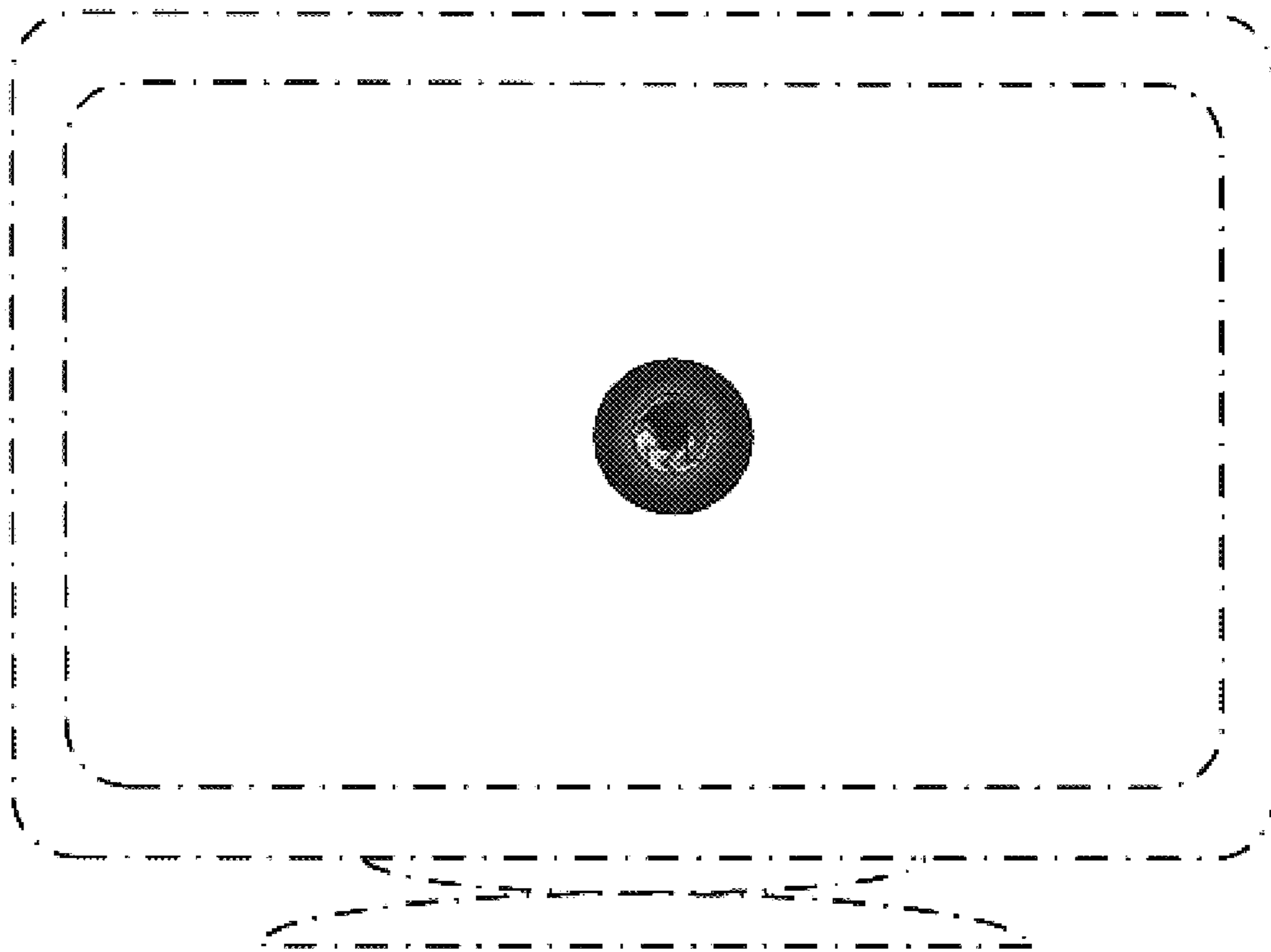

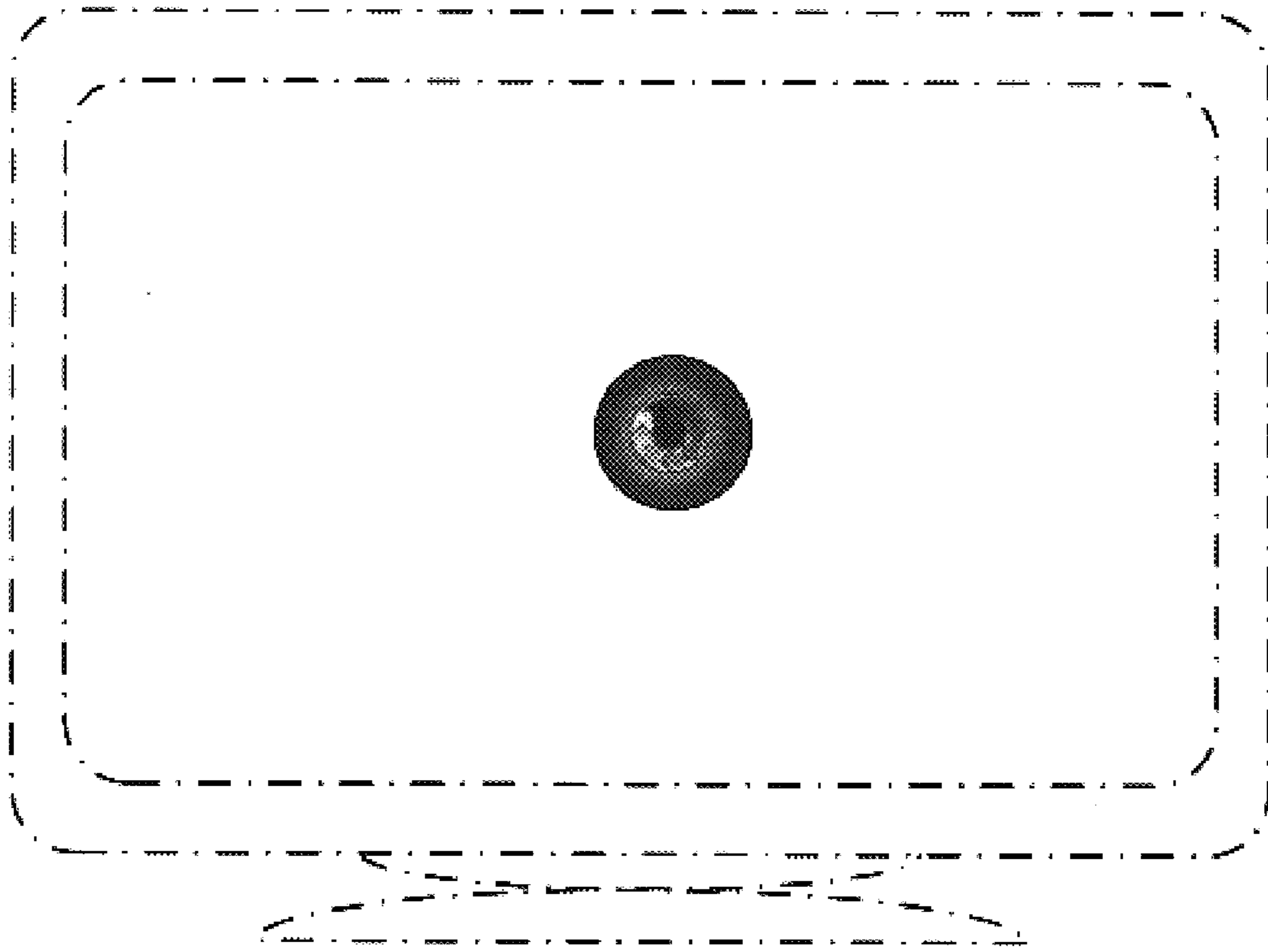

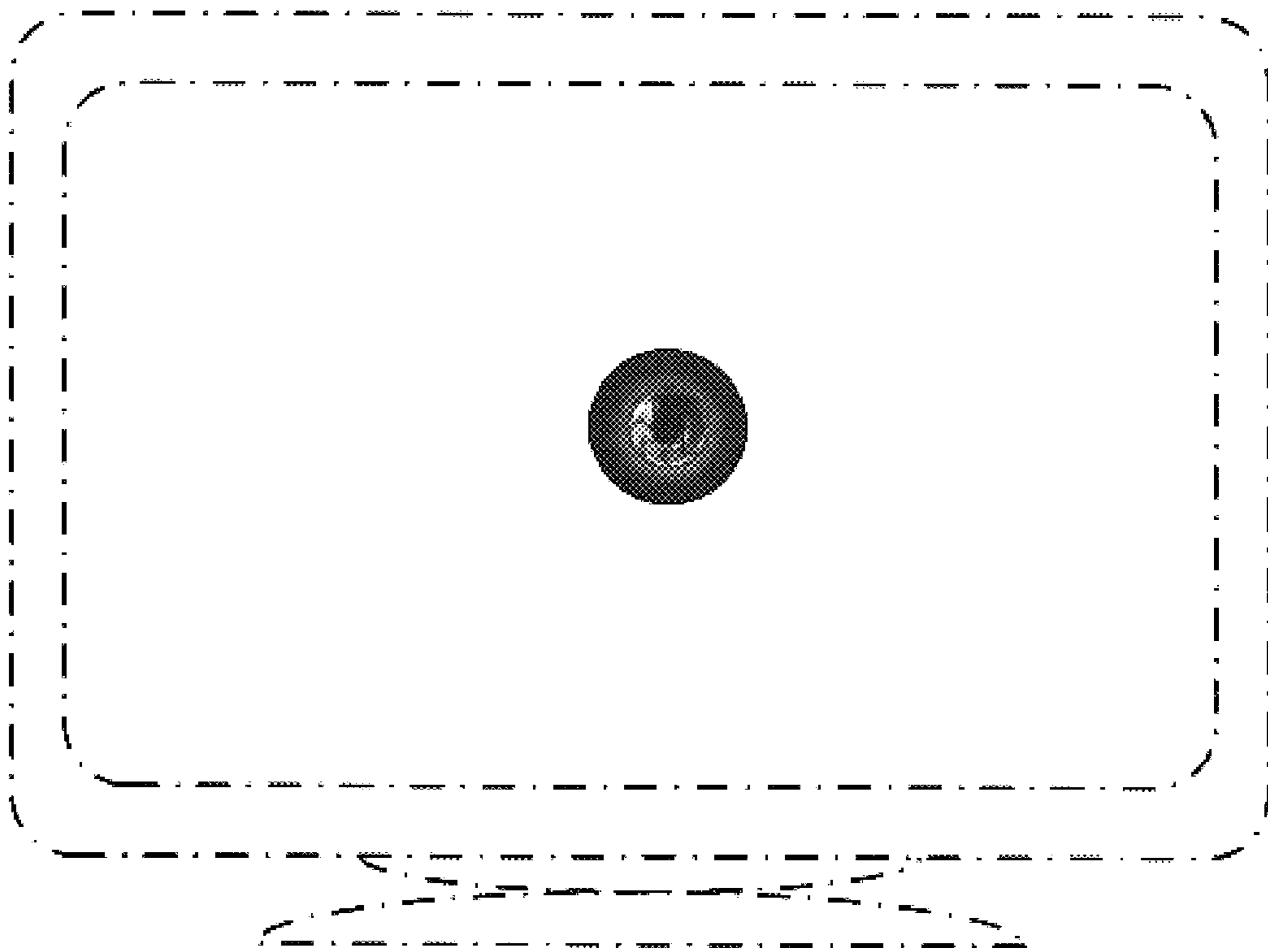

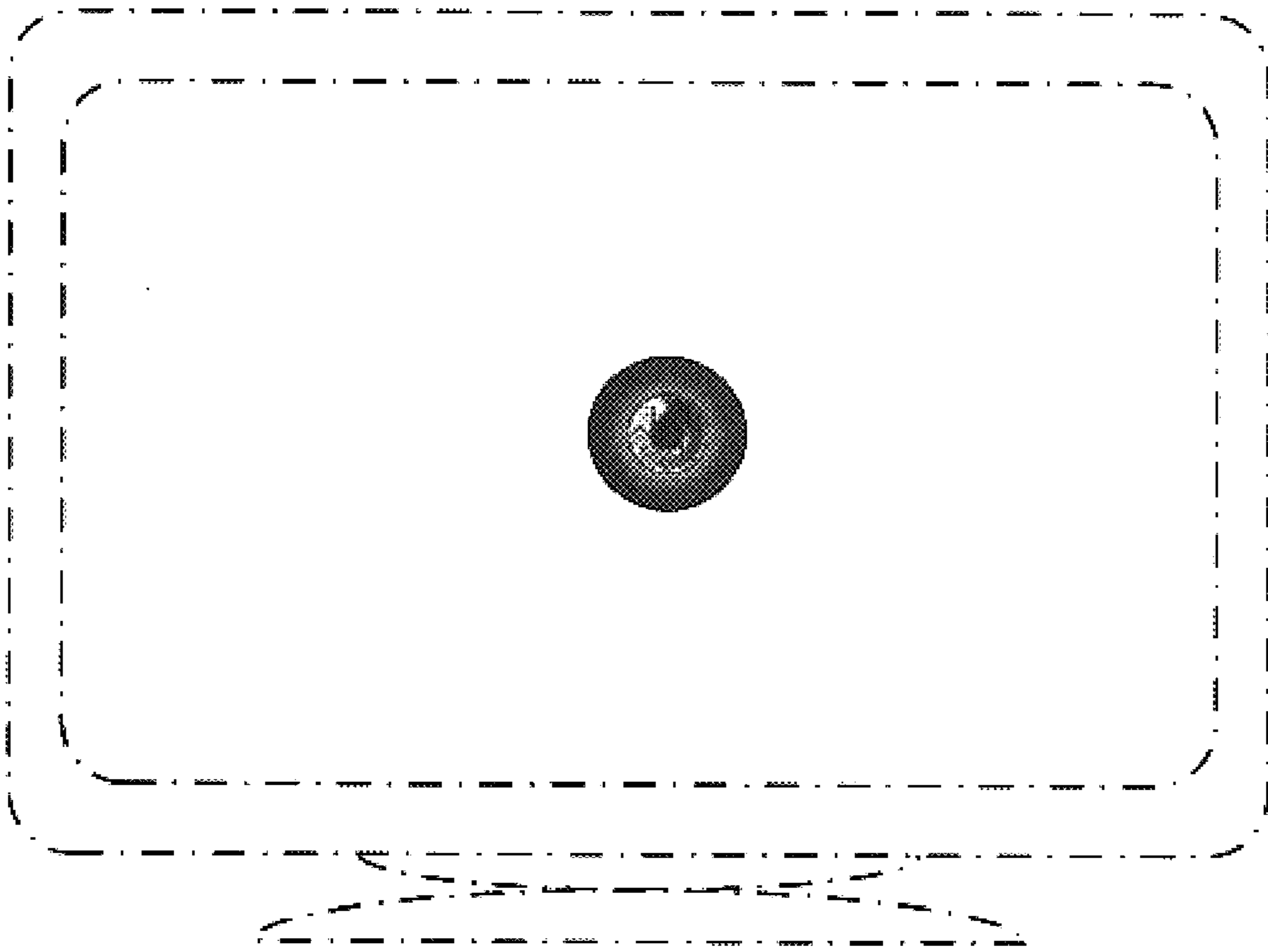

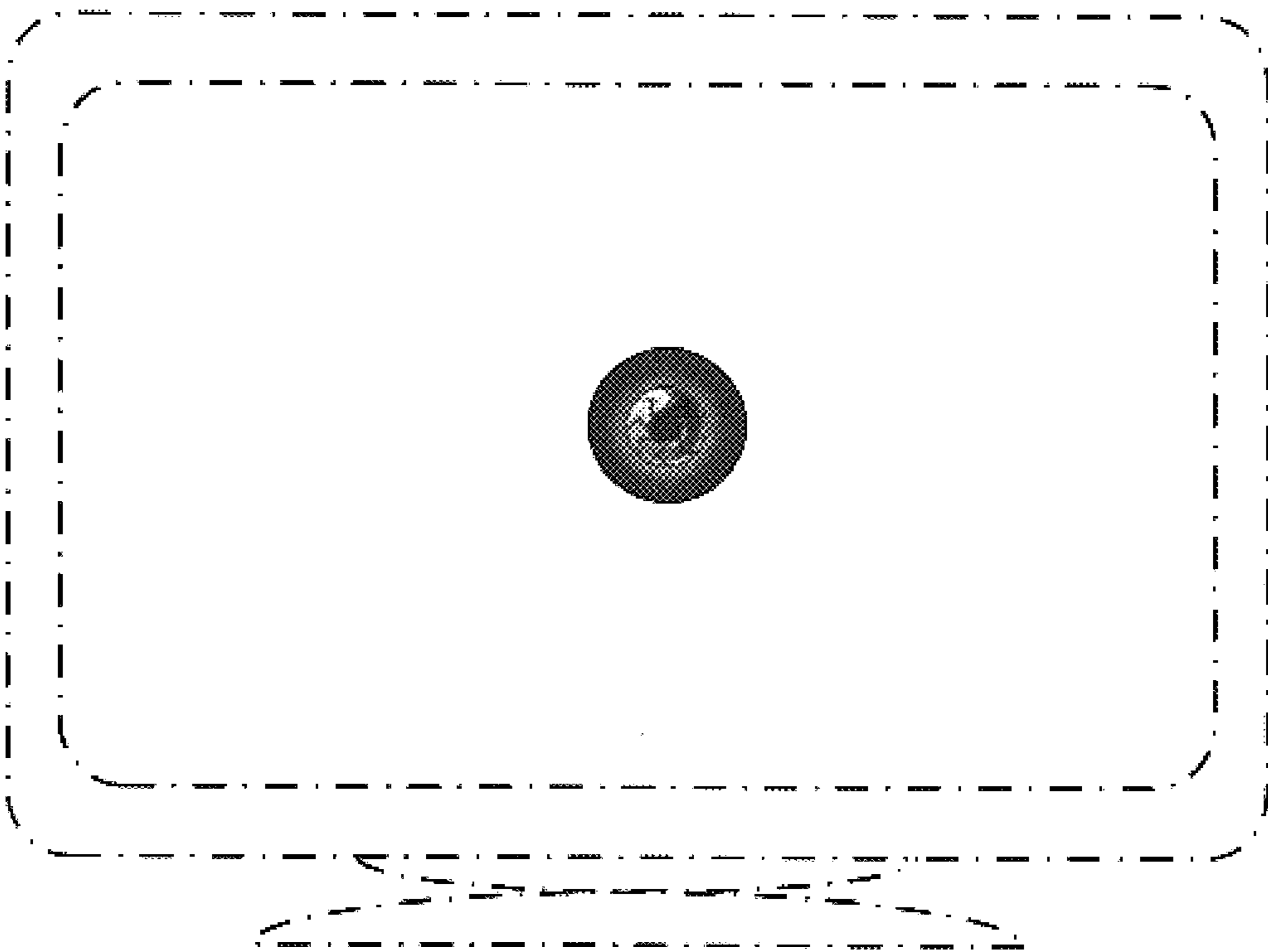

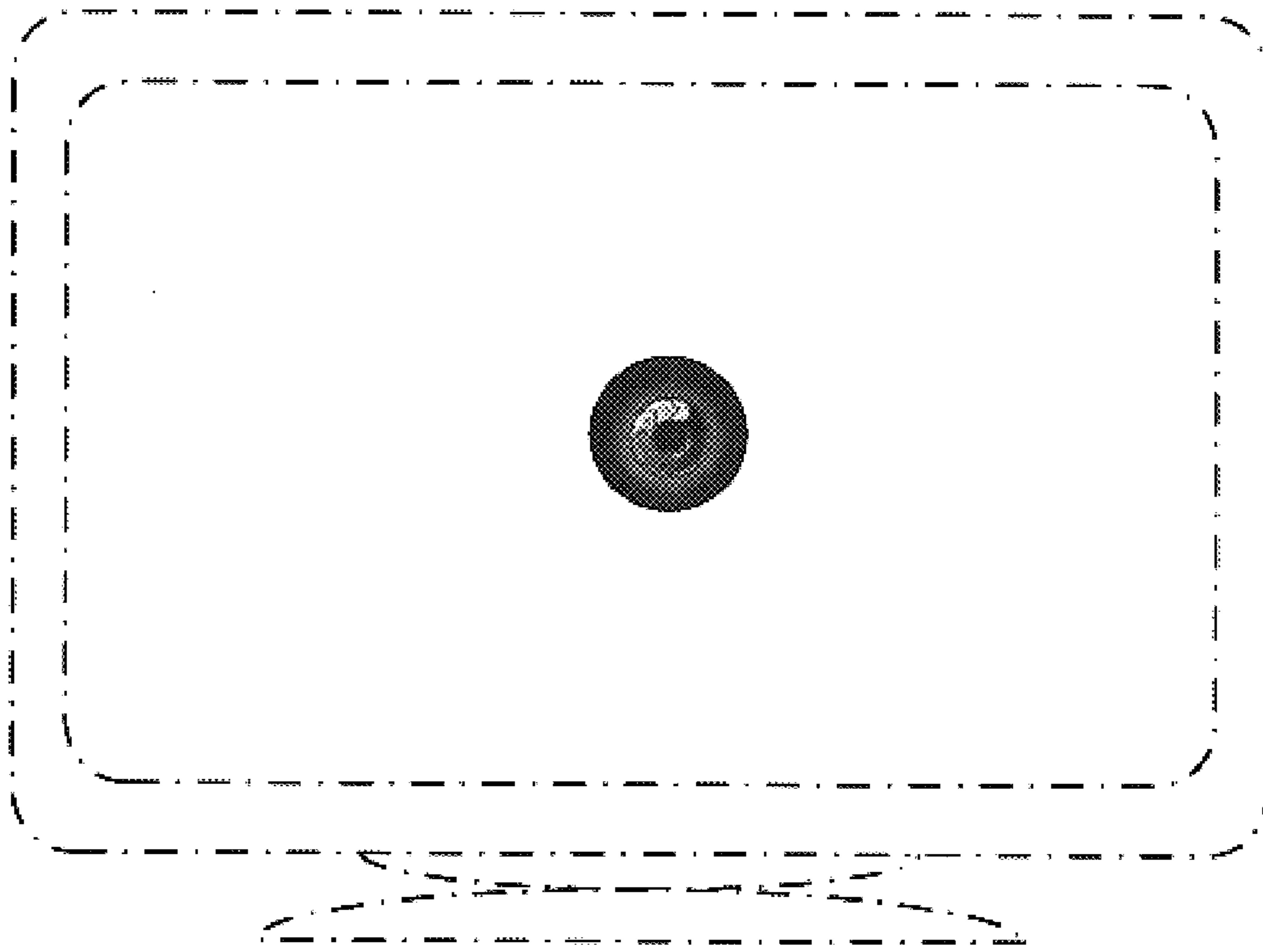

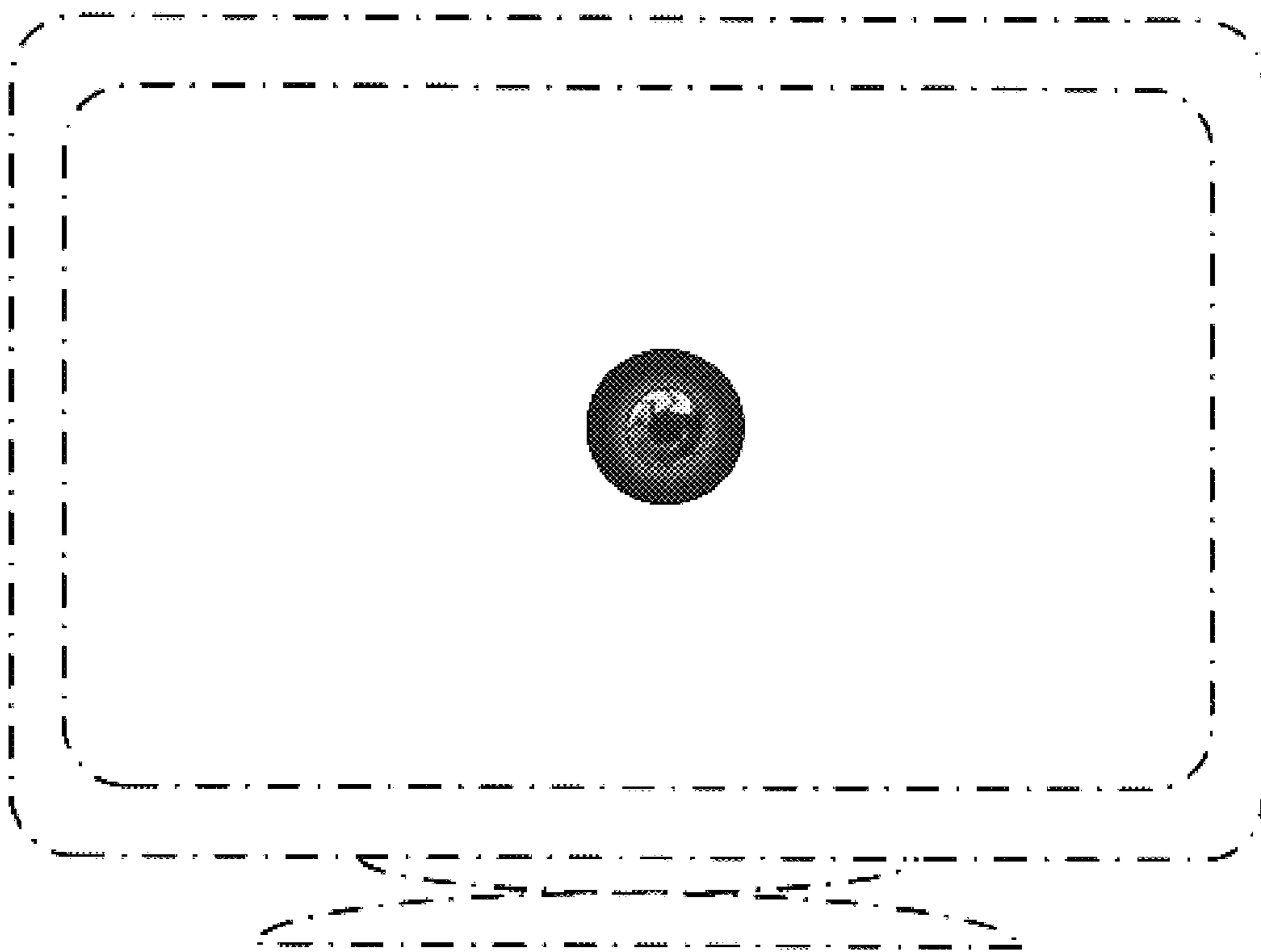

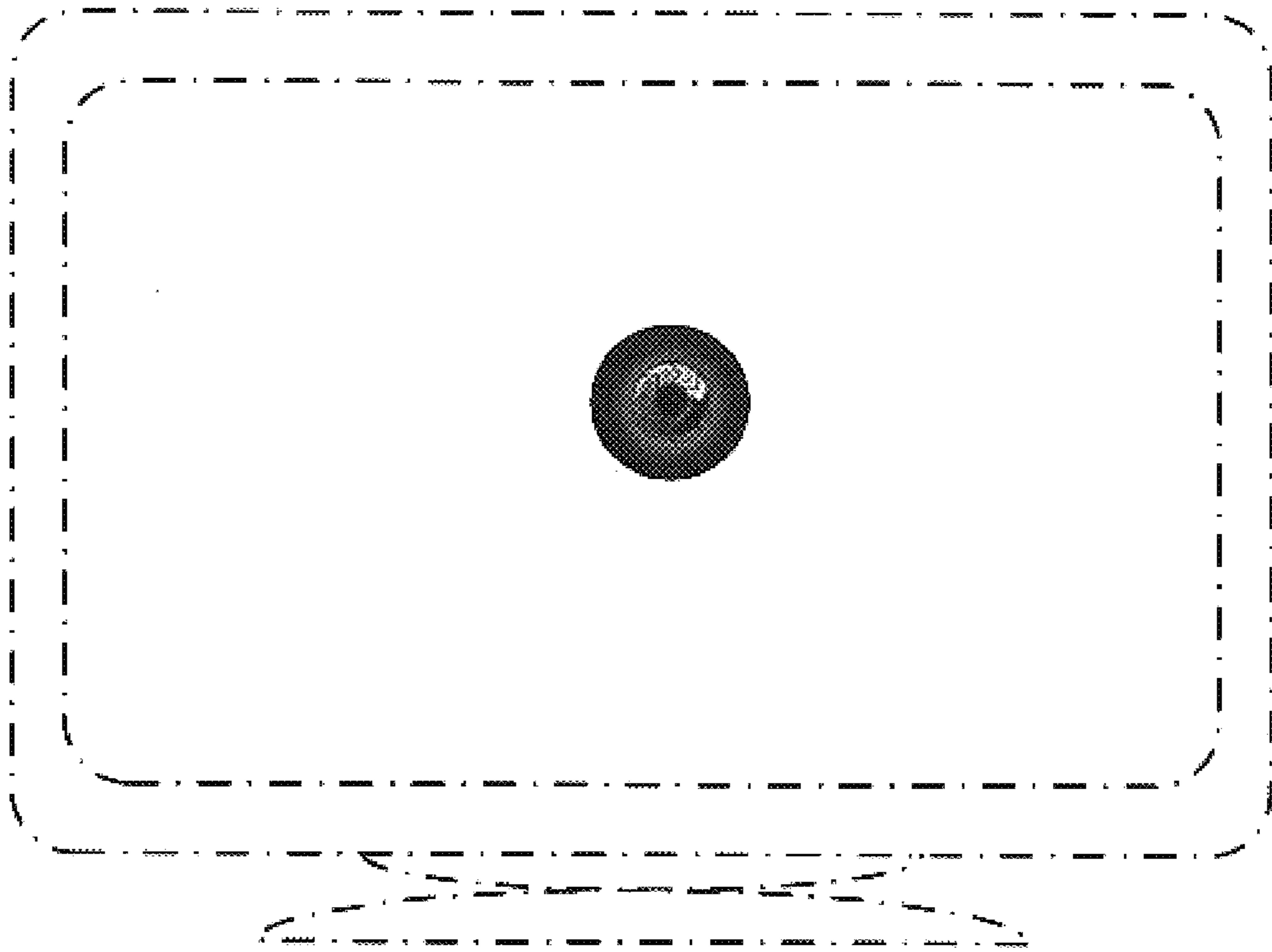

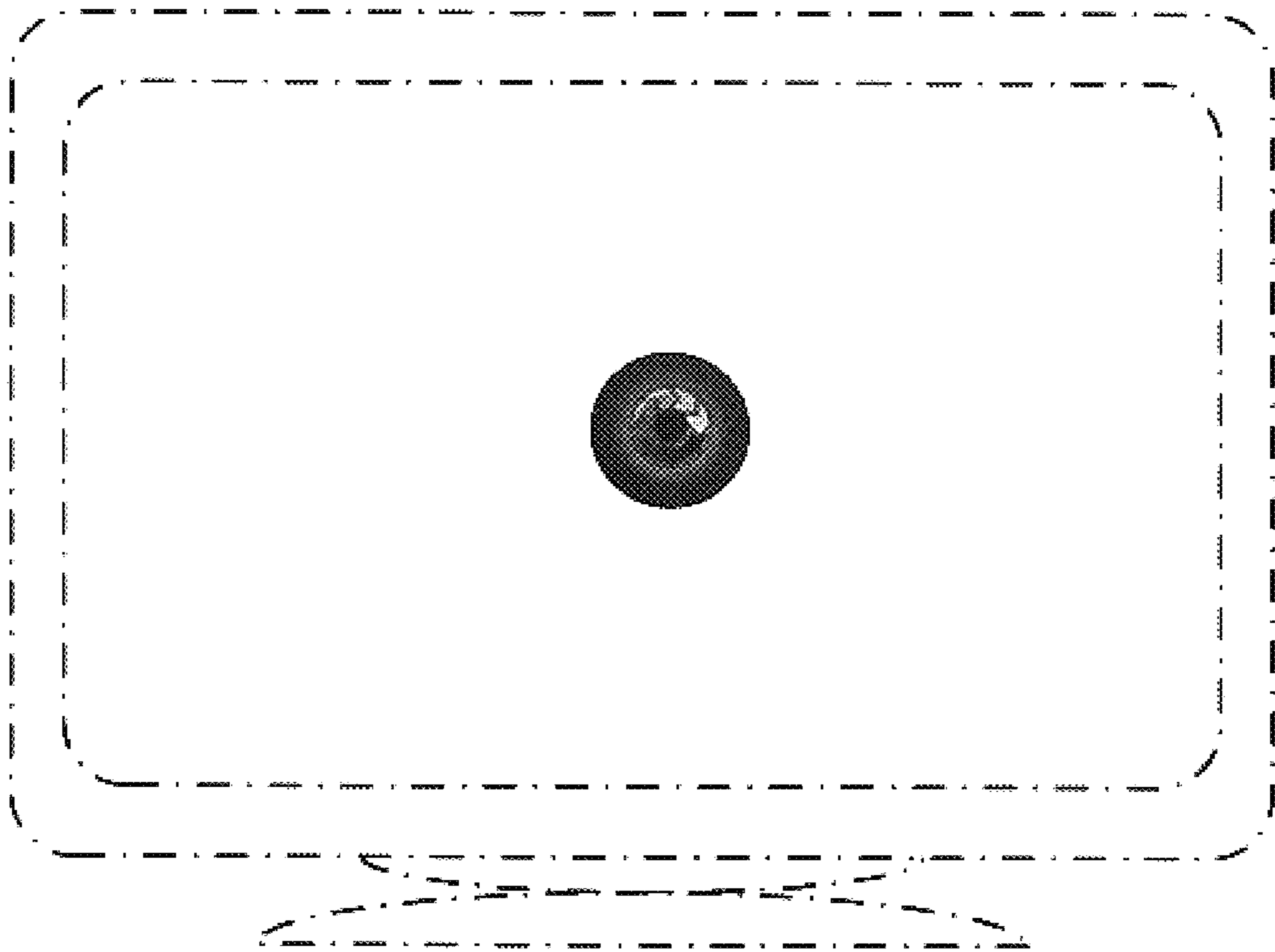

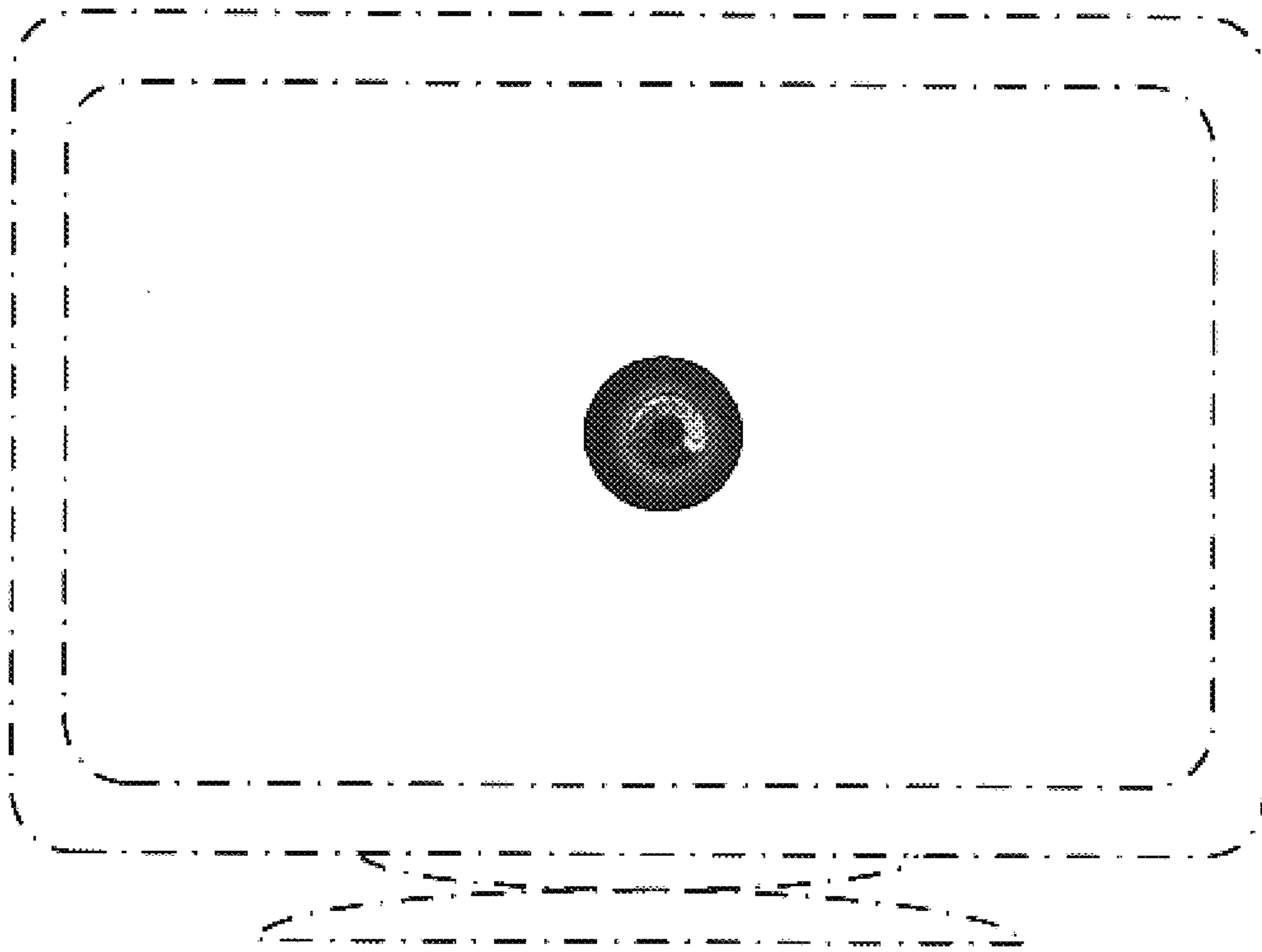

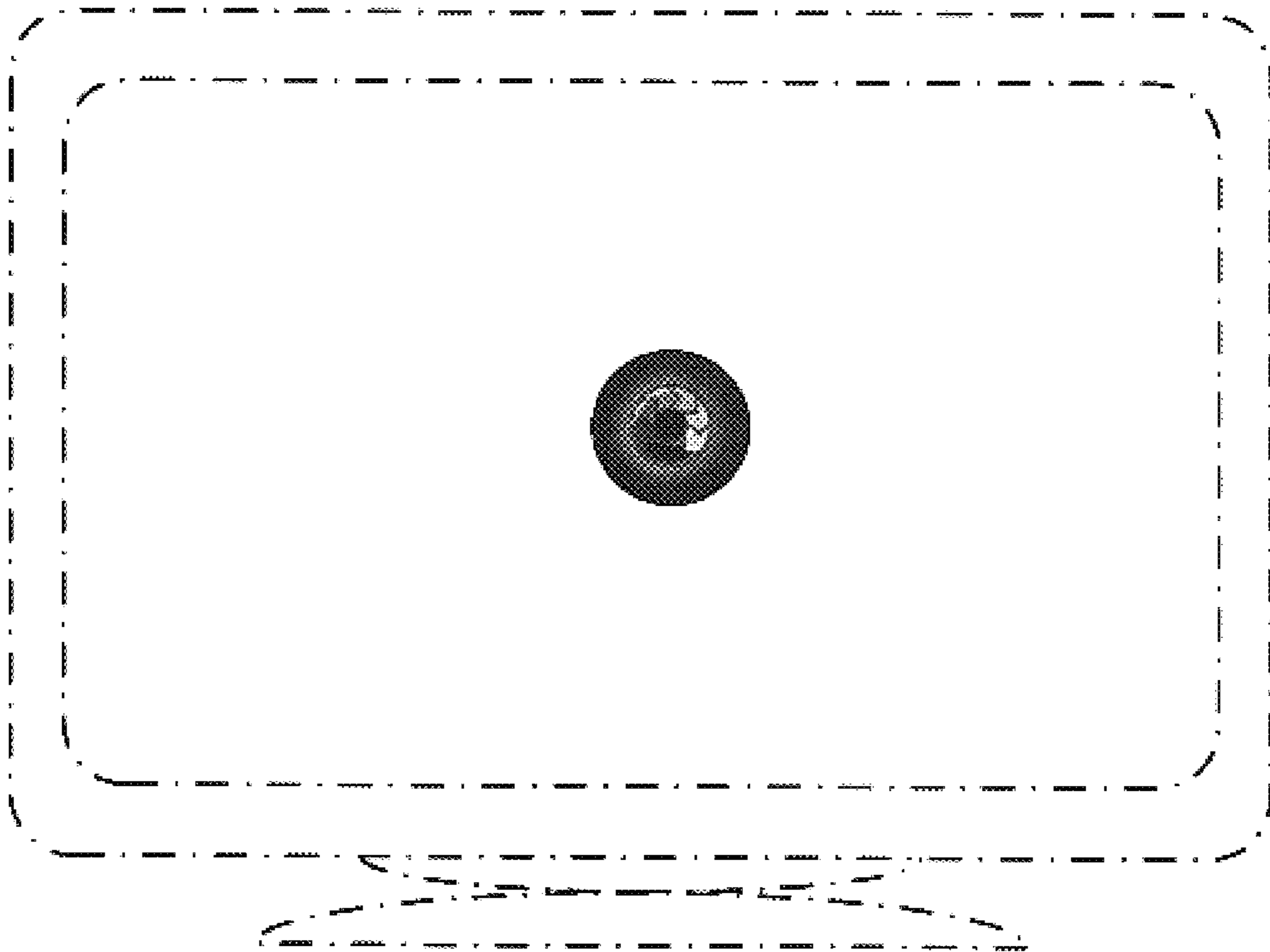

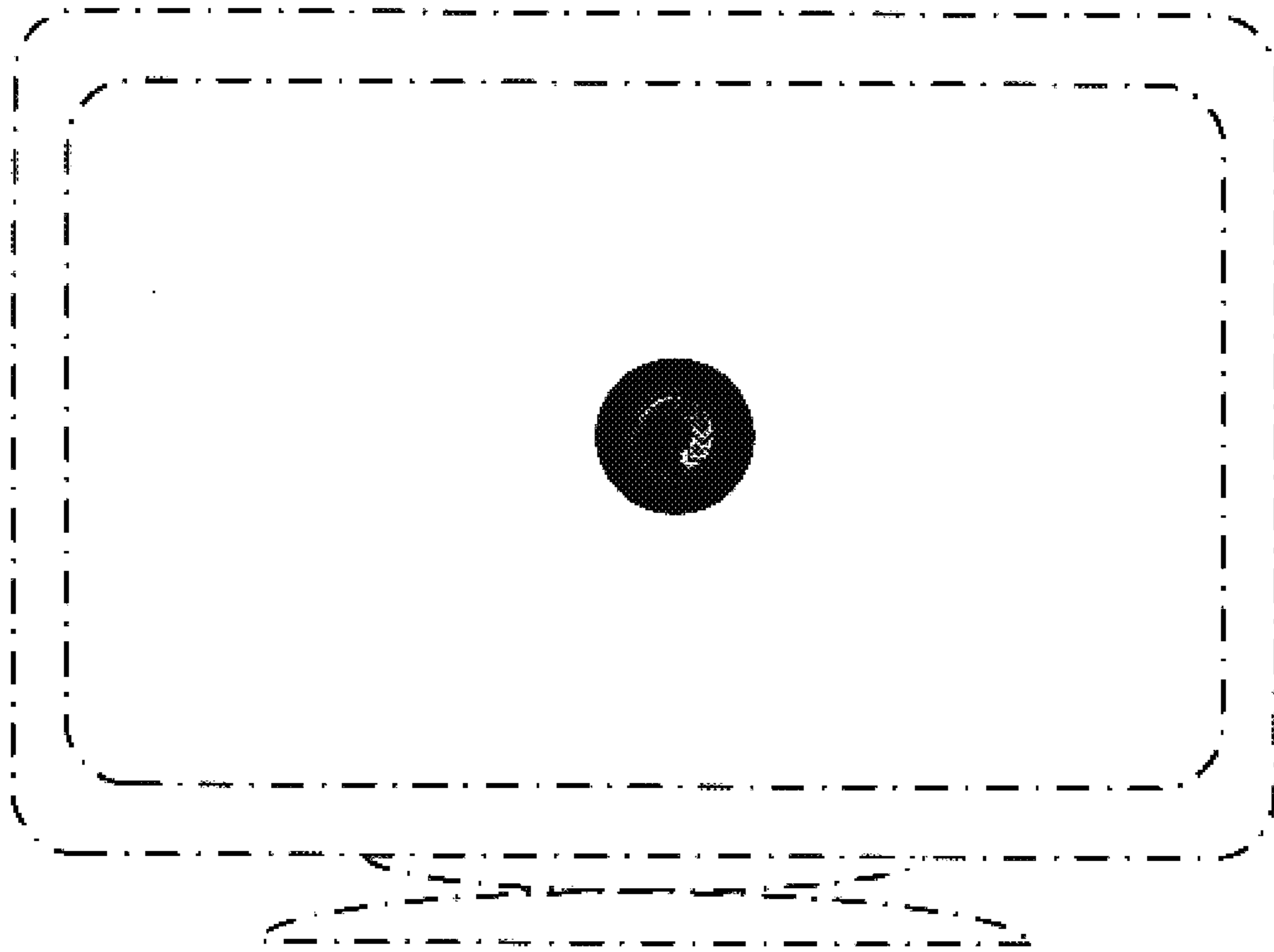

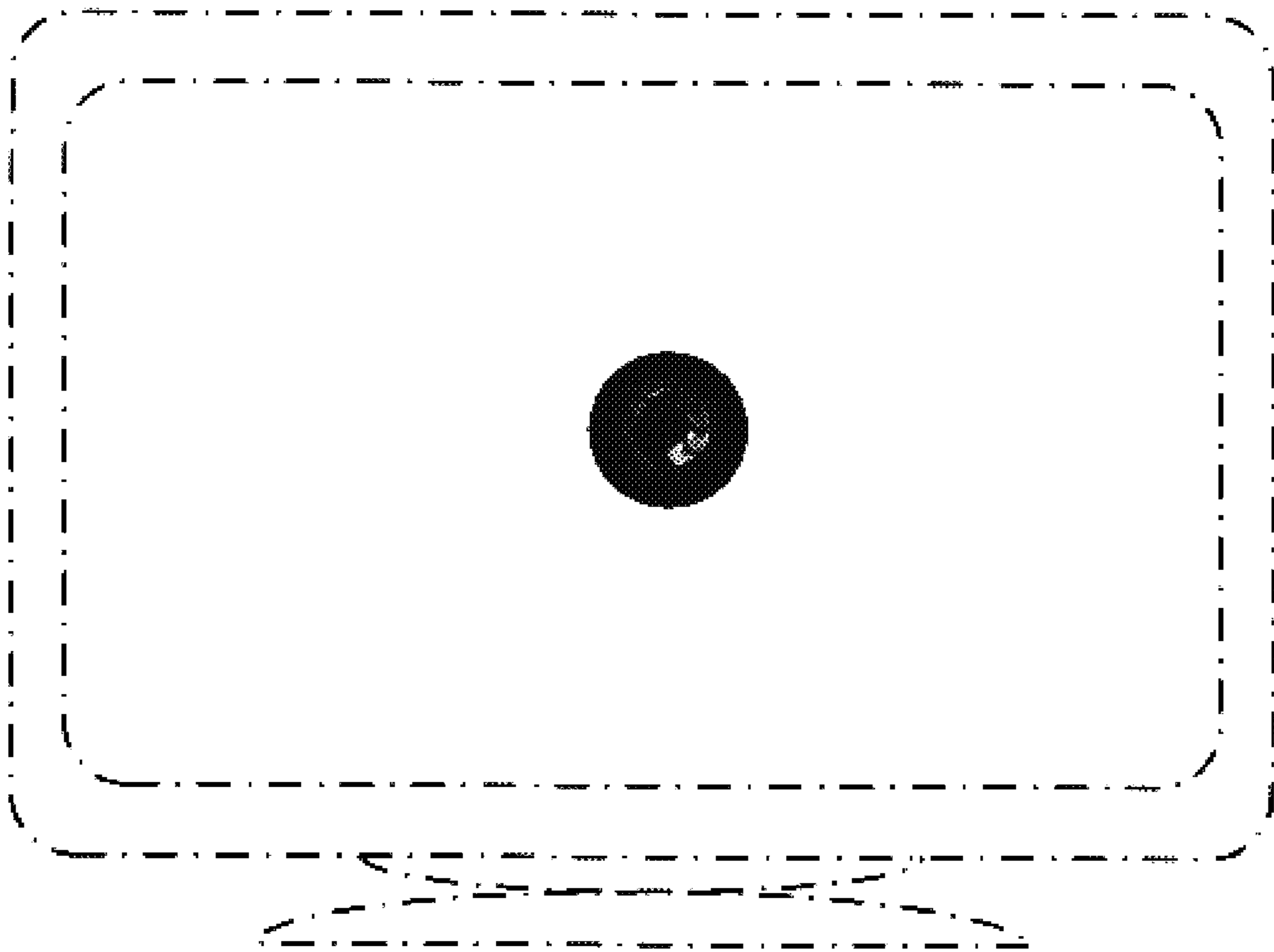

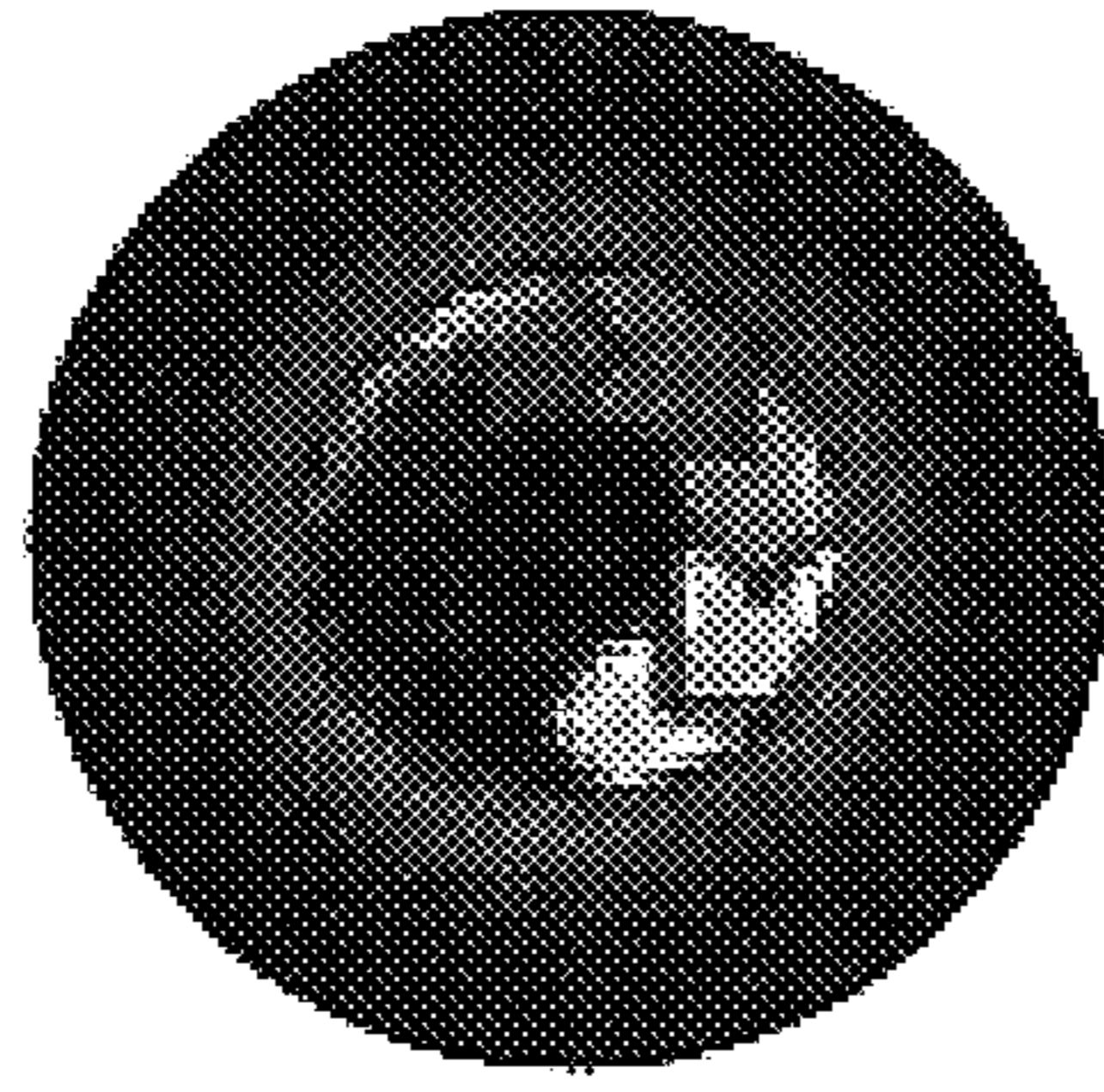

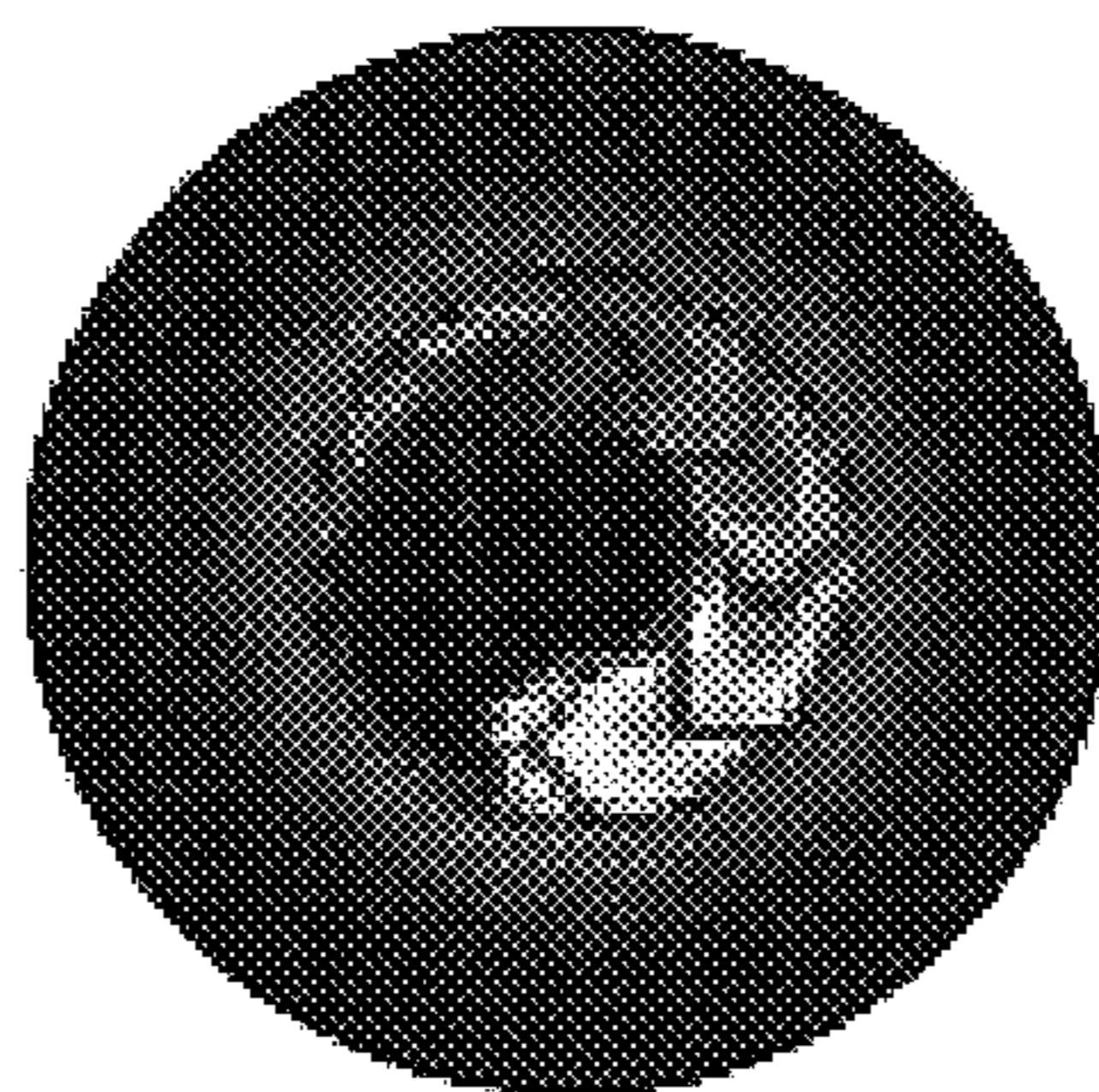

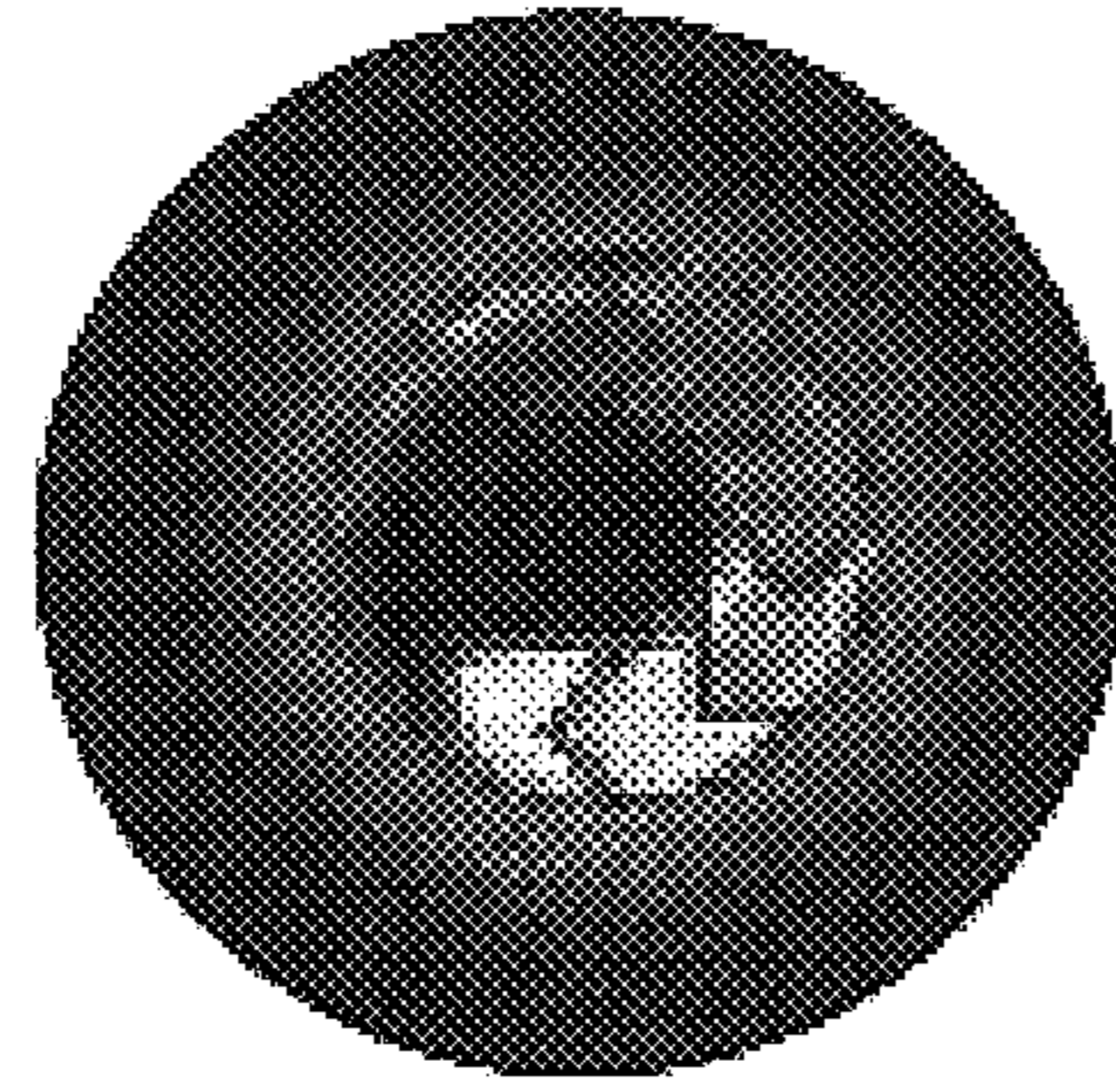

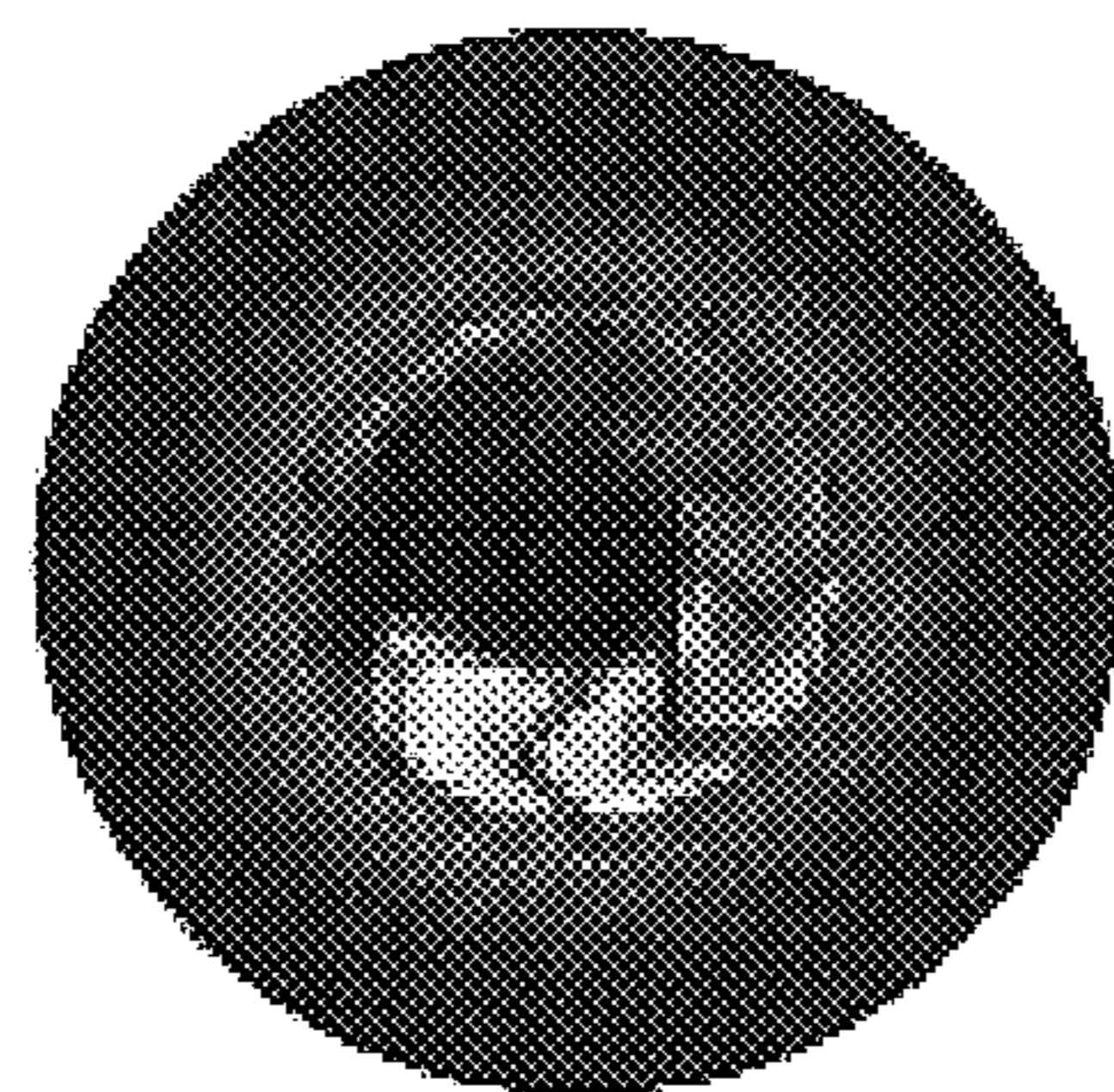

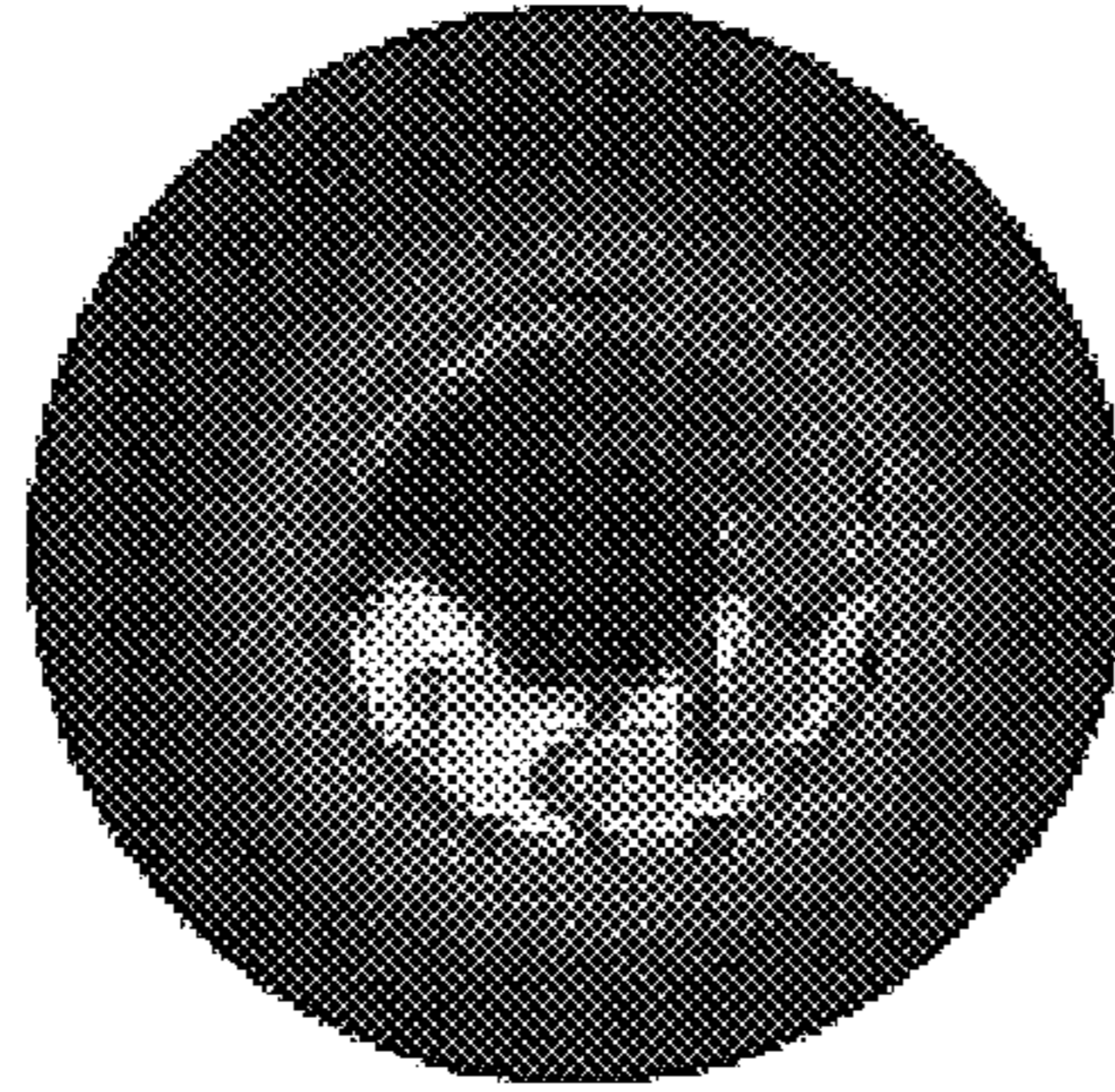

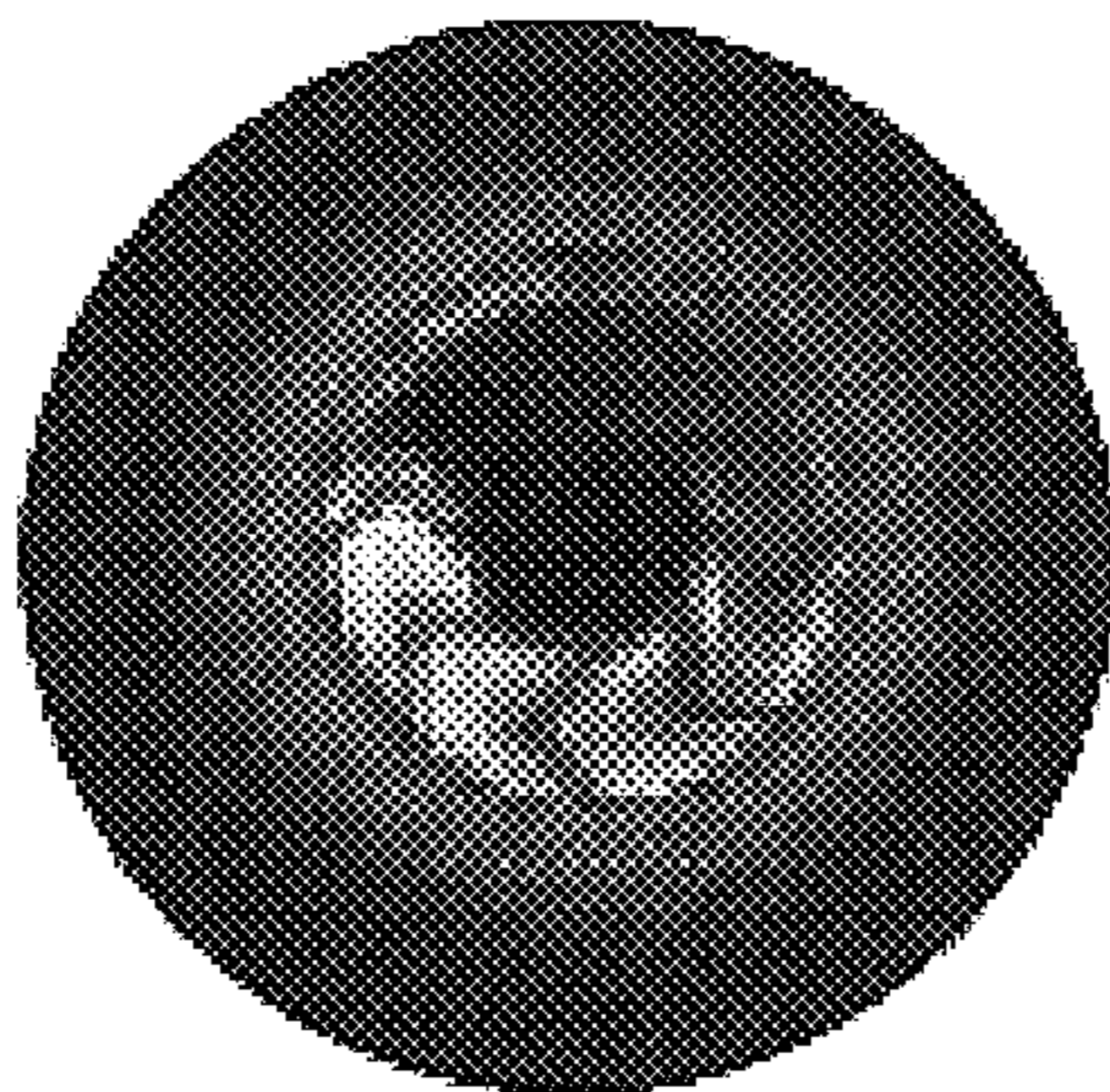

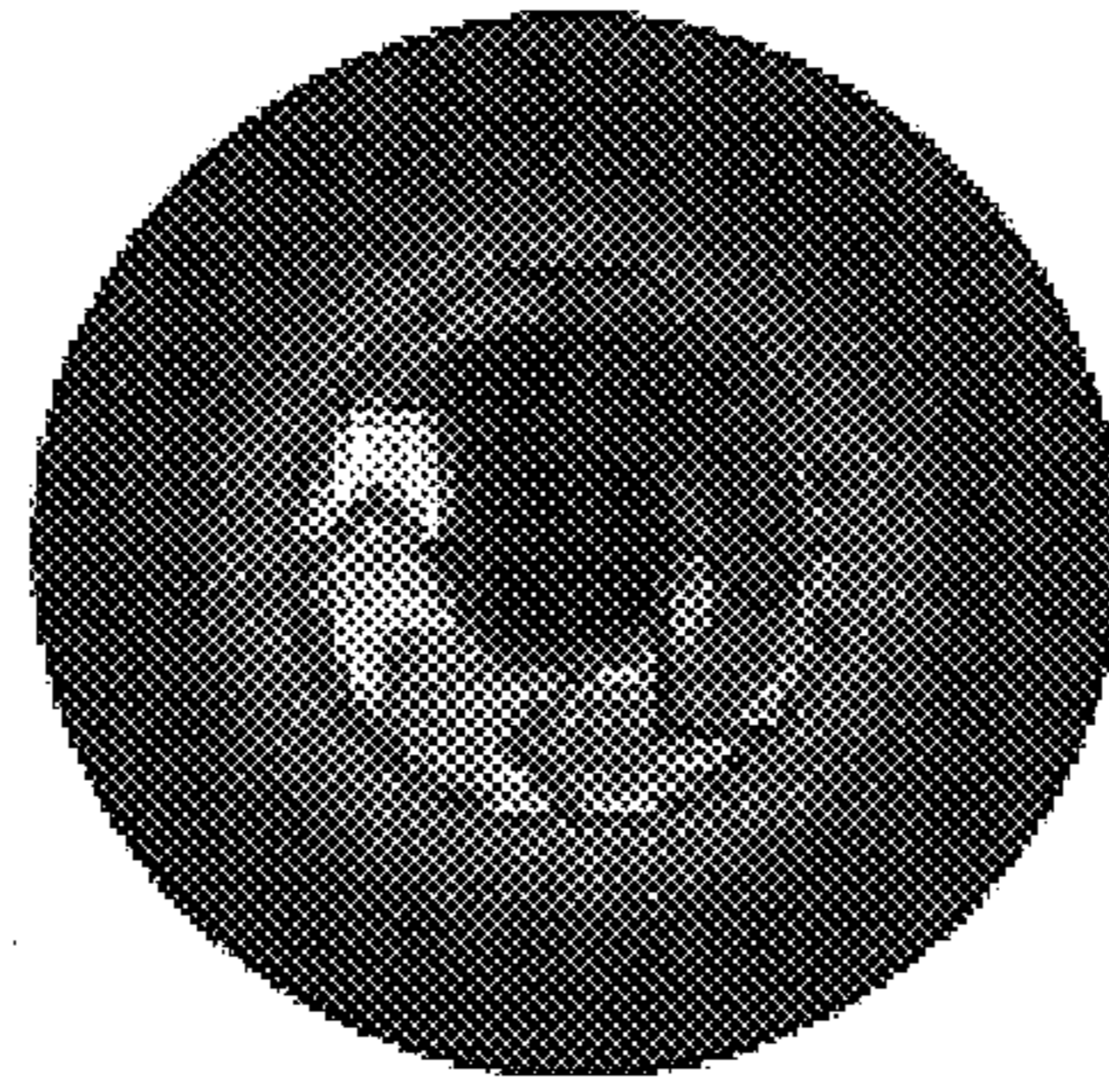

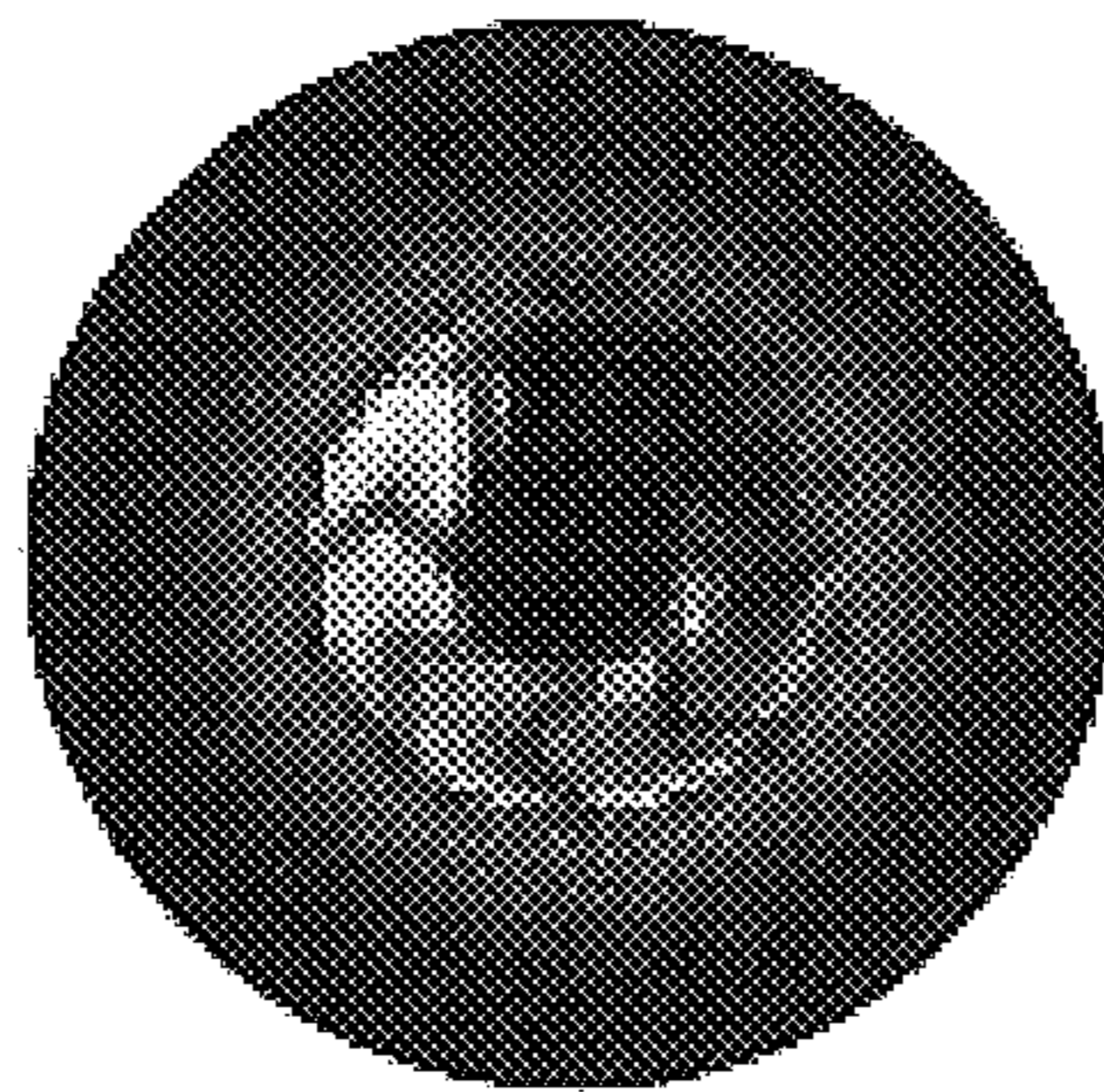

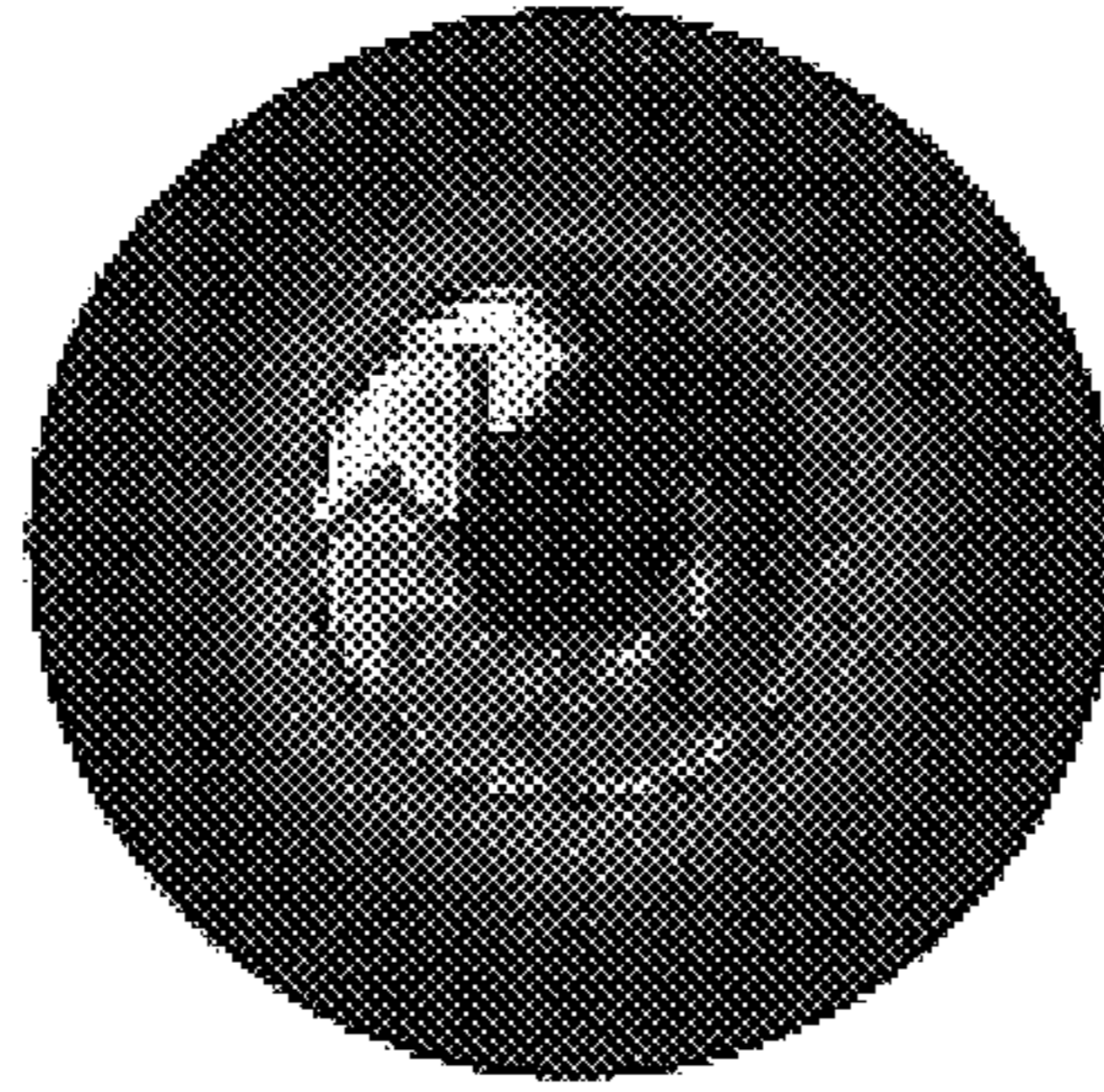

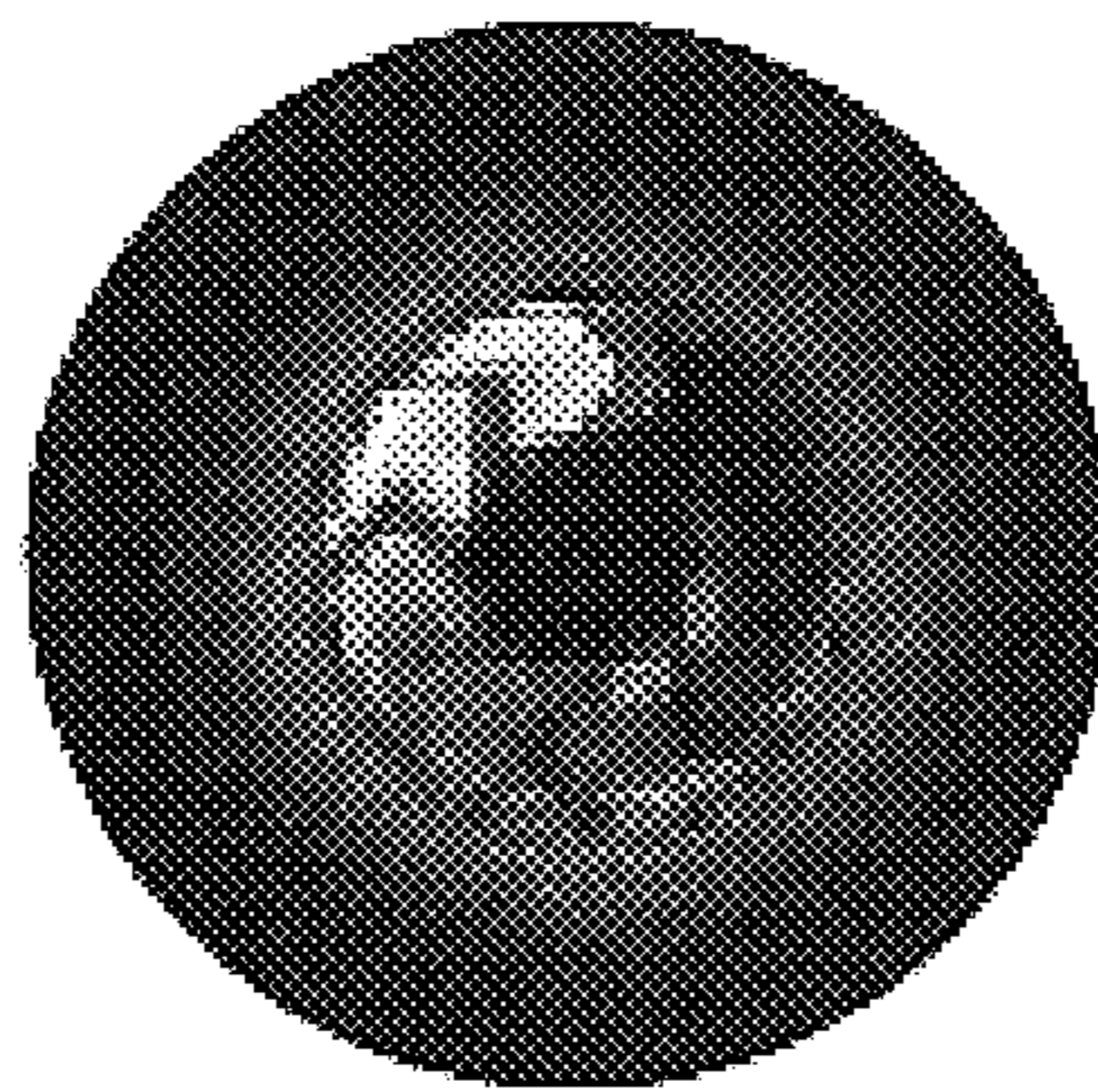

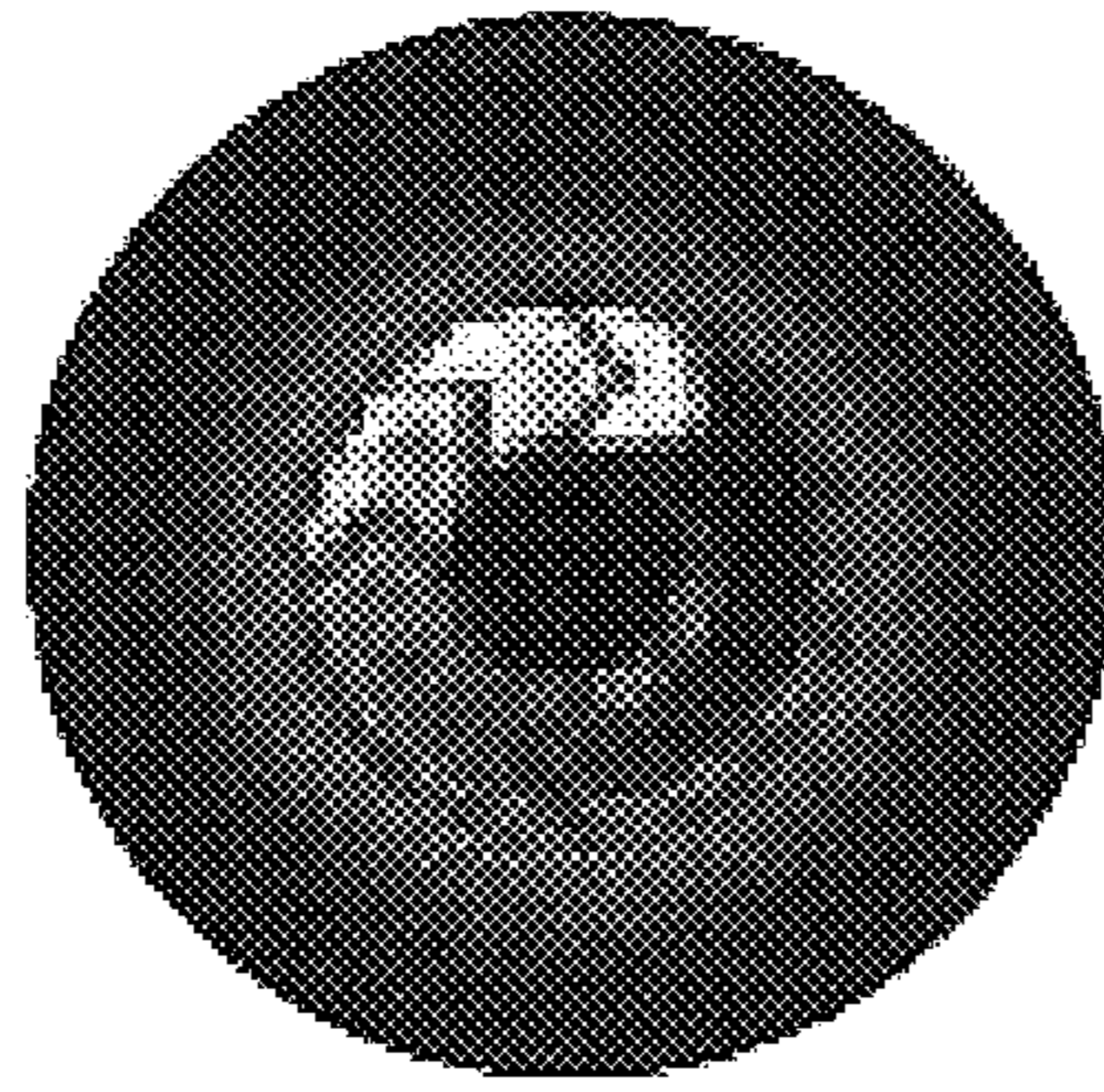

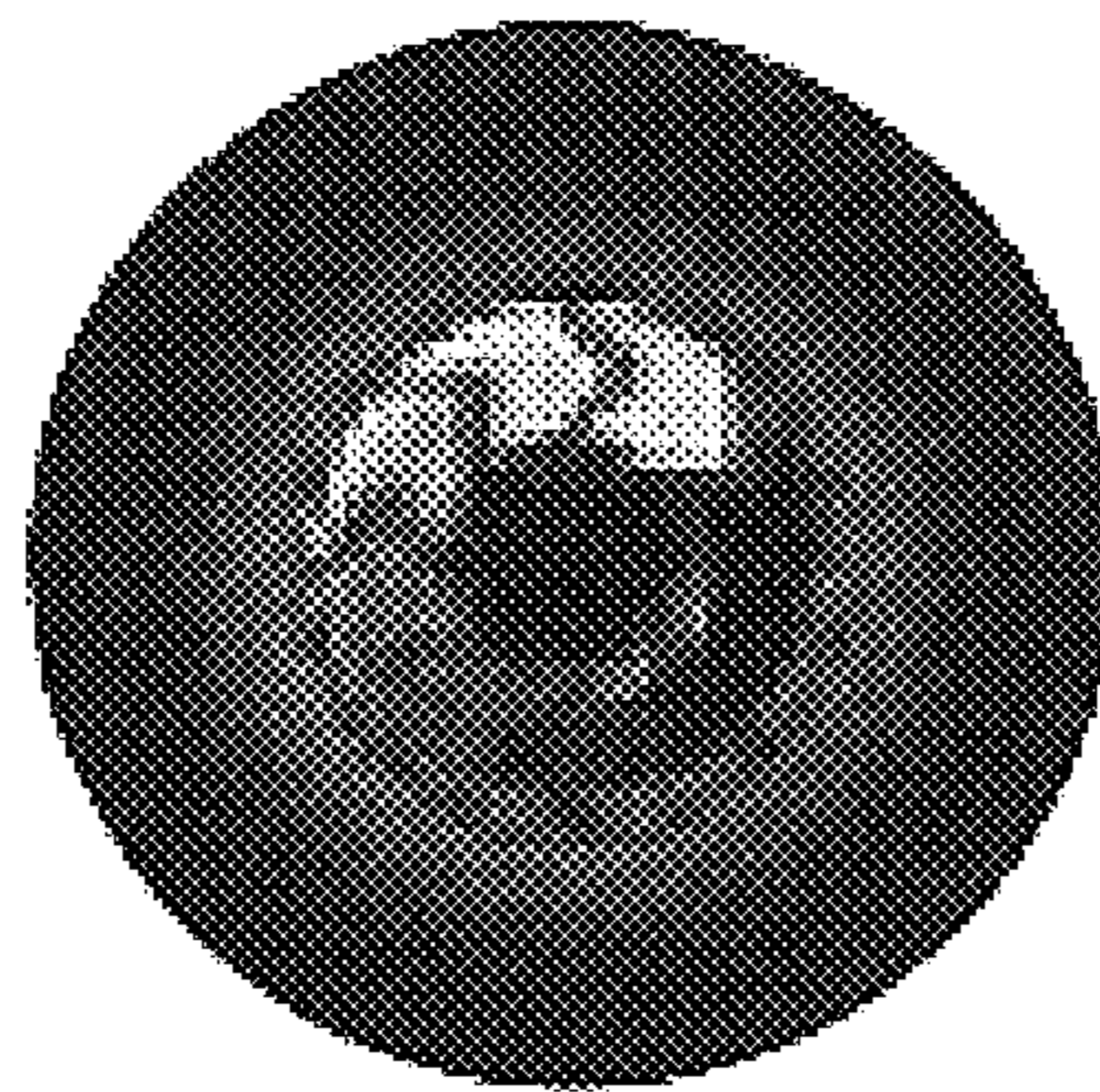

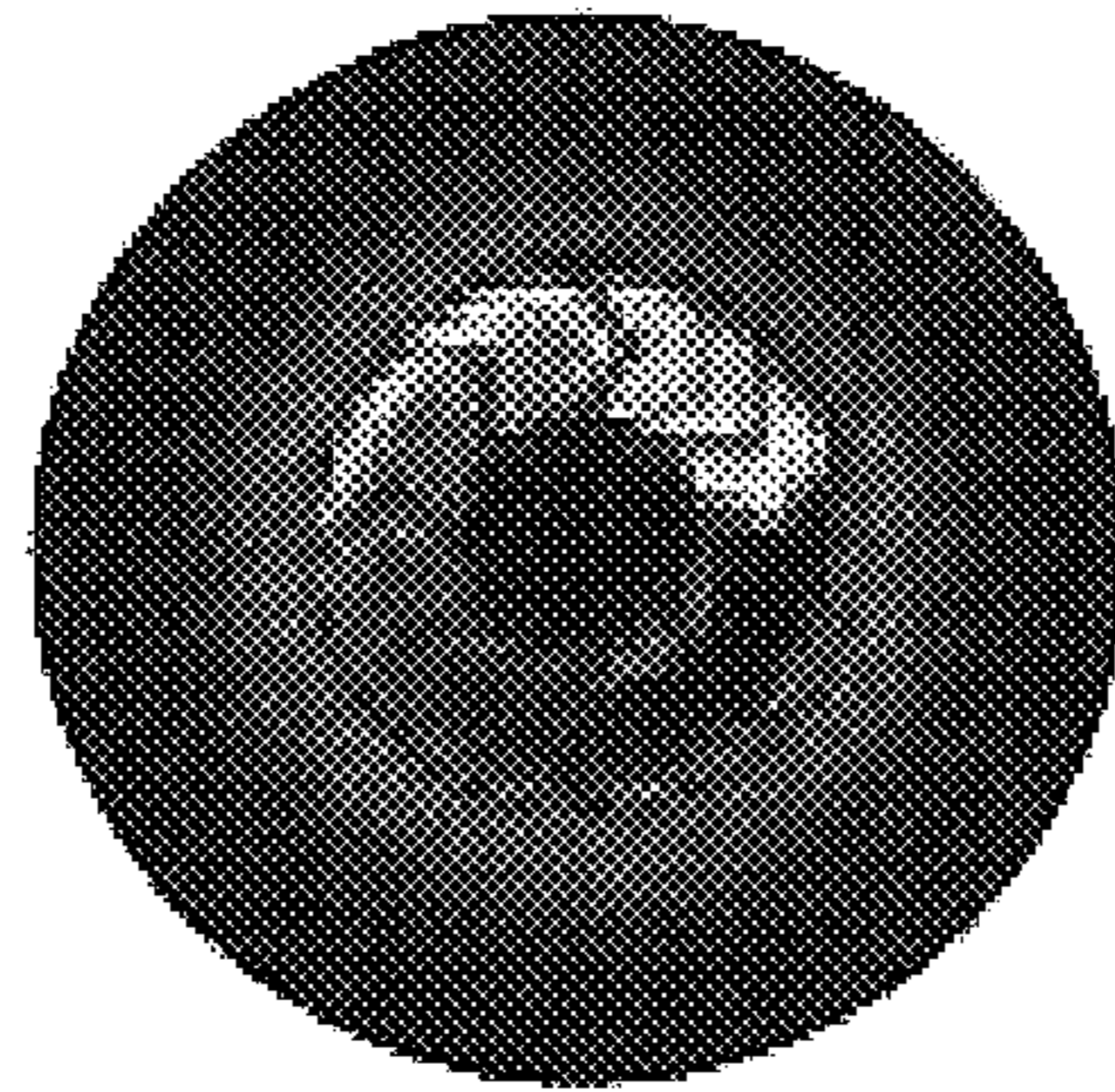

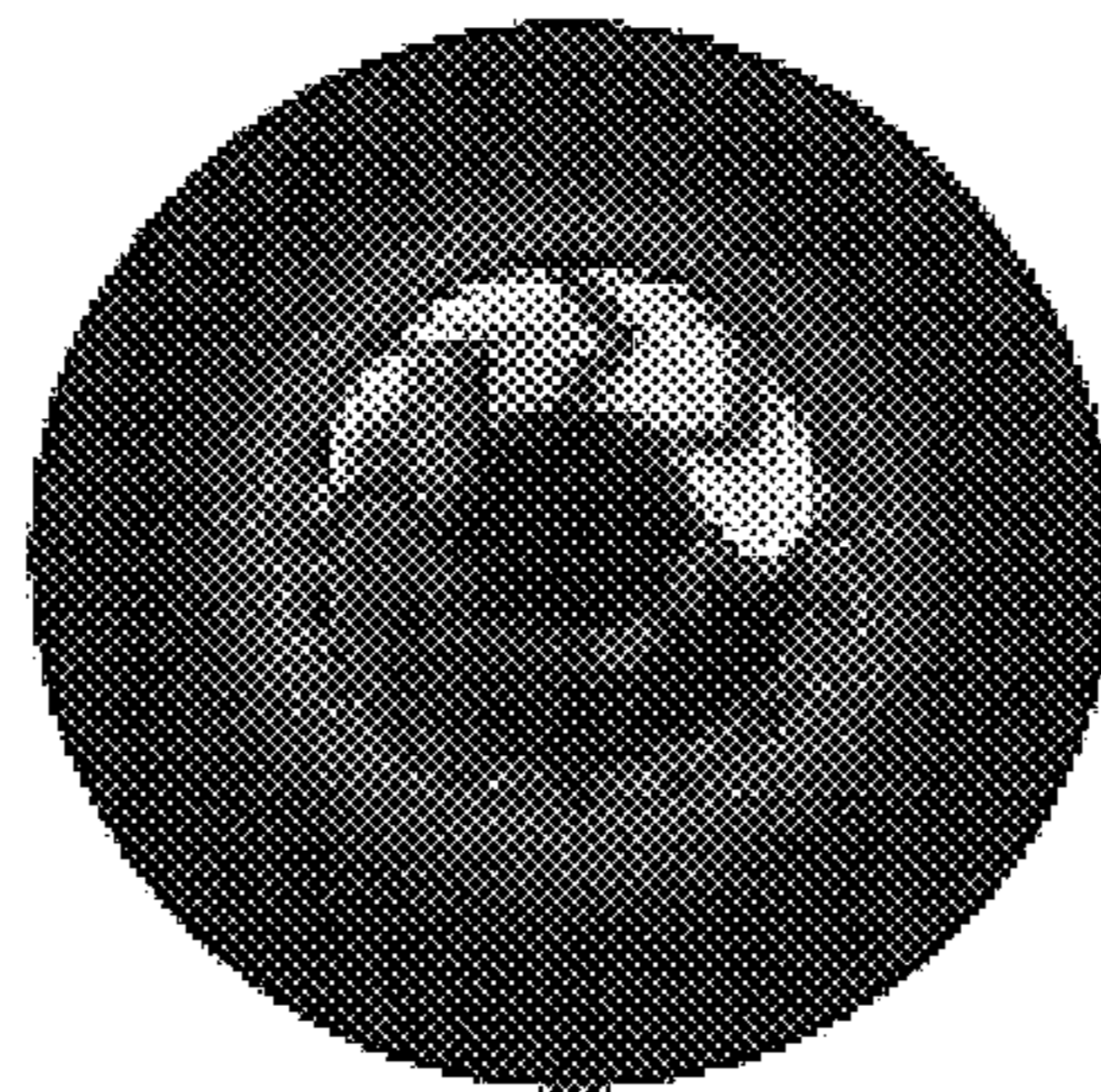

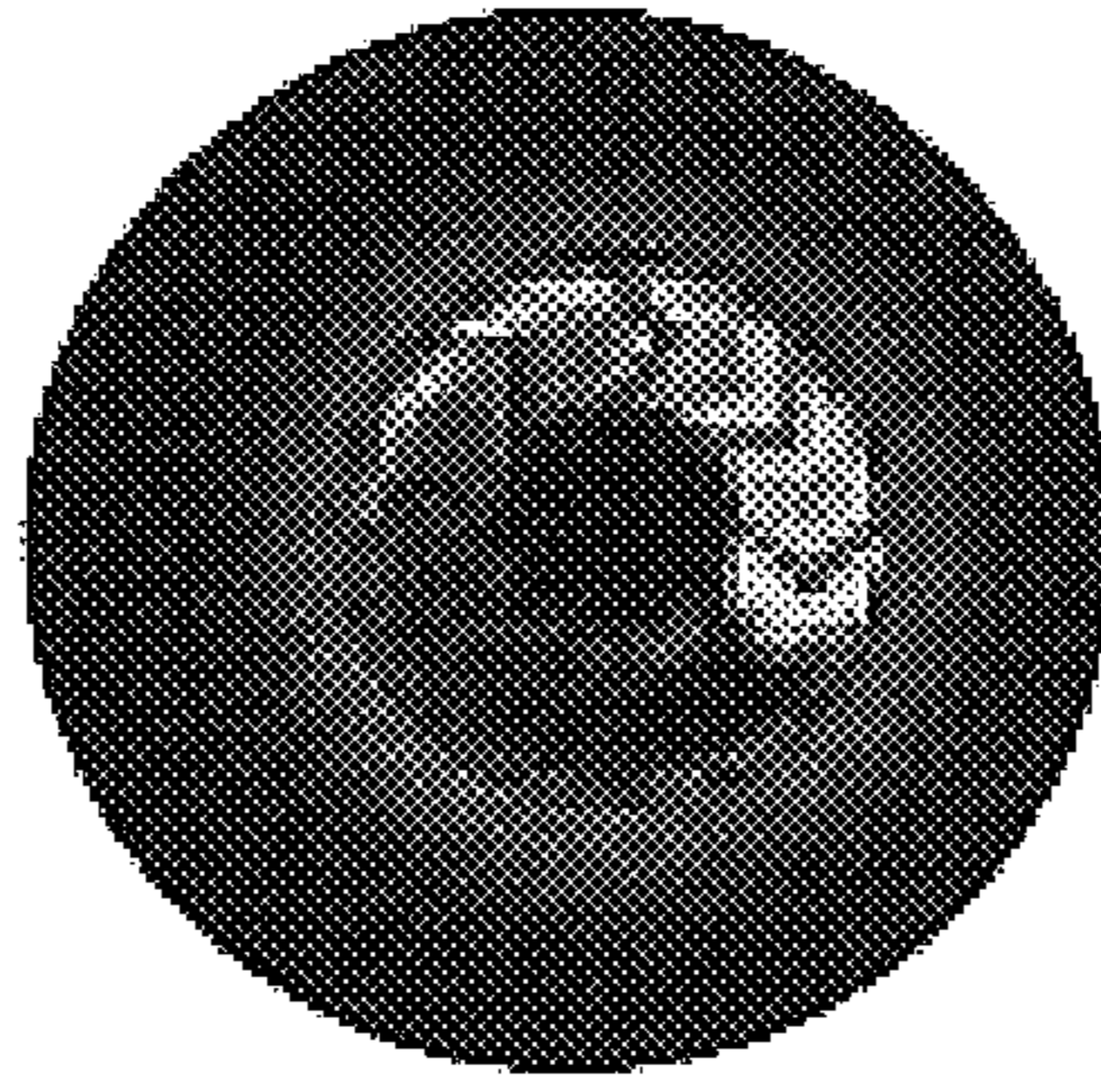

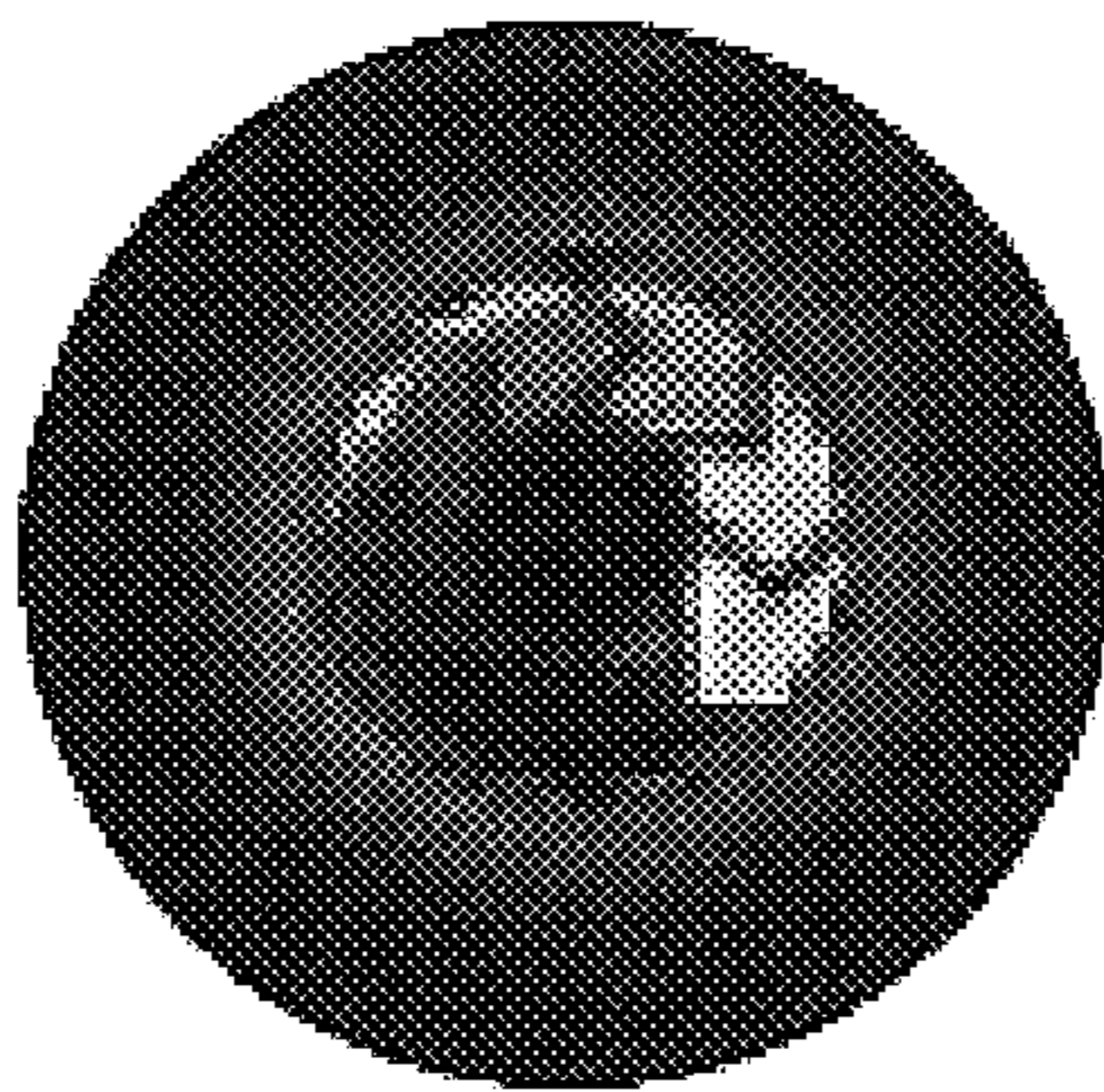

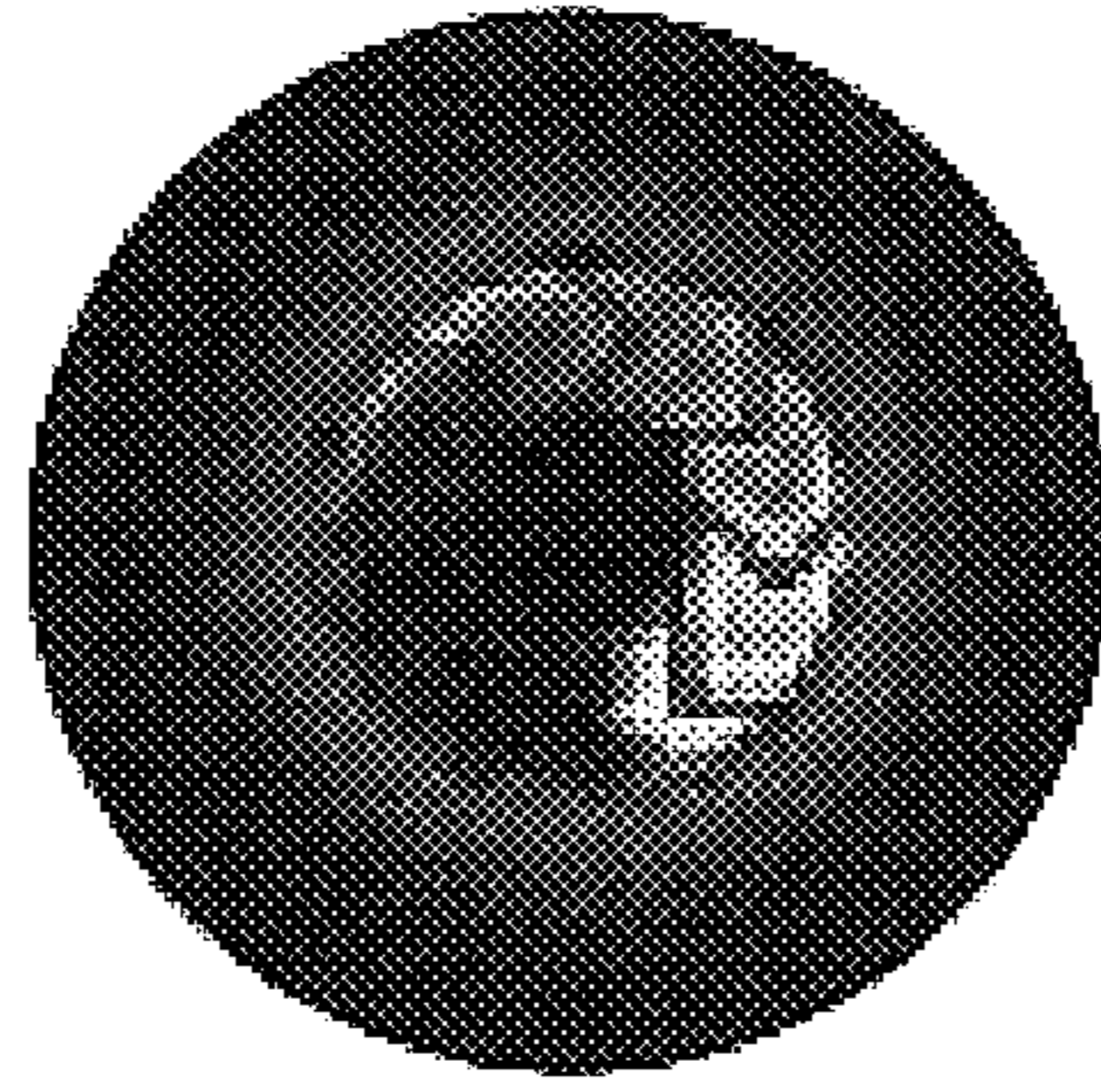

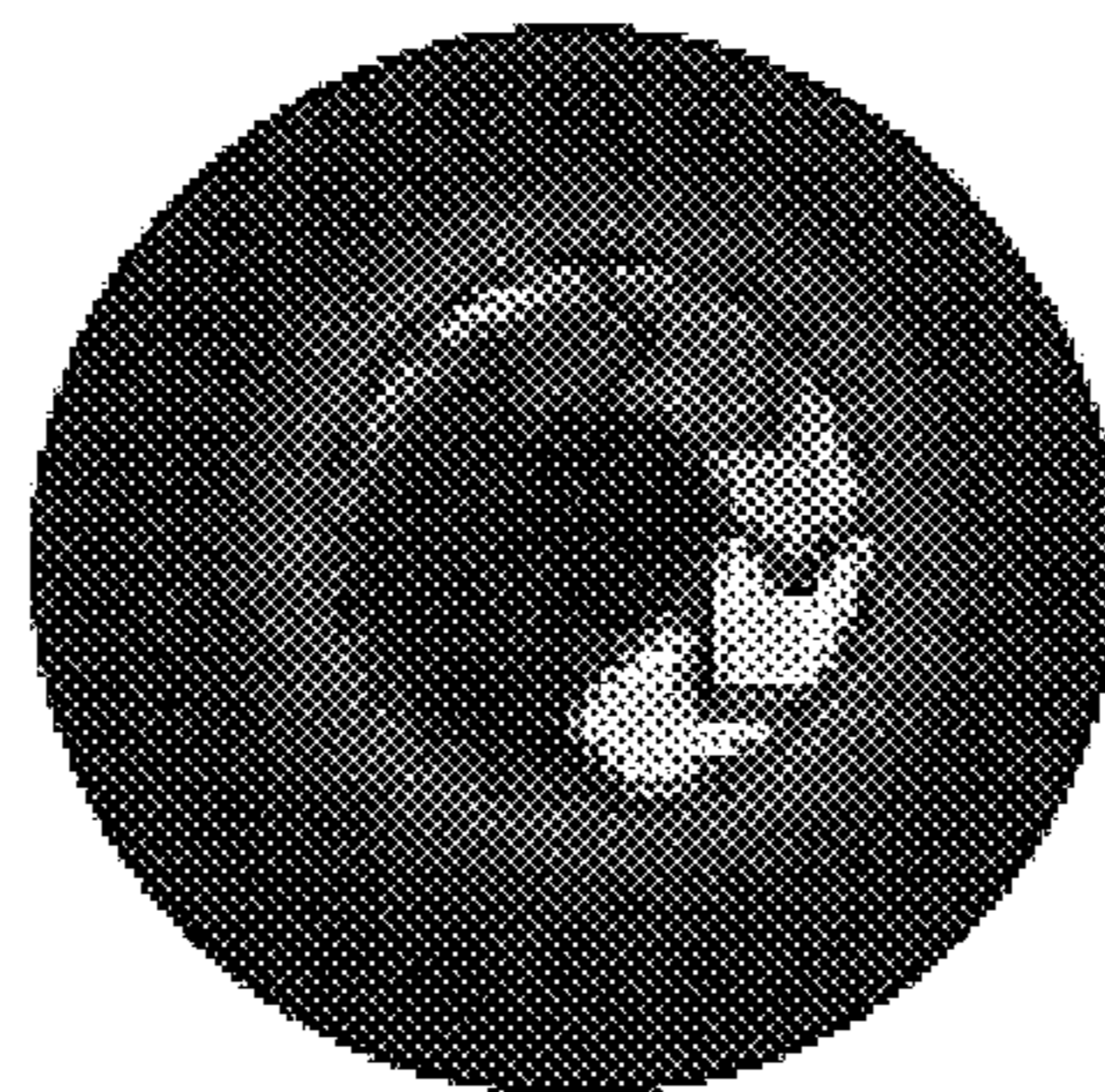
