The ornamental design for a liquid spray applicator device, as shown and described.

**DESCRIPTION**

FIG. 17 is a right side view of the liquid spray applicator device.

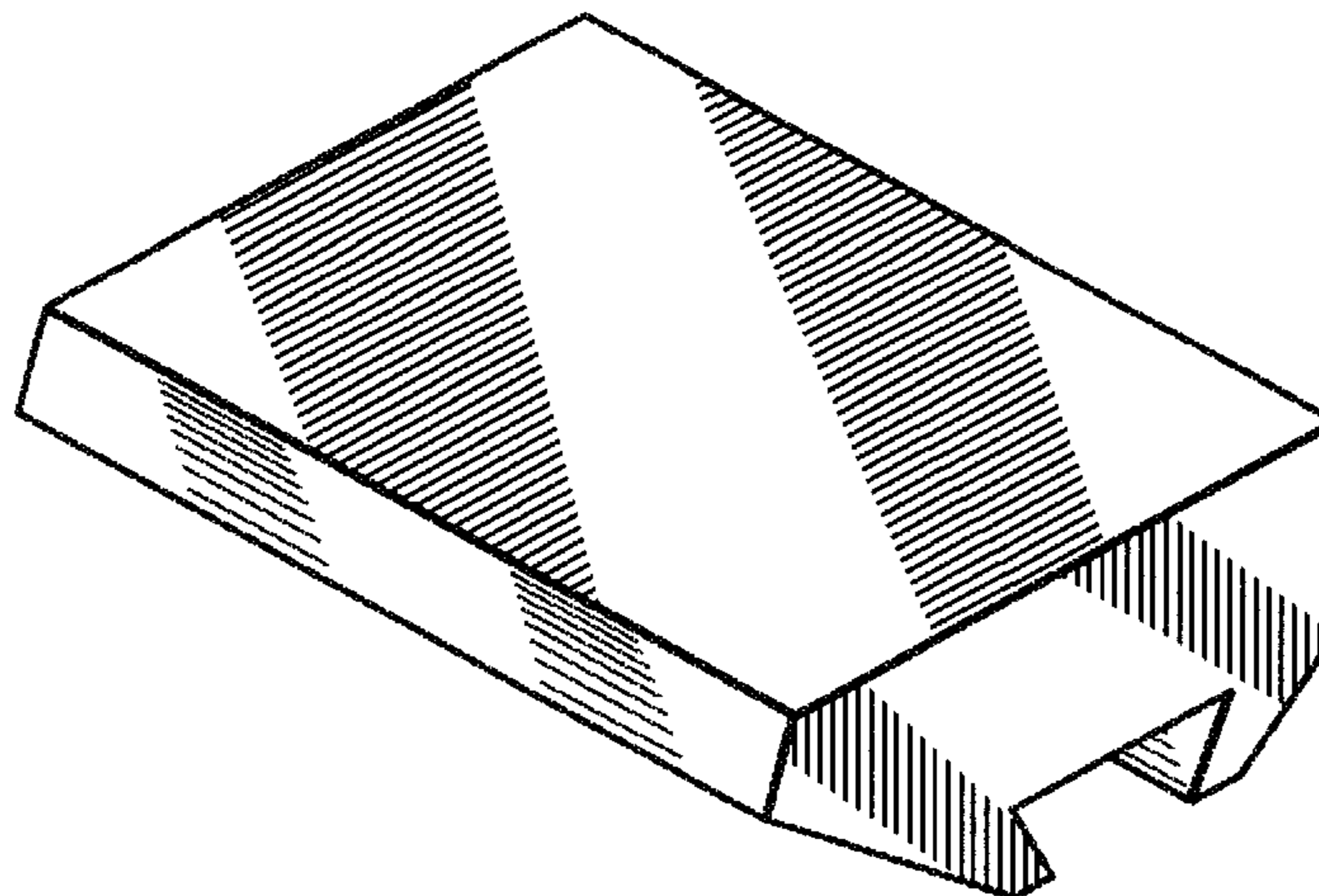
FIG. 18 is a rear view of the liquid spray applicator device.

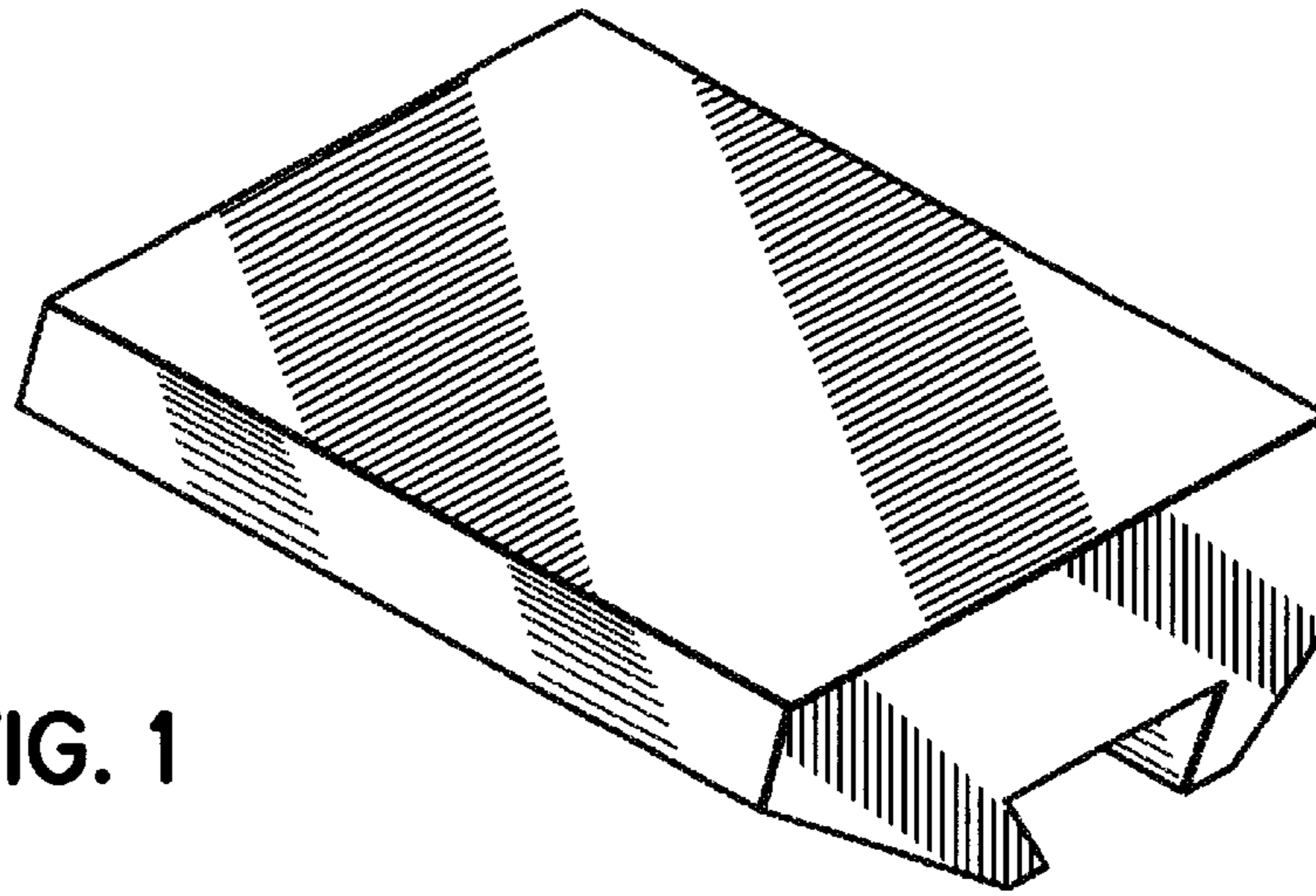

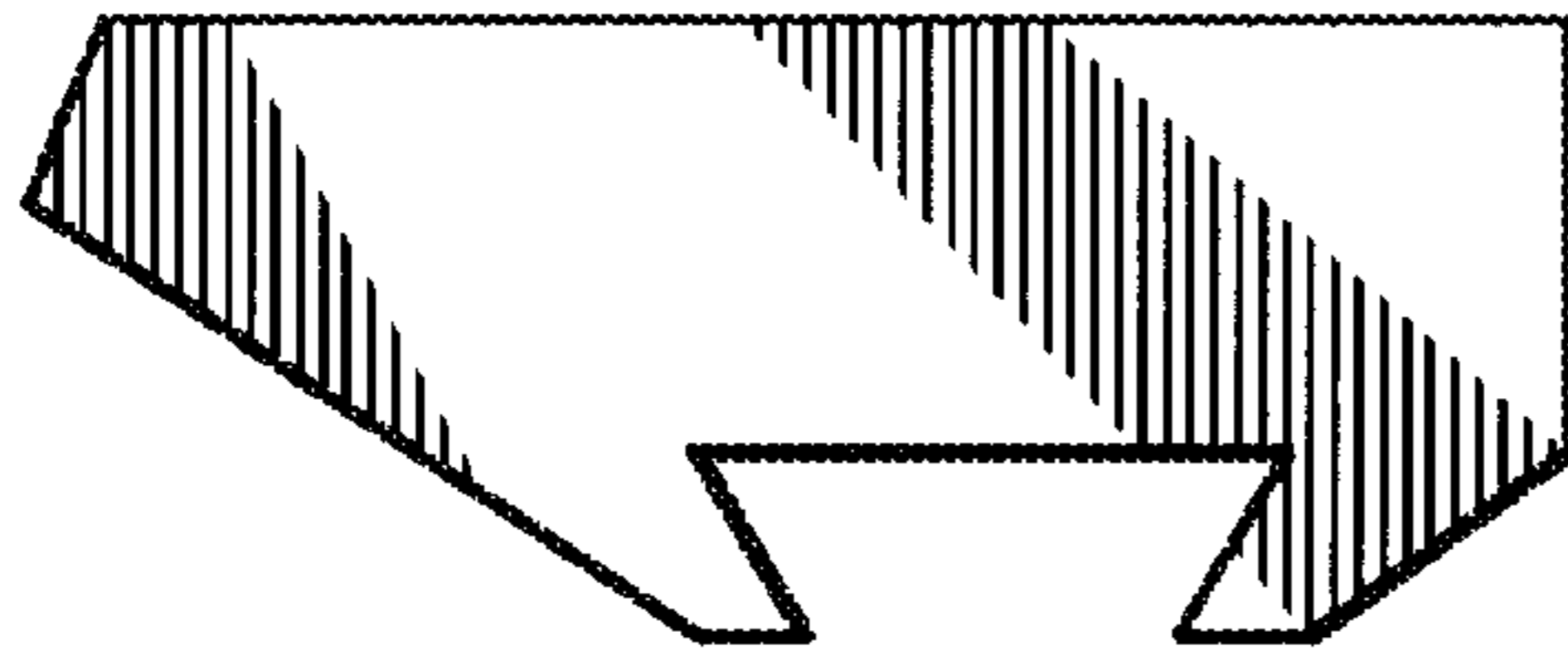

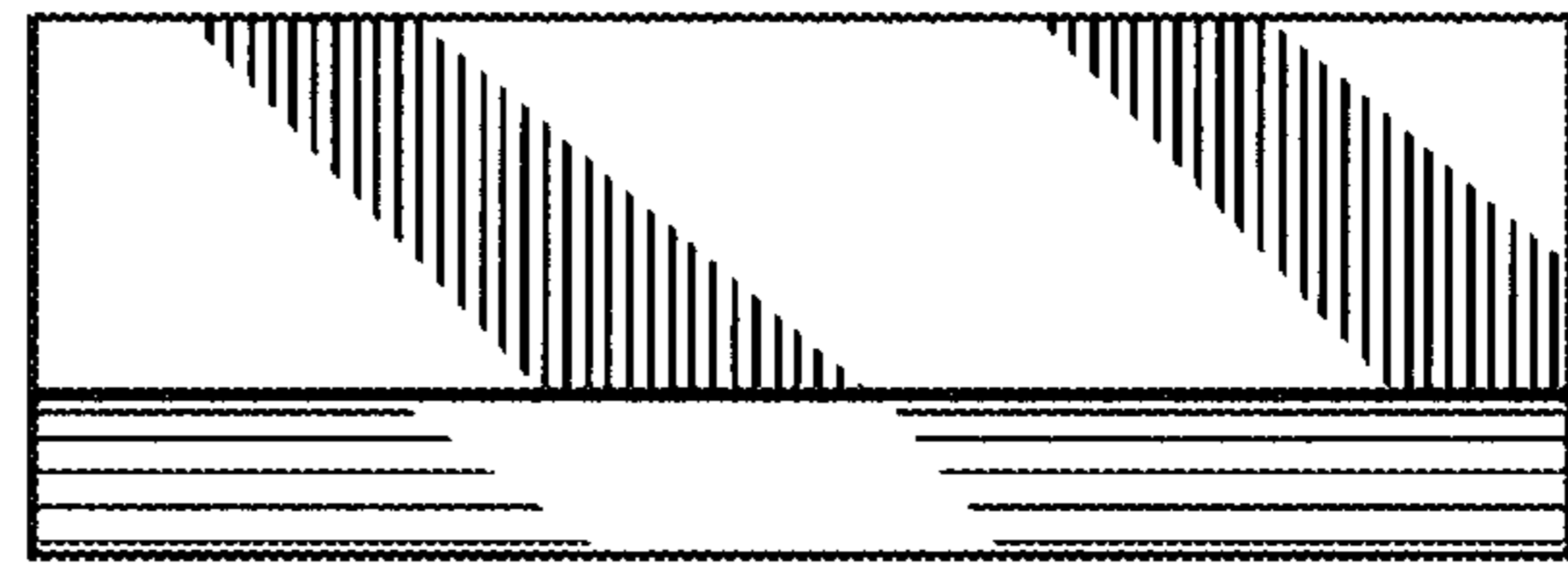

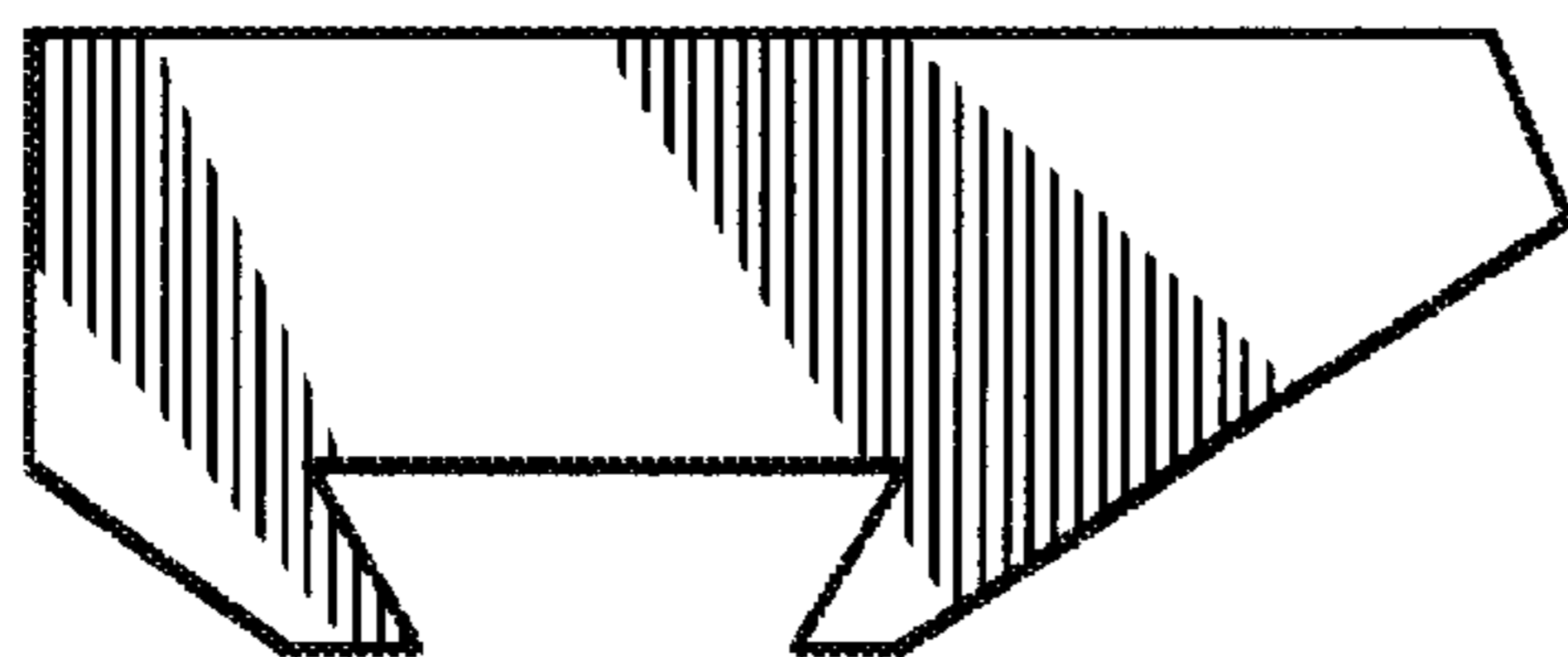

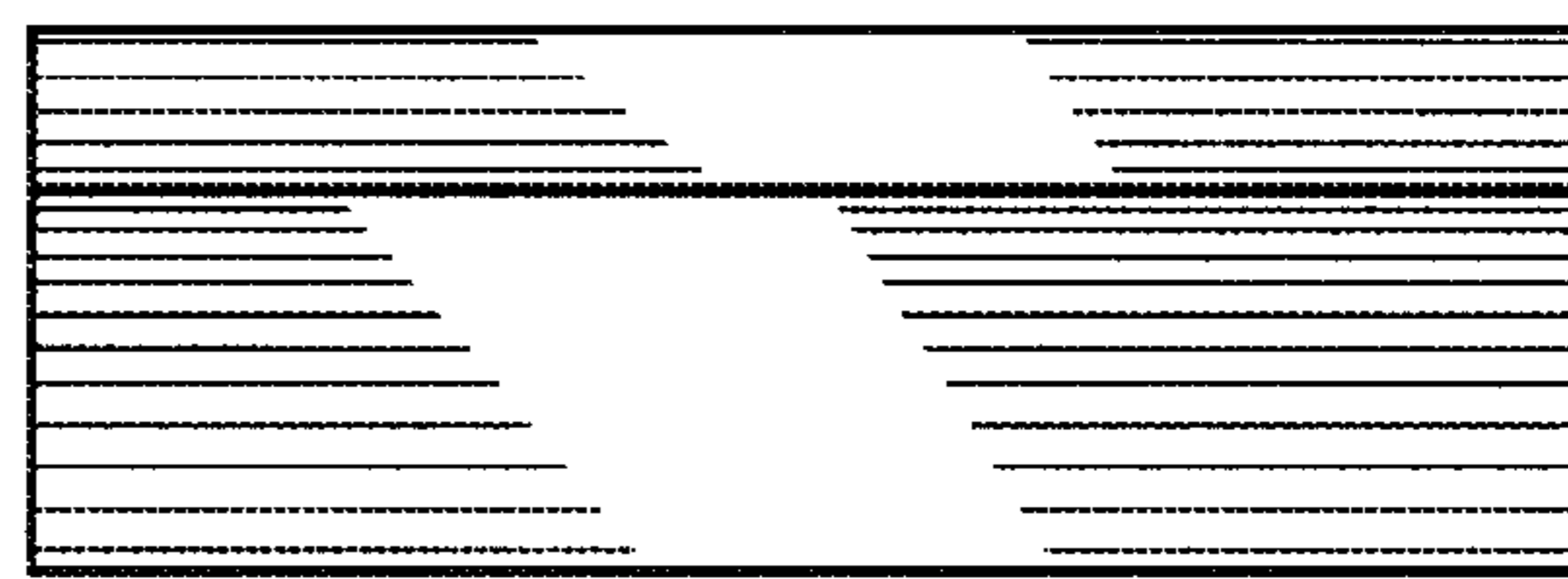

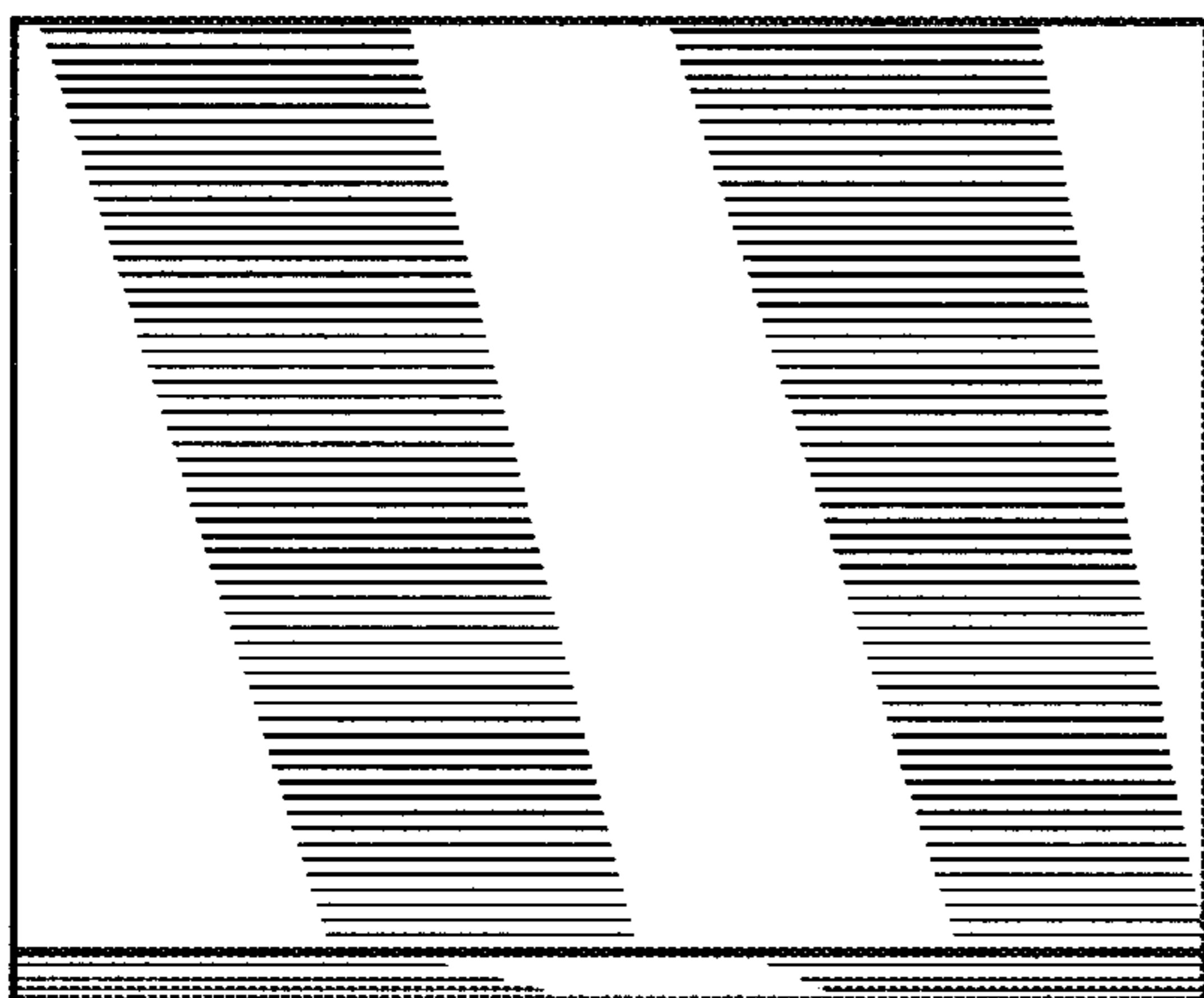

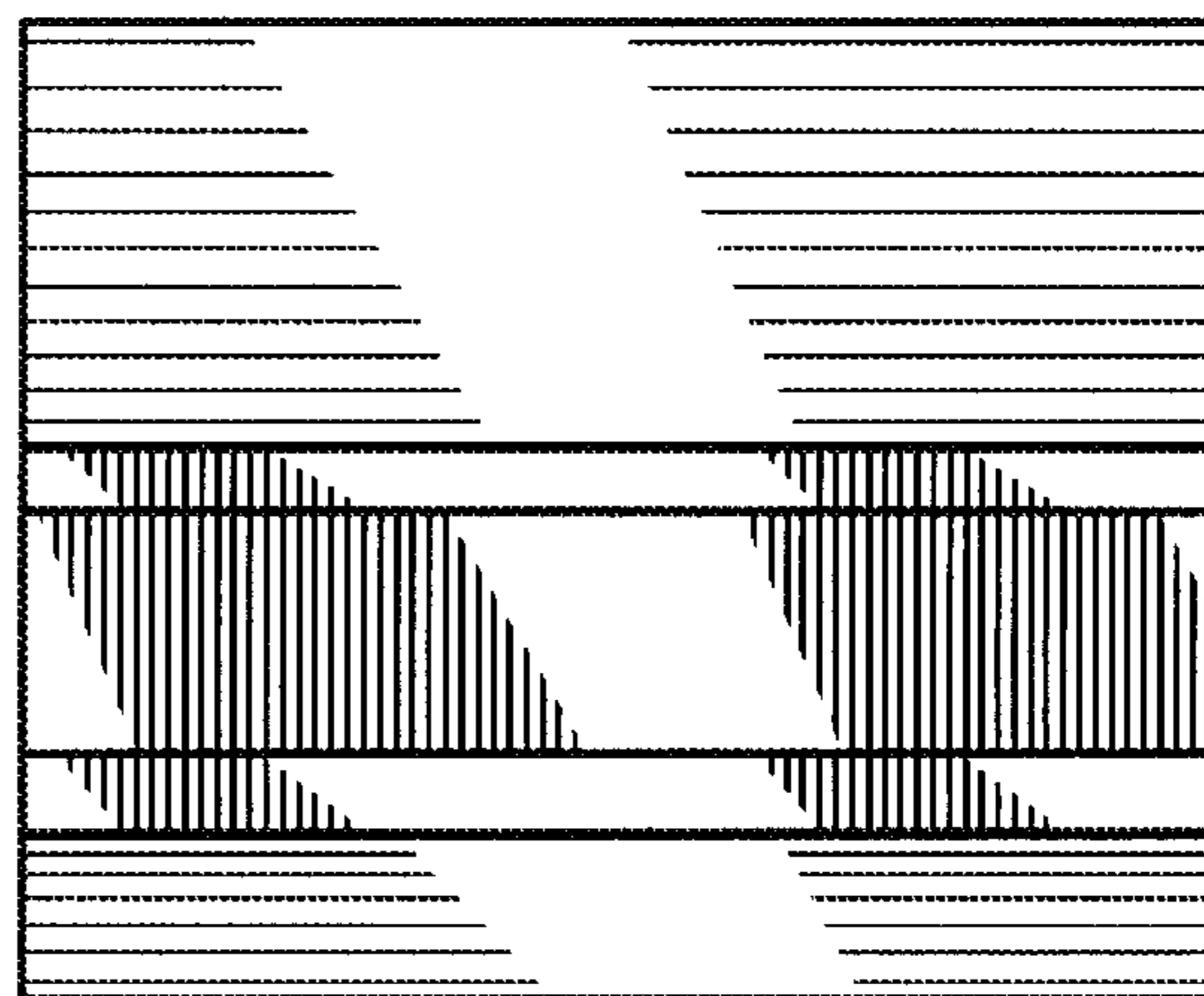

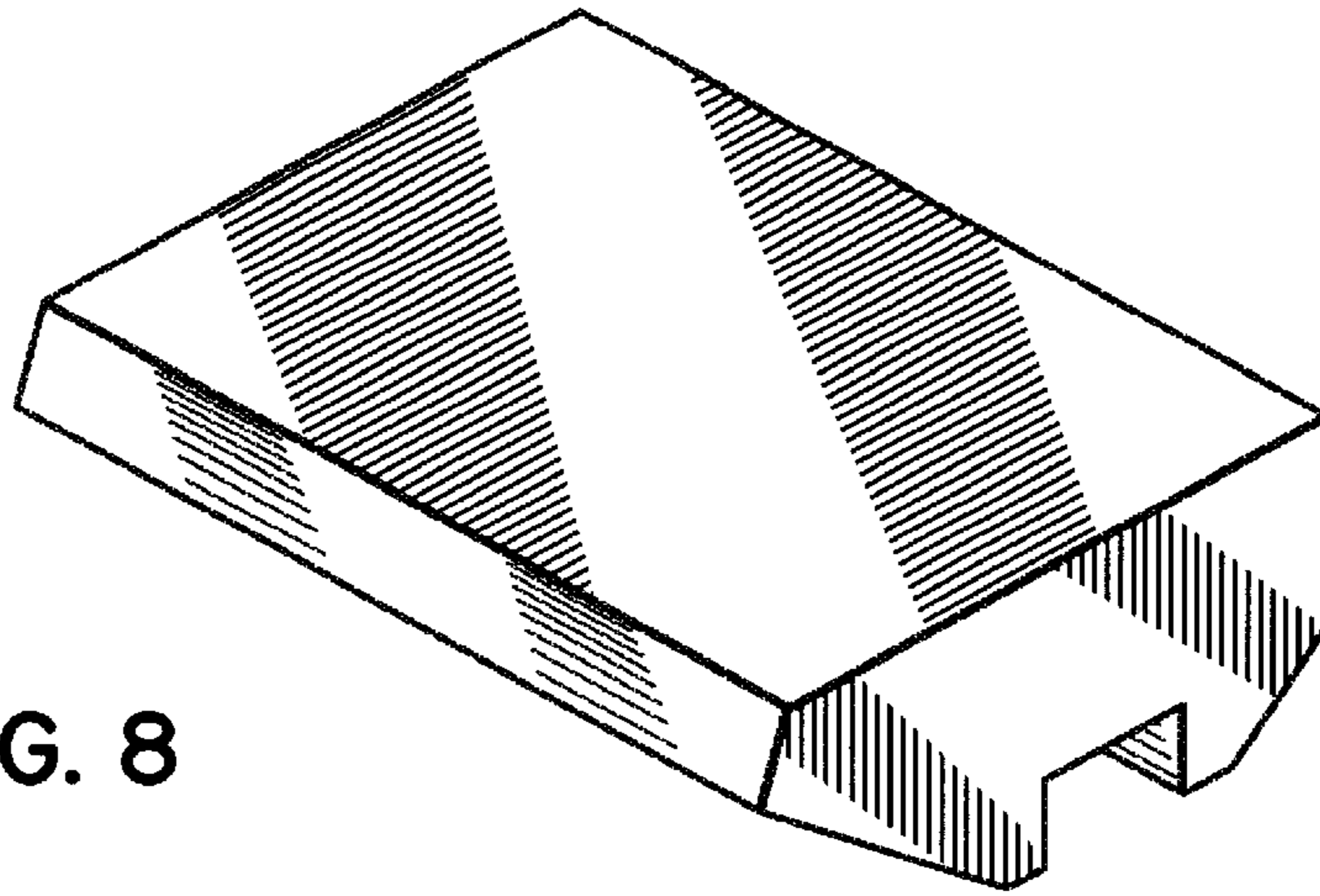

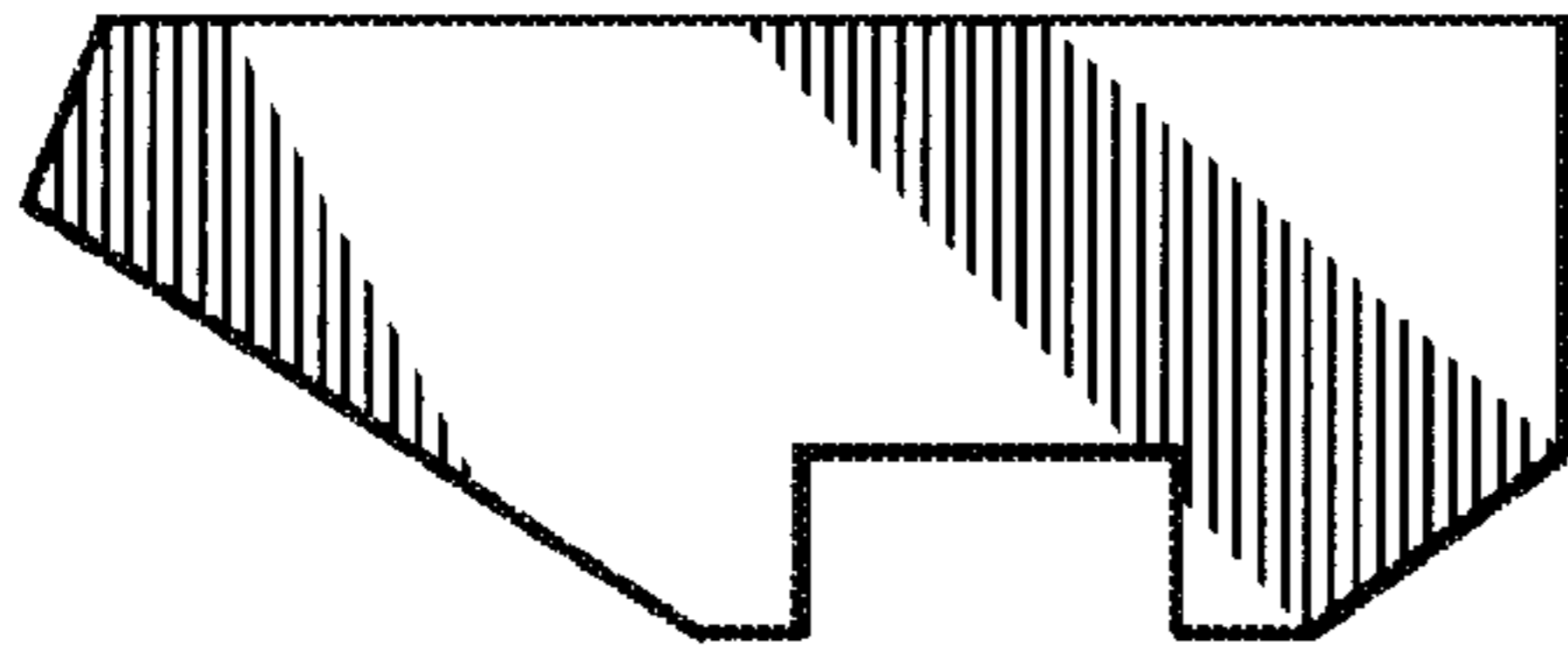

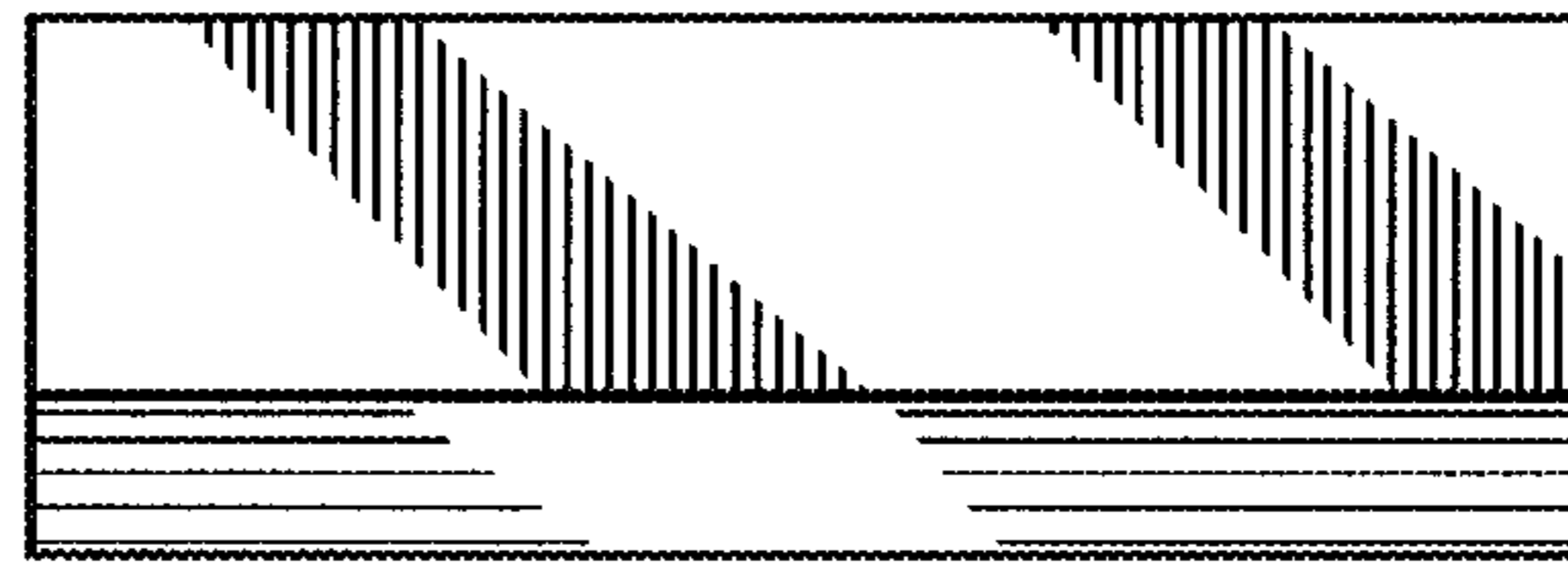

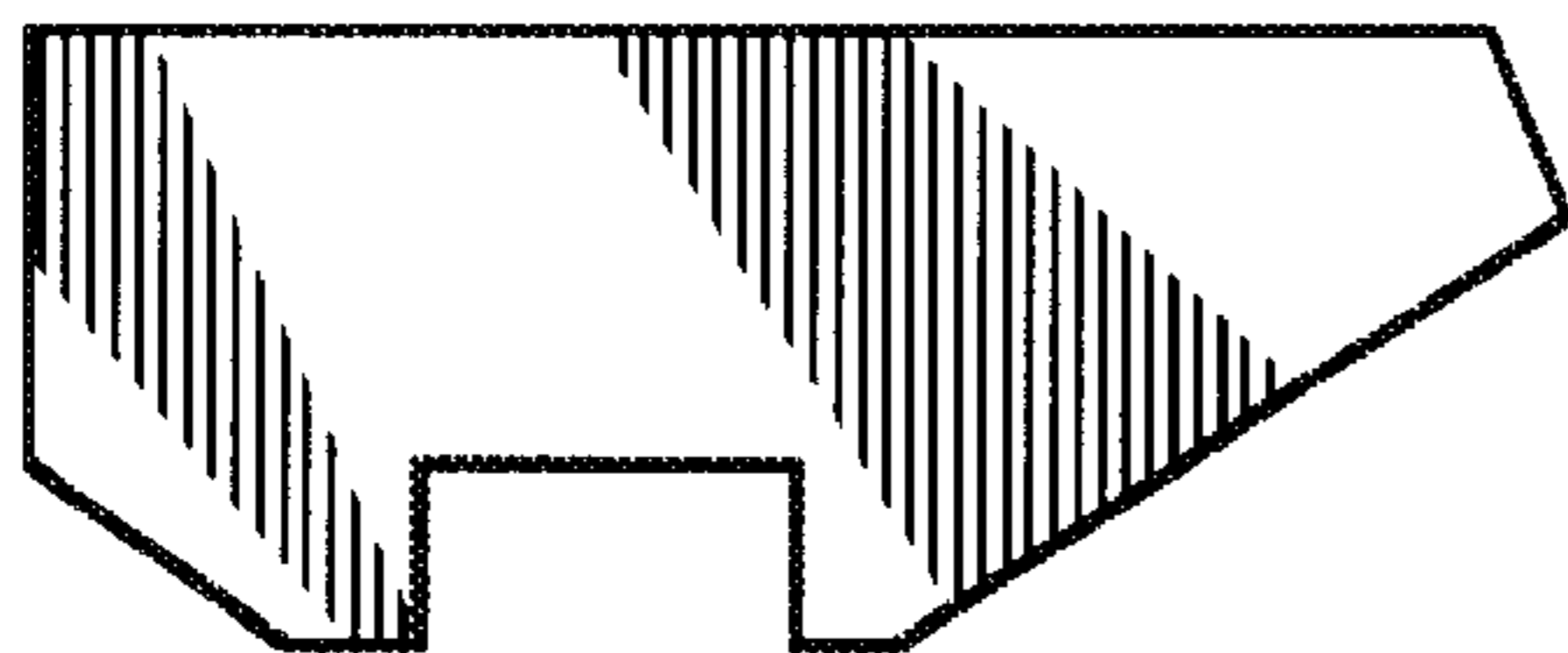

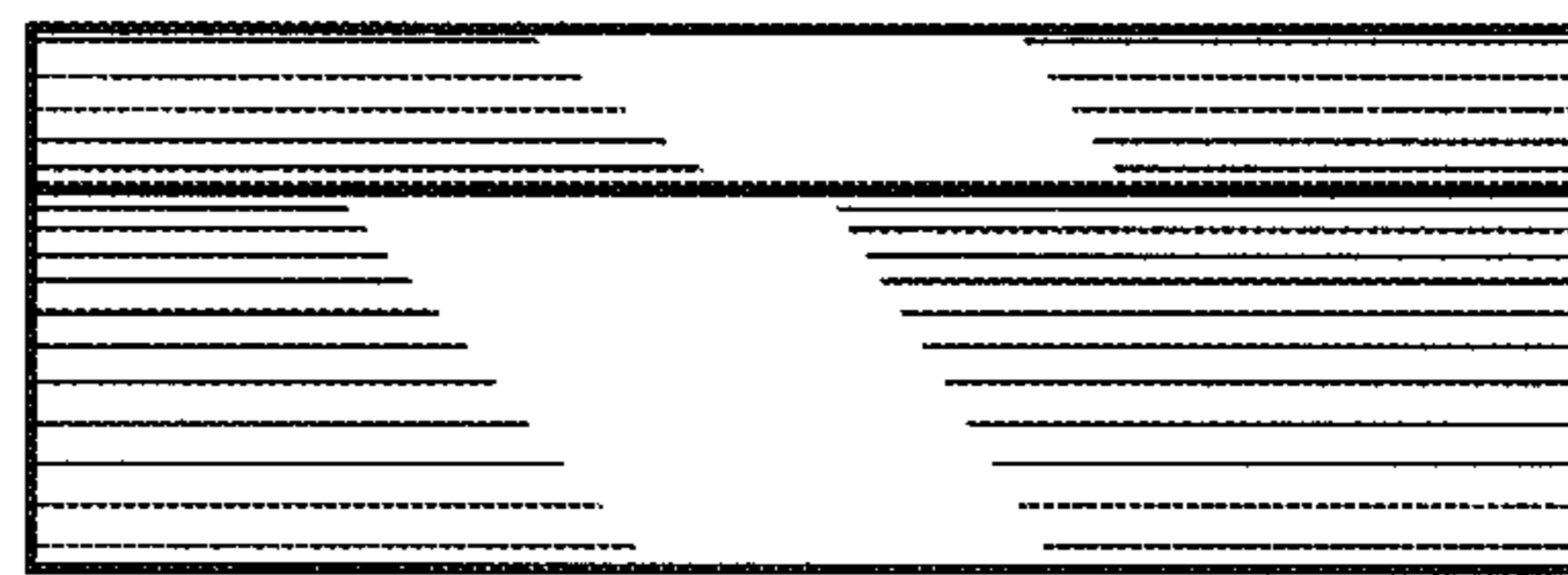

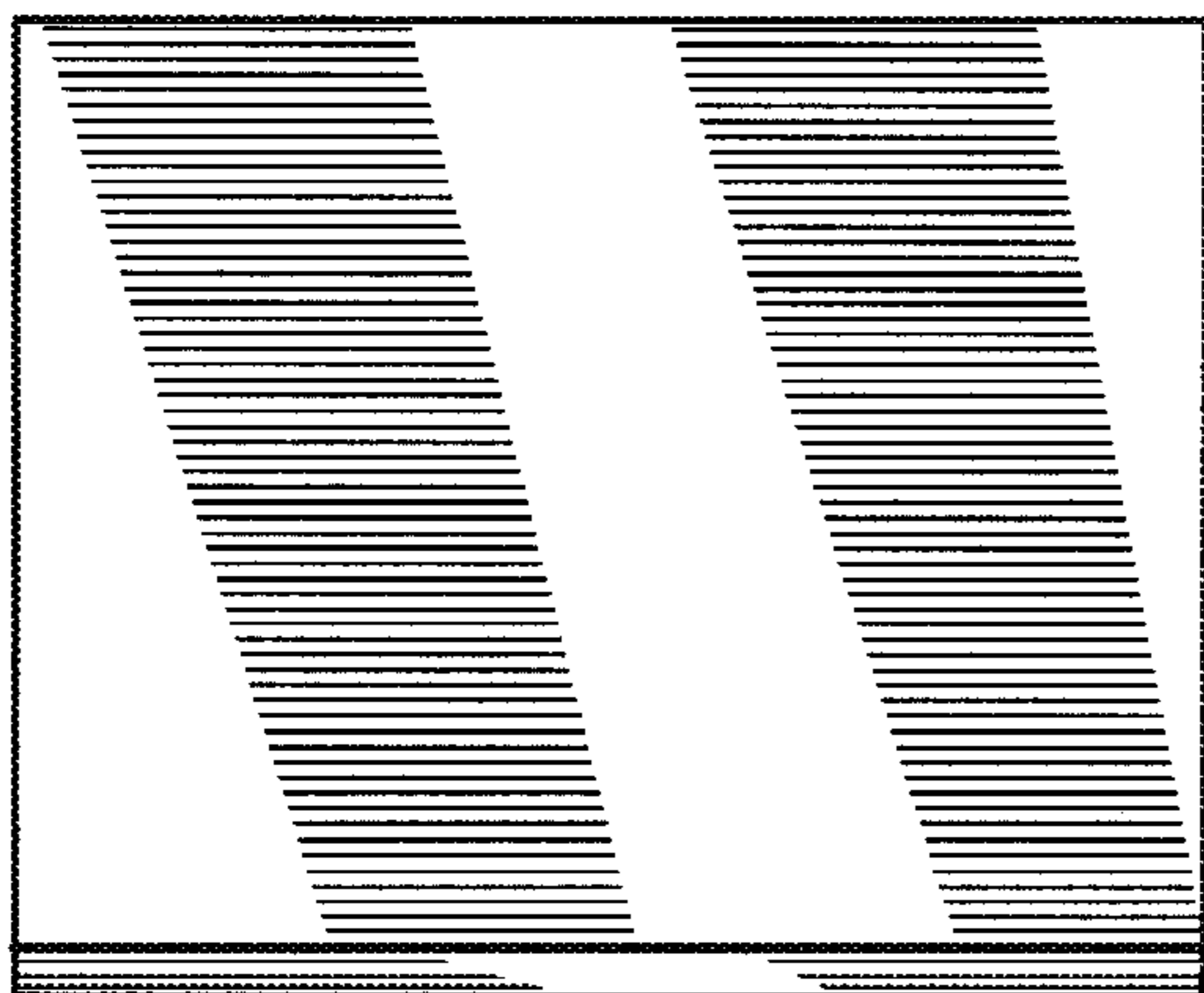

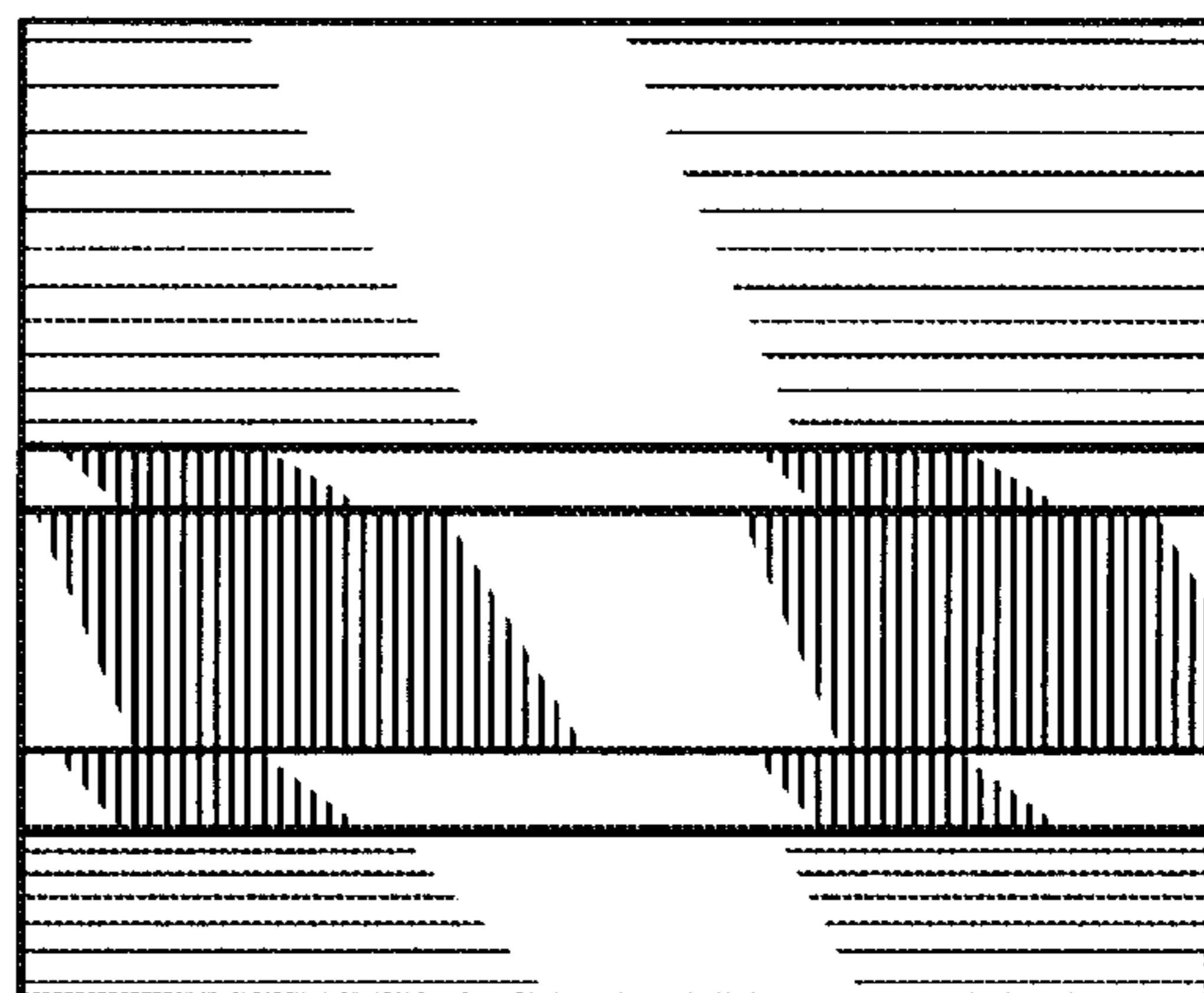

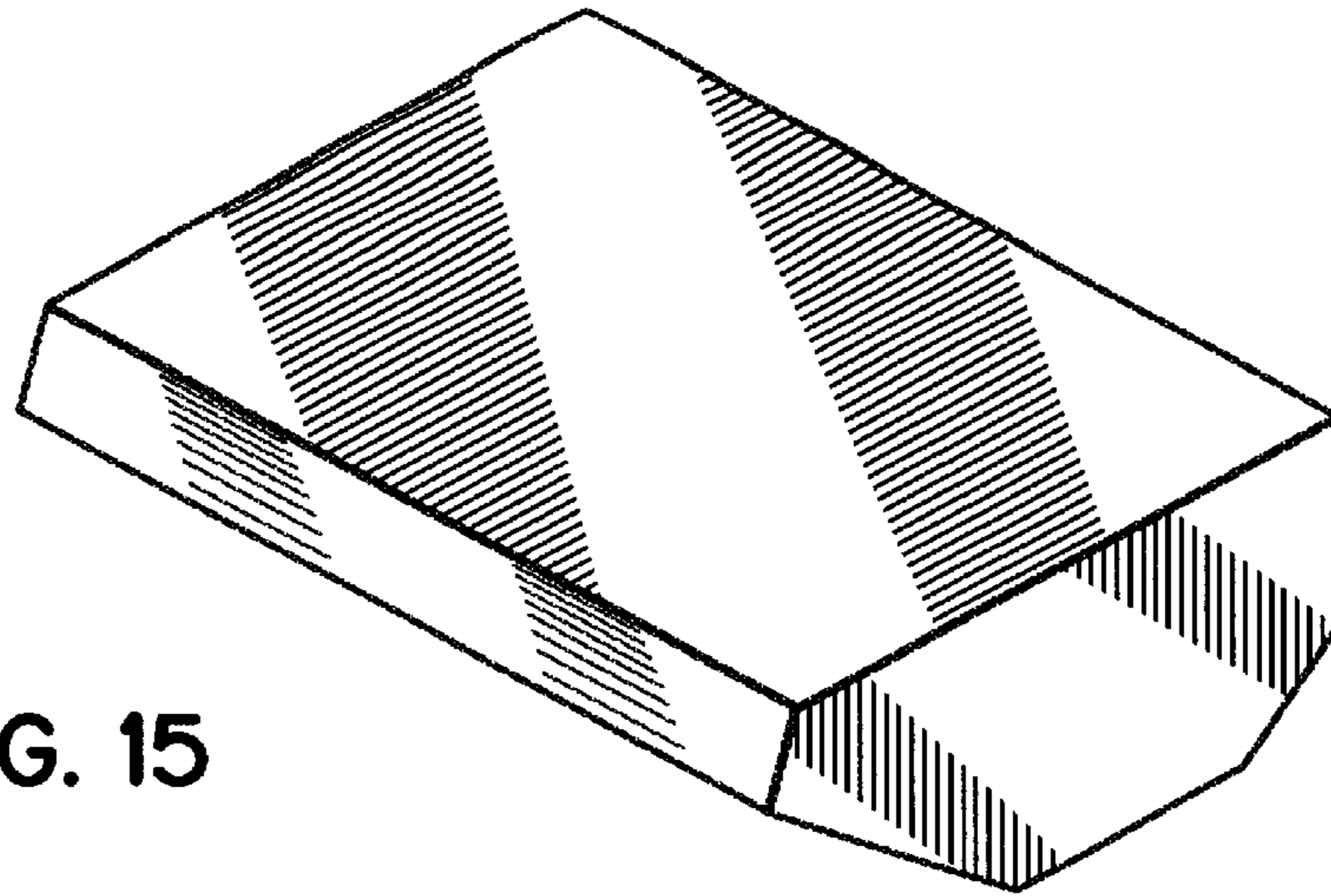

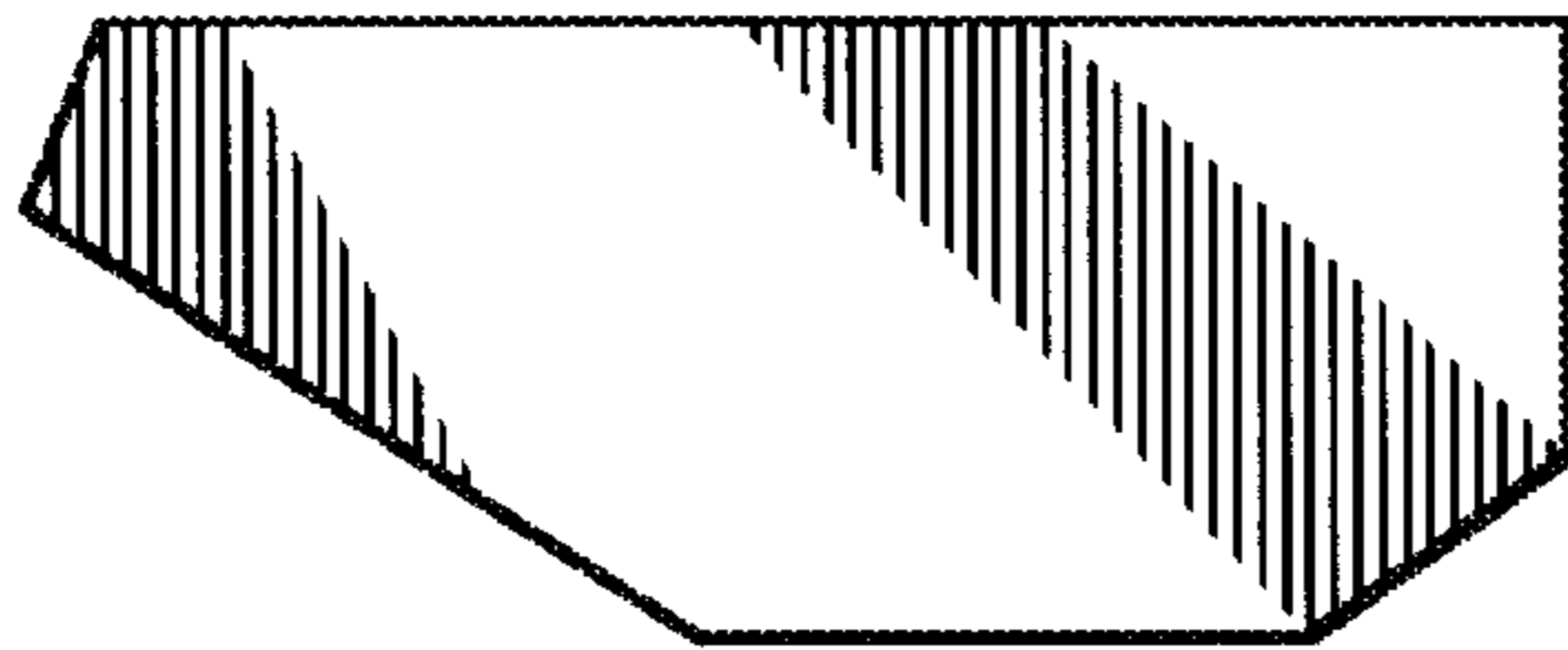

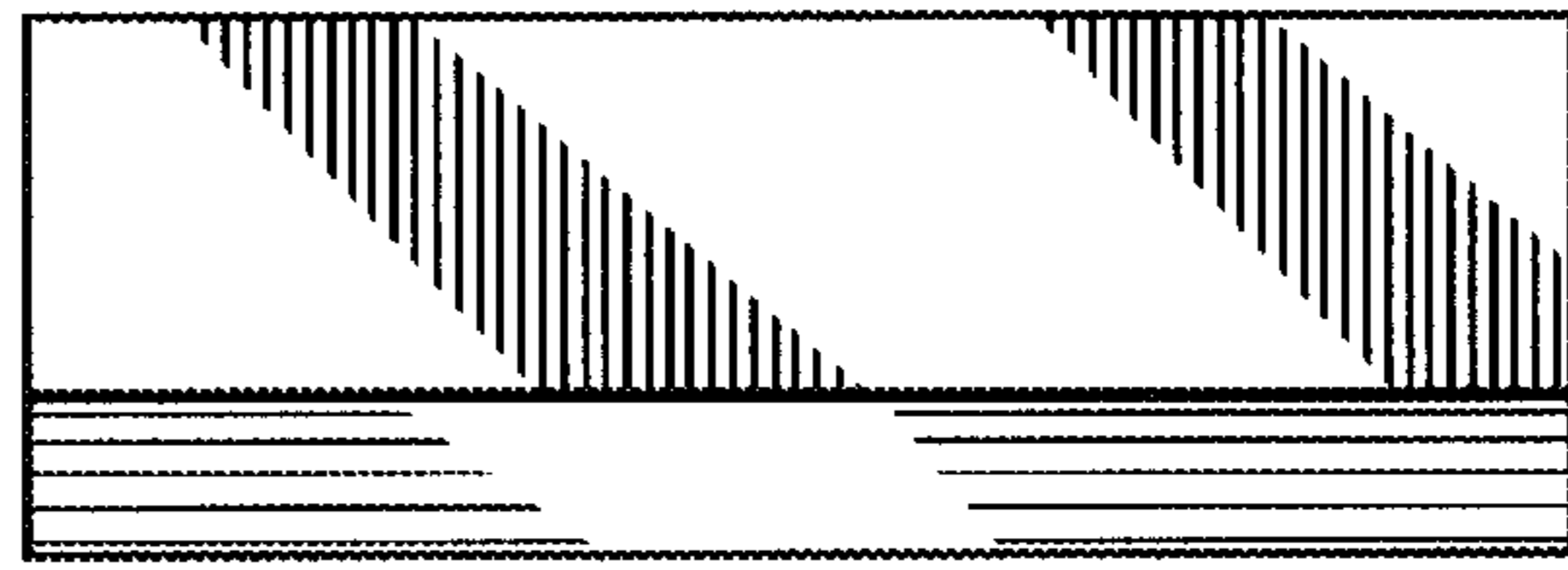

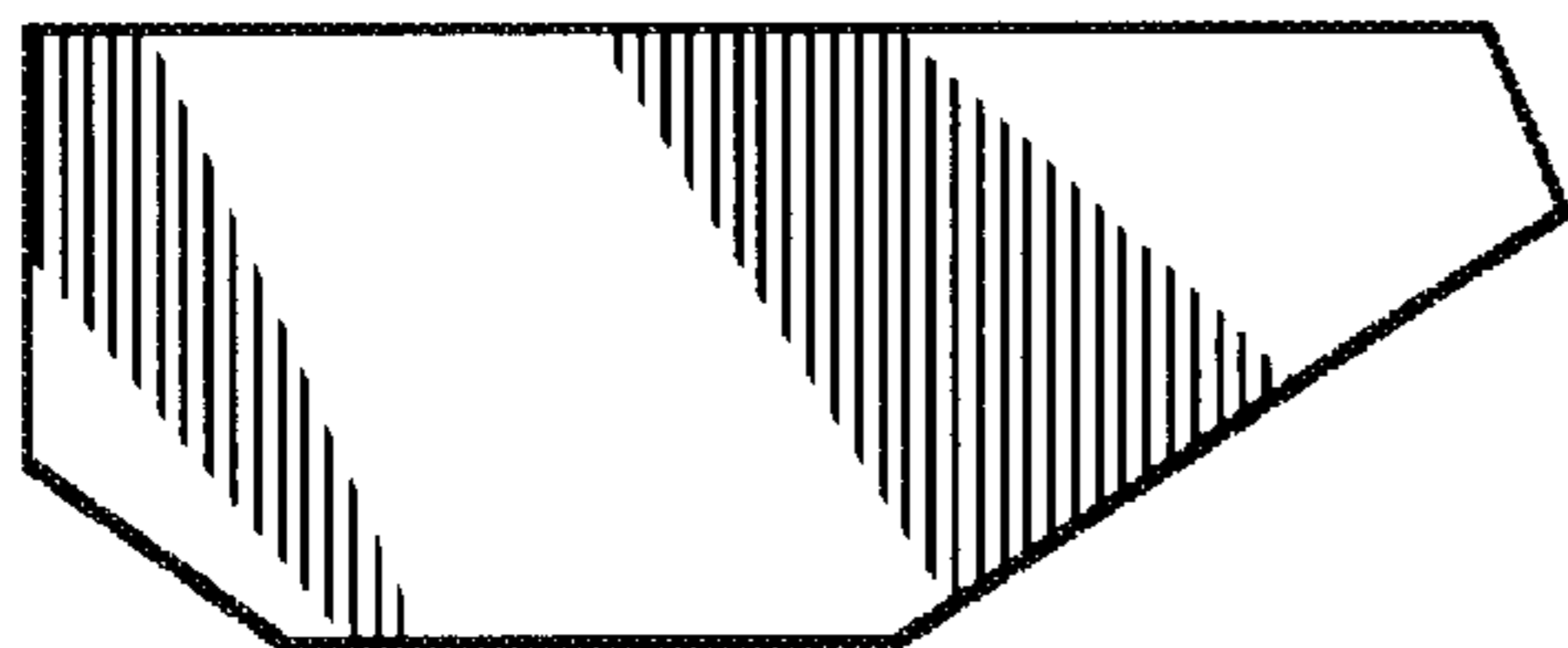

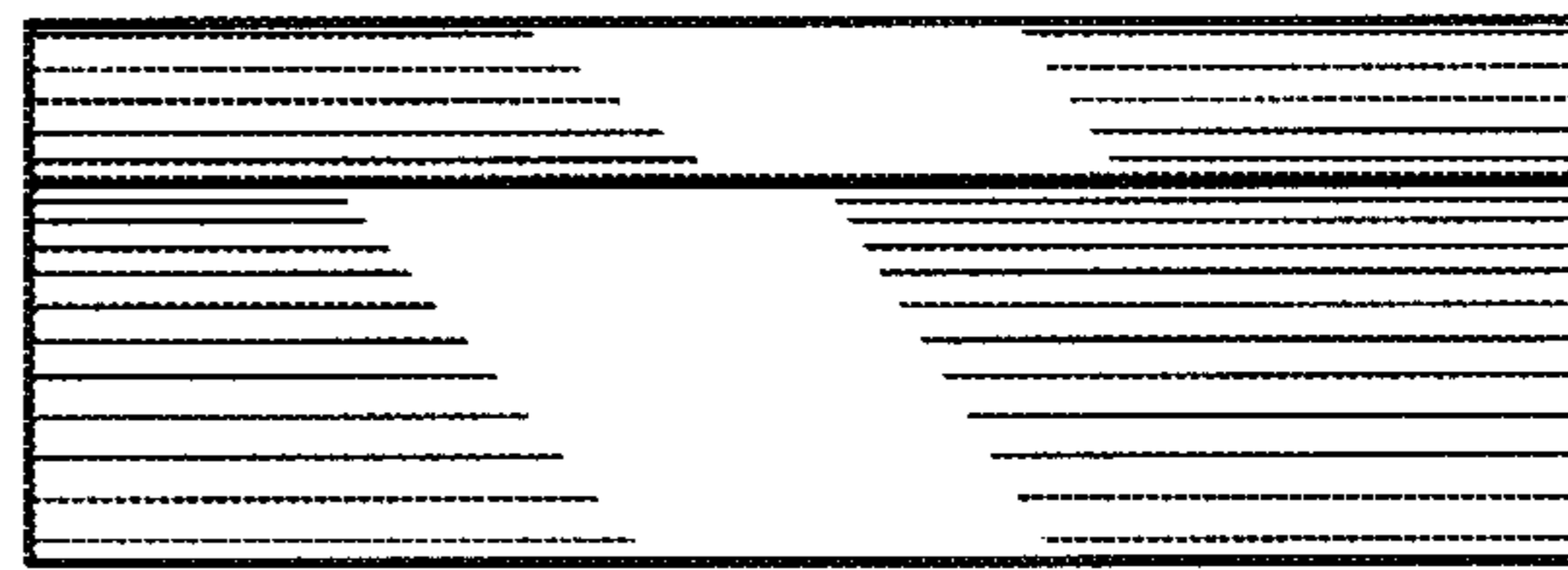

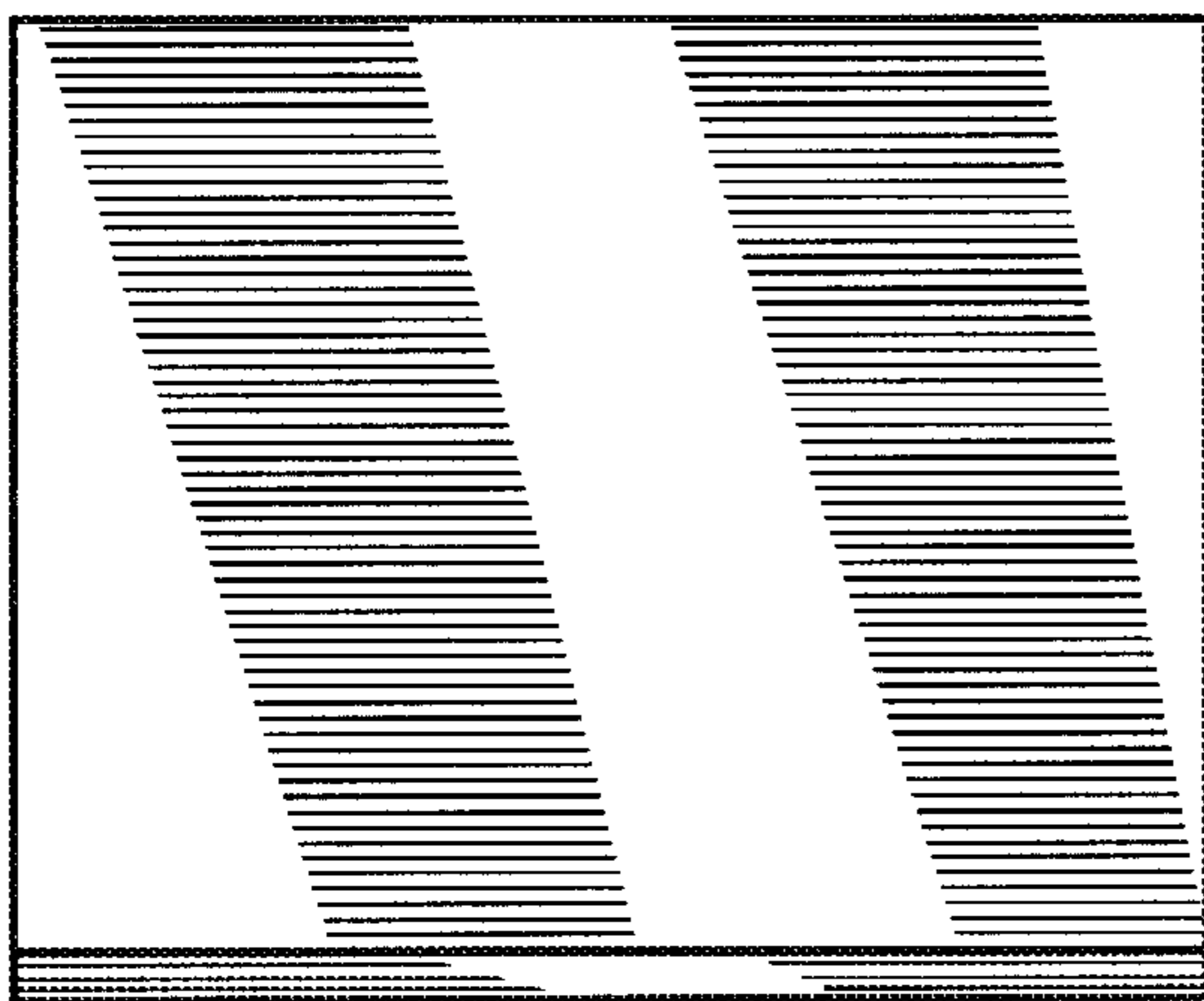

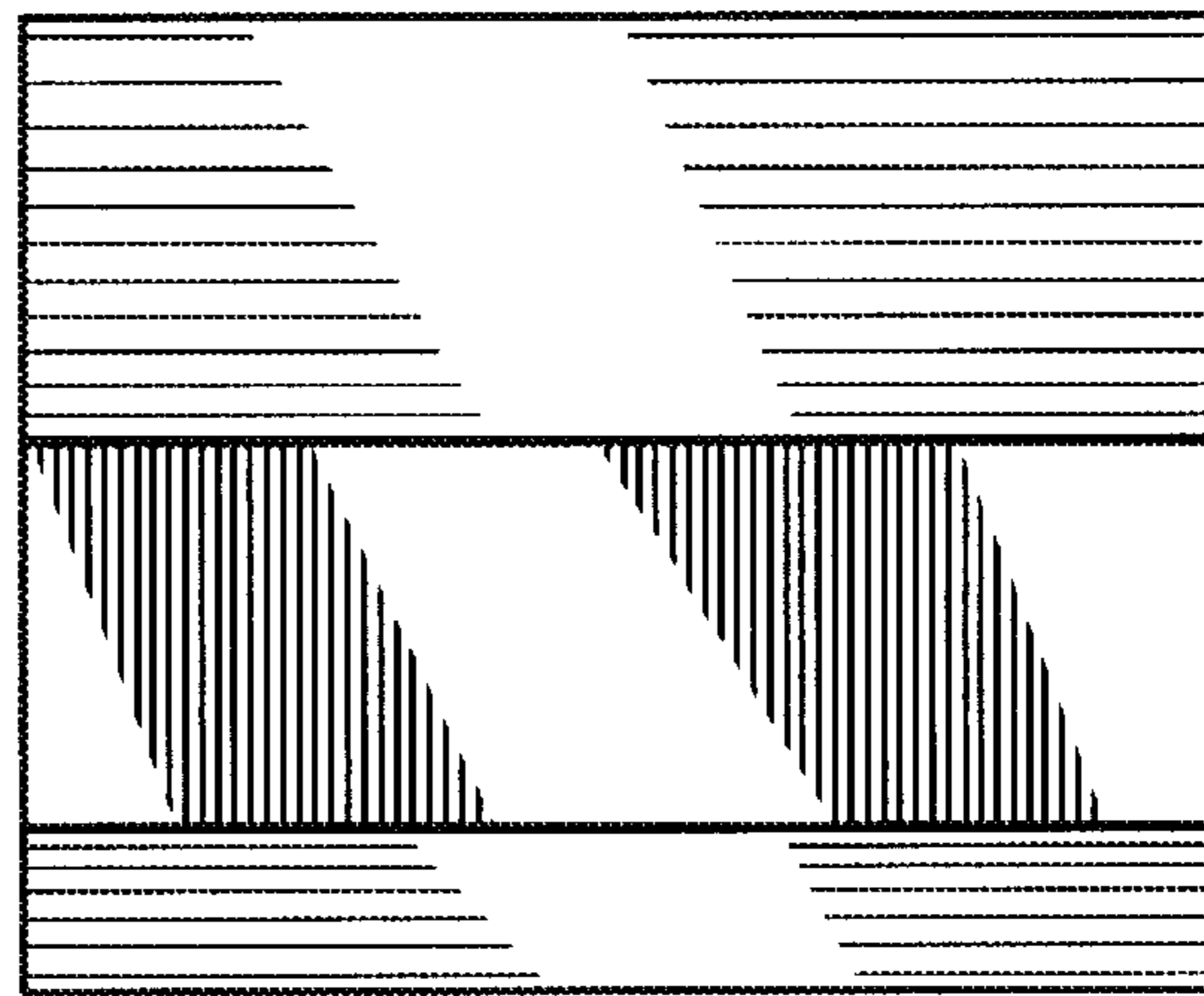
