The ornamental design for a binder, as shown and described.

**DESCRIPTION**

FIG. 29 is a first side view of the binder of FIG. 25;

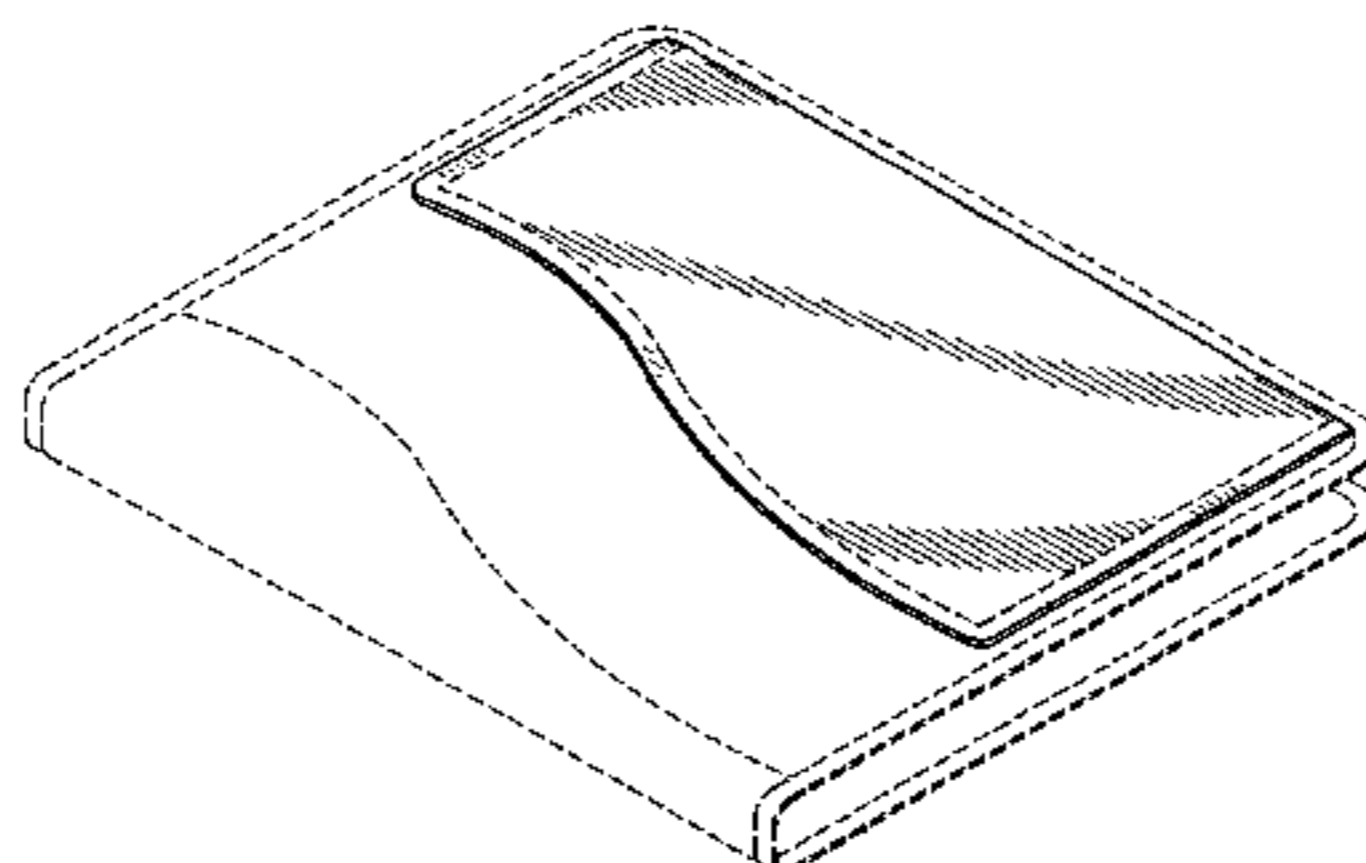
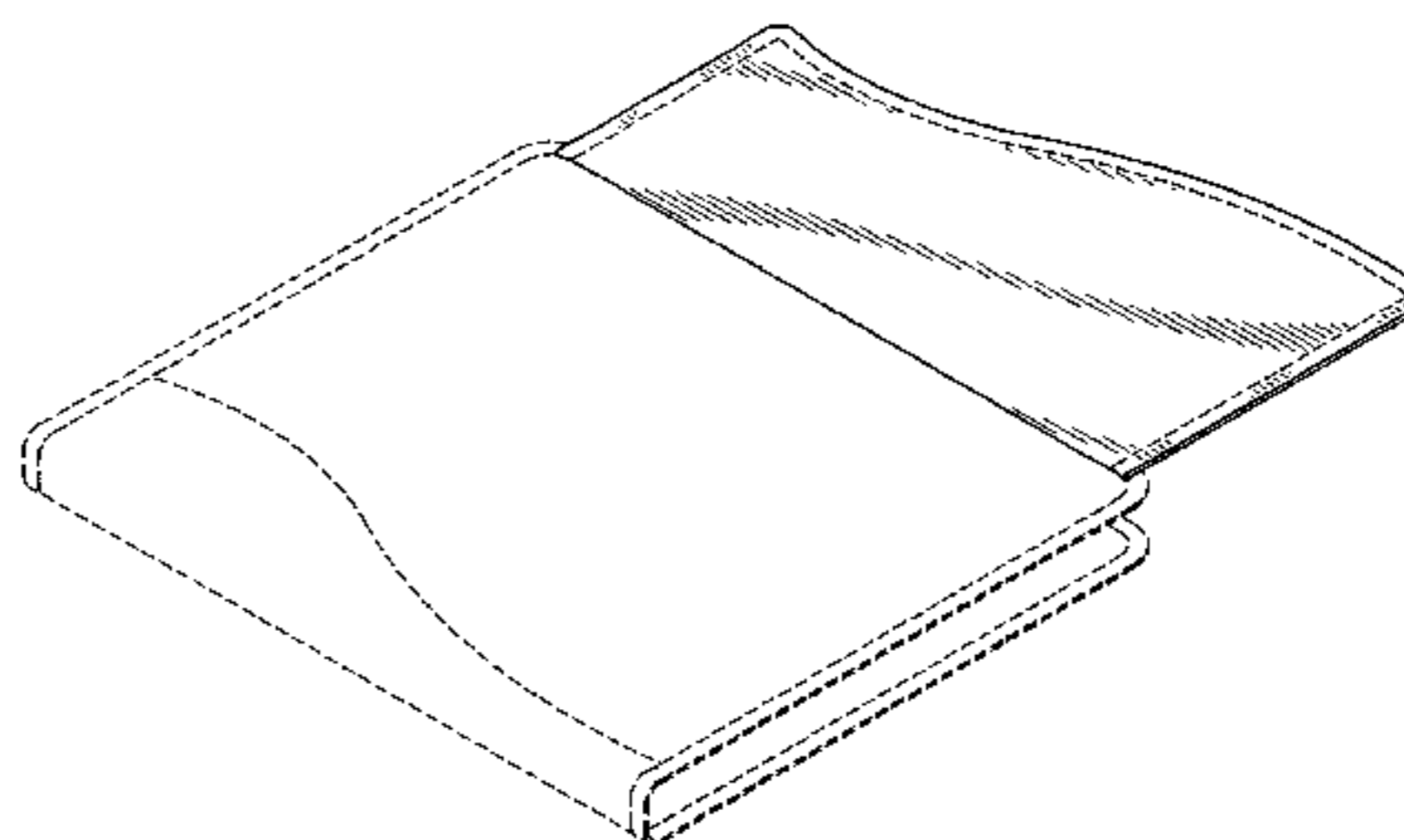
FIG. 30 is a second side view of the binder of FIG. 25;

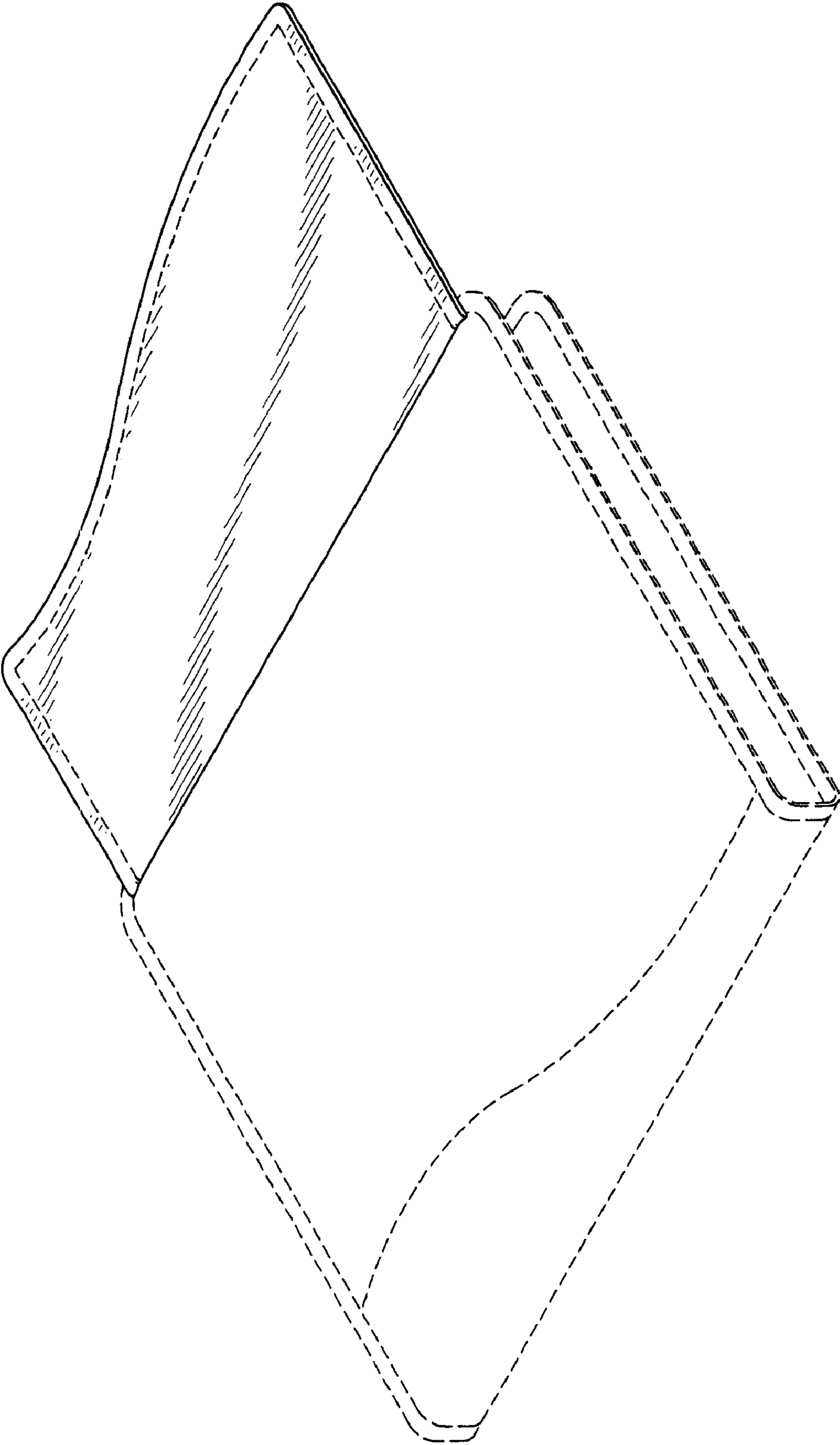

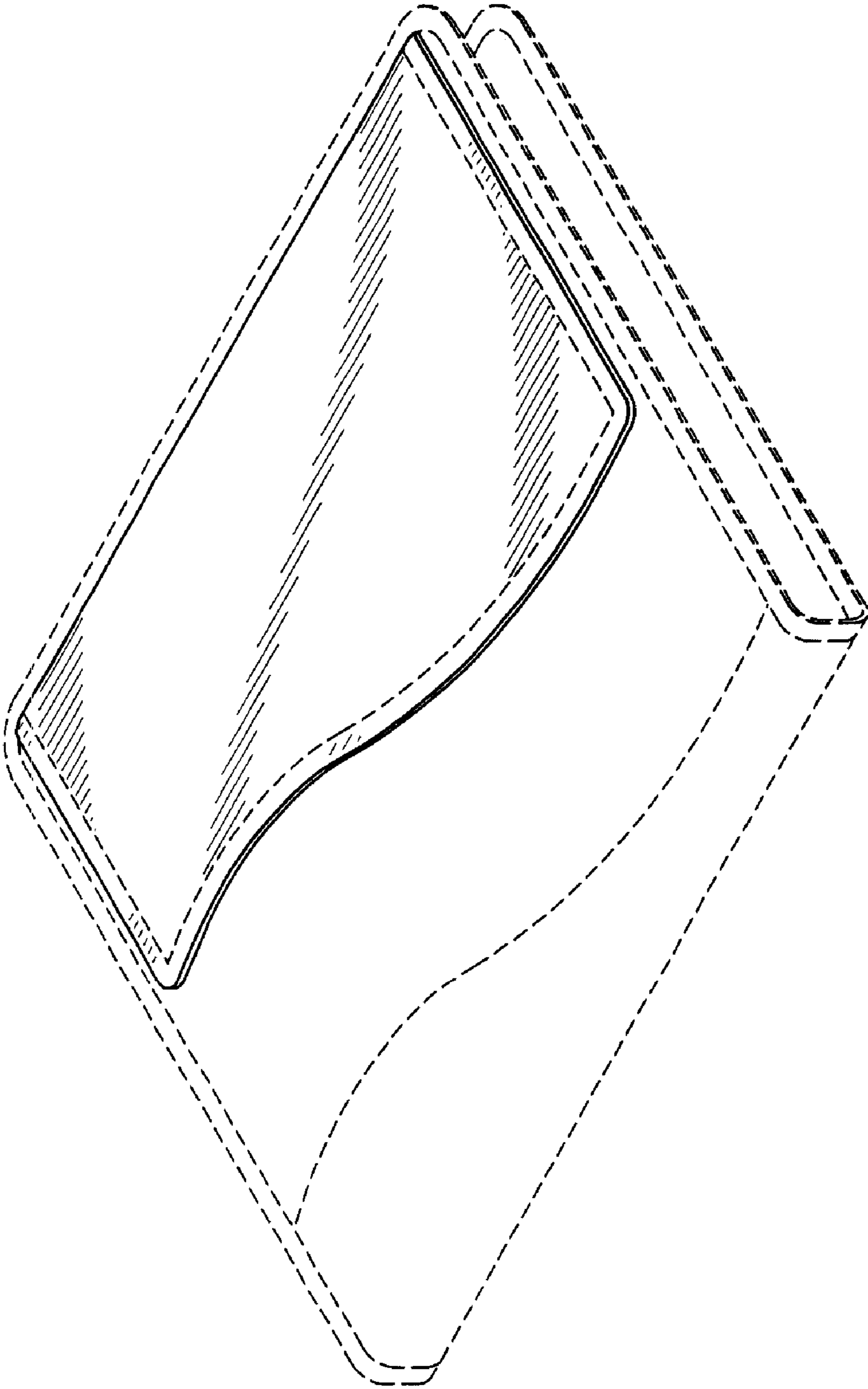

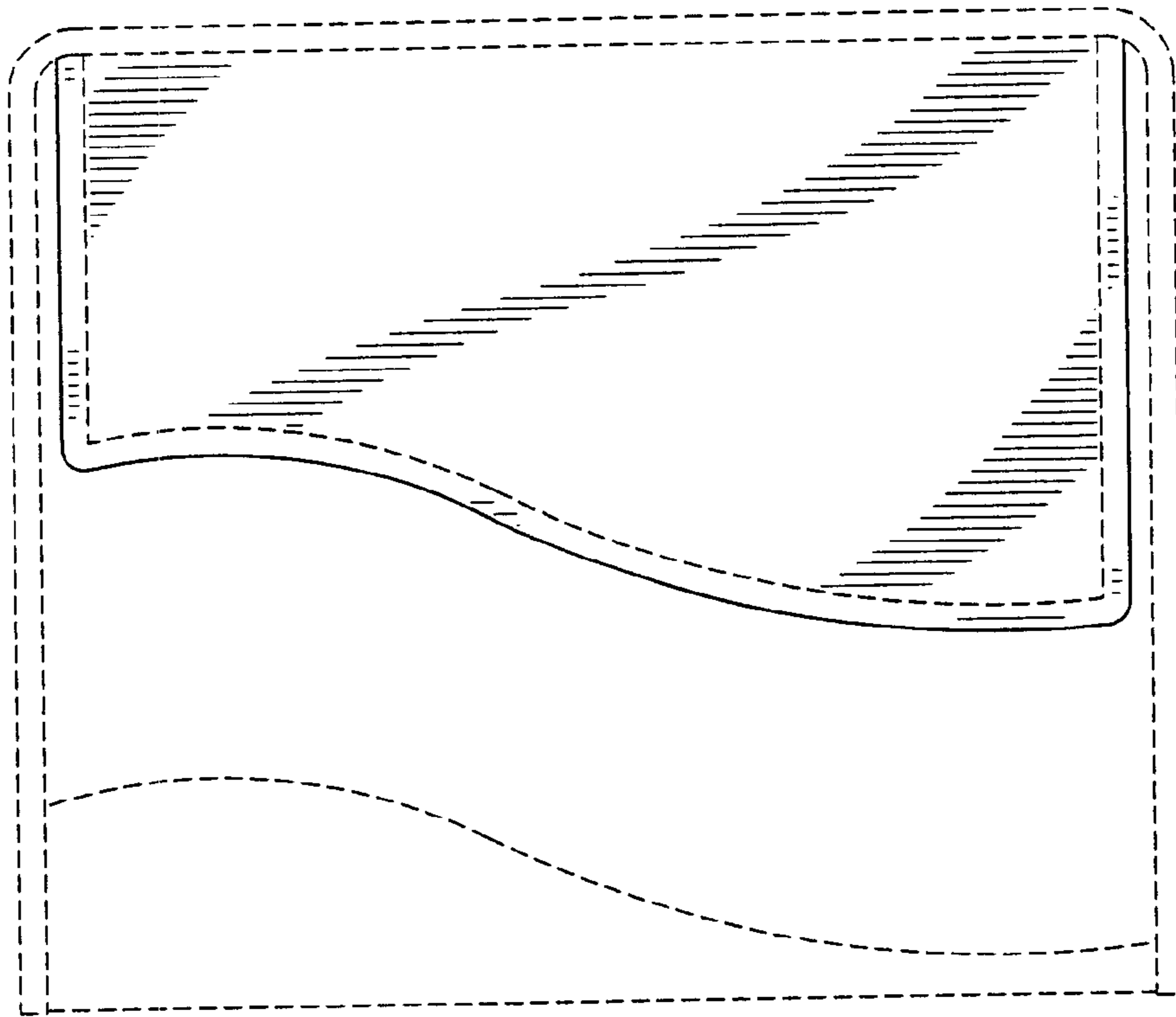

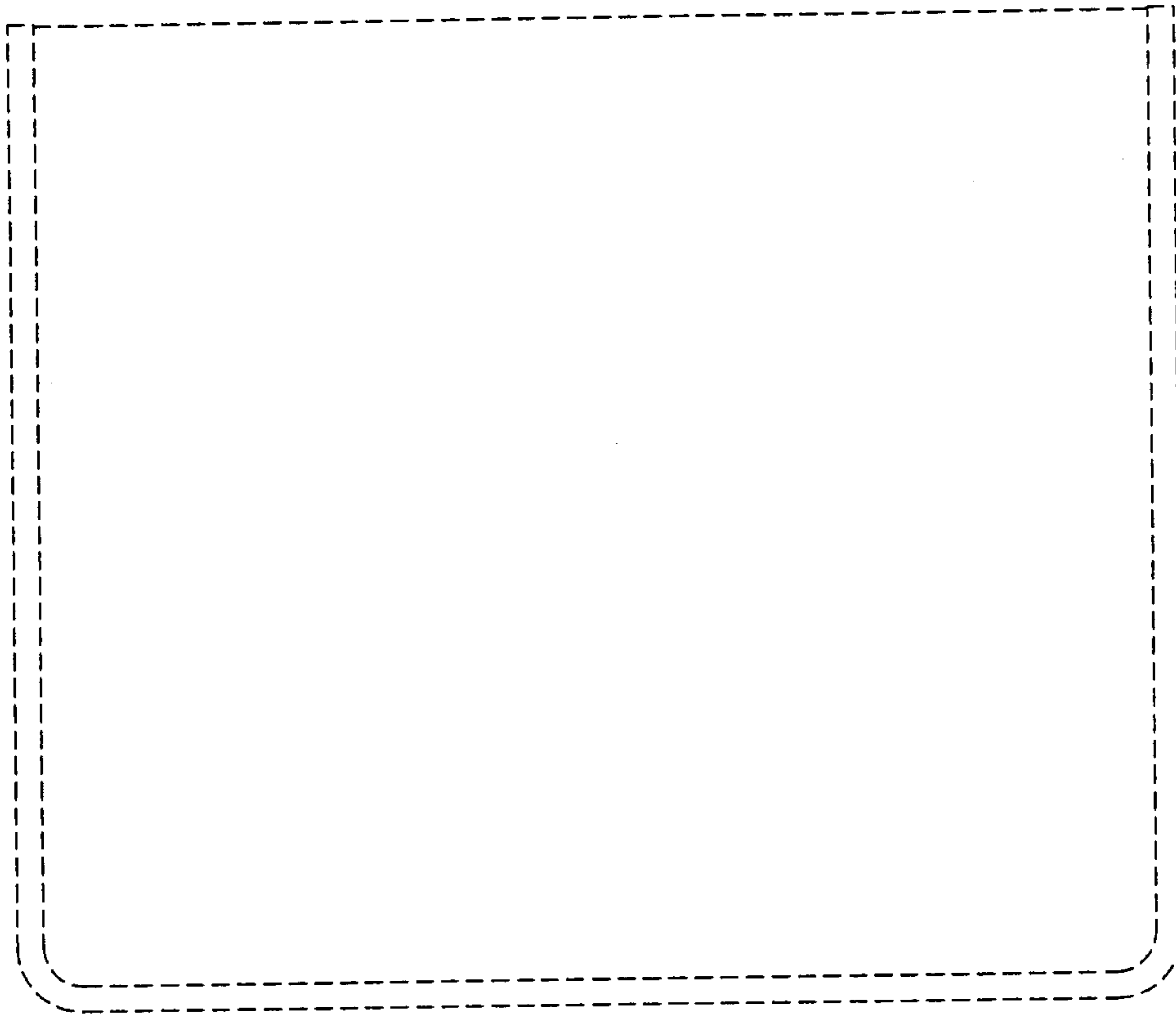

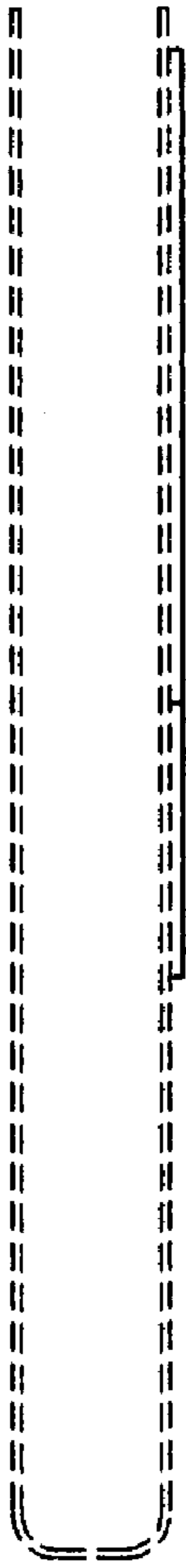

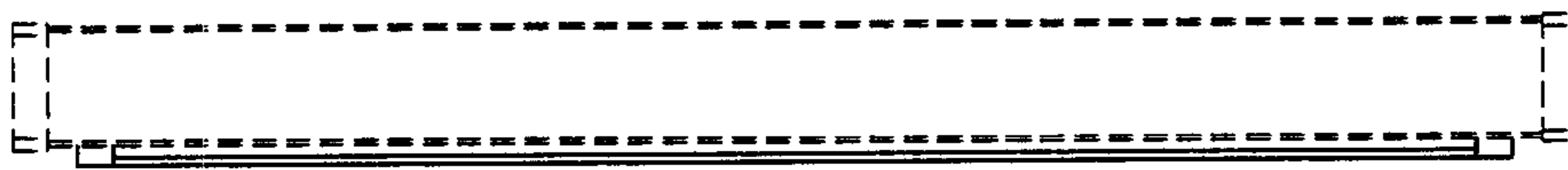

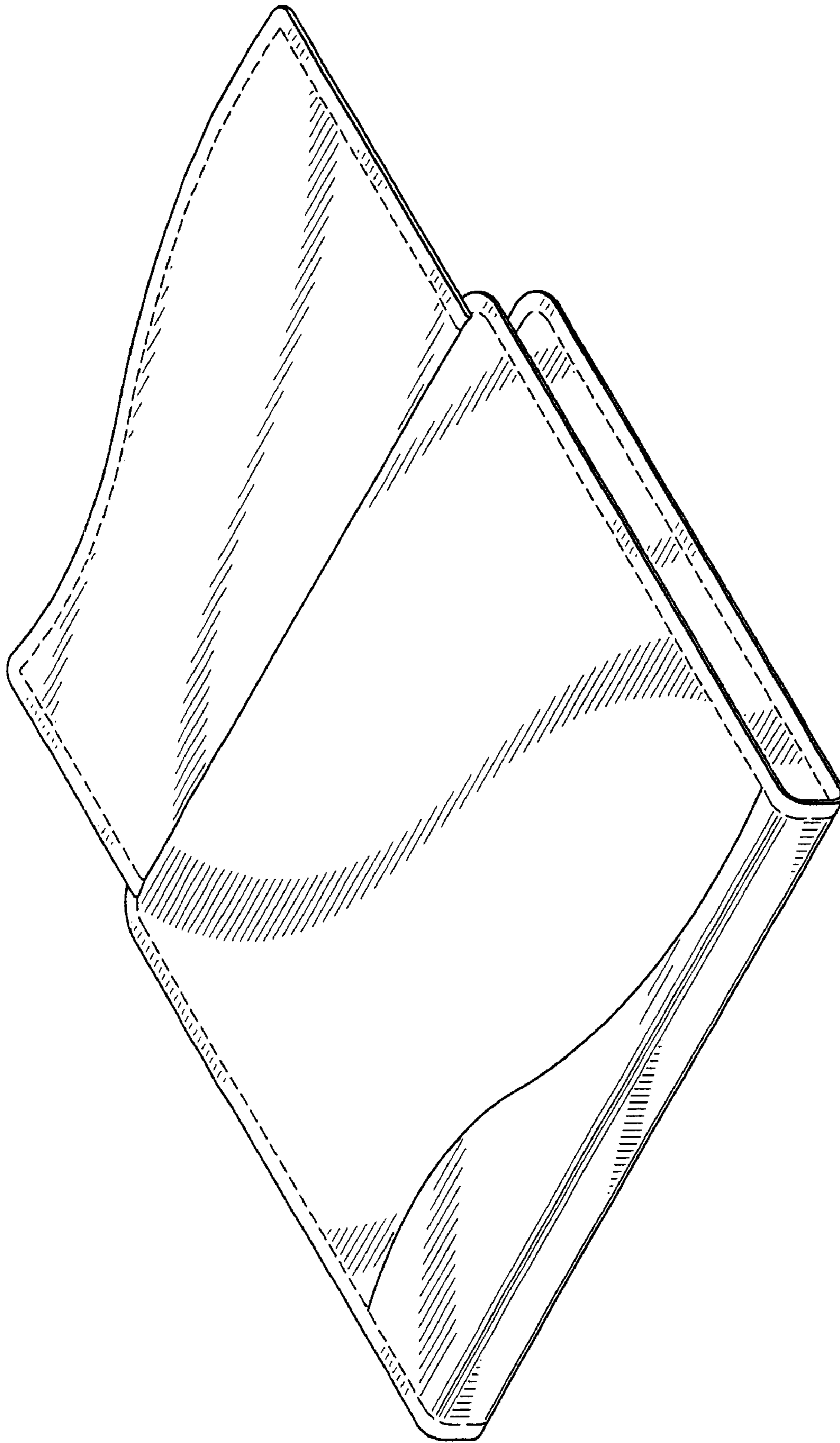

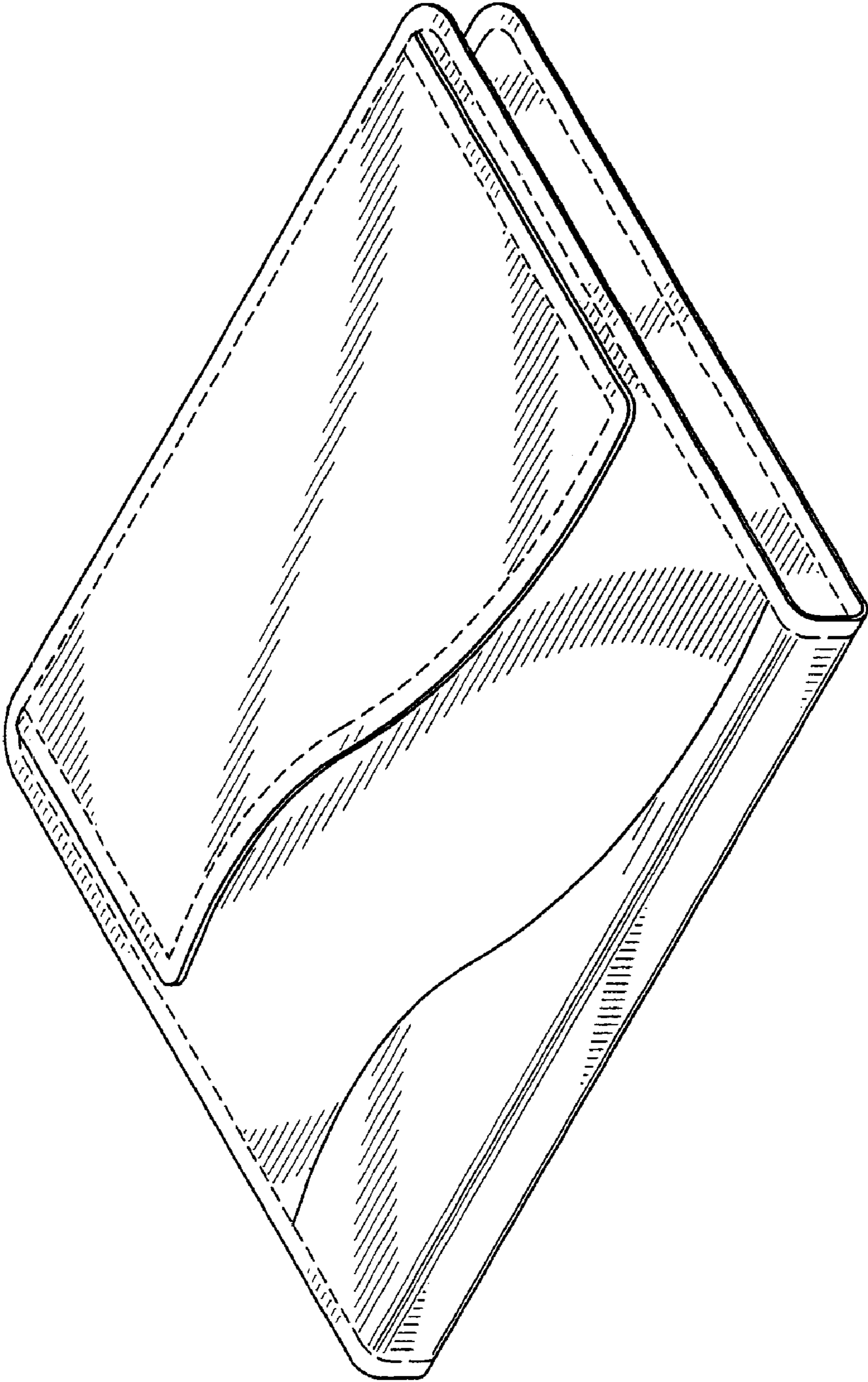

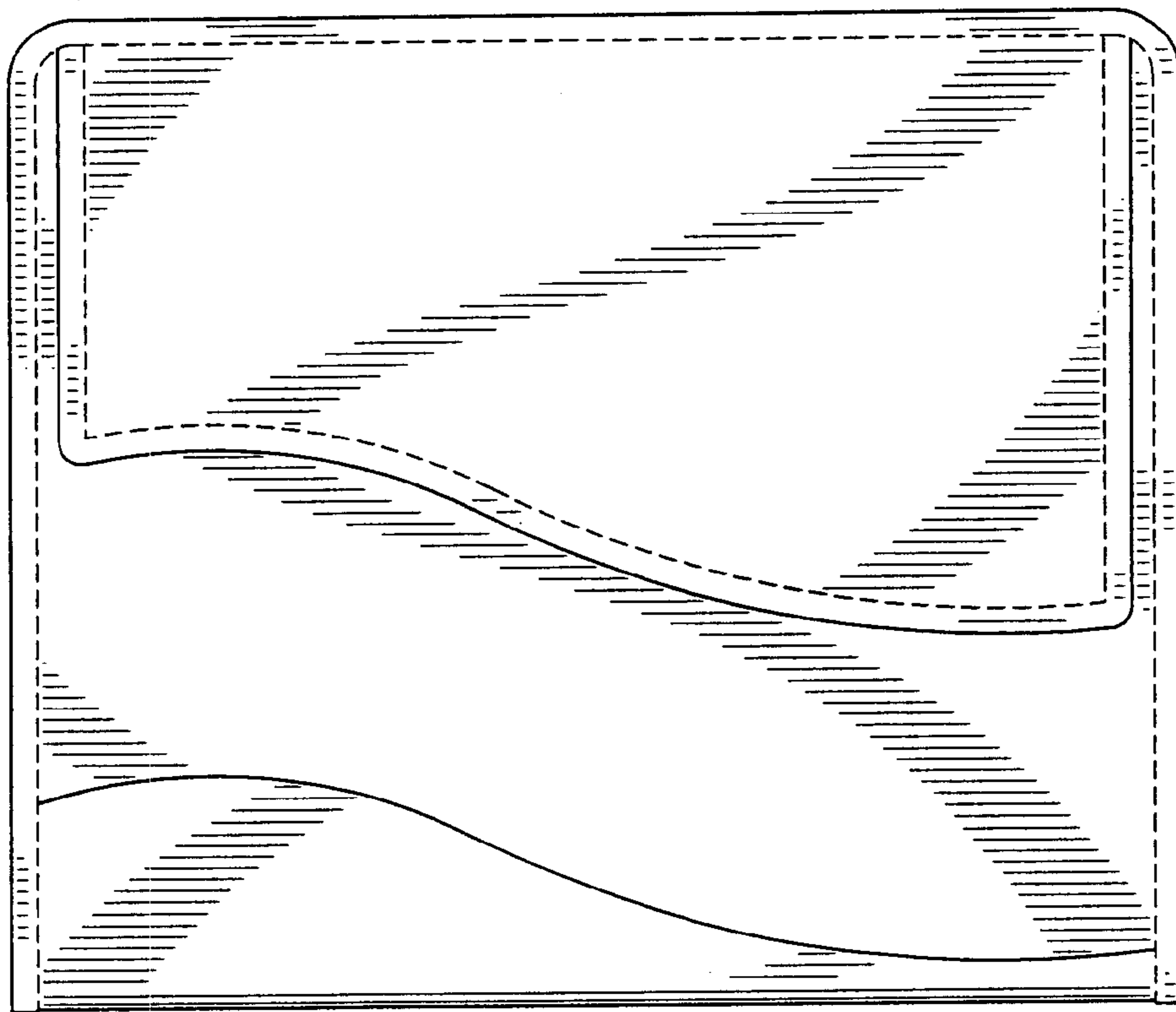

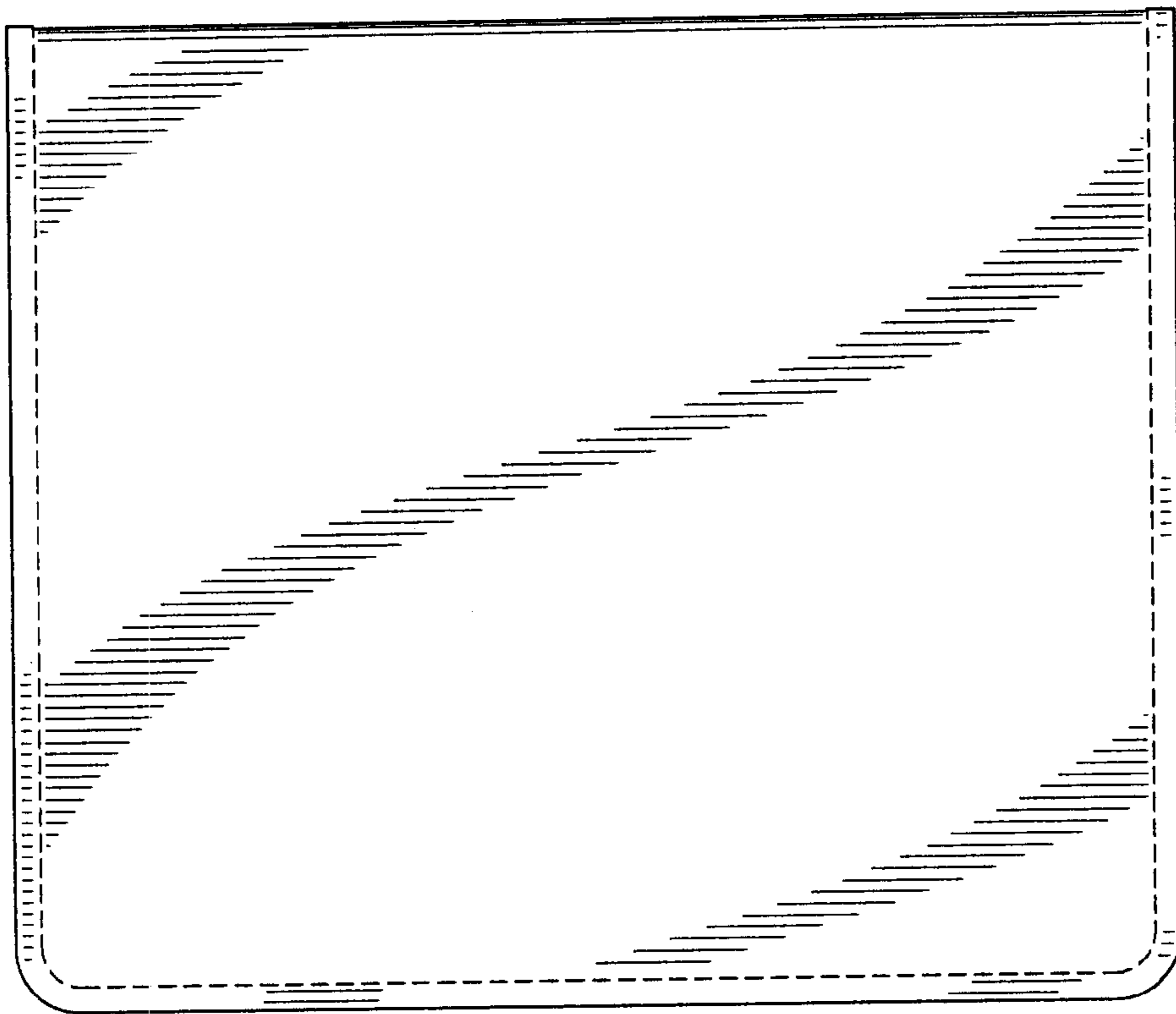

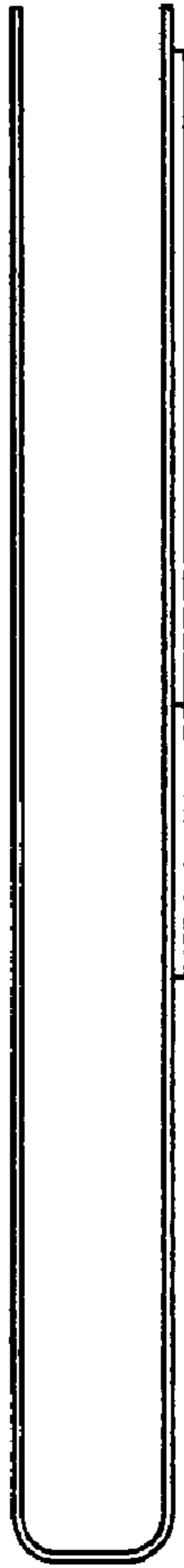

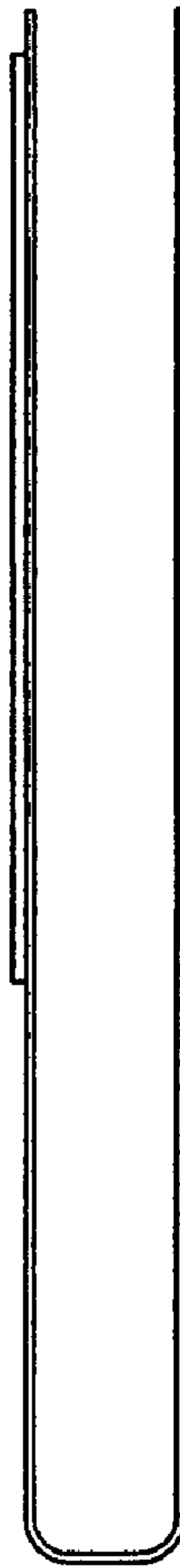

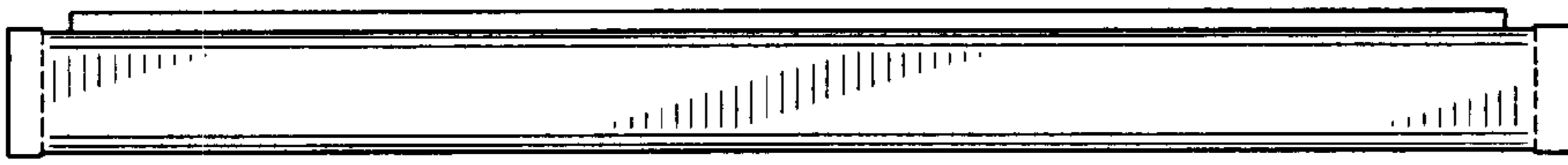

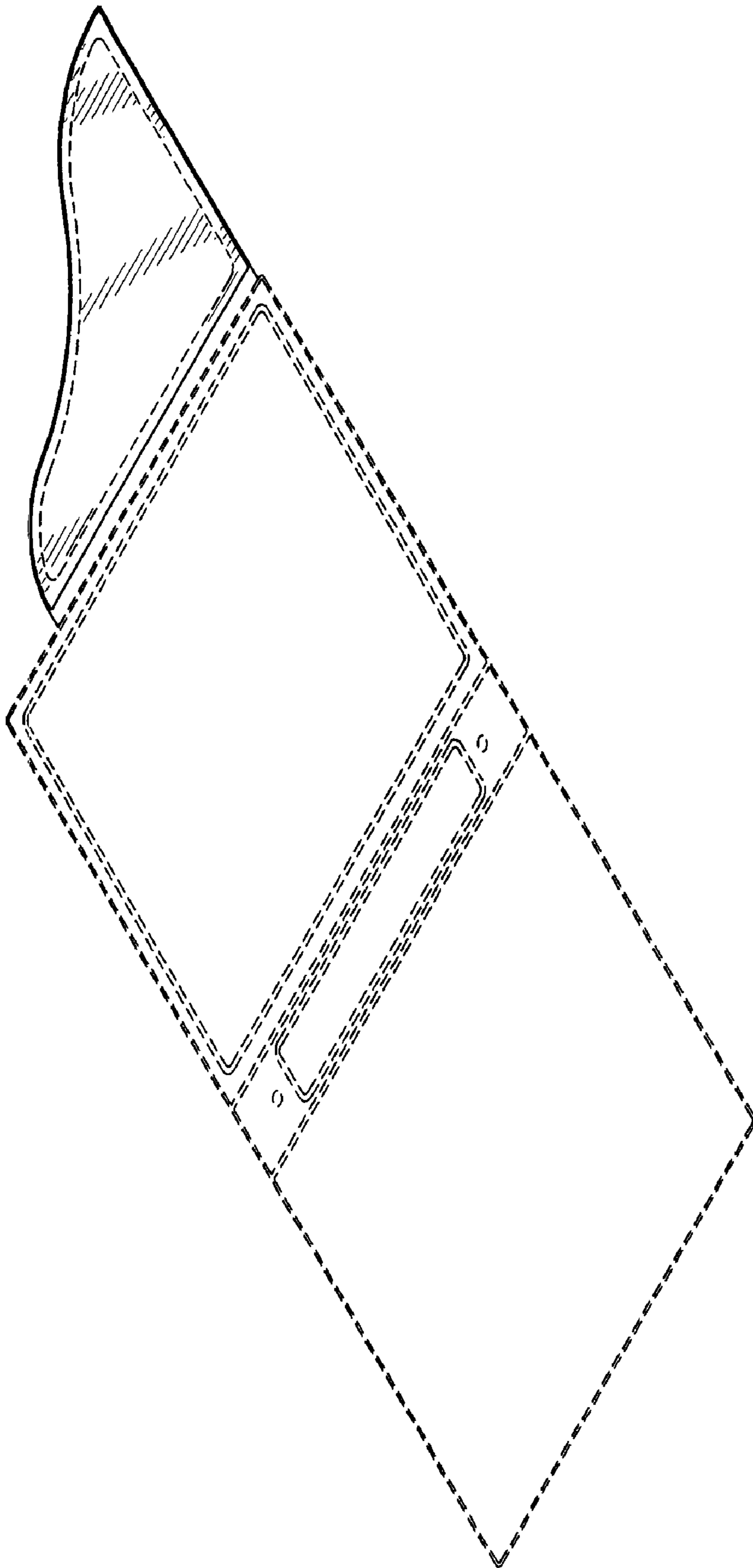

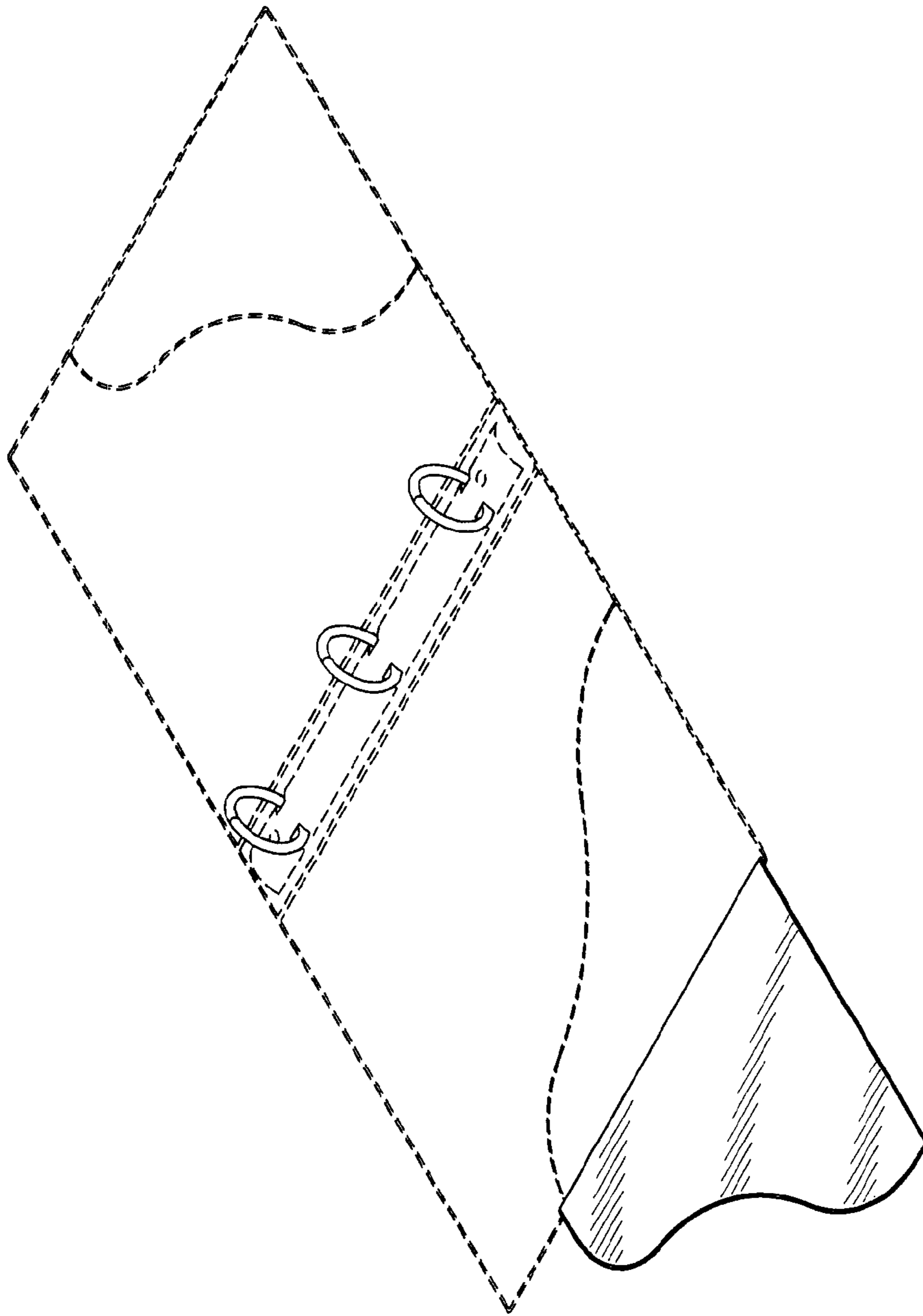

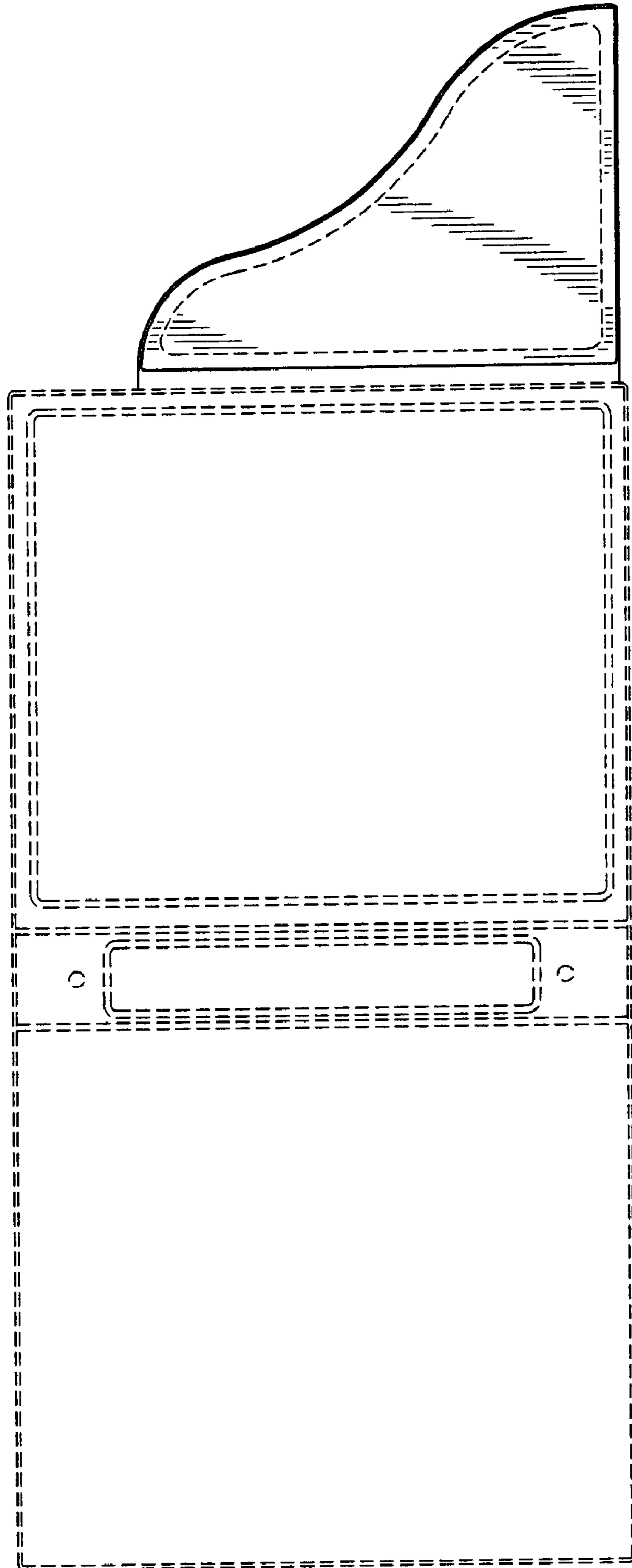

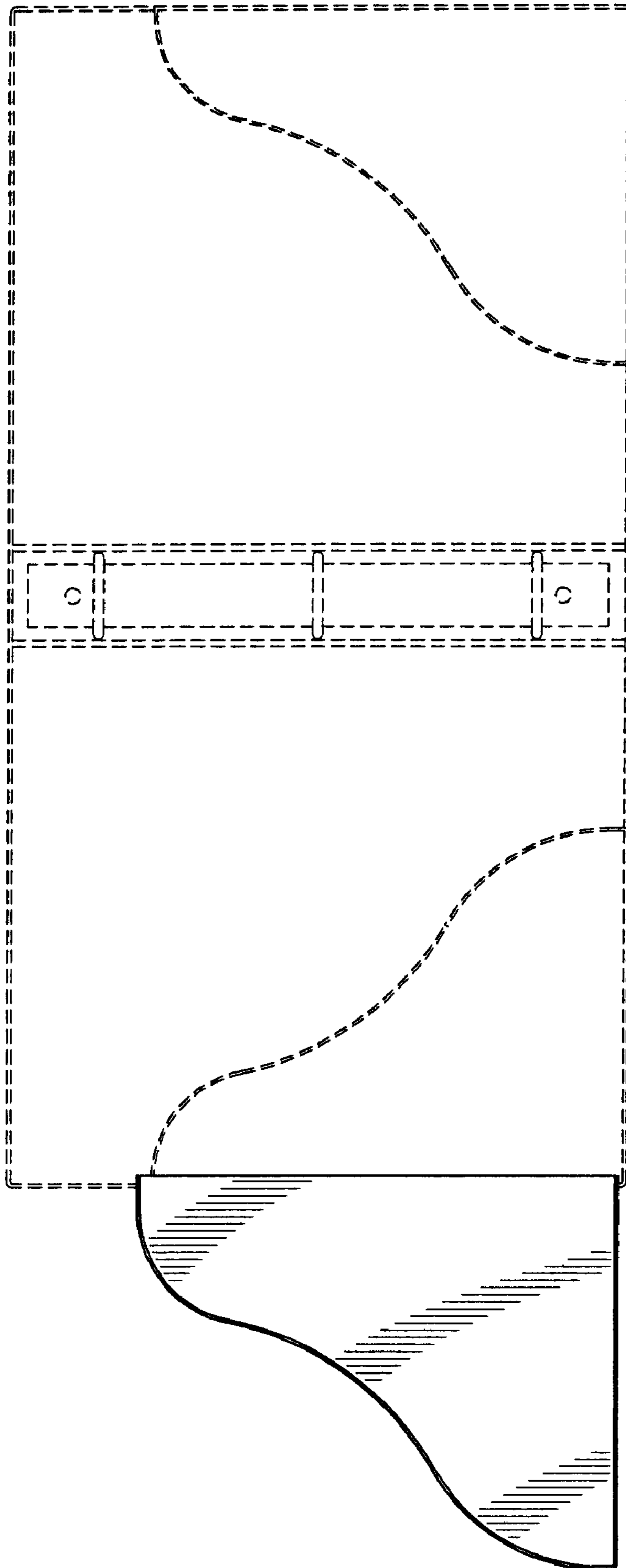

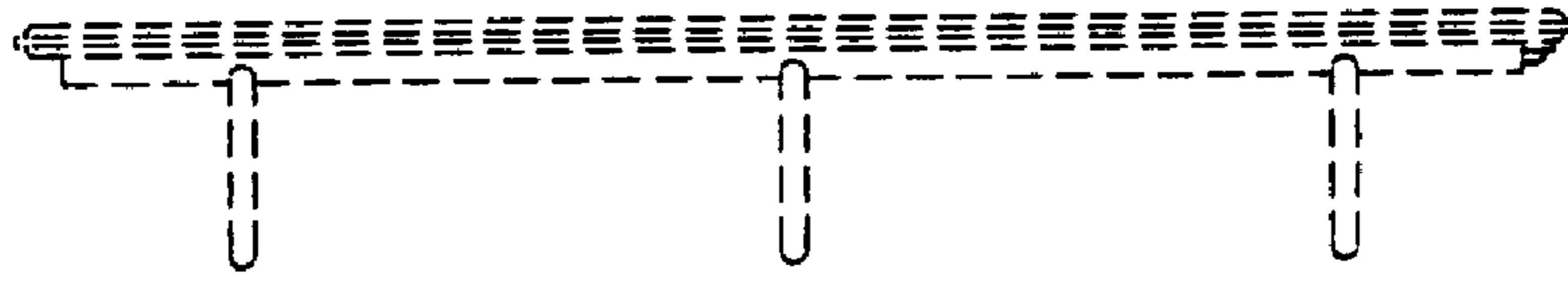

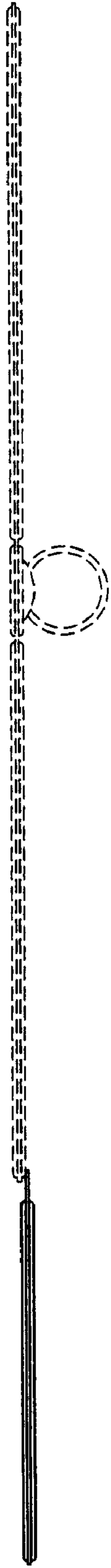

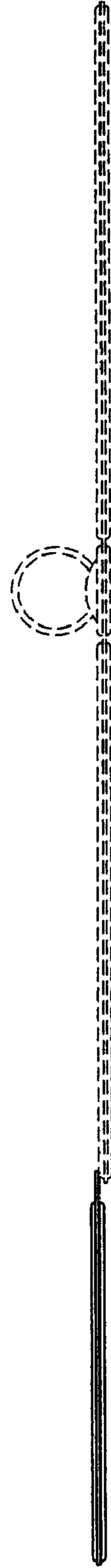

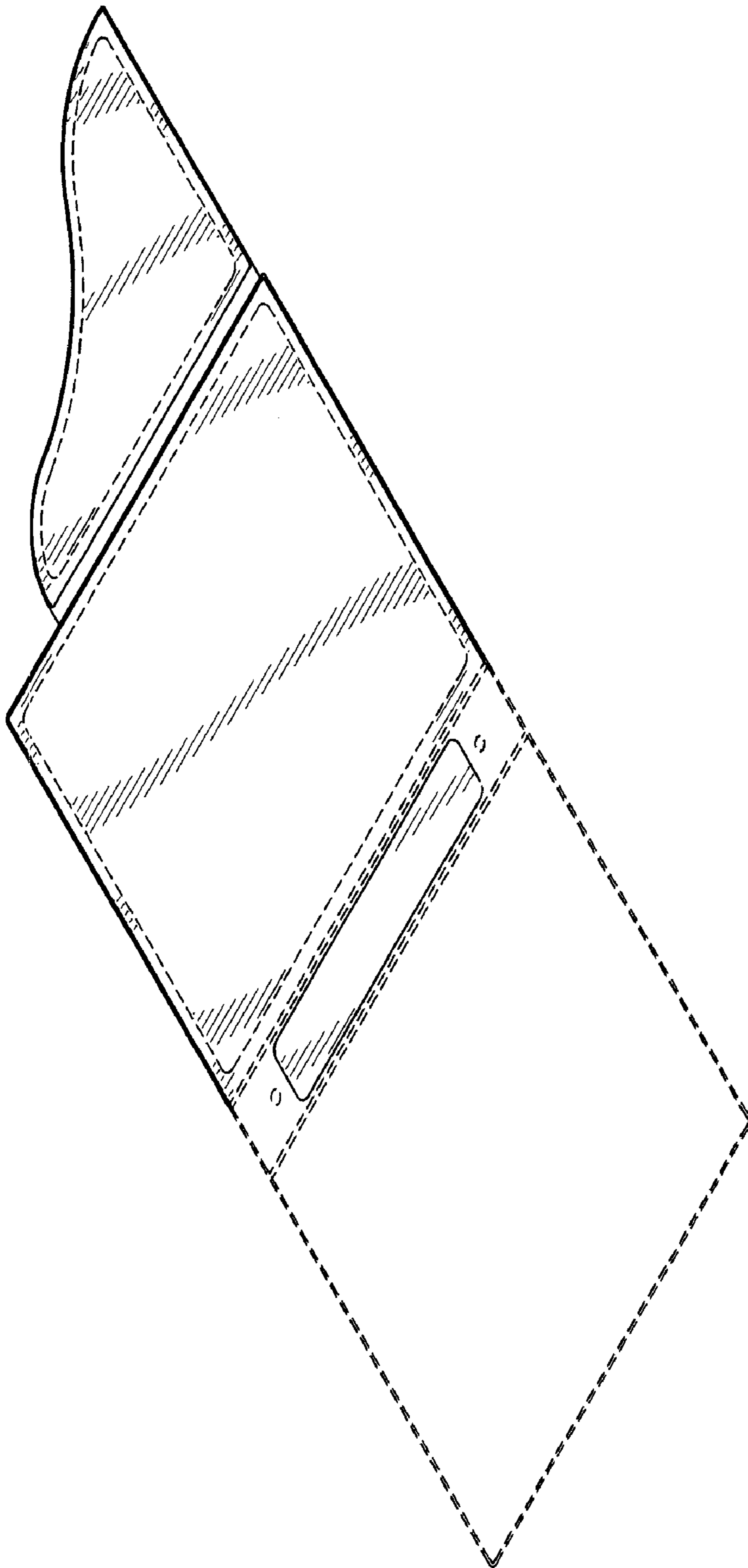

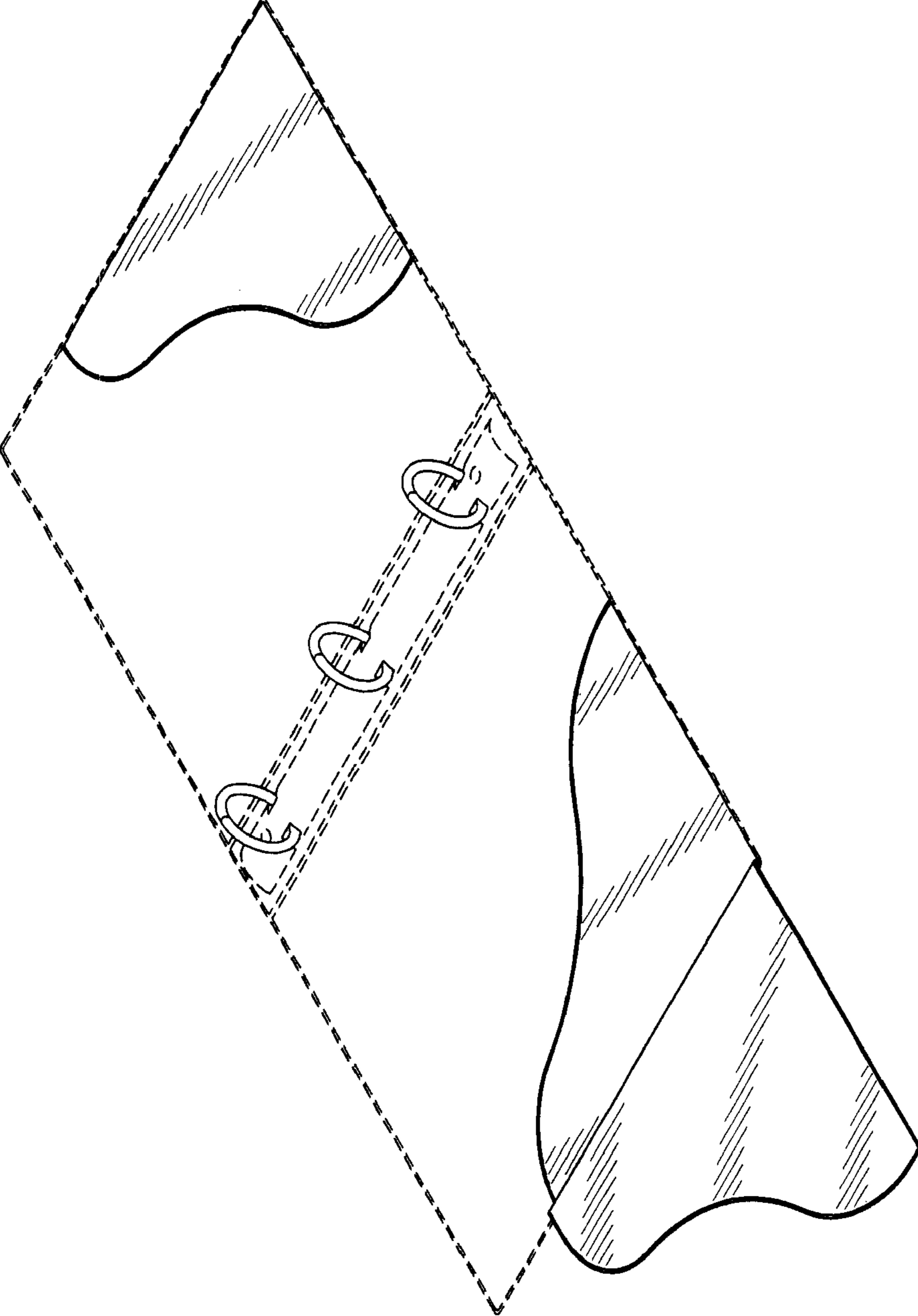

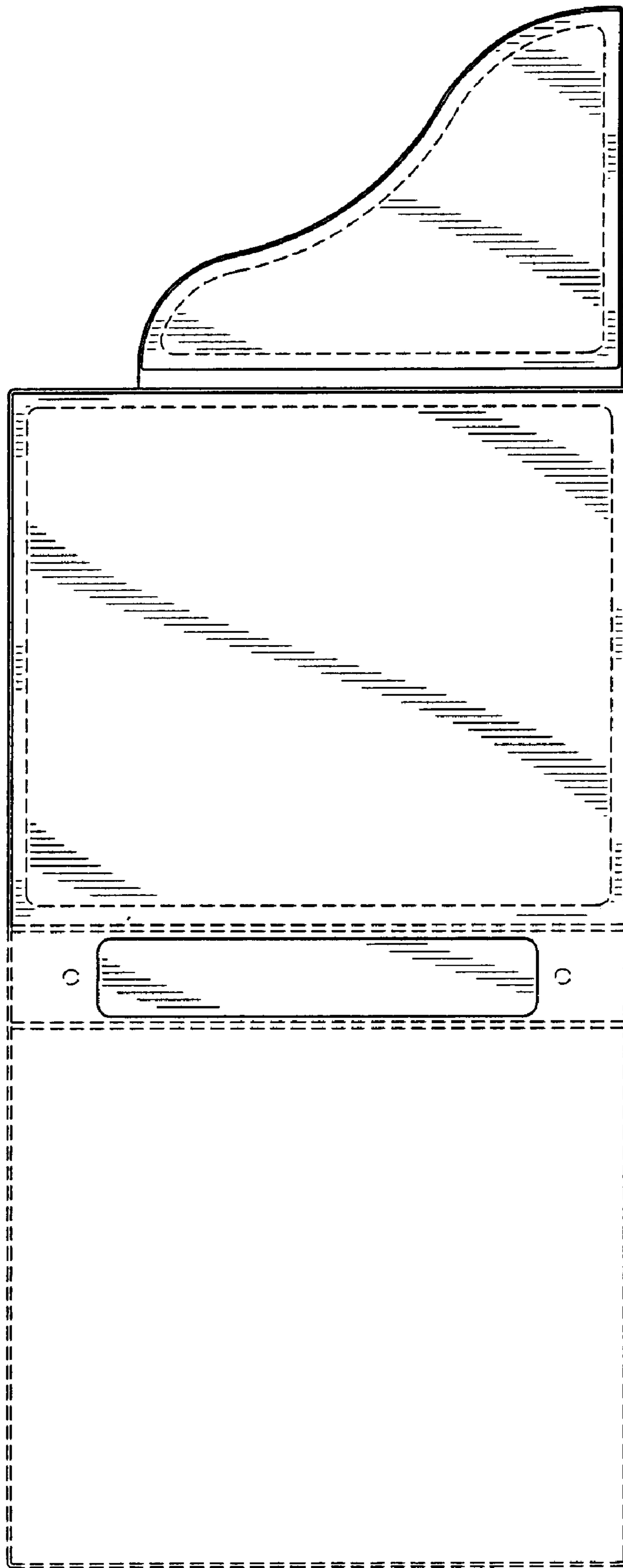

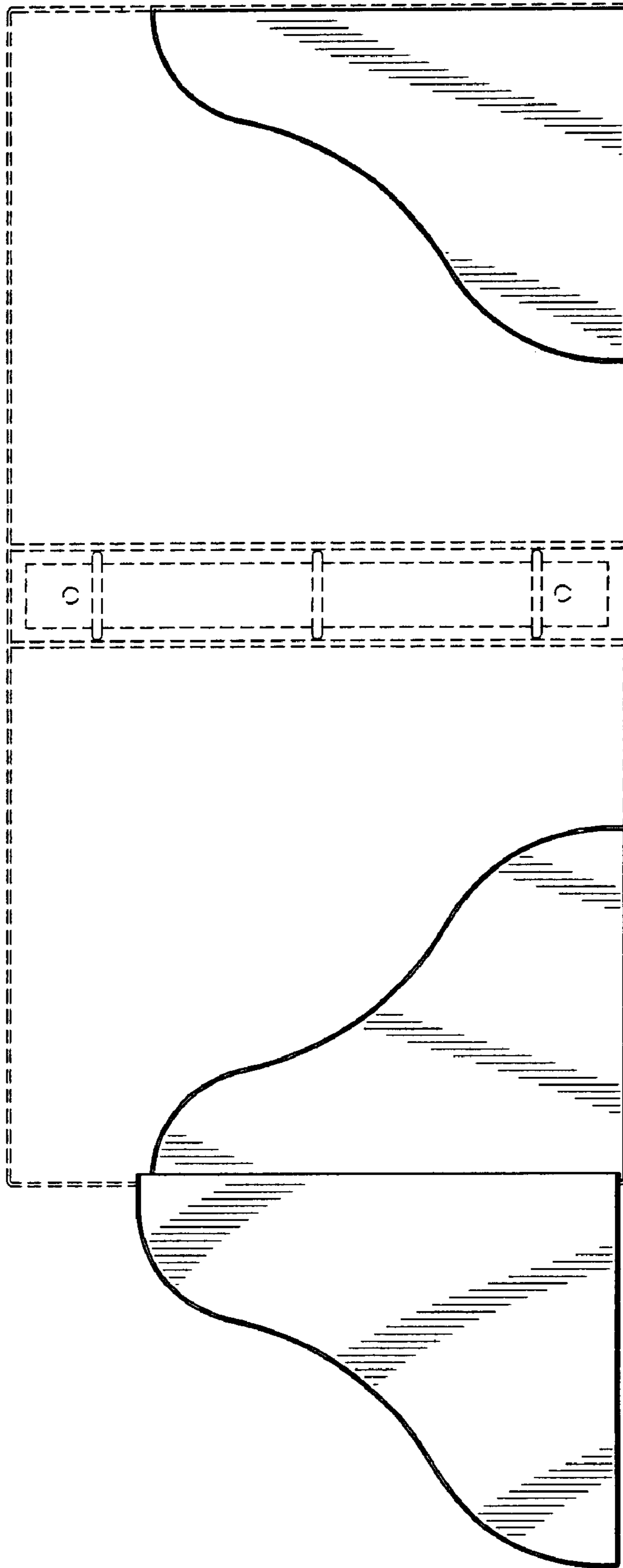

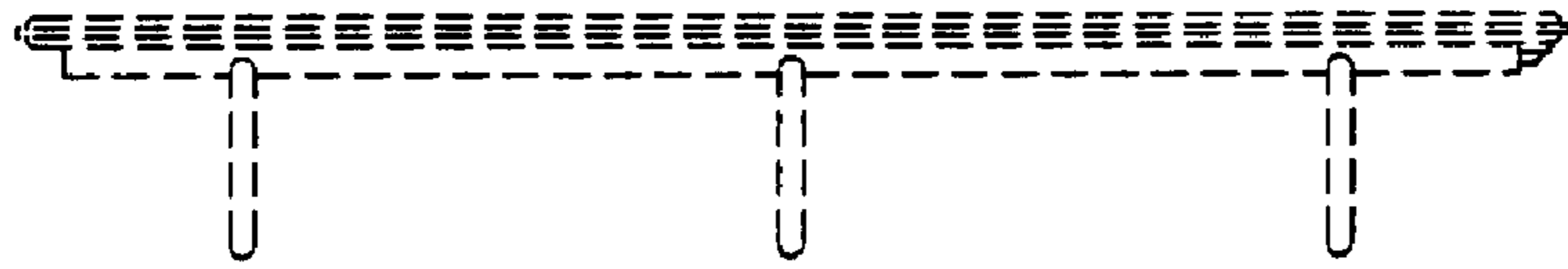

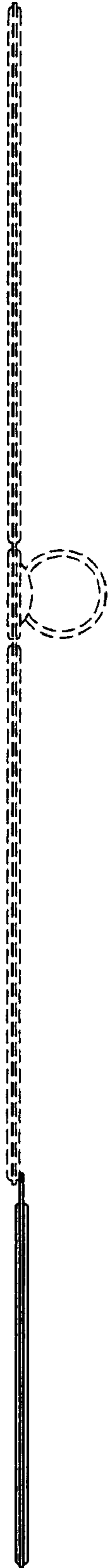

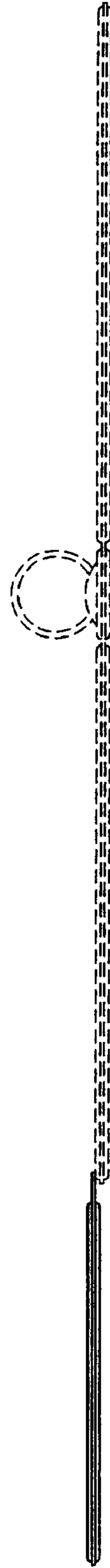
