(57) **CLAIM**

The ornamental design for full scale simulated household furnishing layouts, as shown and described.

FIG. 23 is a left side view, with the opposite side being a mirror image thereof;

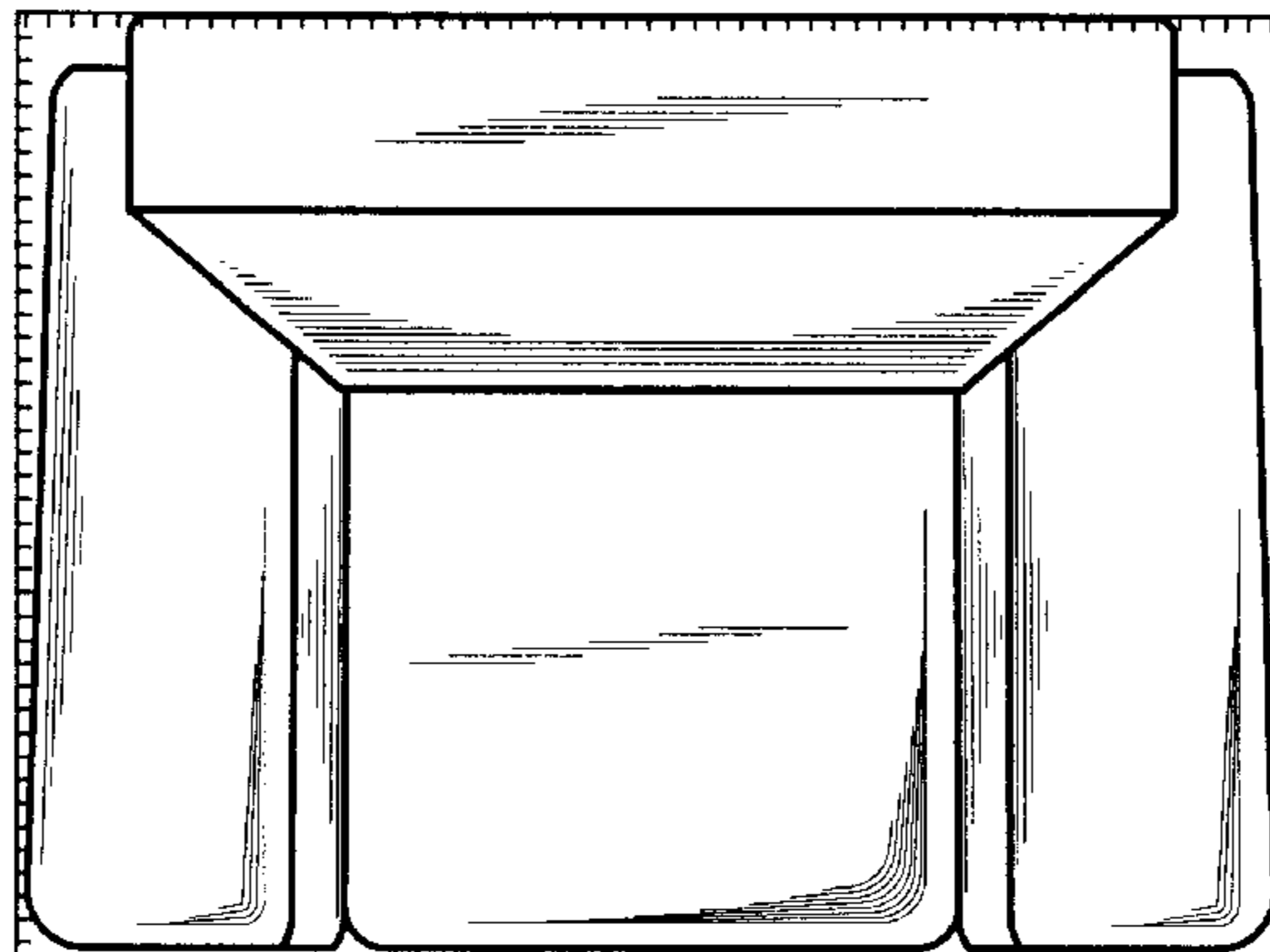


FIG. 24 is a front view with the opposite side being a mirror image thereof;

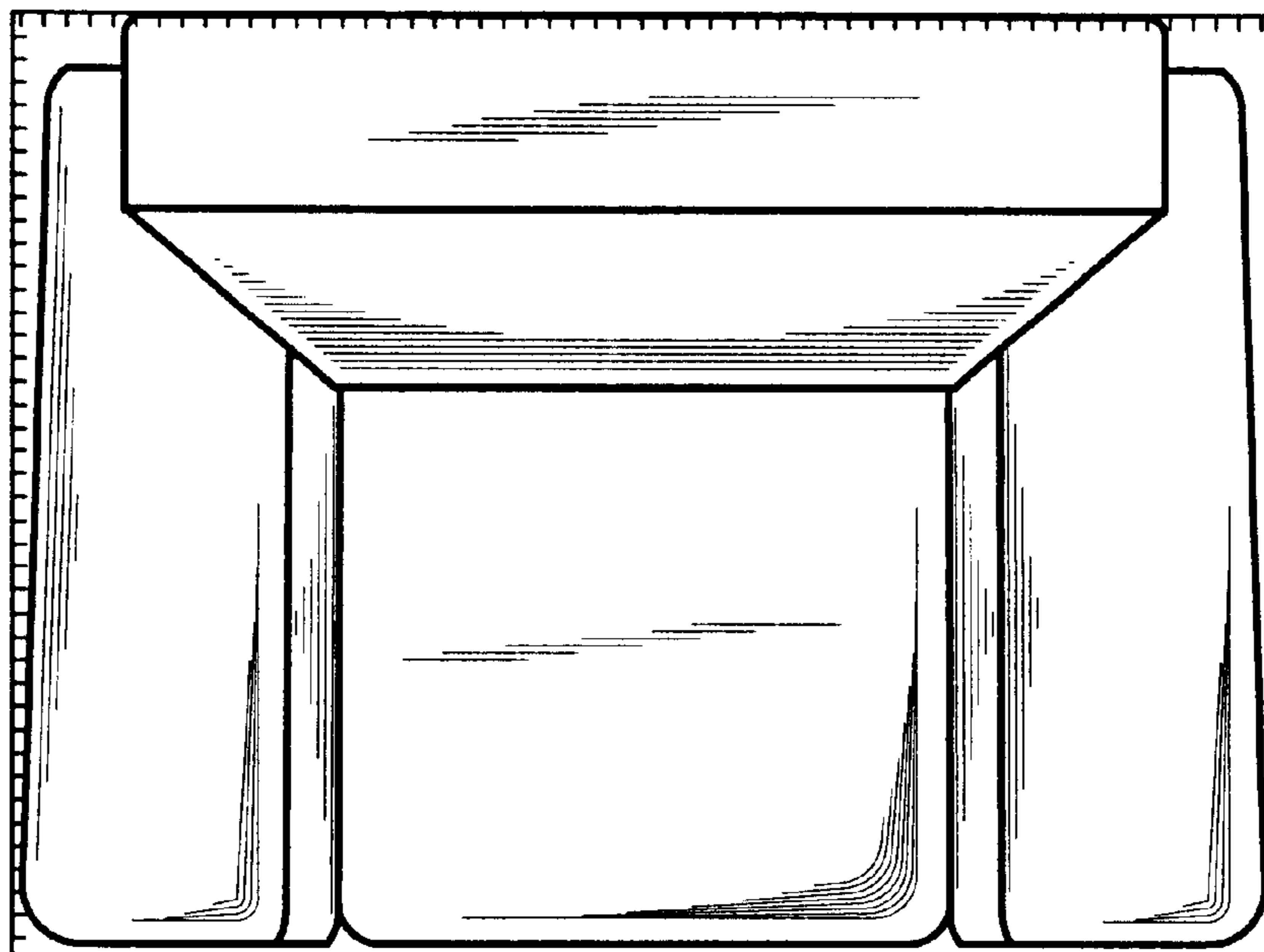

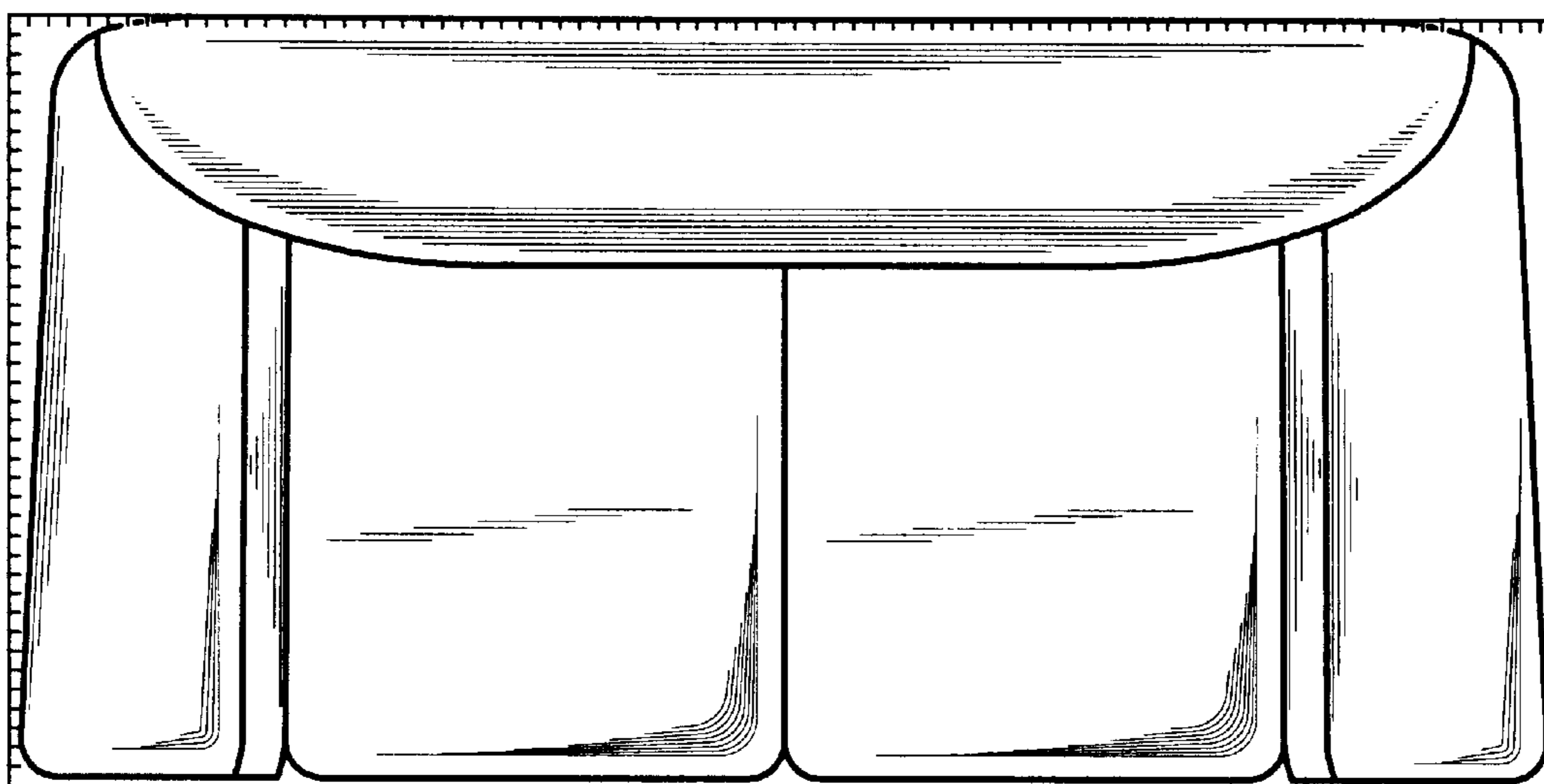

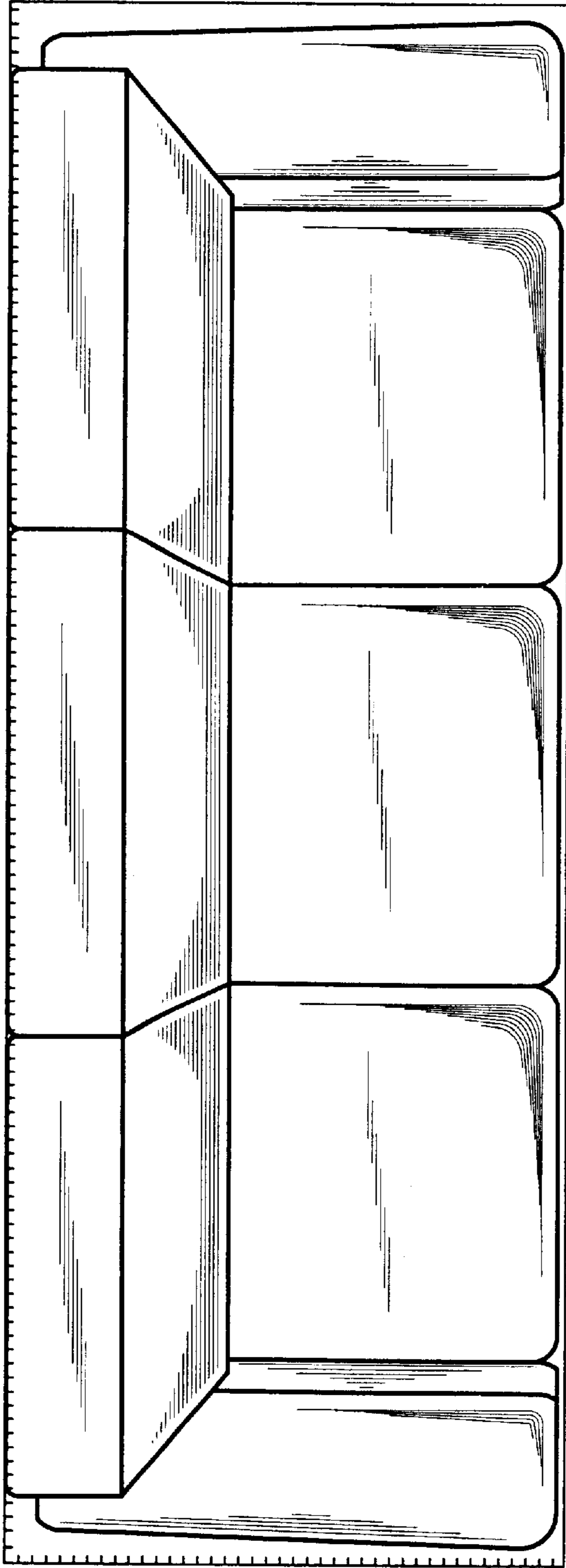

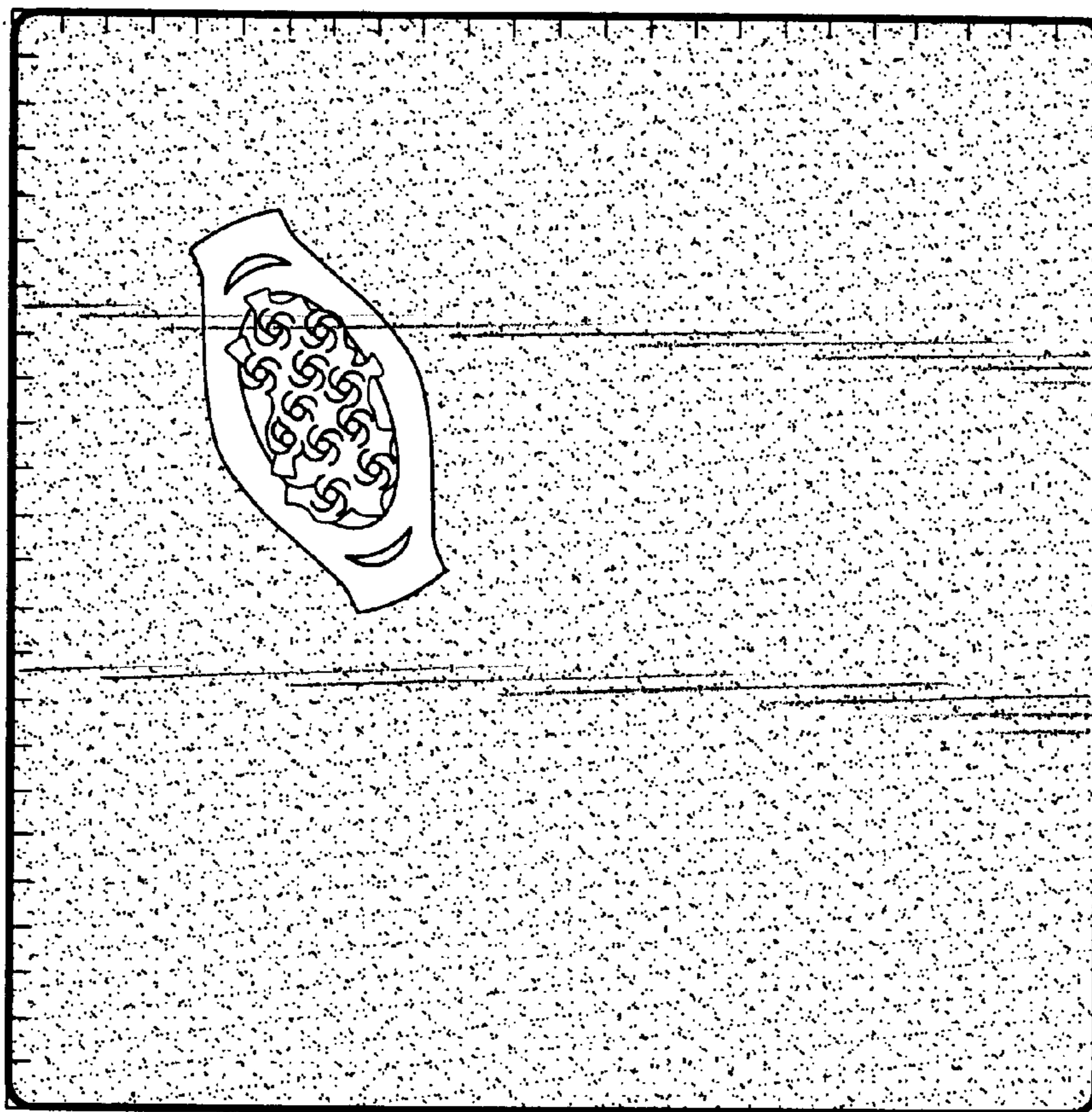

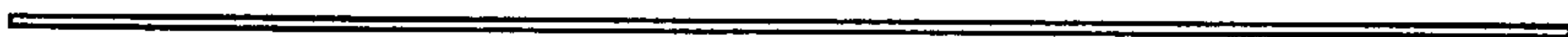

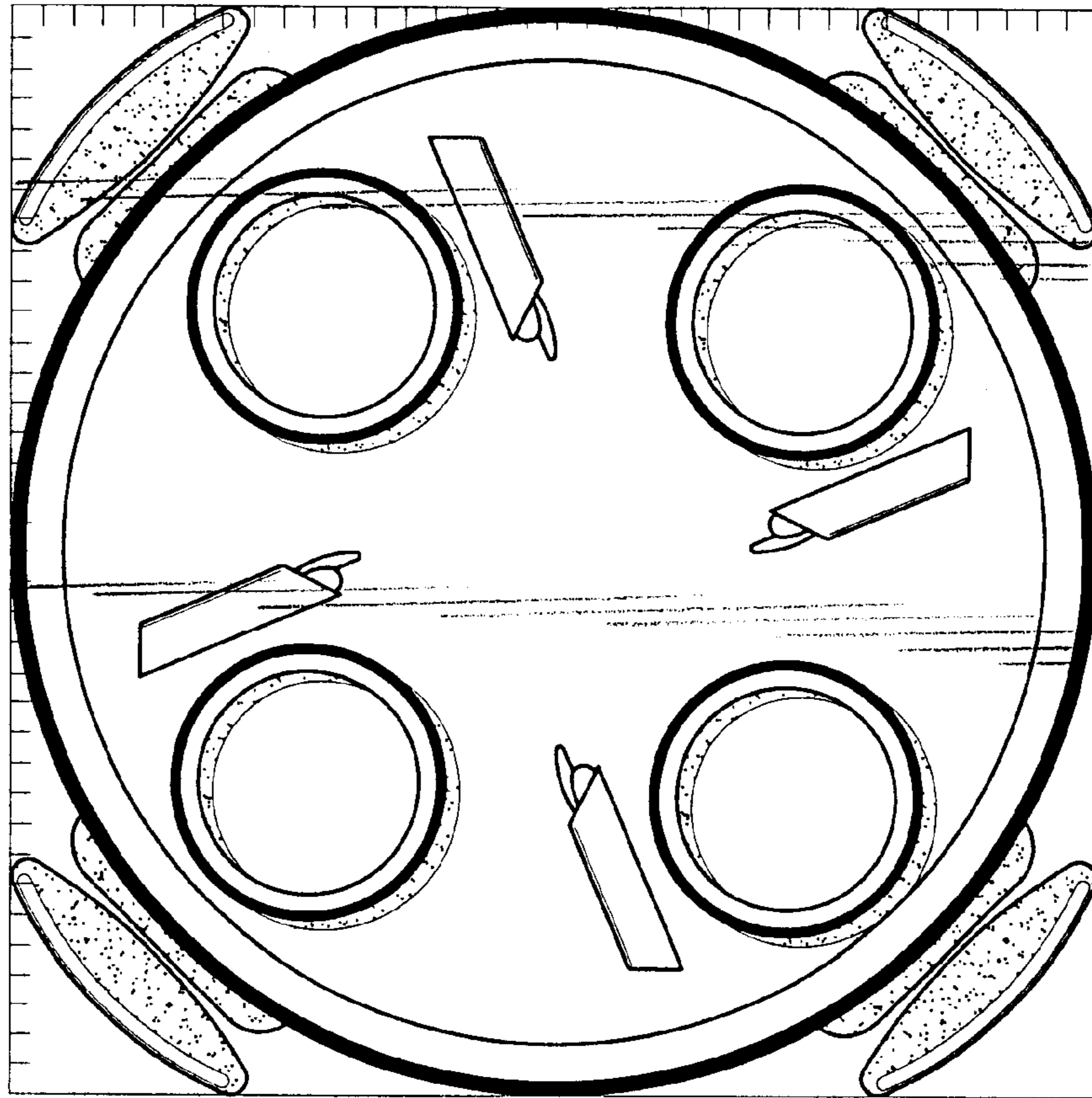

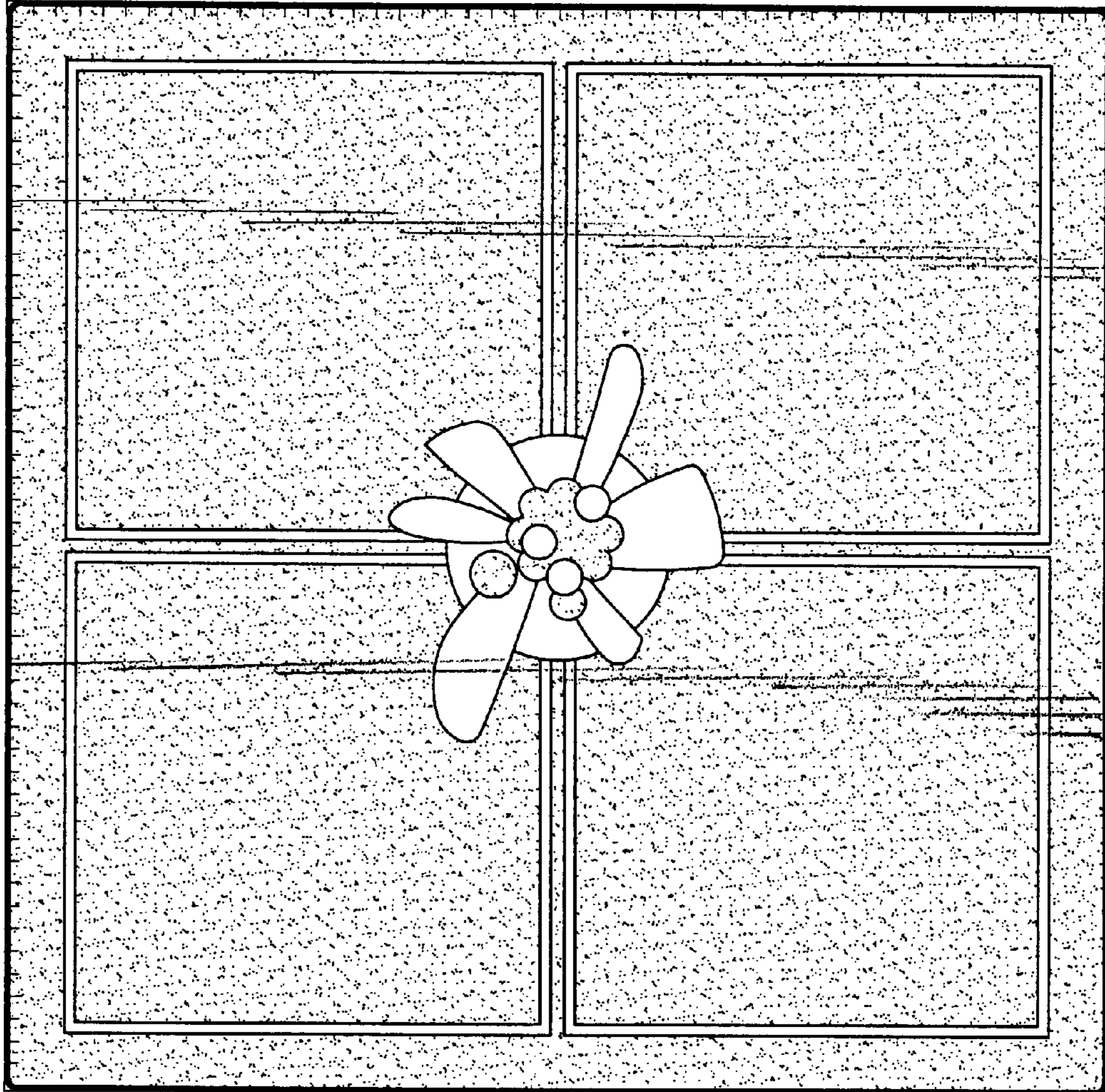

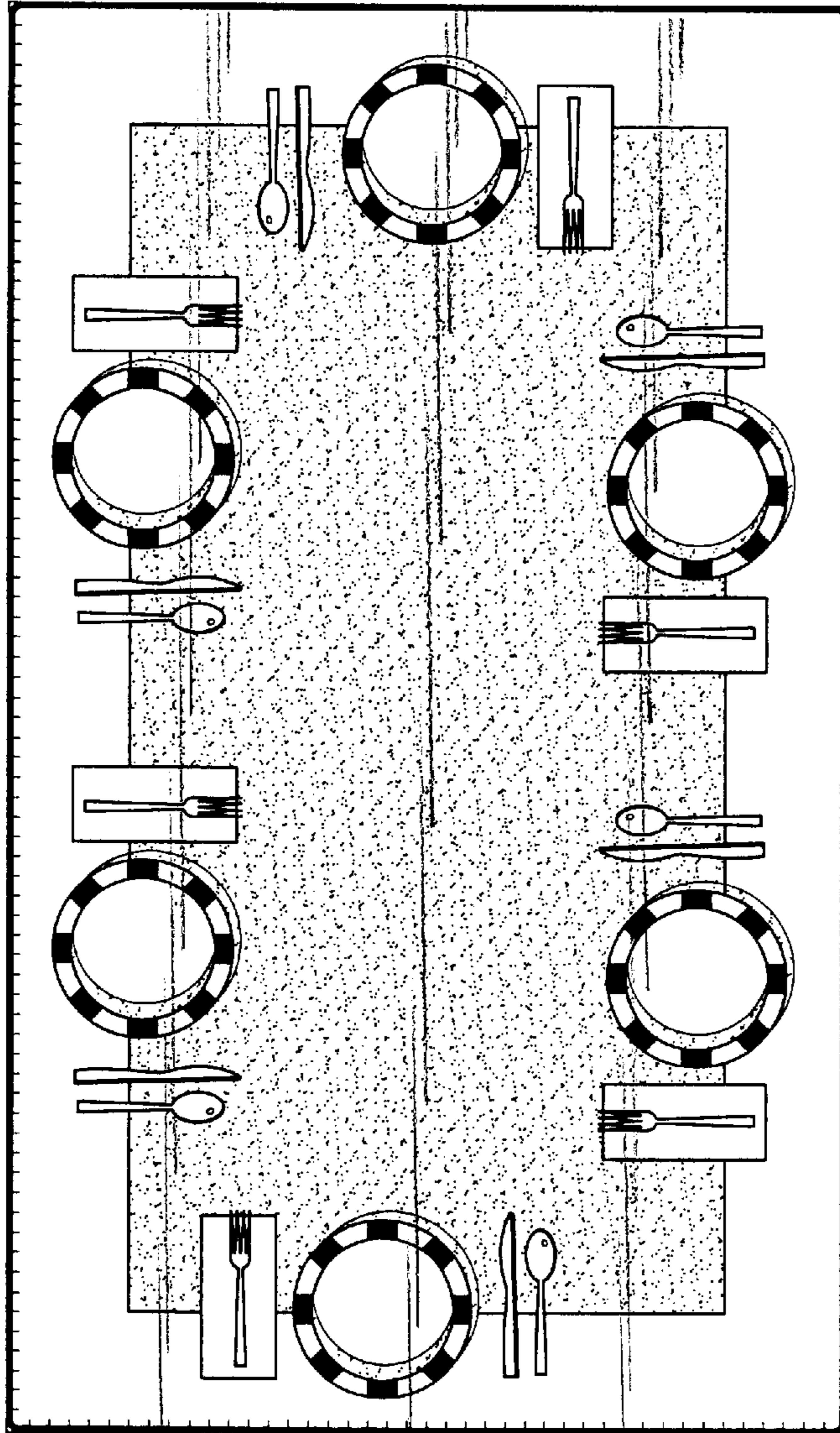

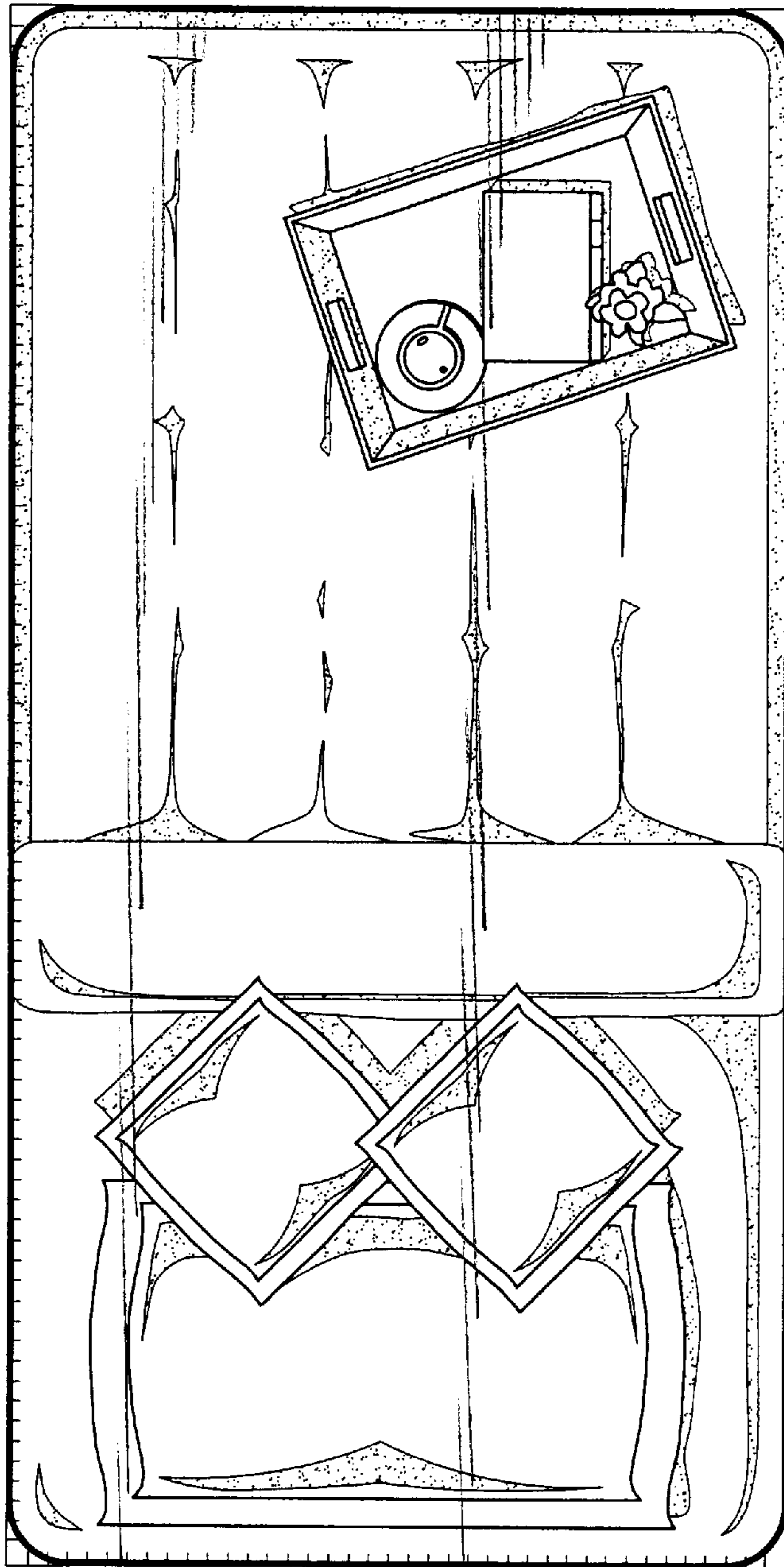

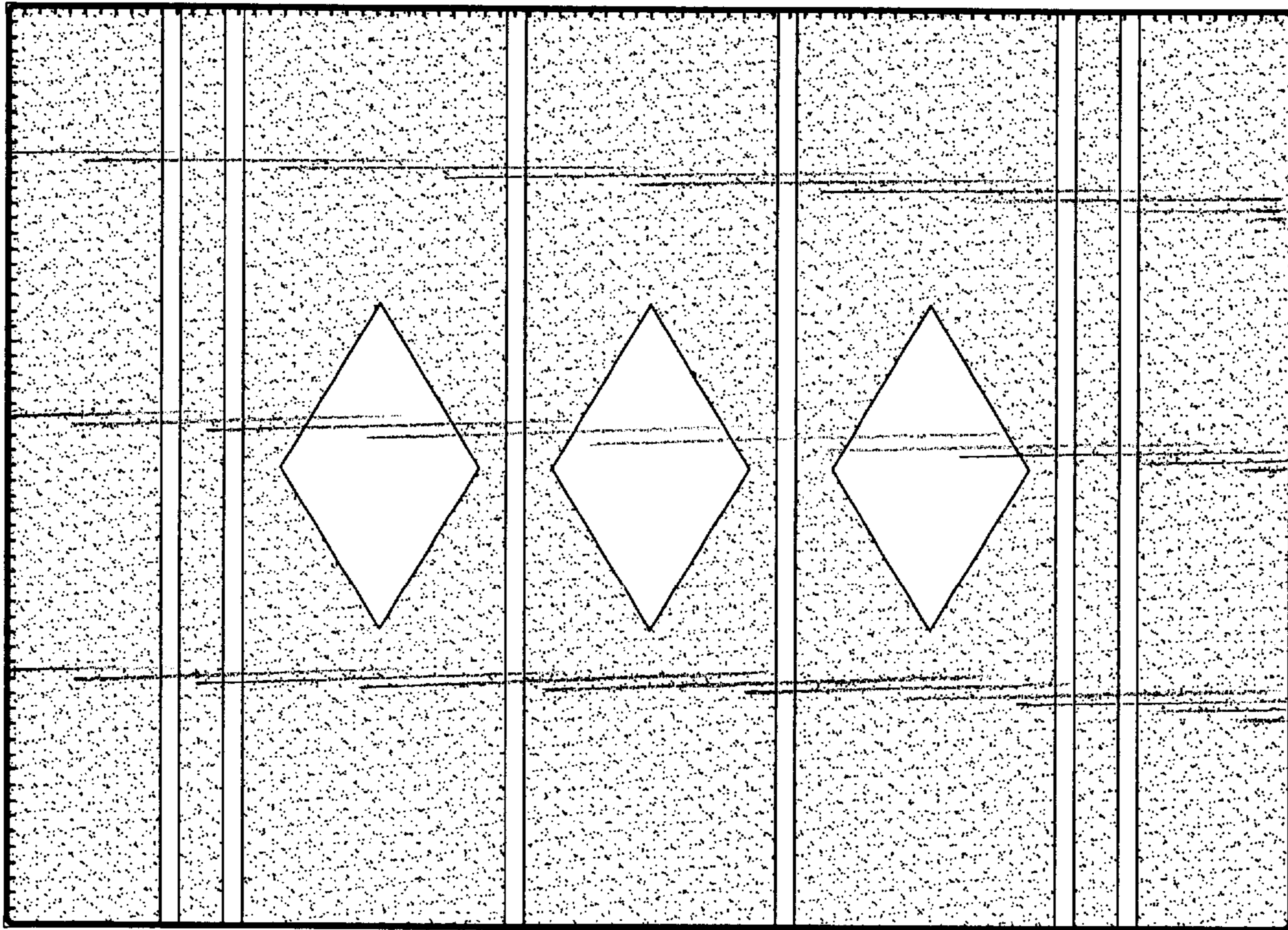

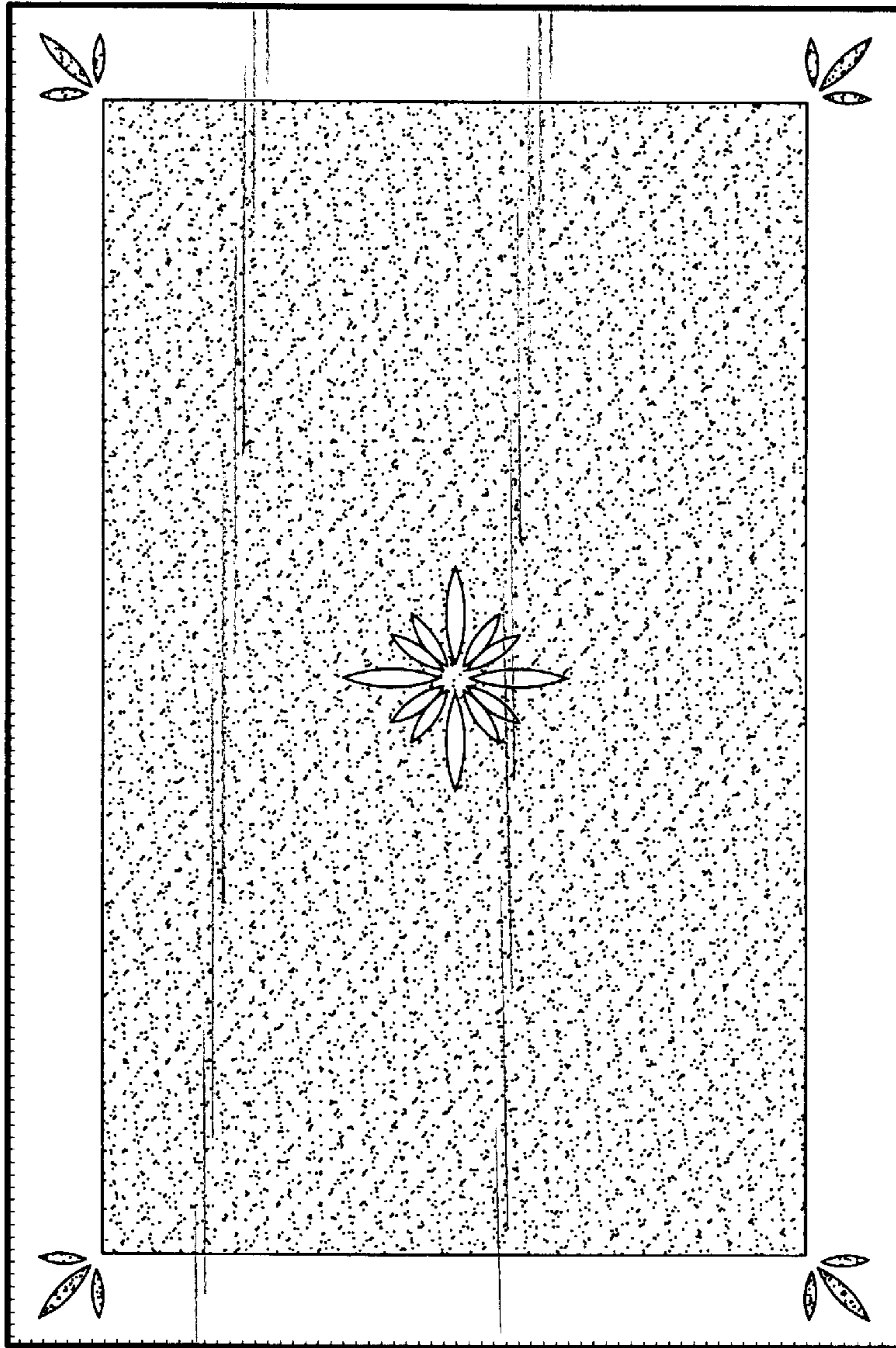

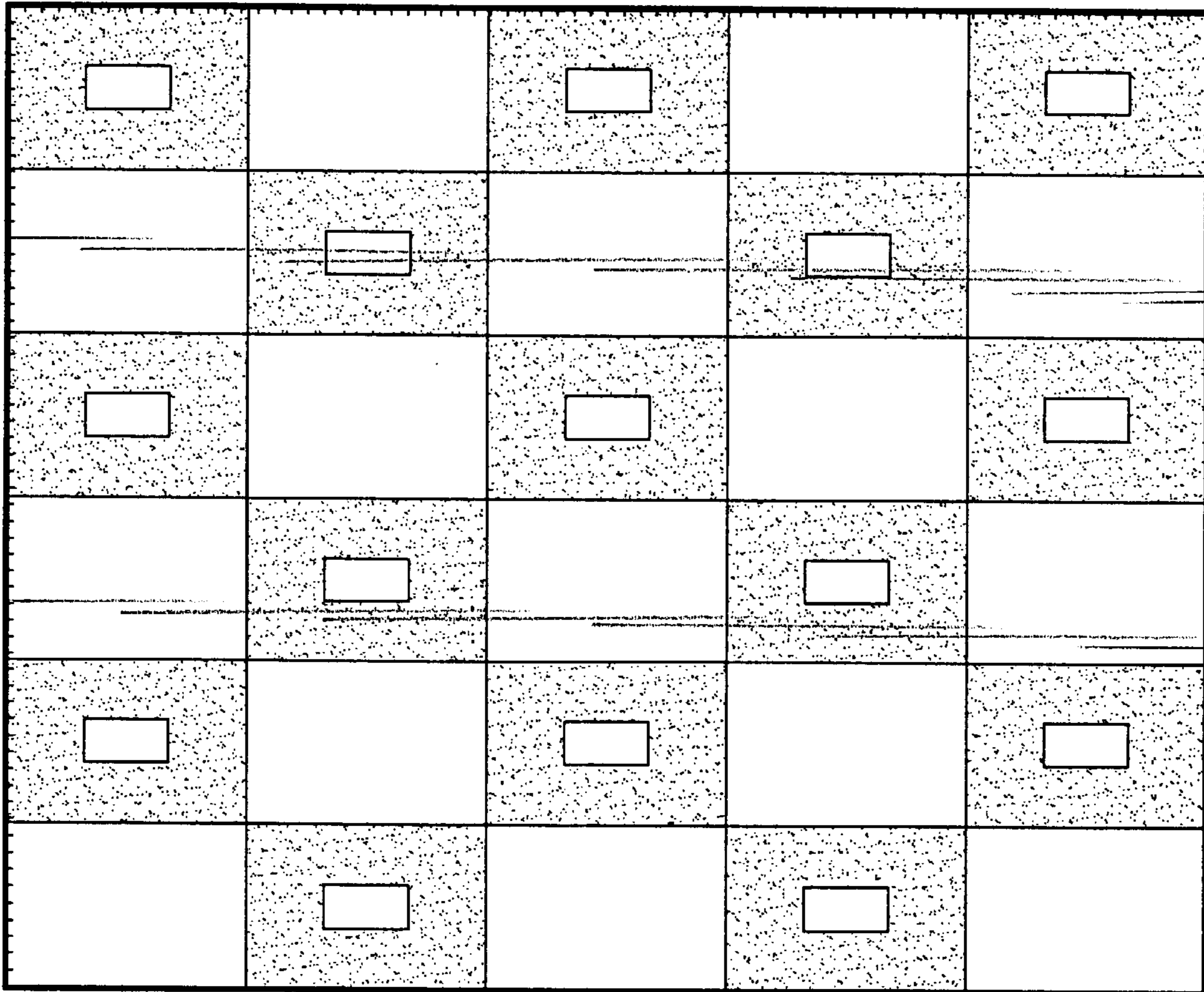

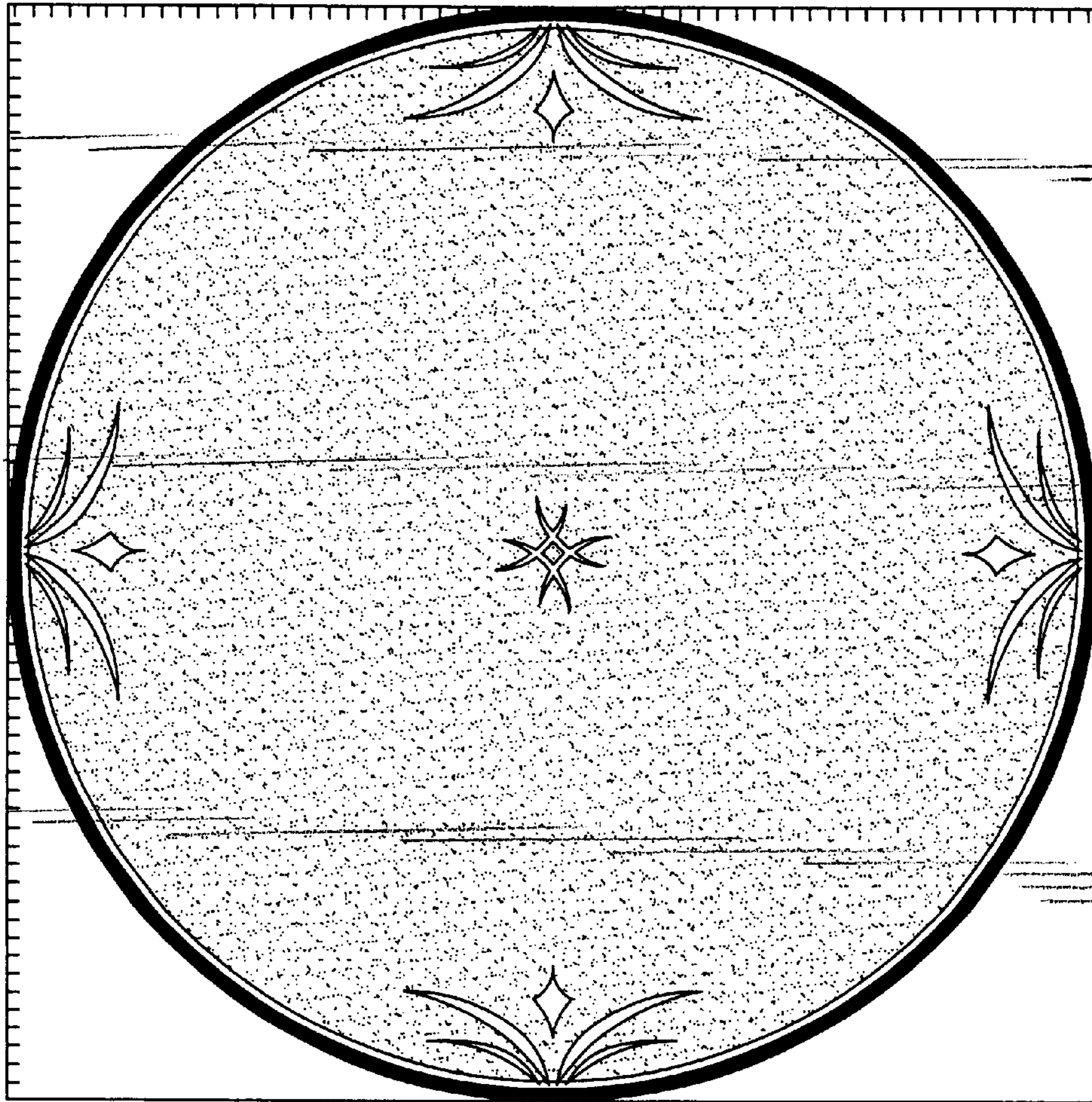

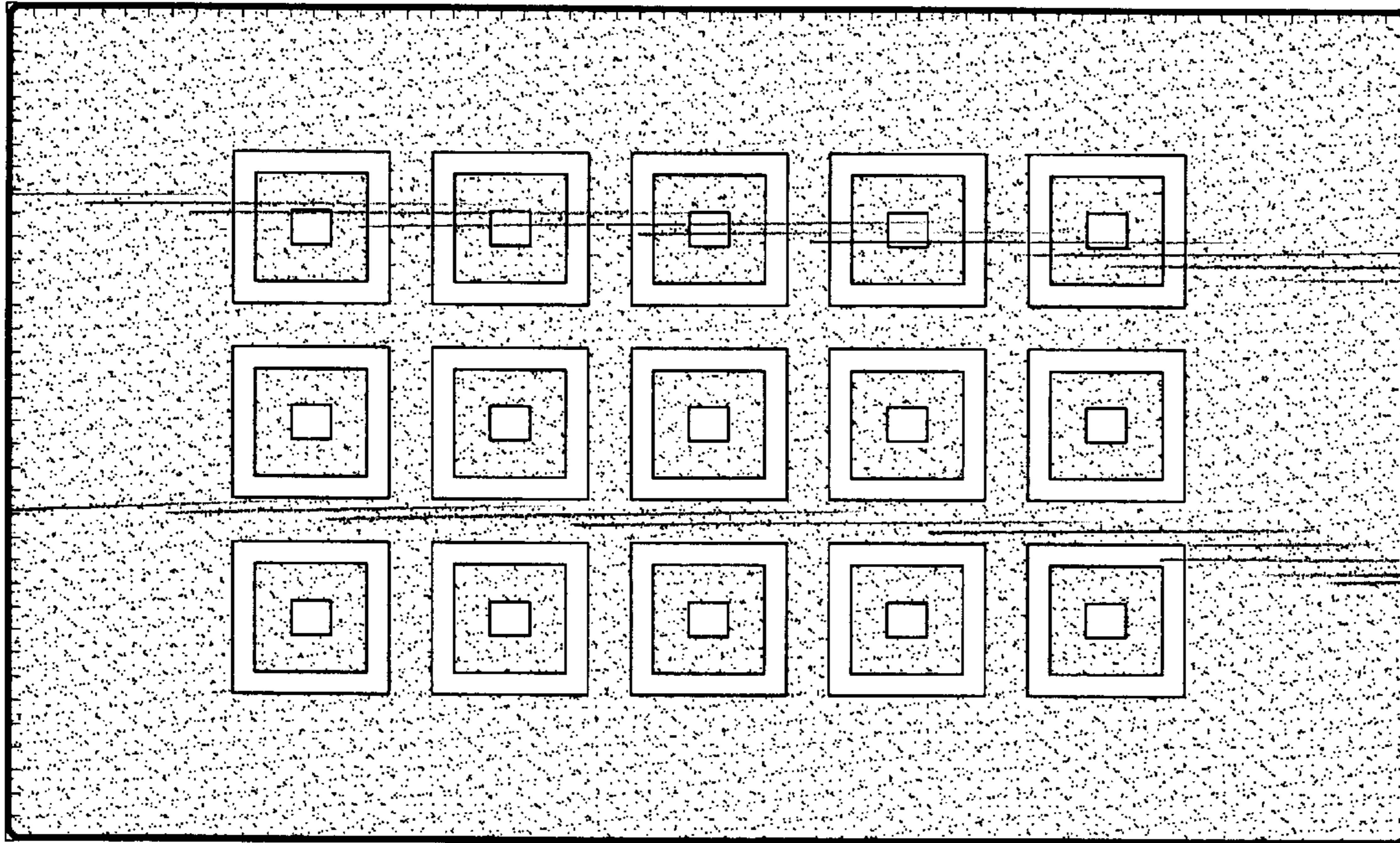

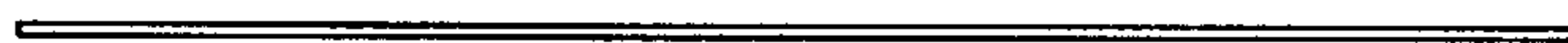

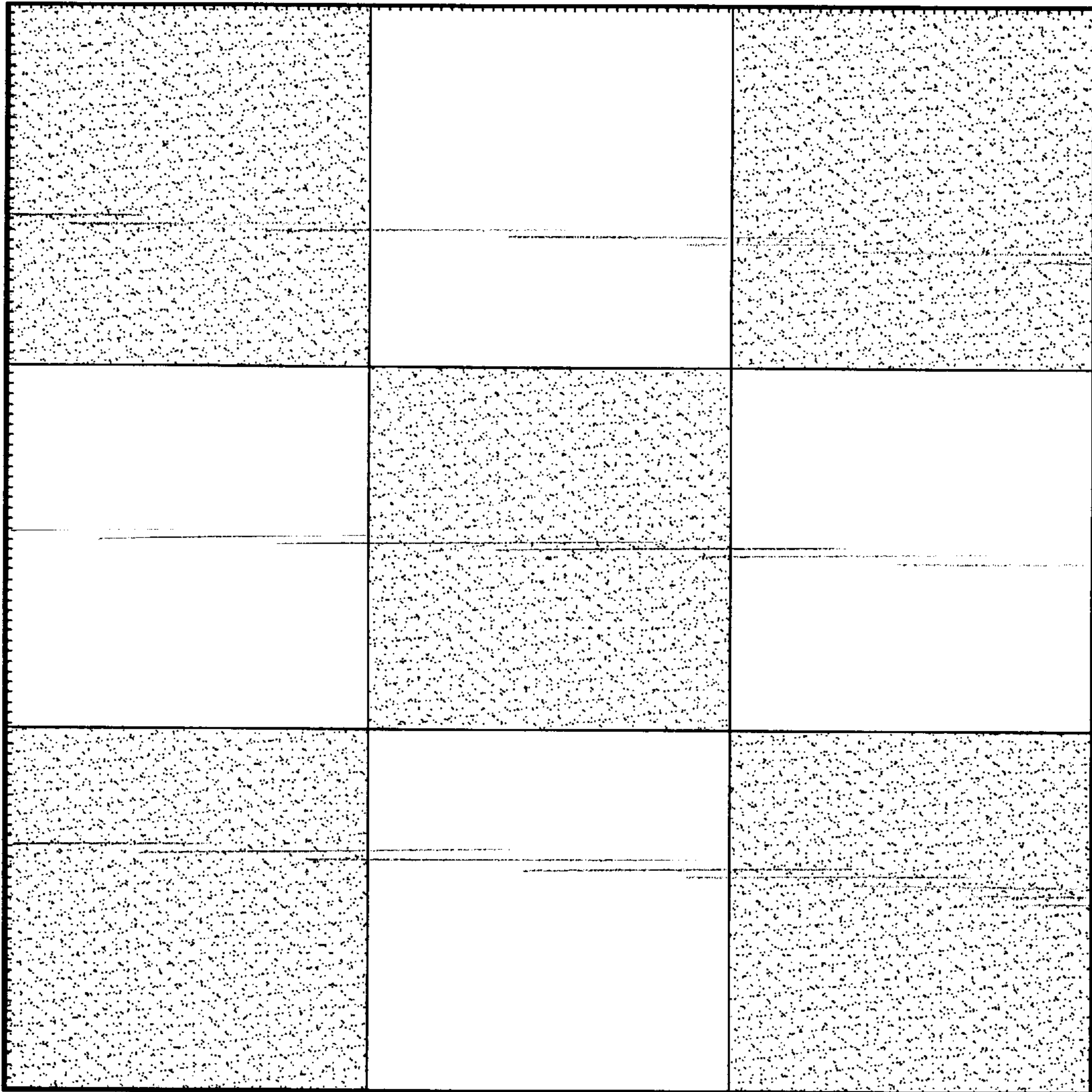

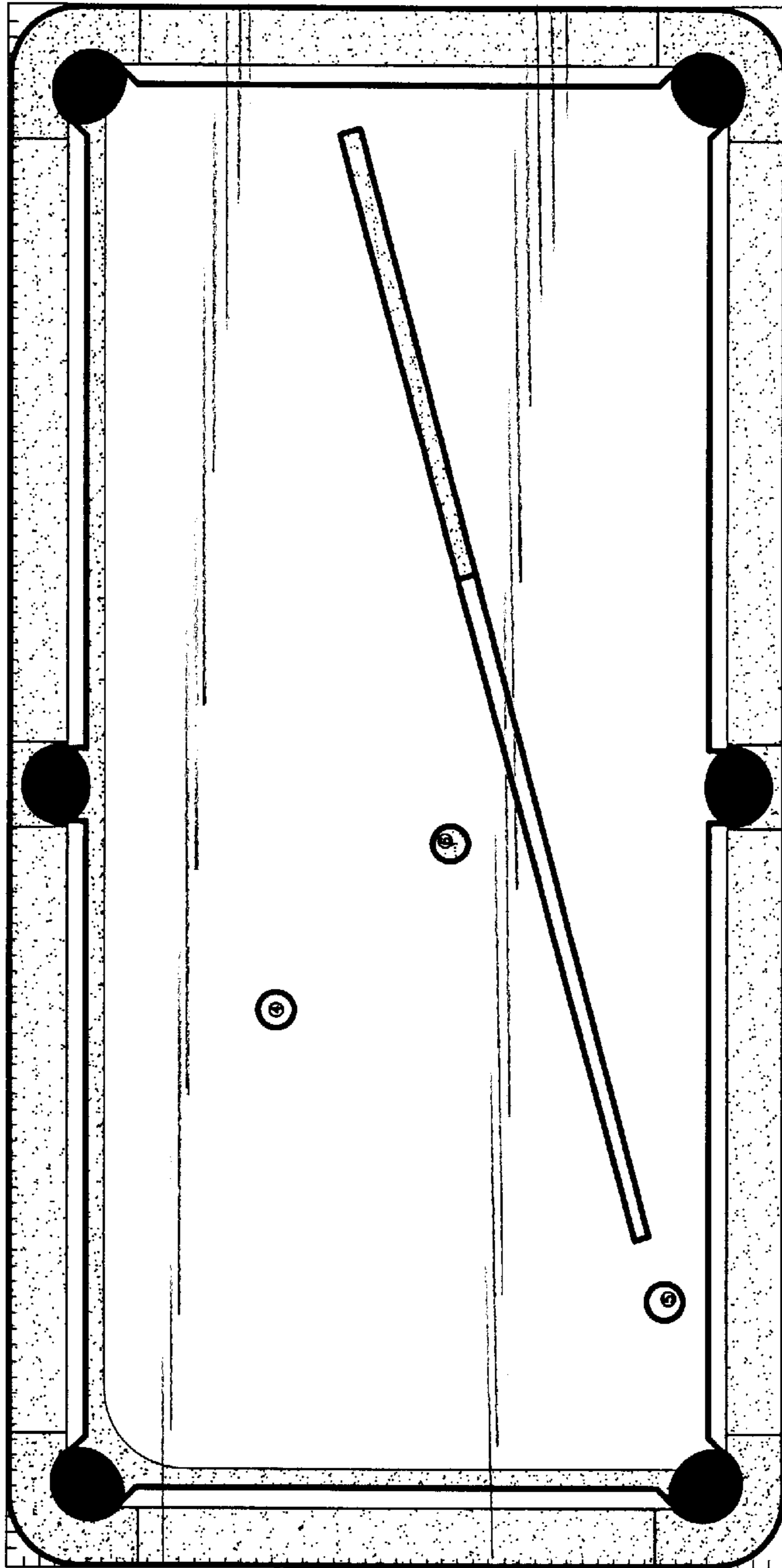
