The ornamental design for a card game, as shown and described.

**DESCRIPTION**

 FIG. 29 is a front plan view of an eighth card showing my new design;

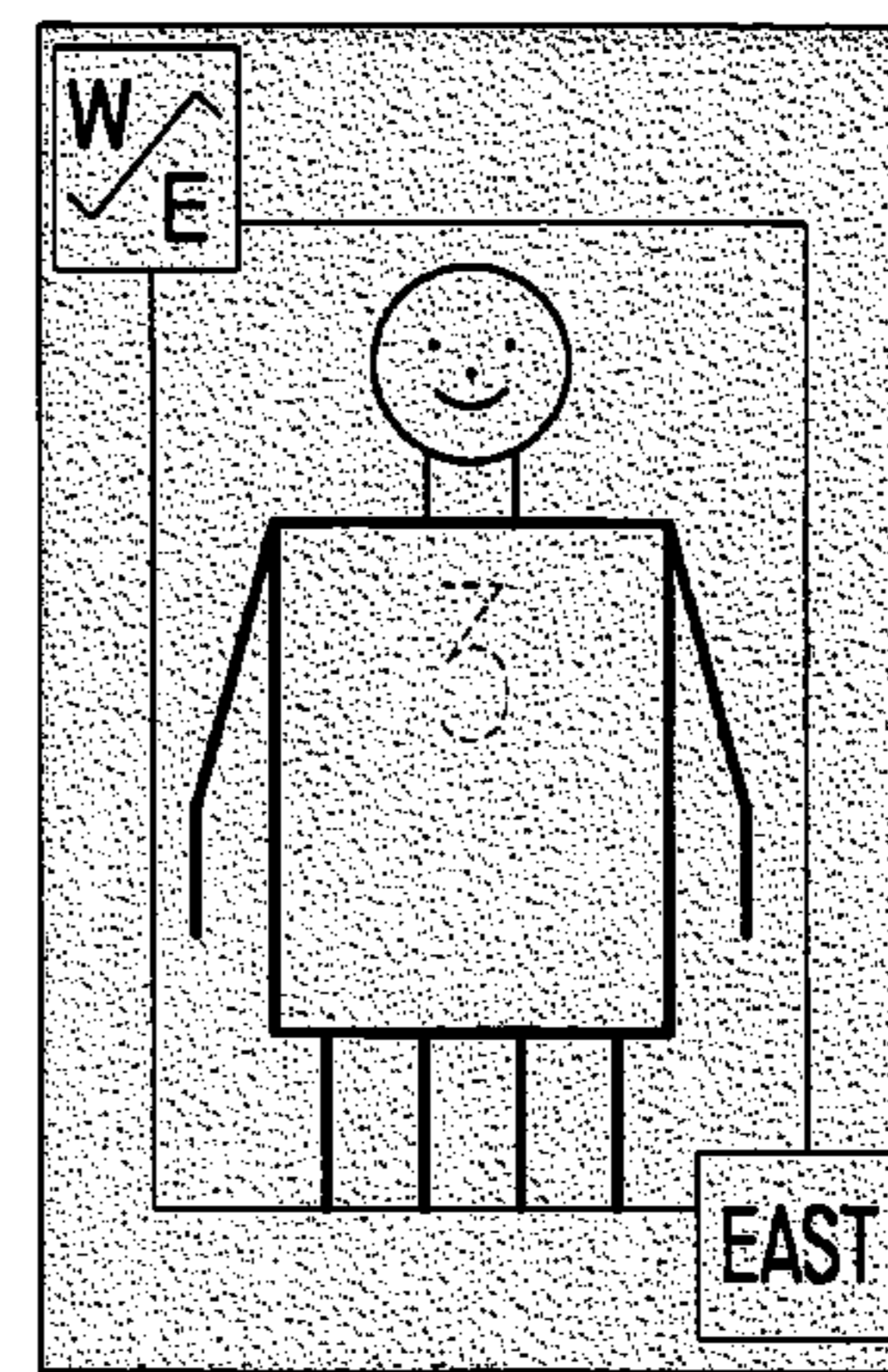
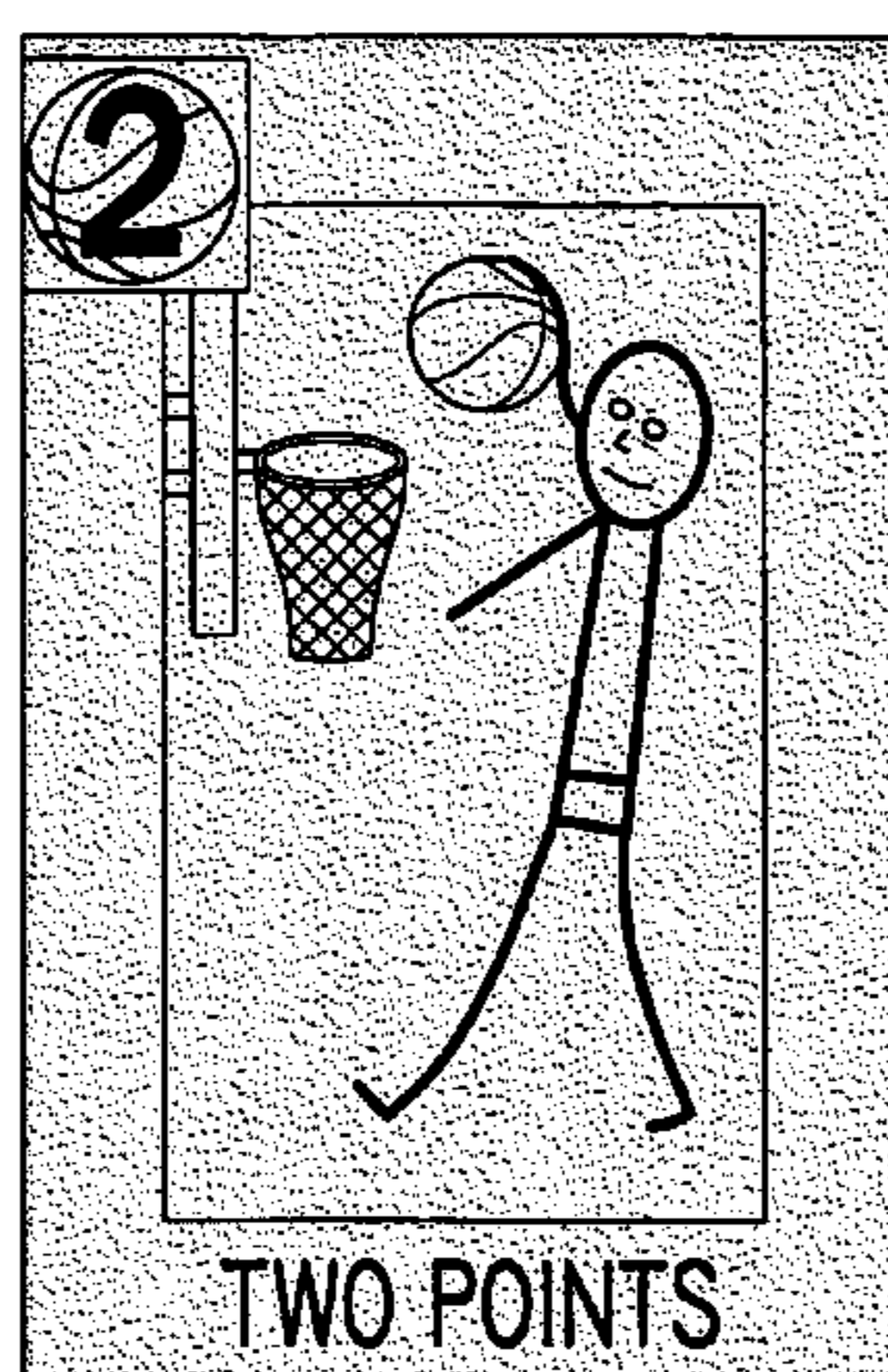
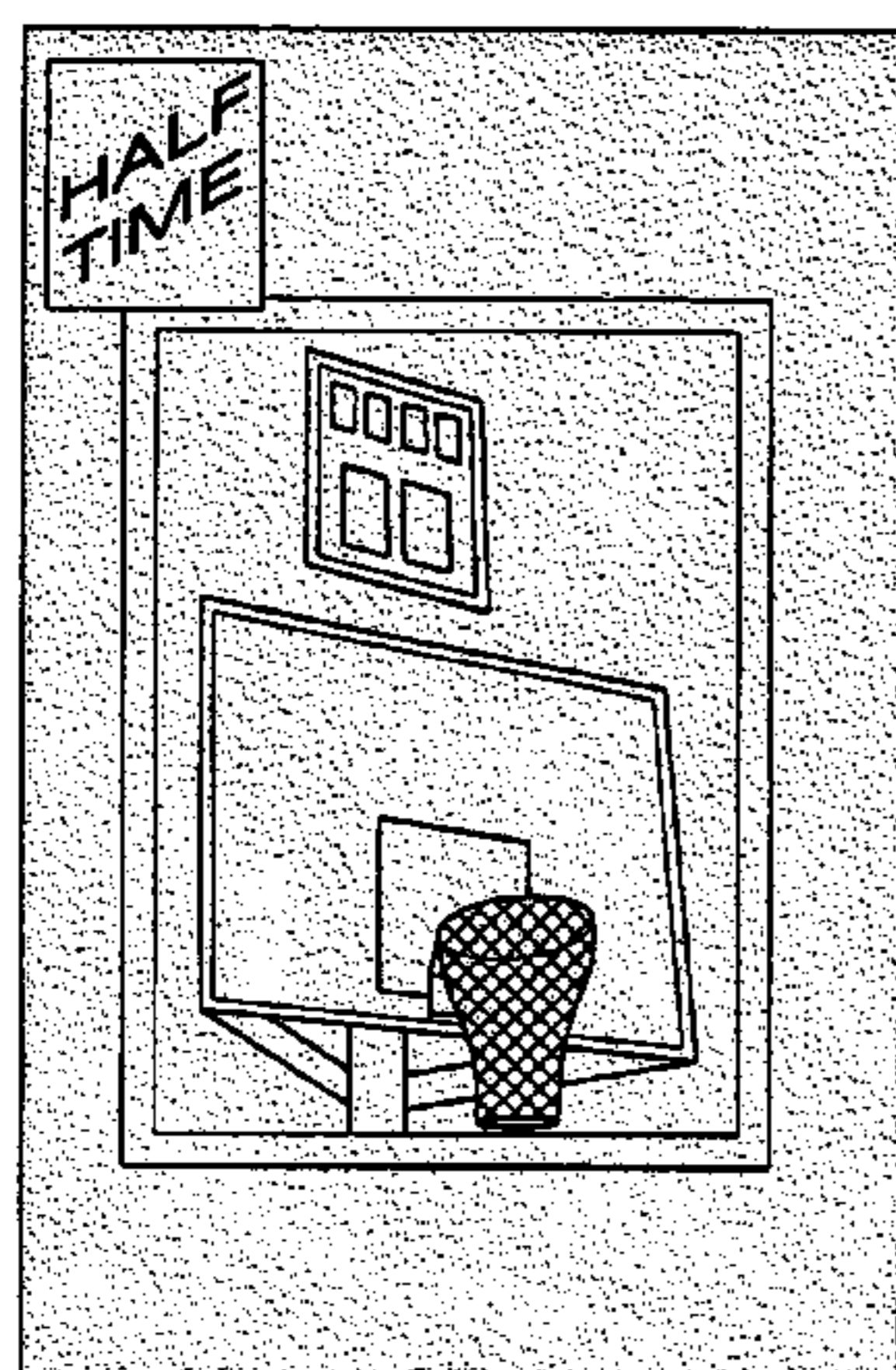
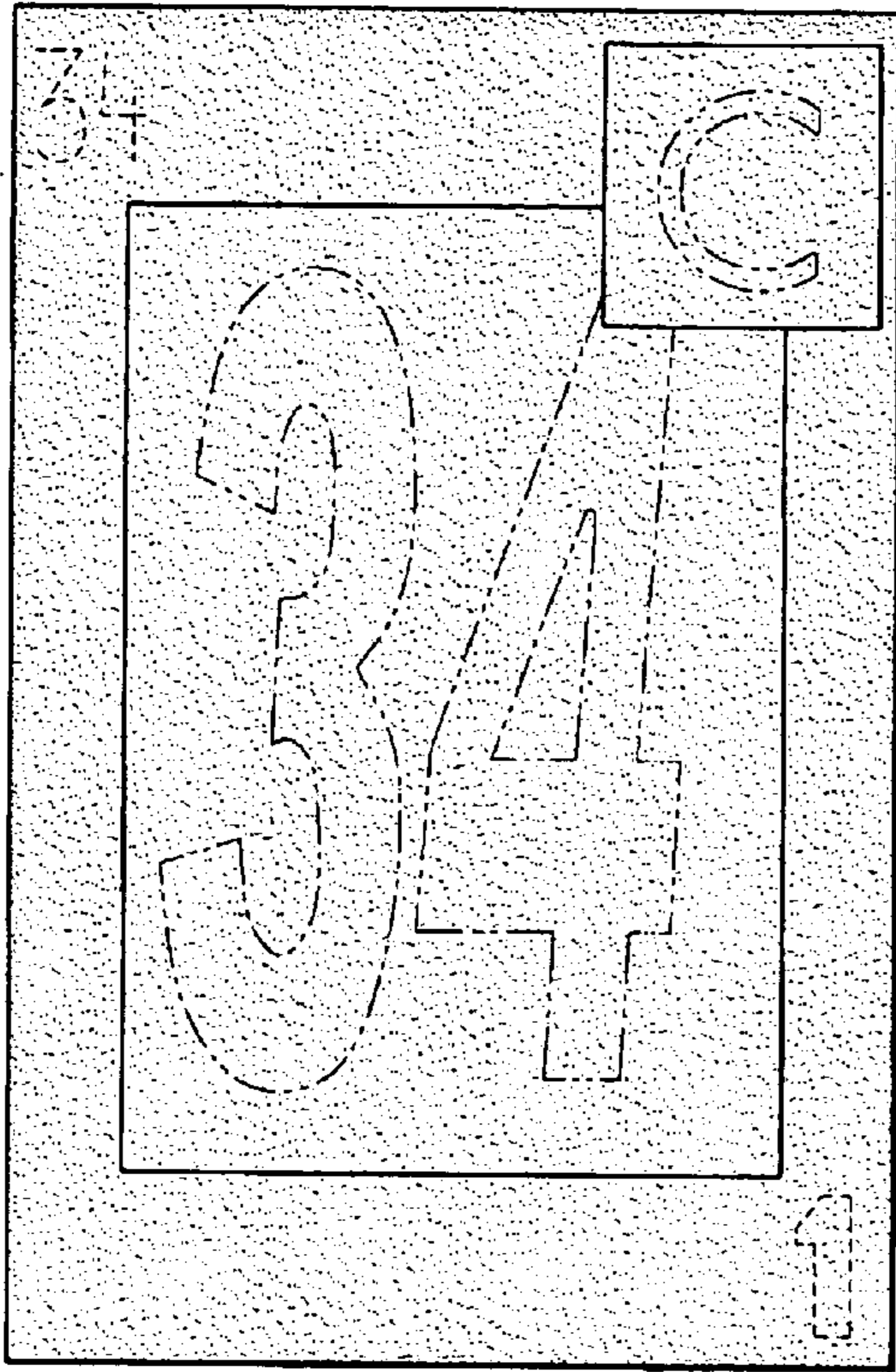

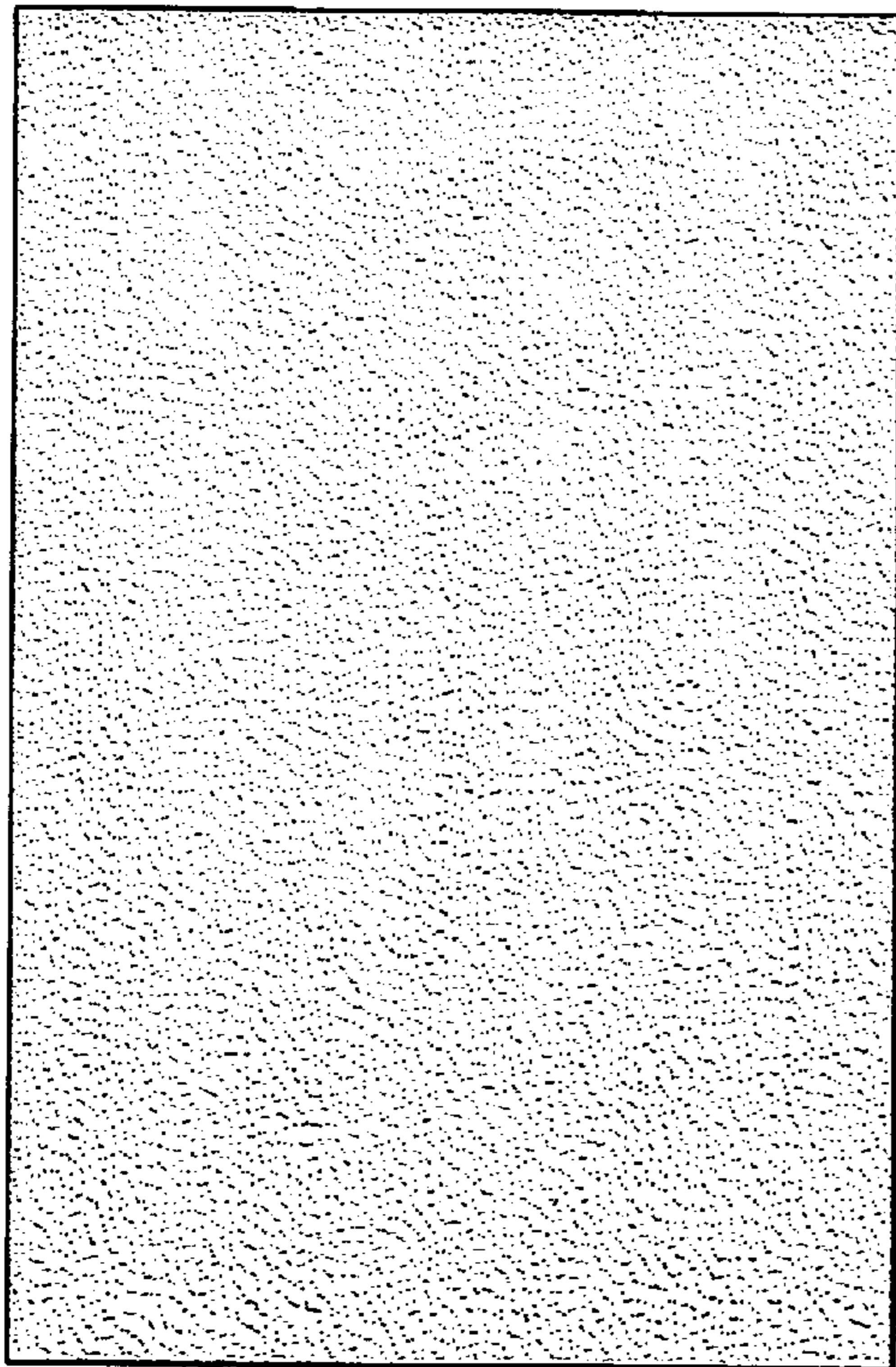

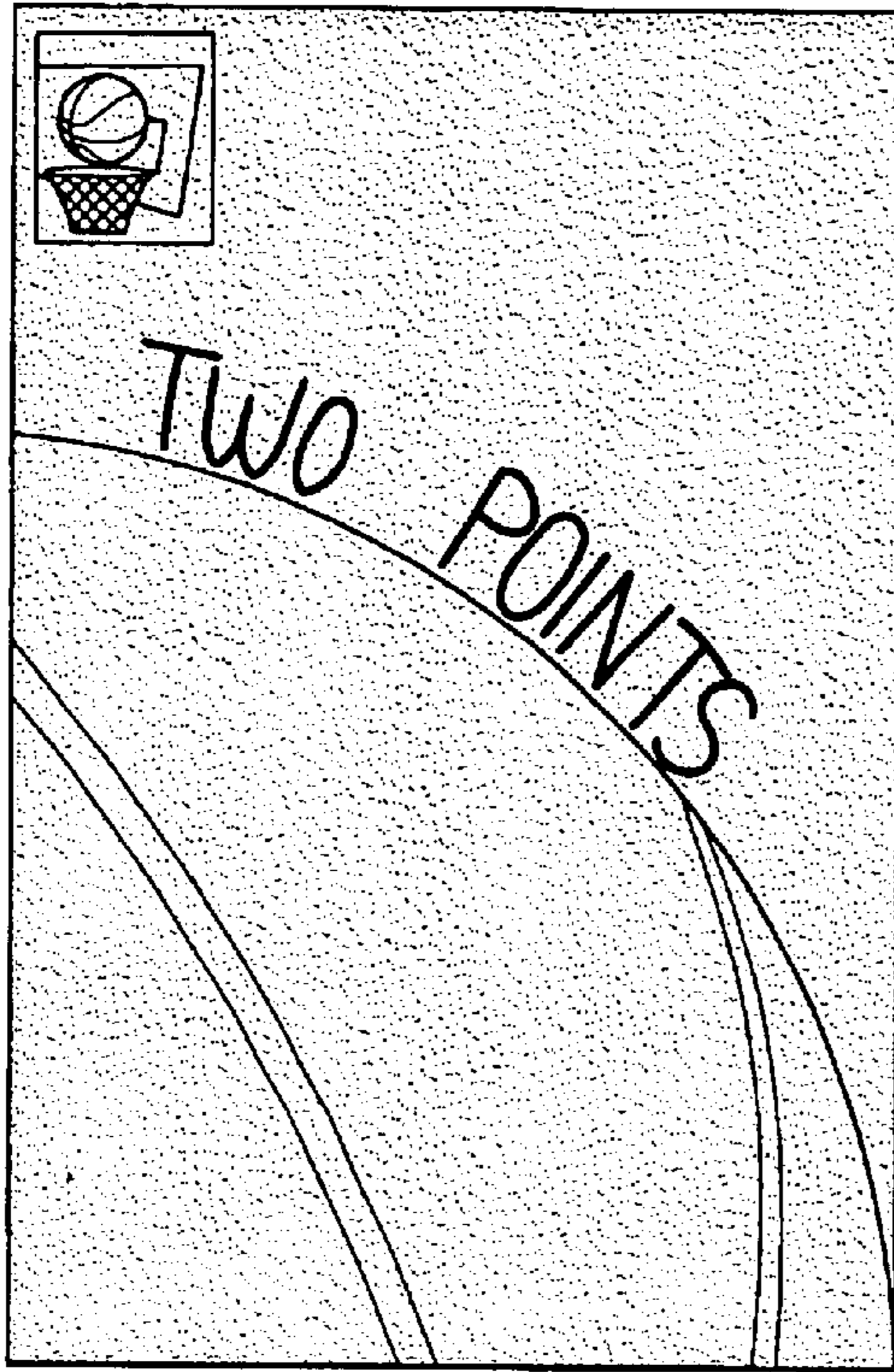

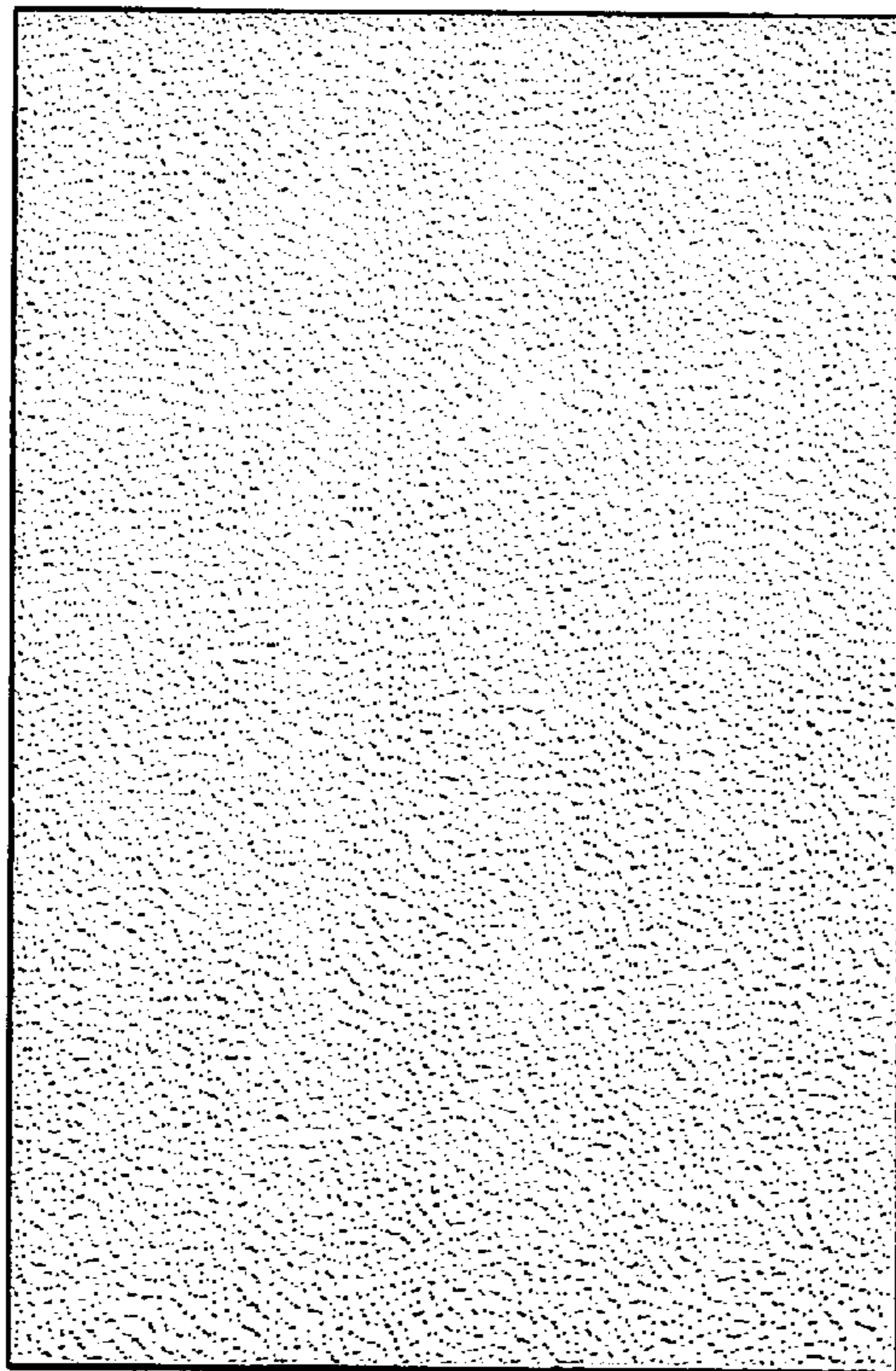

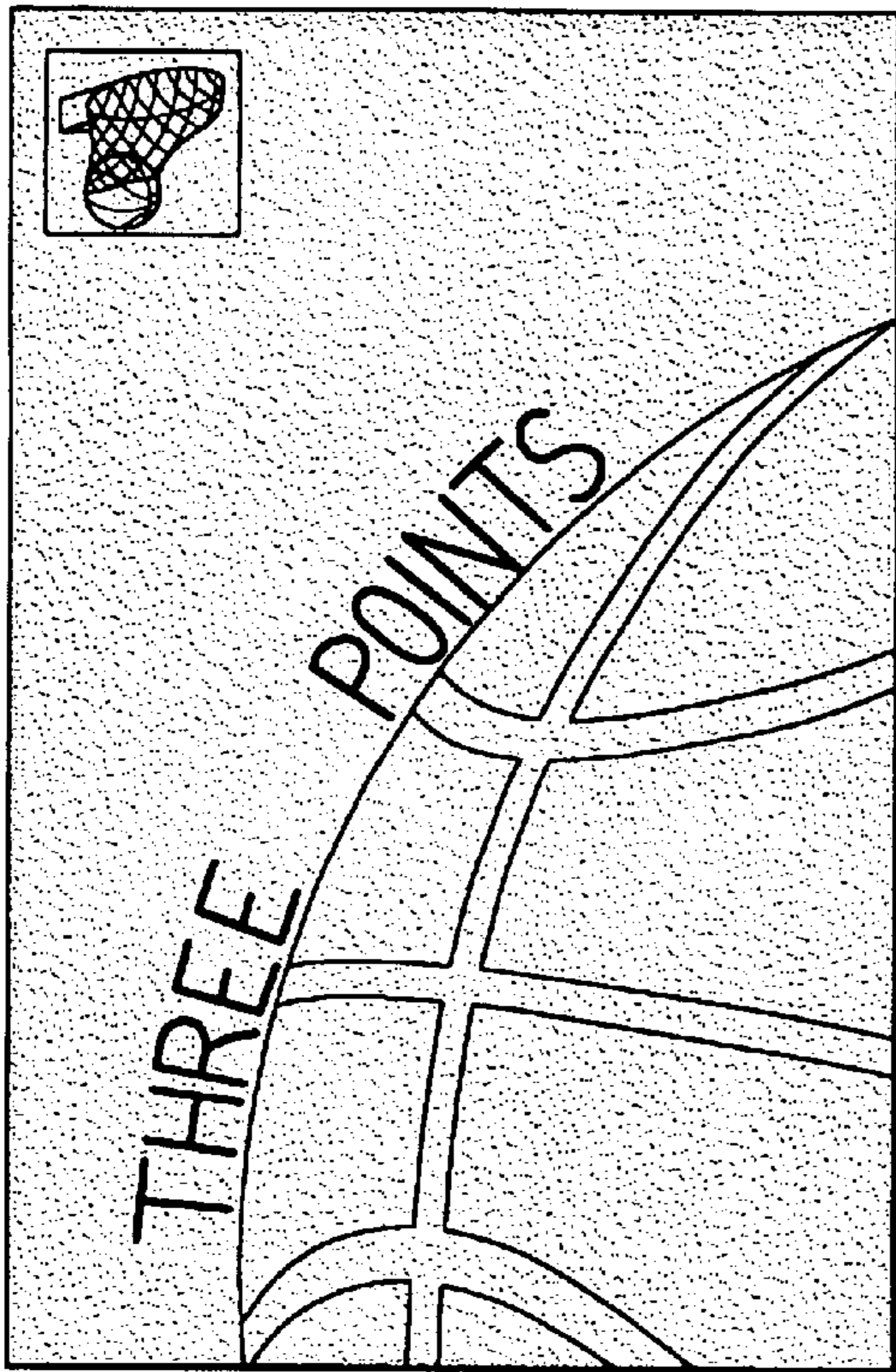

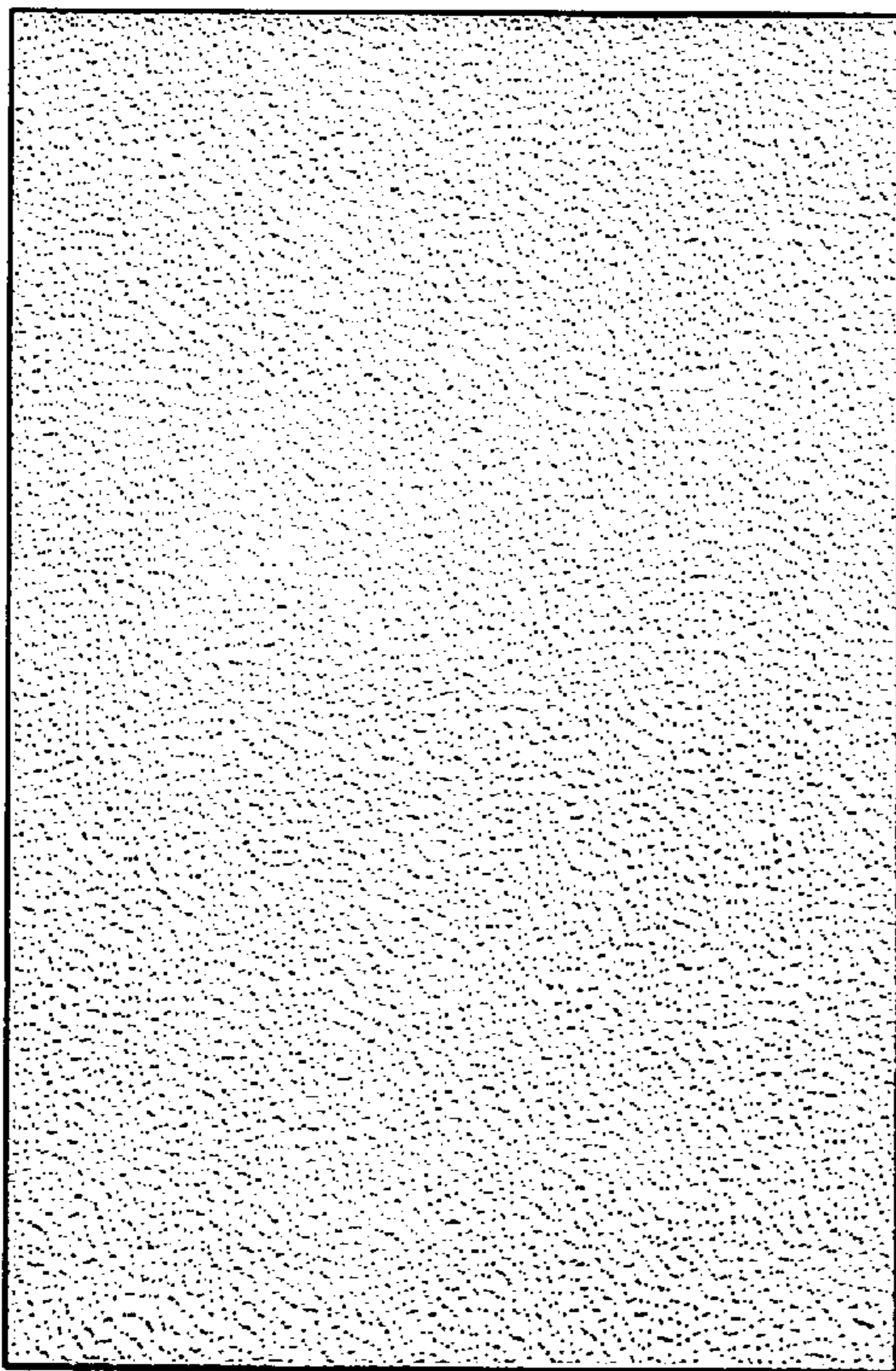

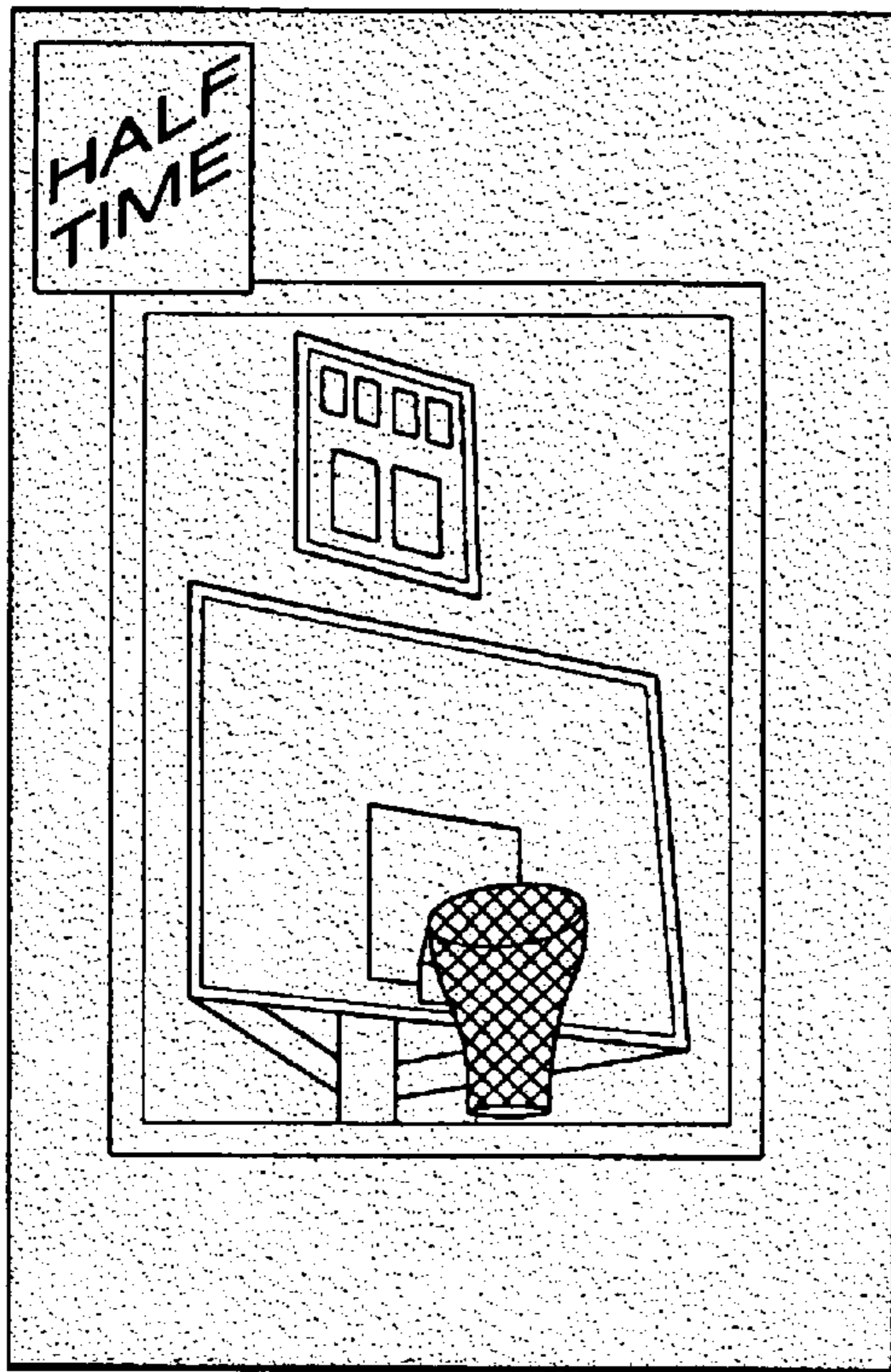

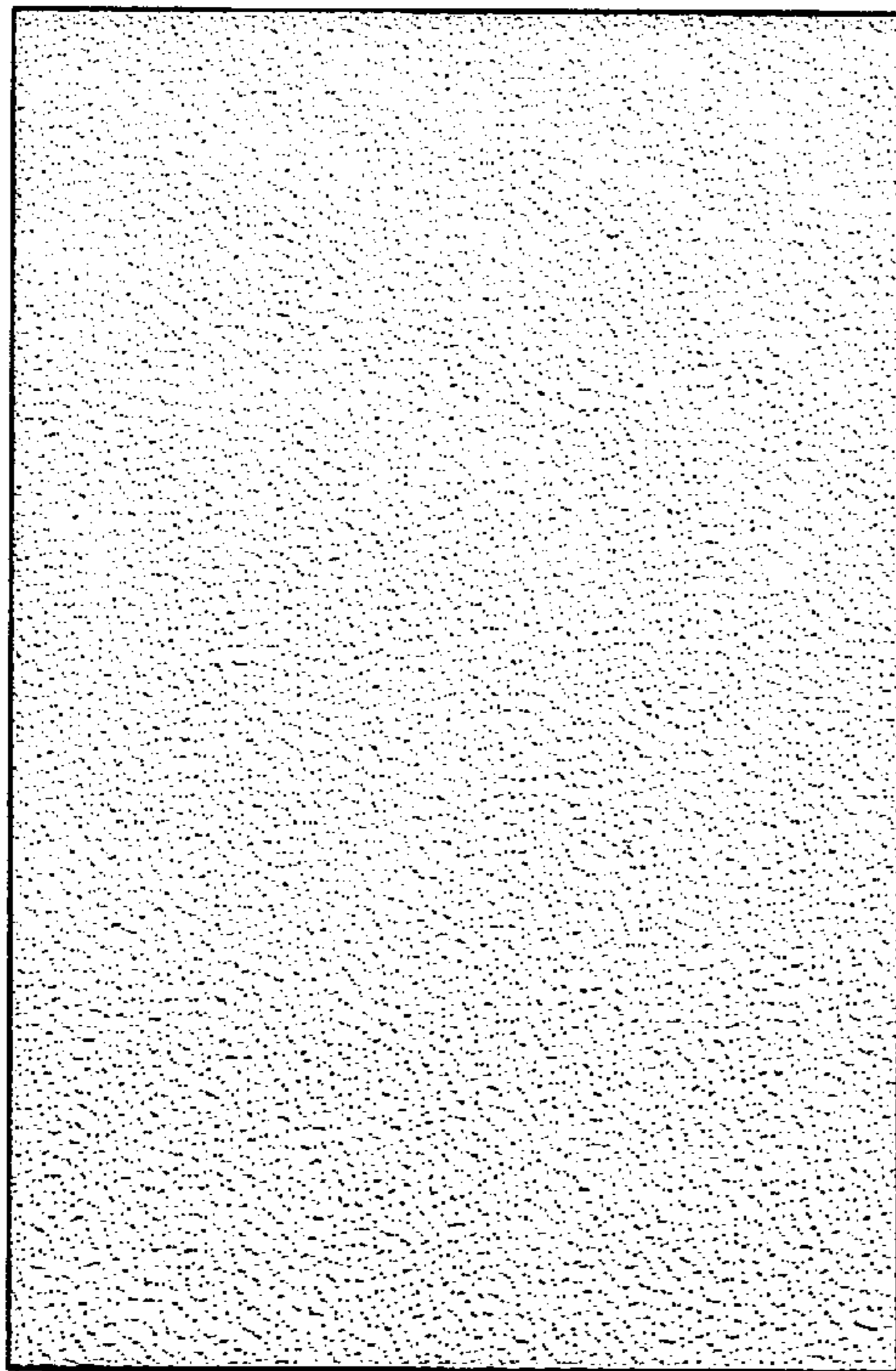

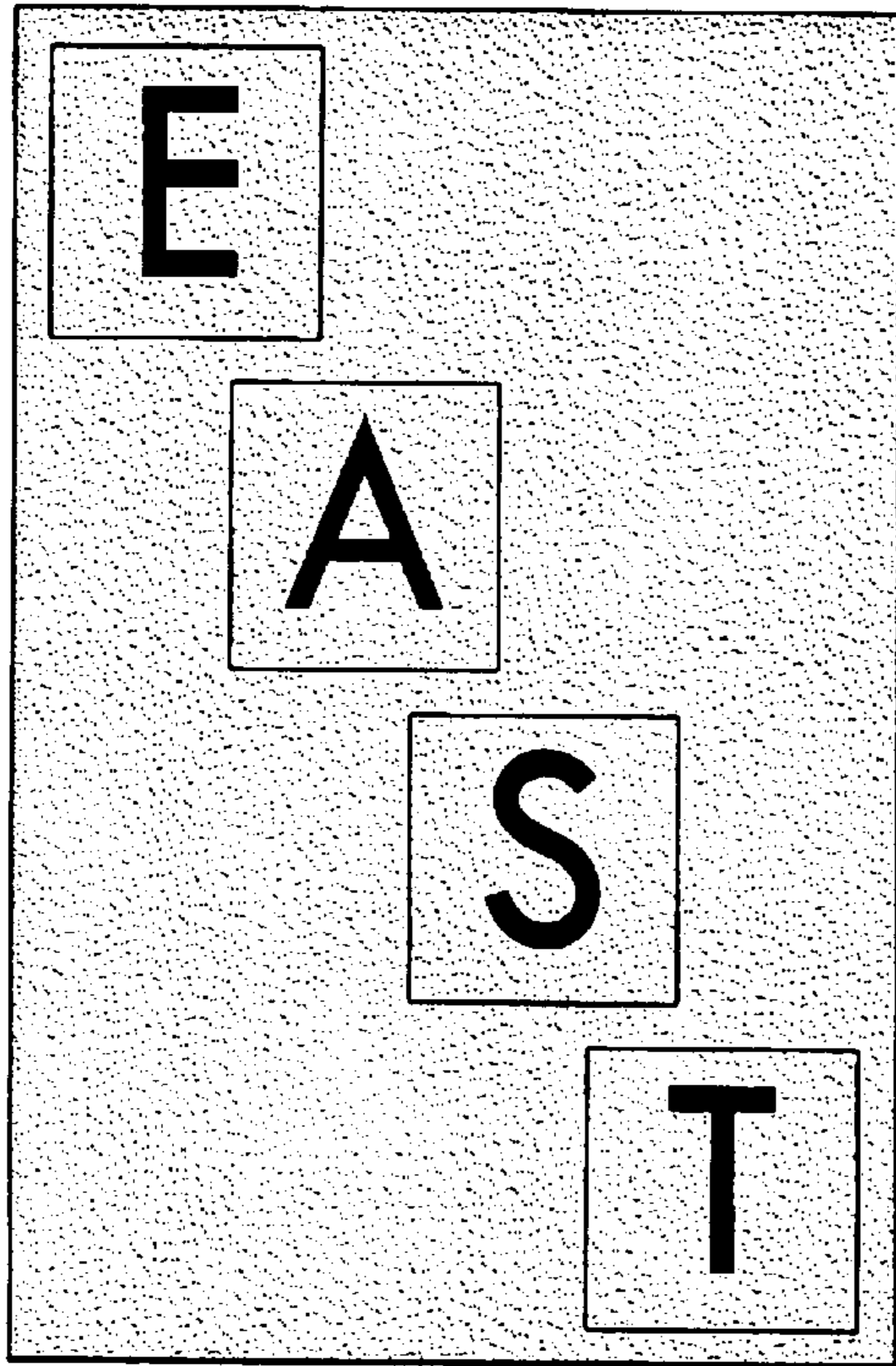

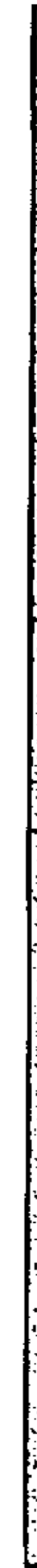

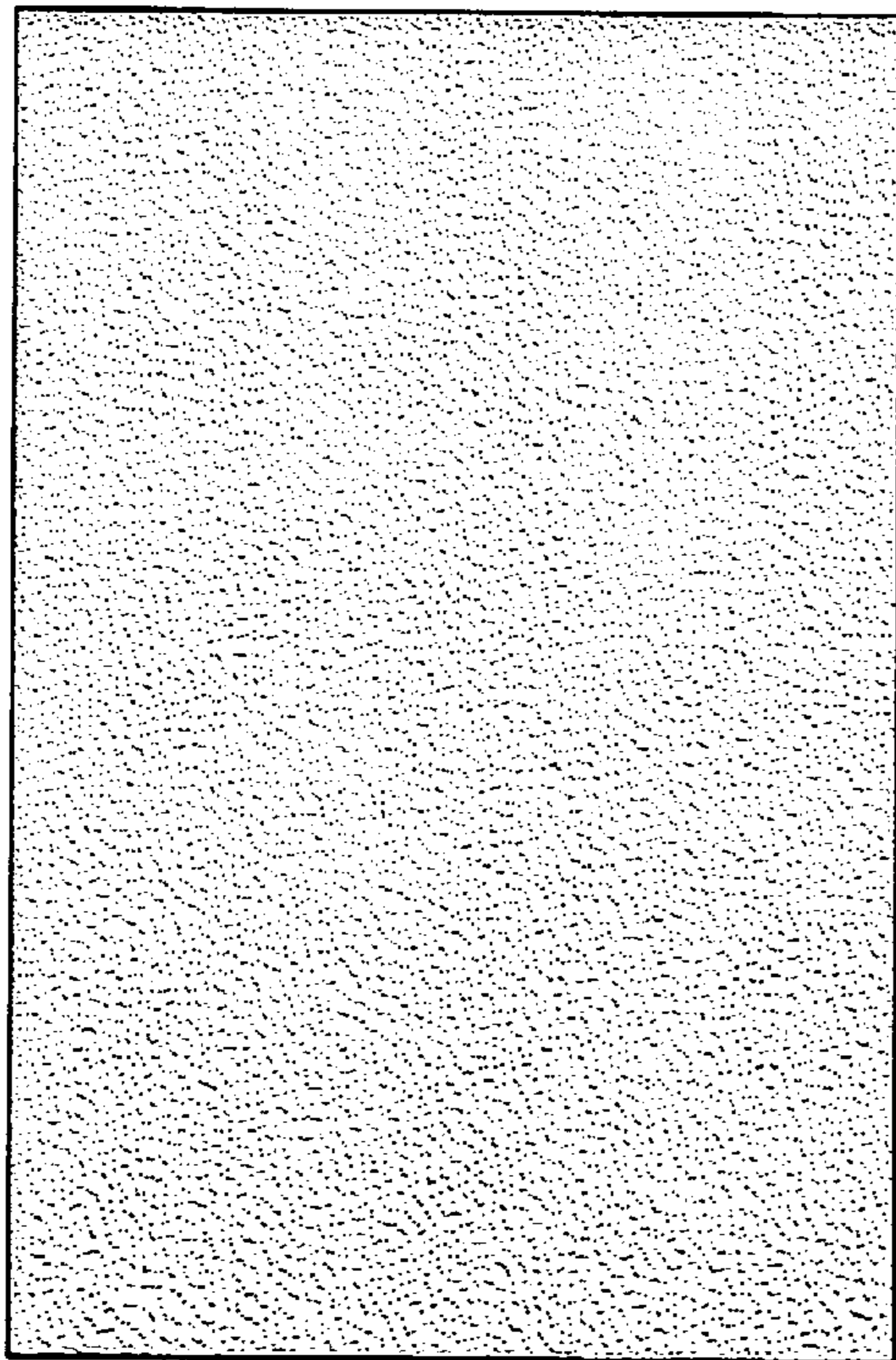

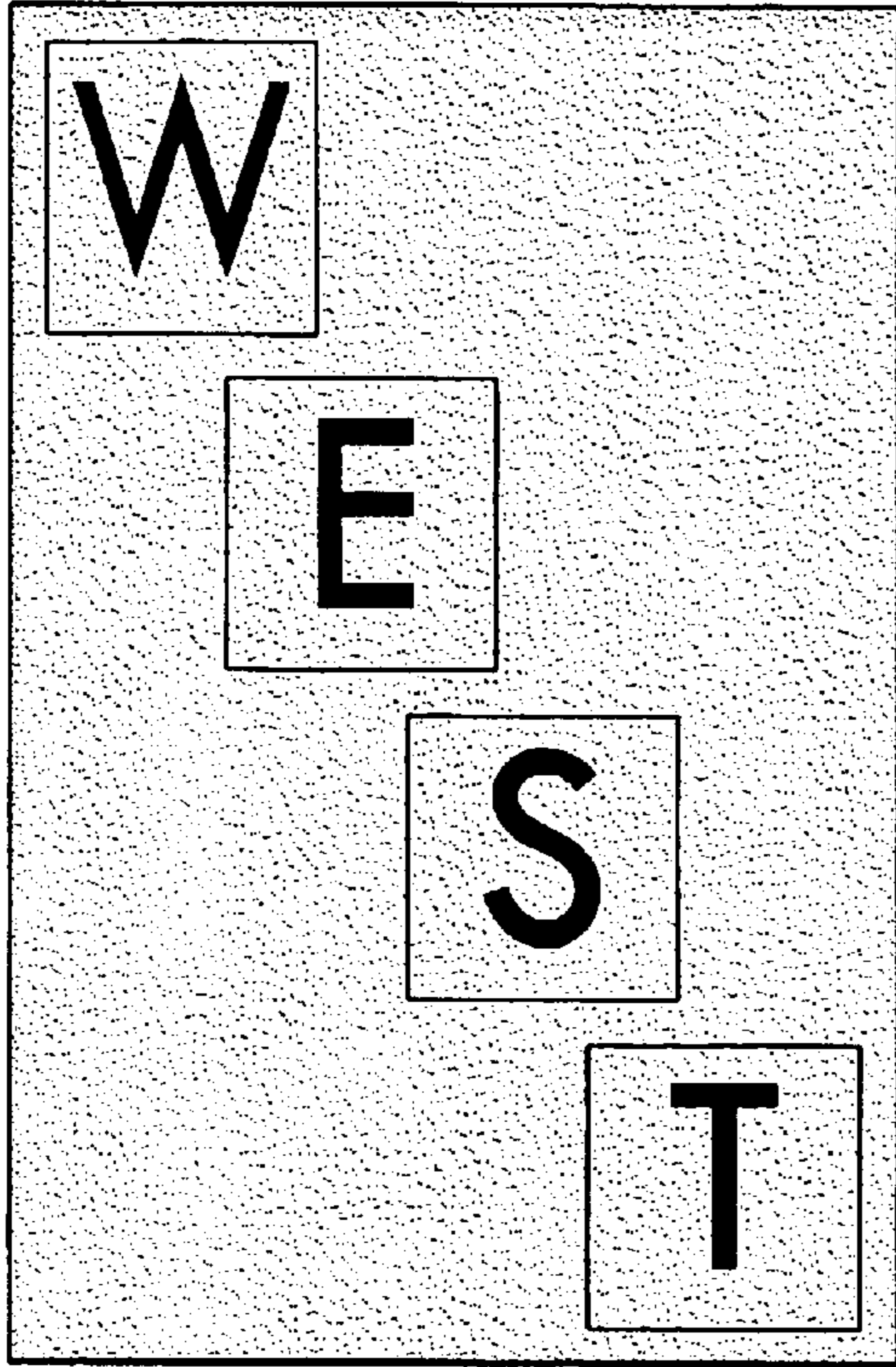

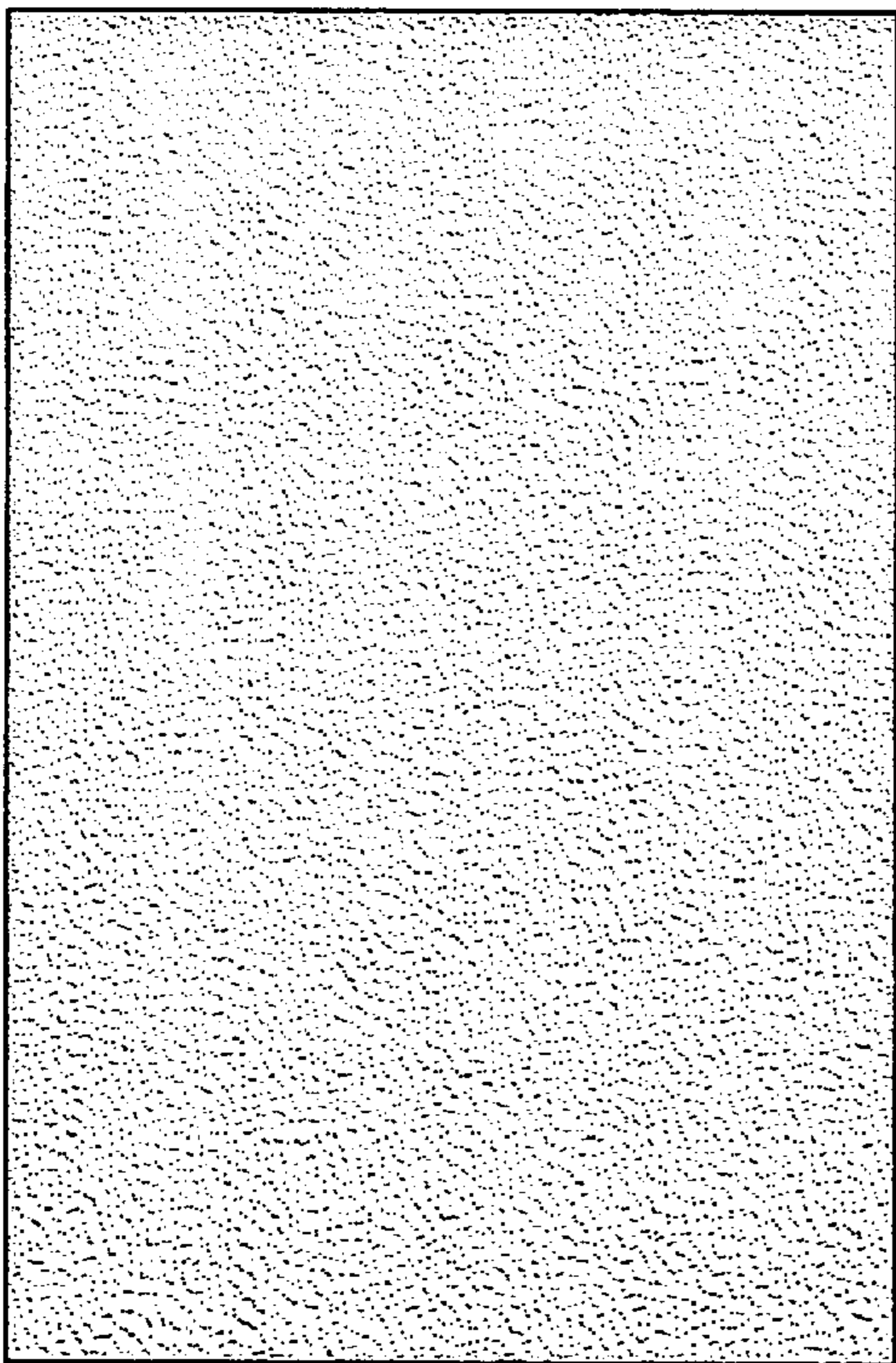

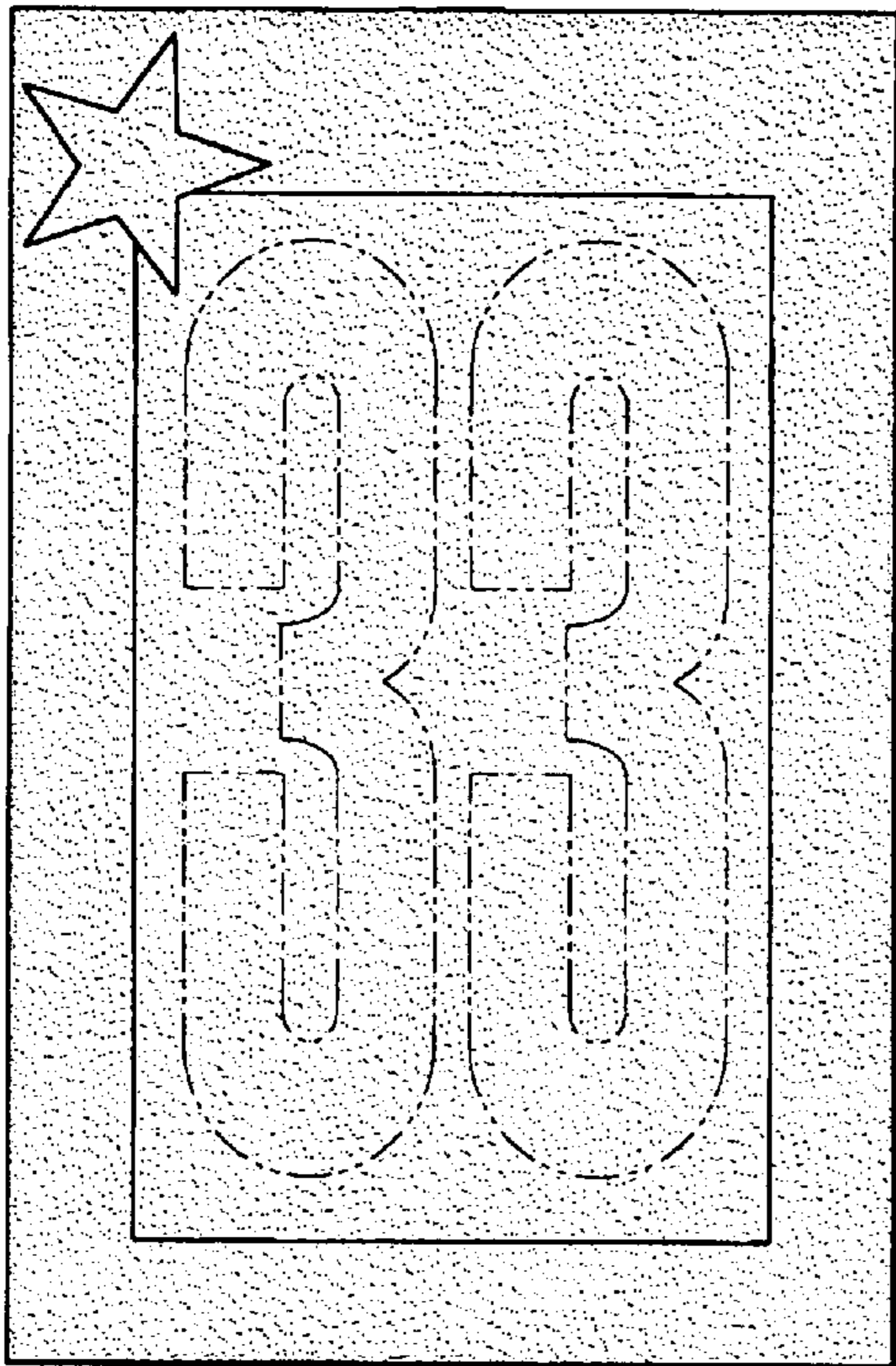

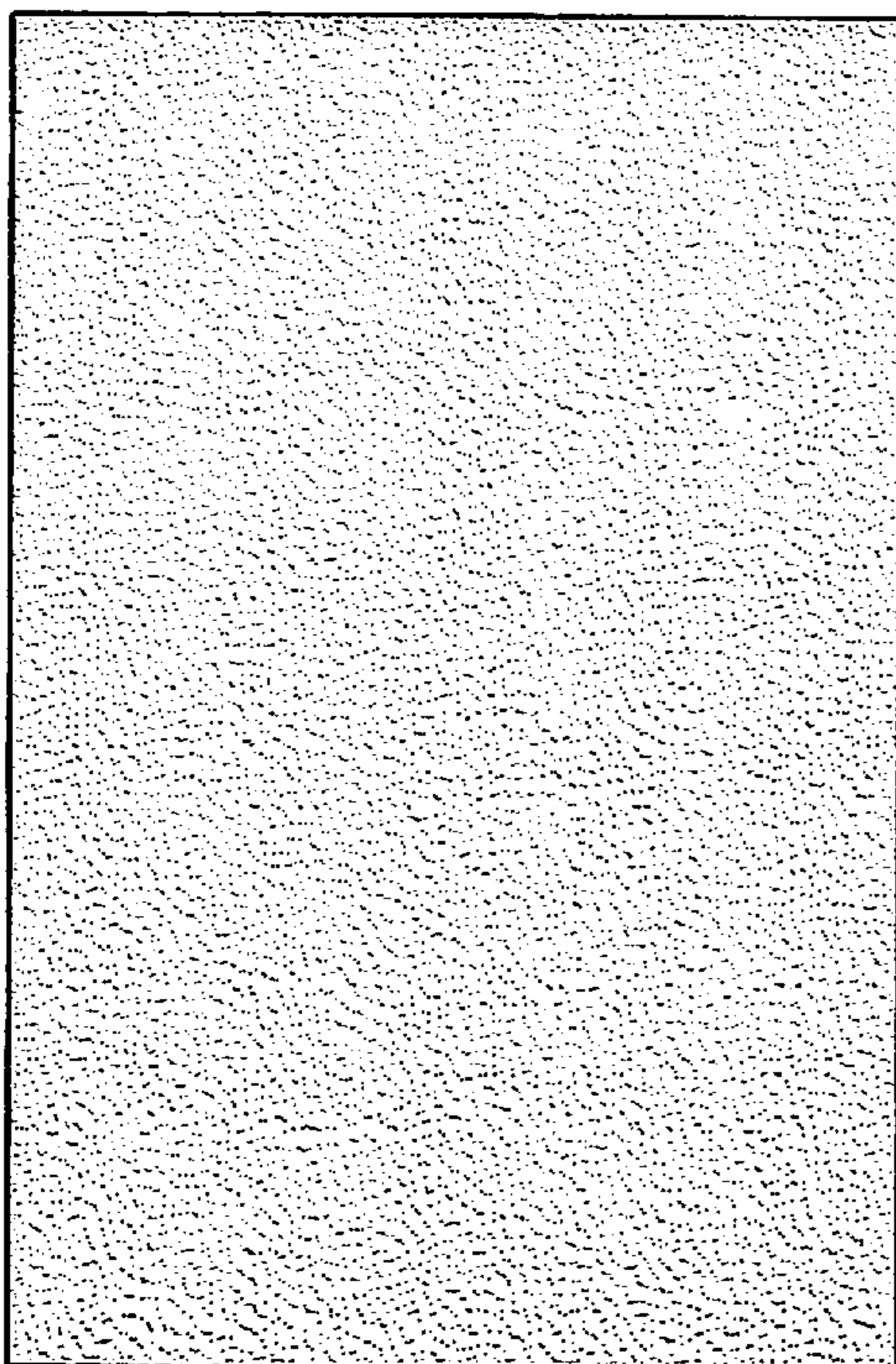

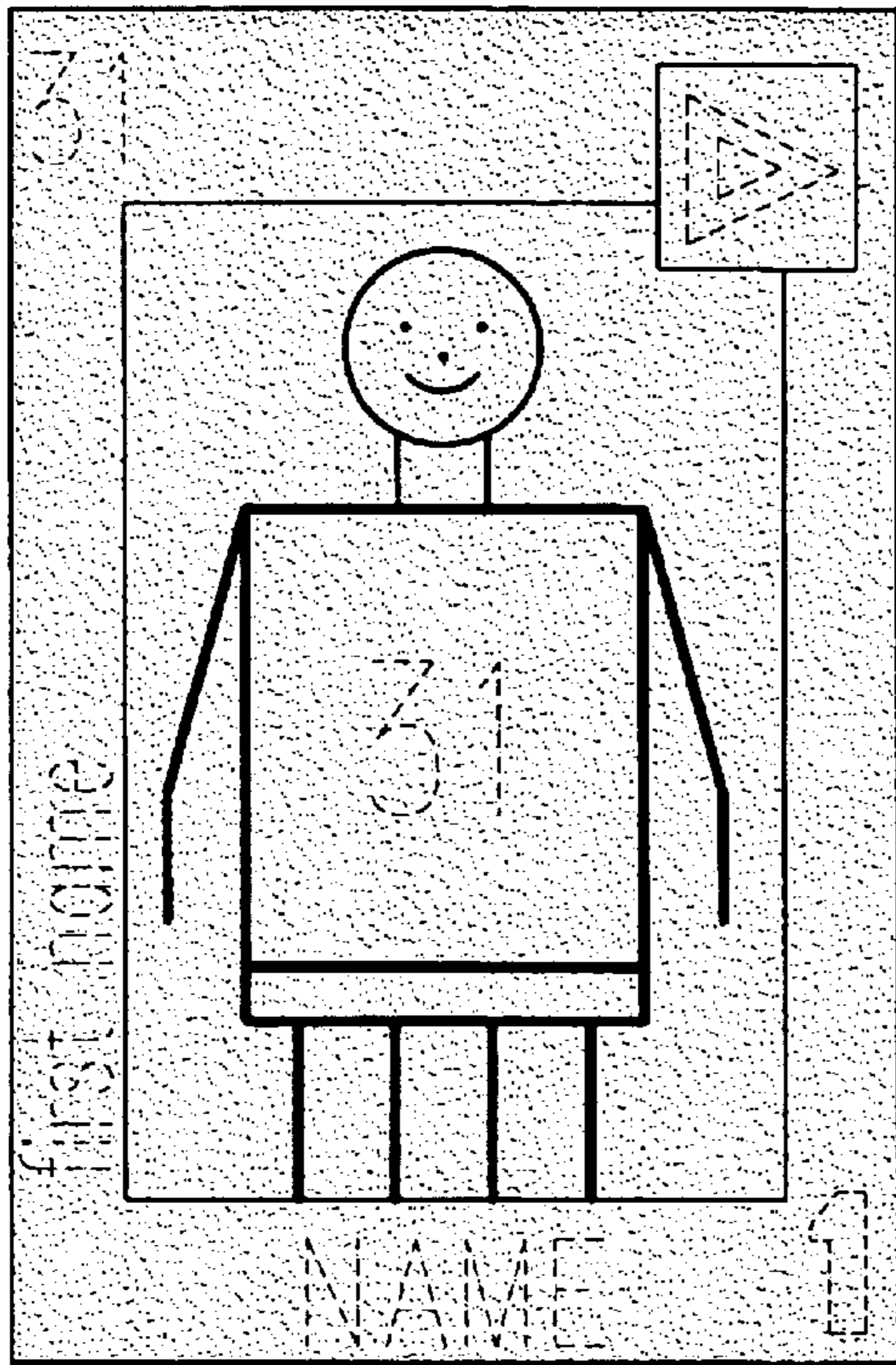

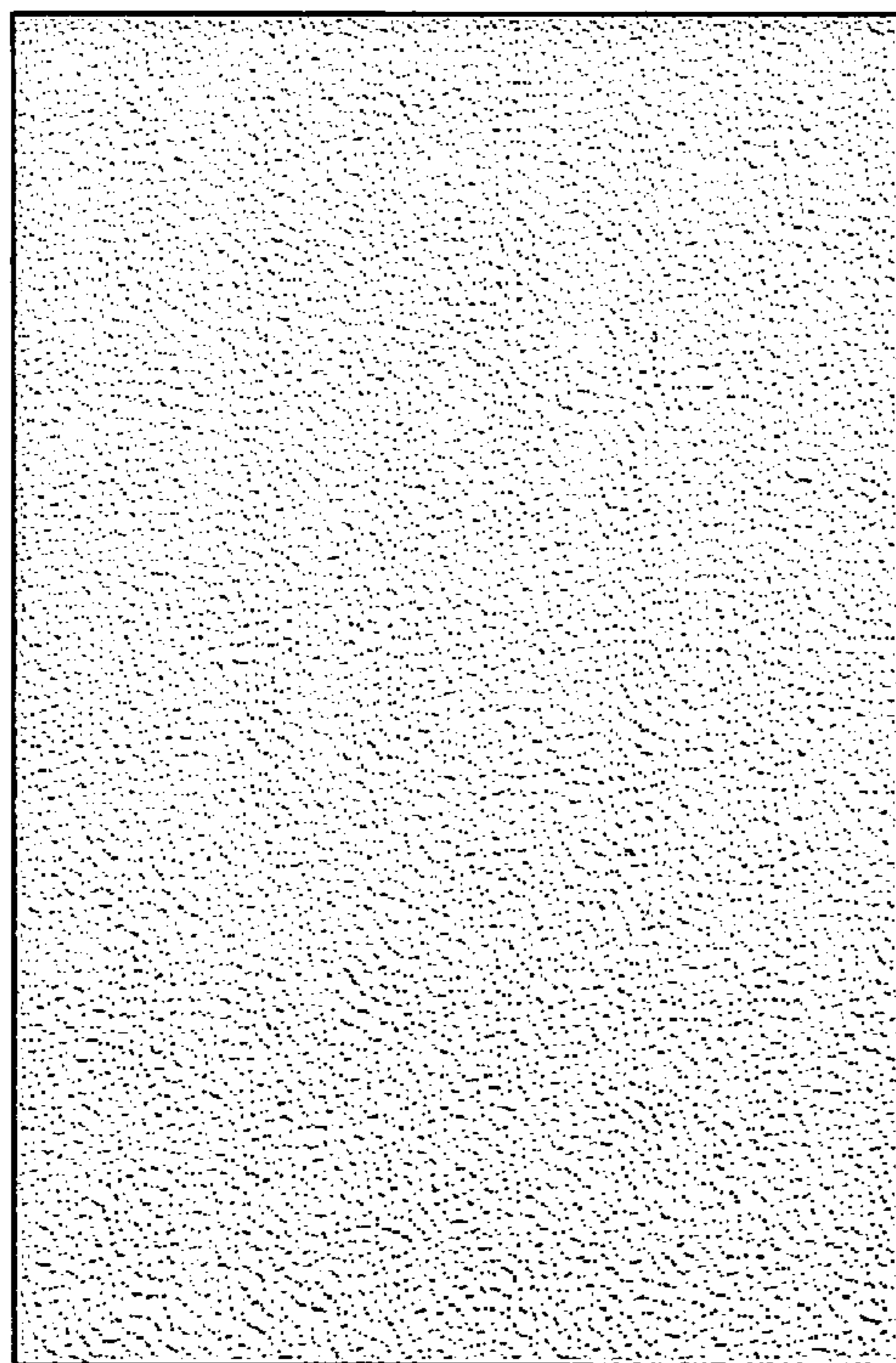

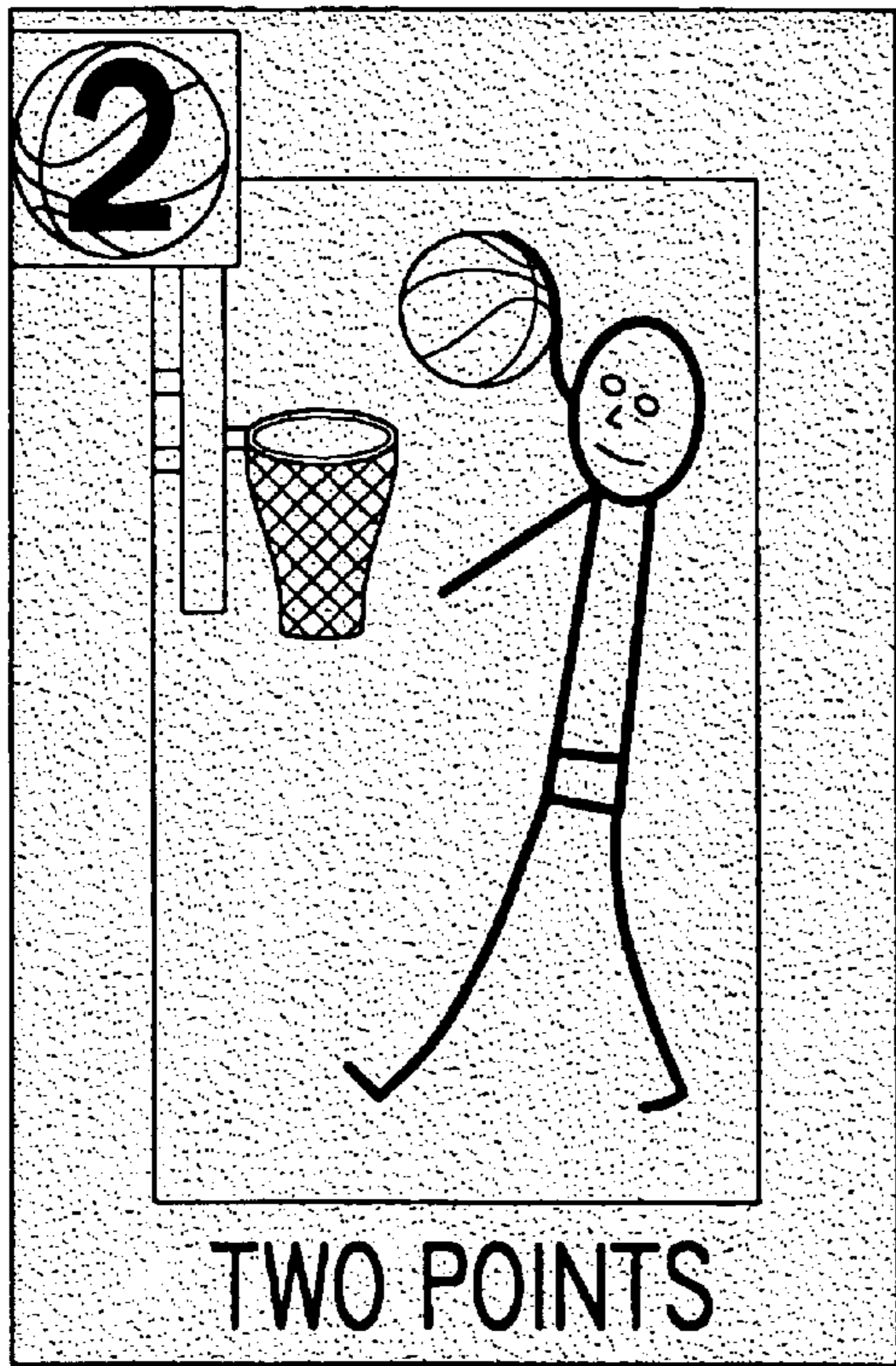

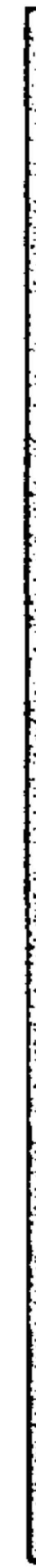

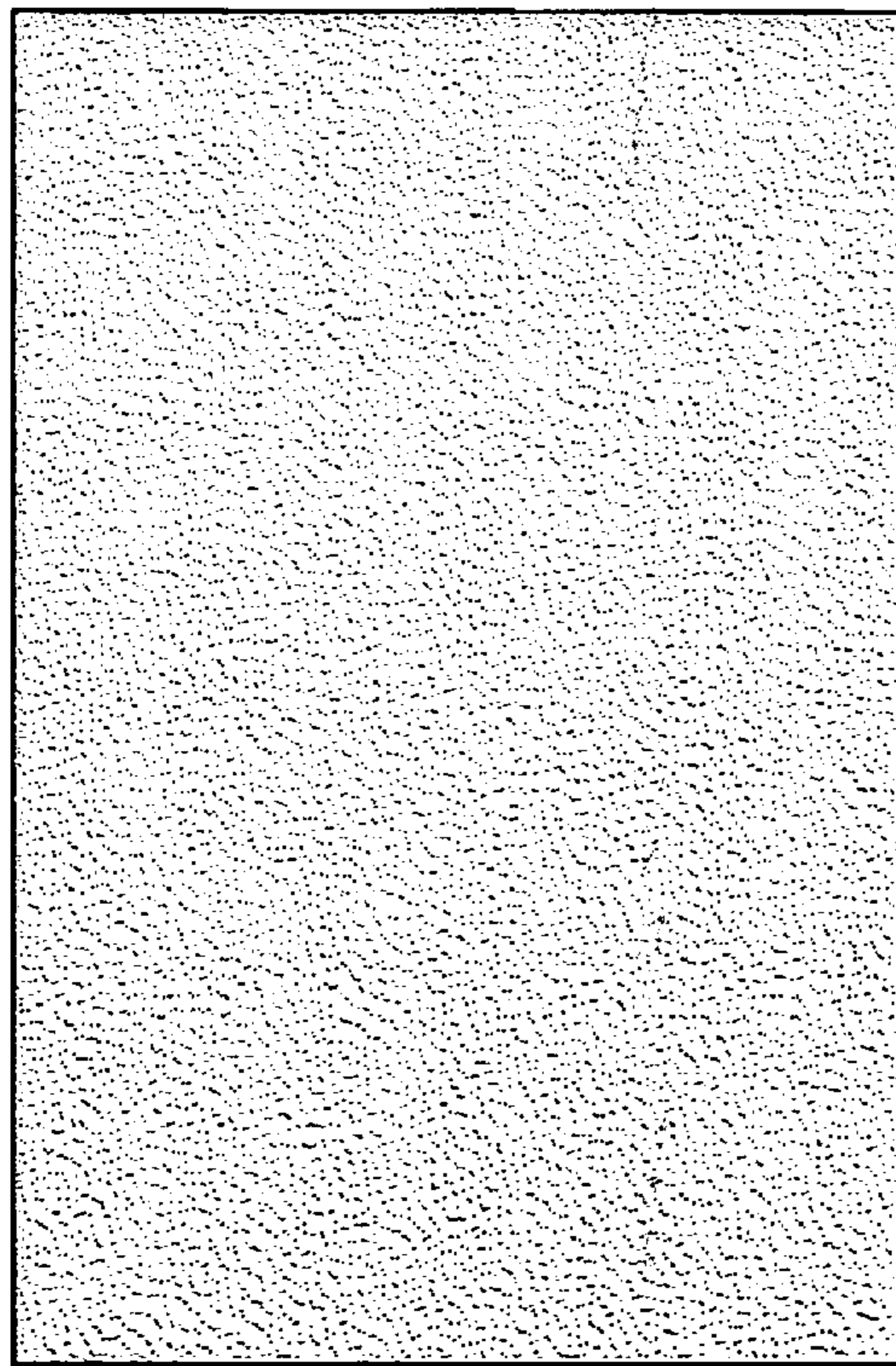

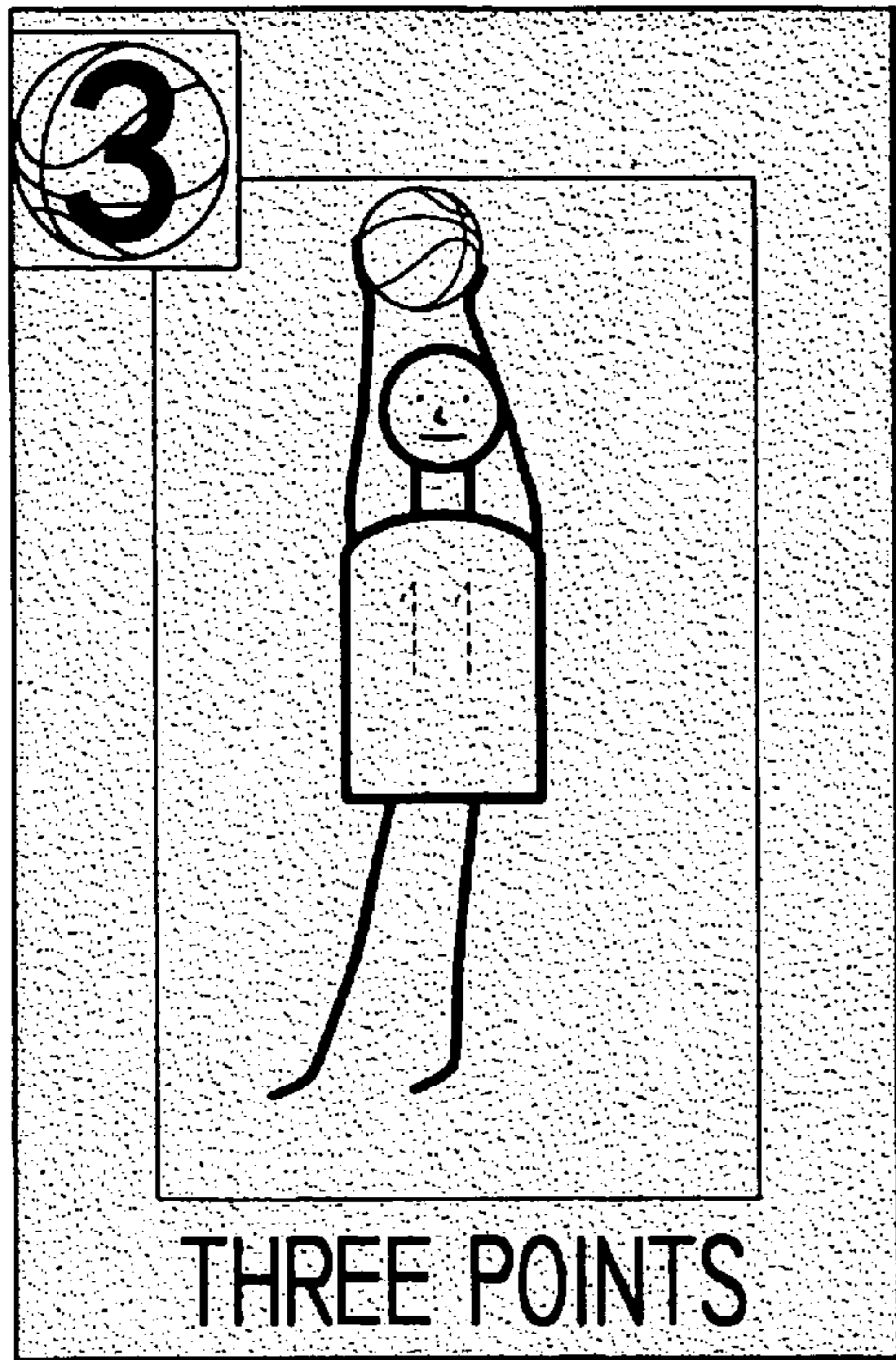

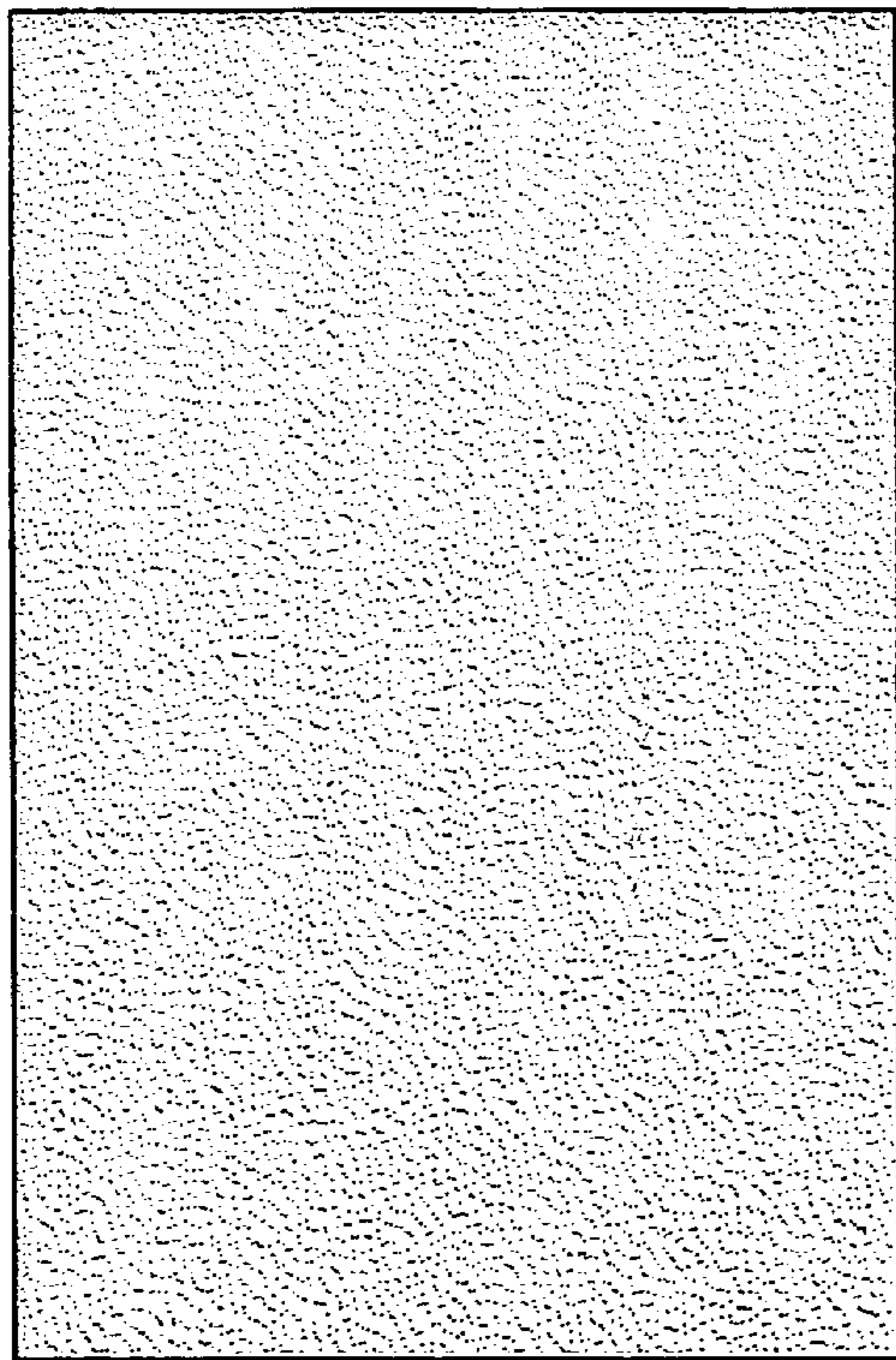

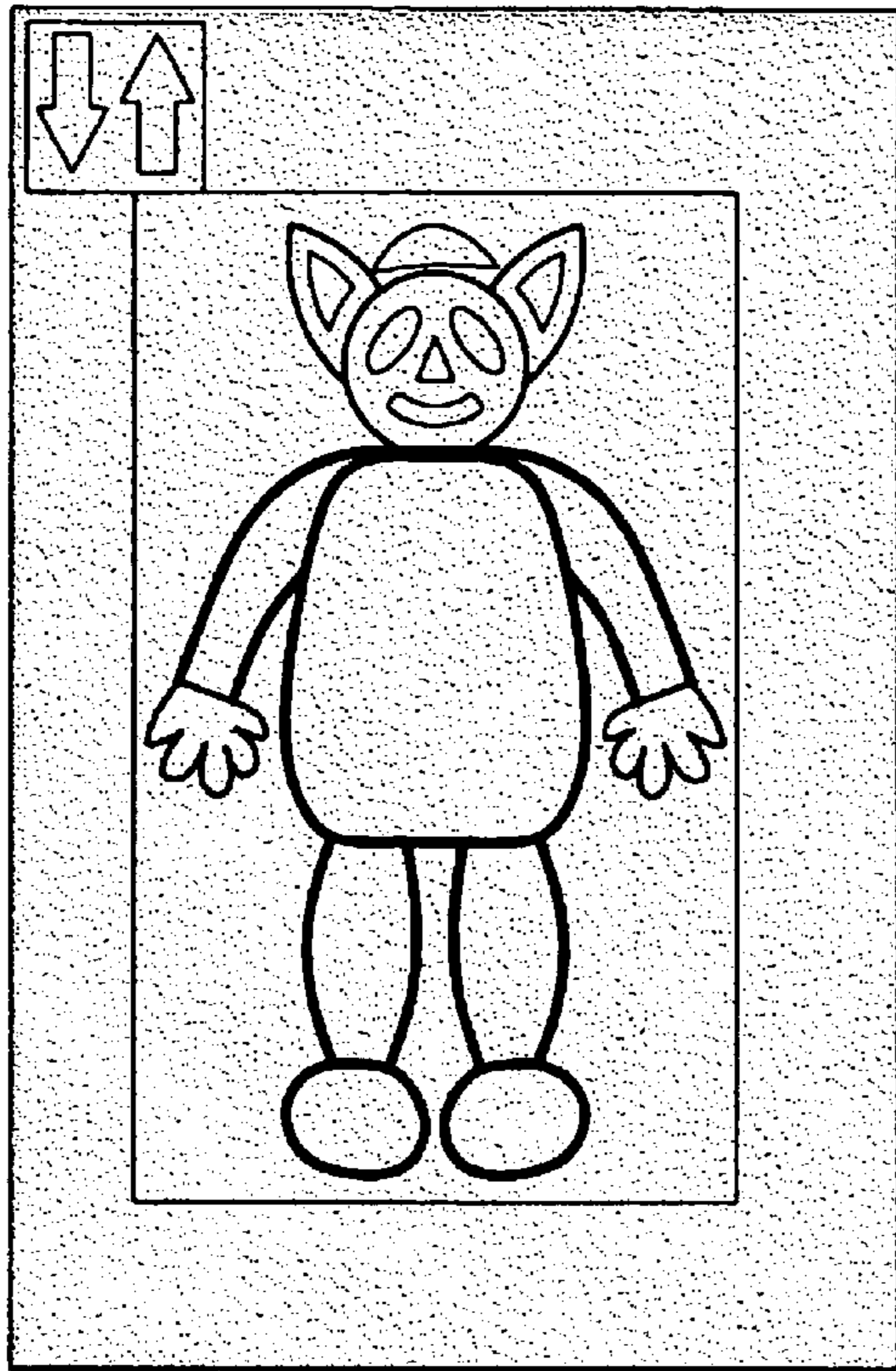

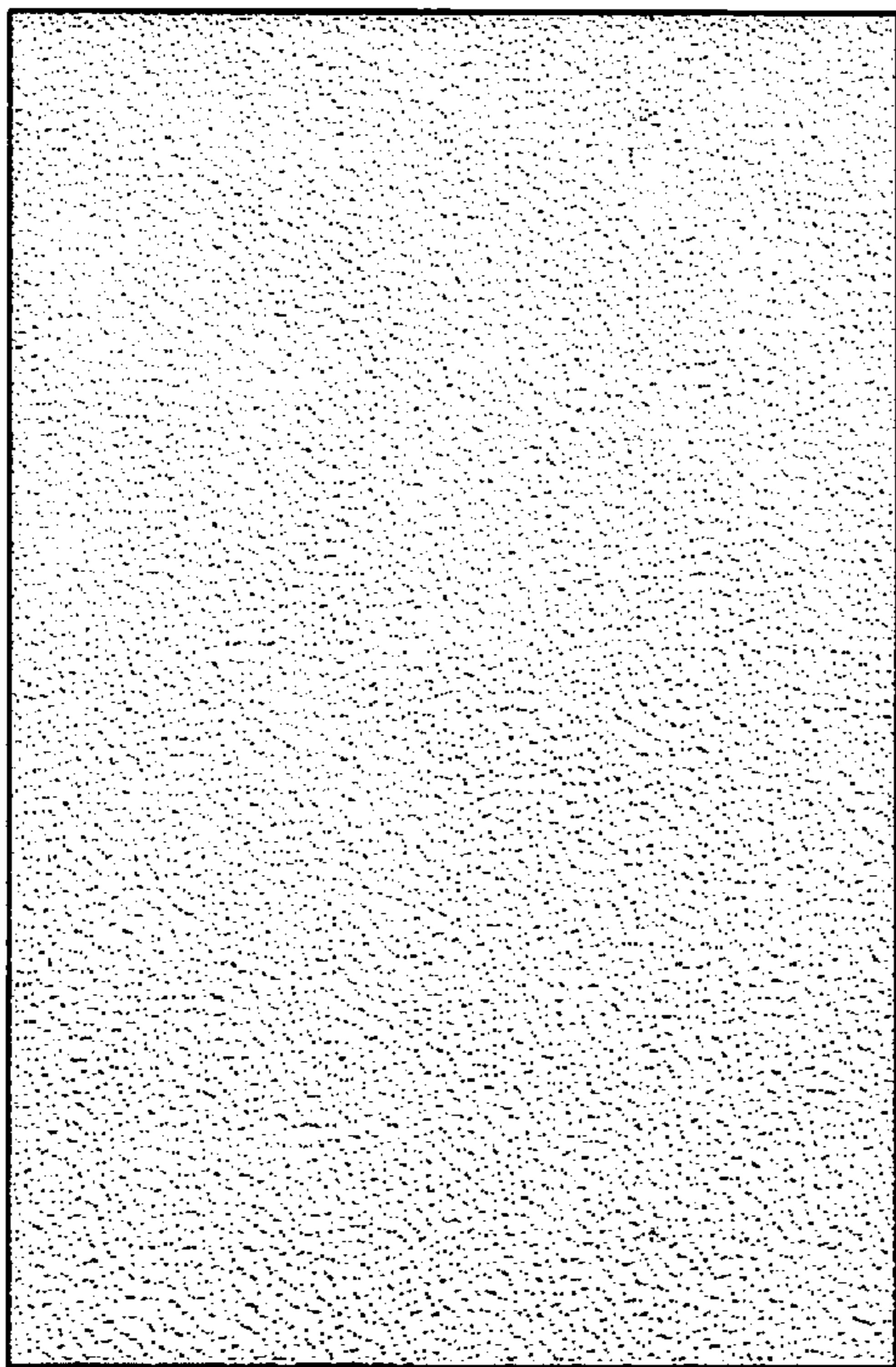

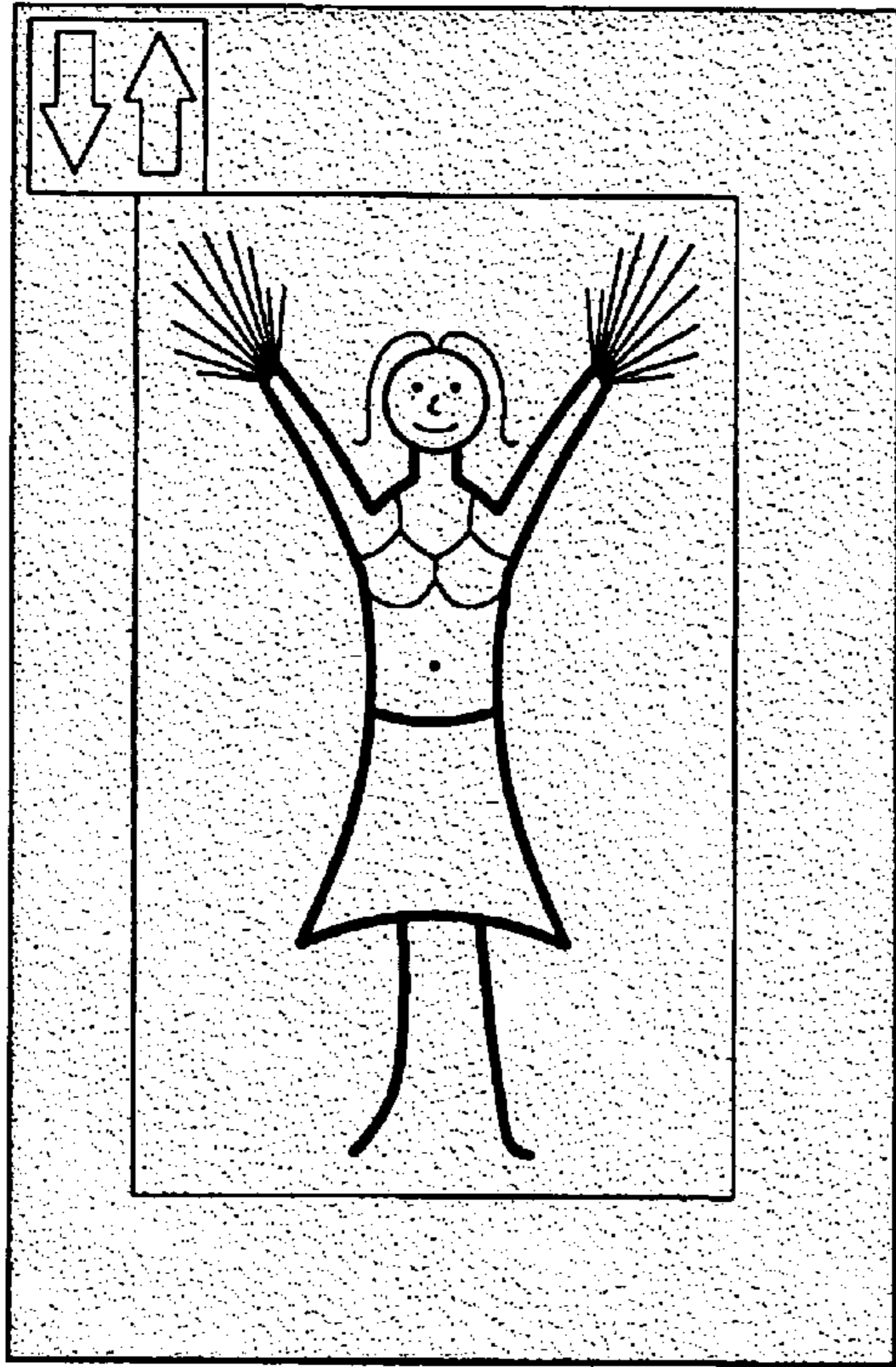

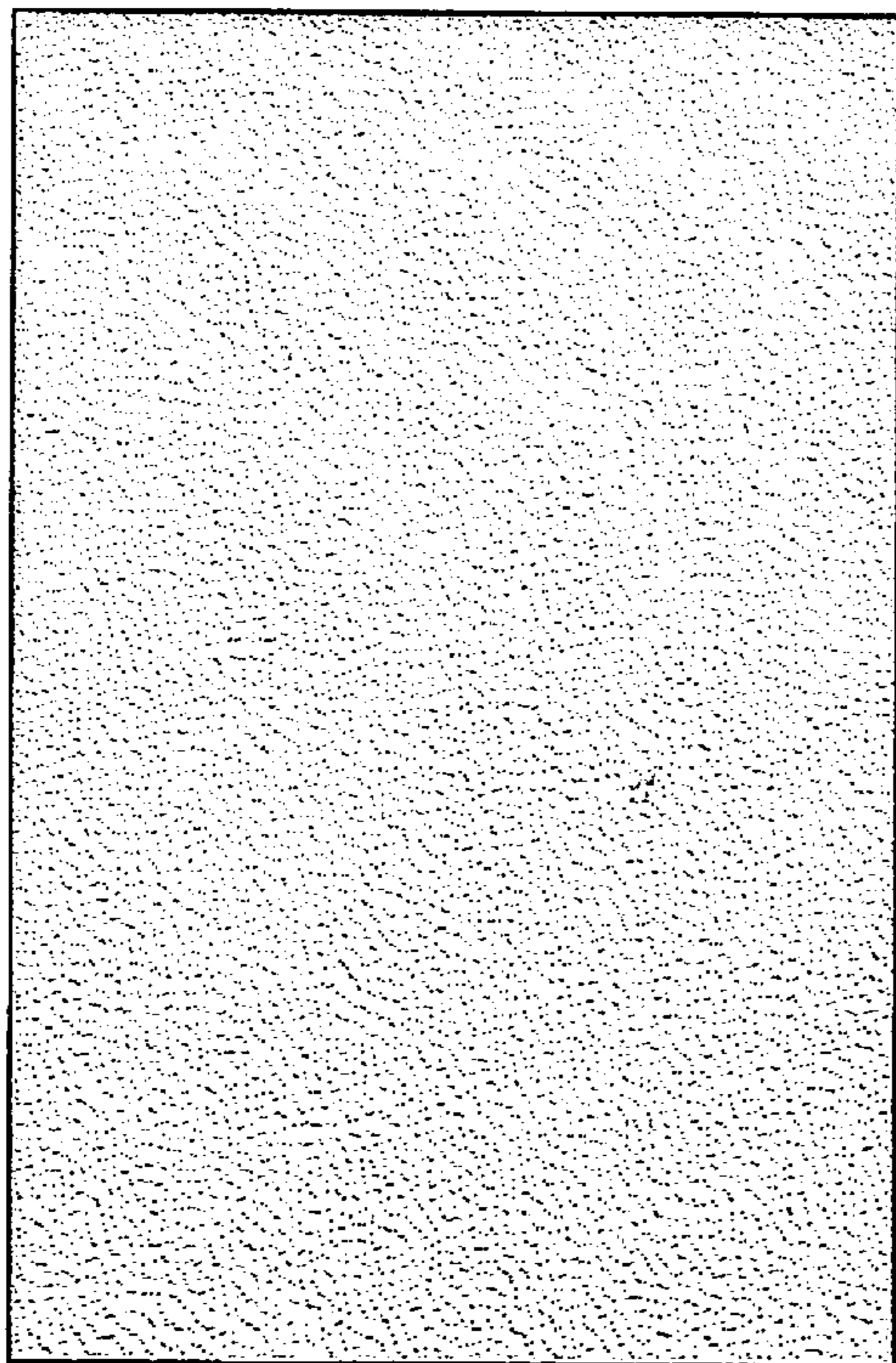

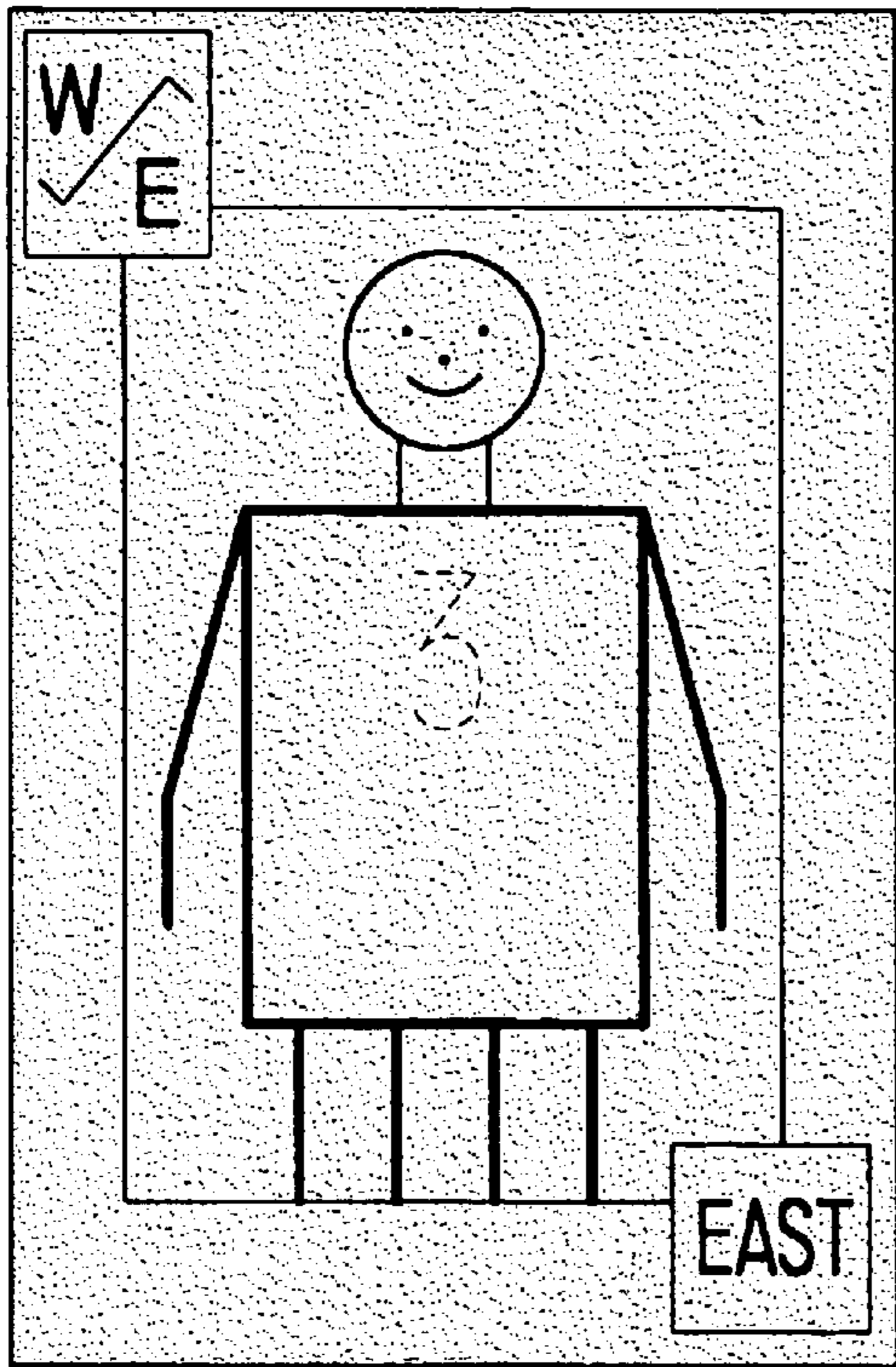

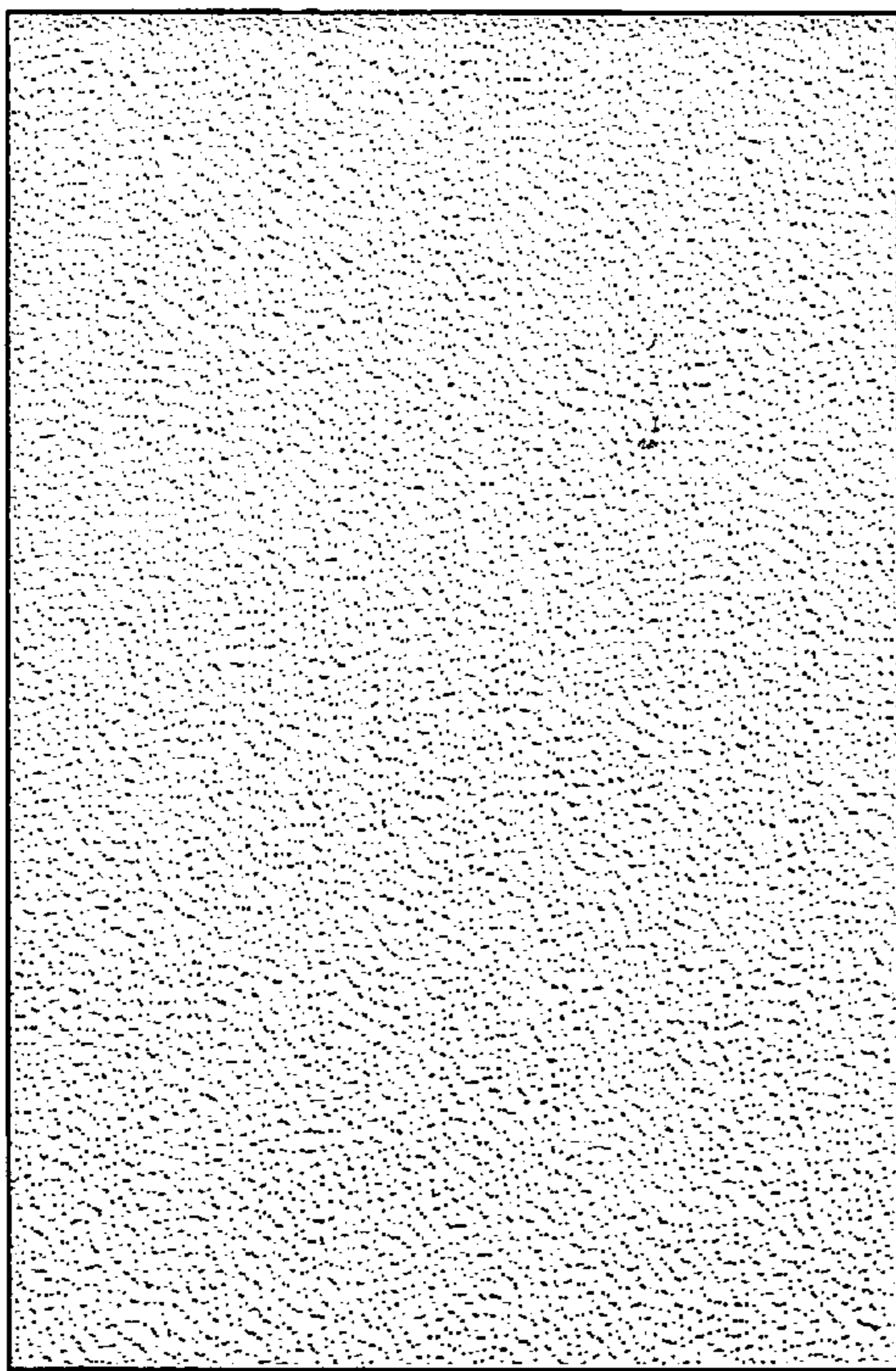

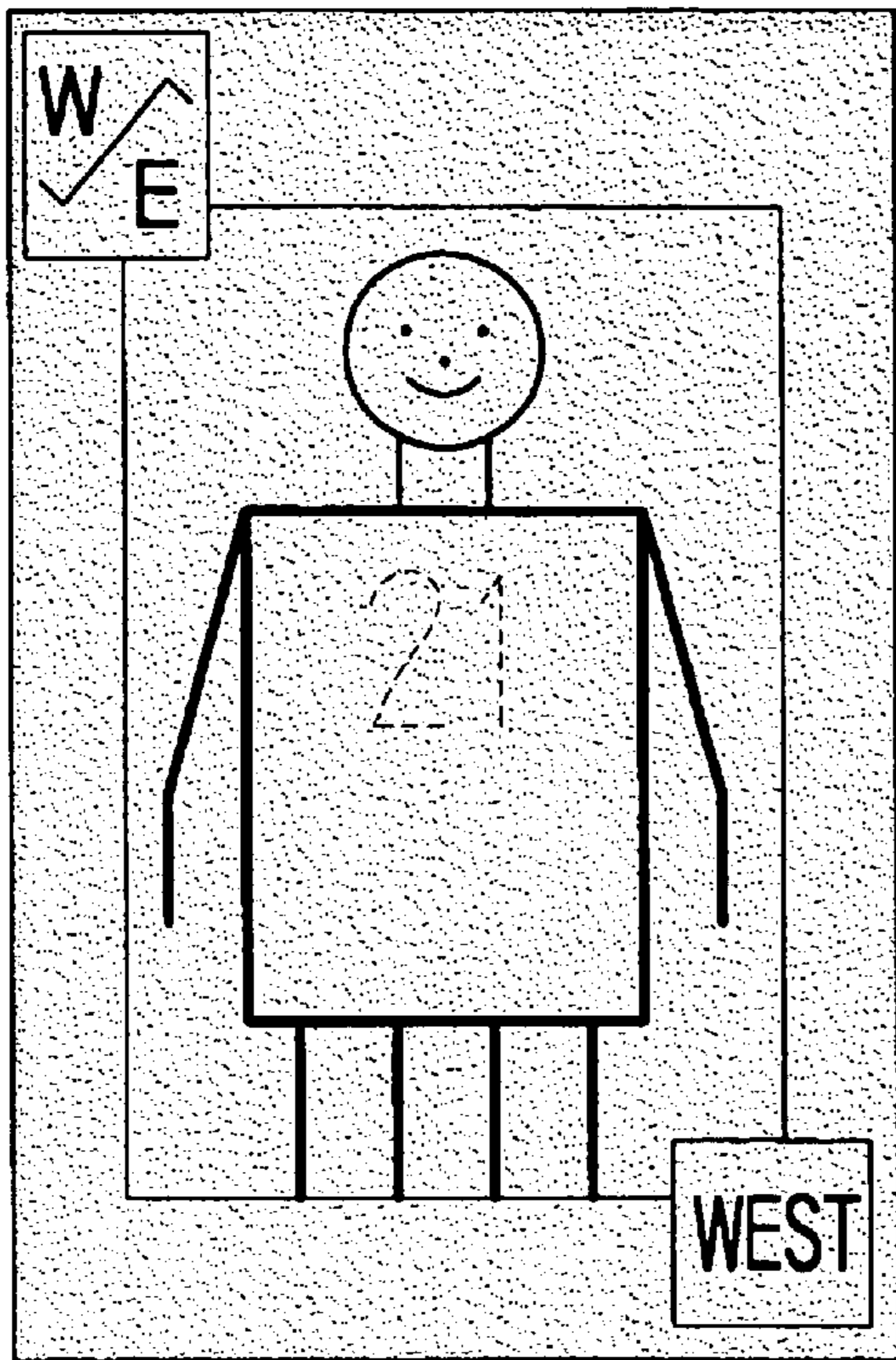

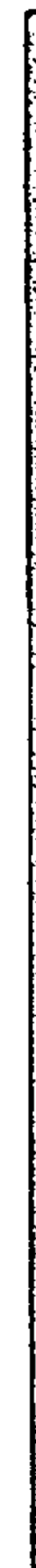

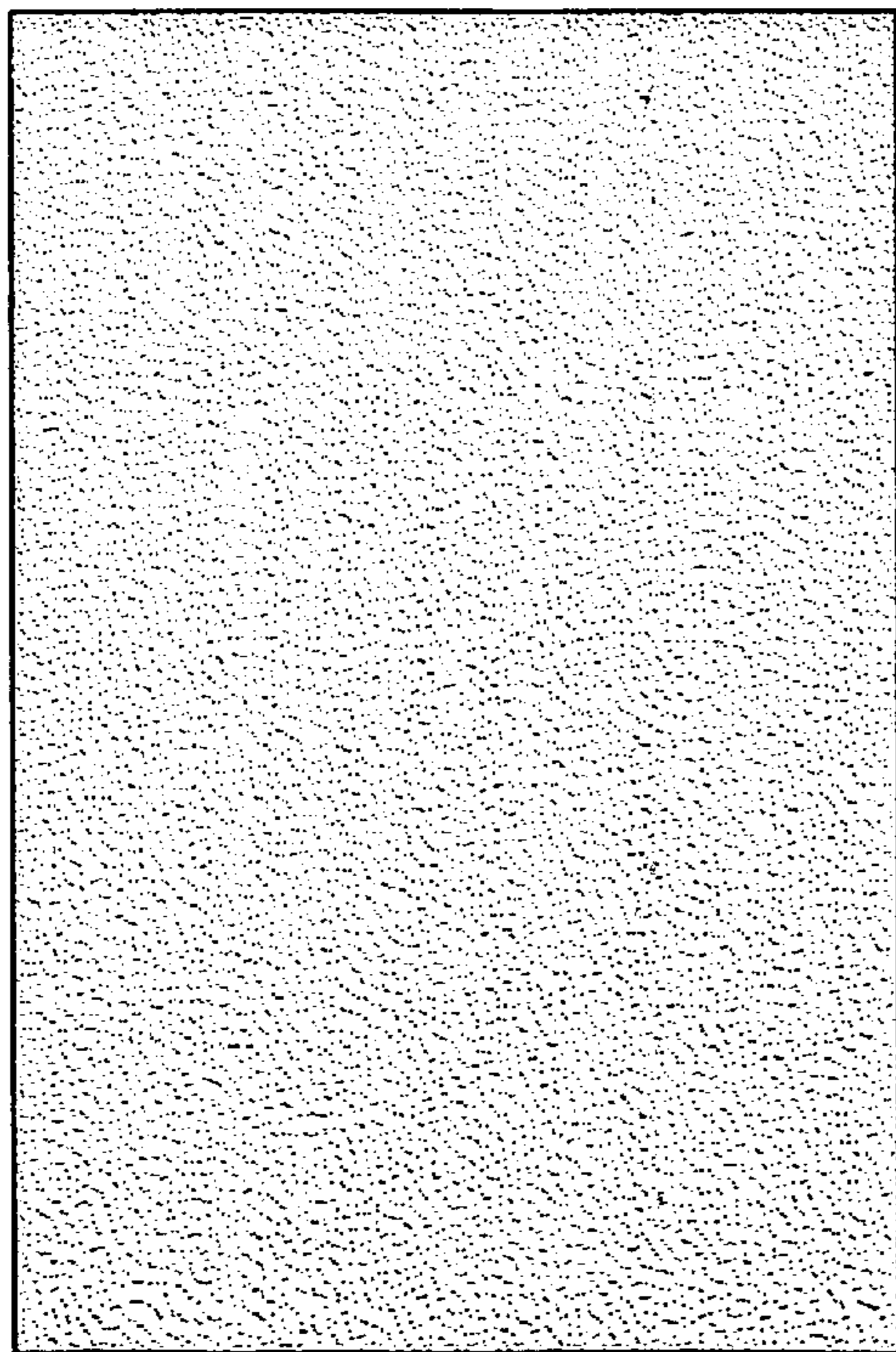

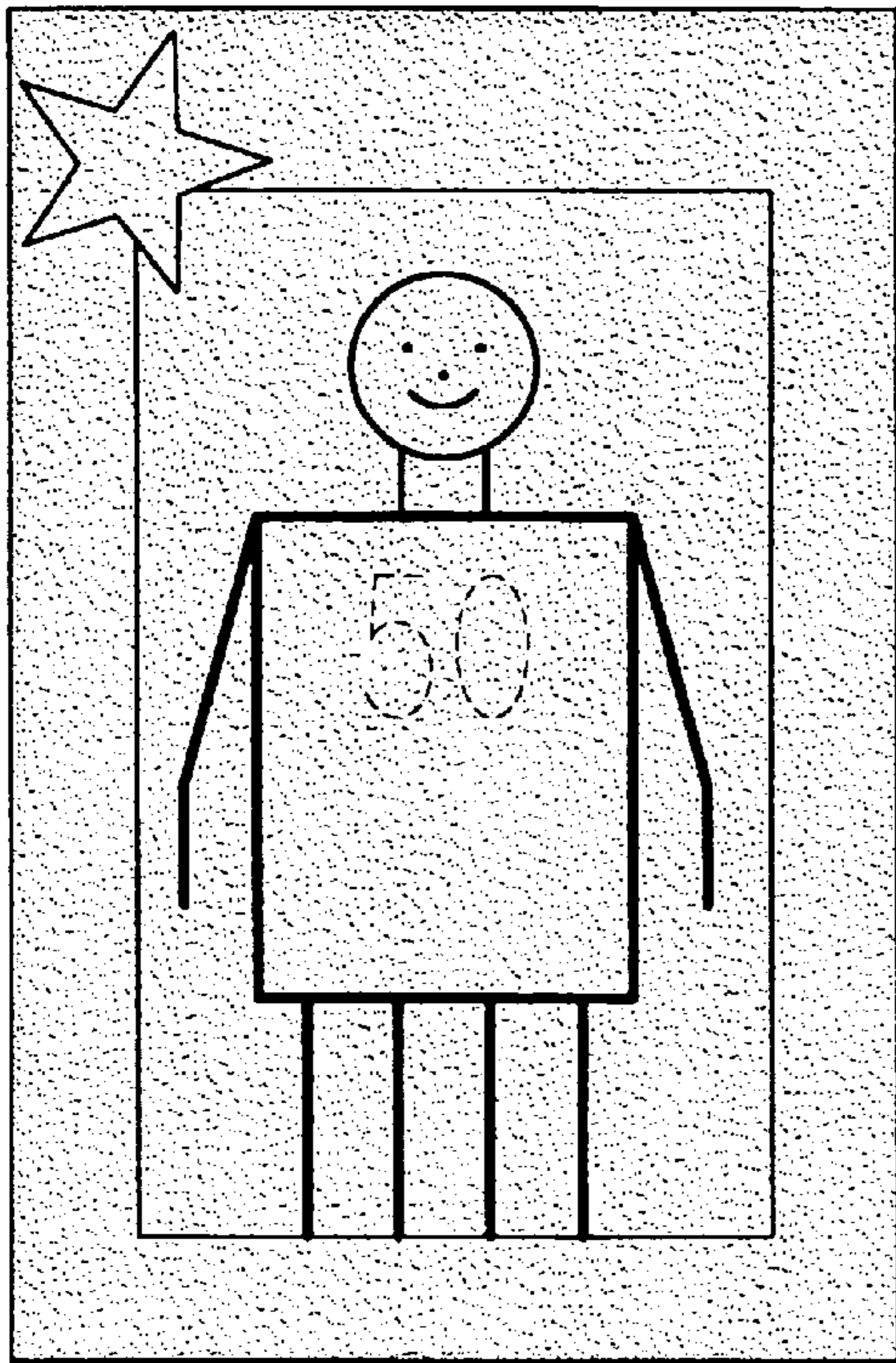

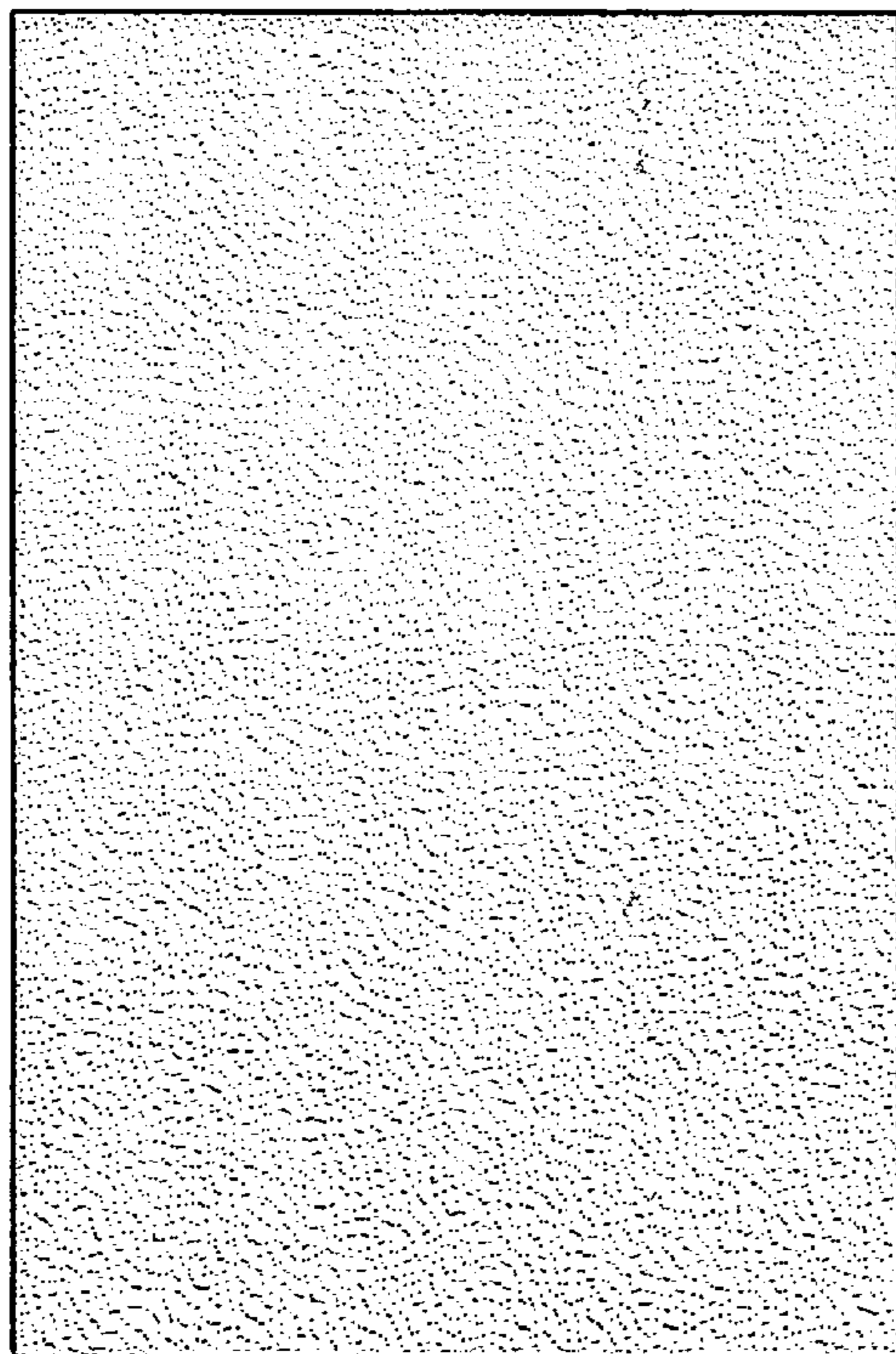
