FIG. 7 is an enlarged front view thereof.

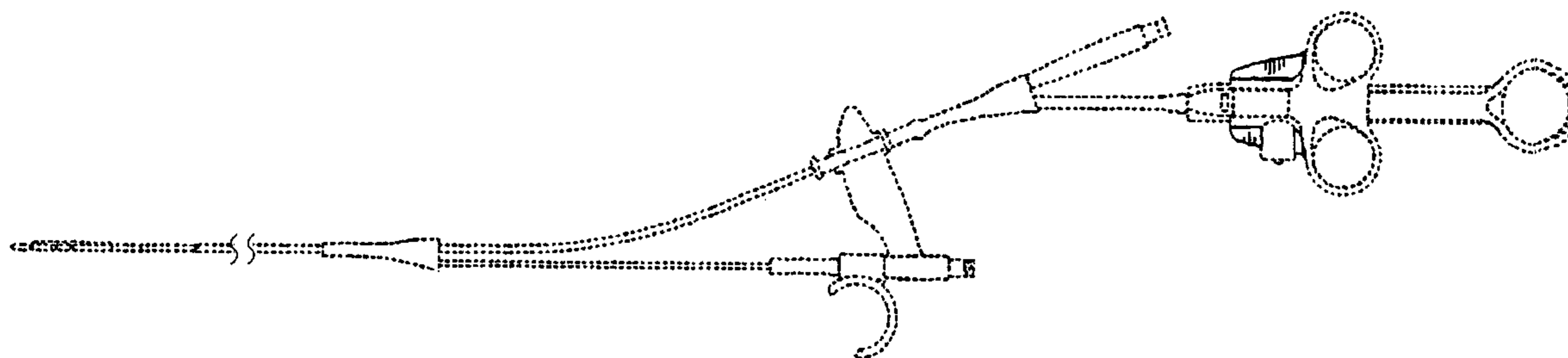
FIG. 8 is an enlarged top plan view thereof.

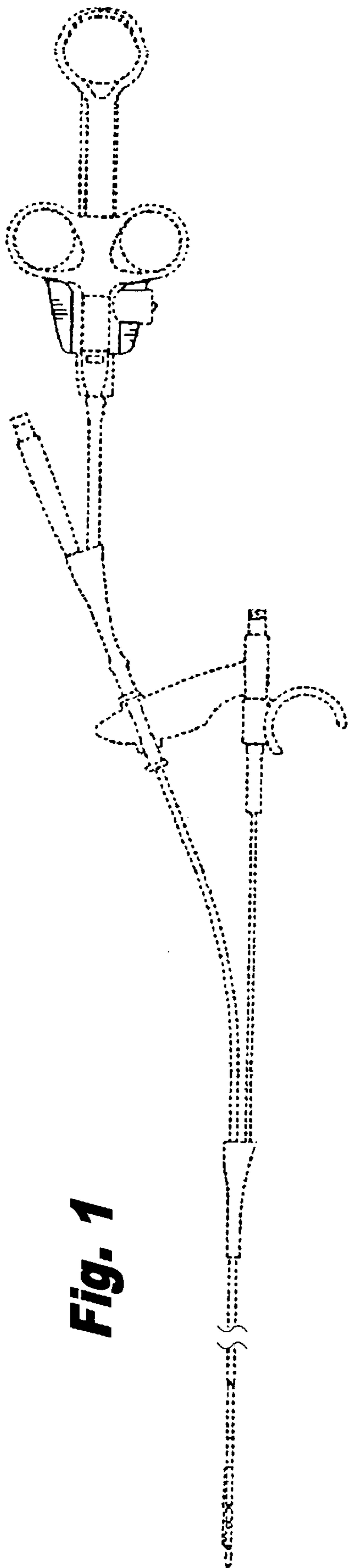

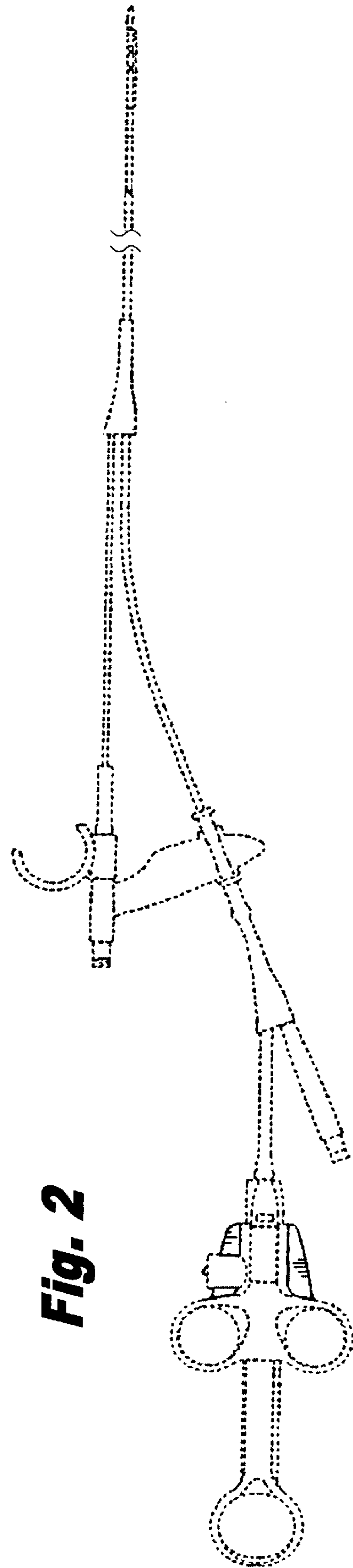

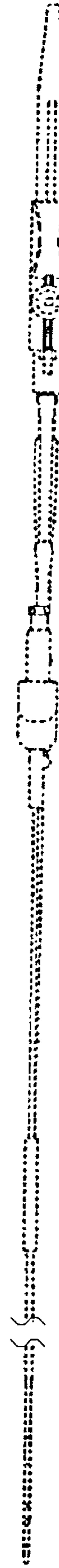

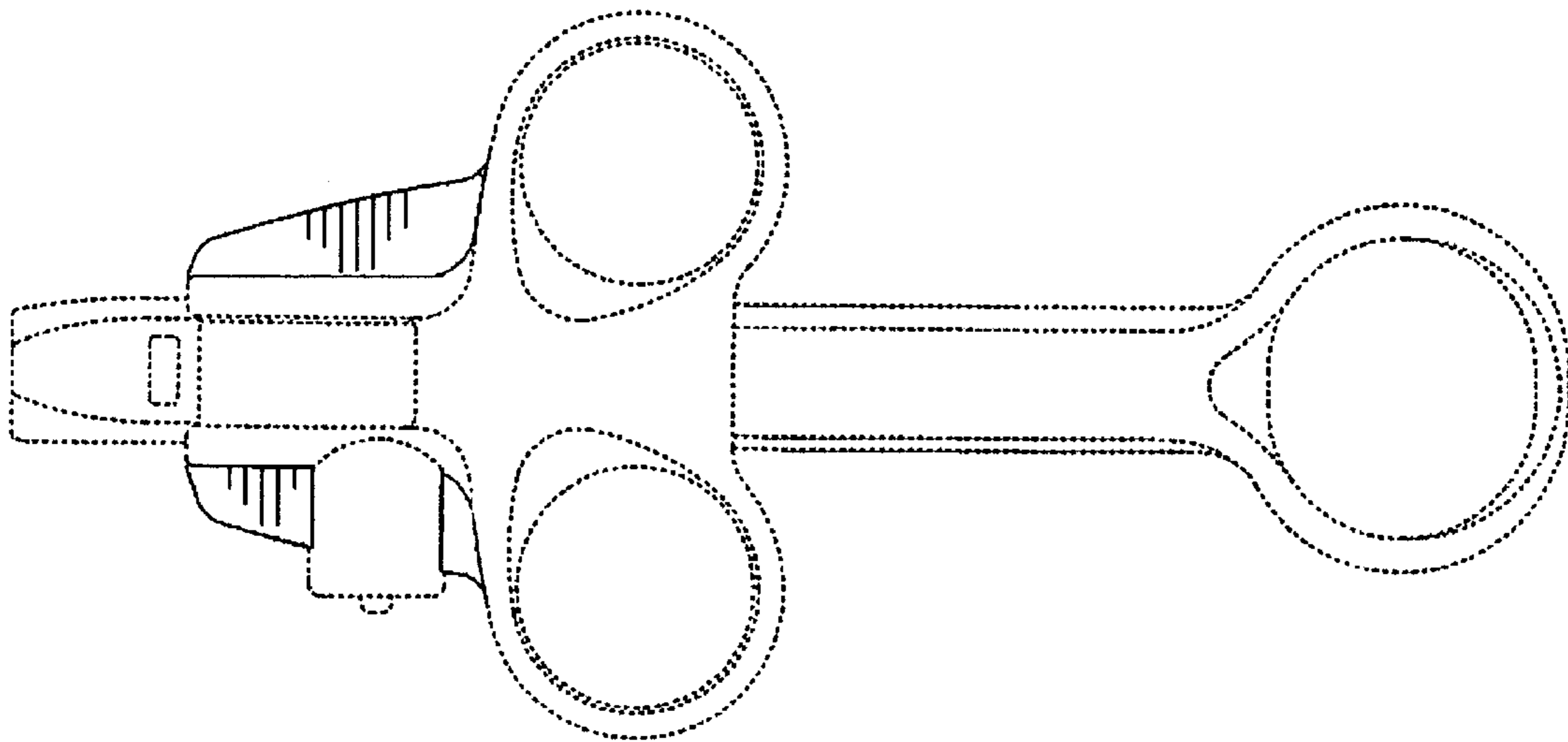

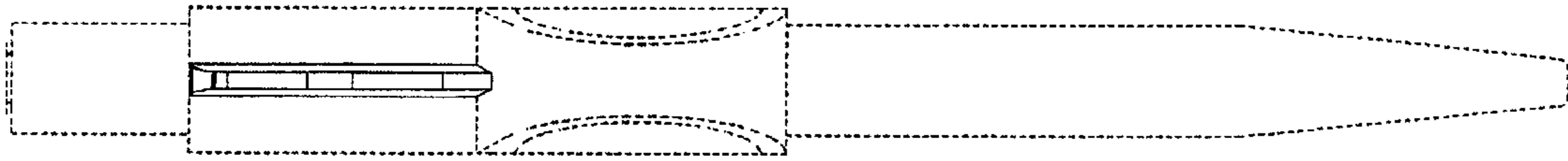

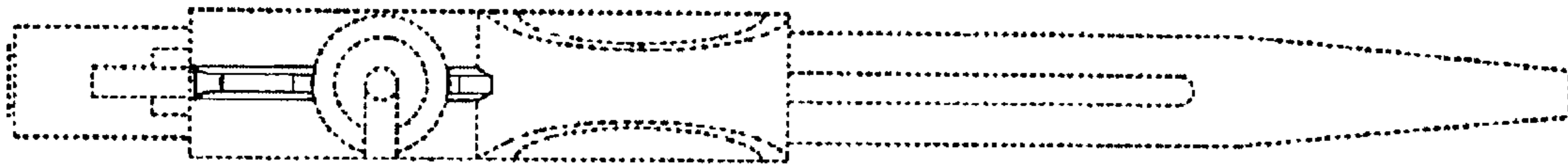

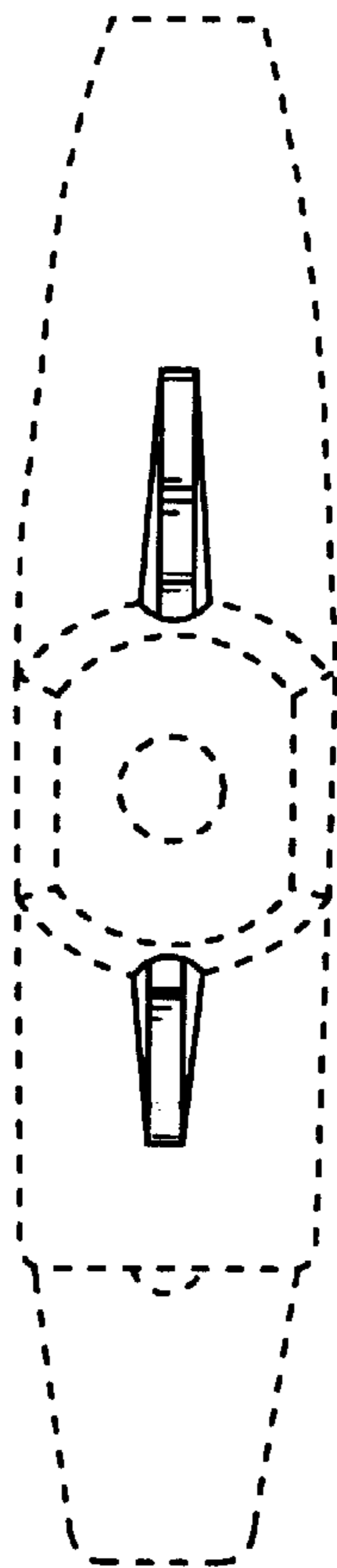
