(57) **CLAIM**

The ornamental design for a vibrator, as shown and described.

**DESCRIPTION**

FIG. 1 is a view in side elevation of the vibrator, showing my new design.

FIG. 2 is a view in side elevation from the back thereof, rotated 180° from that shown in FIG. 1.

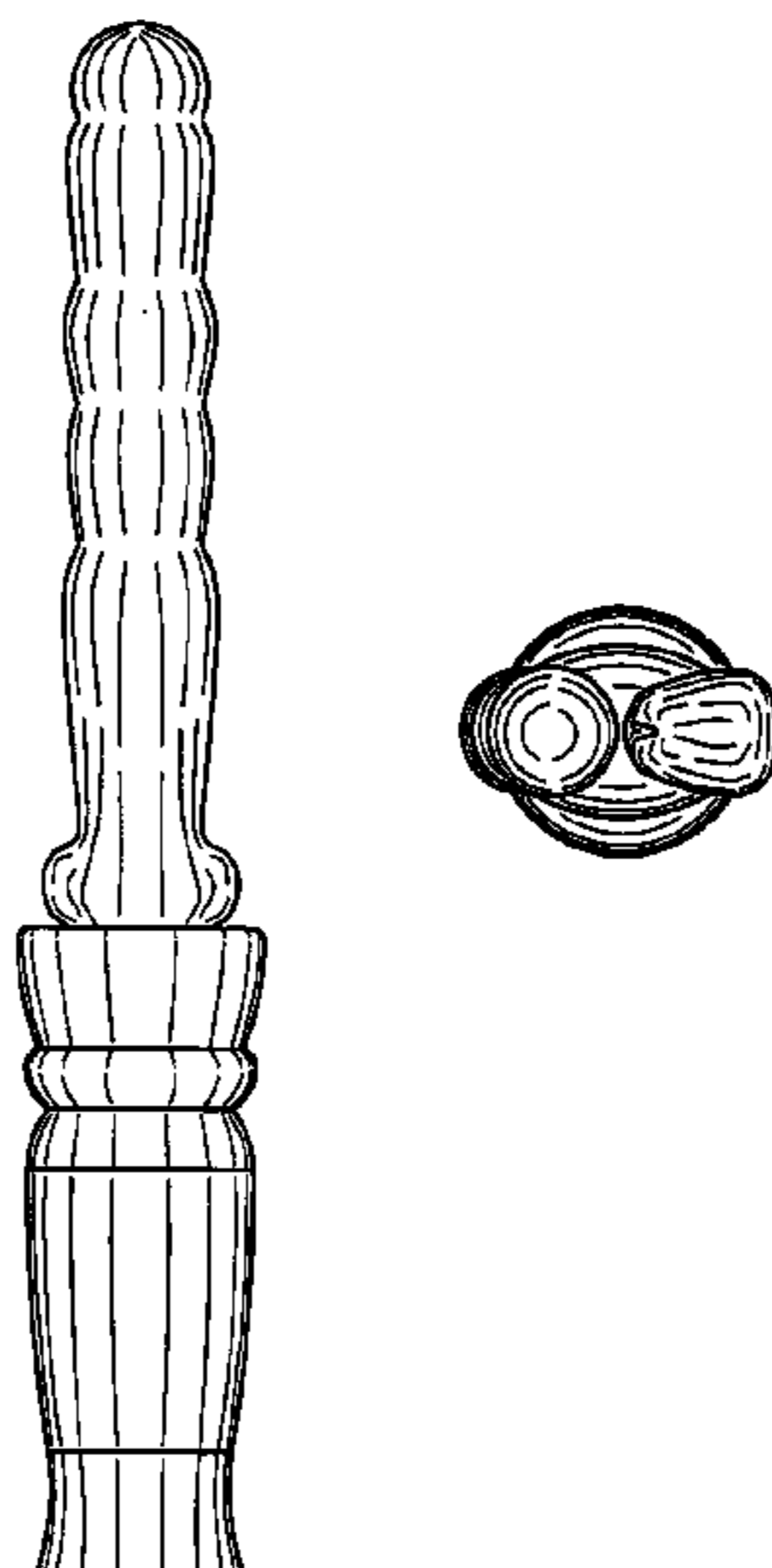
FIG. 3 is a view in side elevation thereof, rotated 90° from that shown in FIG. 1.

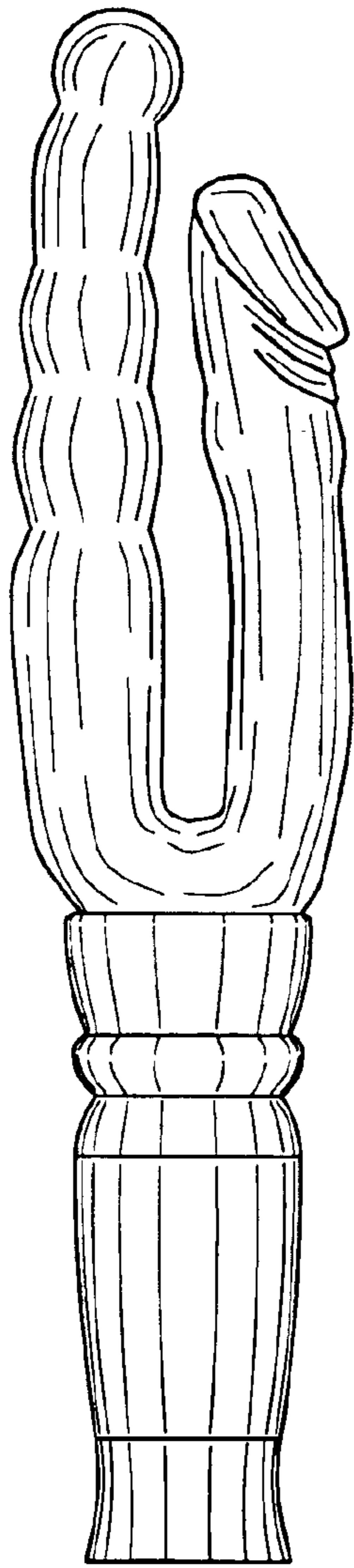

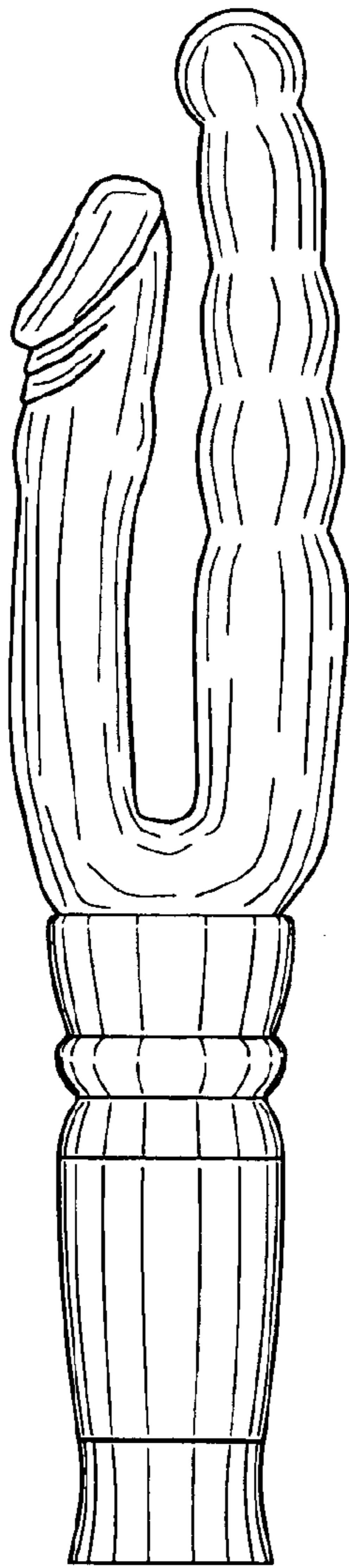

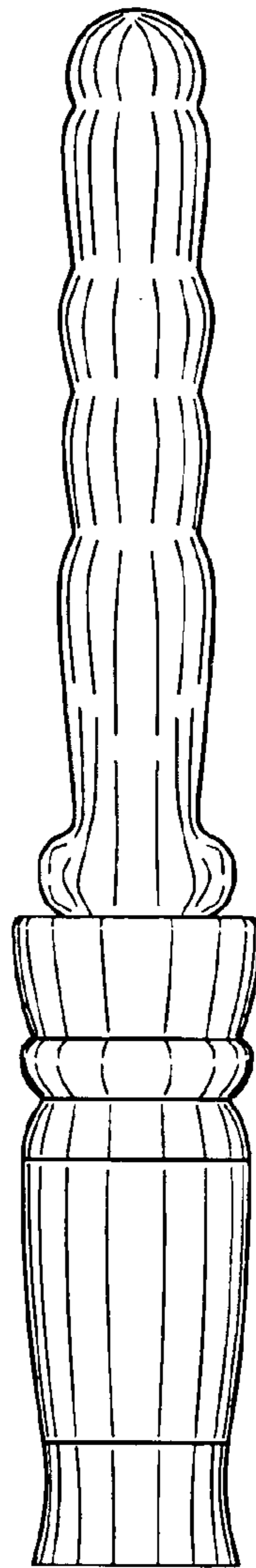

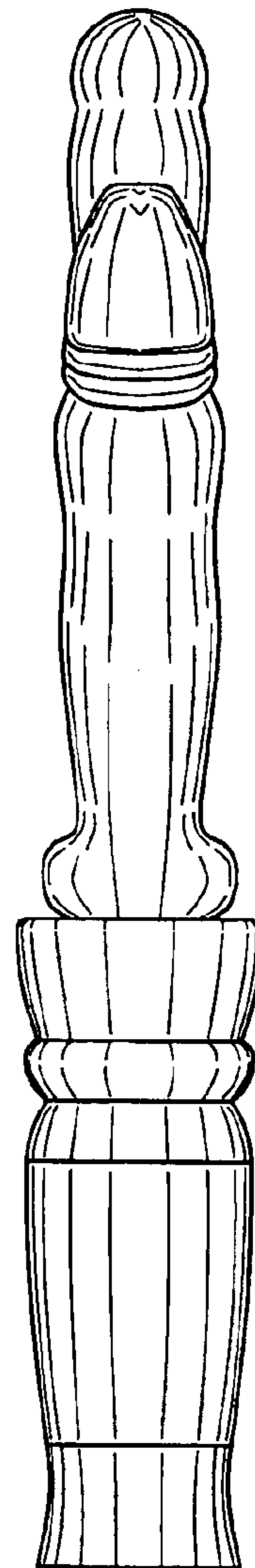

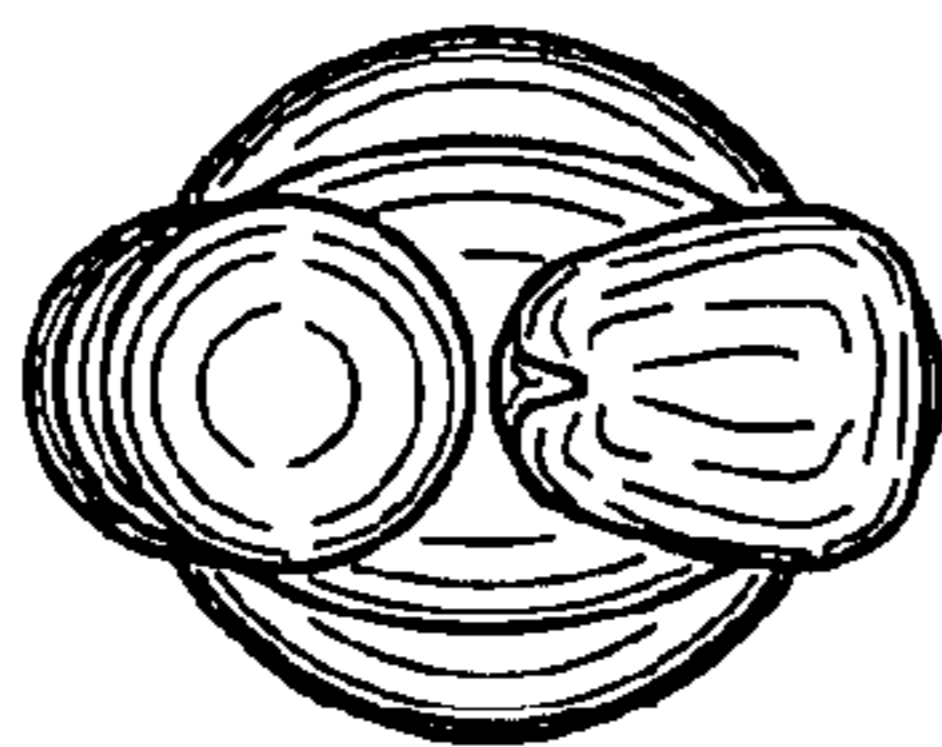

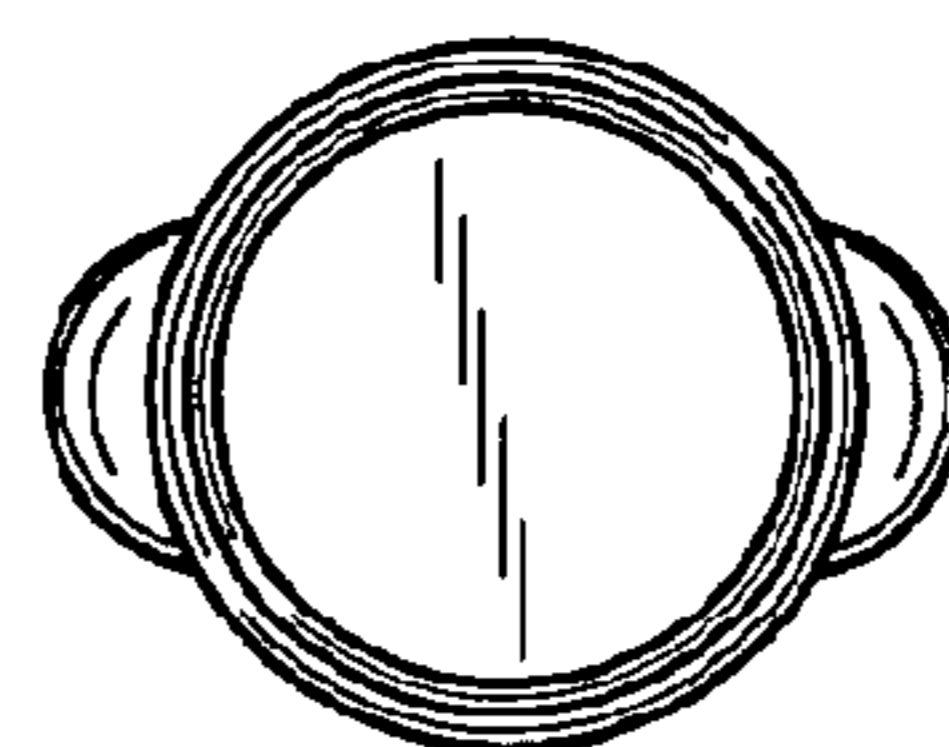
