FIG. 16 is a front perspective view of another preferred embodiment of the lighter according to the present design;

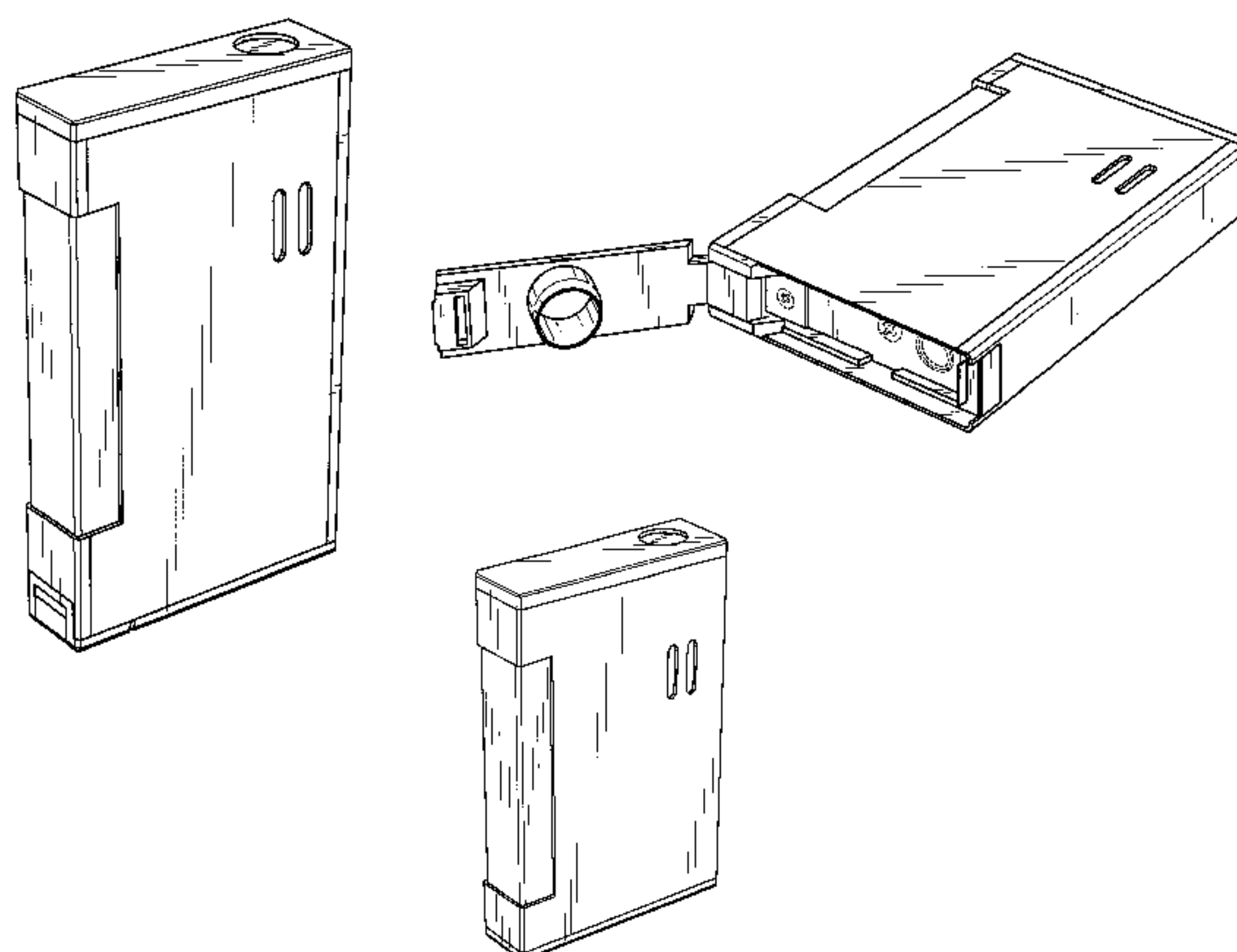

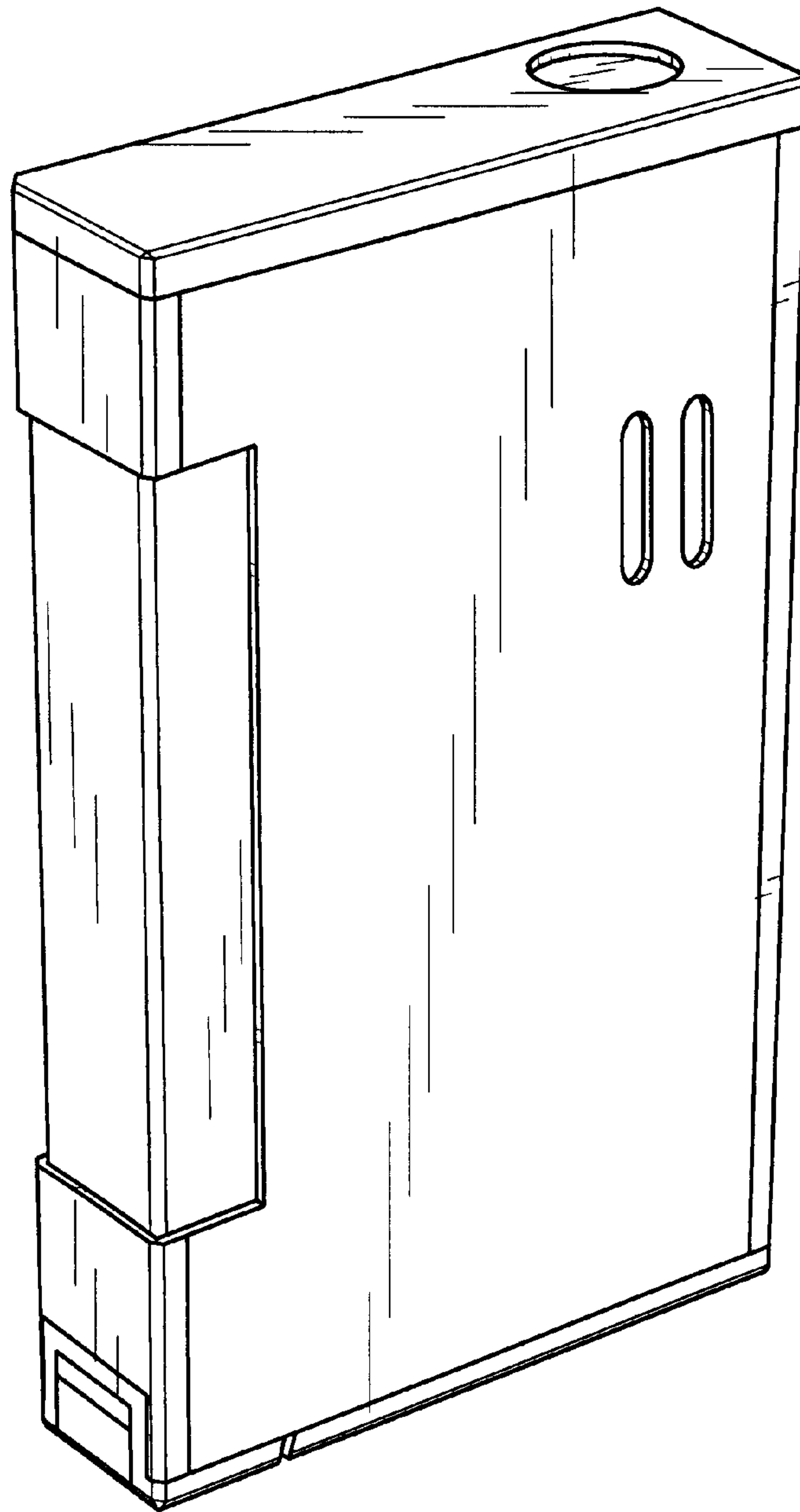

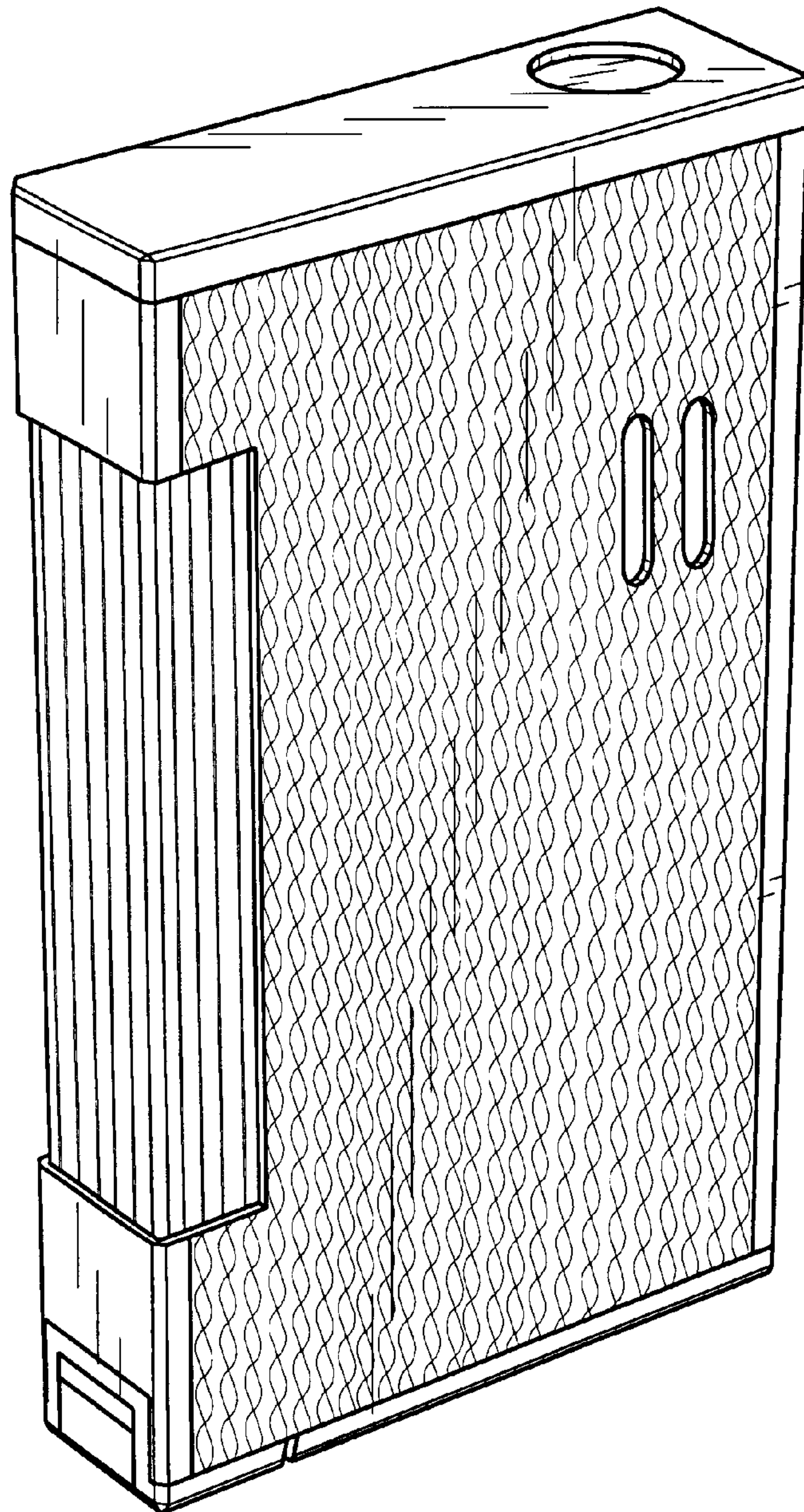

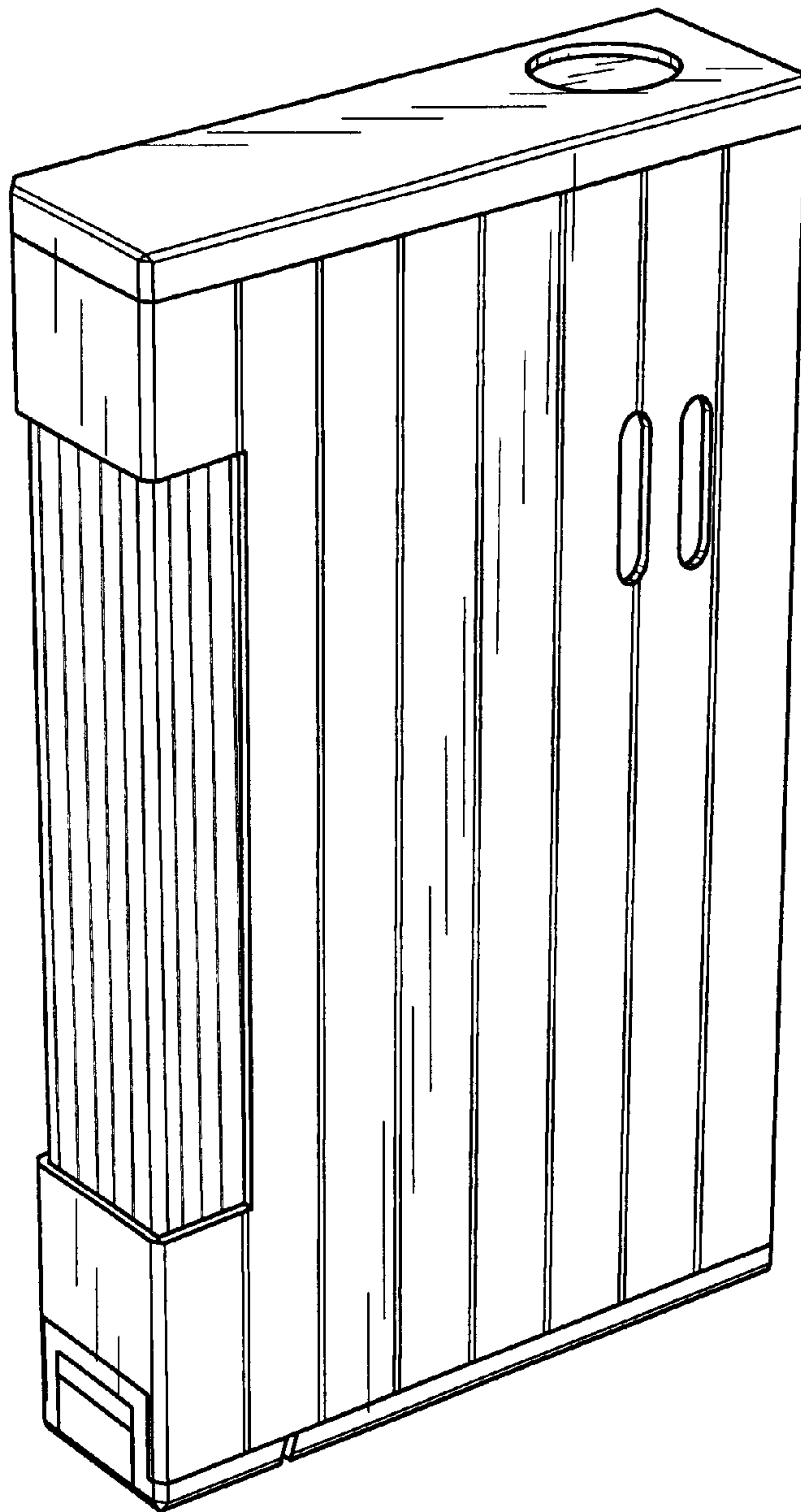

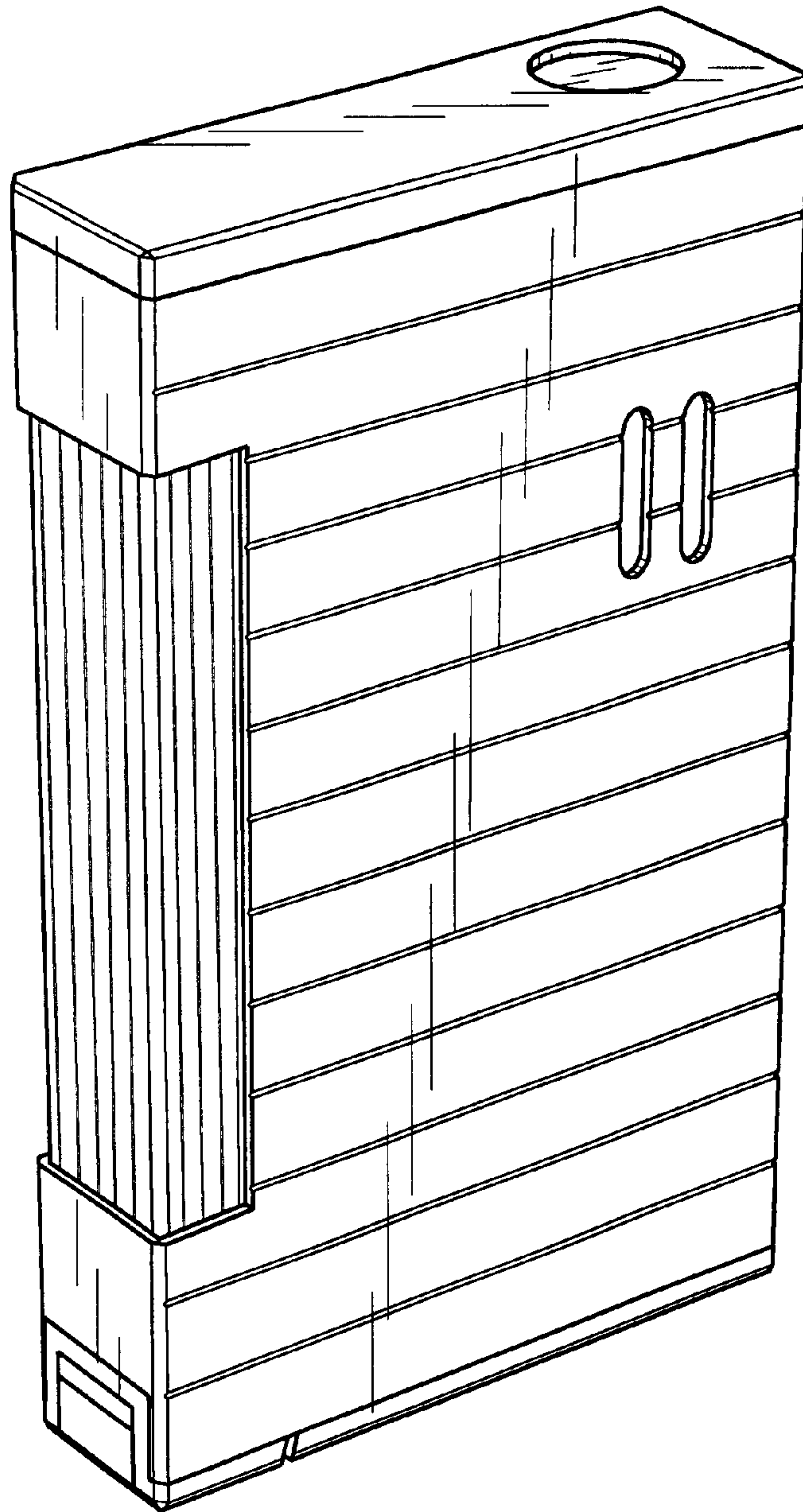

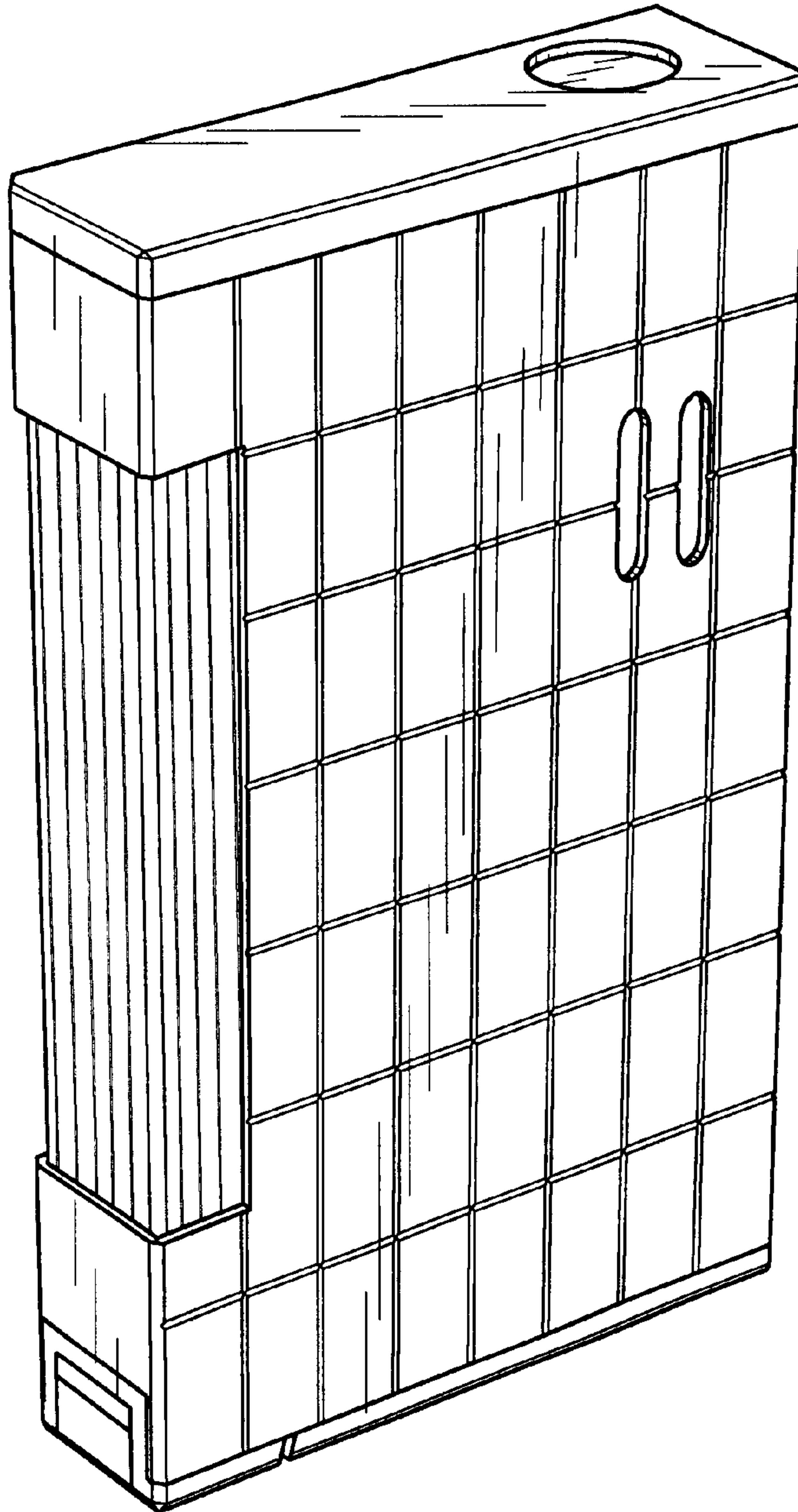

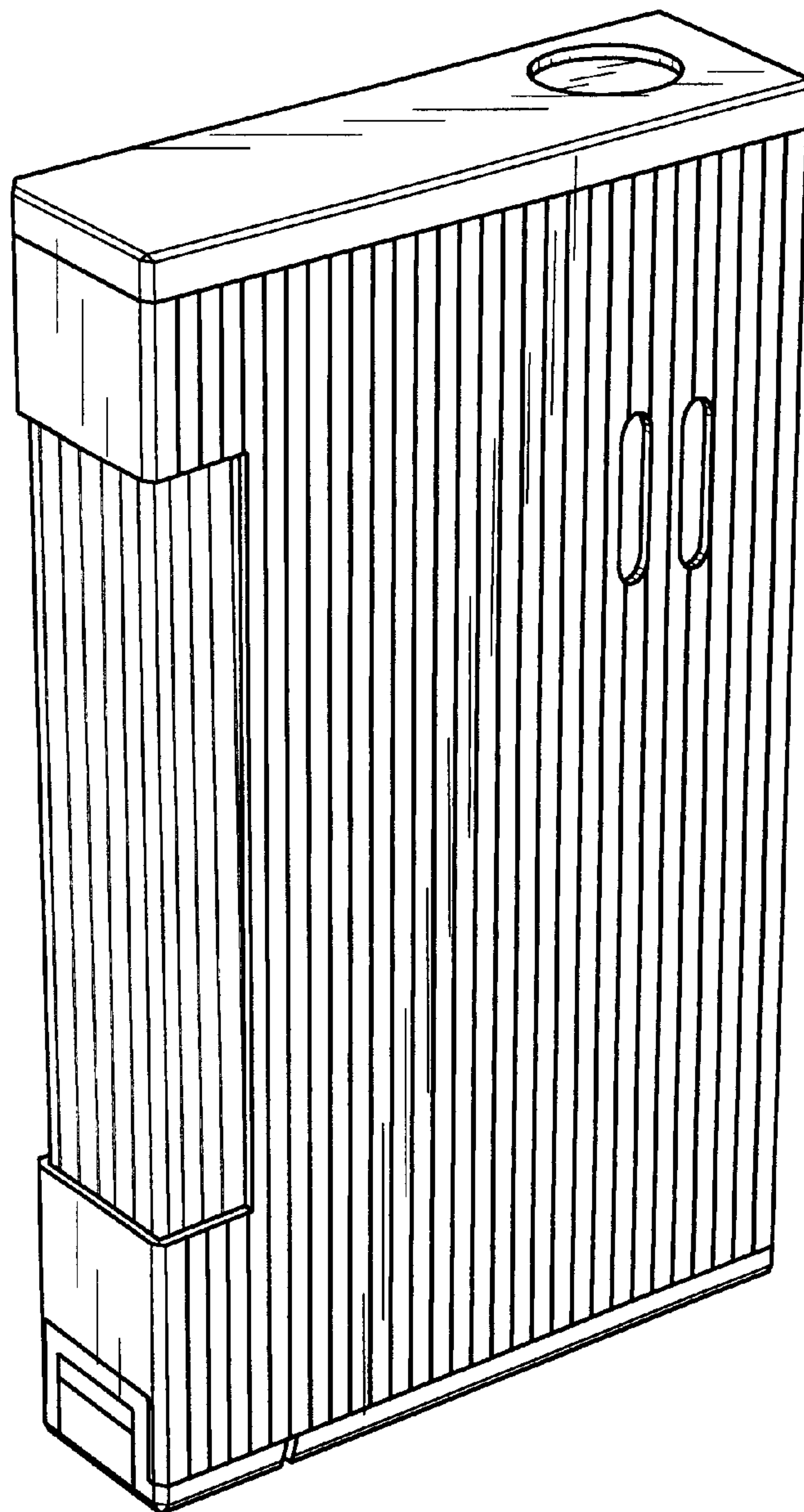

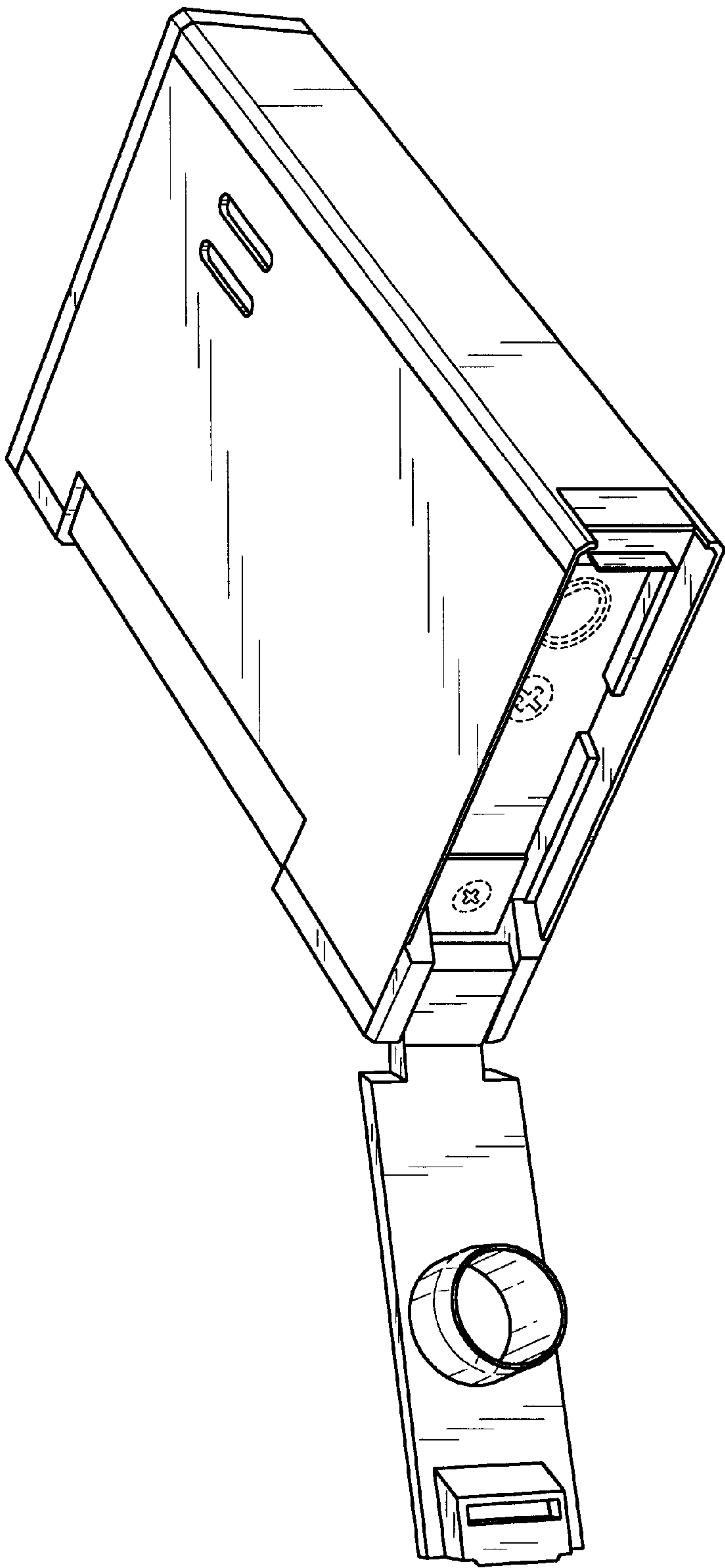

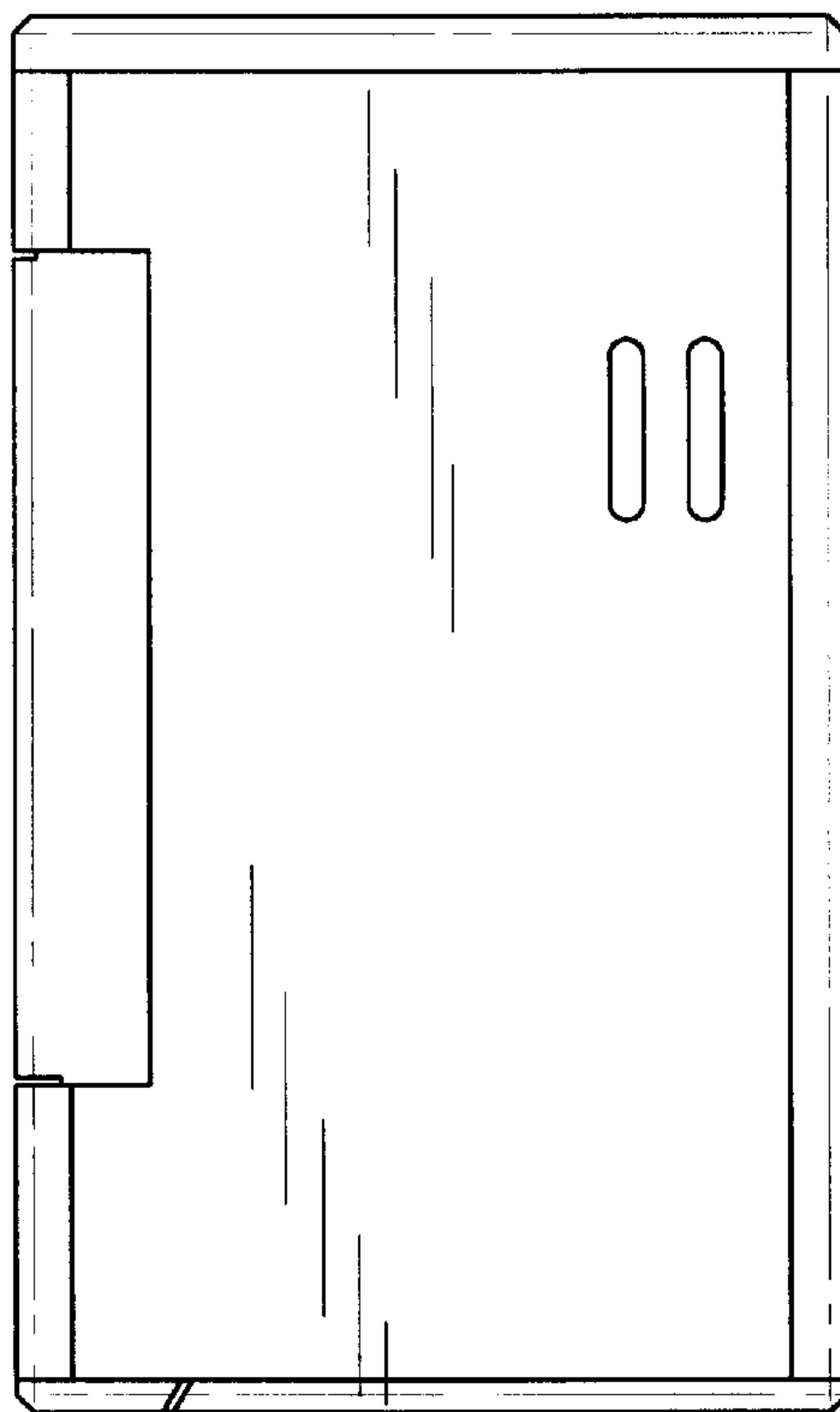

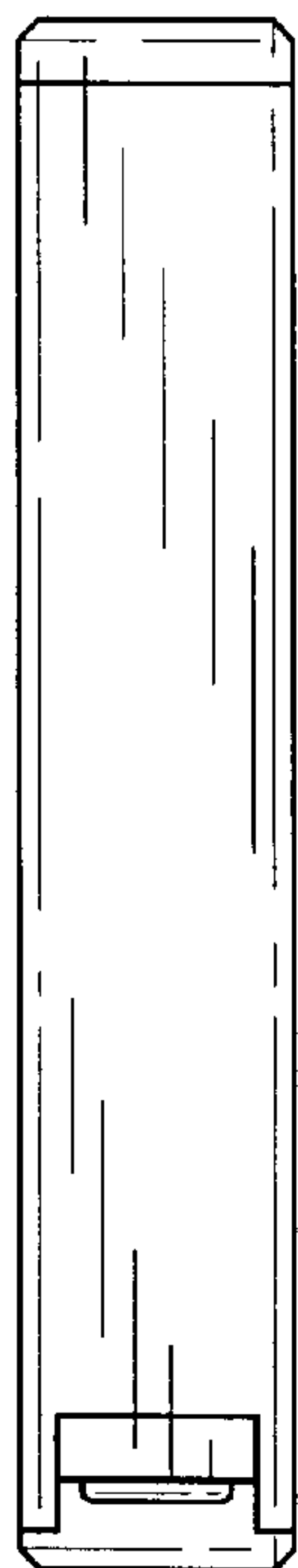

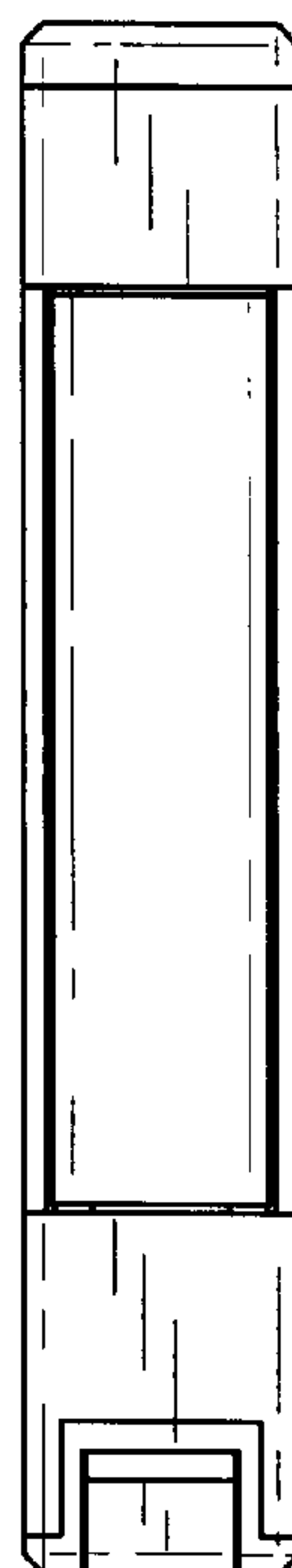

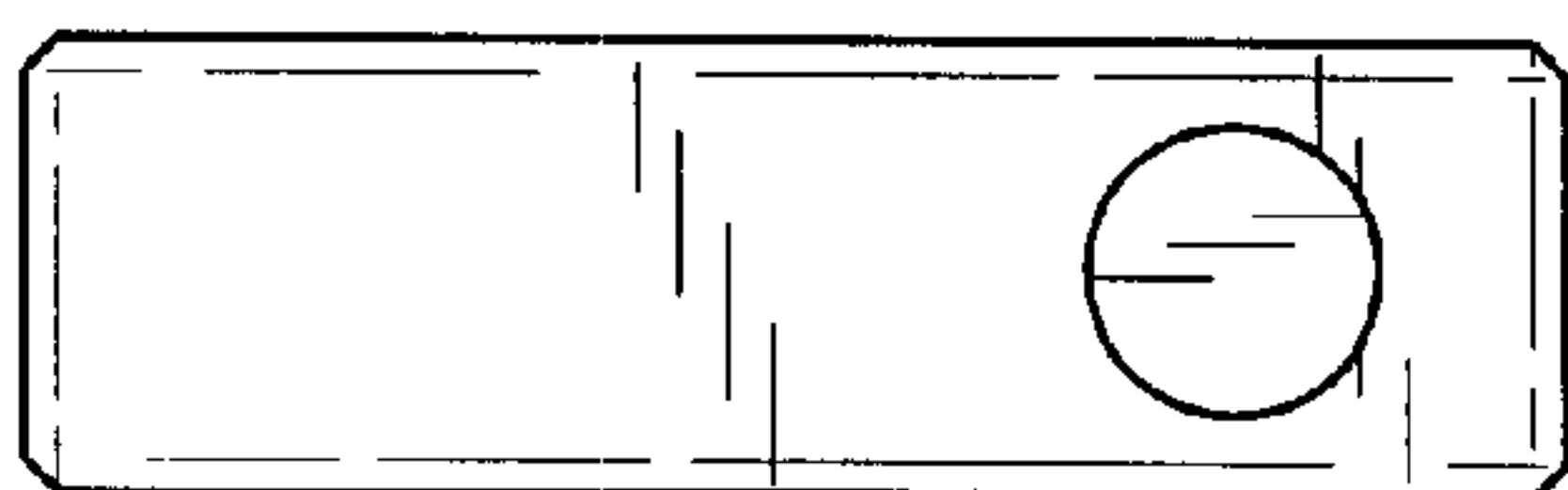

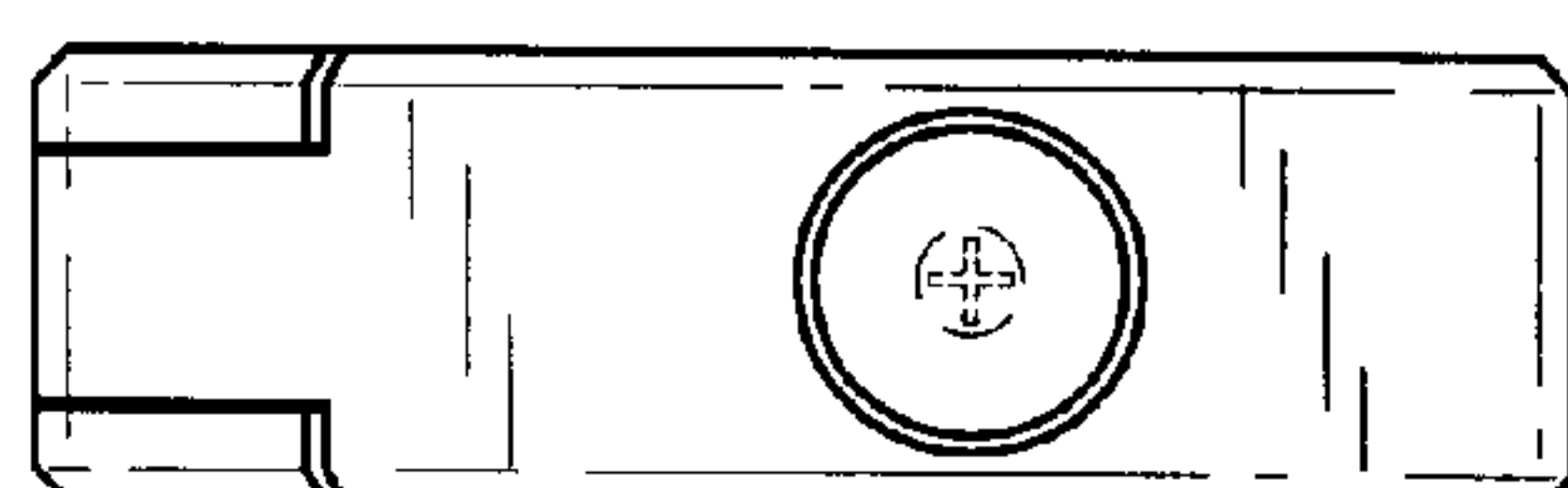

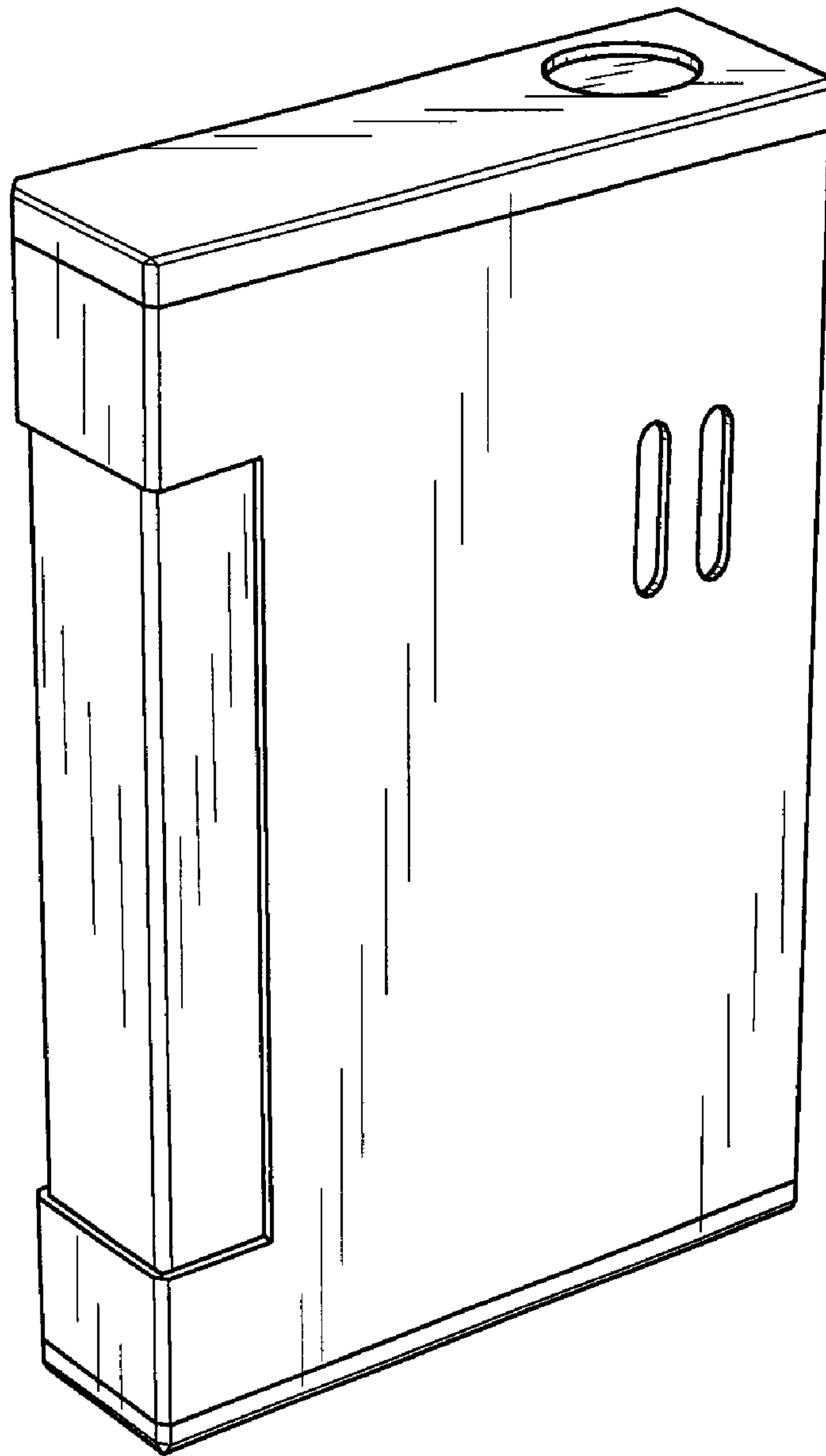

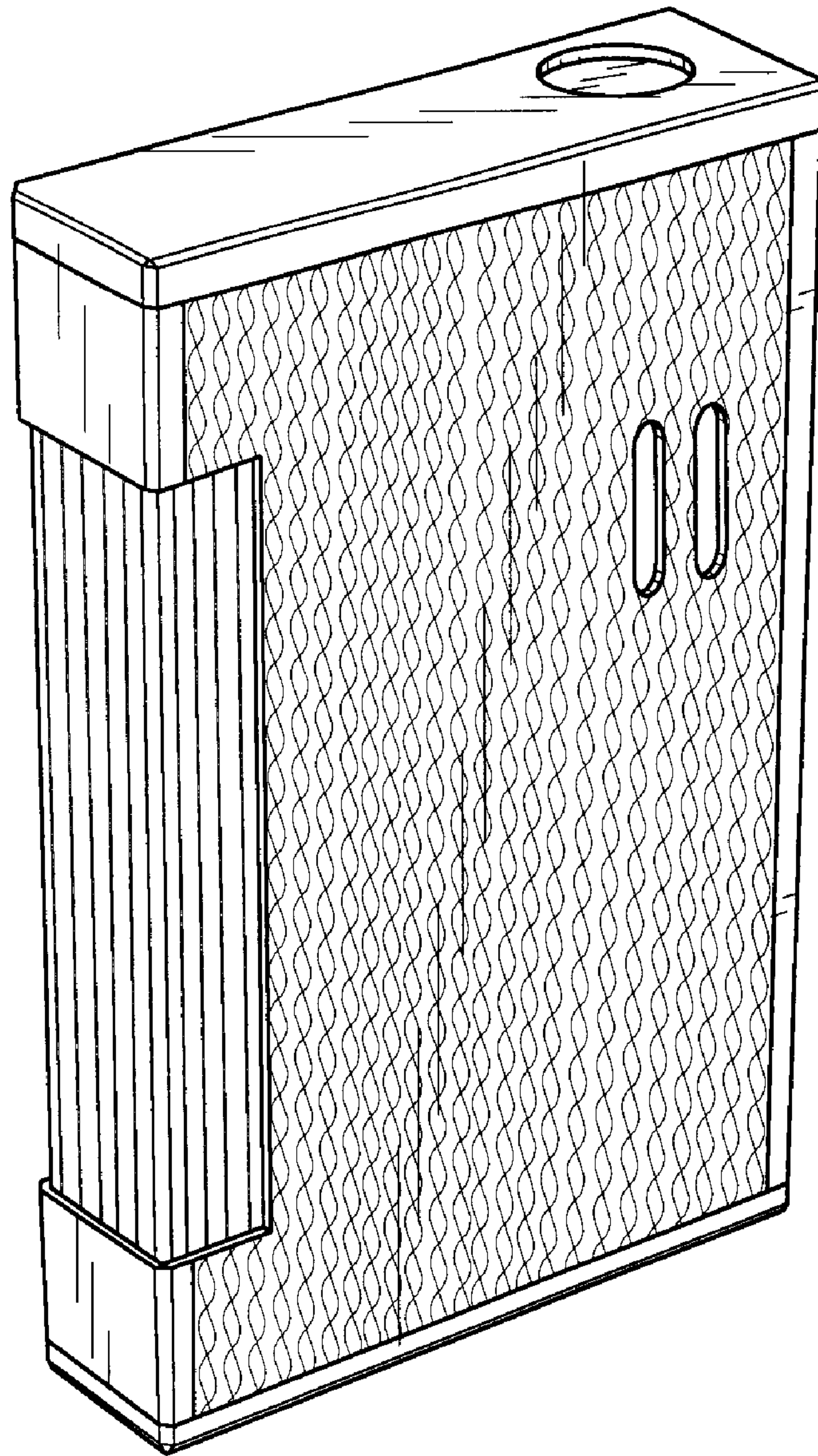

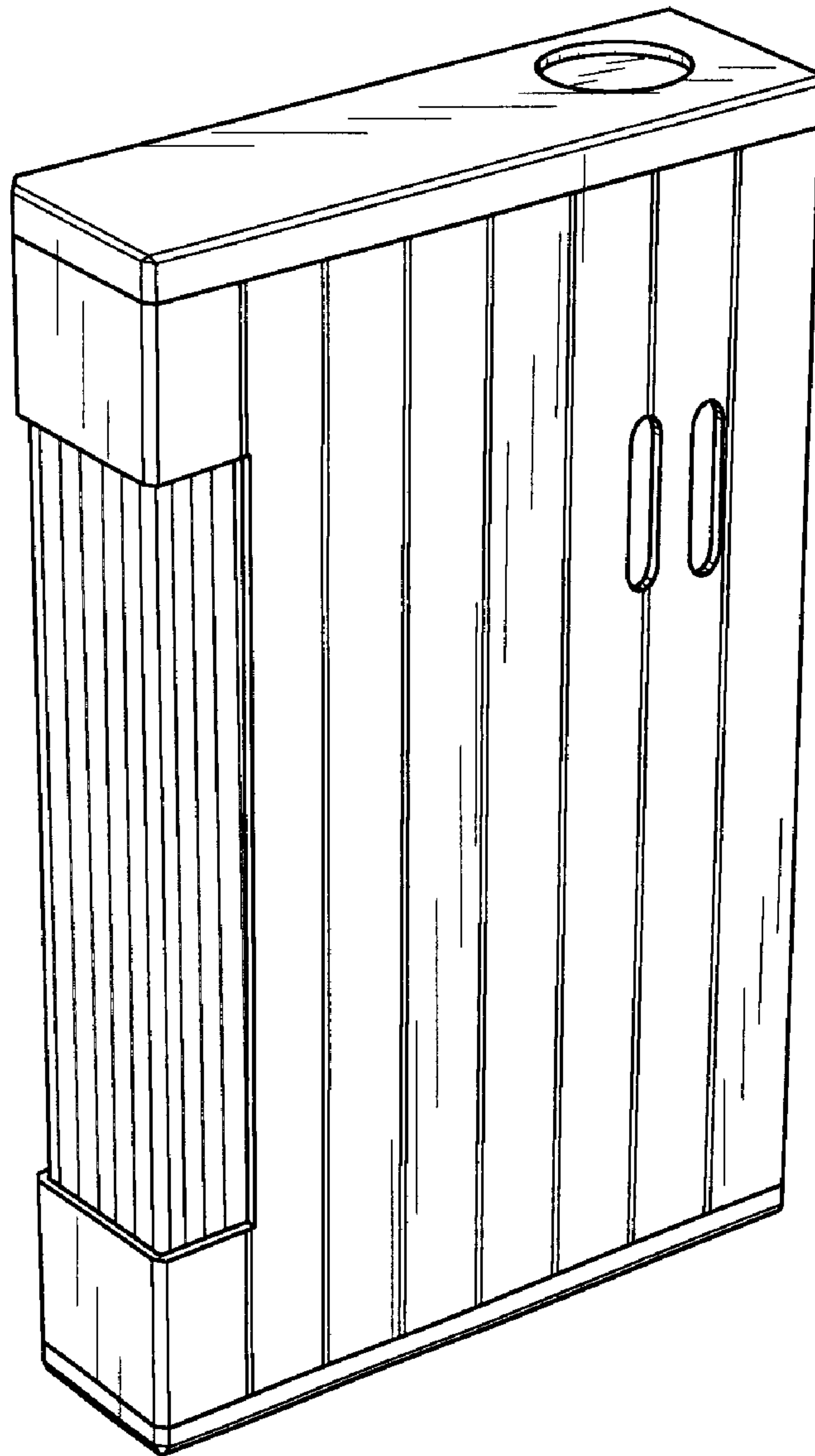

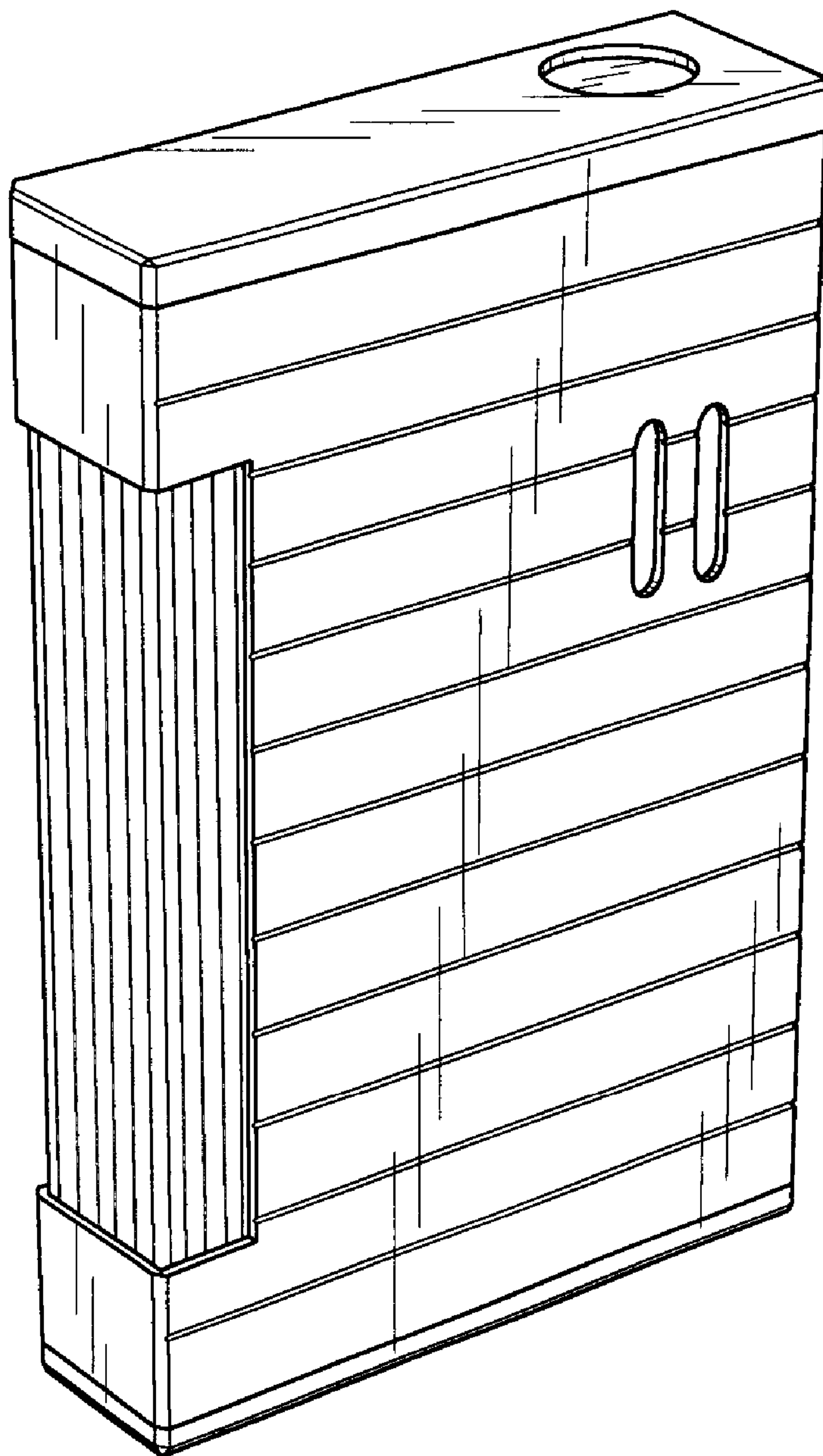

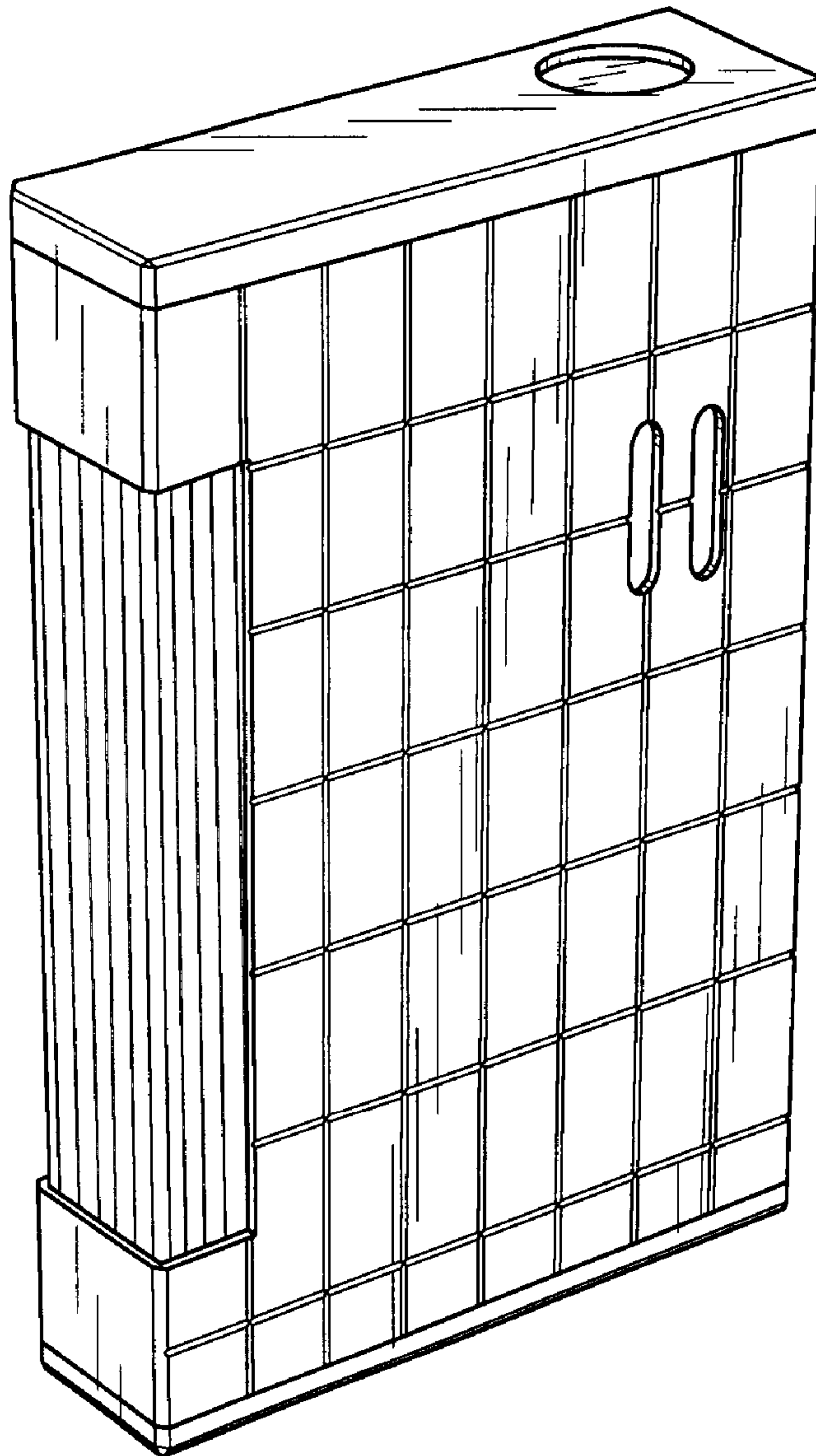

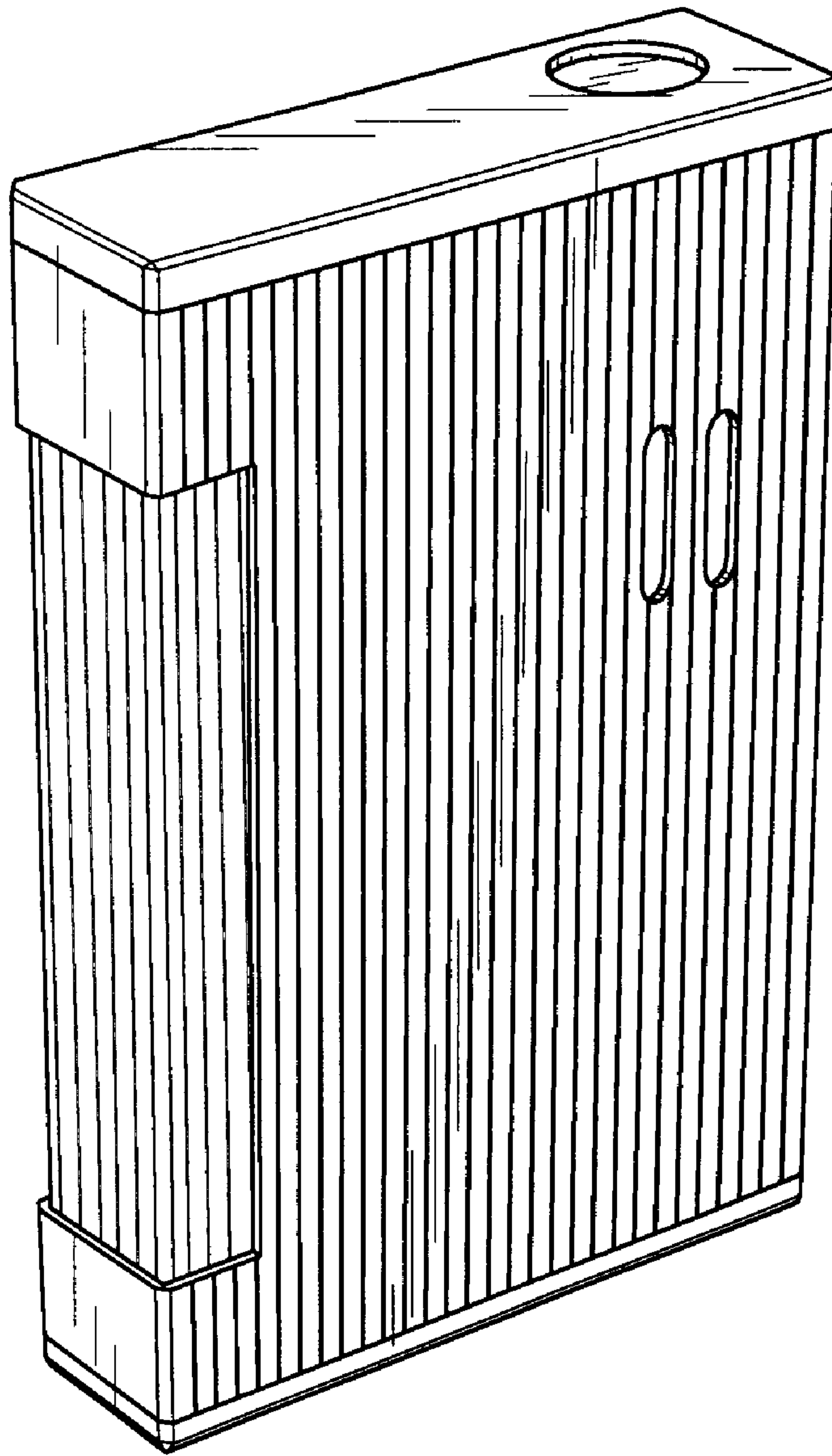

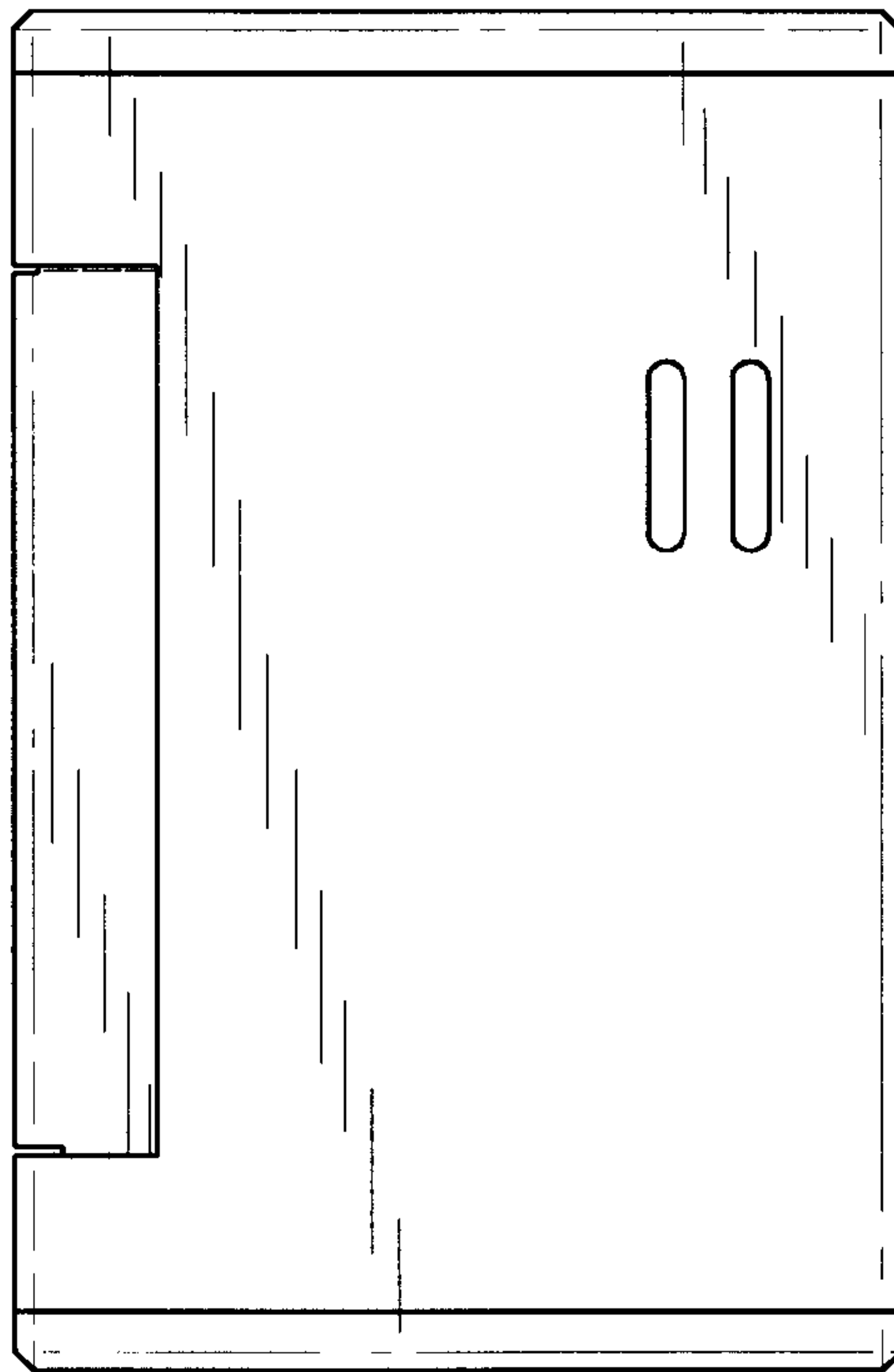

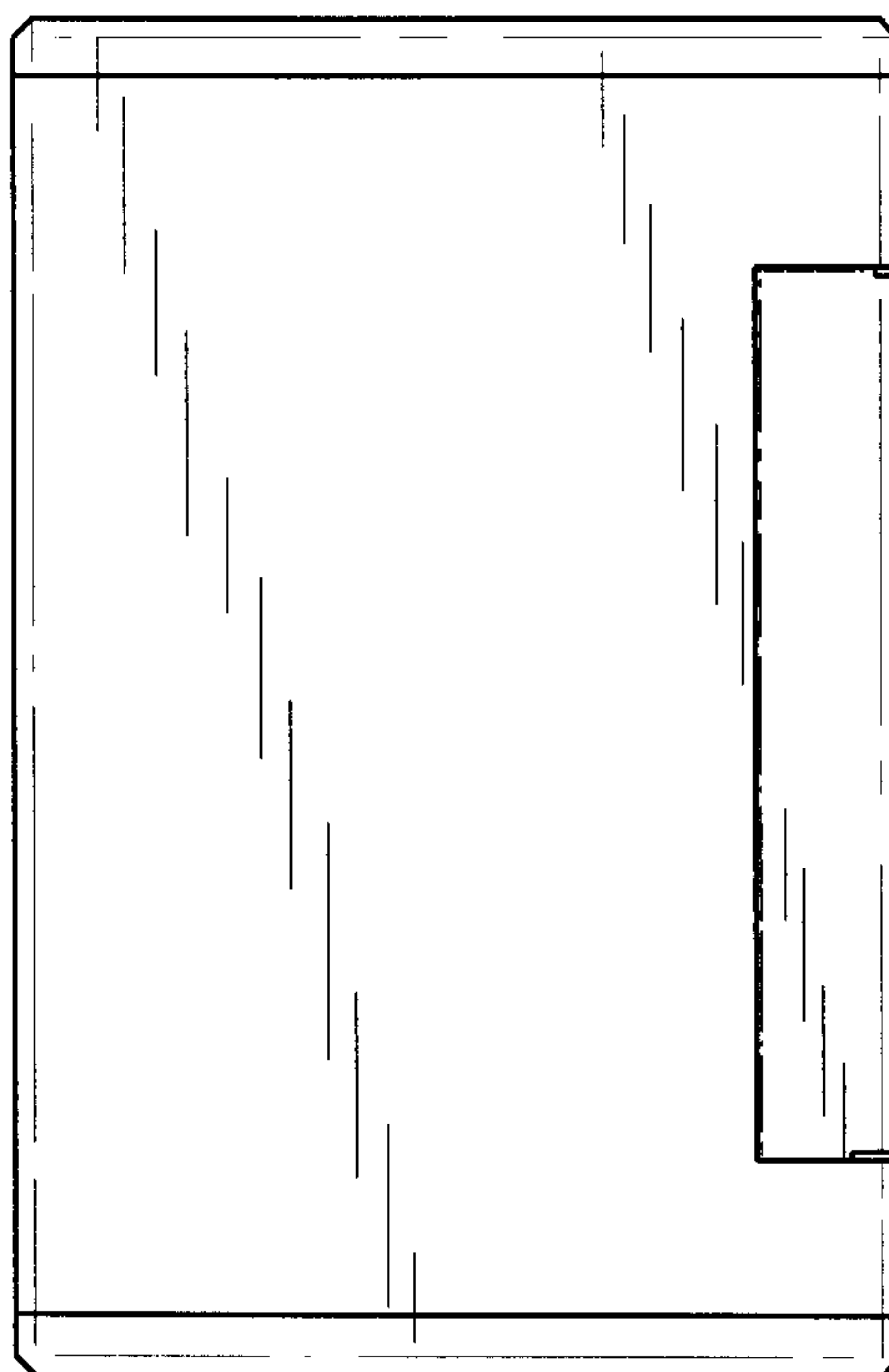

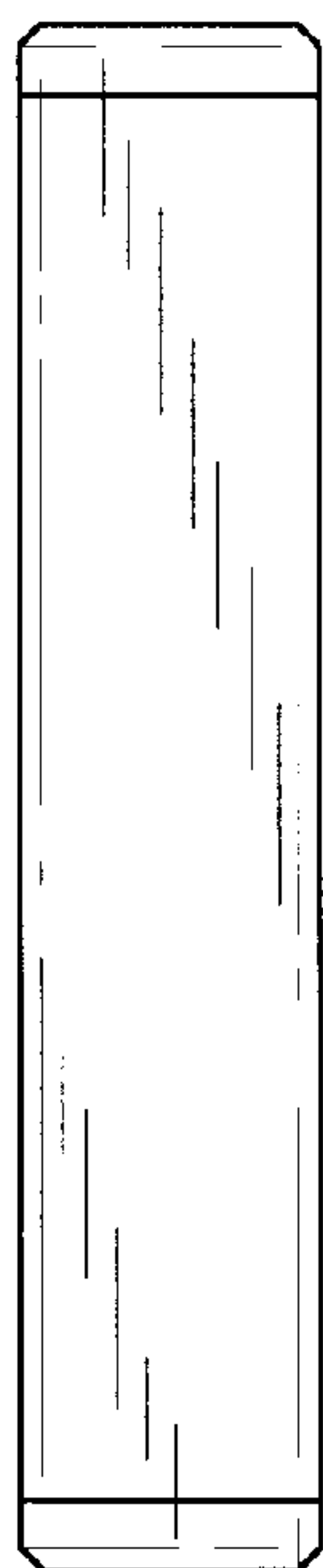

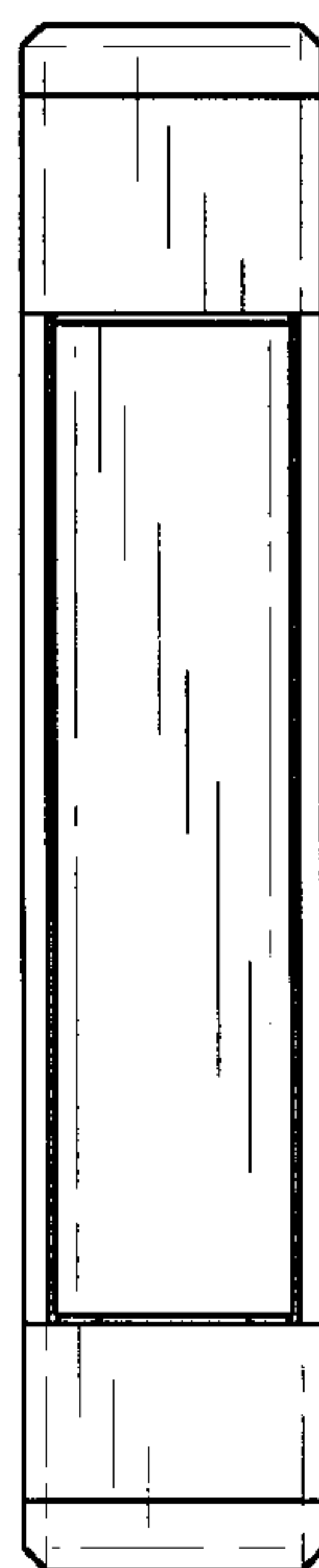

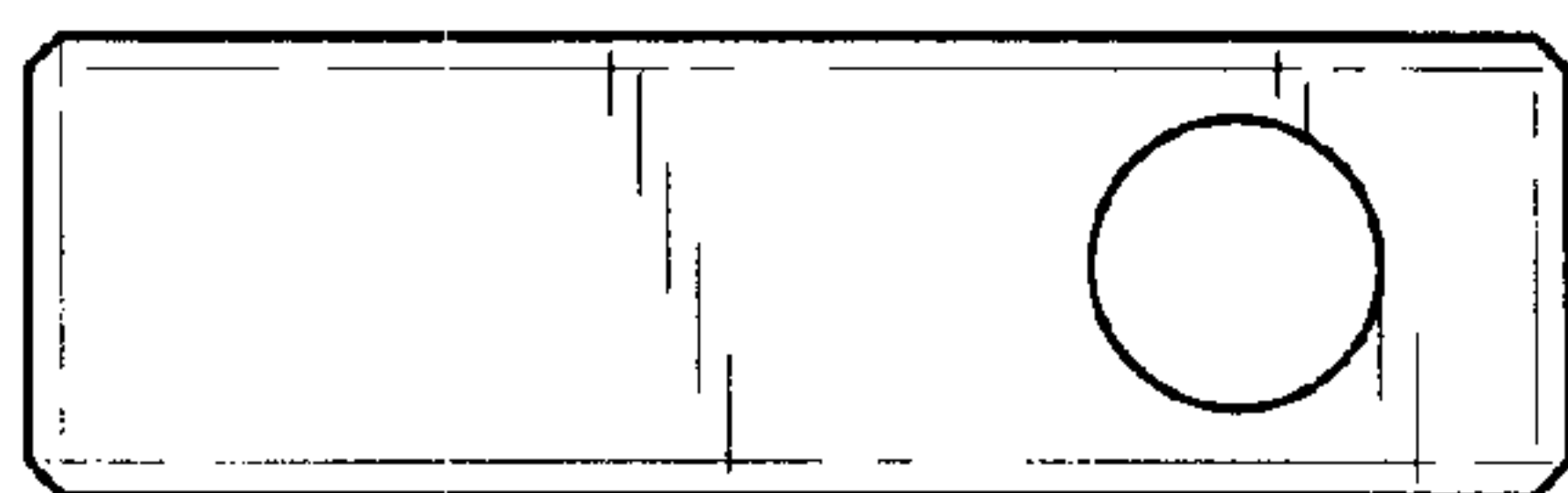

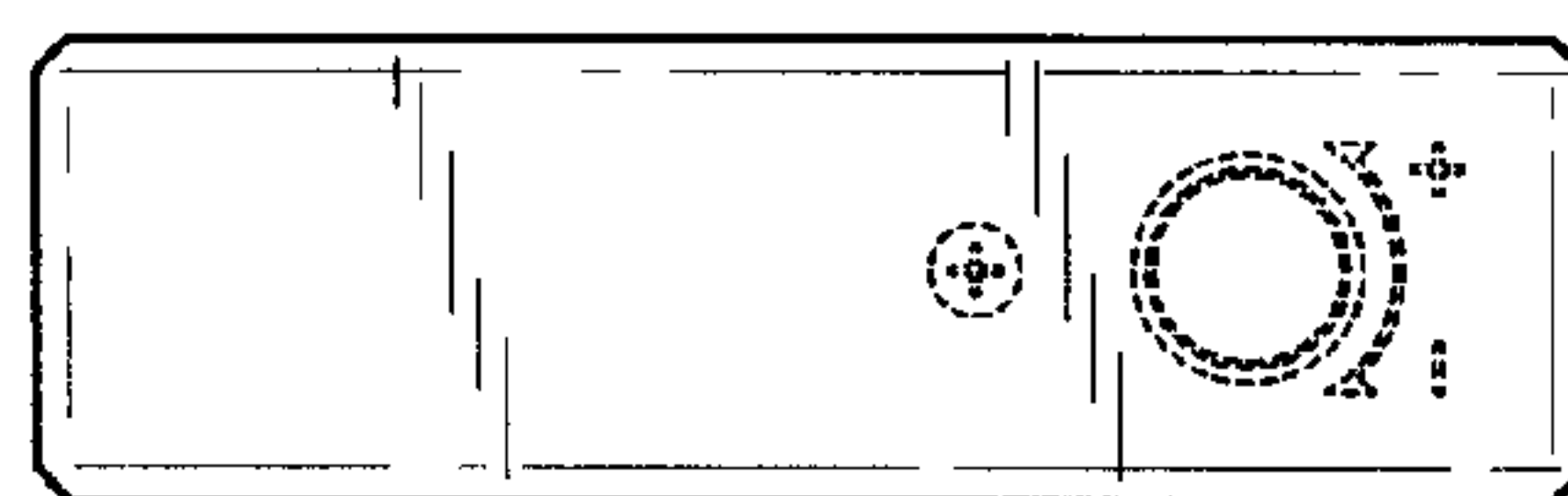

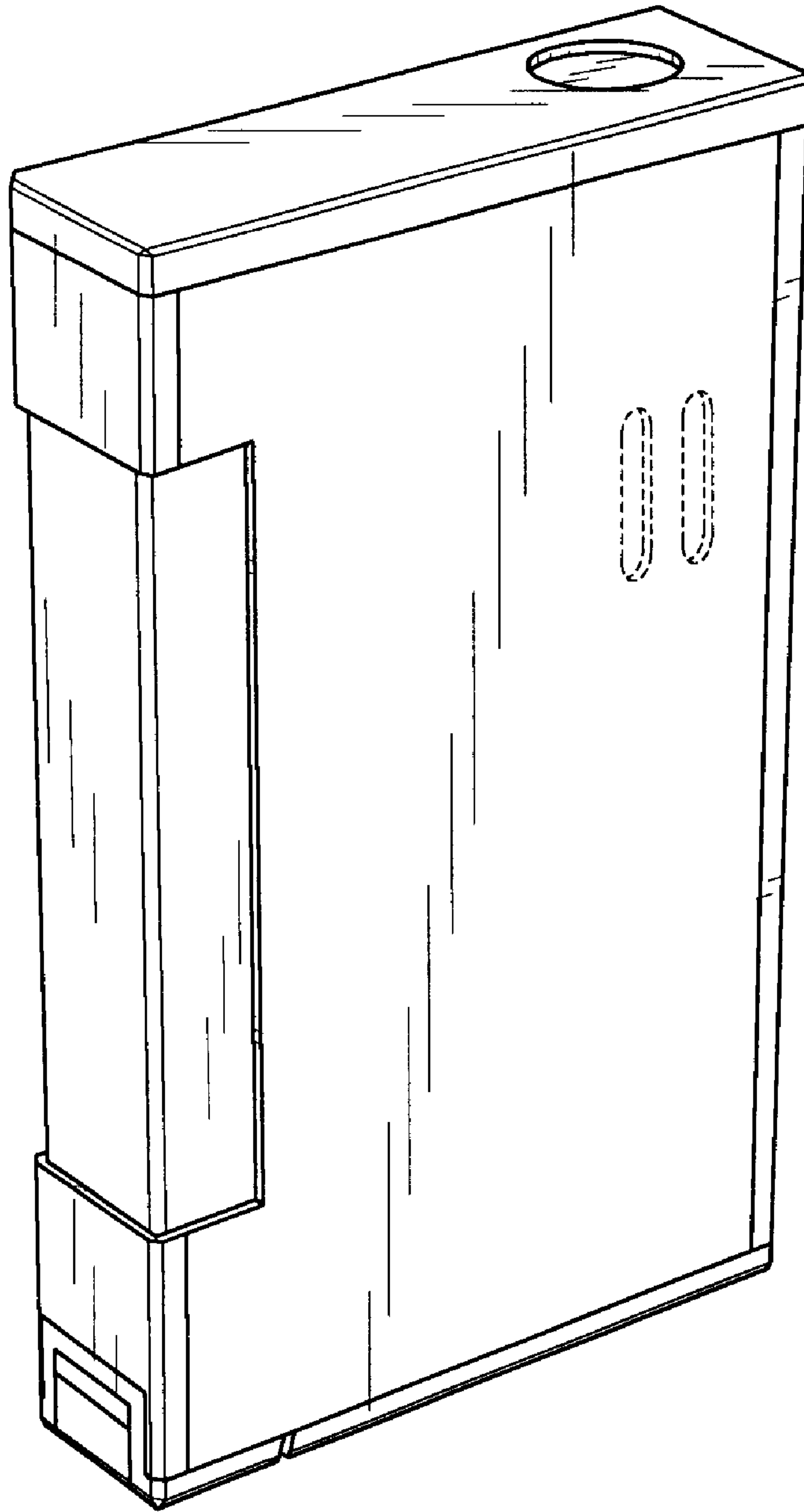

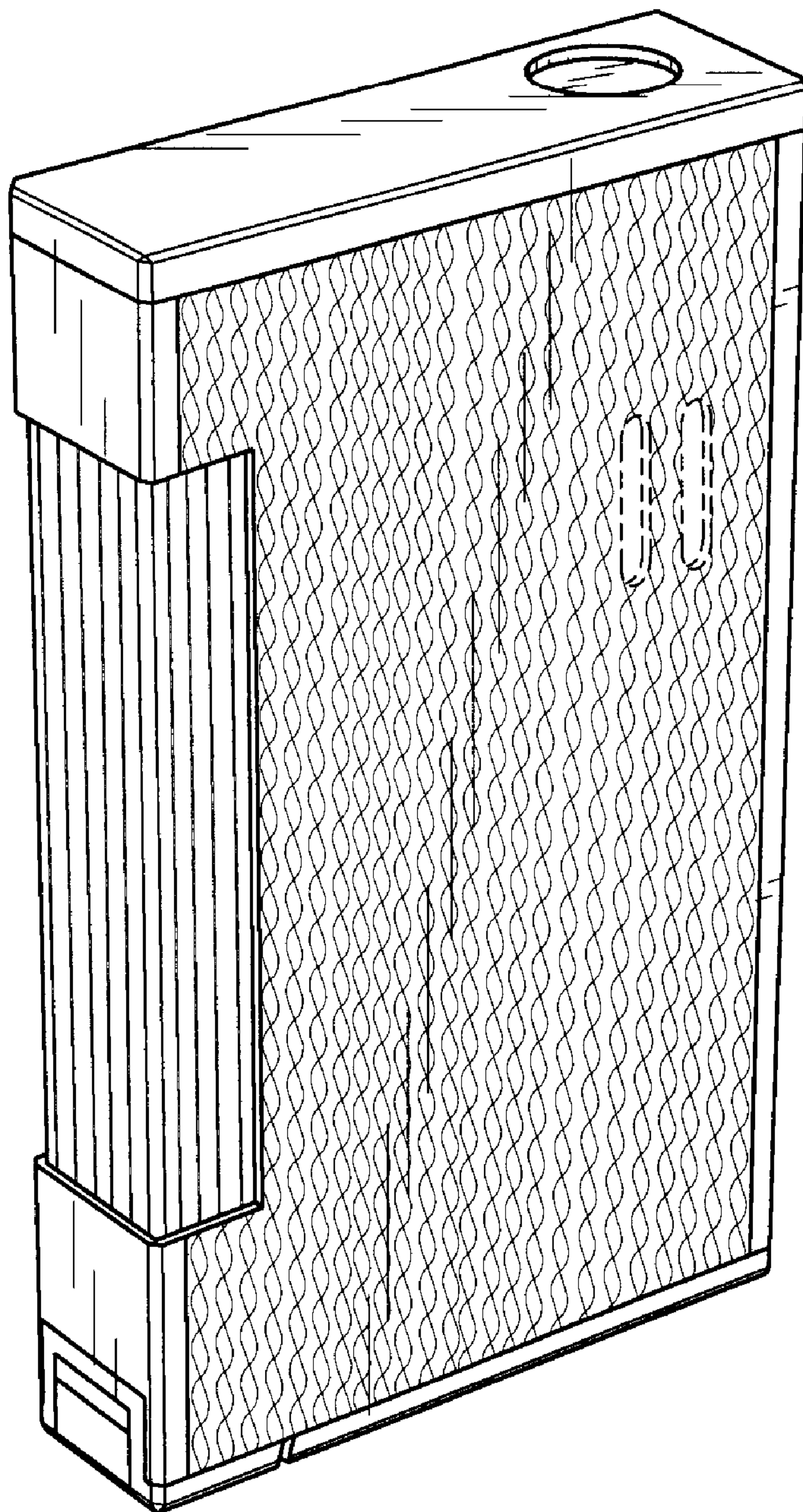

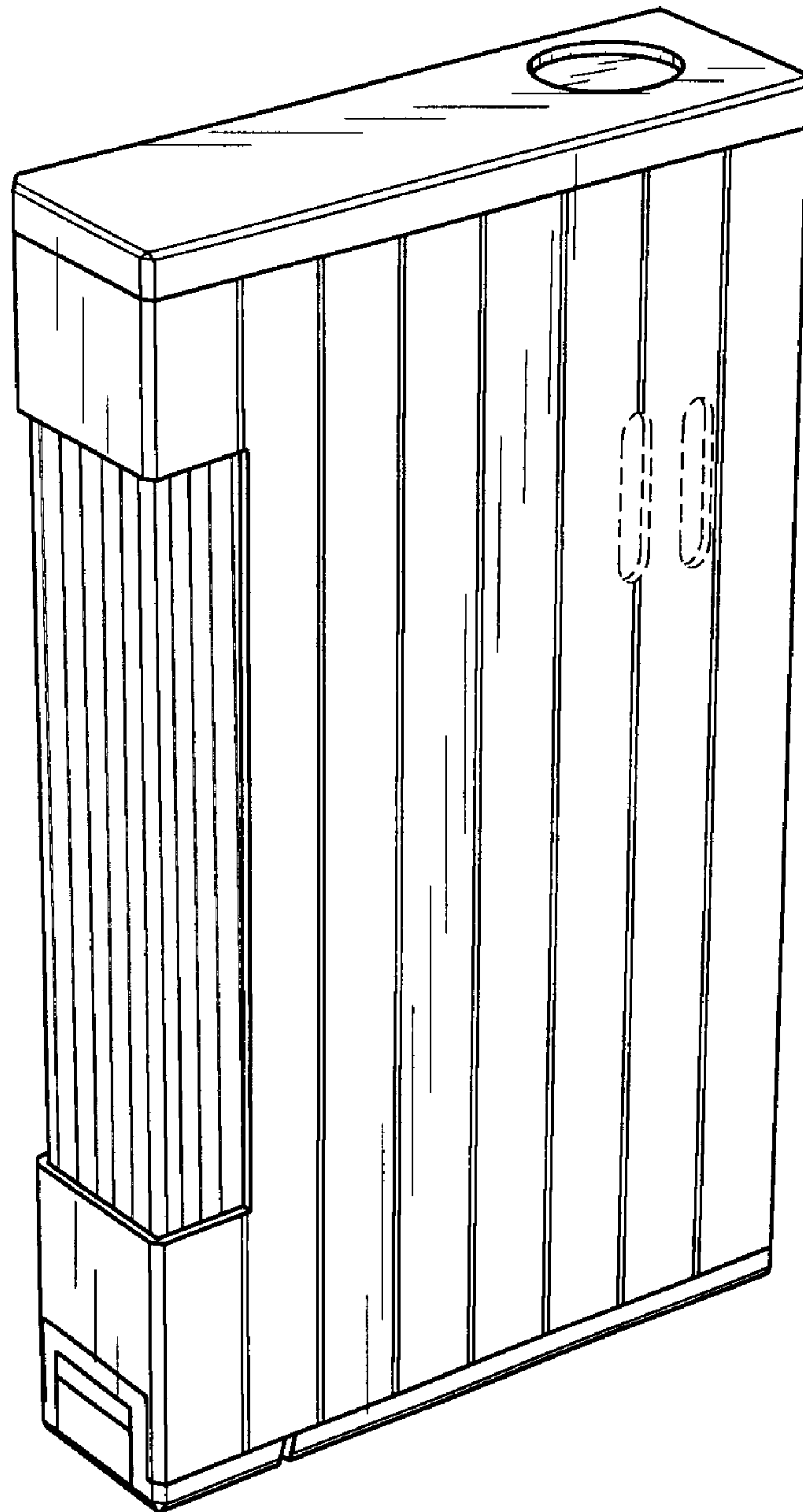

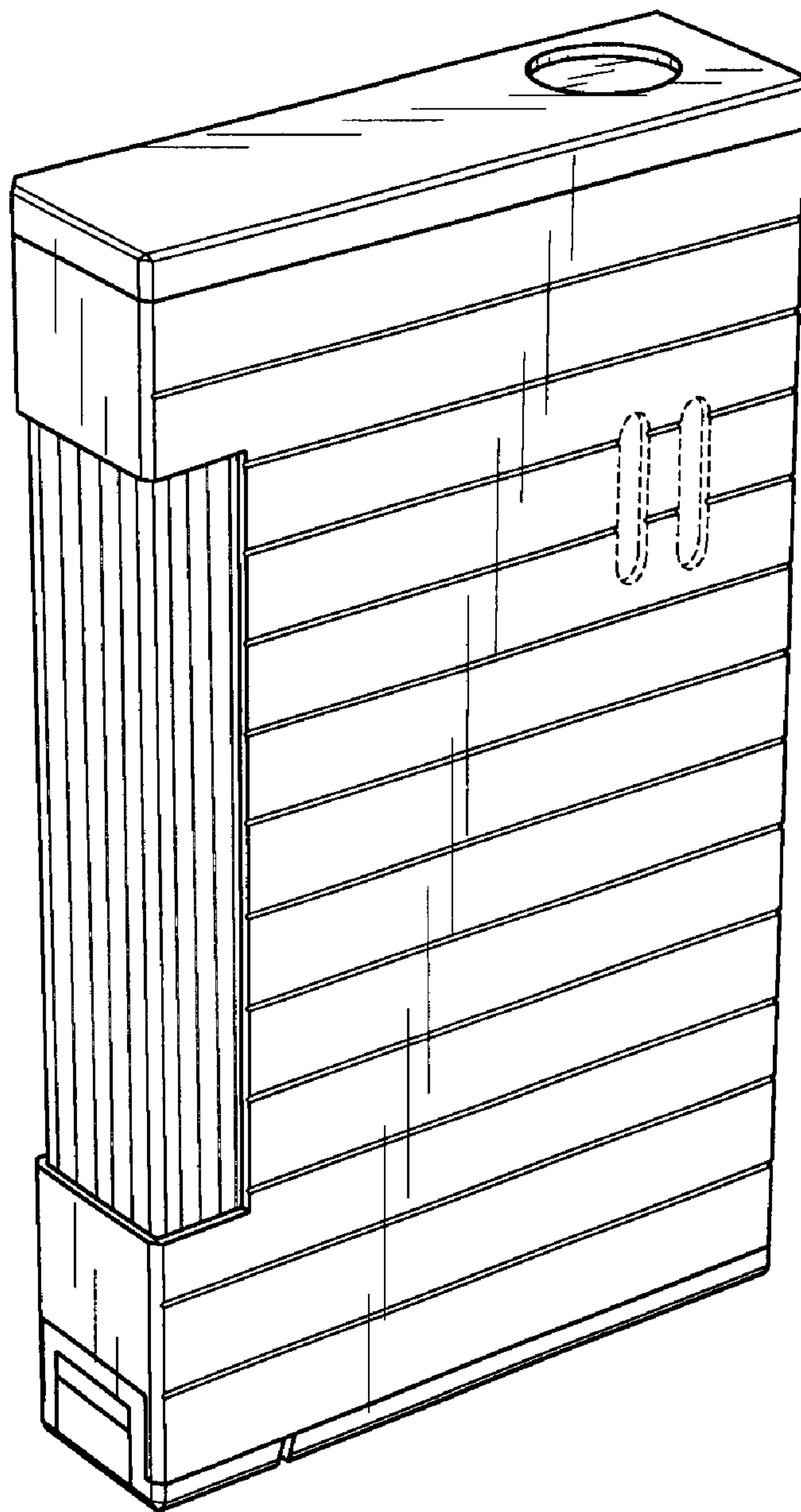

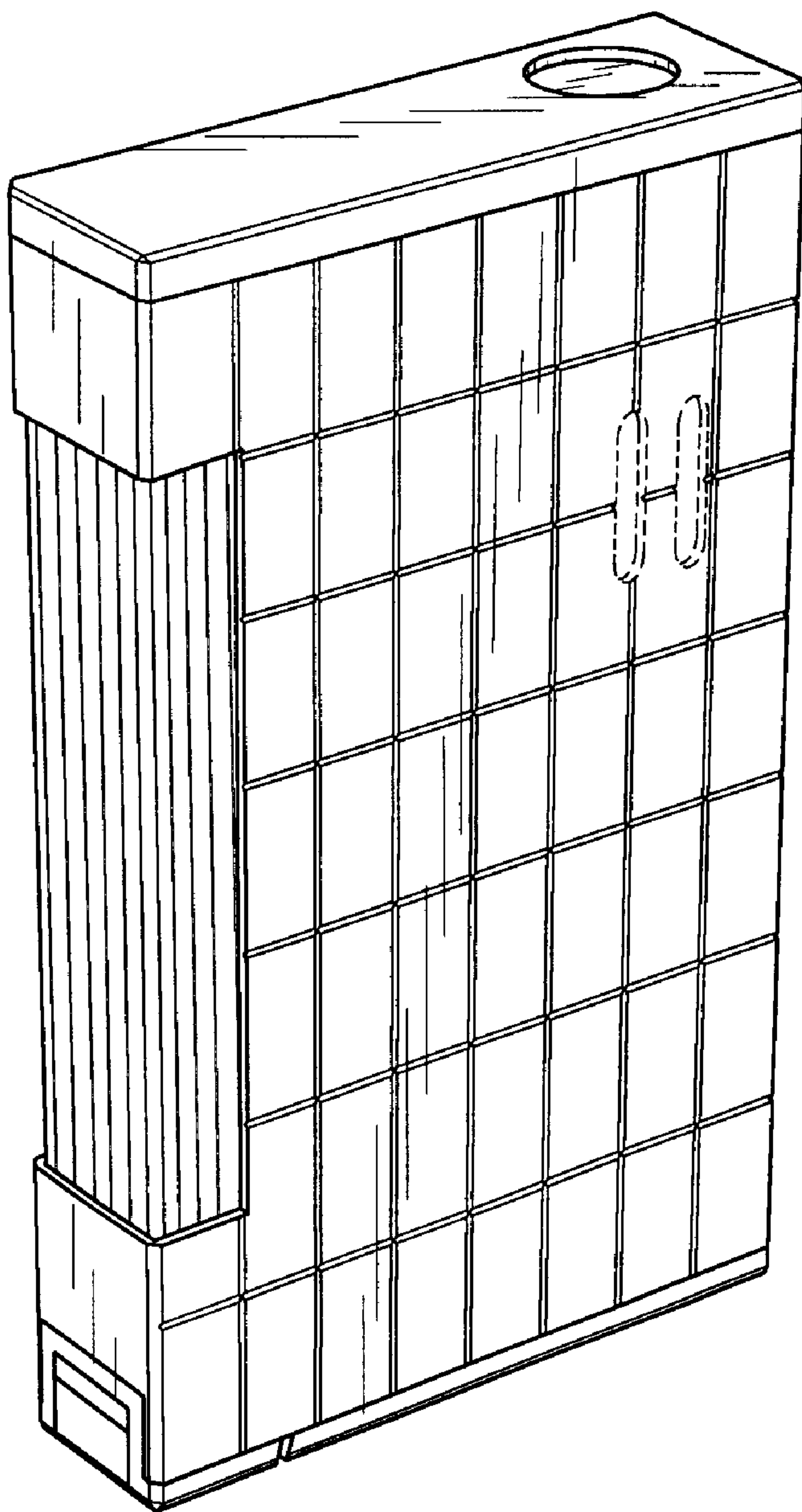

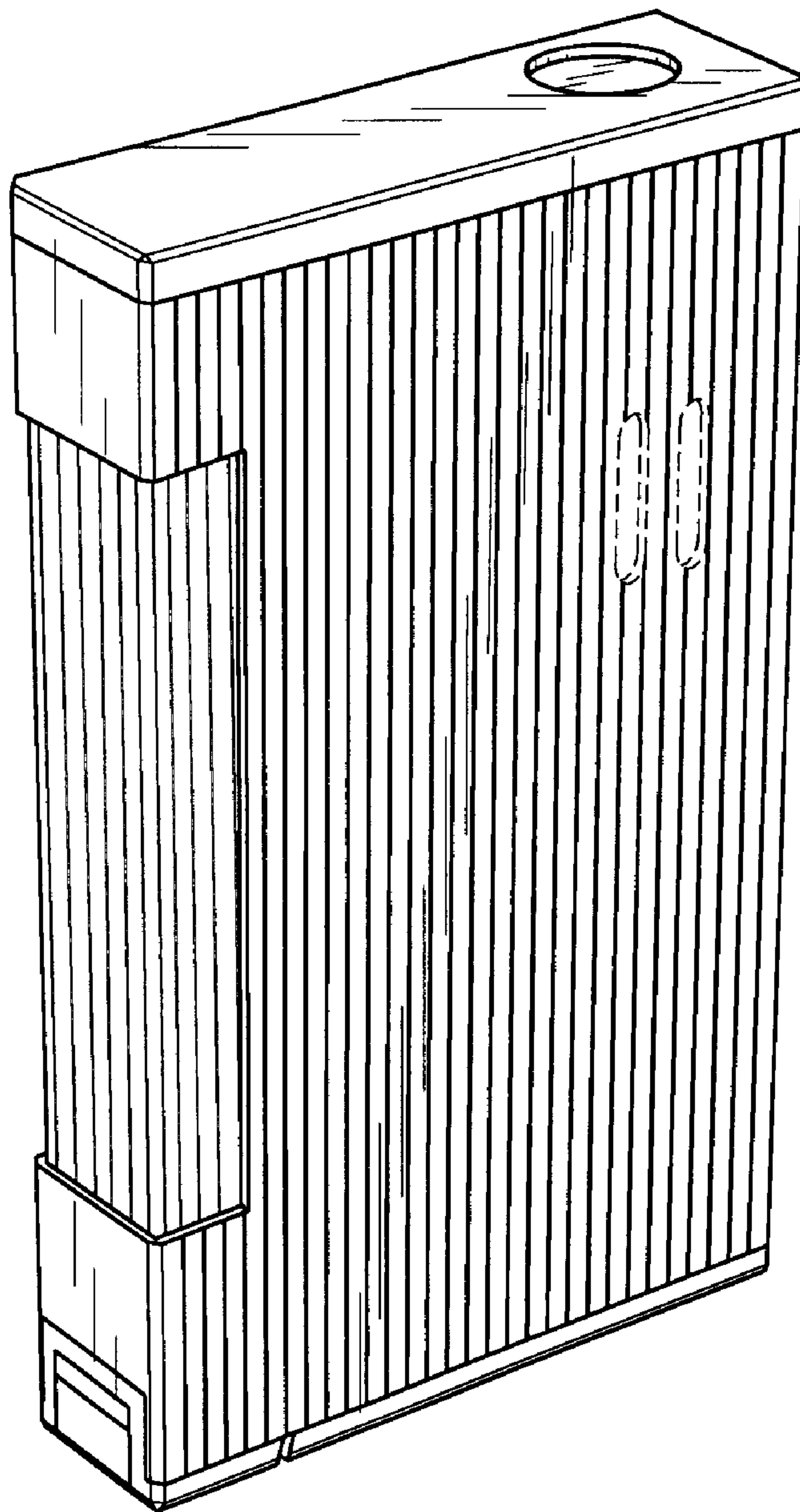

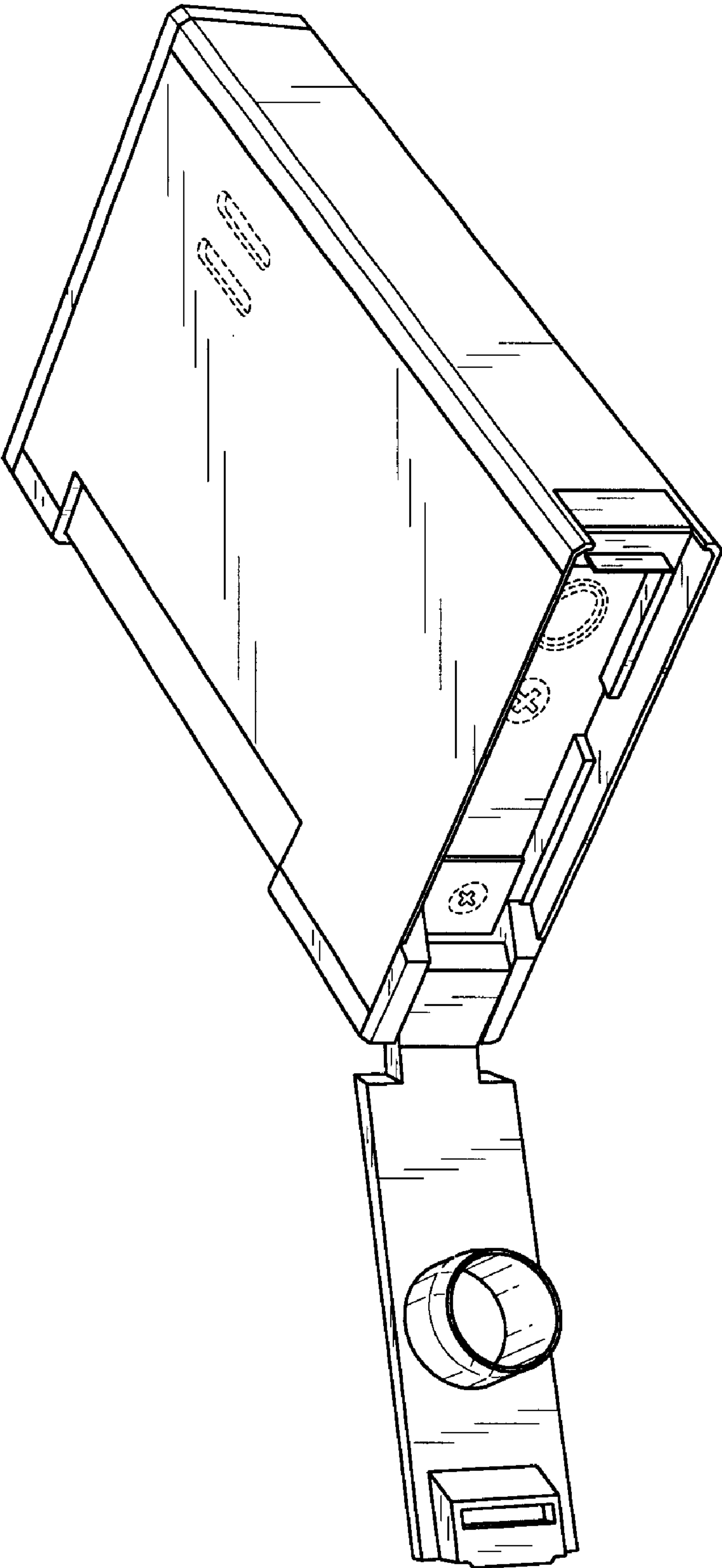

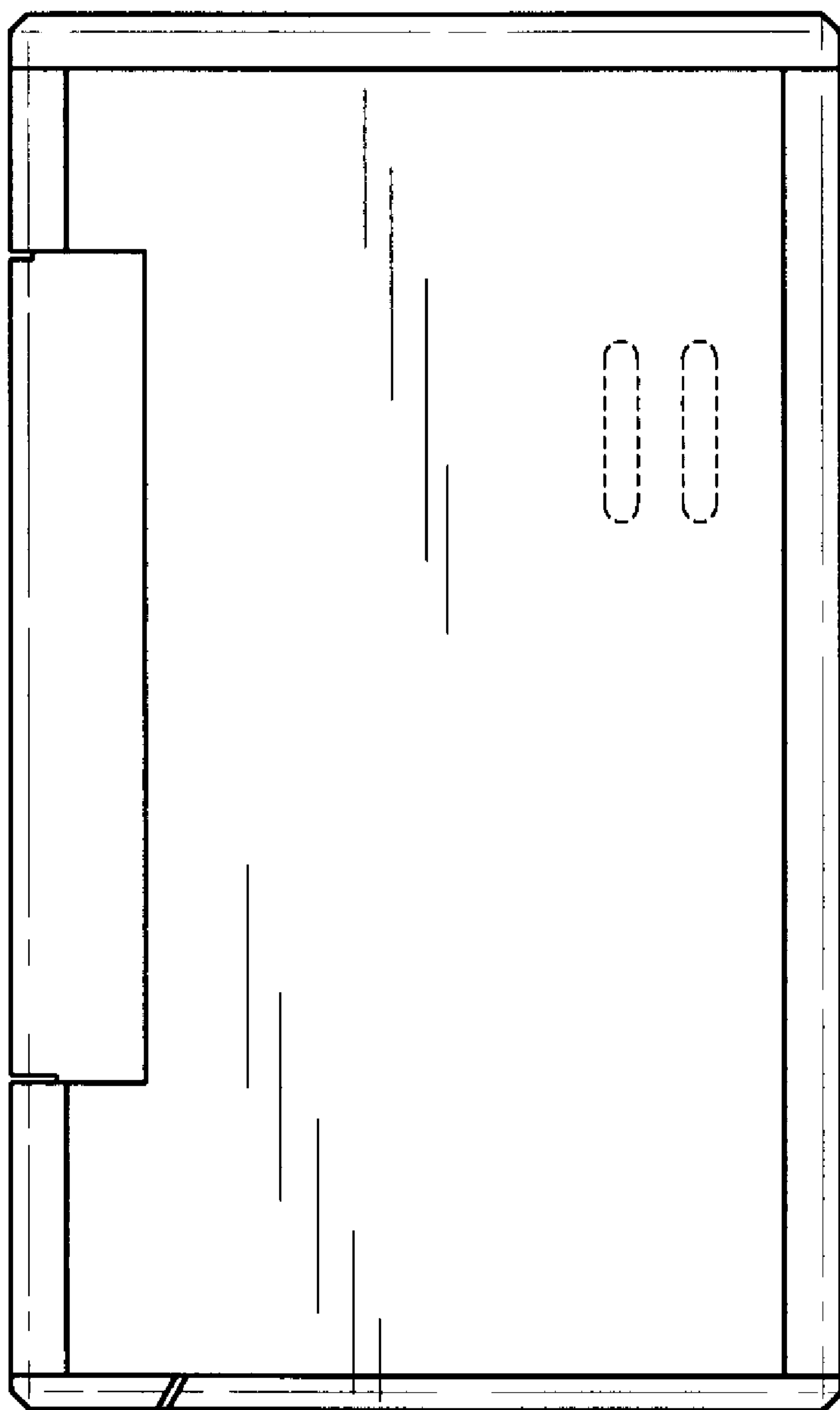

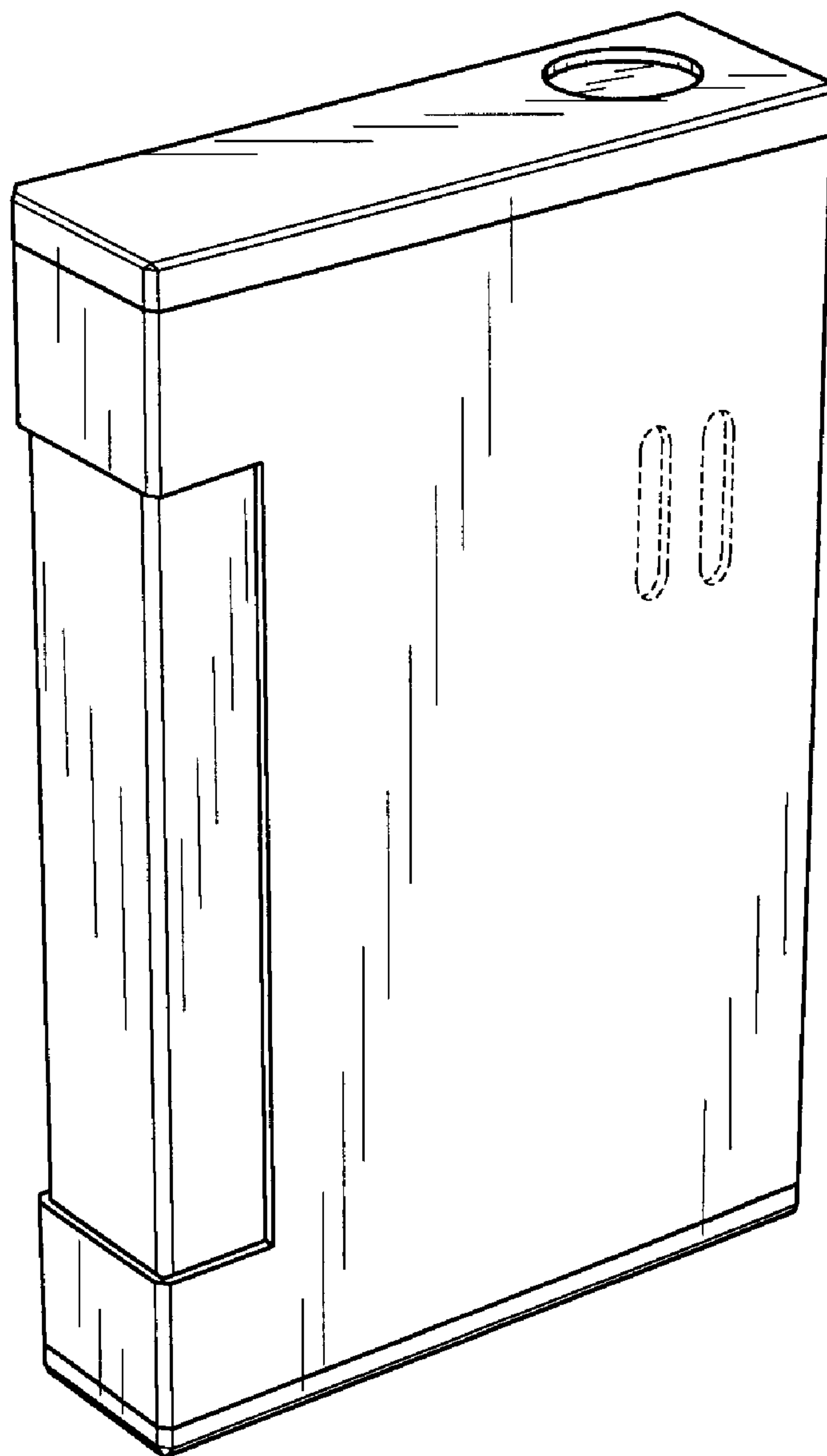

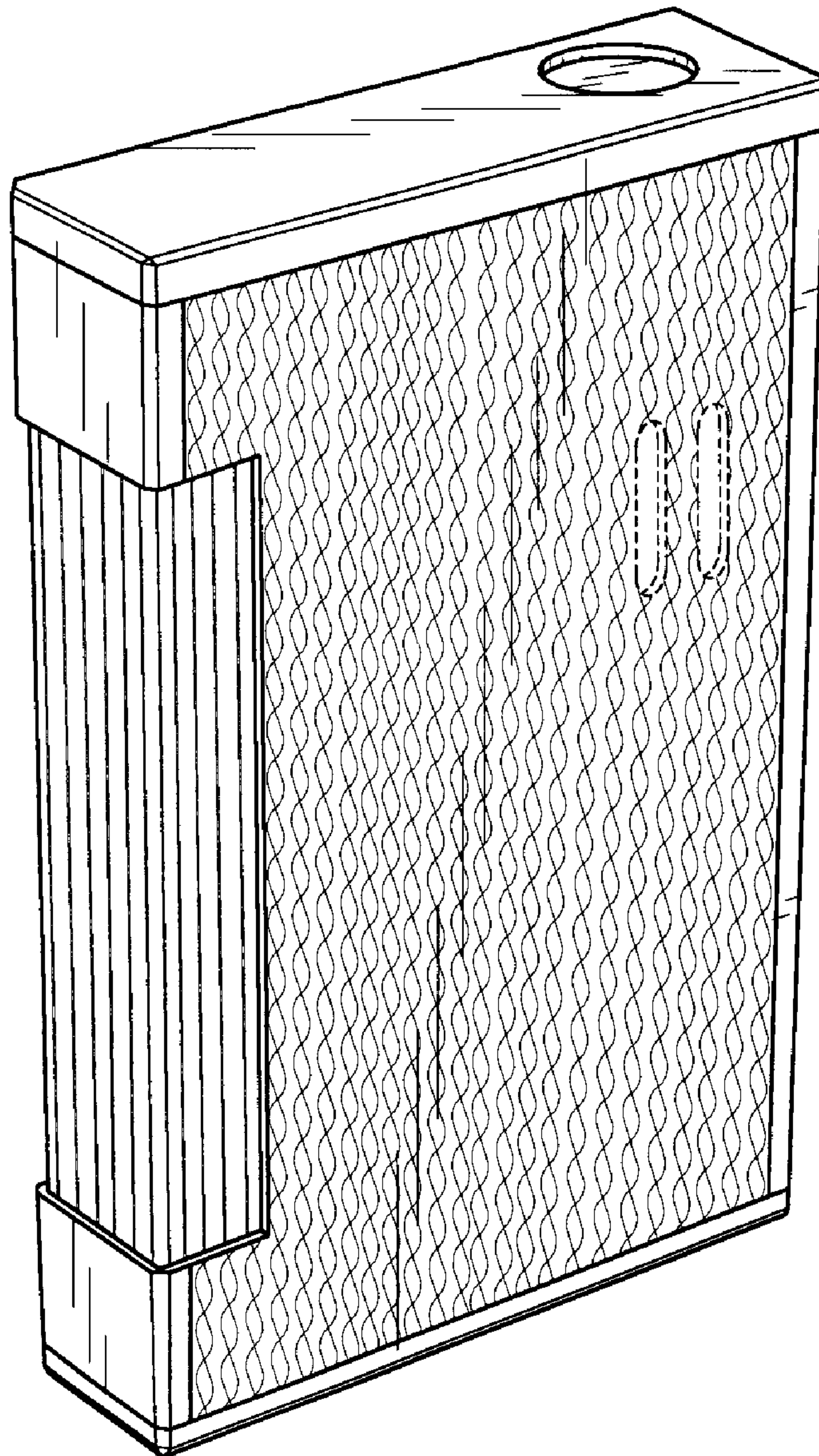

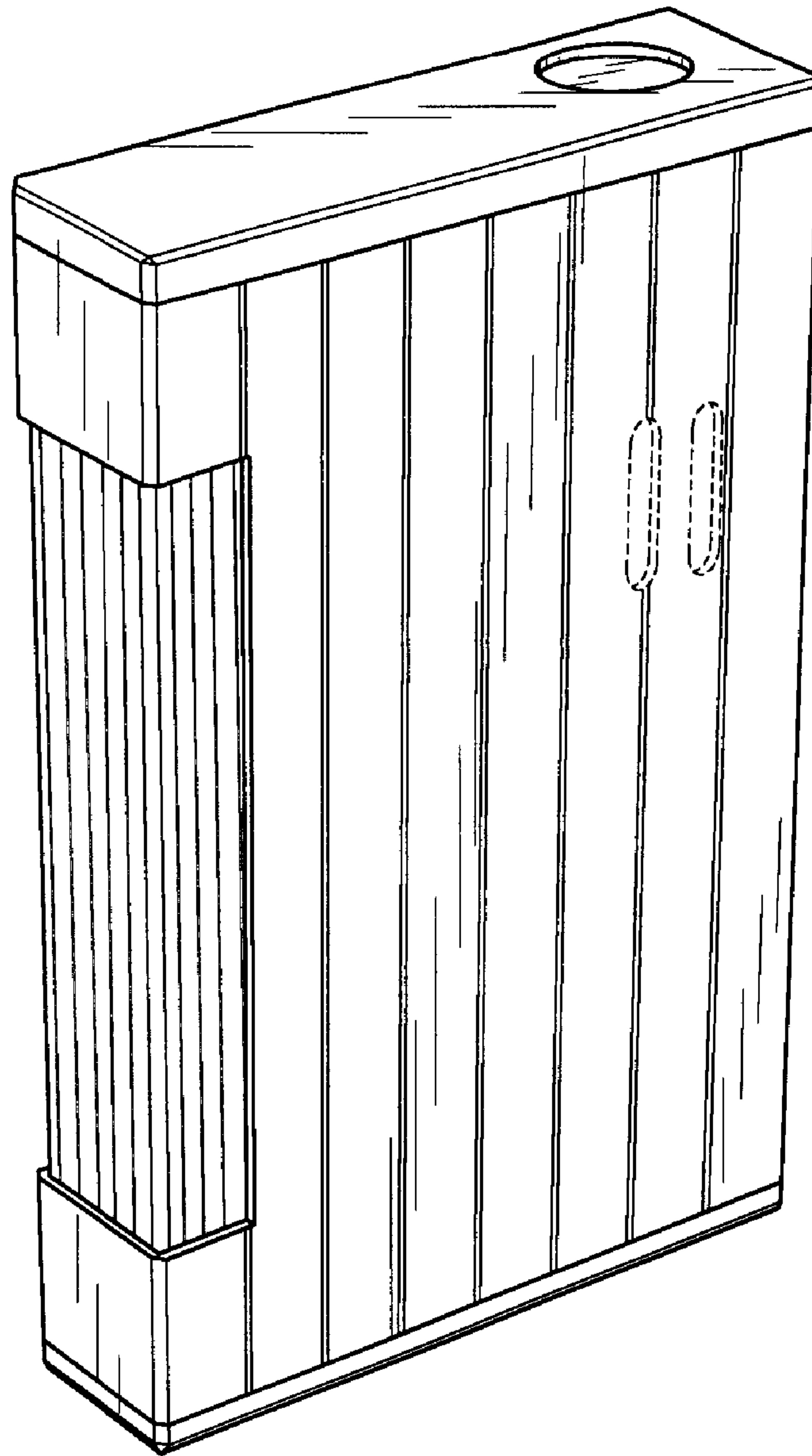

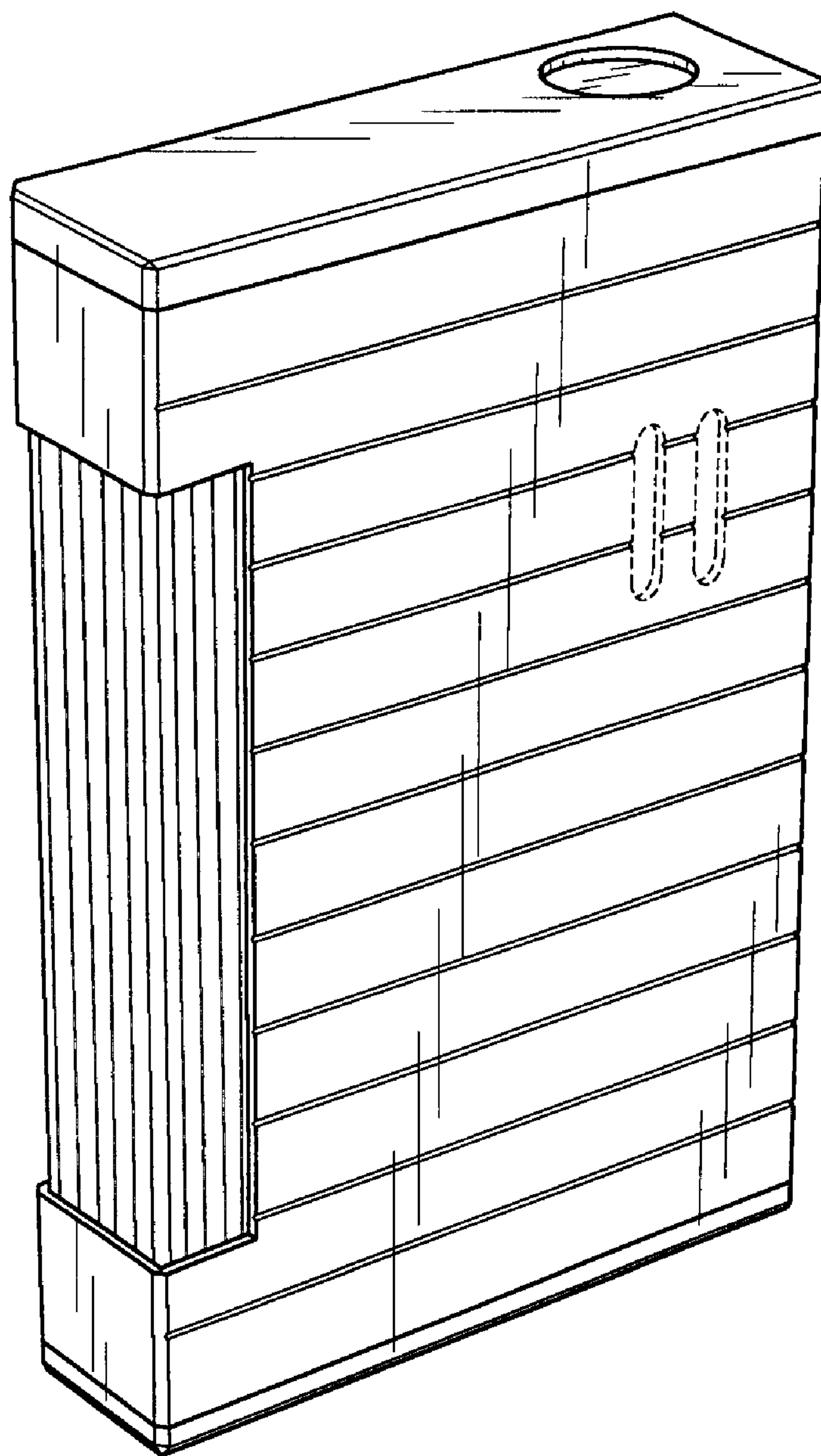

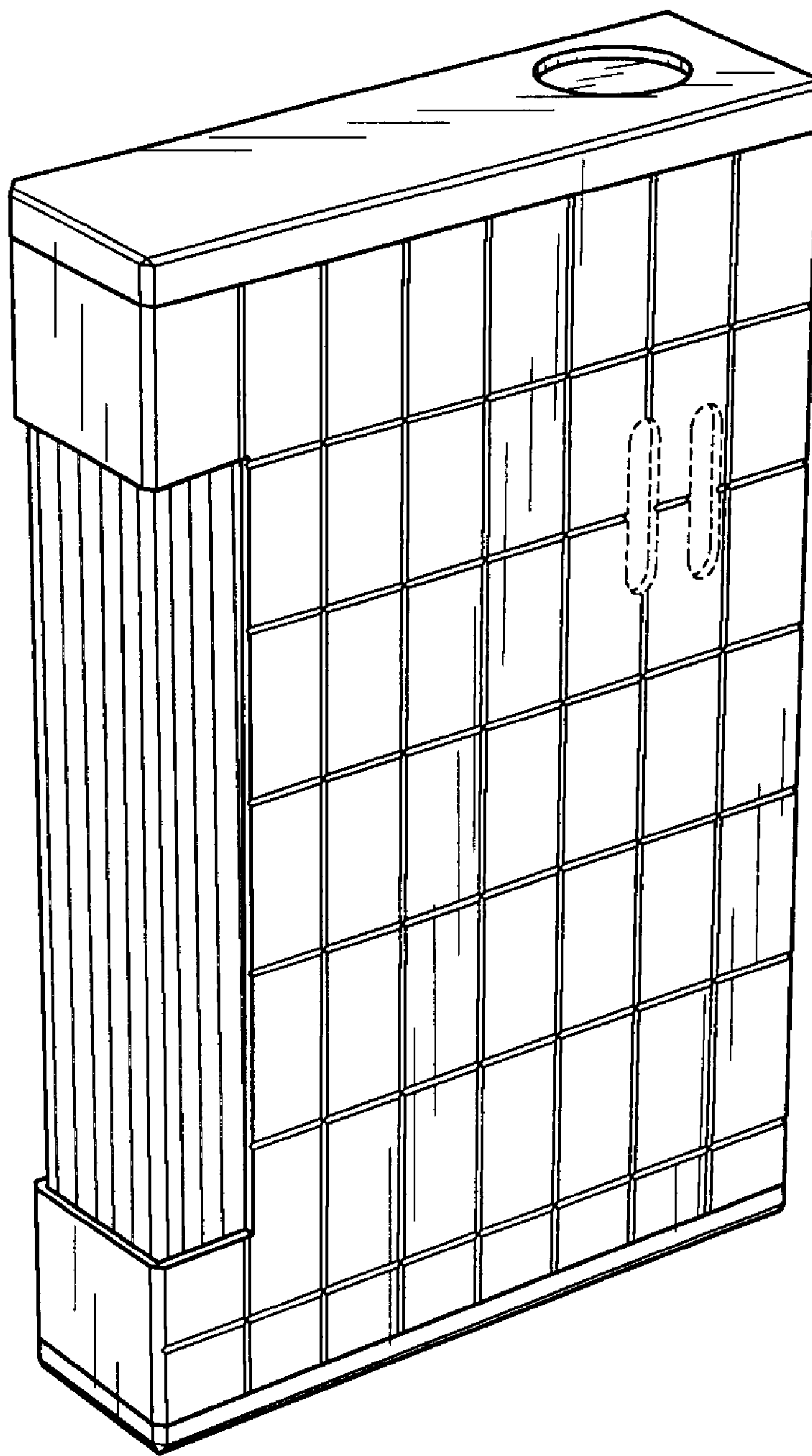

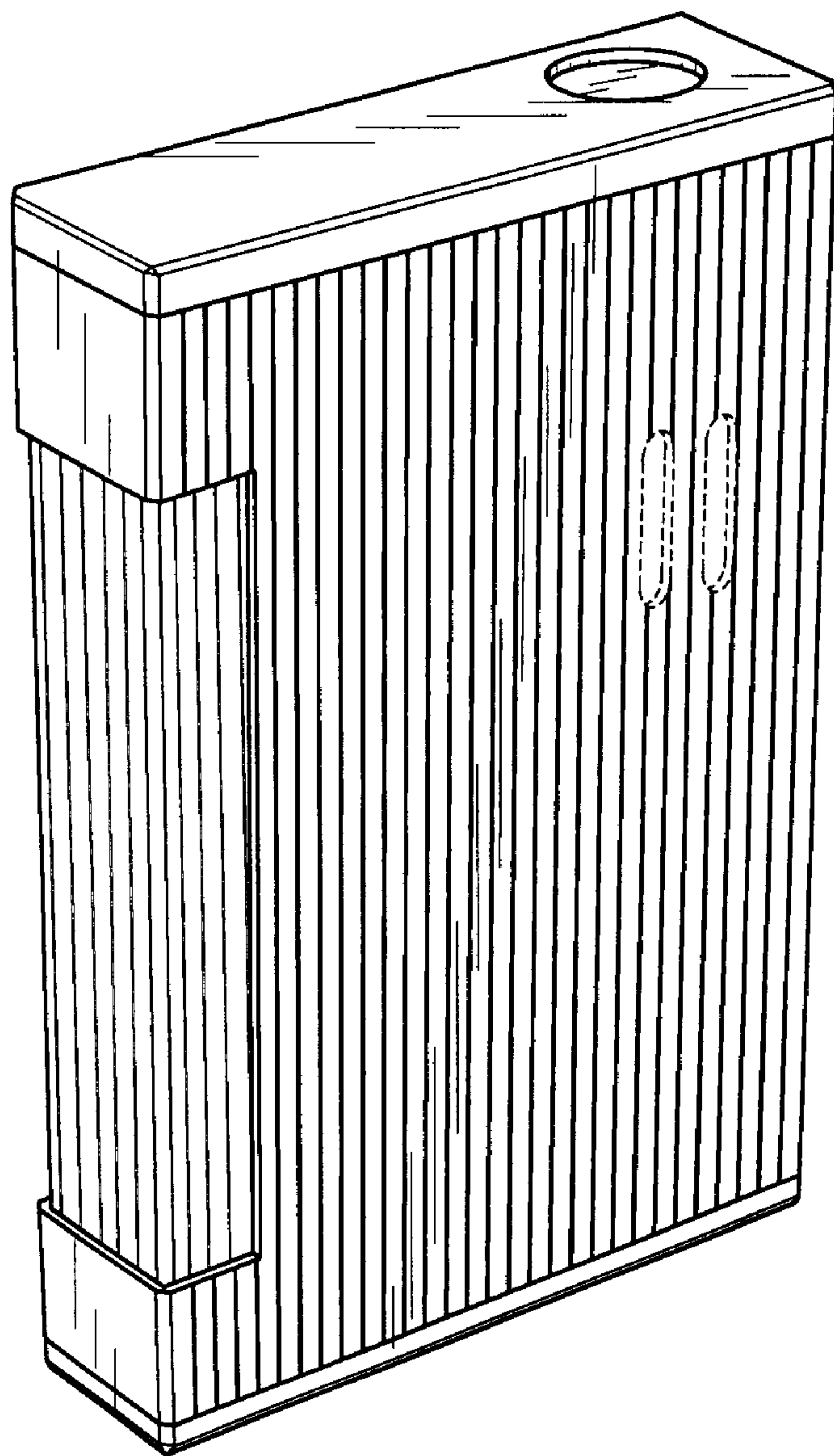

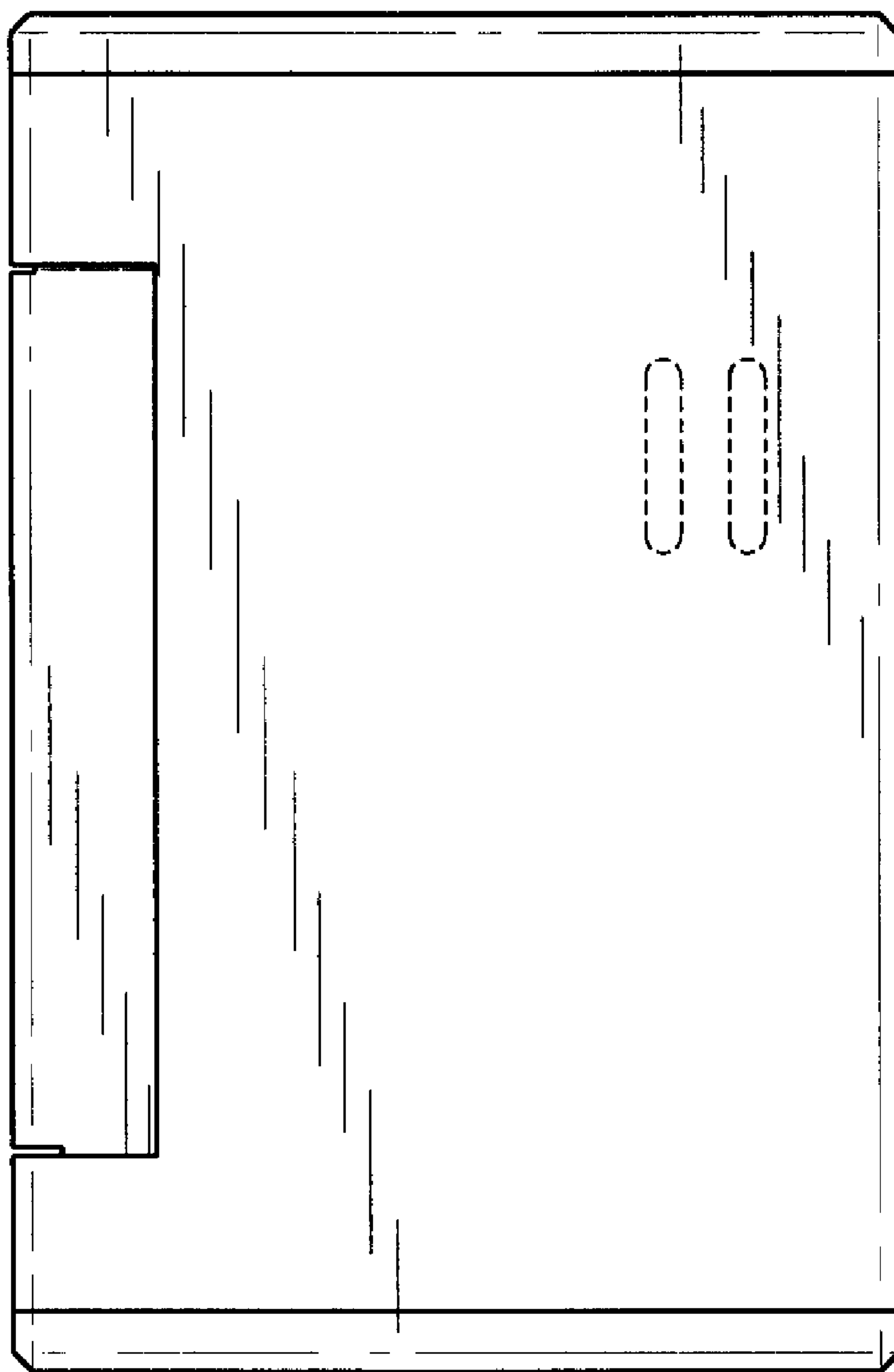
