I claim the ornamental design for a hairband, as shown and
described.

DESCRIPTION

FIG. 1 is a front left perspective view of the new ornamental
hairband of the present invention;

FIG. 2 is a top plan view thereof, the bottom plan view is
identical thereto;

FIG. 3 is a right side elevational view thereof, the left side
elevational view is a mirror image thereof;

FIG. 4 is a rear elevational view thereof;

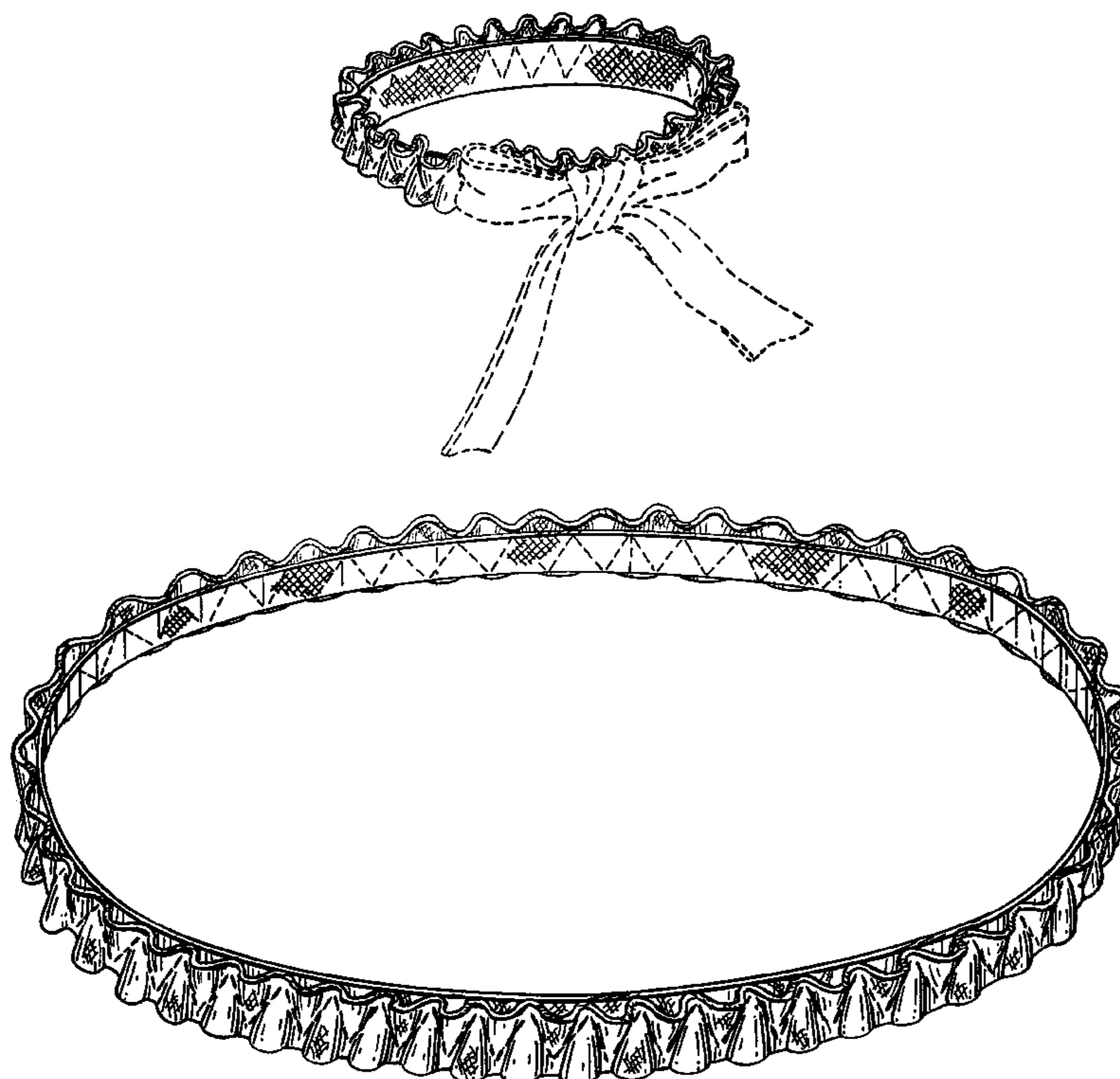
FIG. 5 is a top front perspective view of an alternative
embodiment of the present invention;

FIG. 6 is a front elevational view thereof, the left side, right
side, and rear elevational view are identical thereto; and,

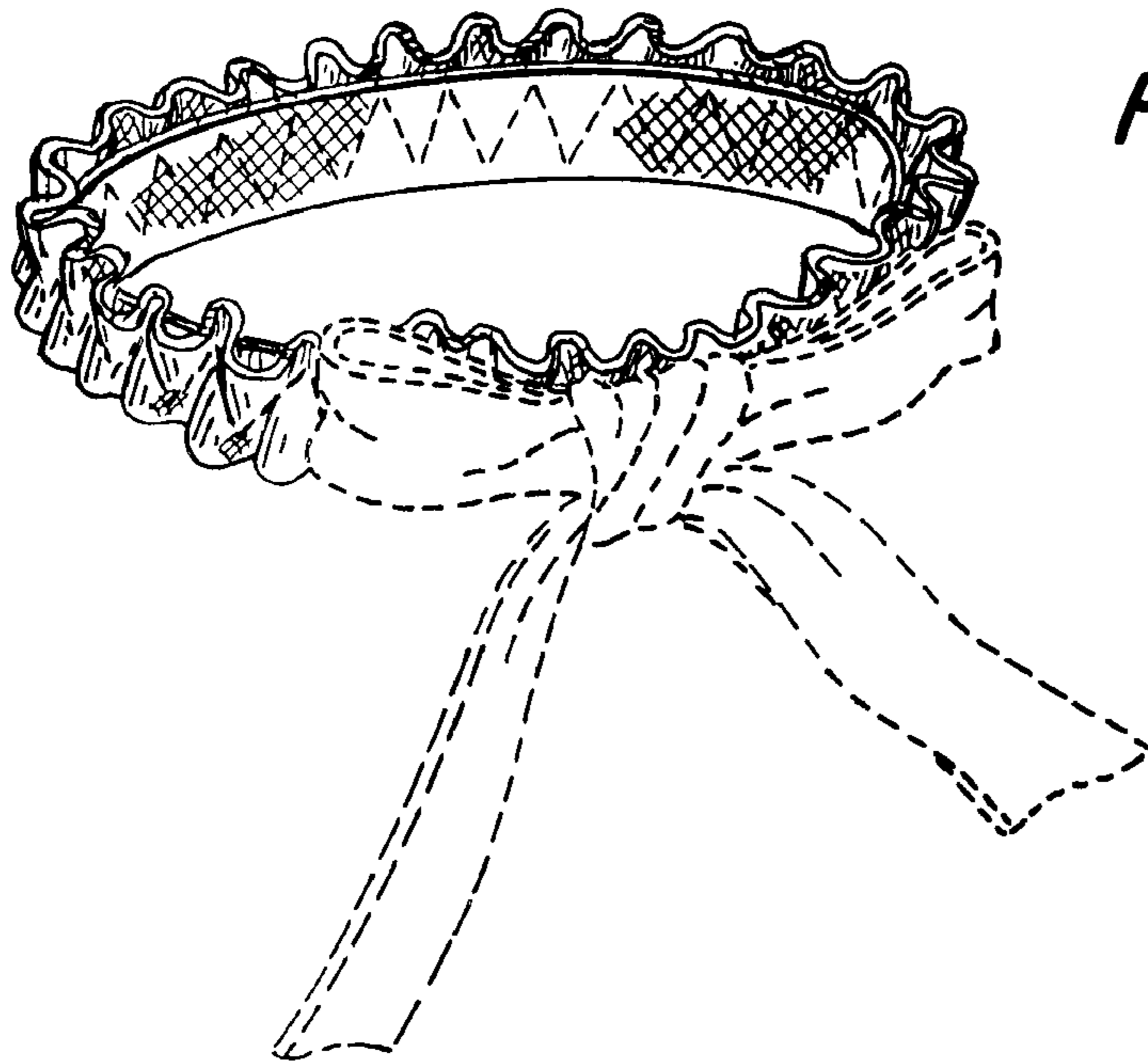

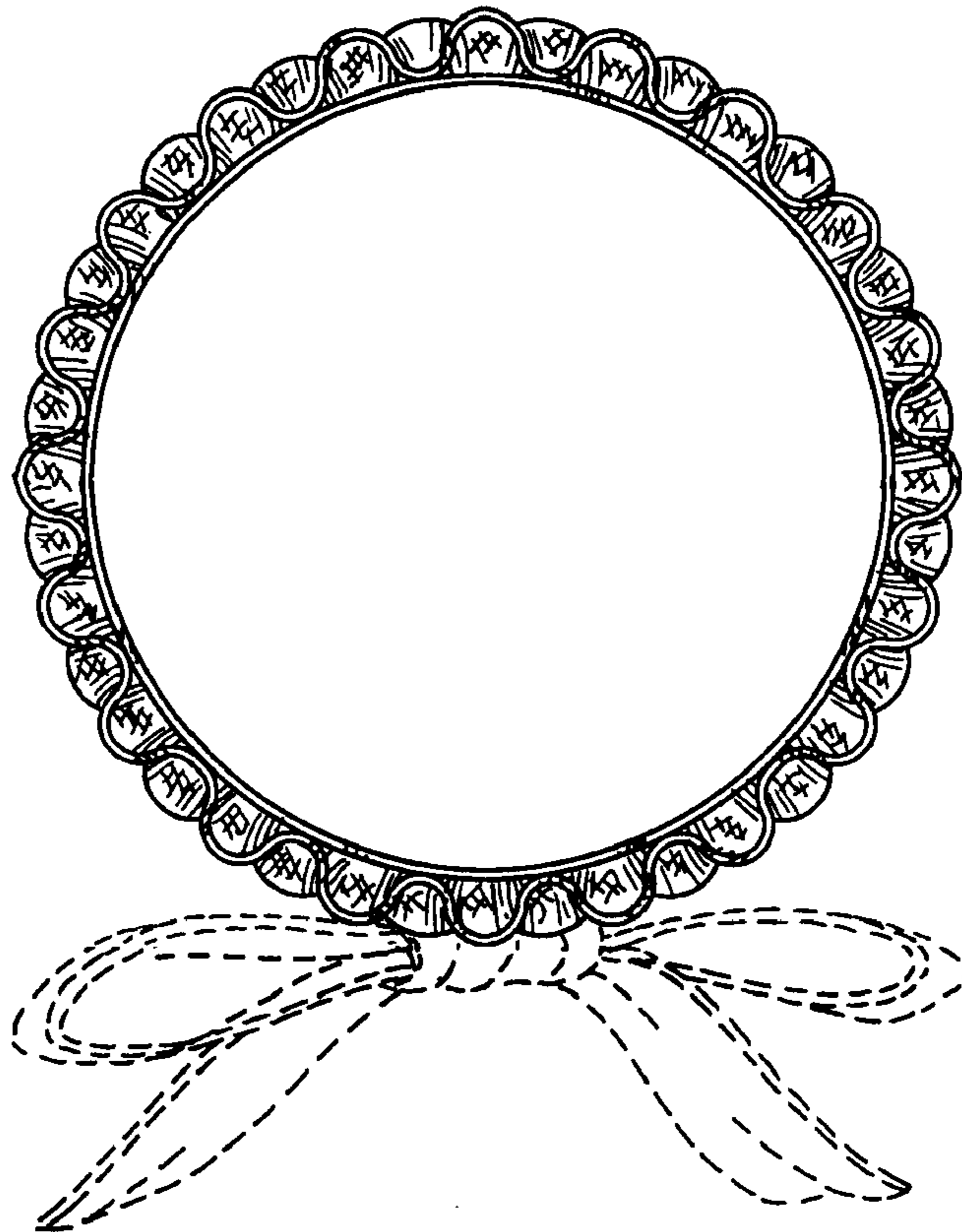

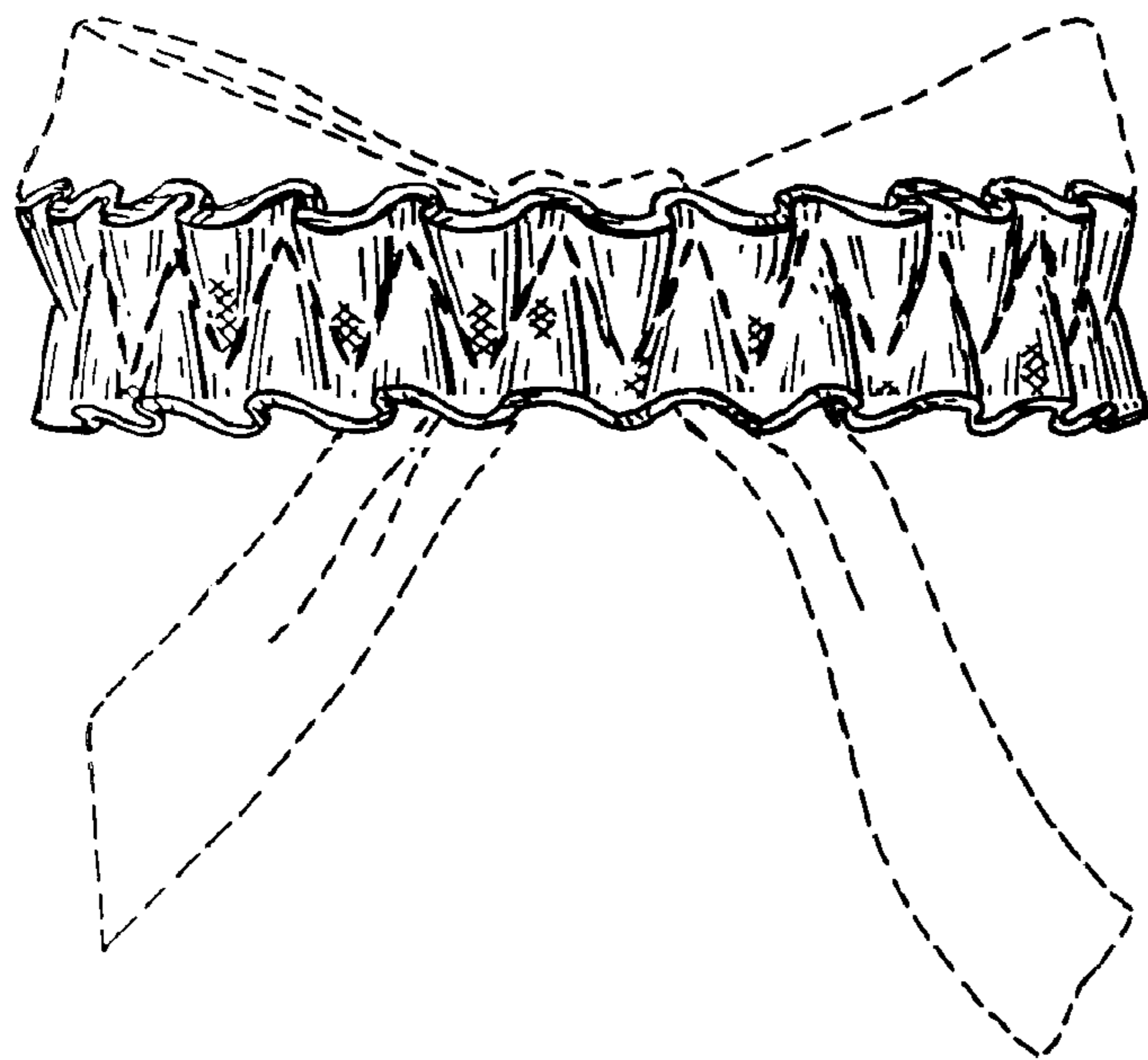
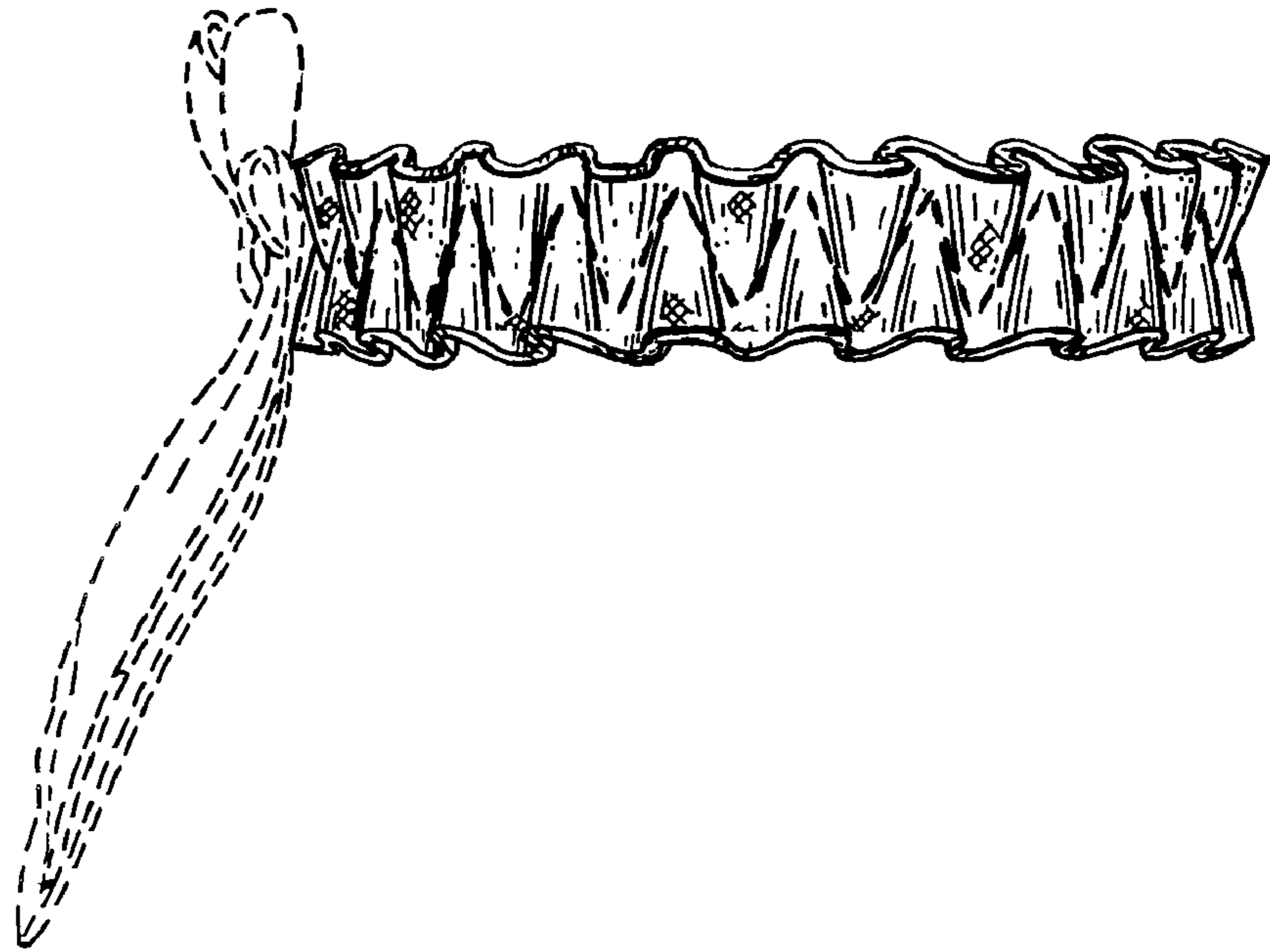

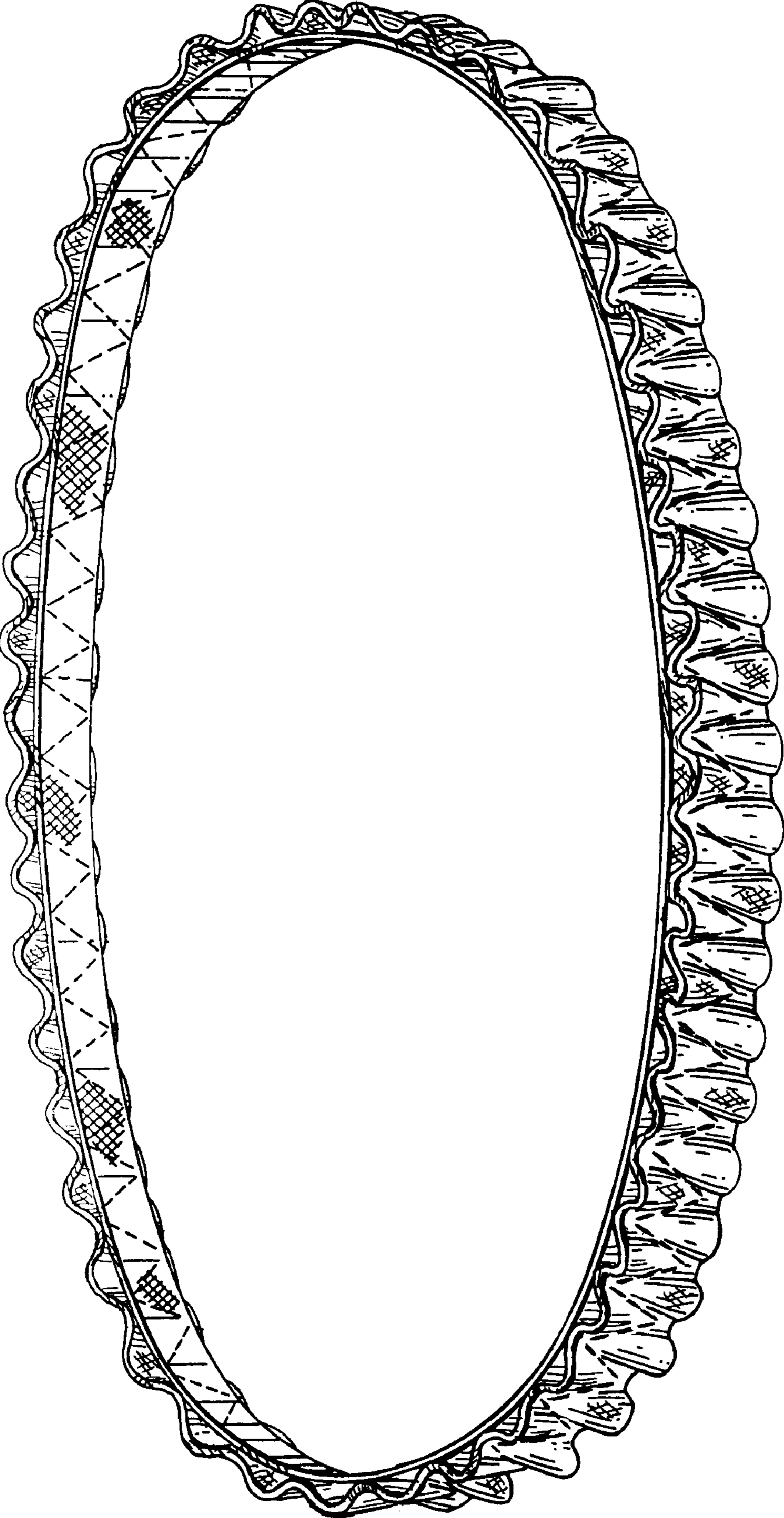
