(57) **CLAIM**

I claim the ornamental design for a revolving anchored pet toy, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view showing the front, top, and left sides of a revolving anchored pet toy;

FIG. 2 is a front plan view of the revolving anchored pet toy depicted in FIG. 1;

FIG. 3 is a rear plan view of the revolving anchored pet toy depicted in FIG. 1;

FIG. 4 is a left-side view of the revolving anchored pet toy depicted in FIG. 1;

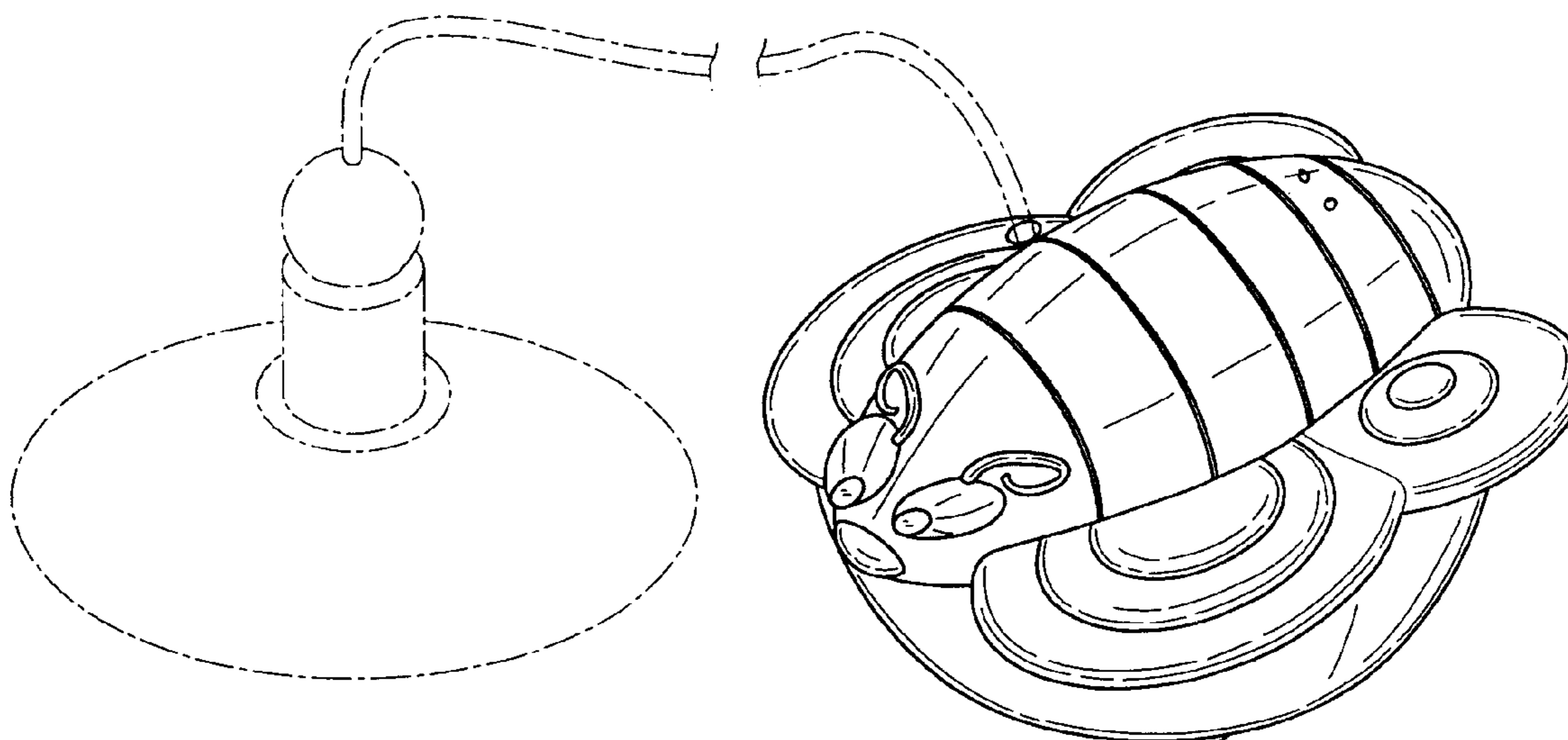
FIG. 5 is a right-side view of the revolving anchored pet toy depicted in FIG. 1;

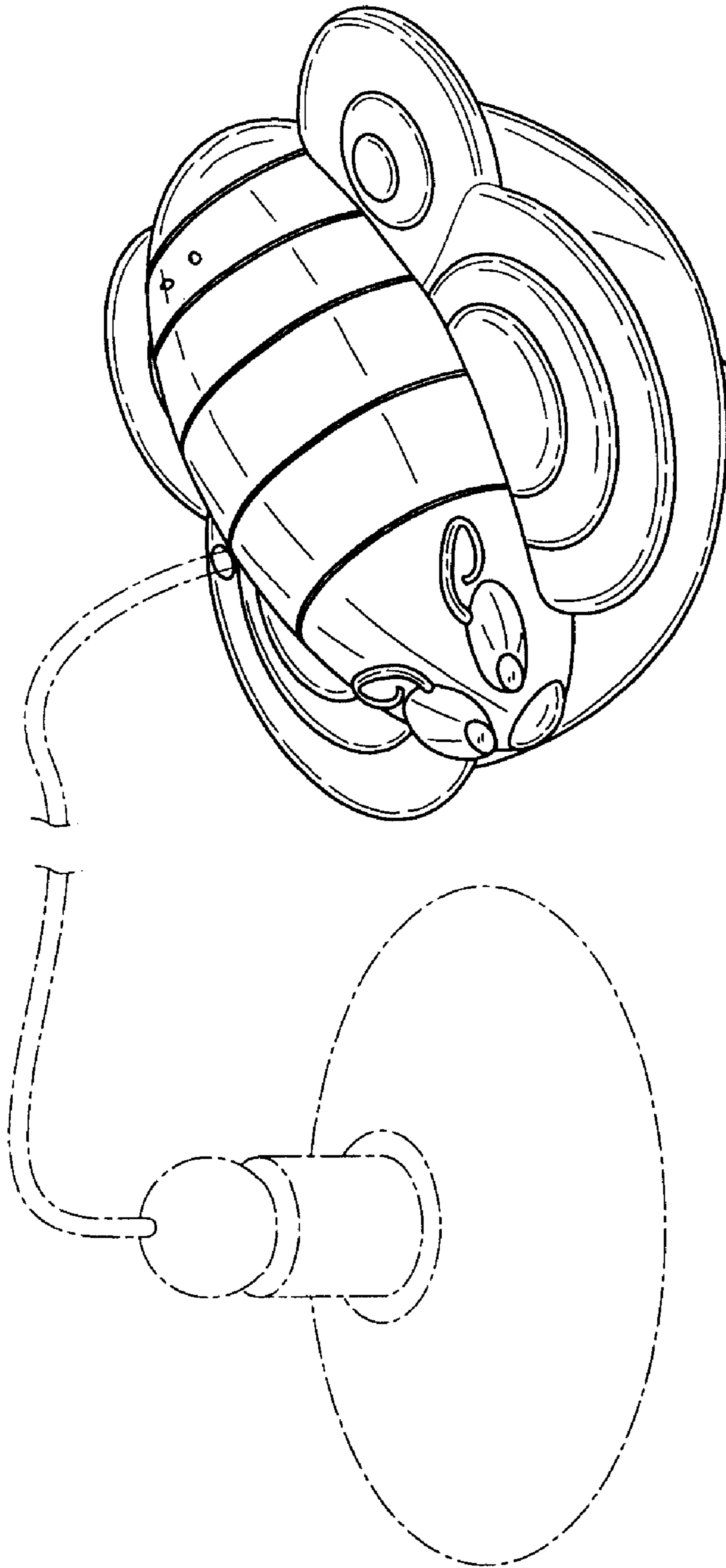

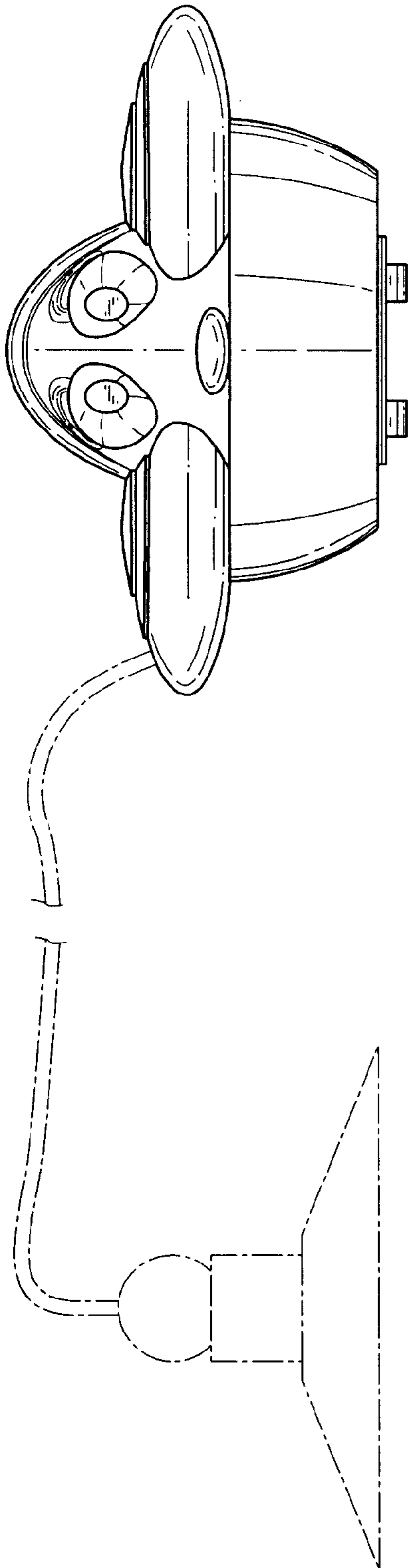

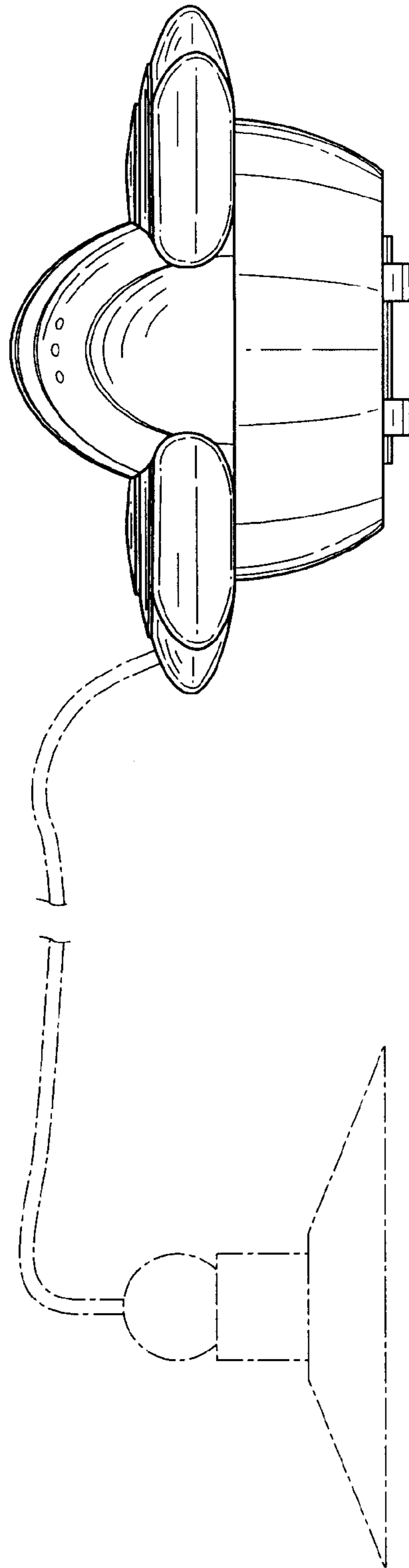

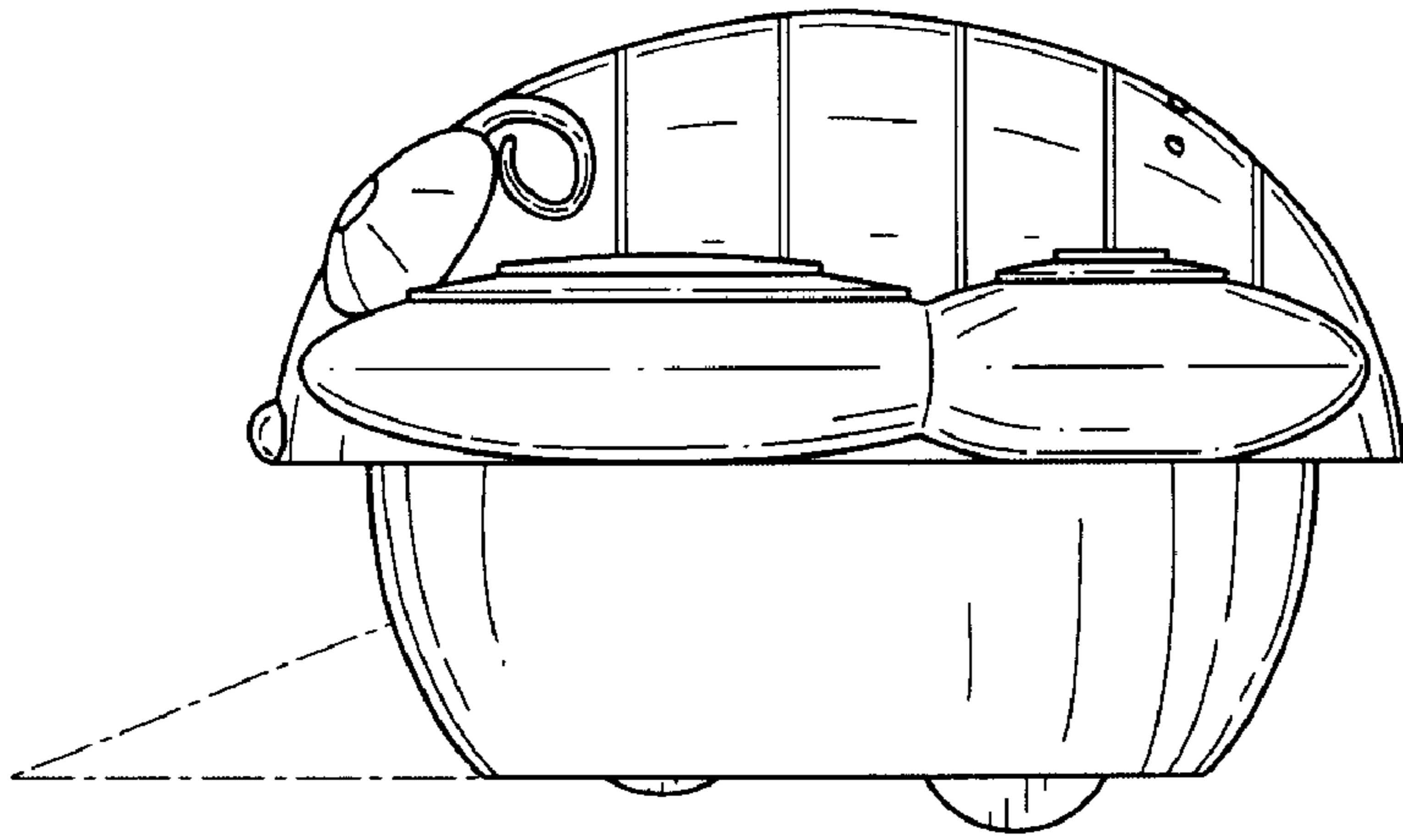

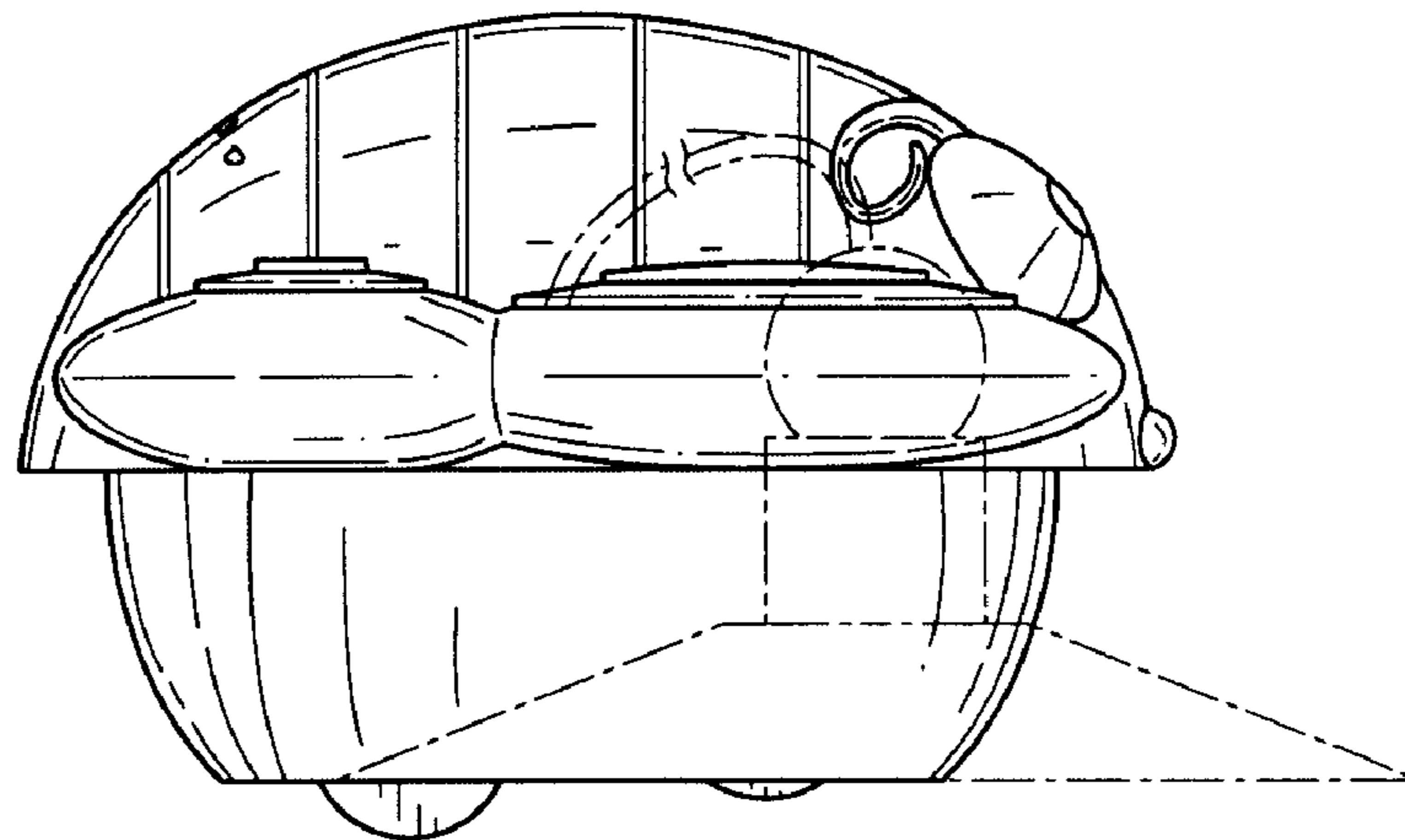

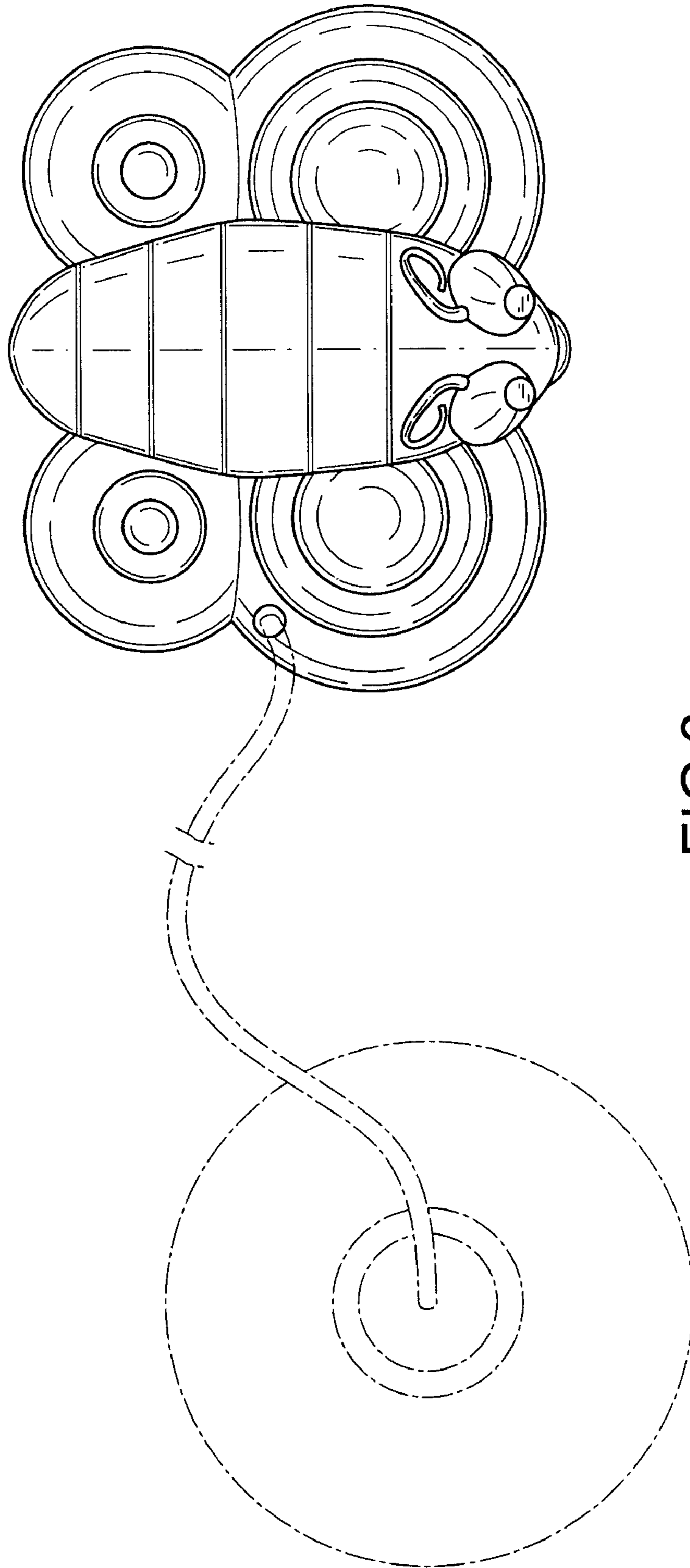

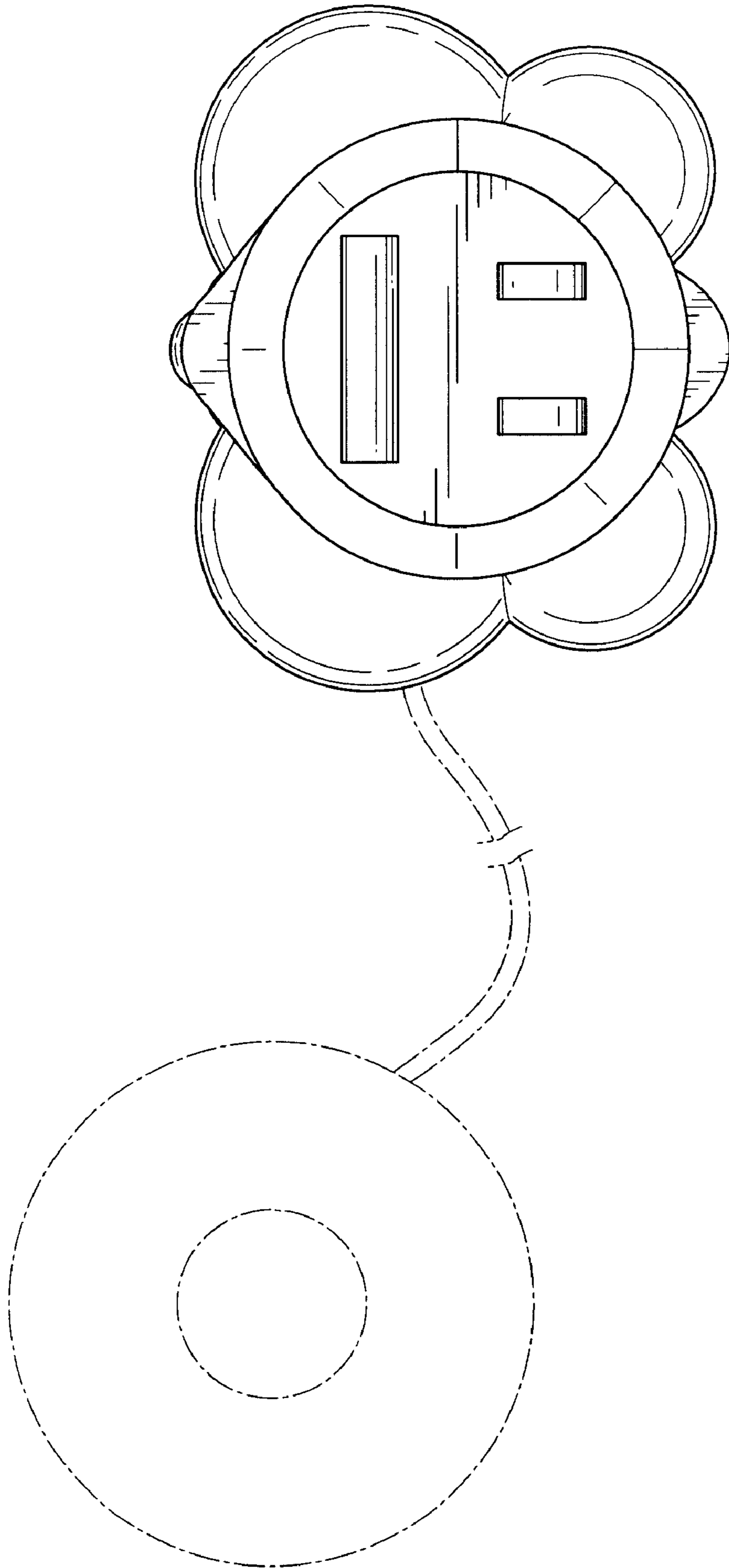
