DESCRIPTION

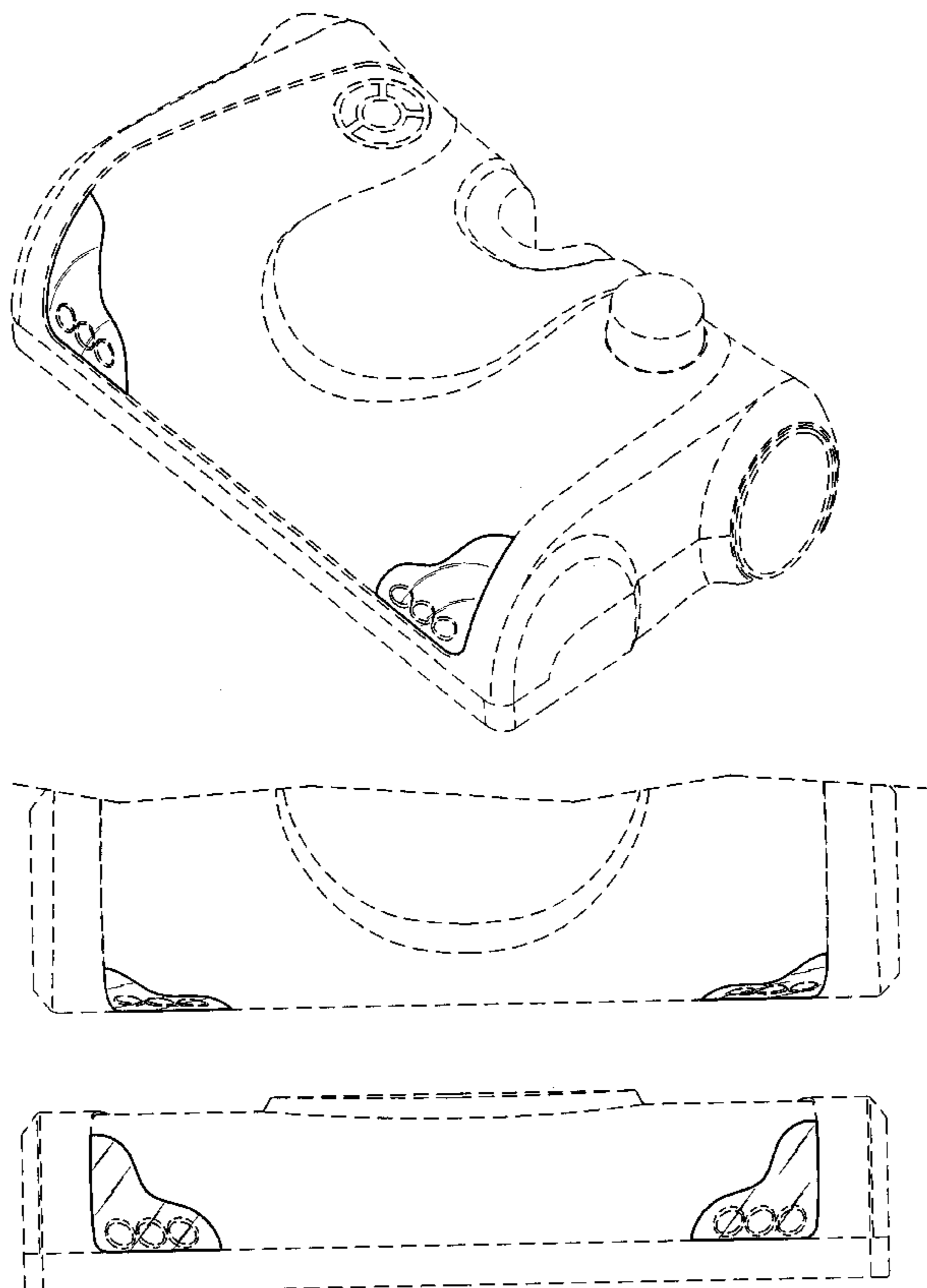
FIG. 1 is a perspective view of lighting for a suction nozzle showing our new design;

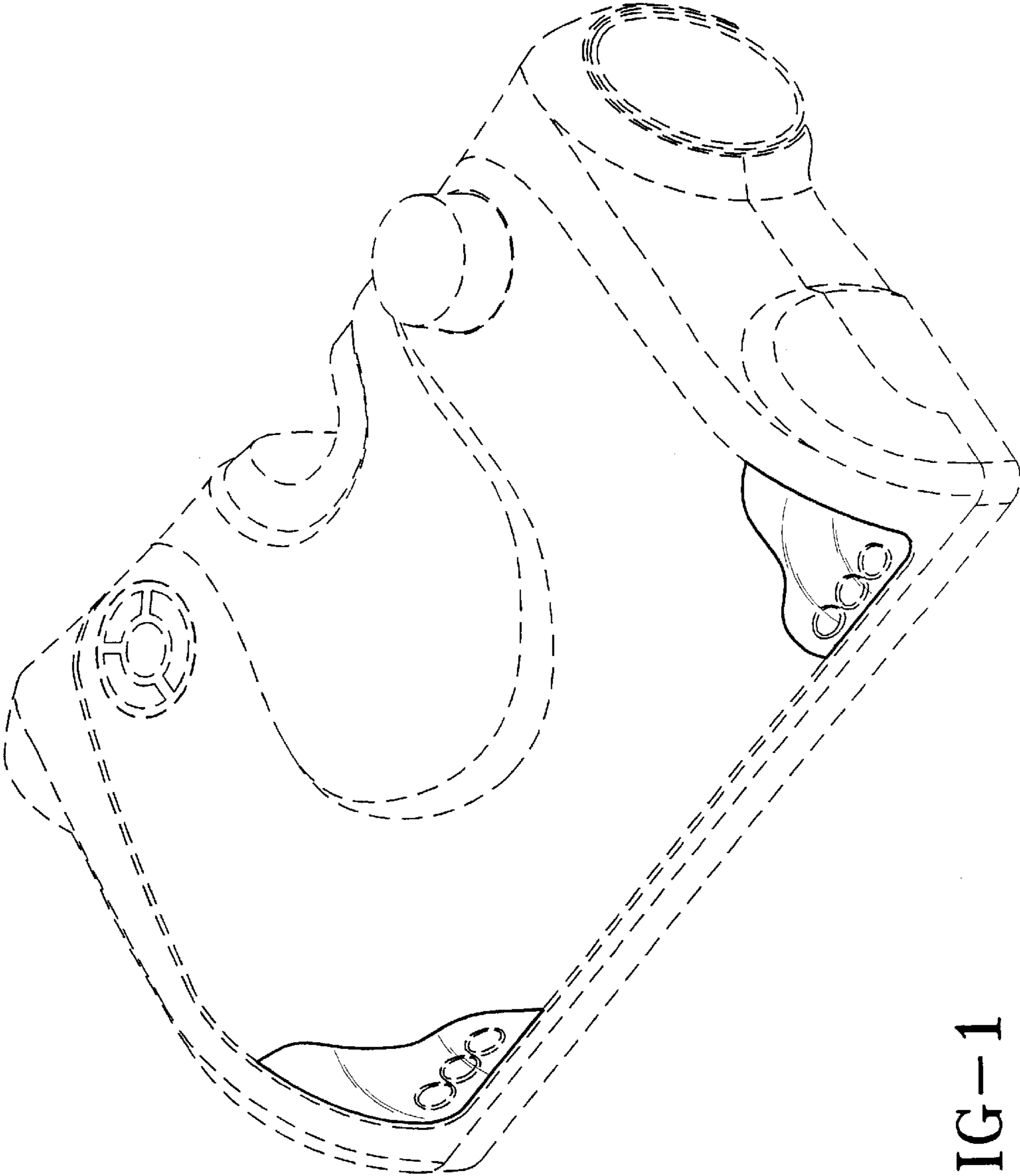

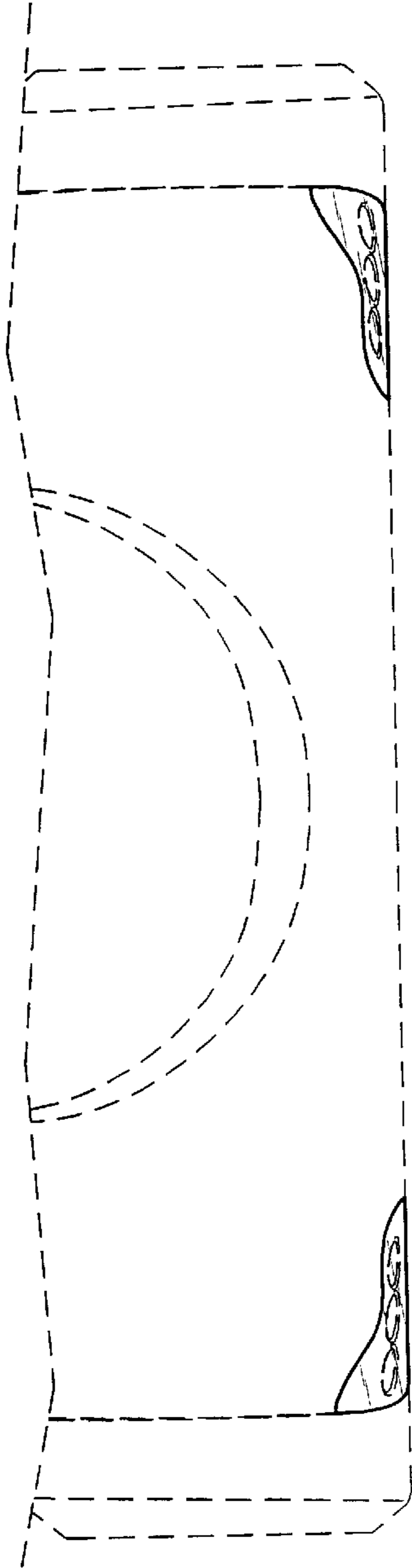

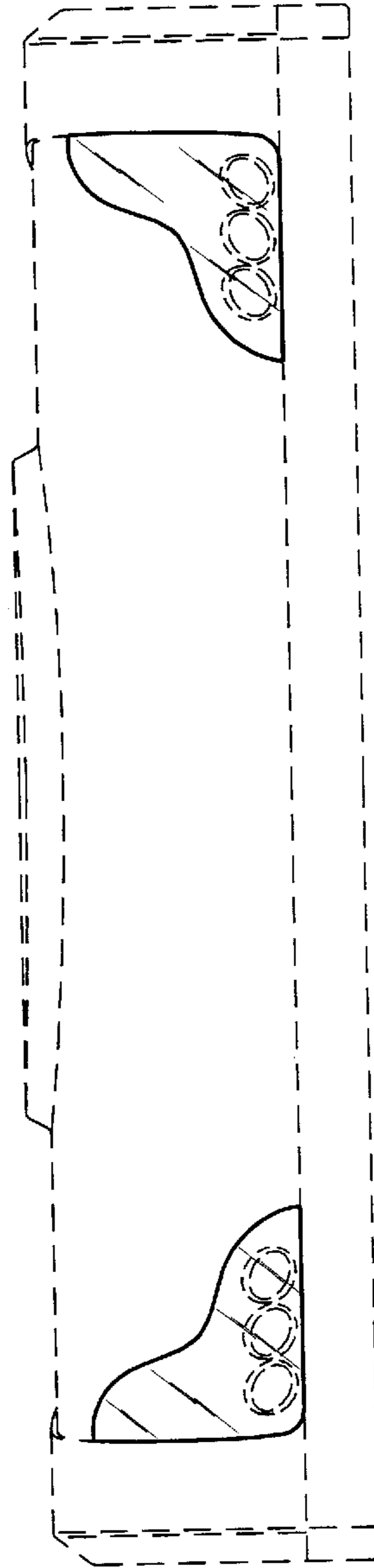
