(57) **CLAIM**

The ornamental design for a child supporting apparatus for attachment to a shopping cart, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a child supporting apparatus coupled with a large shopping cart according to our new design;

FIG. 6 is a perspective view of the child supporting apparatus coupled with a medium shopping cart, according to our new design;

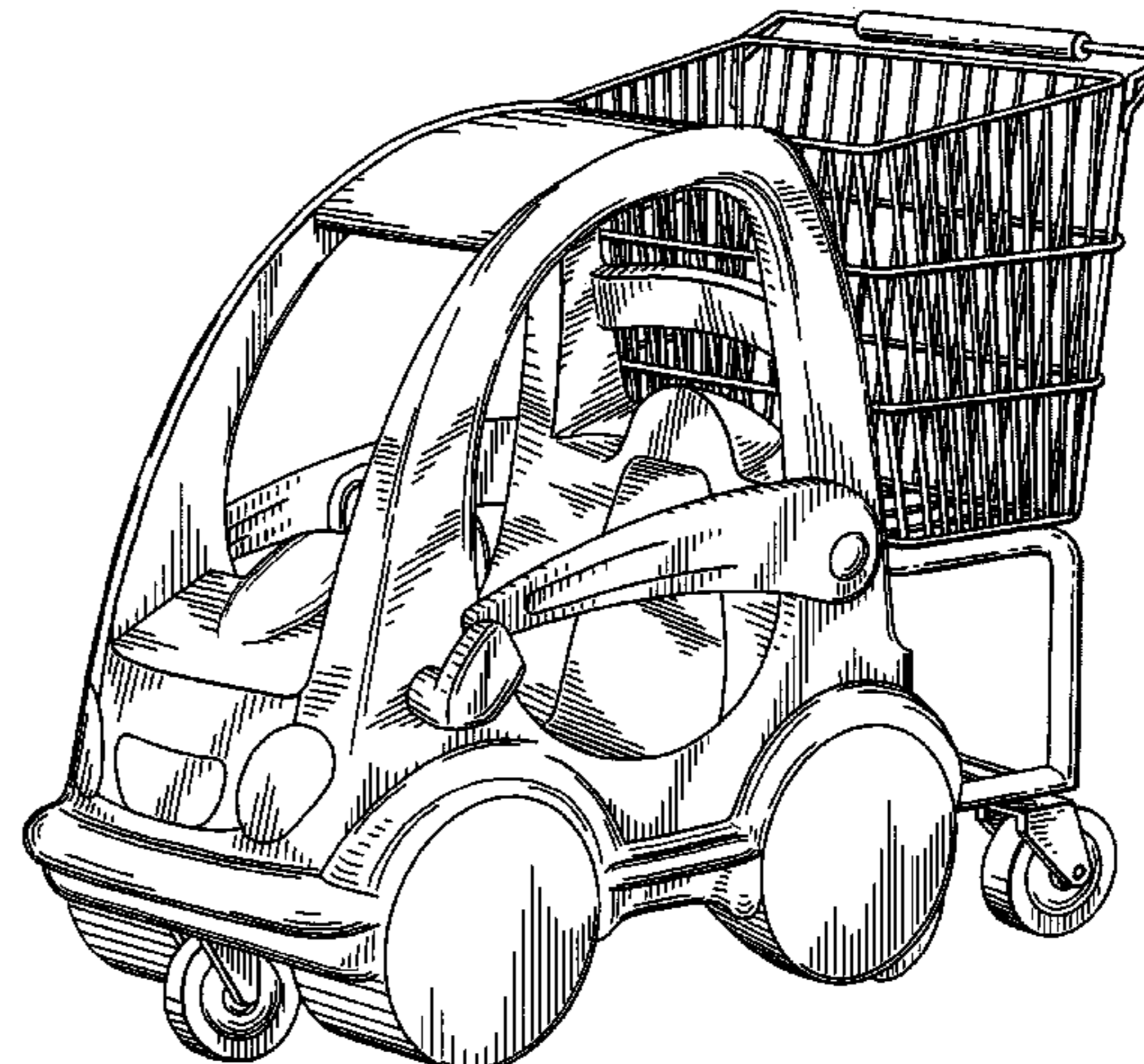
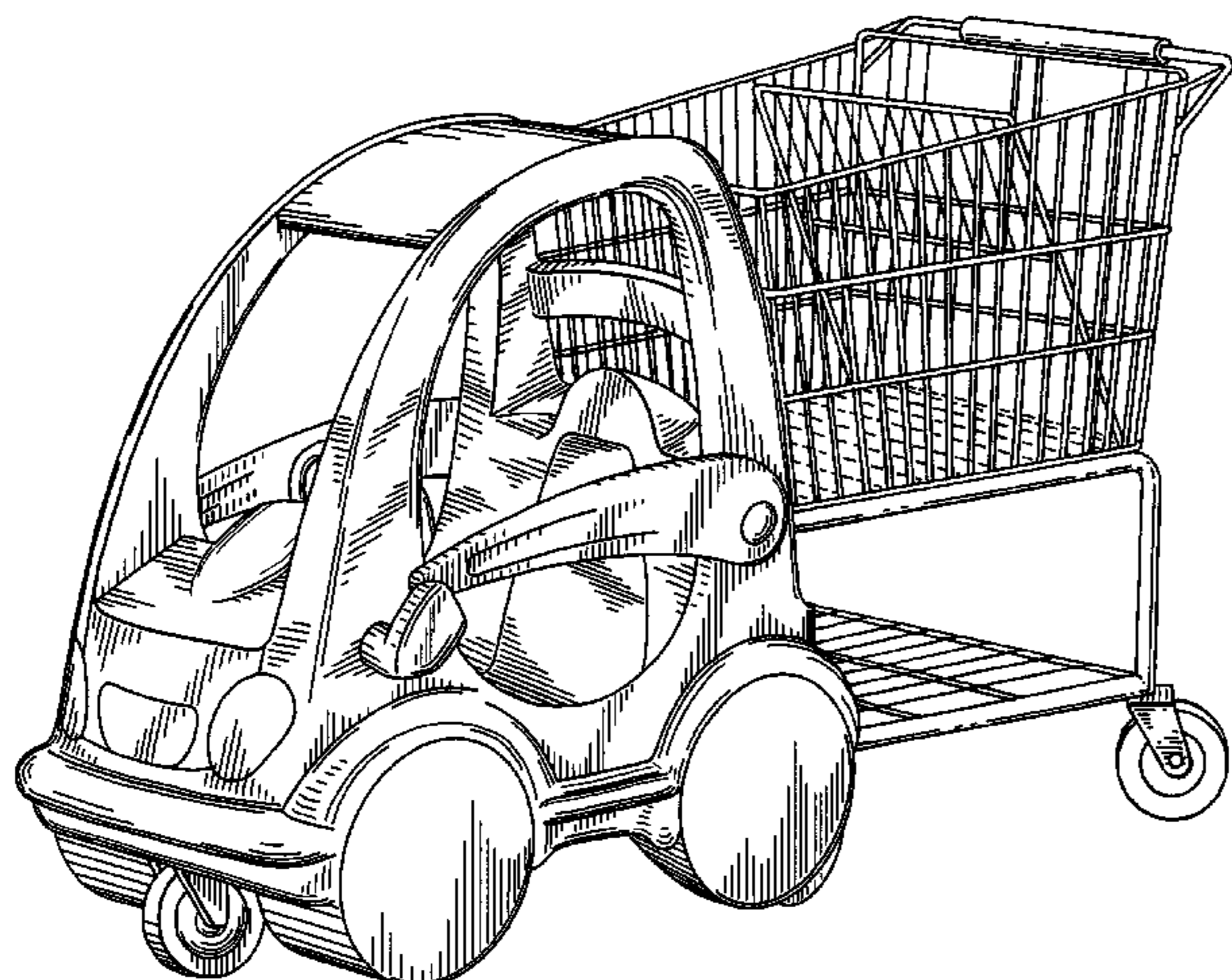
FIG. 7 is a side view thereof;

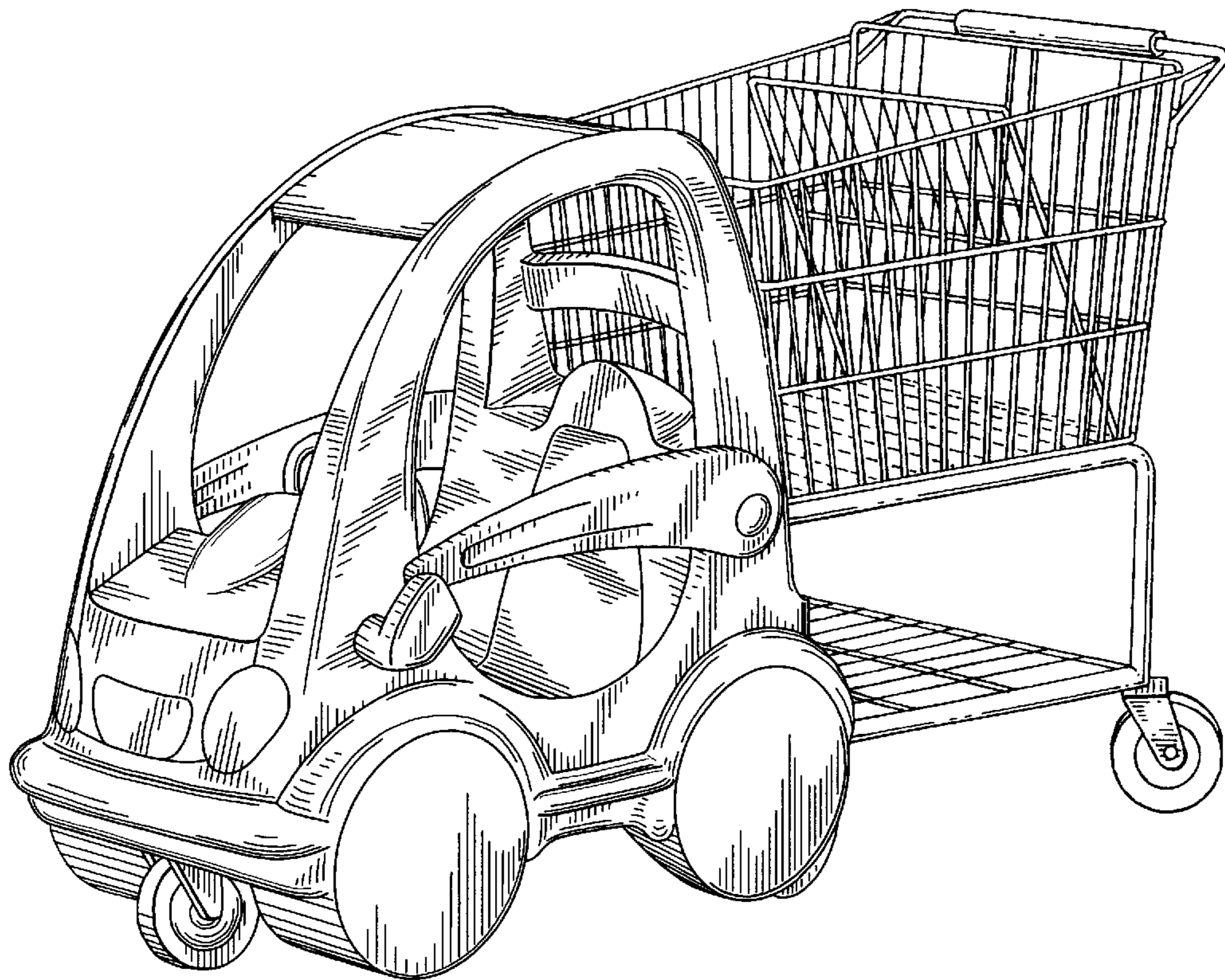

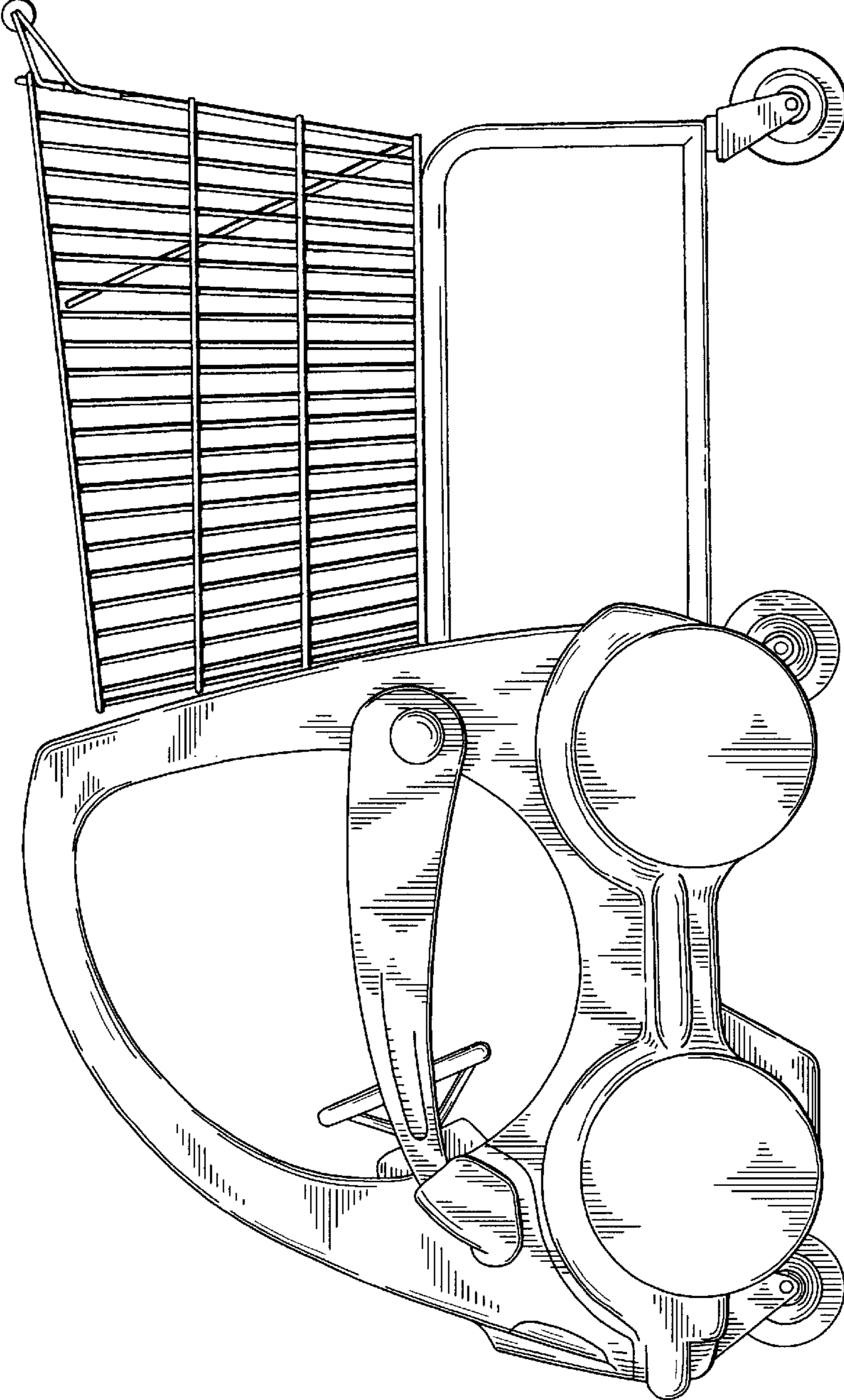

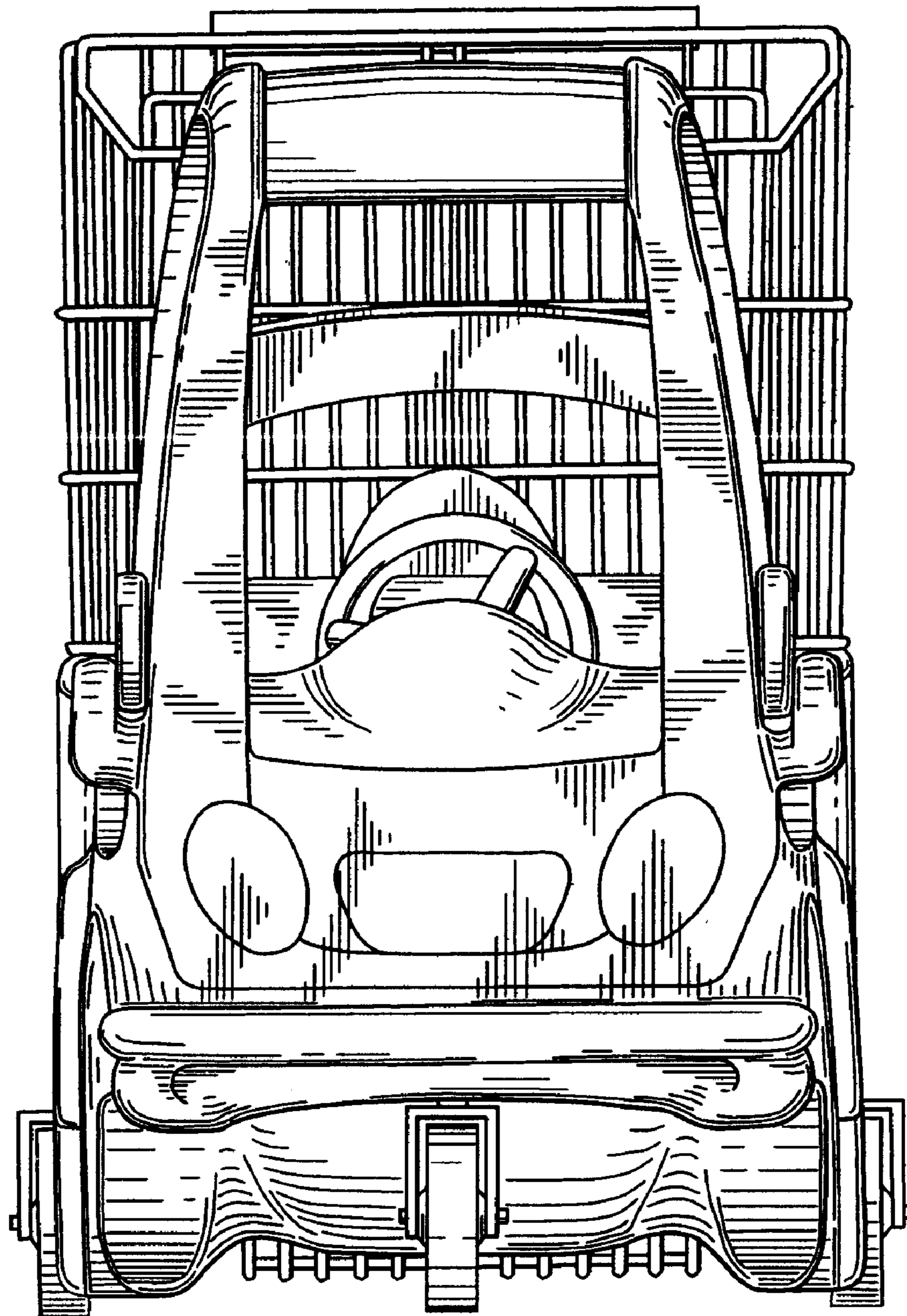

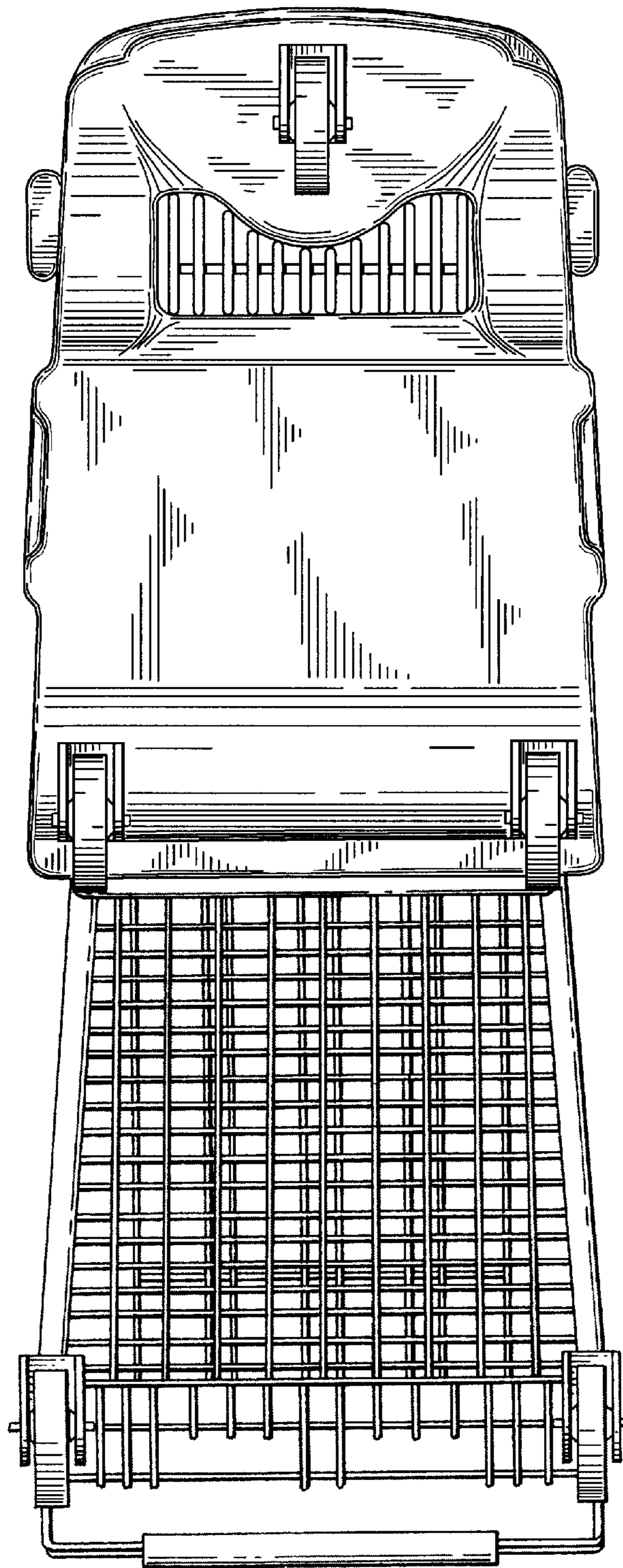

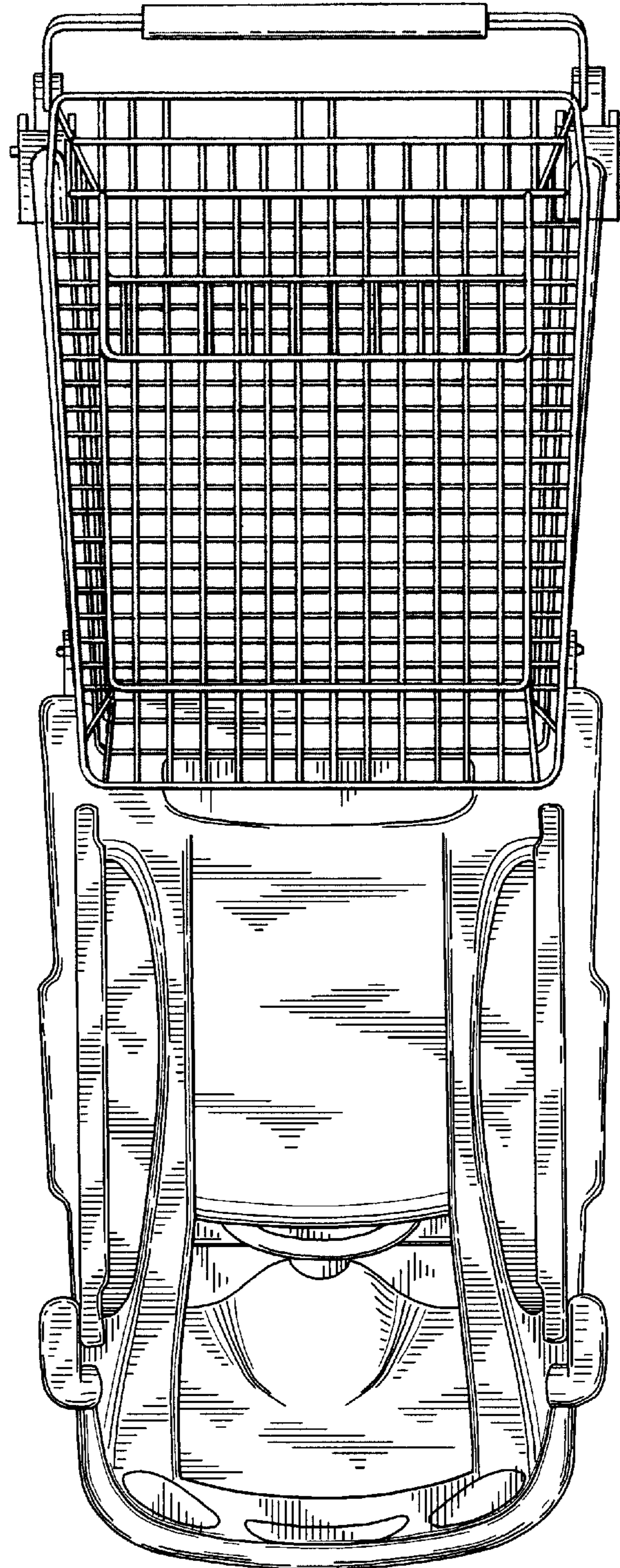

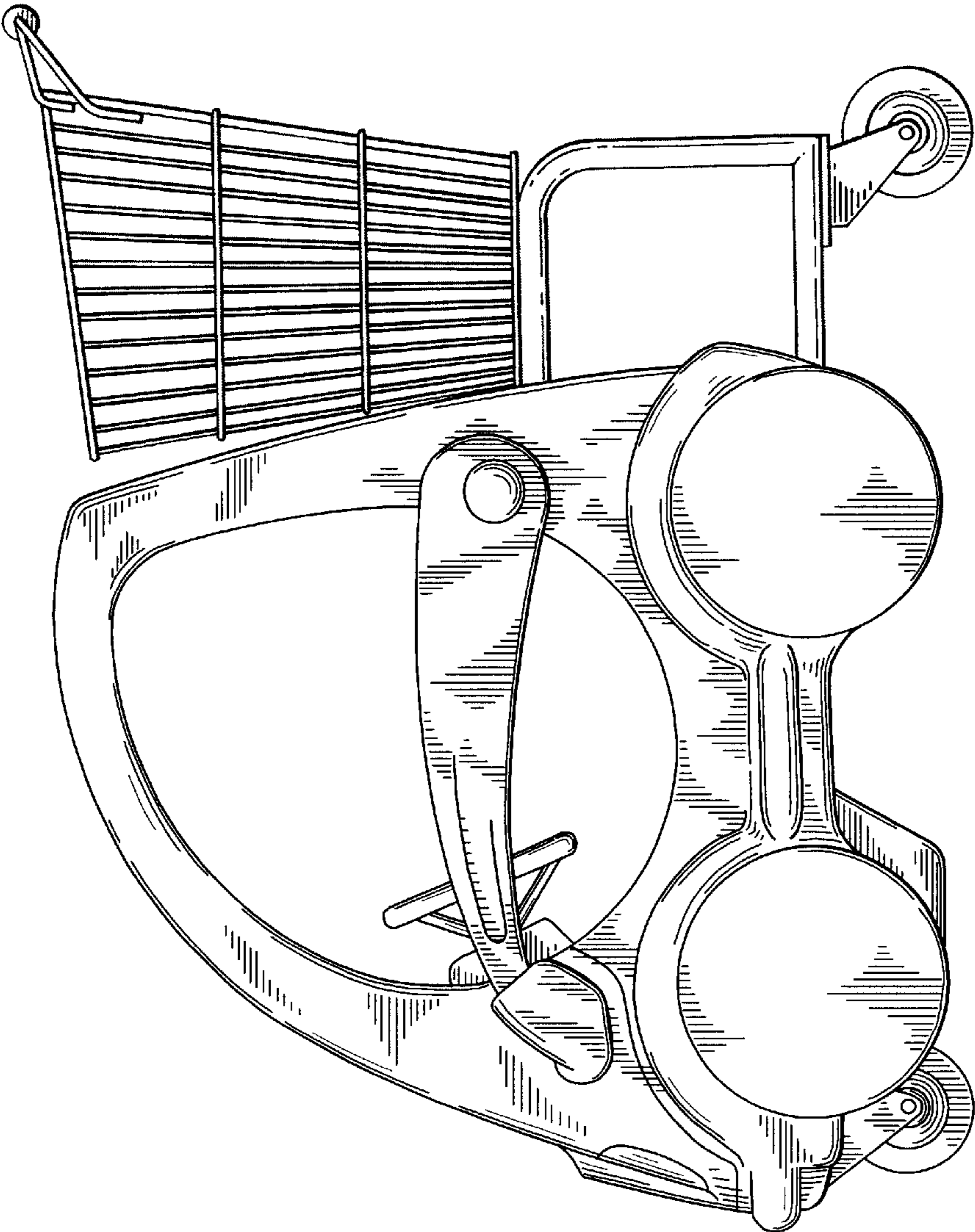

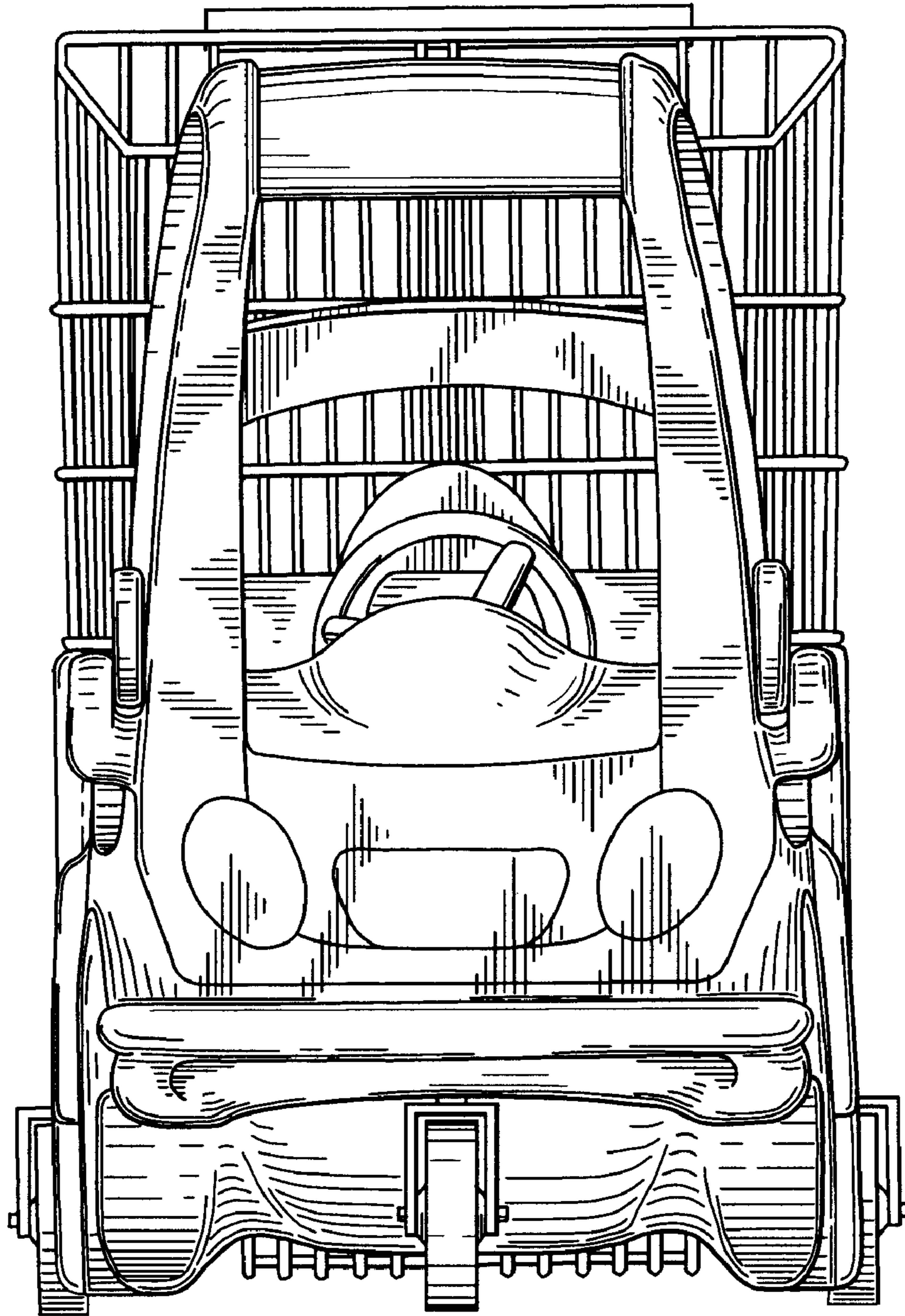

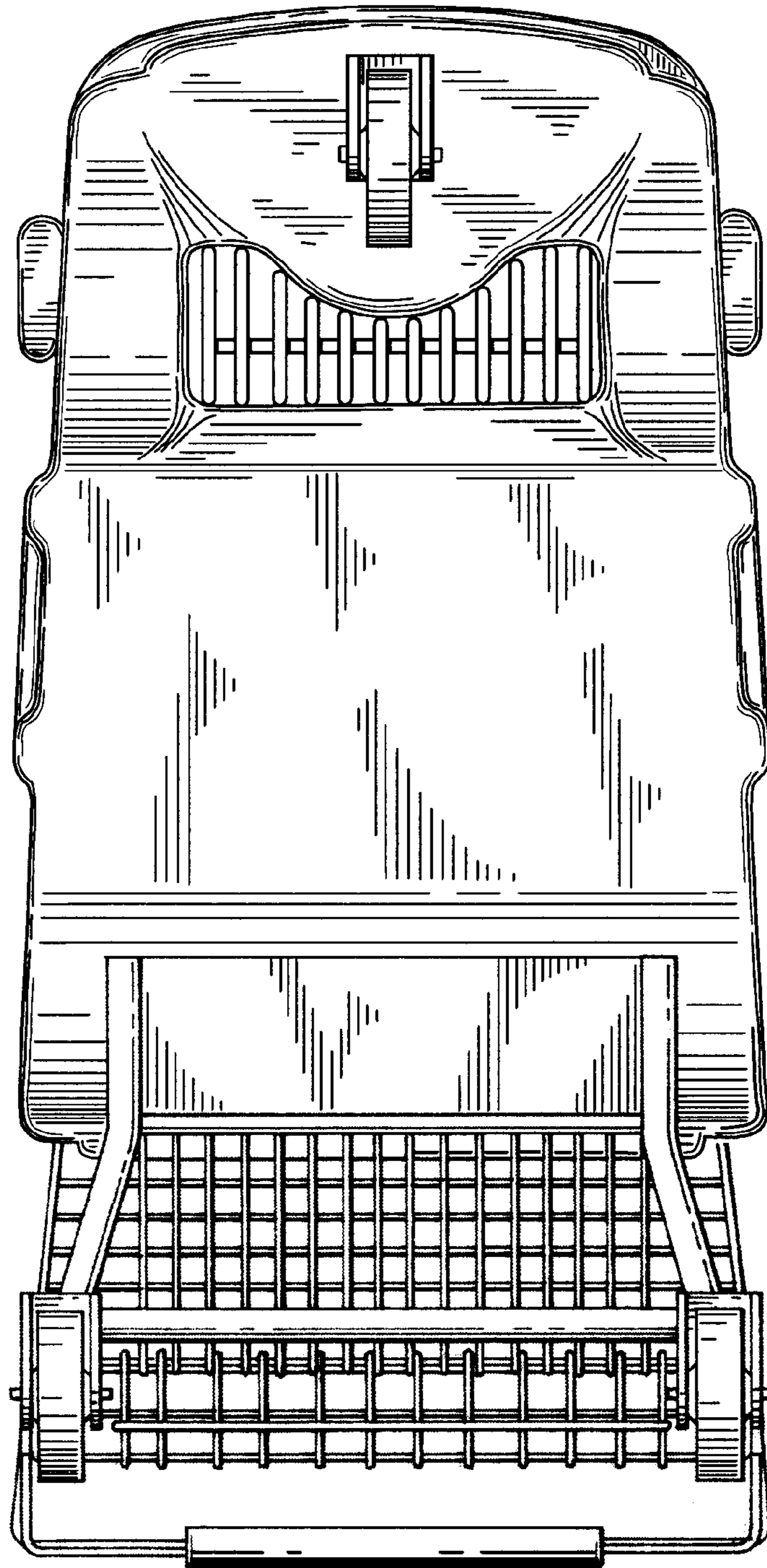

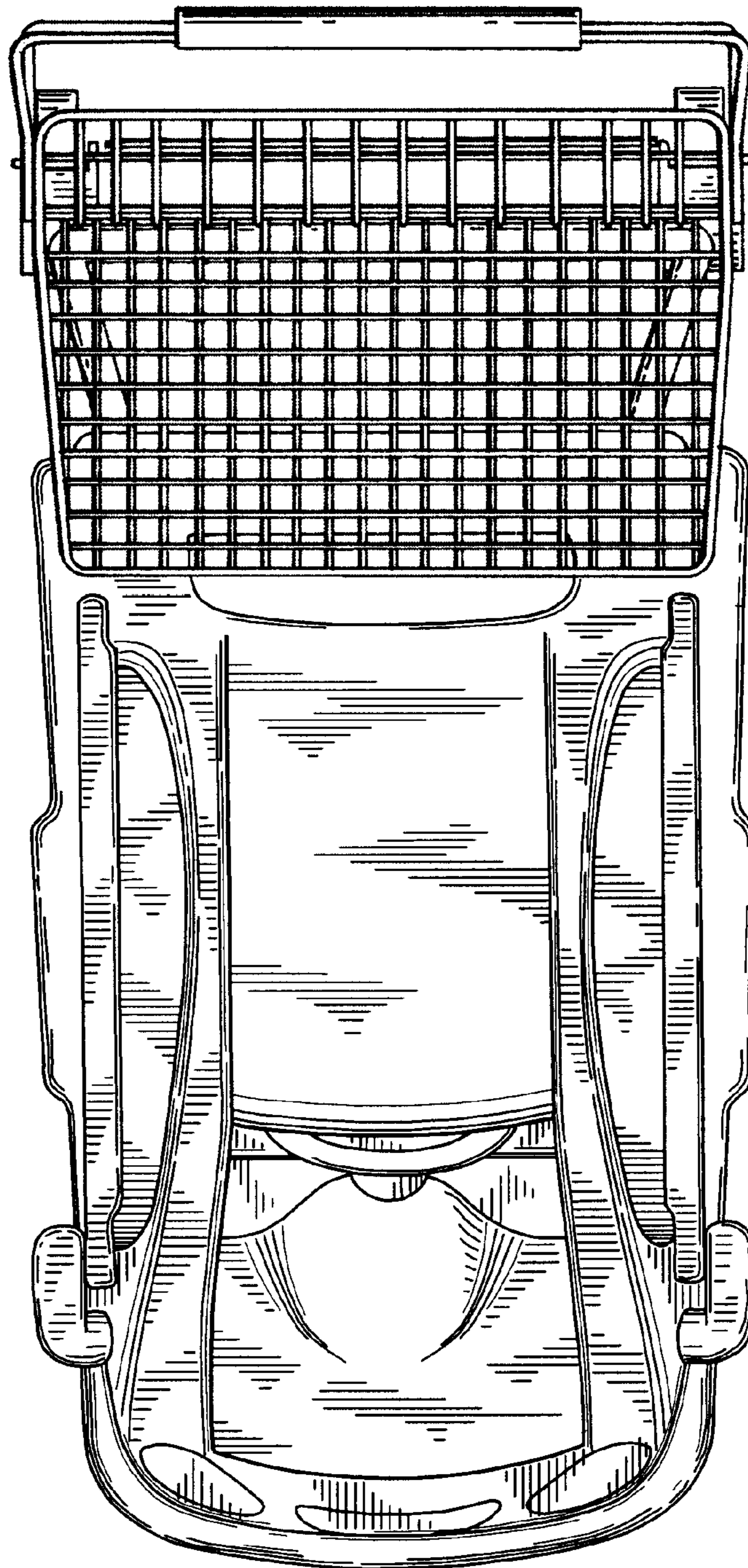
