(57) **CLAIM**

The ornamental design for a removable receptacle for a tissue box, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a removable receptacle for a tissue box, showing the design, as viewed from in front and above;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a plan view thereof;

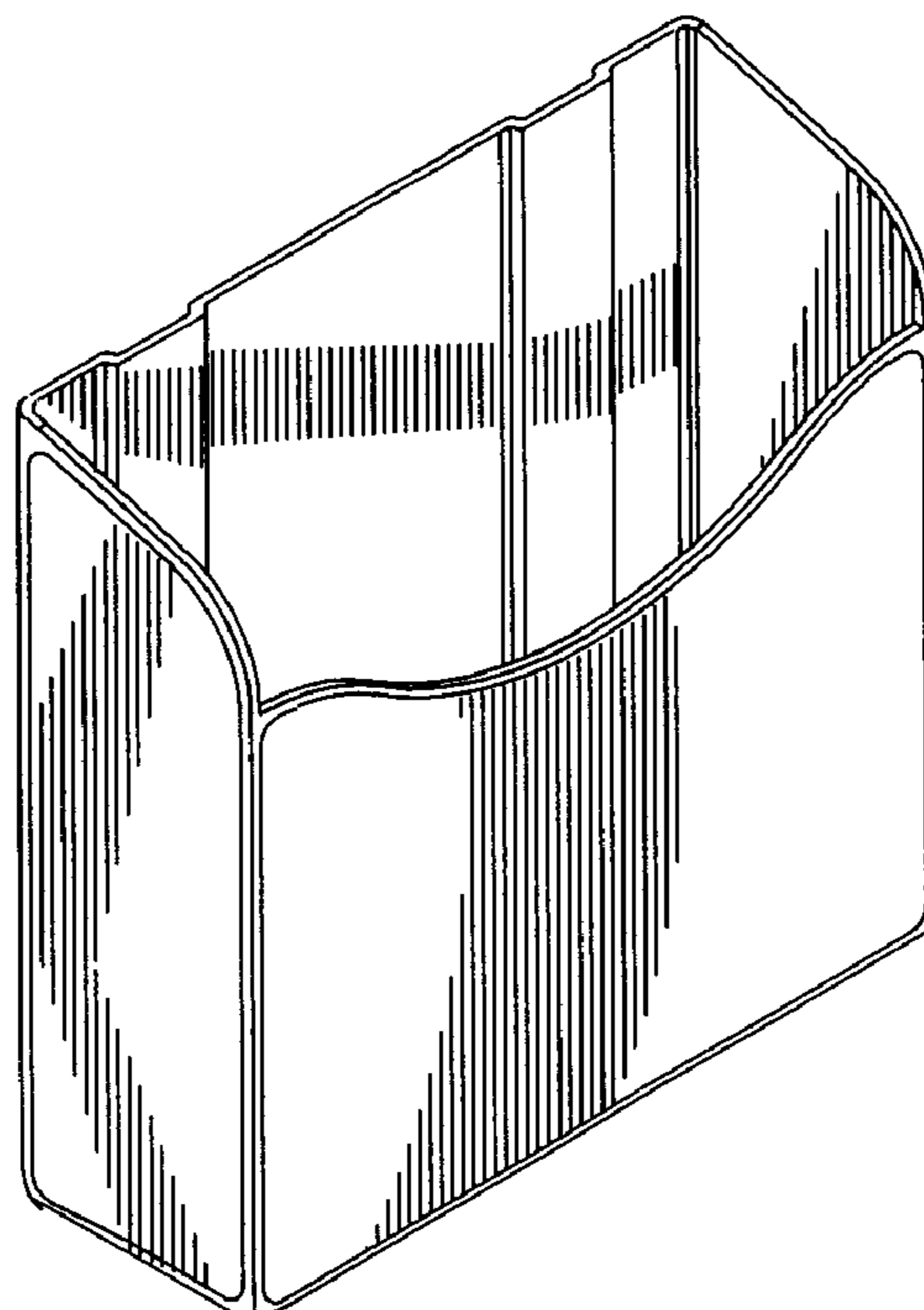
FIG. 4 is a left elevation view thereof;

FIG. 5 is a rear elevation view thereof;

FIG. 6 is a perspective view of the removable receptacle for a tissue box, holding a tissue box, with dashed lines being environmental only, forming no part of the design; and,

FIG. 7 is a plan view of a receptacle built in accordance with an alternate version of the invention to include a curved front wall.

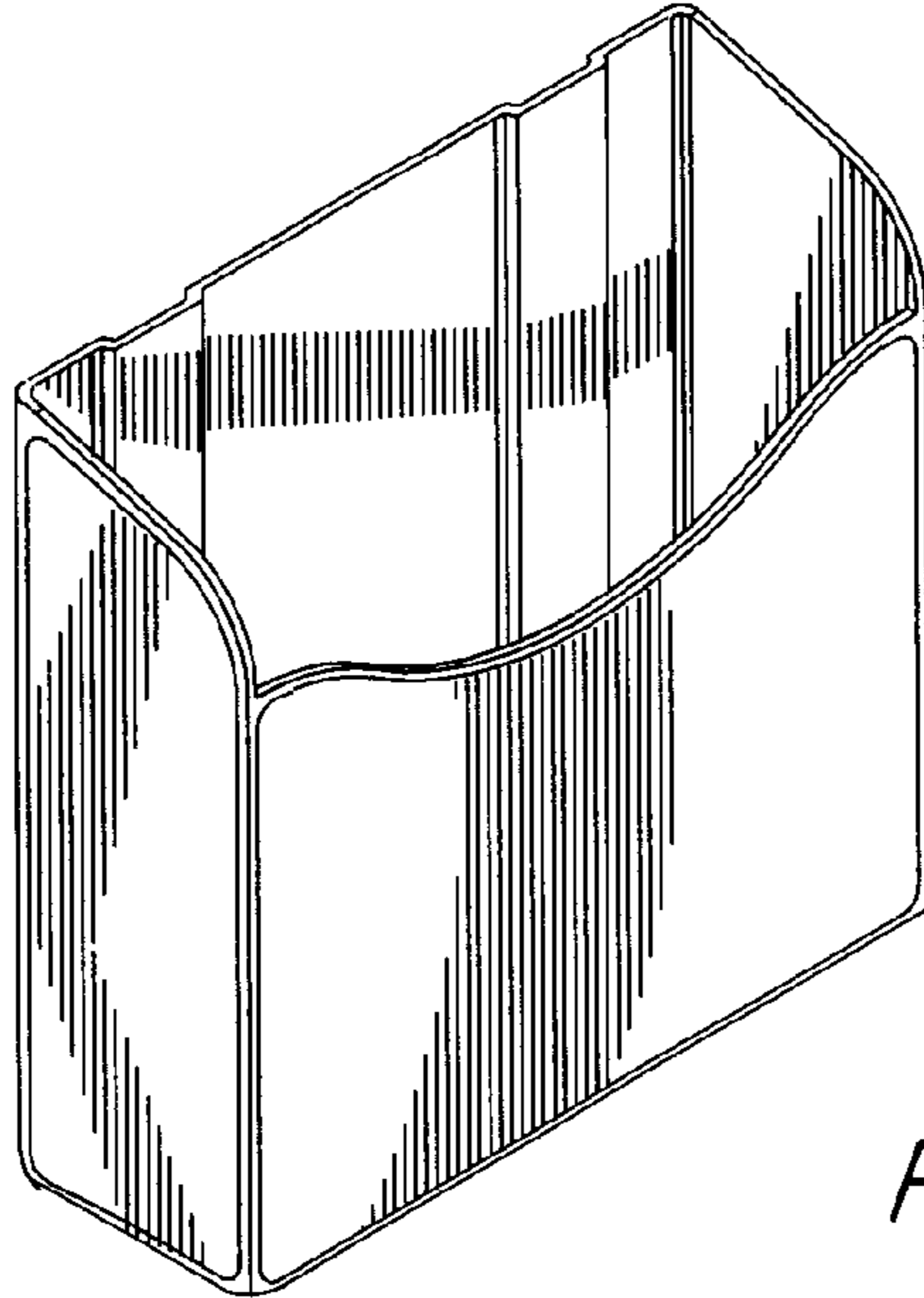

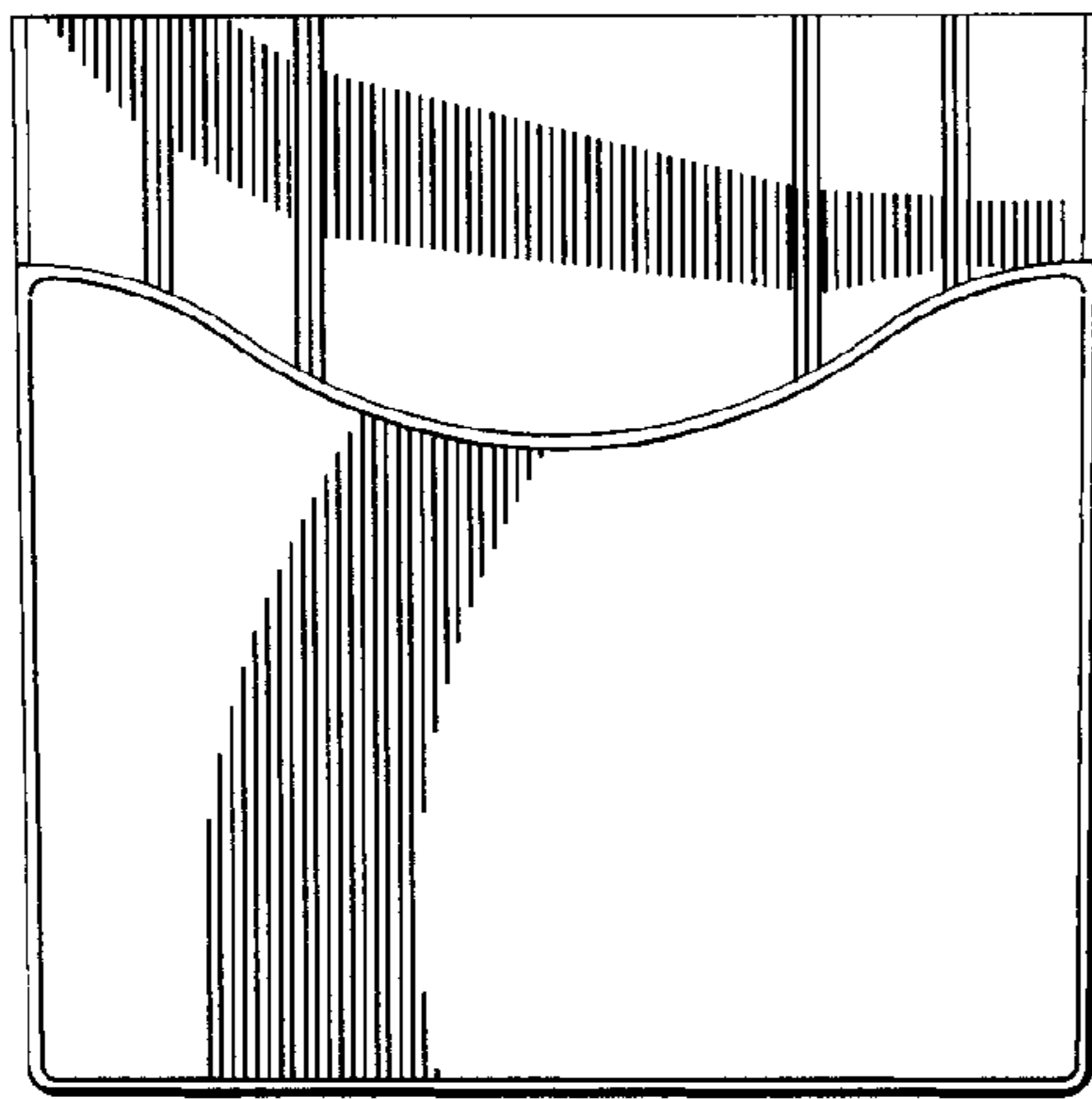

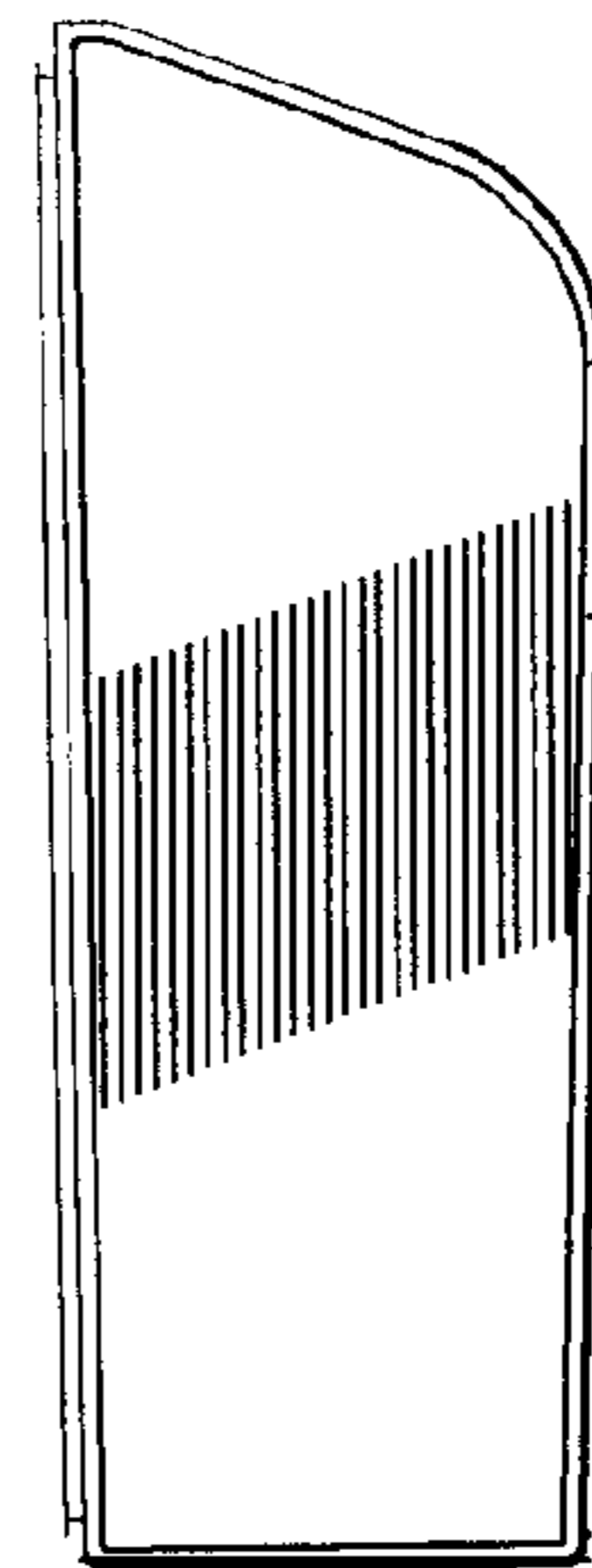

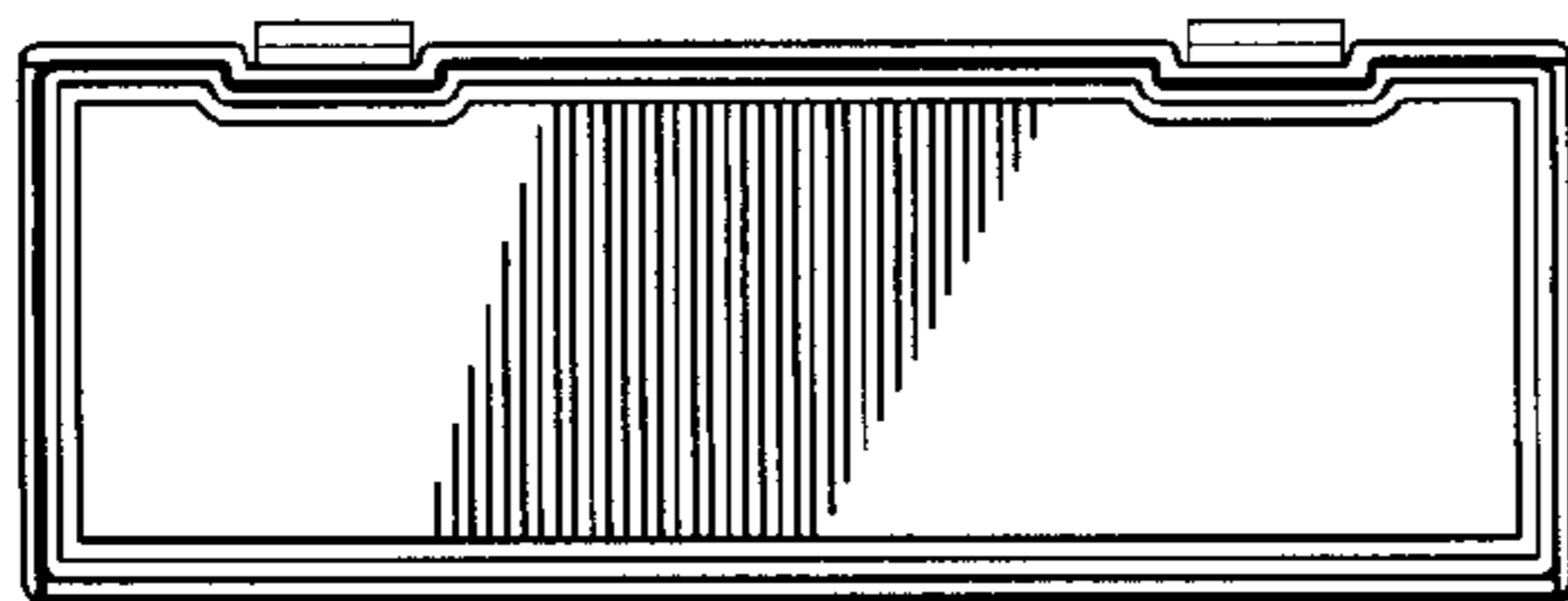

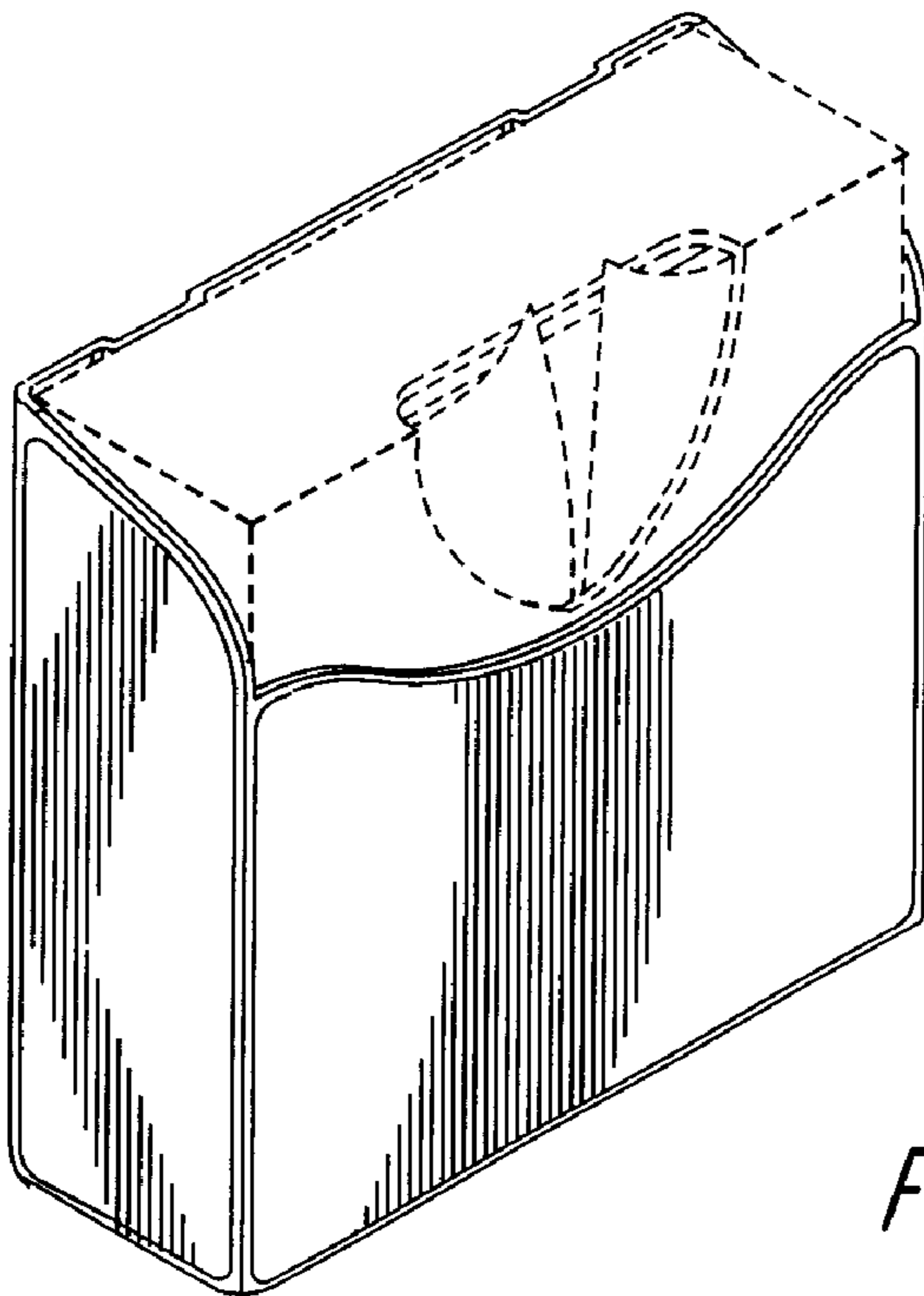
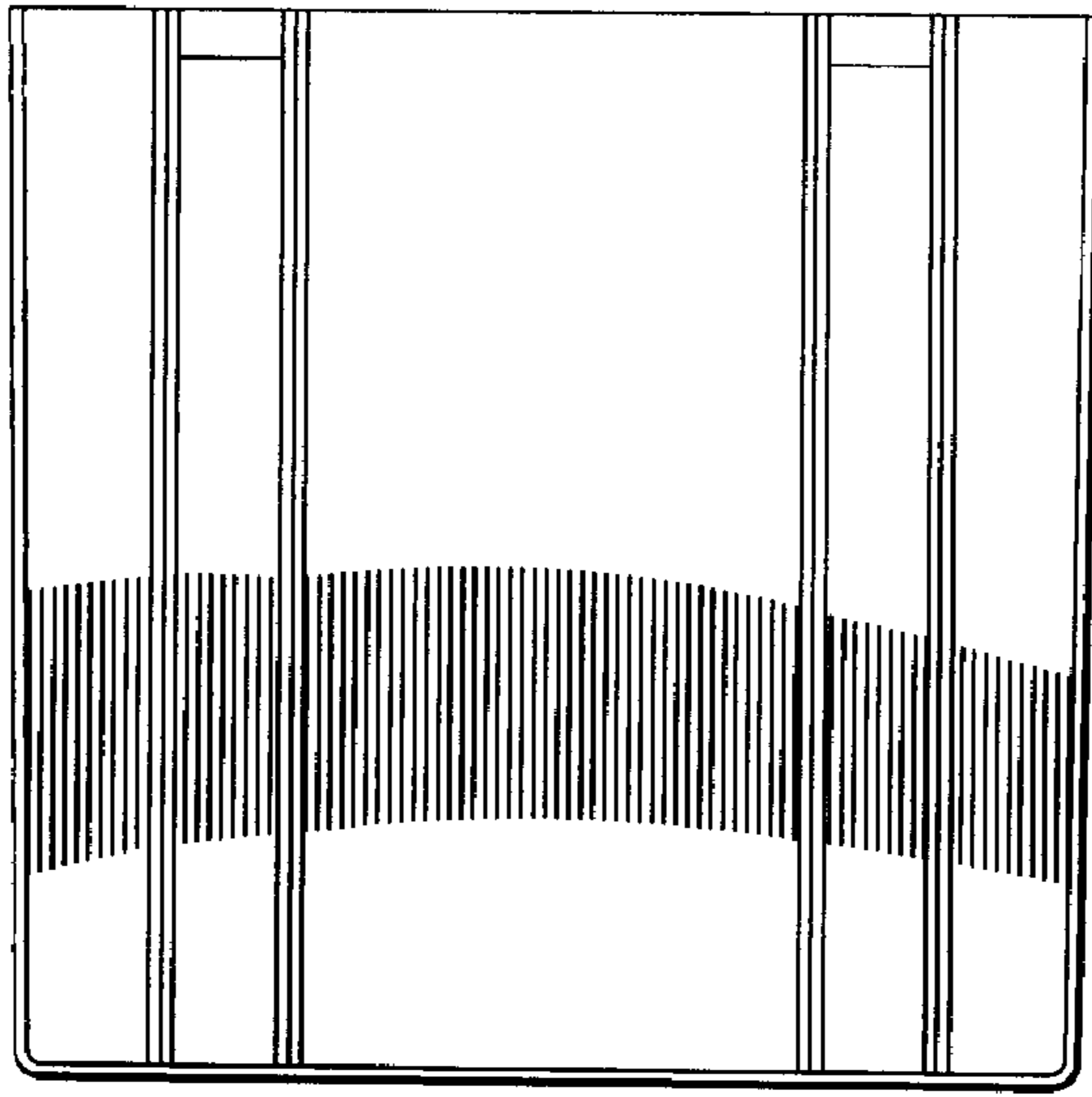
