(57) **CLAIM**

We claim the ornamental design for scissors, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pair of scissors showing our new design;

FIG. 2 is a right side view thereof;

FIG. 3 is a left side view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom view thereof;

FIG. 6 is a front view thereof;

FIG. 7 is rear view thereof;

FIG. 8 is a perspective view of another embodiment of a pair of scissors showing our new design;

FIG. 9 is a right side view of the scissors in FIG. 8;

FIG. 10 is a left side view of the scissors in FIG. 8.

FIG. 11 is a top view of the scissors in FIG. 8;

FIG. 12 is a bottom view of the scissors in FIG. 8; and

FIG. 13 is a front view of the scissors in FIG. 8;

FIG. 14 is rear view of the scissors in FIG. 8;

FIG. 15 is a perspective view of yet another embodiment of a pair of scissors showing our new design;

FIG. 16 is a right side view of the scissors in FIG. 15;

FIG. 18 is a top view of the scissors in FIG. 15;

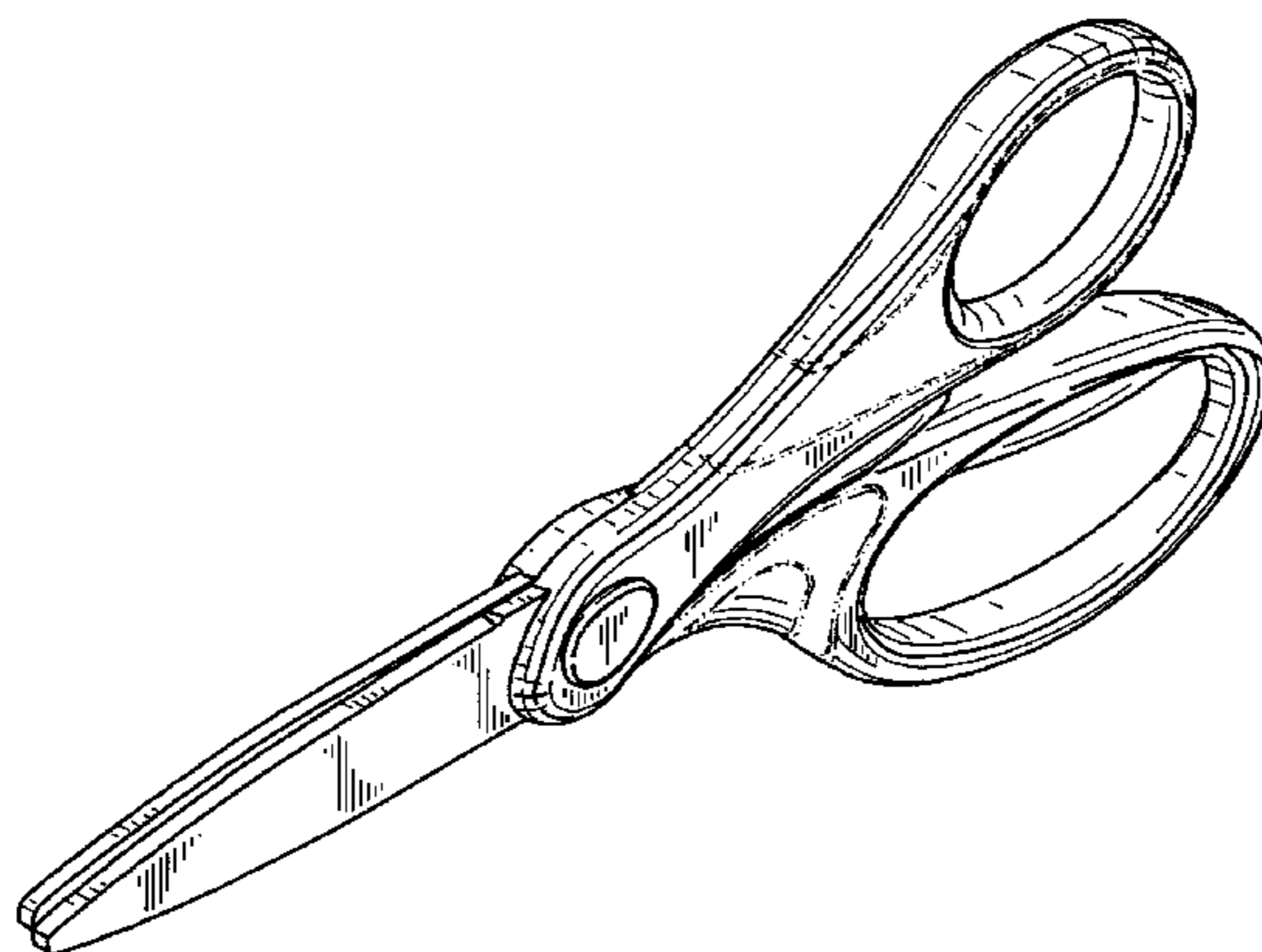
FIG. 19 is a bottom view of the scissors in FIG. 15; and

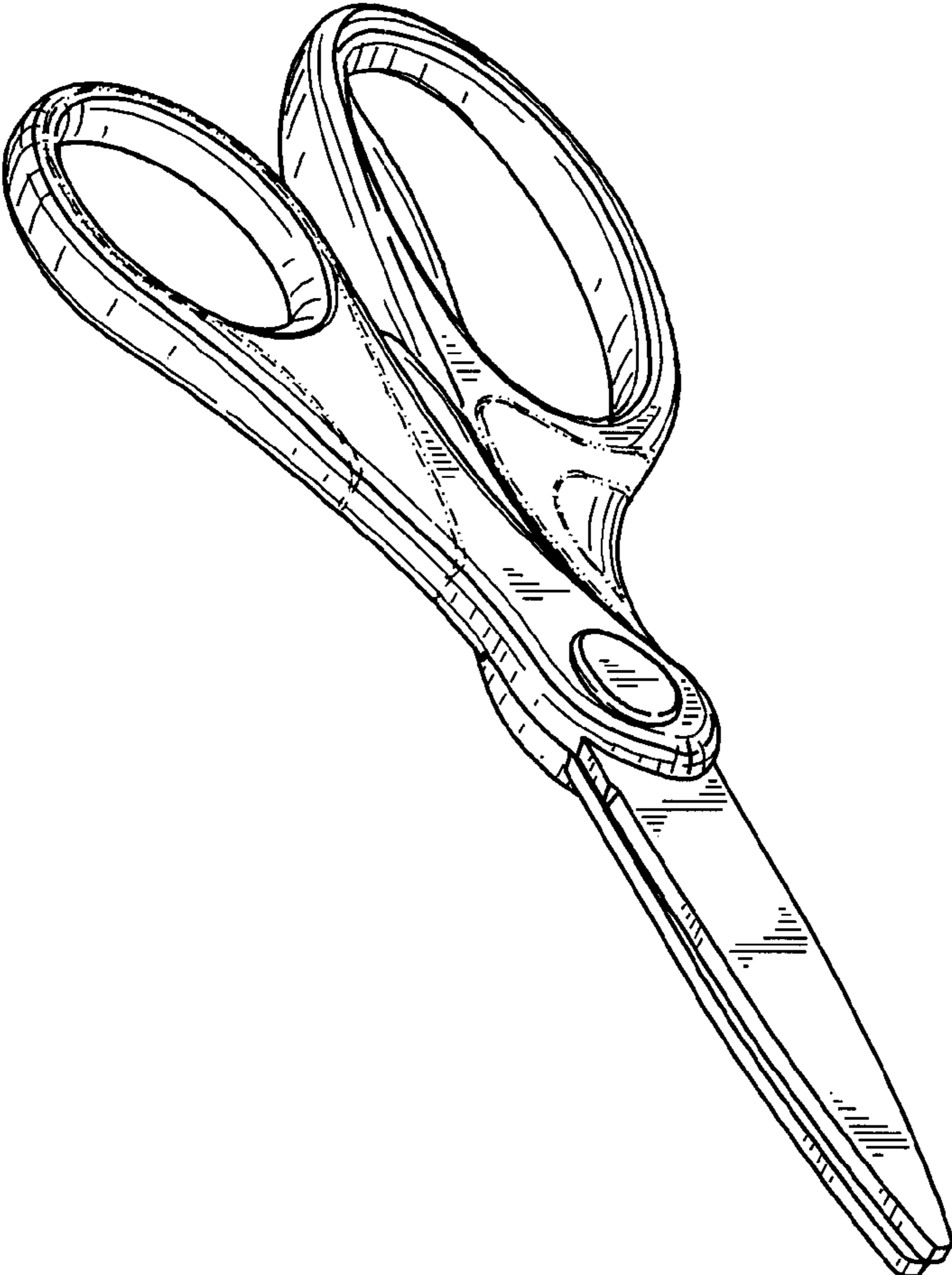
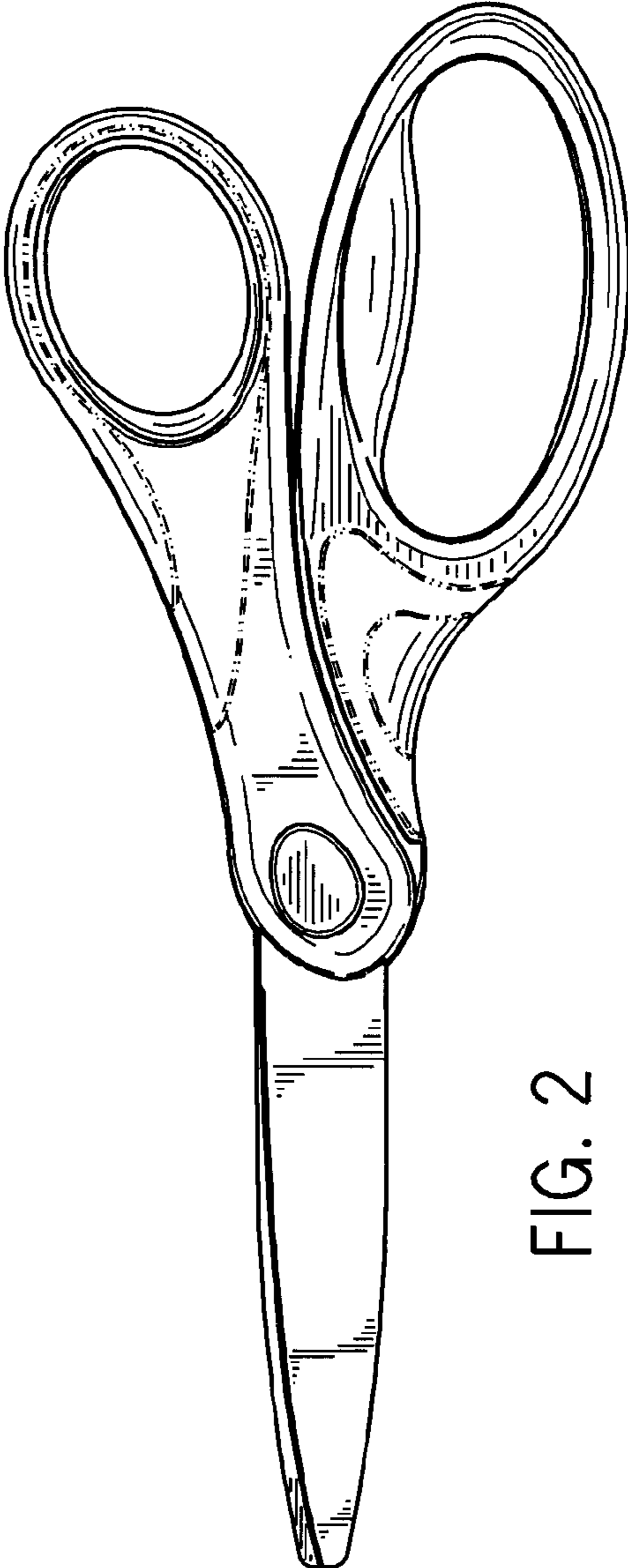

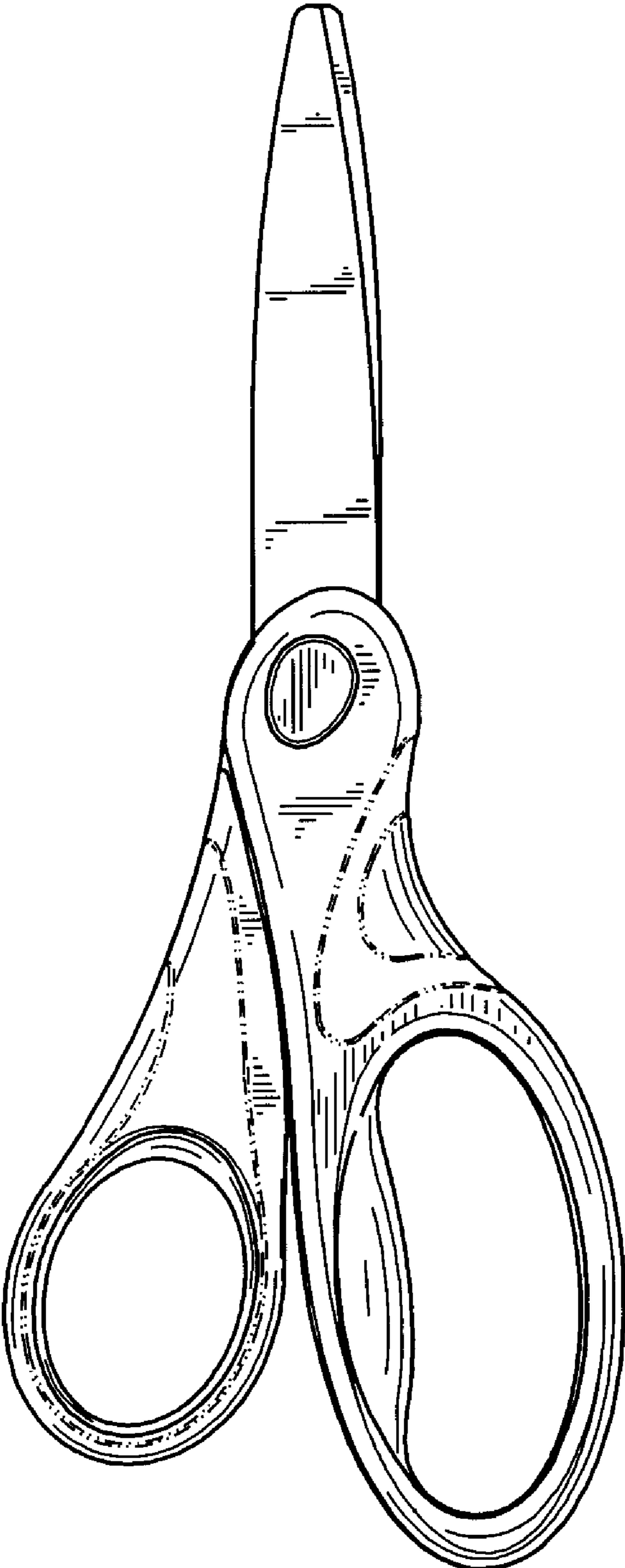

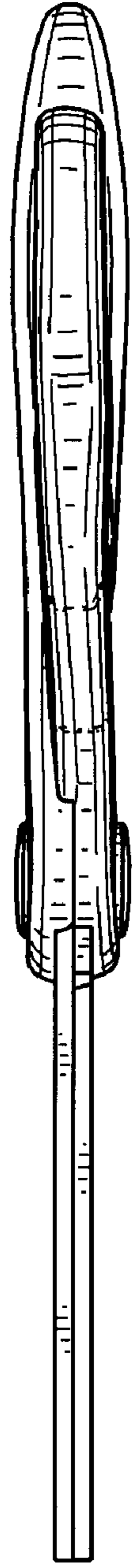

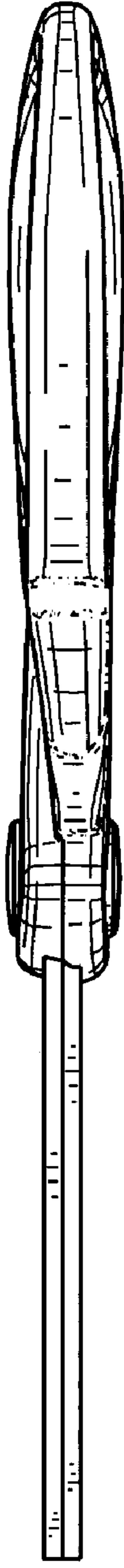

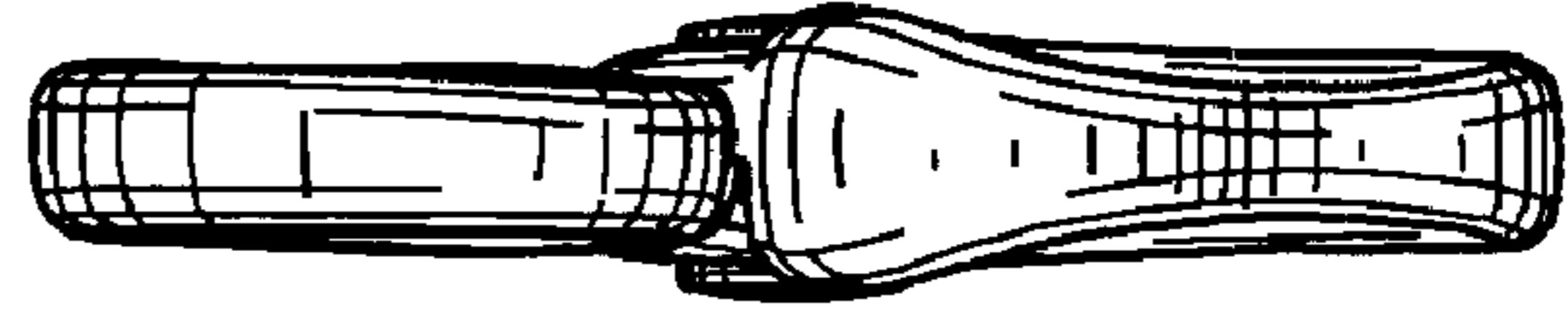

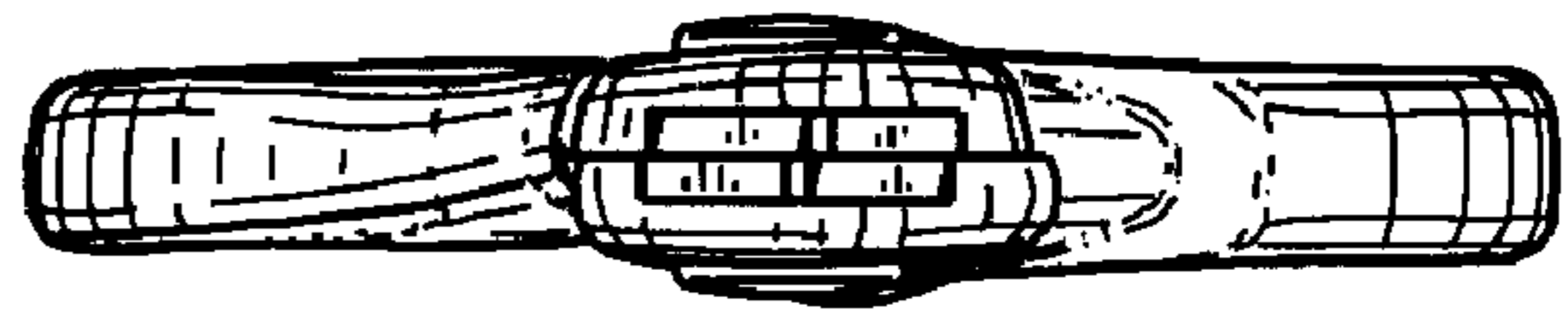

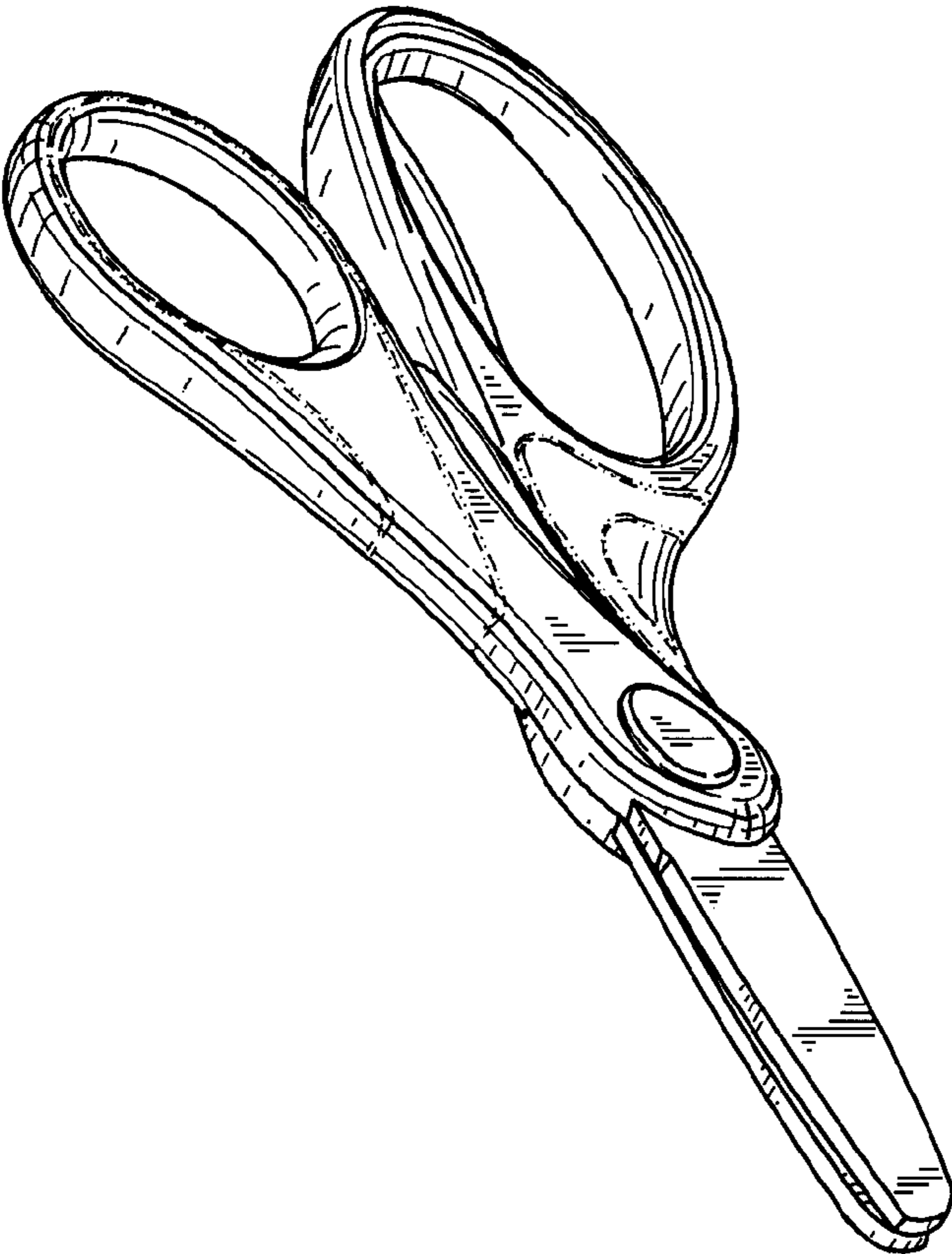
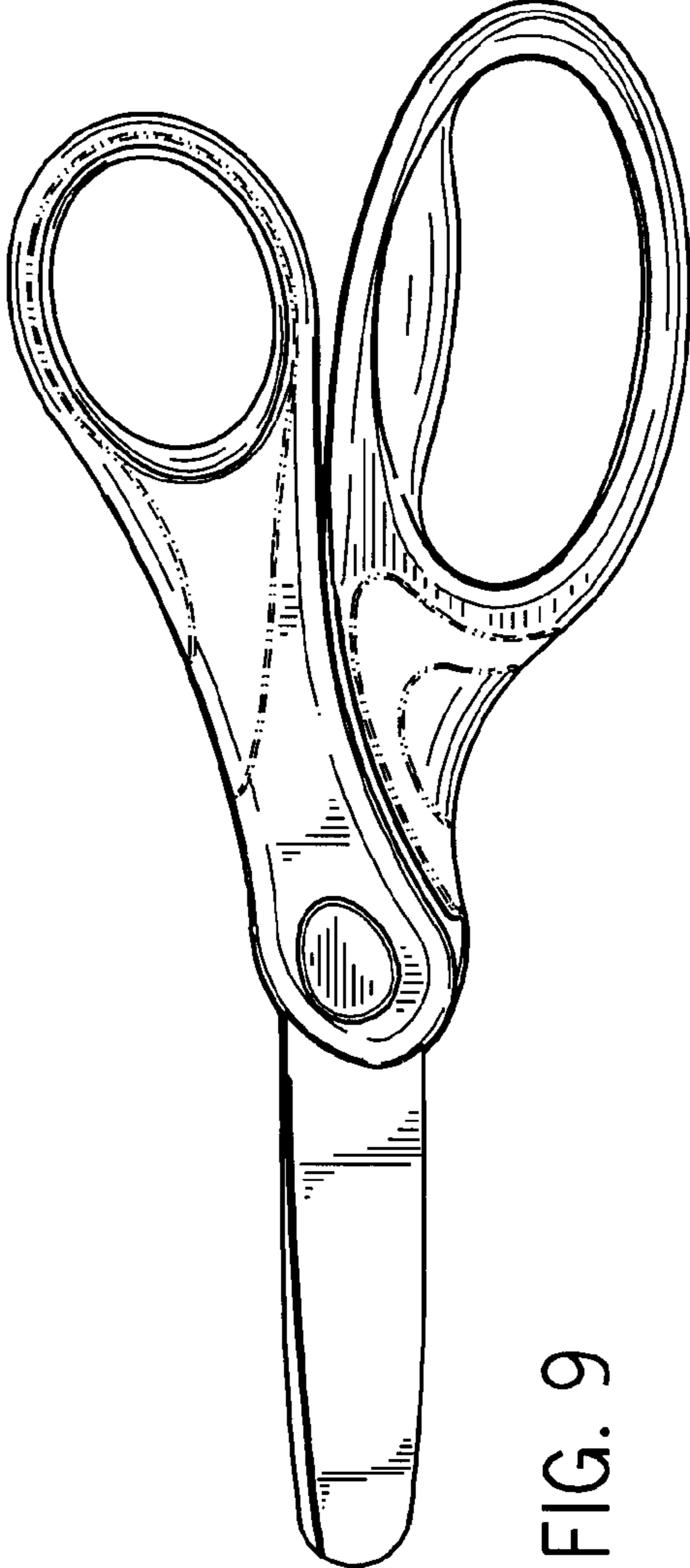

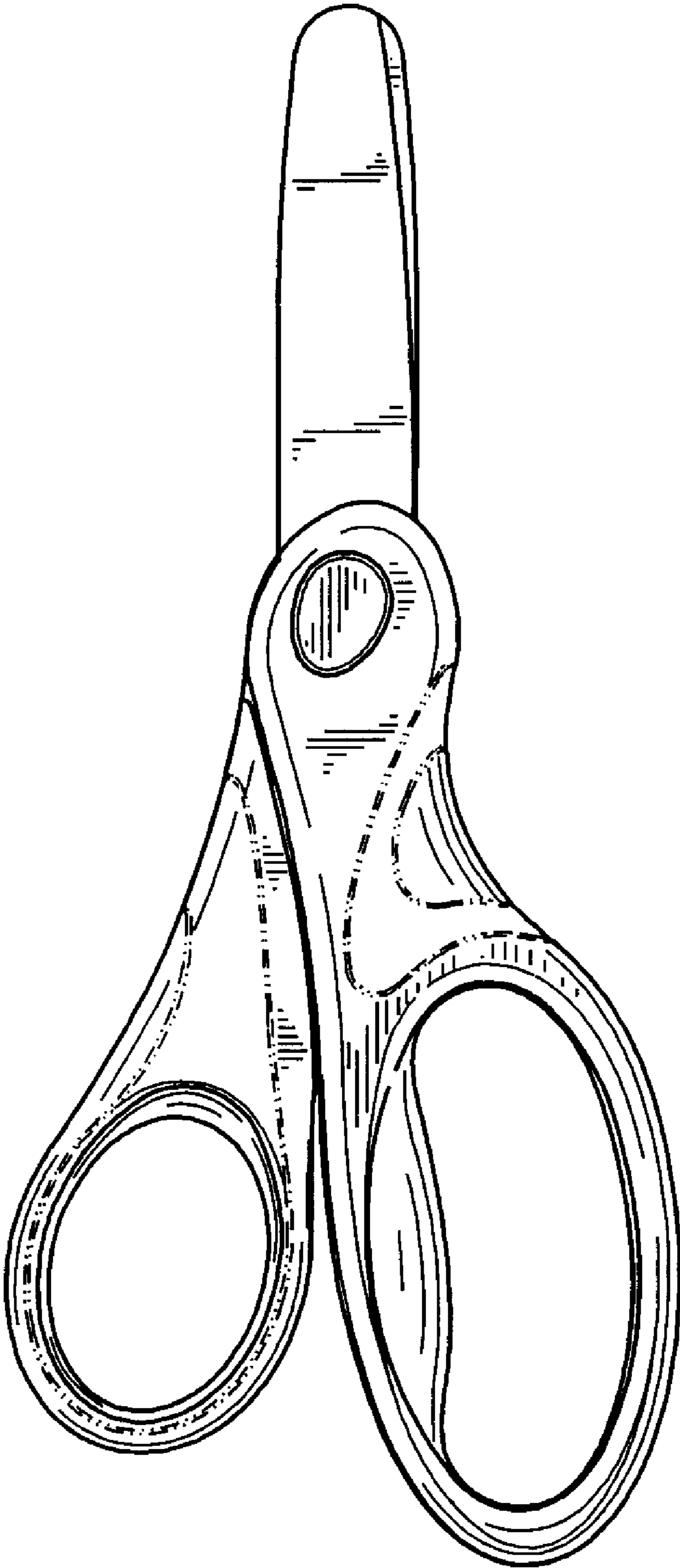

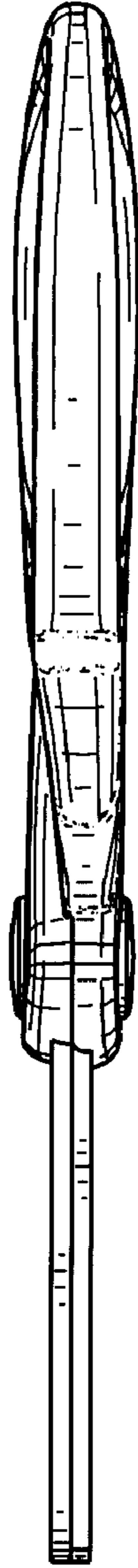

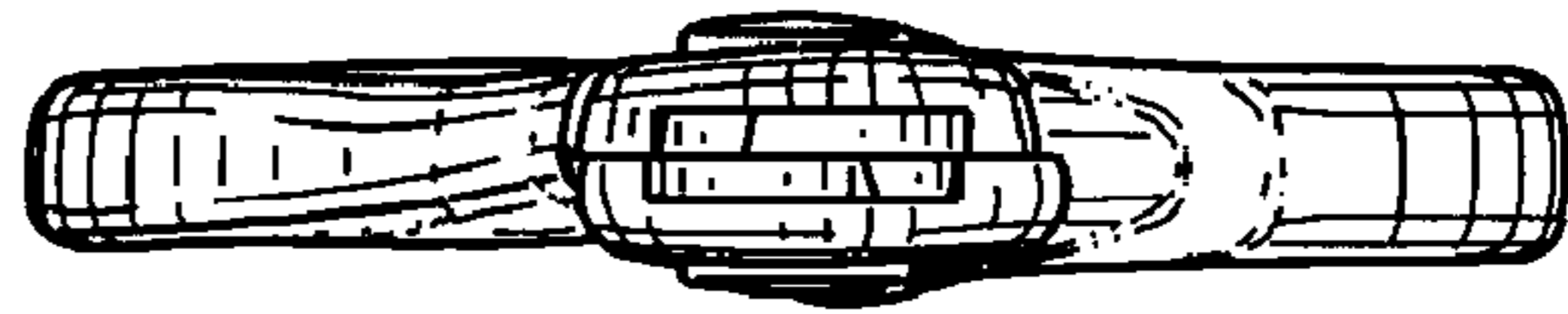

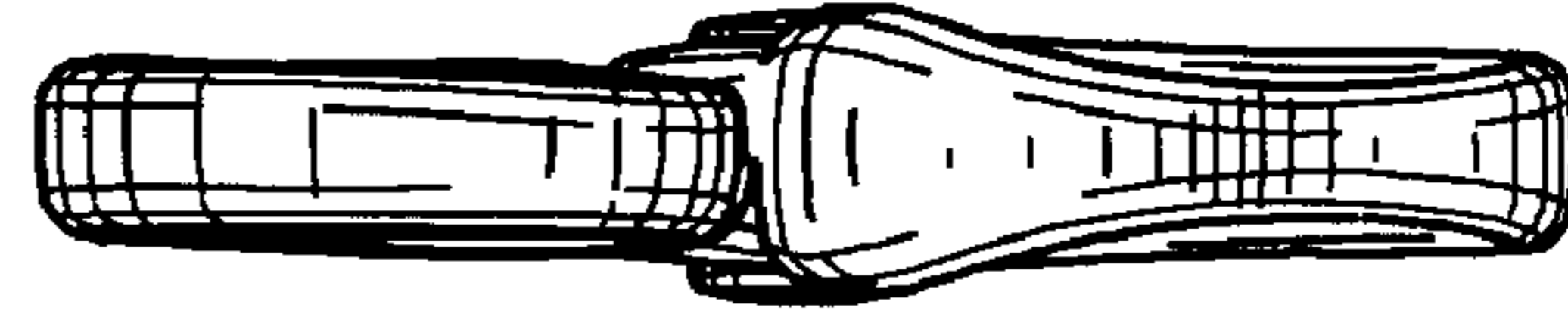

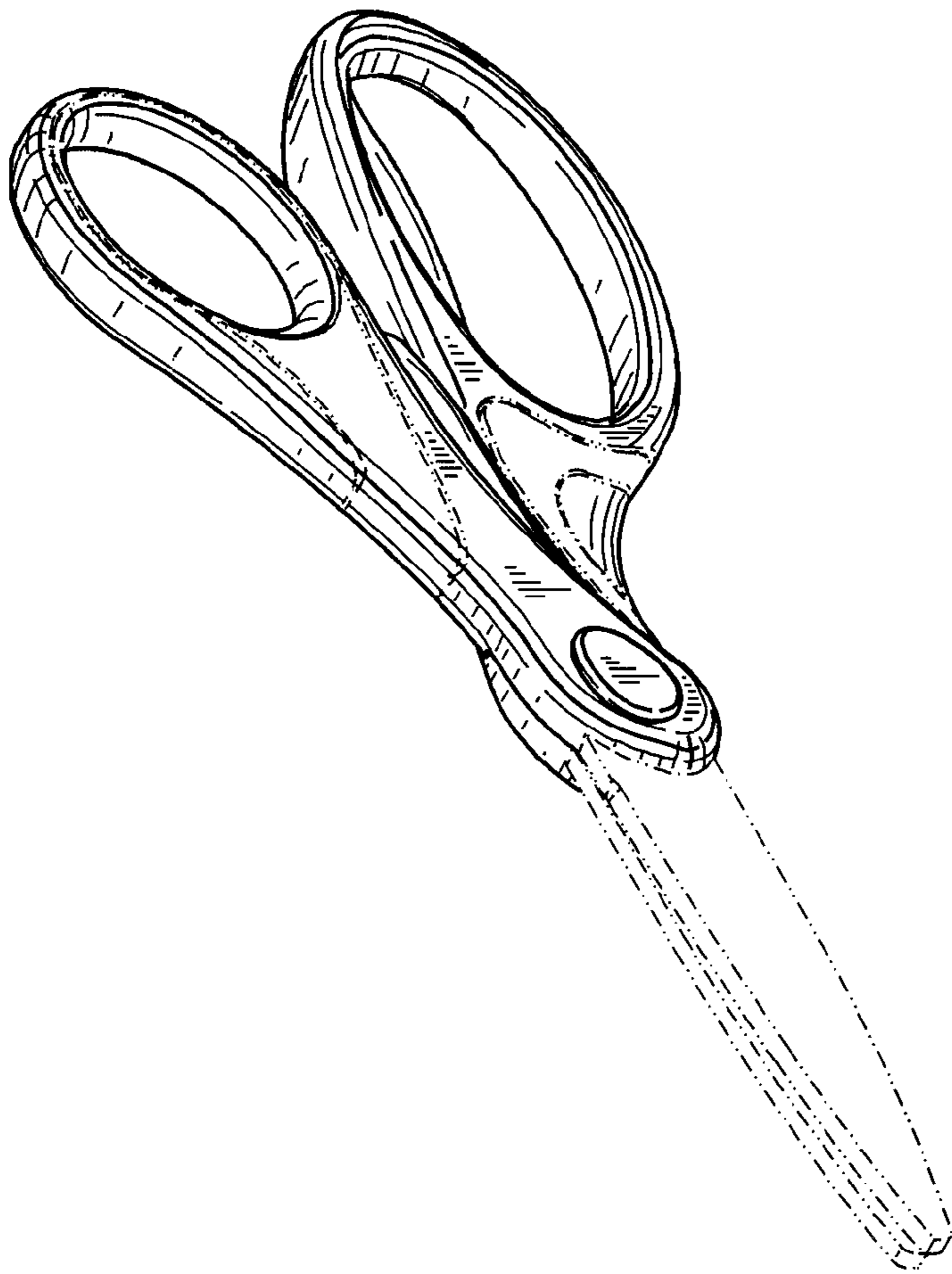
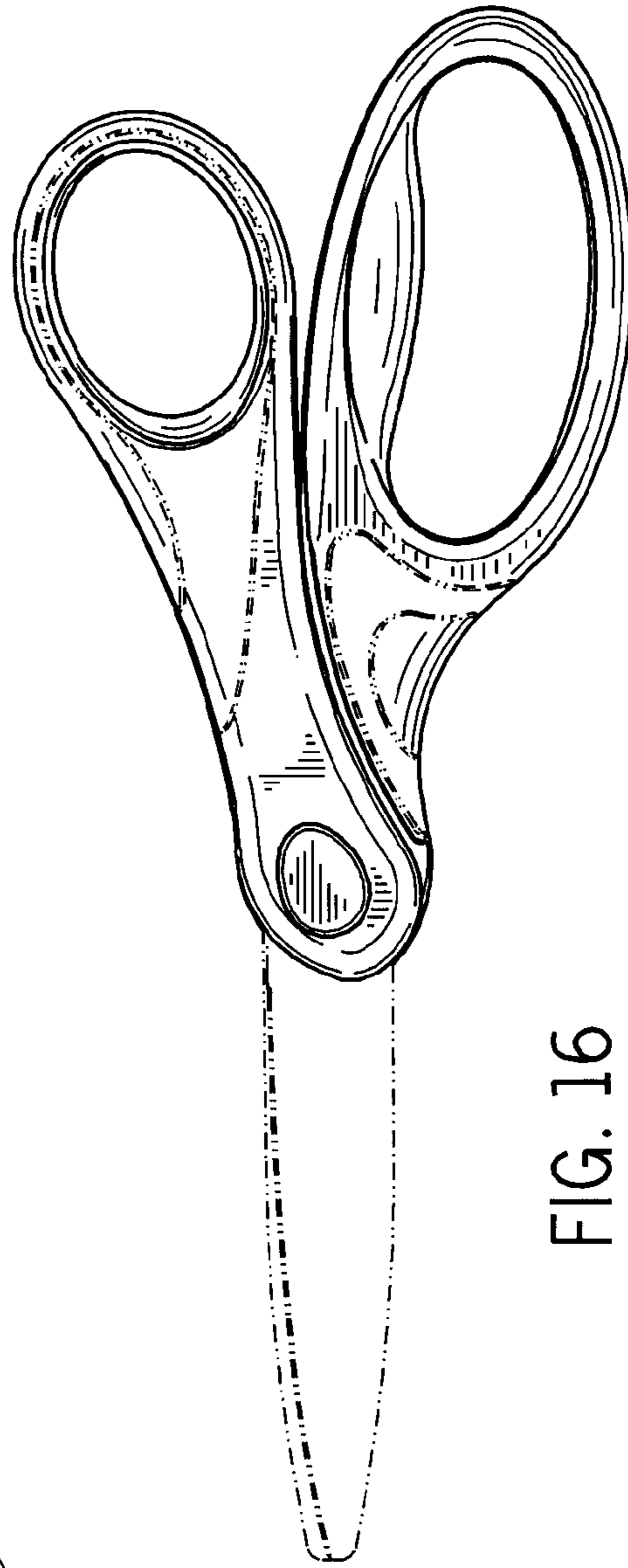

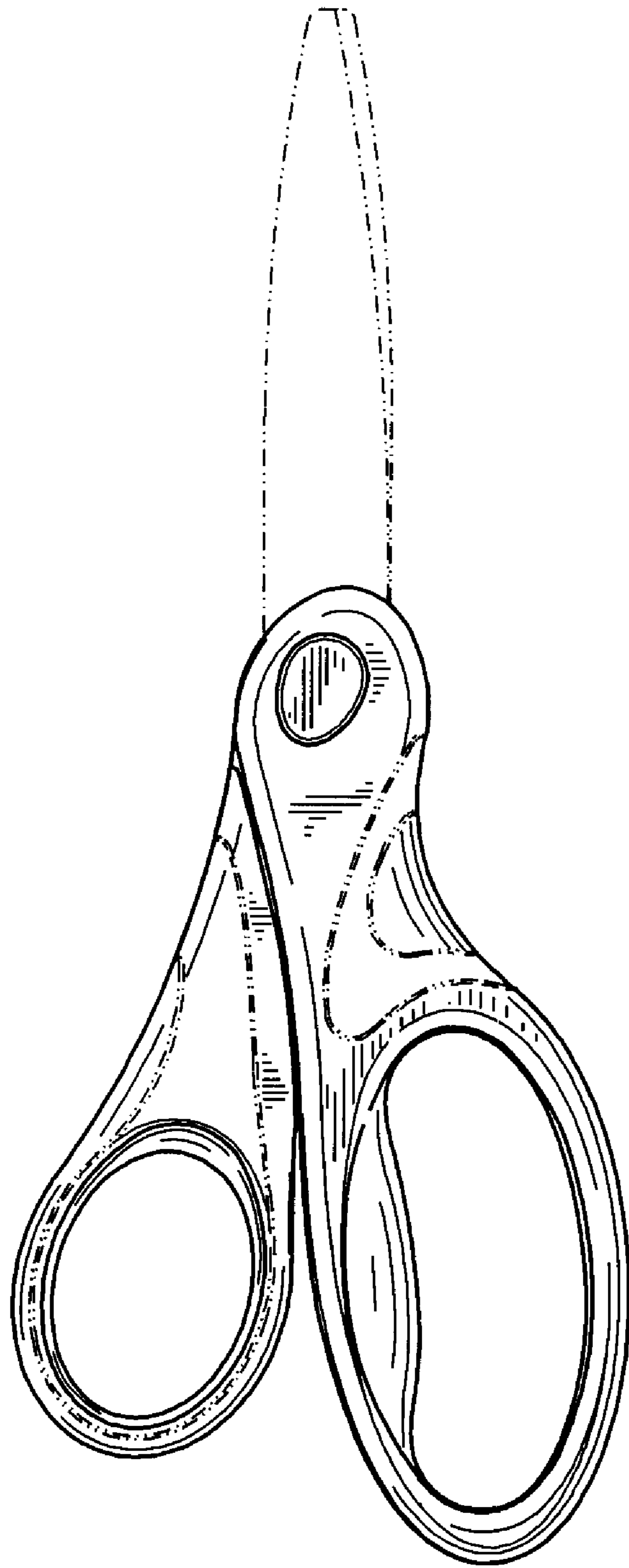

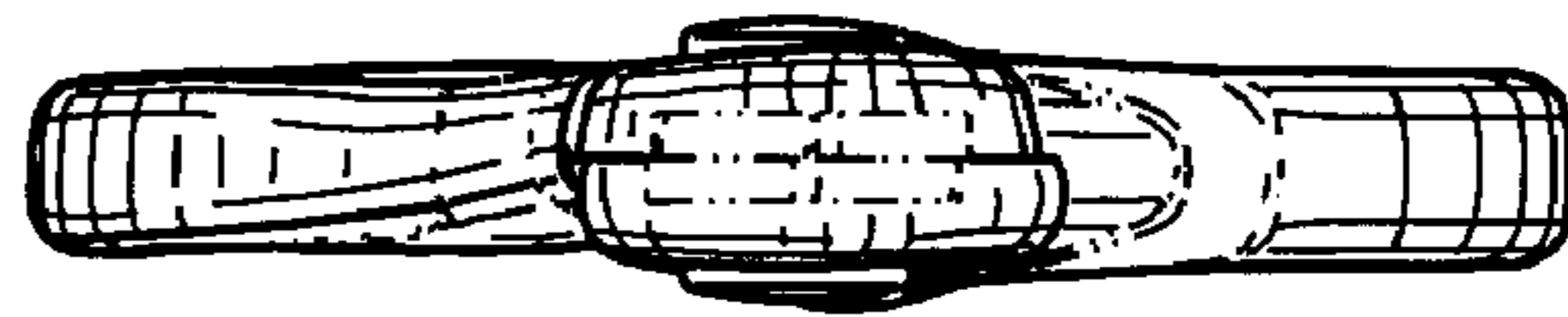
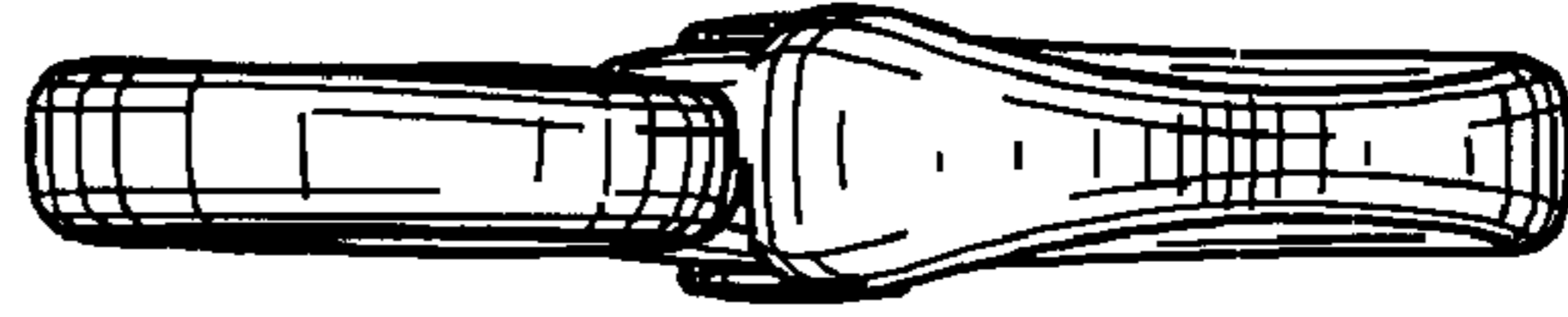
