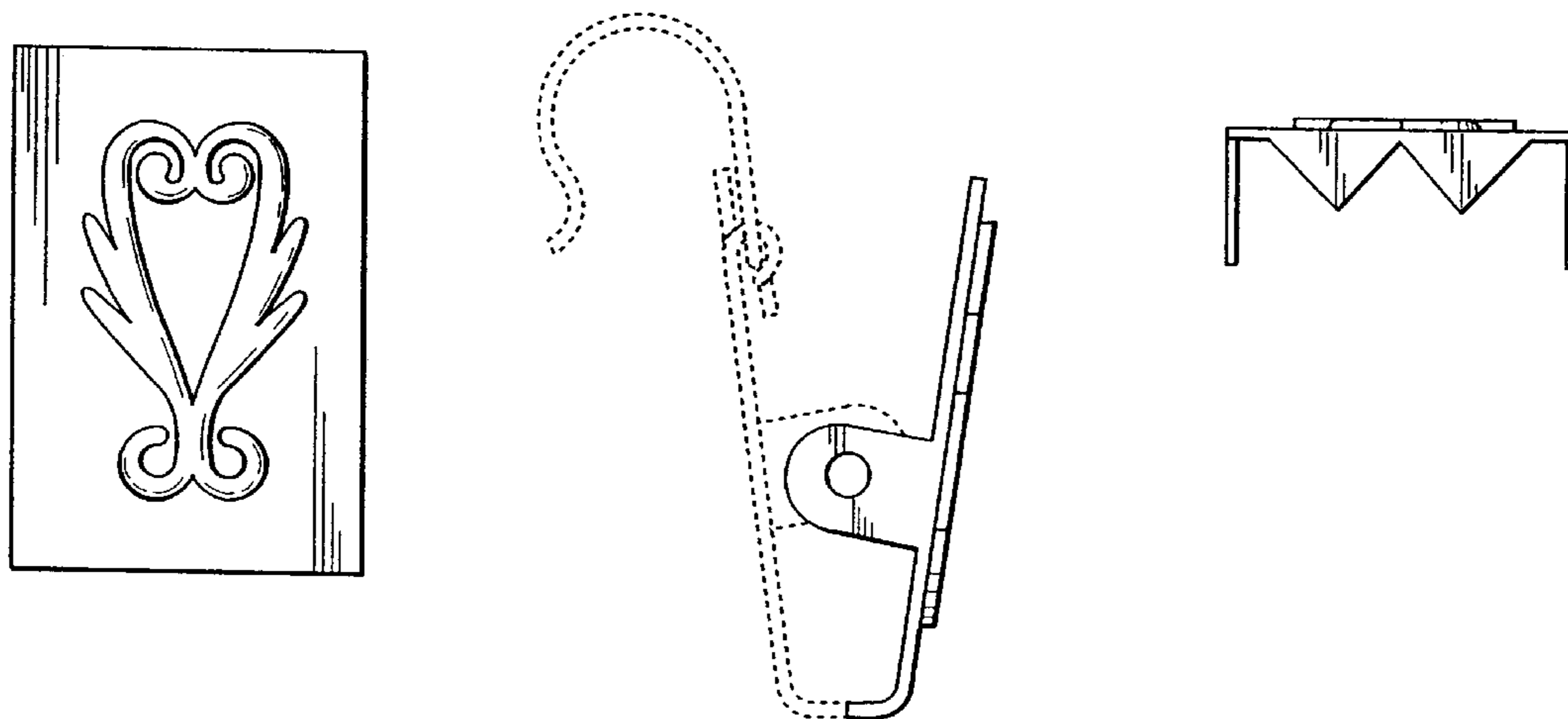
(57) **CLAIM**

The ornamental design for a clip, as shown and described.

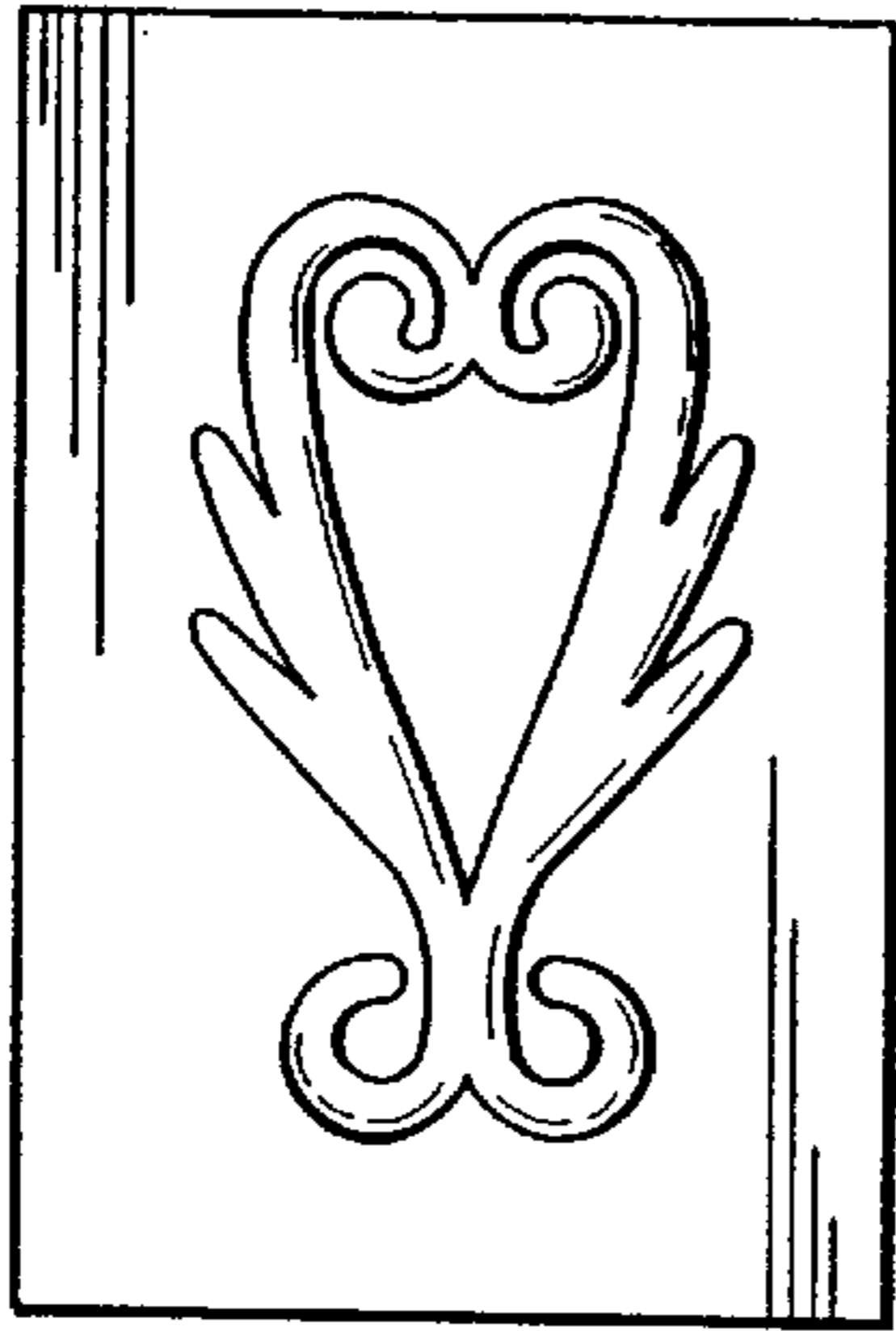
**DESCRIPTION**

FIG. 1 is a front elevational view of a clip according to my new design;

 The broken lines shown in FIGS. 1-5 are for illustrative purposes only and form no part of the claimed design.

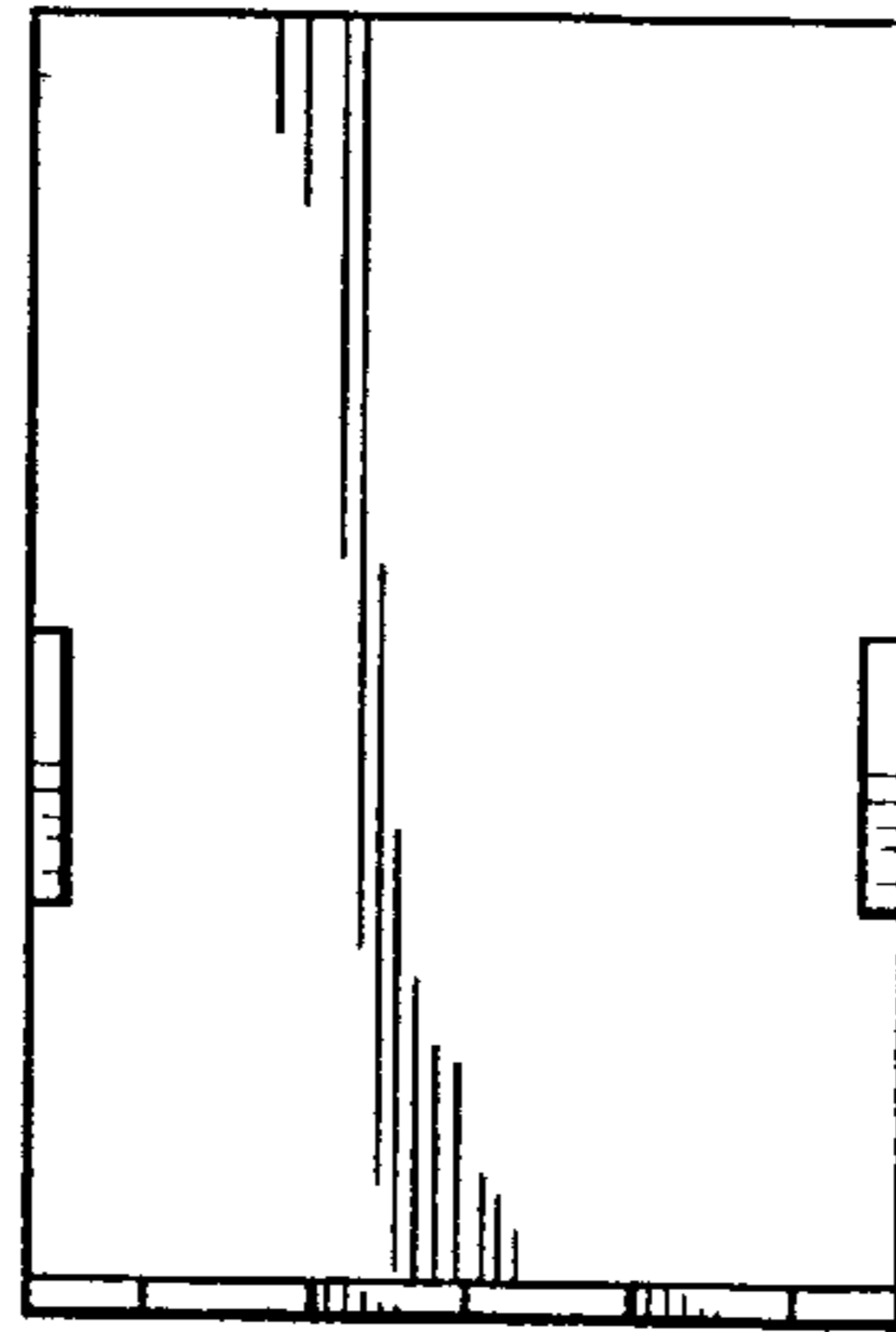

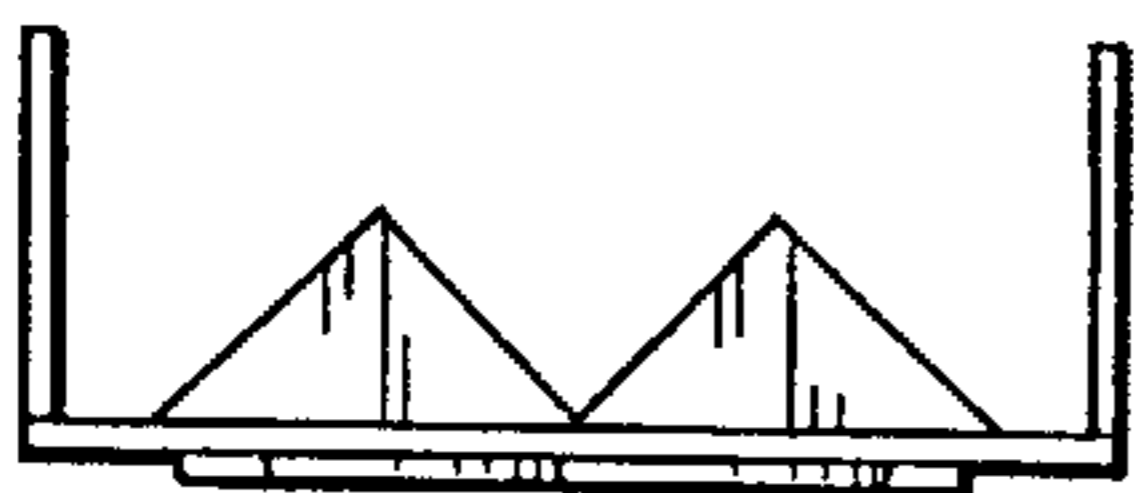
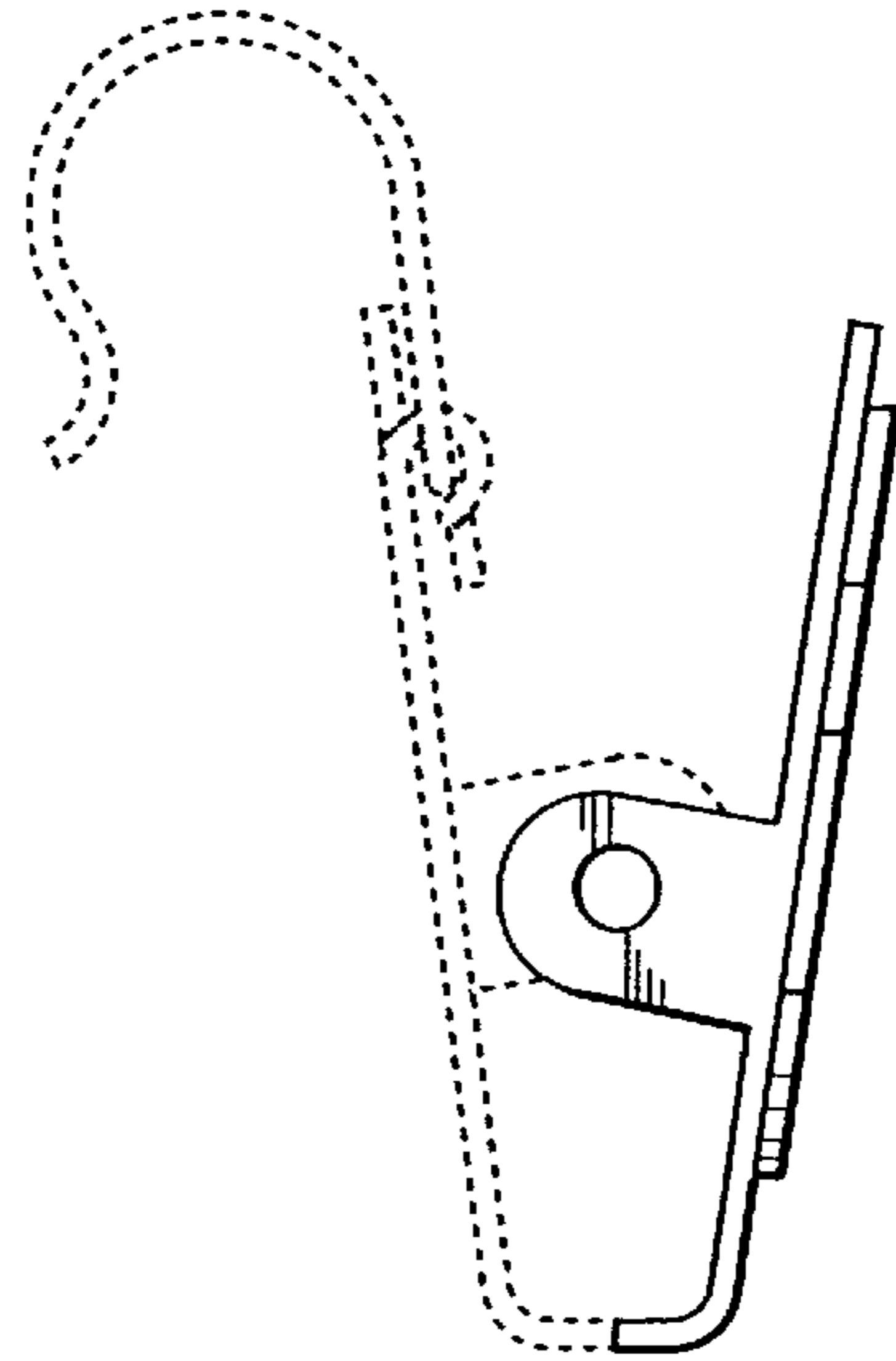

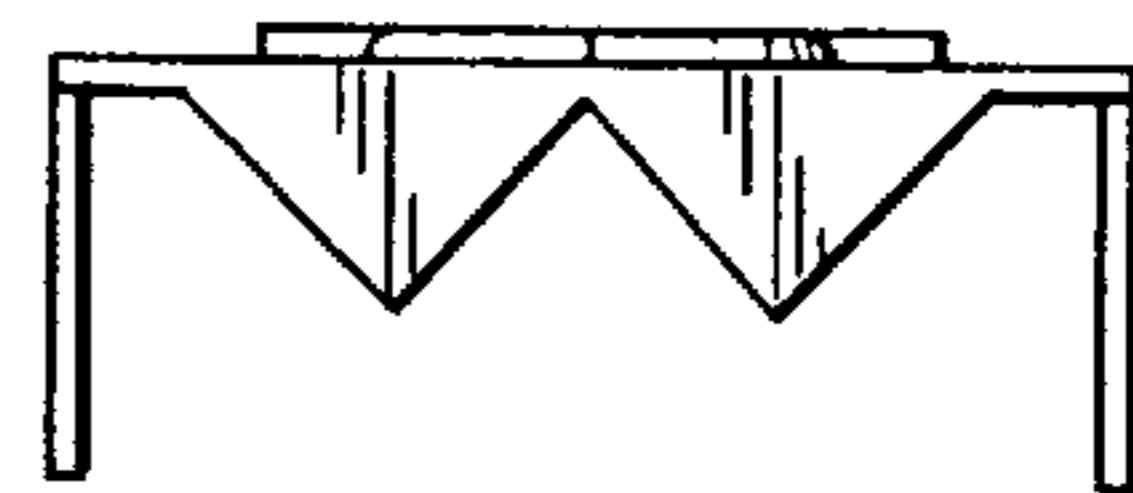
