**DESCRIPTION**

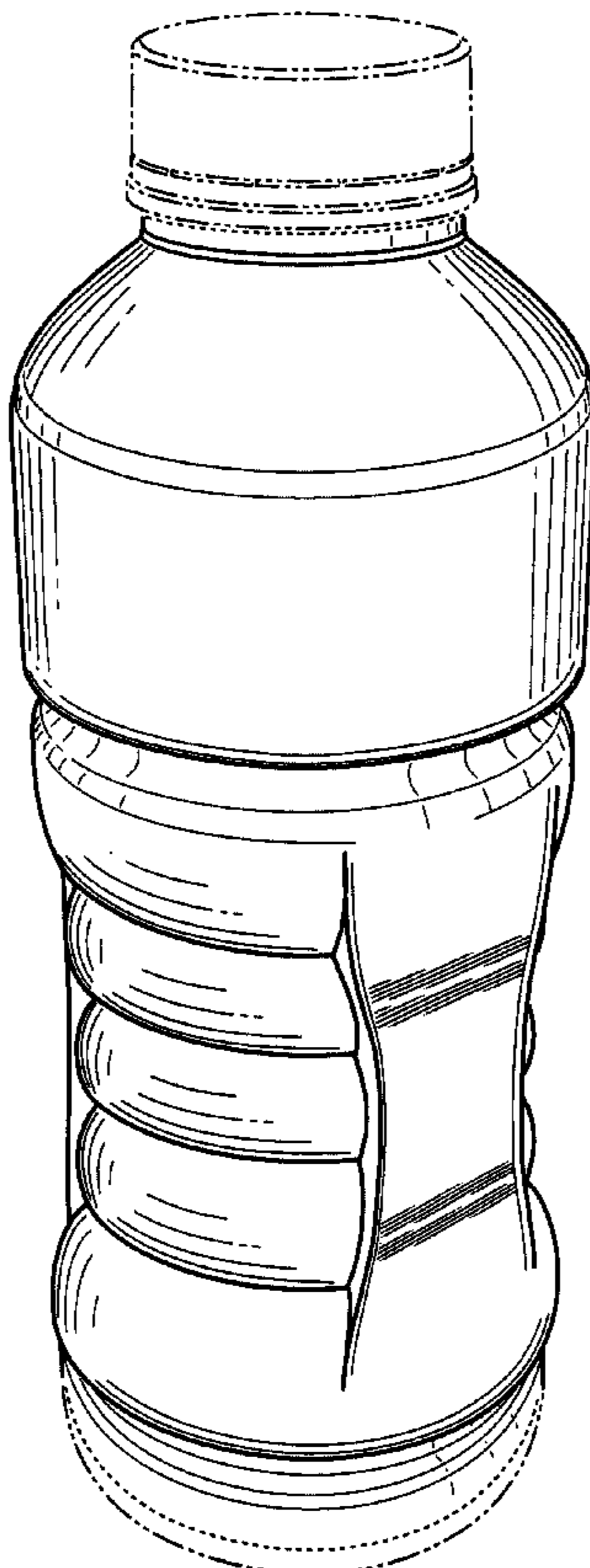
FIG. 1 is a top, front, left side perspective view of a bottle showing our new design;

The broken lines shown in the drawings are for illustrative purposes only and form no part of the claimed design.

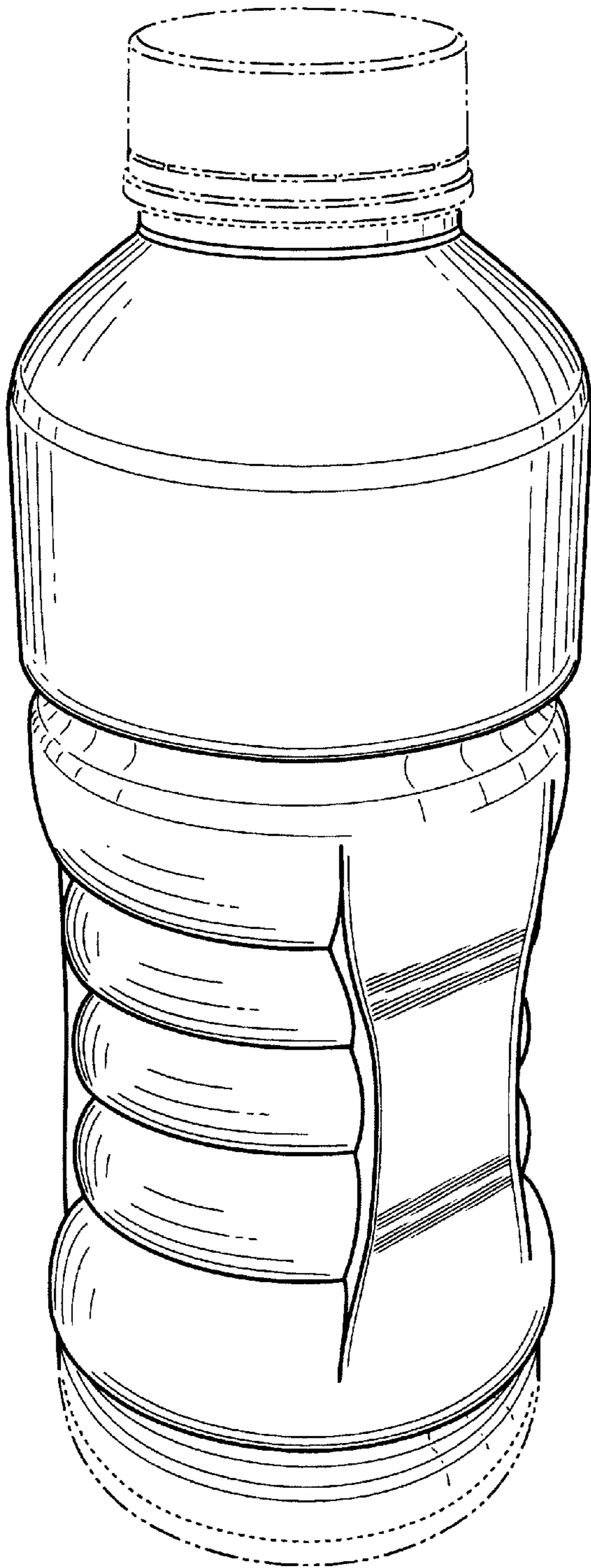

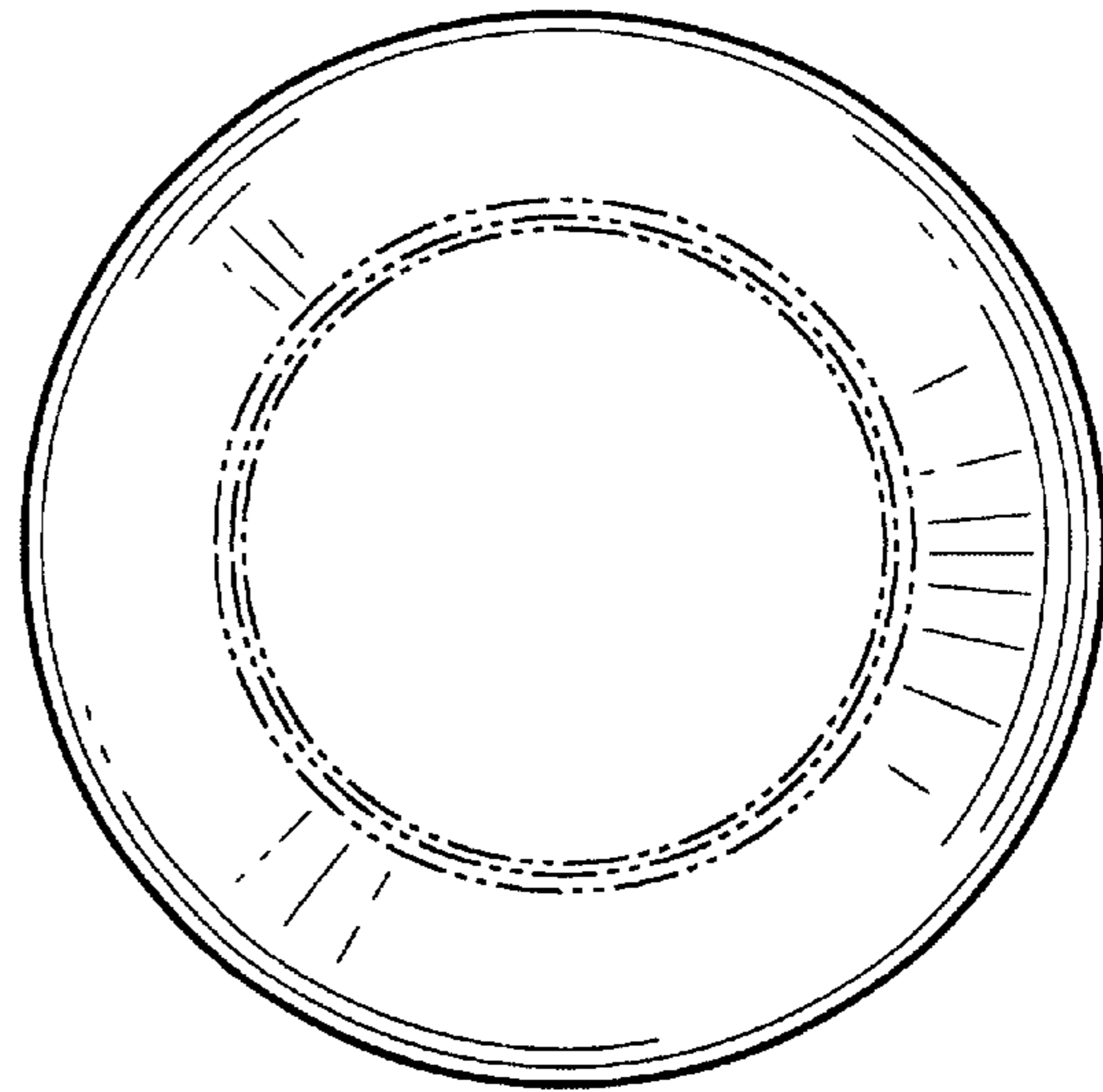

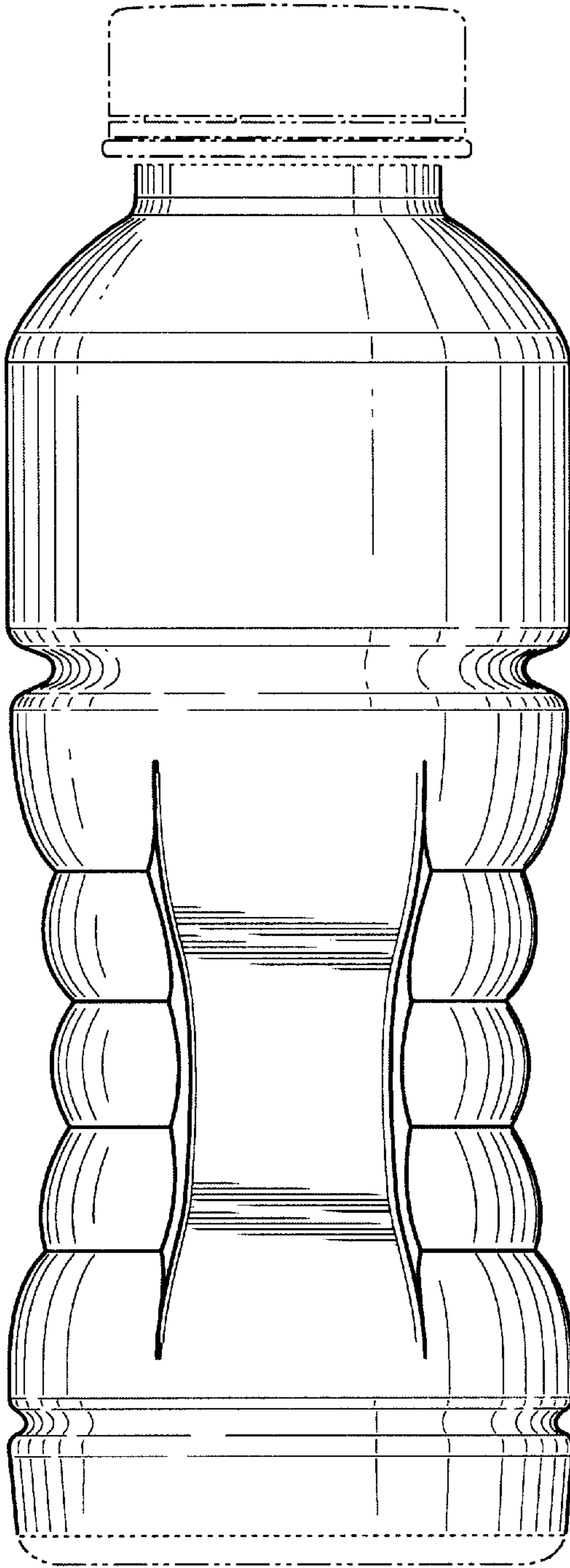




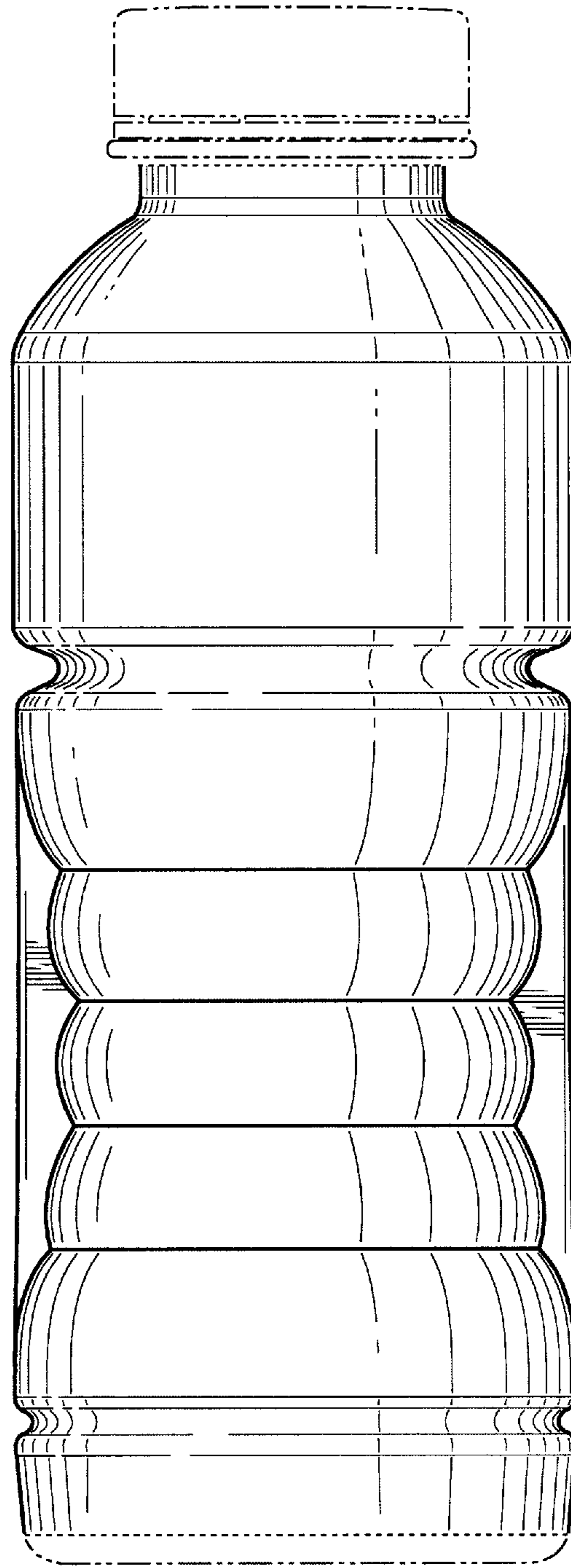
