The ornamental design for a contoured container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view taken from the top and front of the contoured container;

FIG. 2 is a front elevation view of the contoured container of FIG. 1;

FIG. 3 is a back elevation view of the contoured container of FIG. 1;

FIG. 4 is a left side elevation view of the contoured container of FIG. 1;

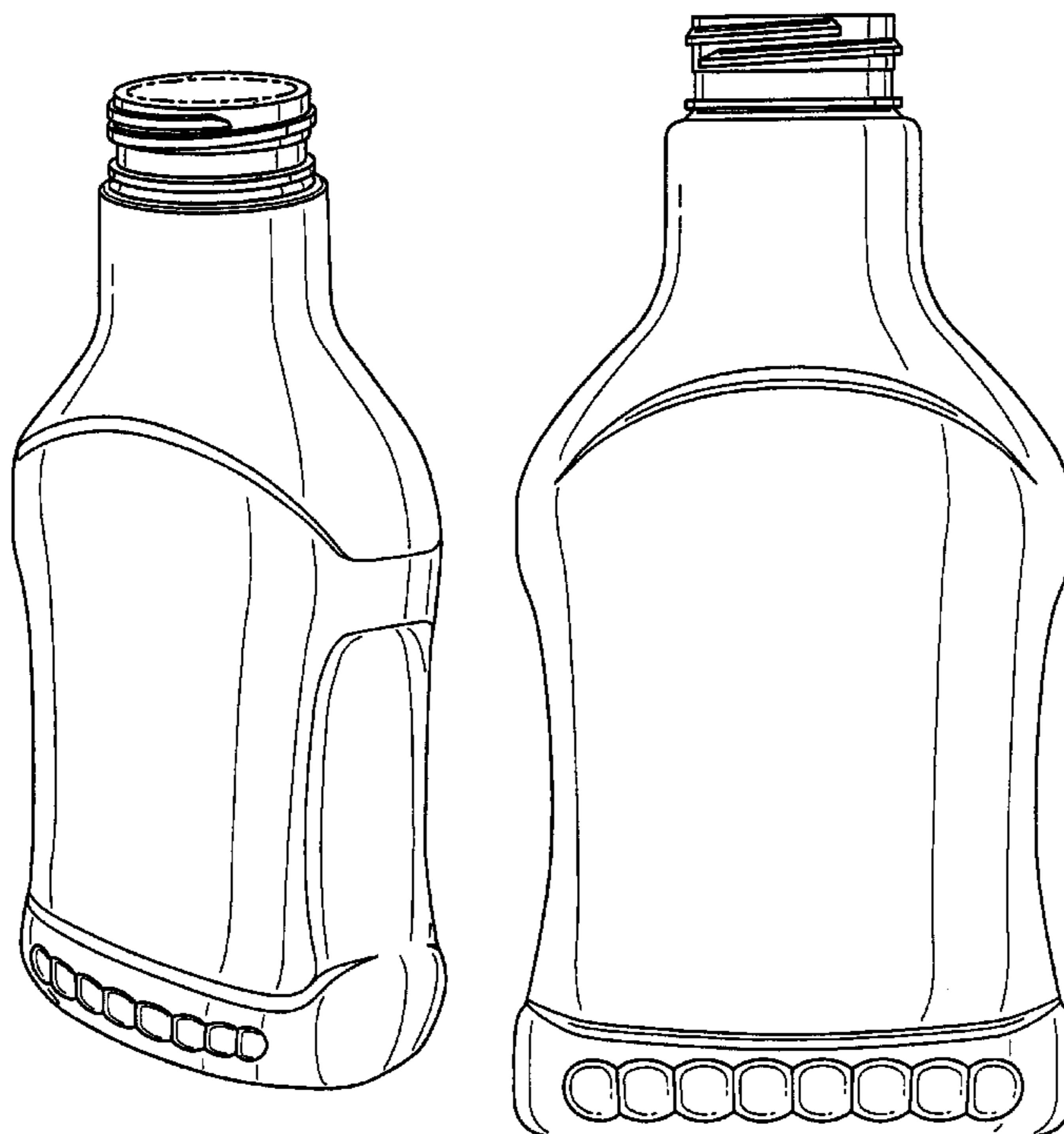
FIG. 5 is a right side elevation view of the contoured container of FIG. 1

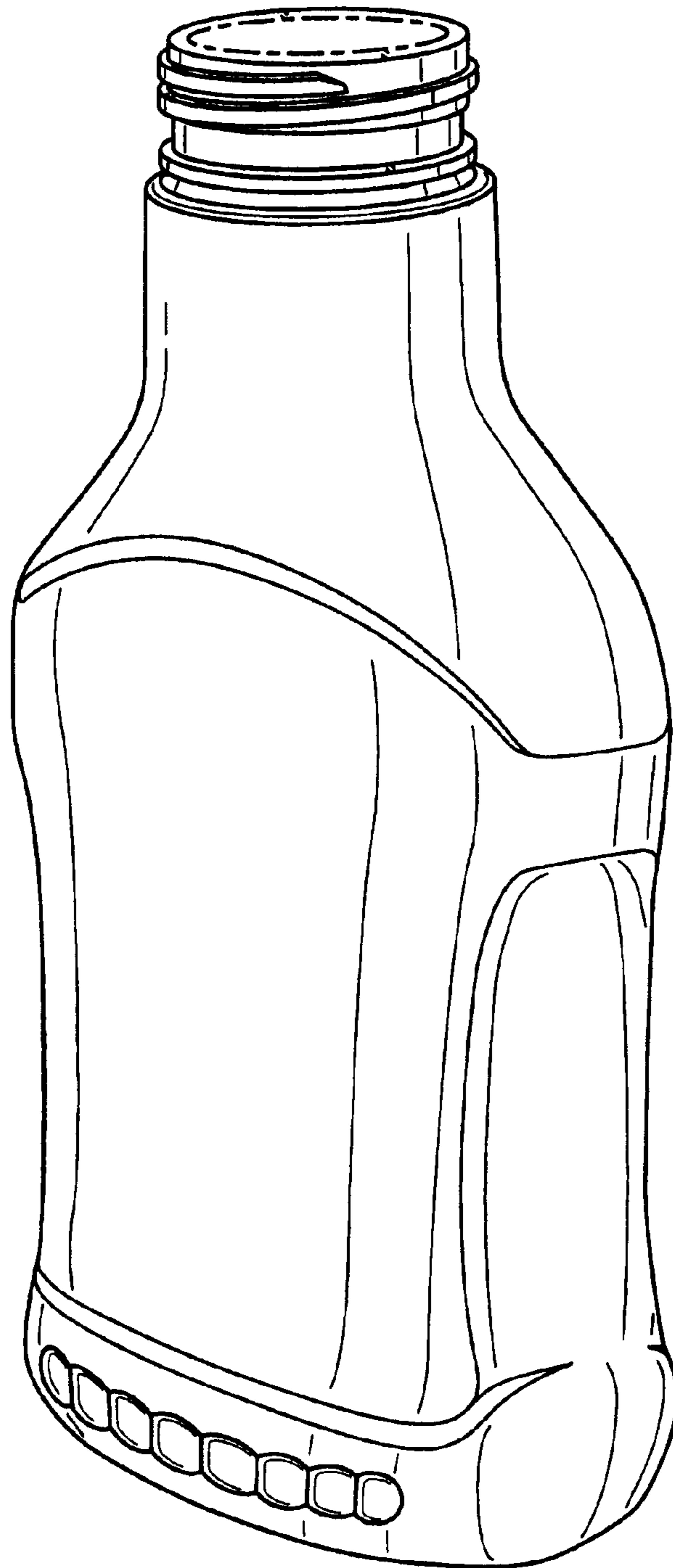

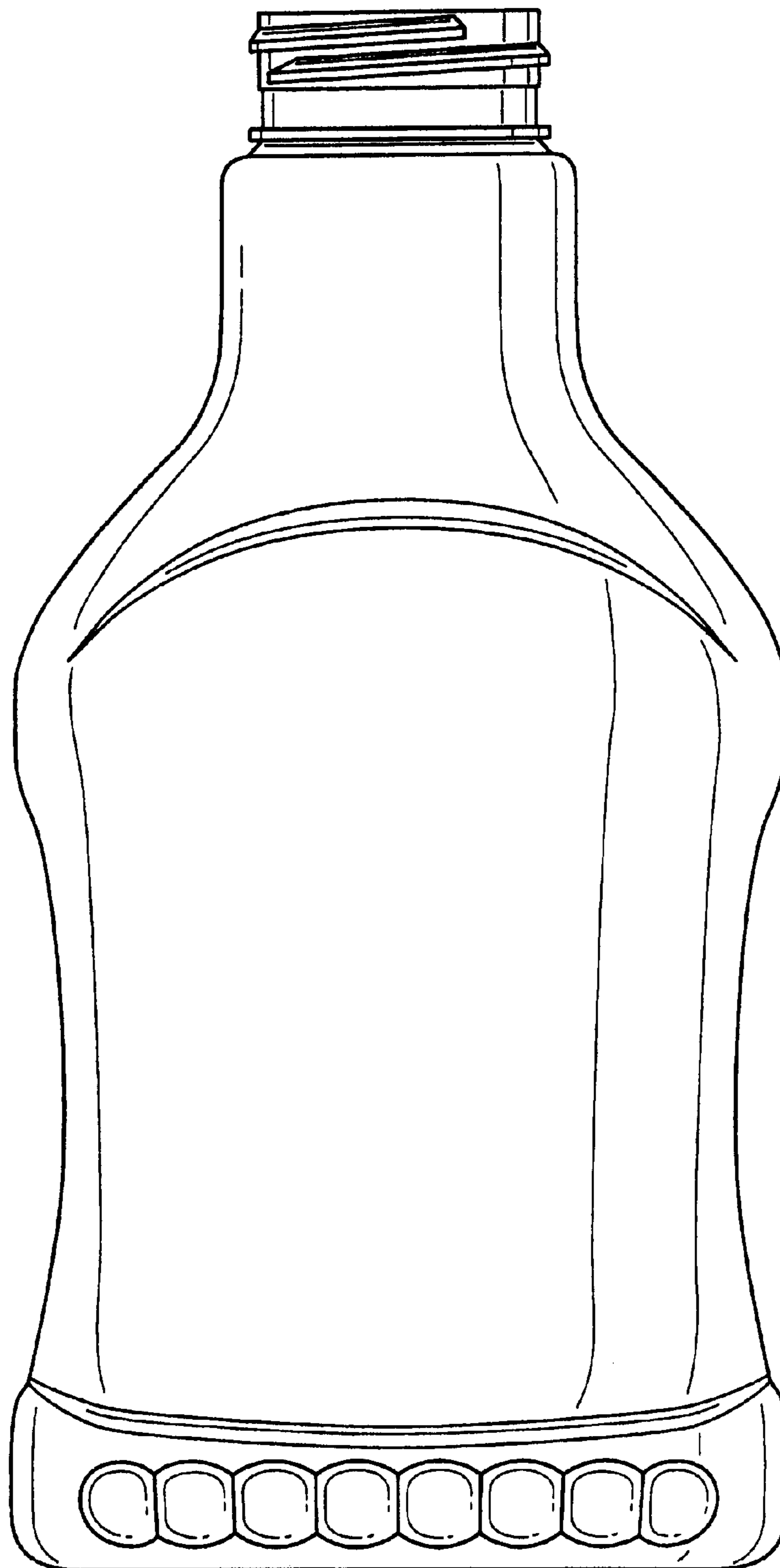

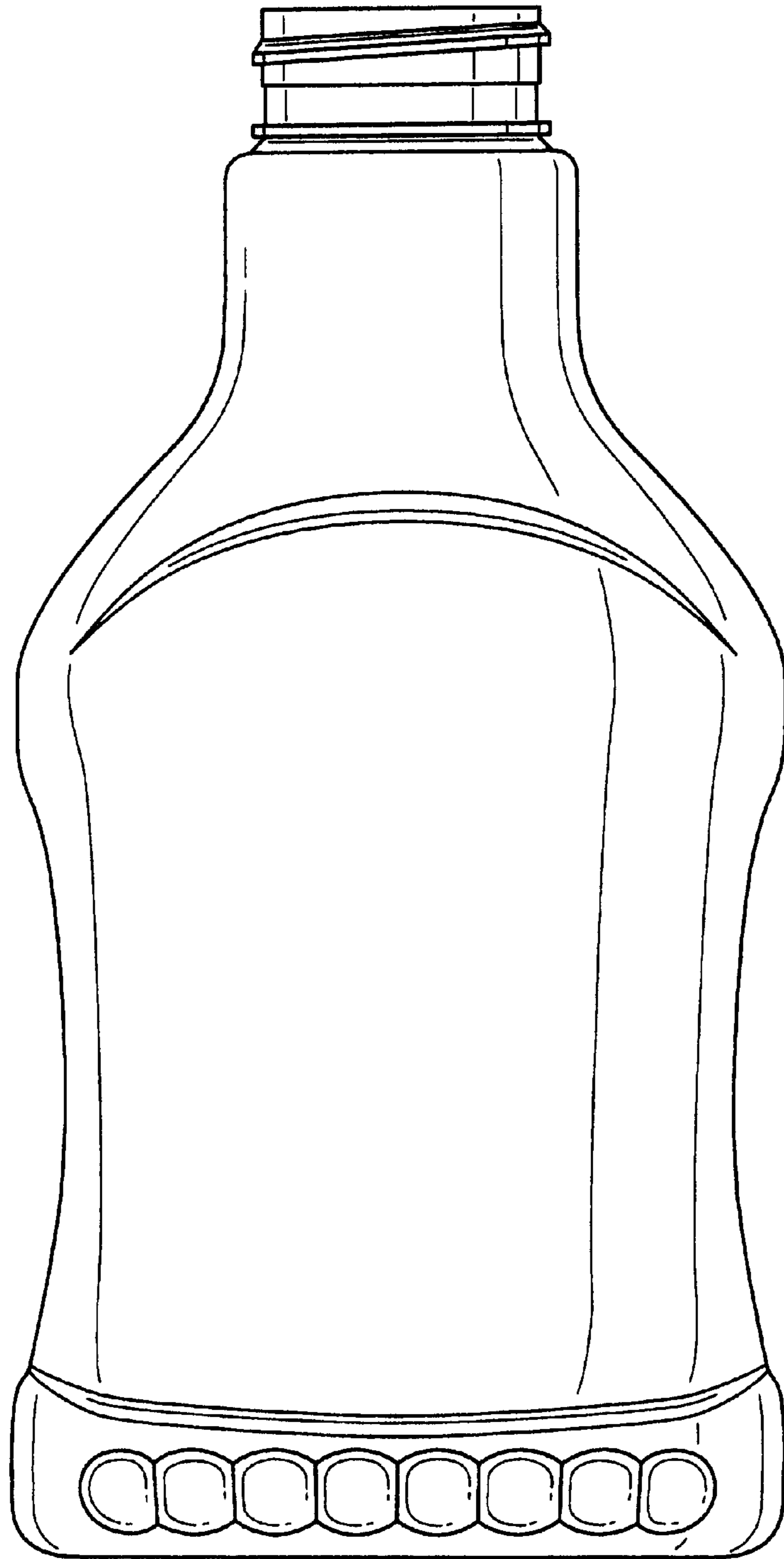

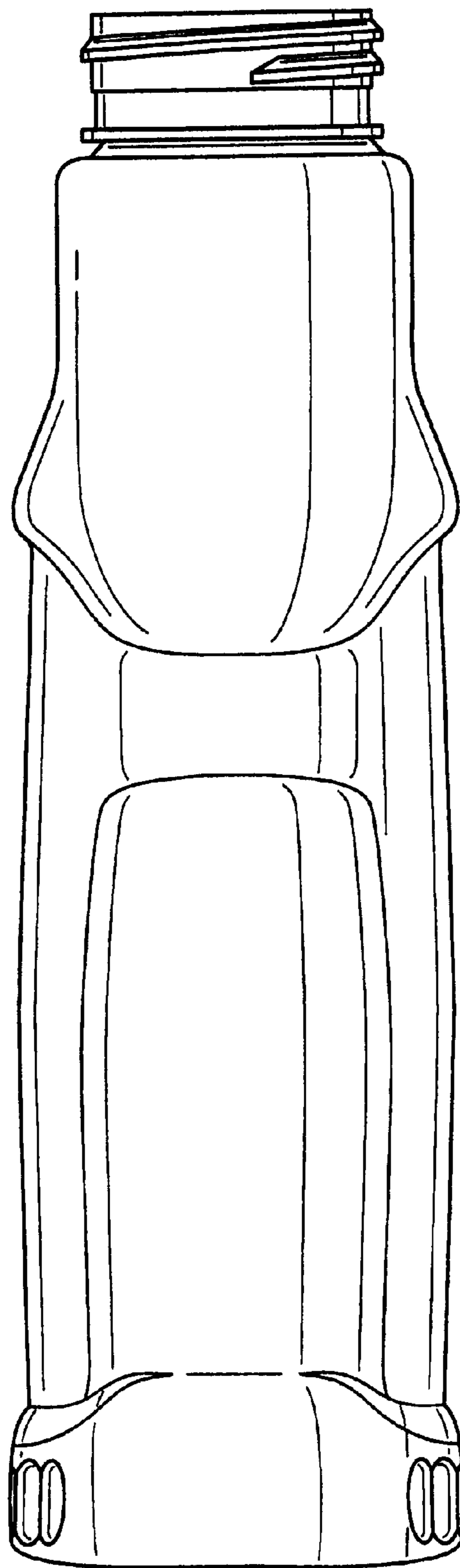

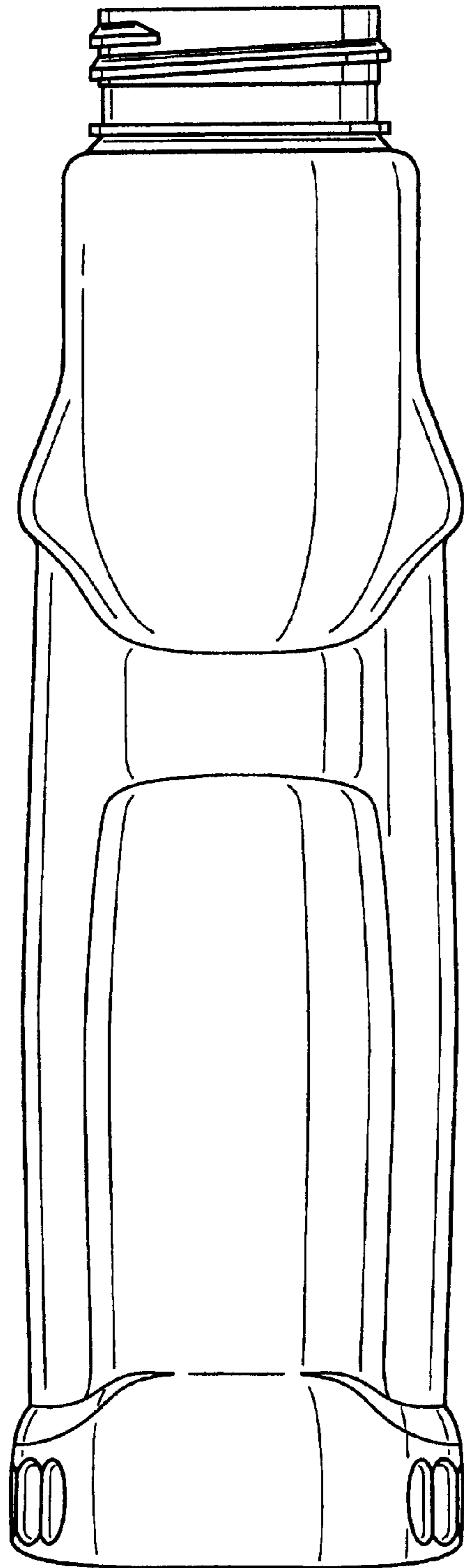

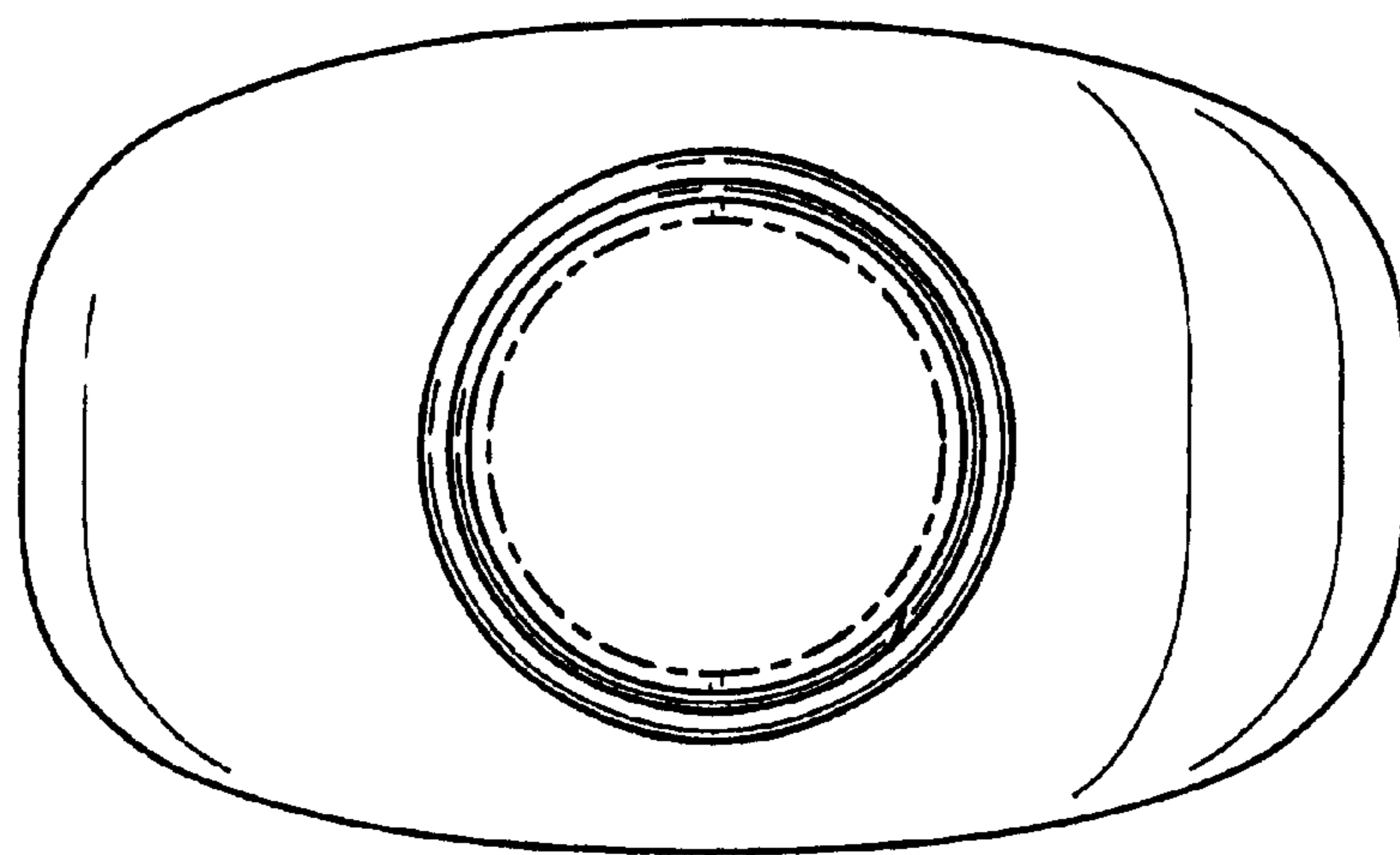

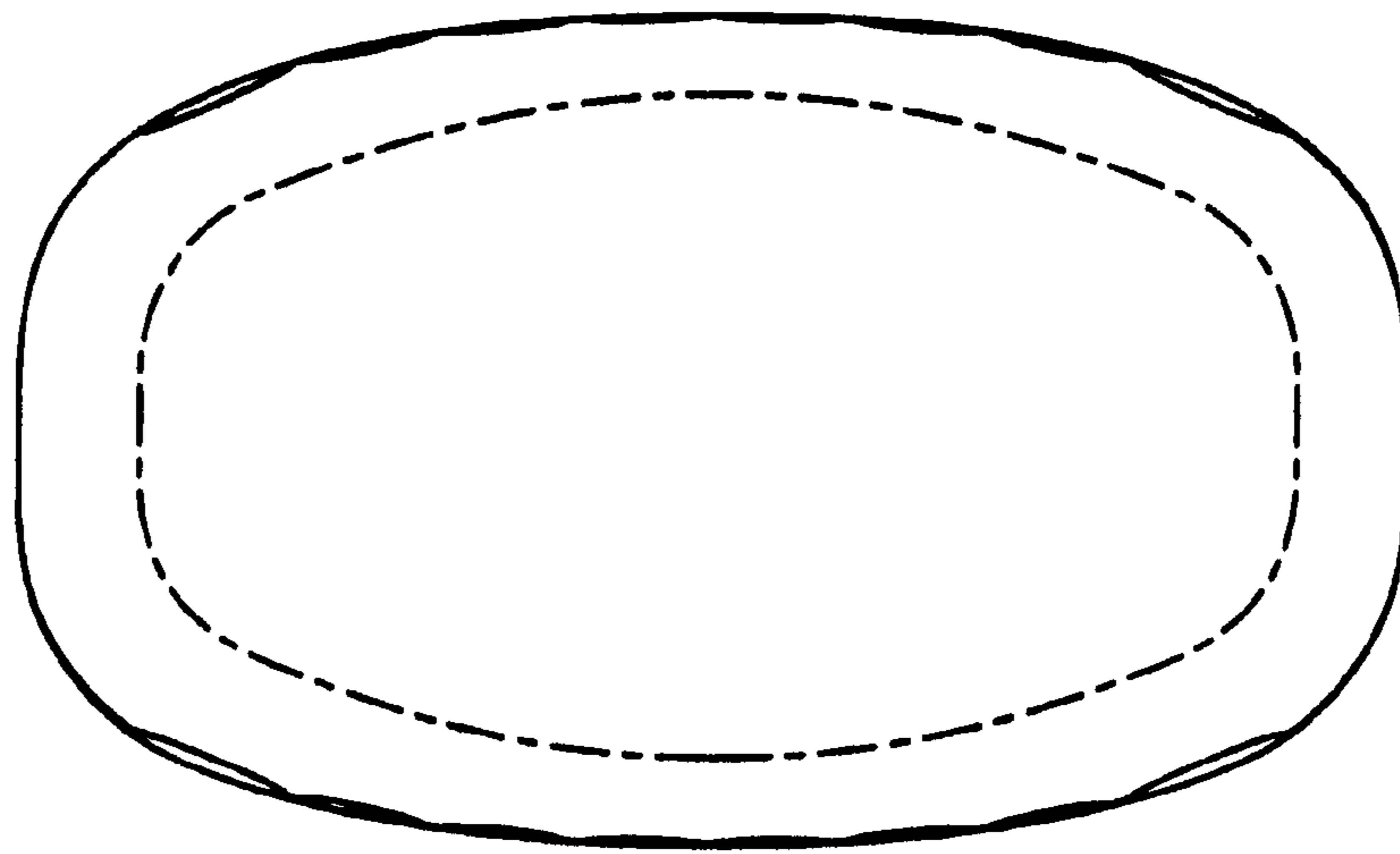
