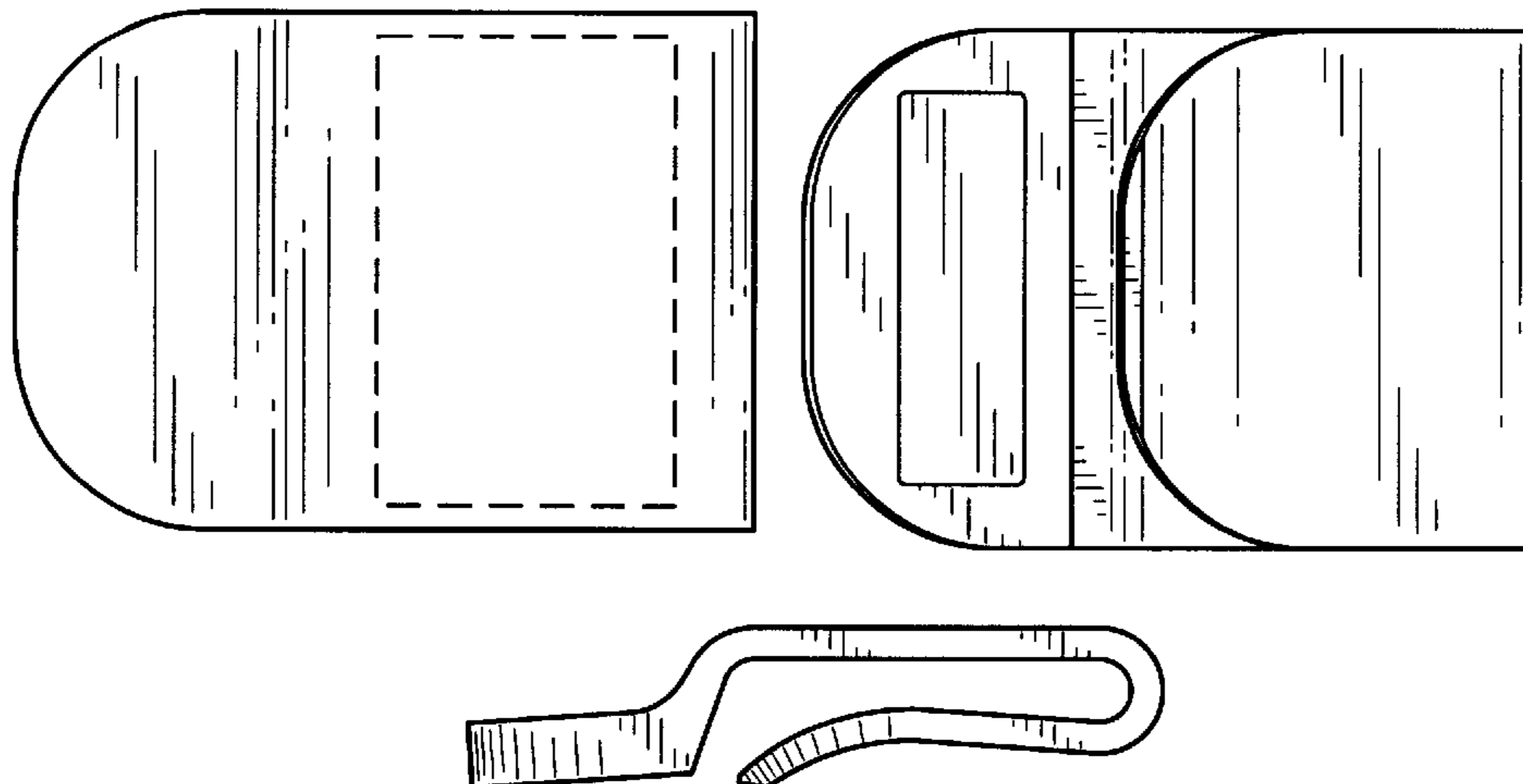
(57) **CLAIM**

The ornamental design for a pencil holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of the pencil holder.  
 FIG. 2 is a bottom plan view of the pencil holder.  
 FIG. 3 is a left side elevation view of the pencil holder, the right side being a mirror image thereof.  
 FIG. 4 is a front elevation view of the pencil holder; and,  
 FIG. 5 is a back elevation view of the pencil holder.  
 The broken lines showing environment in the drawings are for information purposes only and form no part of the claimed design.

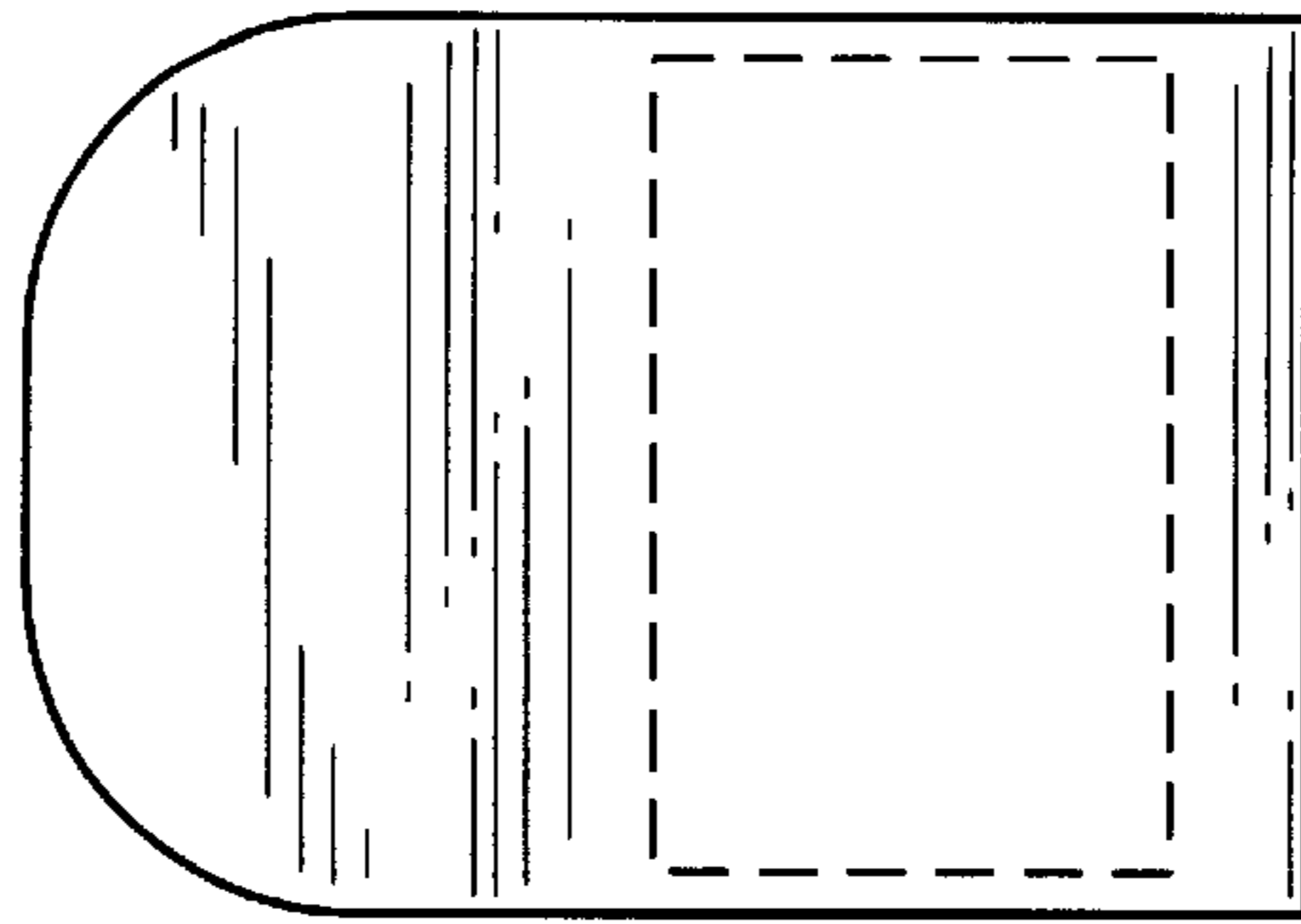

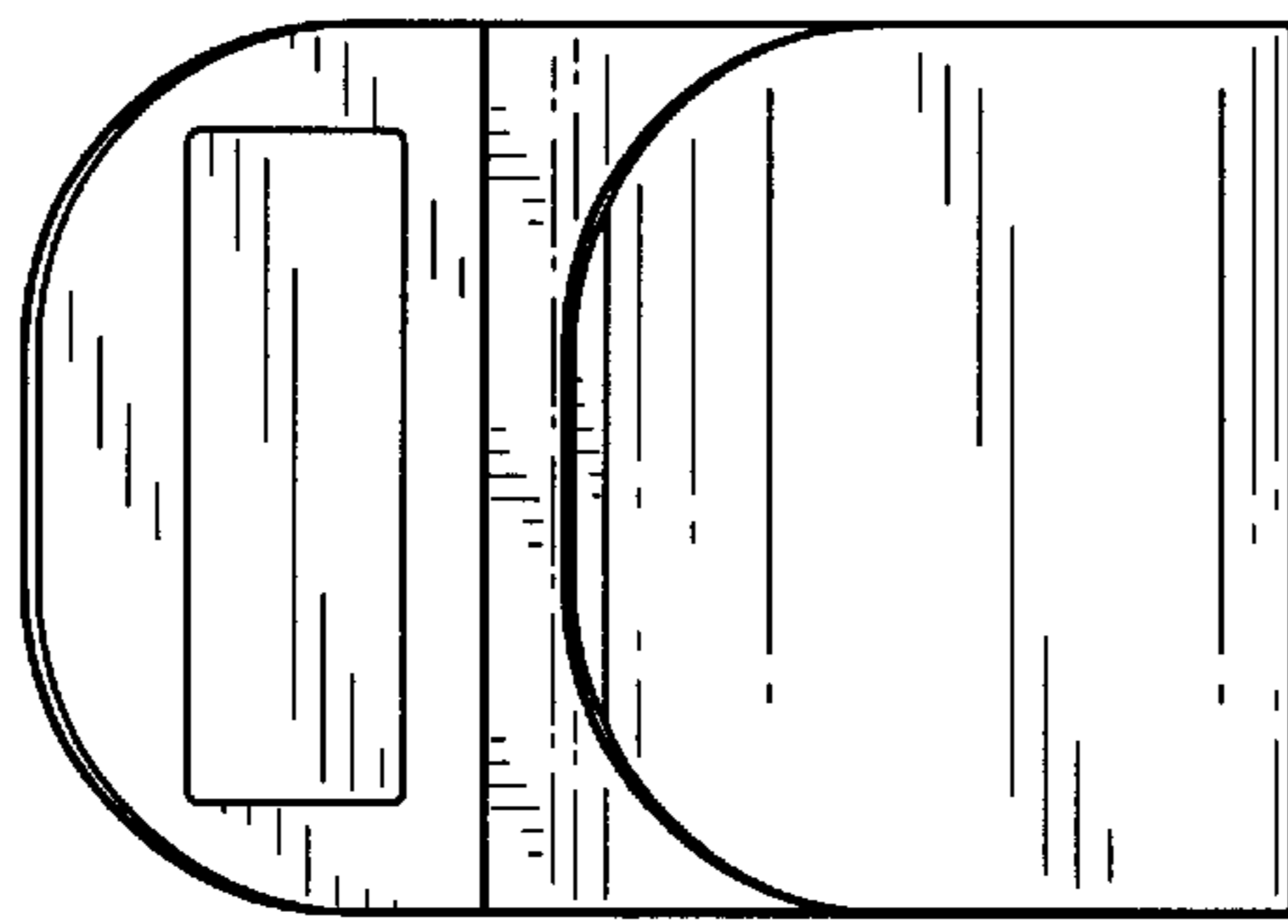

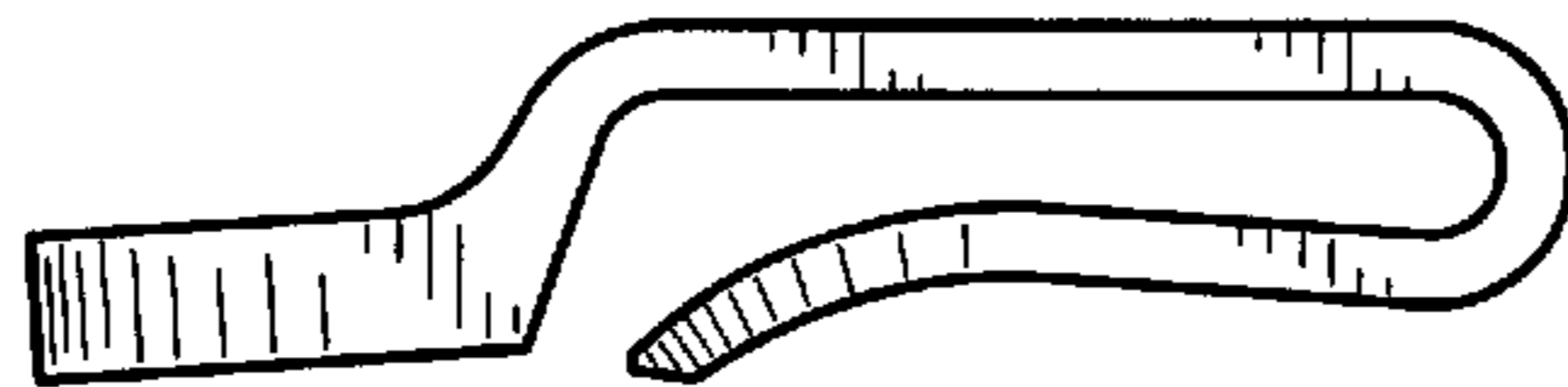
