FIG. 1 is a perspective view of the heart shaped decorative magnet showing my new design.

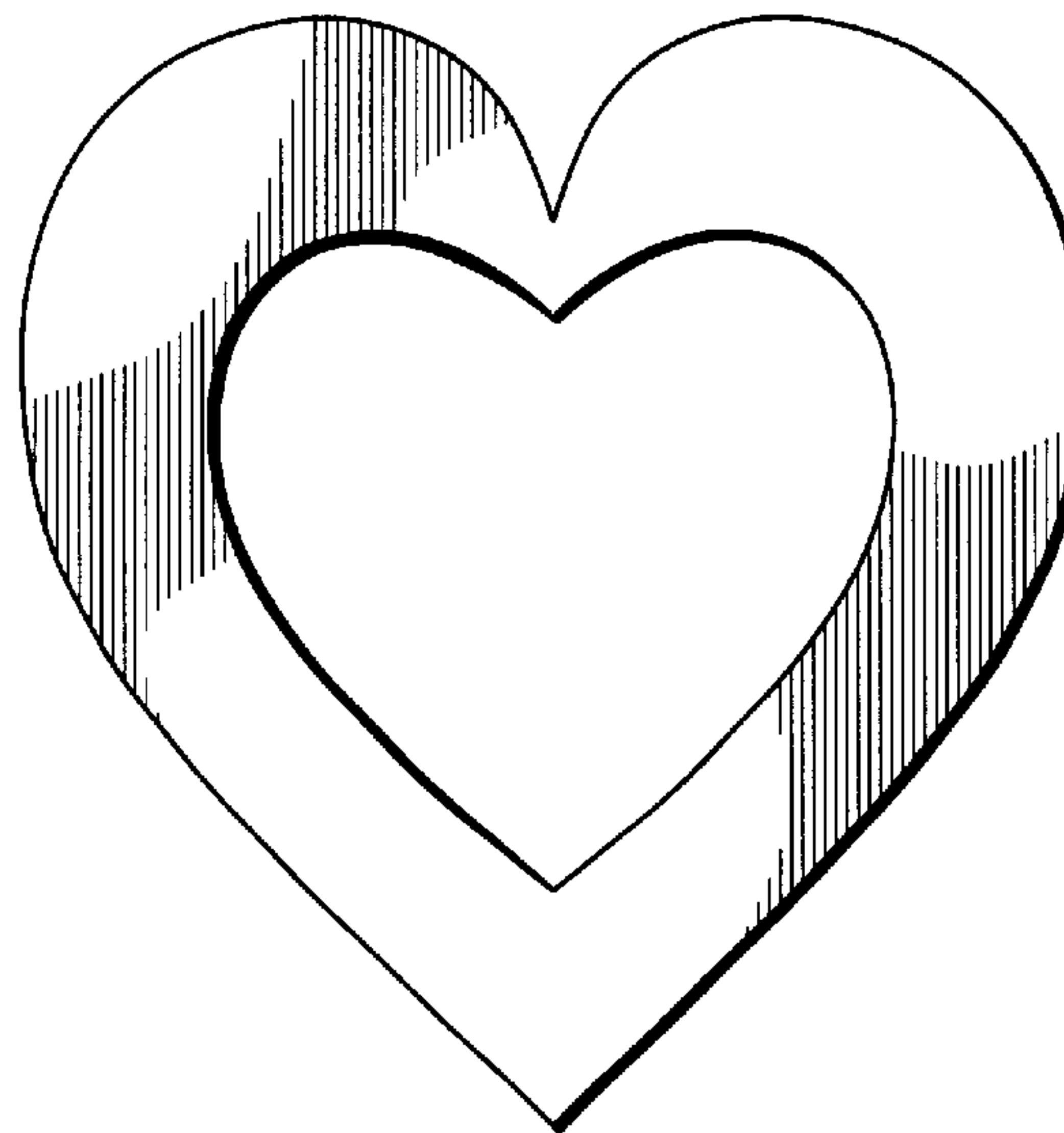
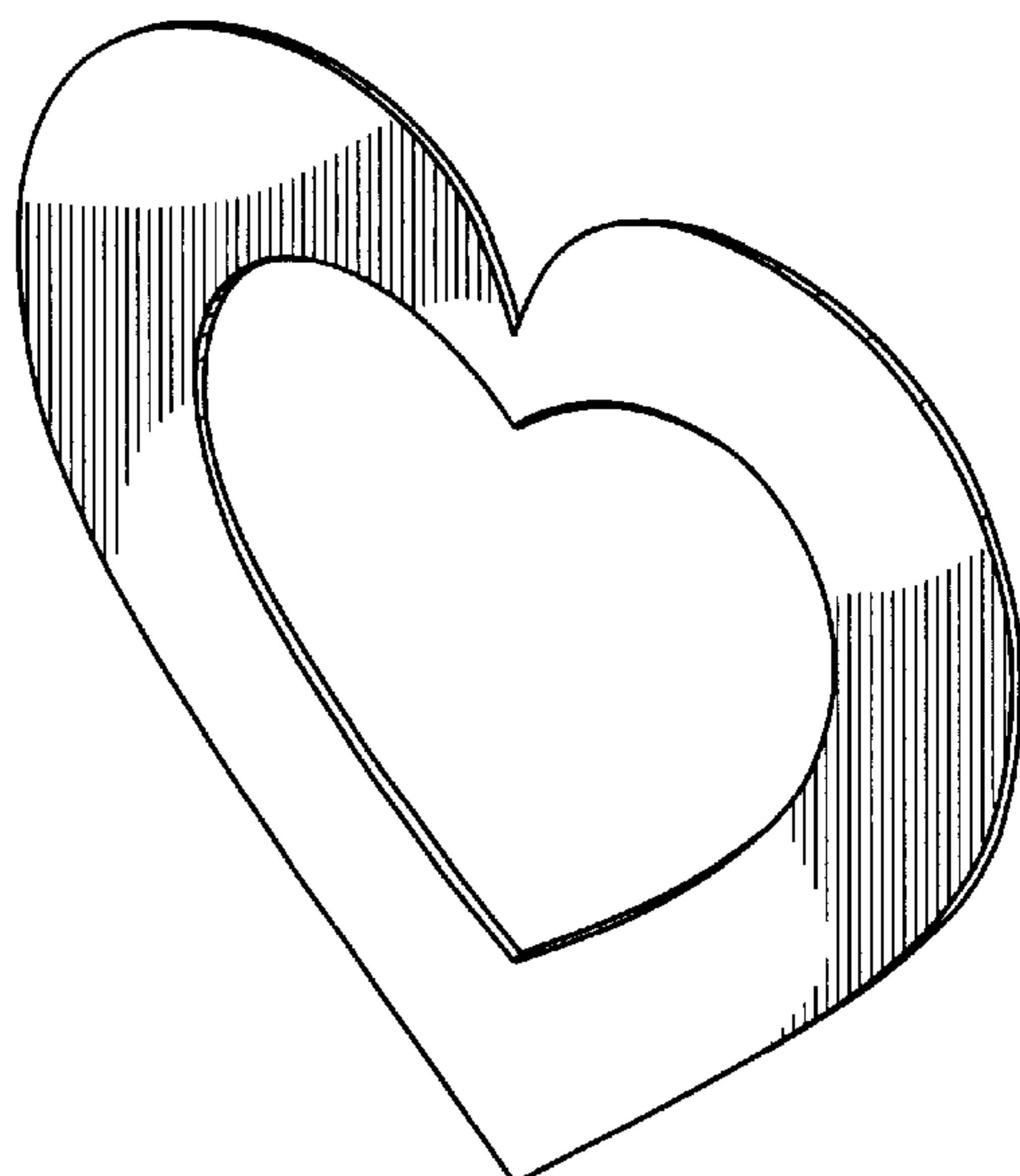
FIG. 2 is a front view, as well as a back view, of the heart shaped decorative magnet.

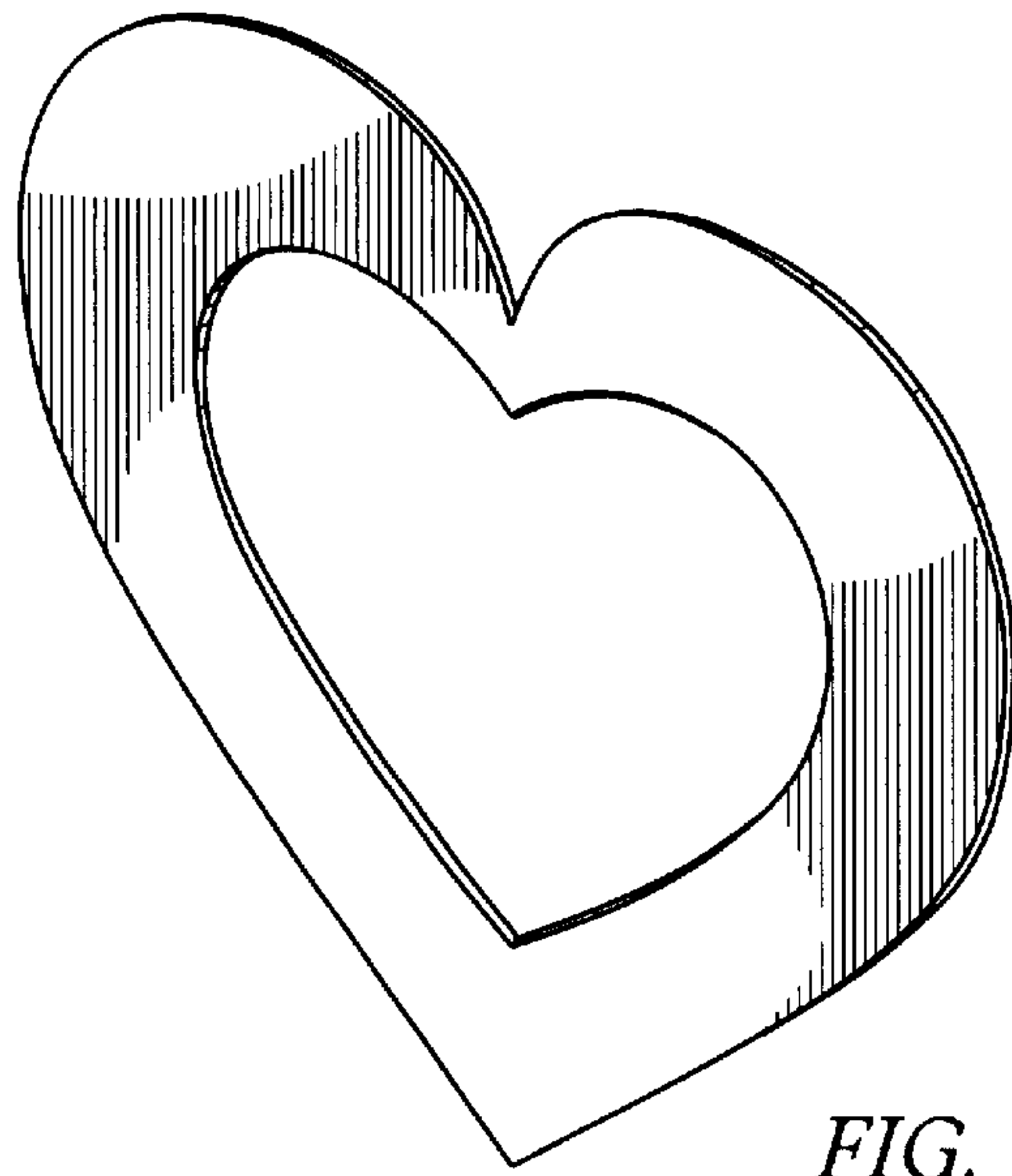

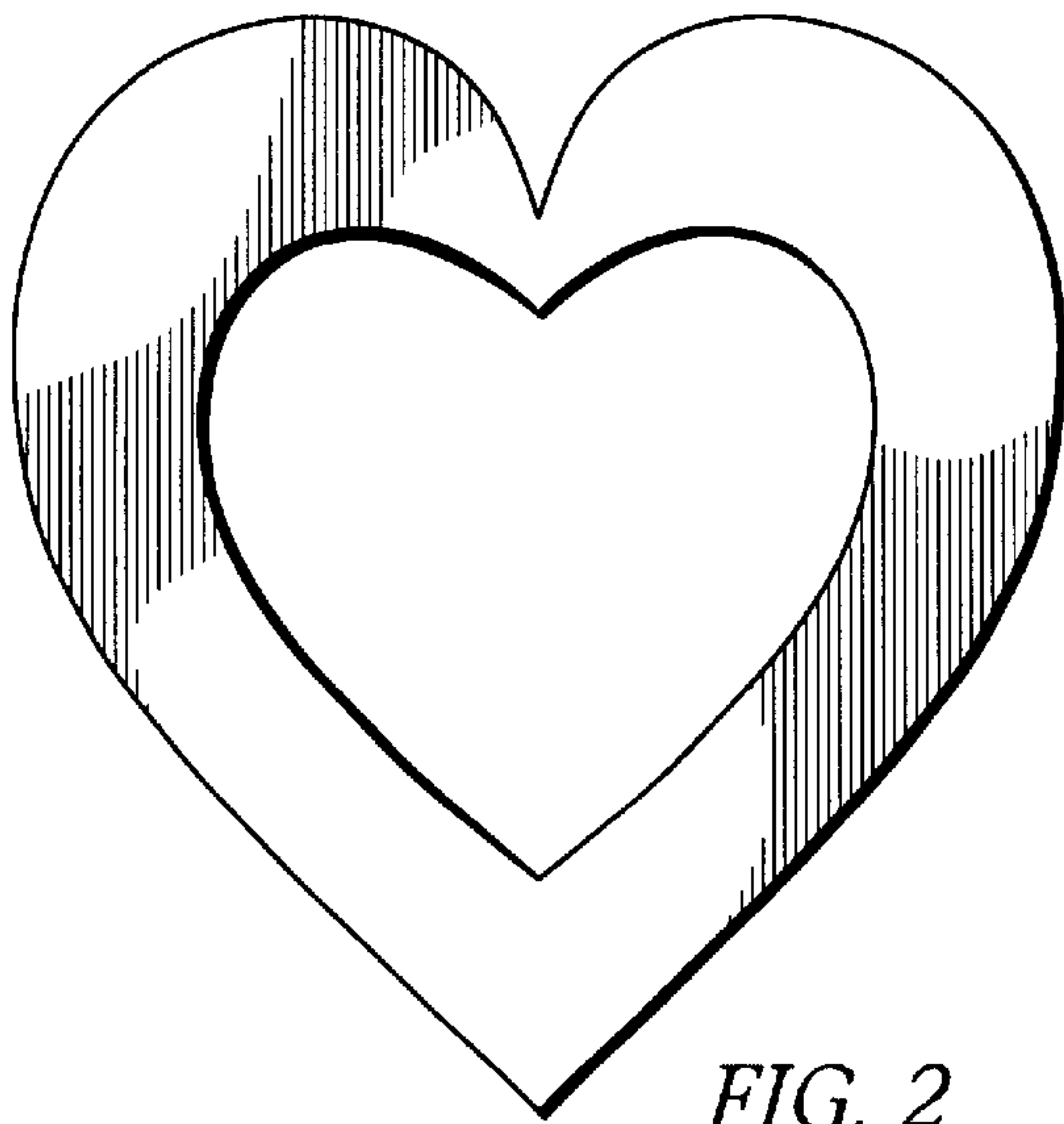
