The ornamental design for a football exhibiting an exterior waffle pattern, as shown and described.

DESCRIPTION

FIG. 1 is a left rear perspective view showing my new design;

FIG. 2 is a front view thereof;

FIG. 3 is a right end view thereof;

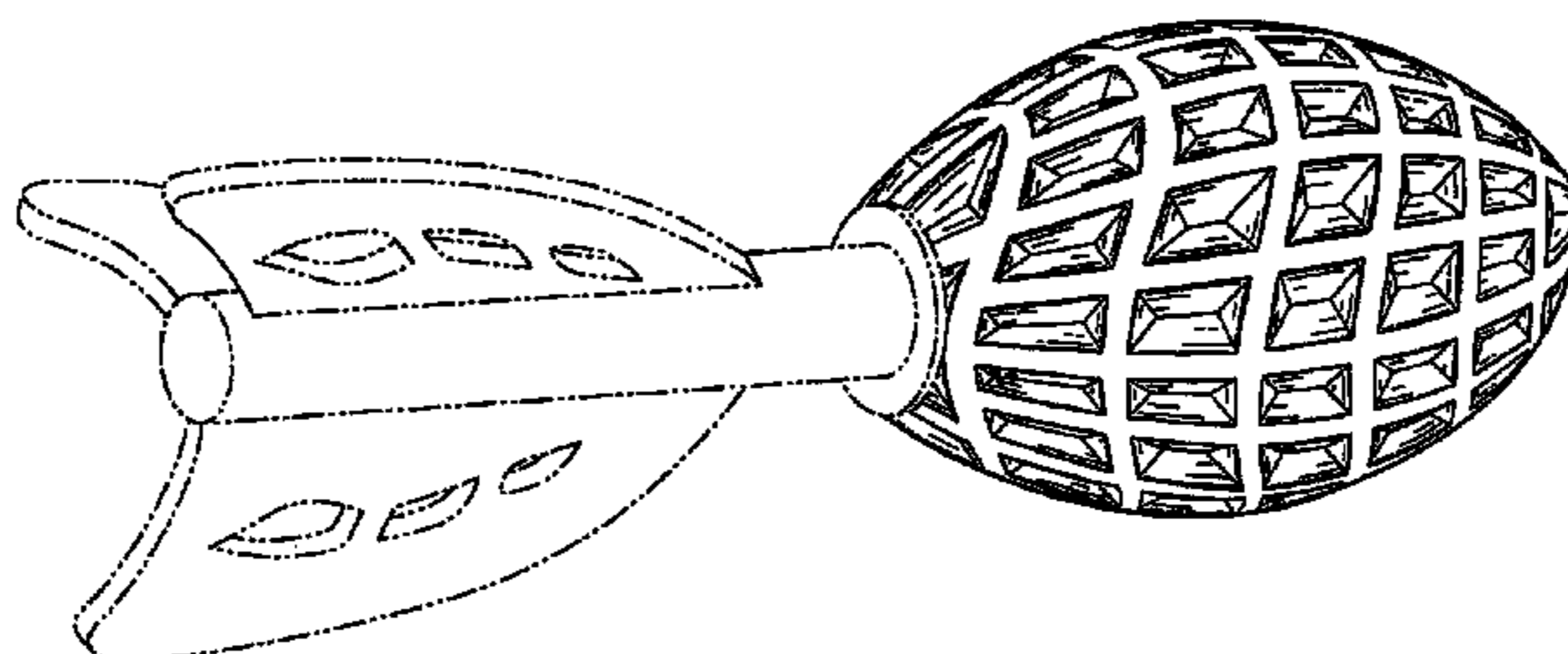
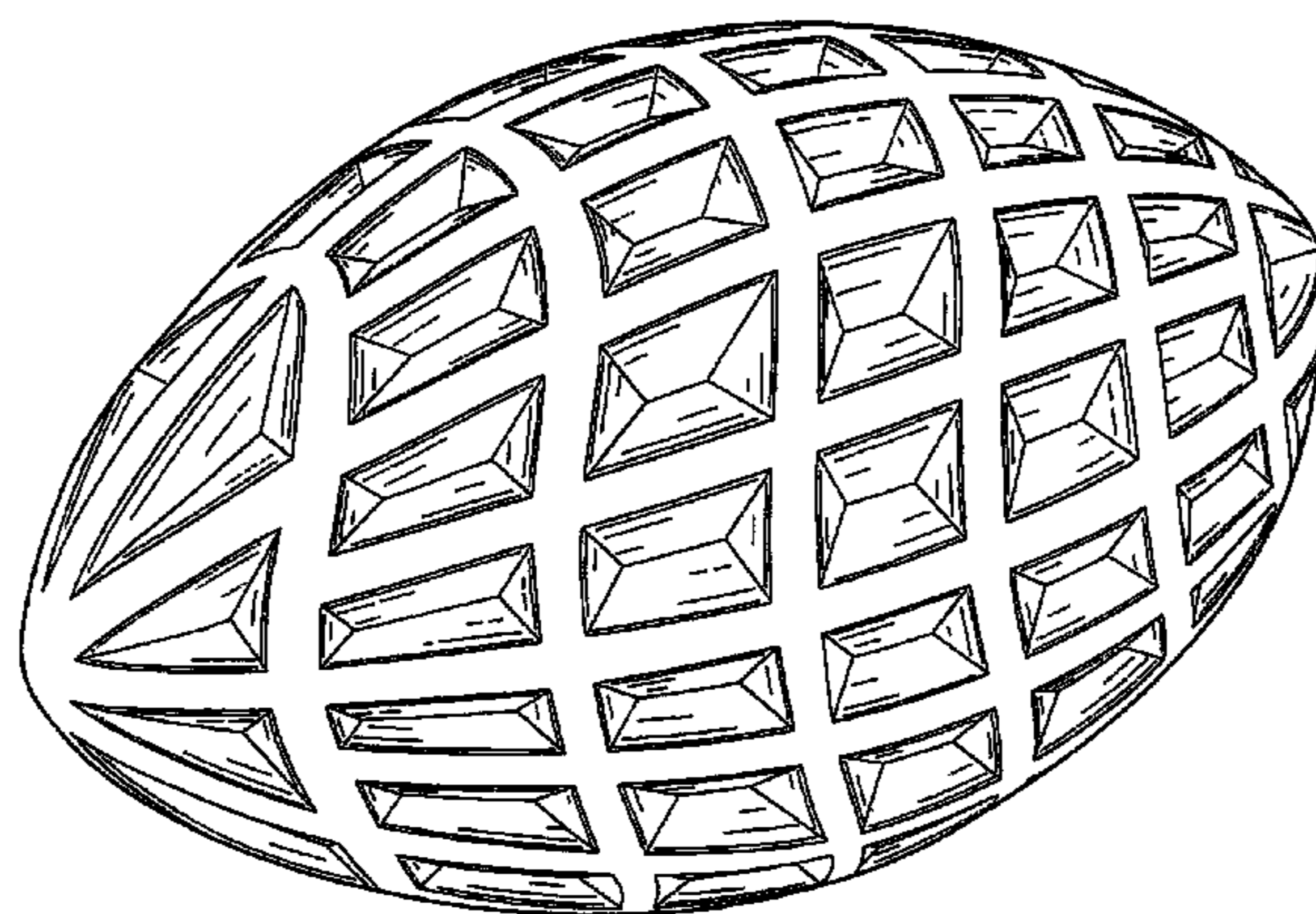
FIG. 4 is a rear view thereof;

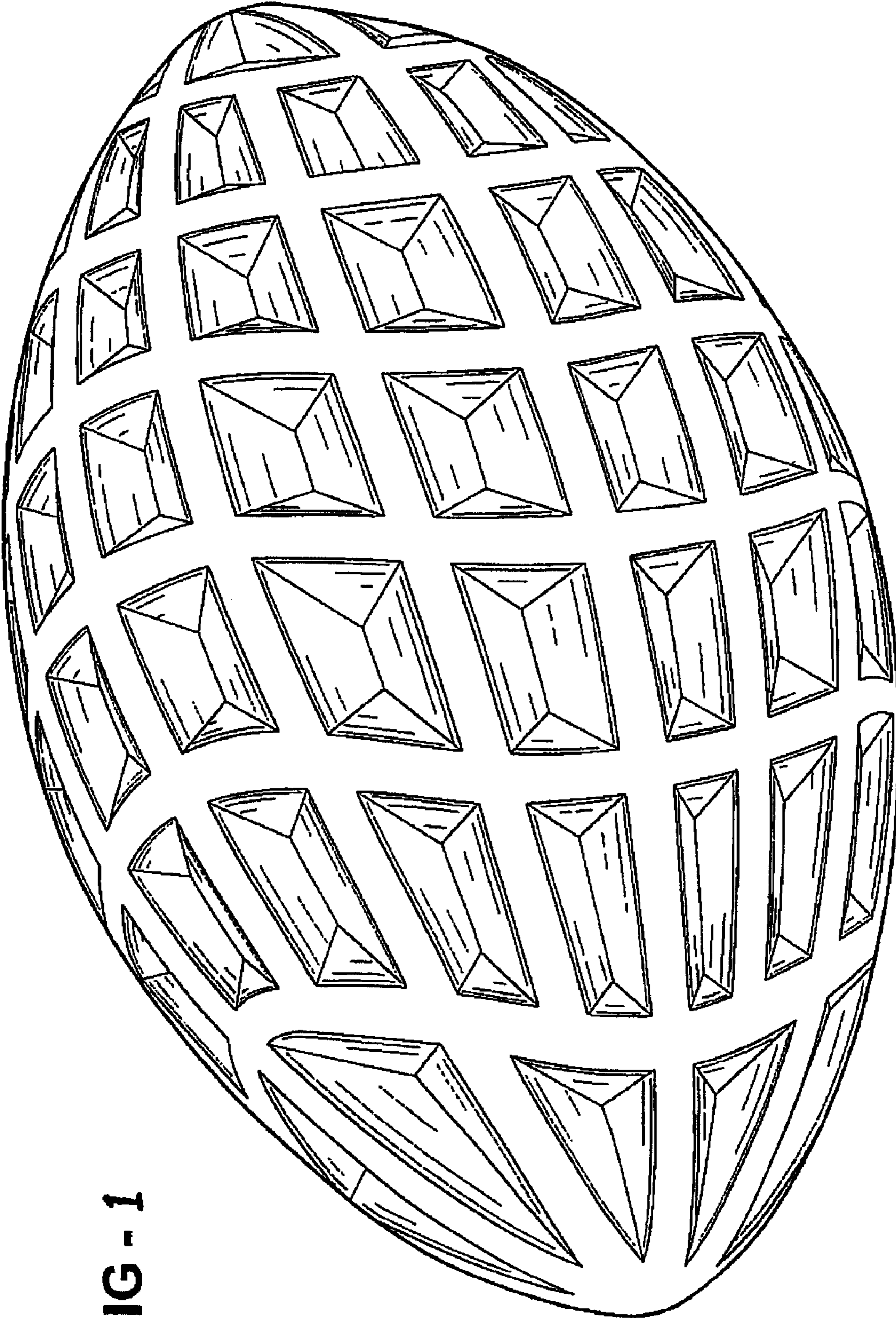

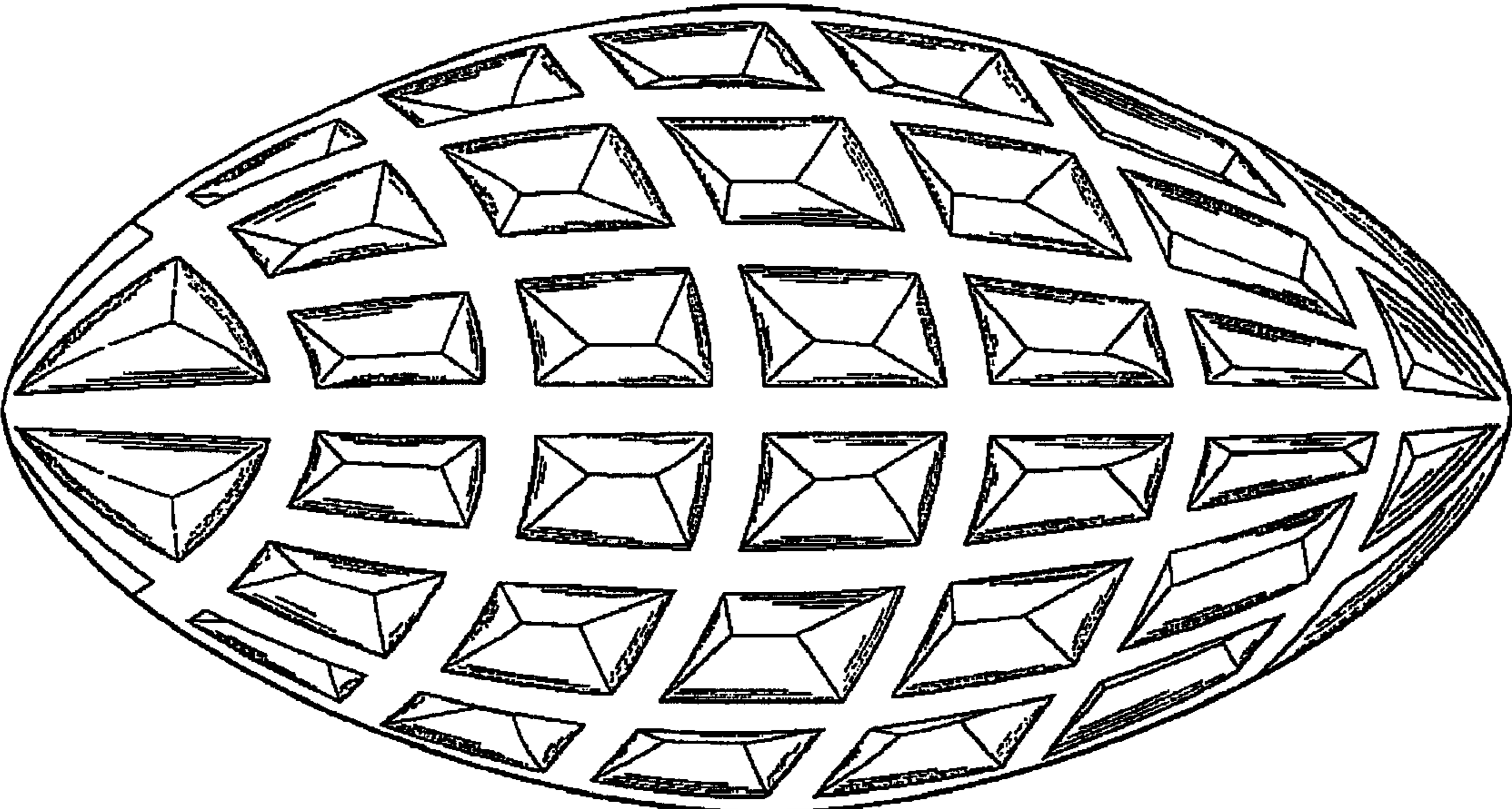
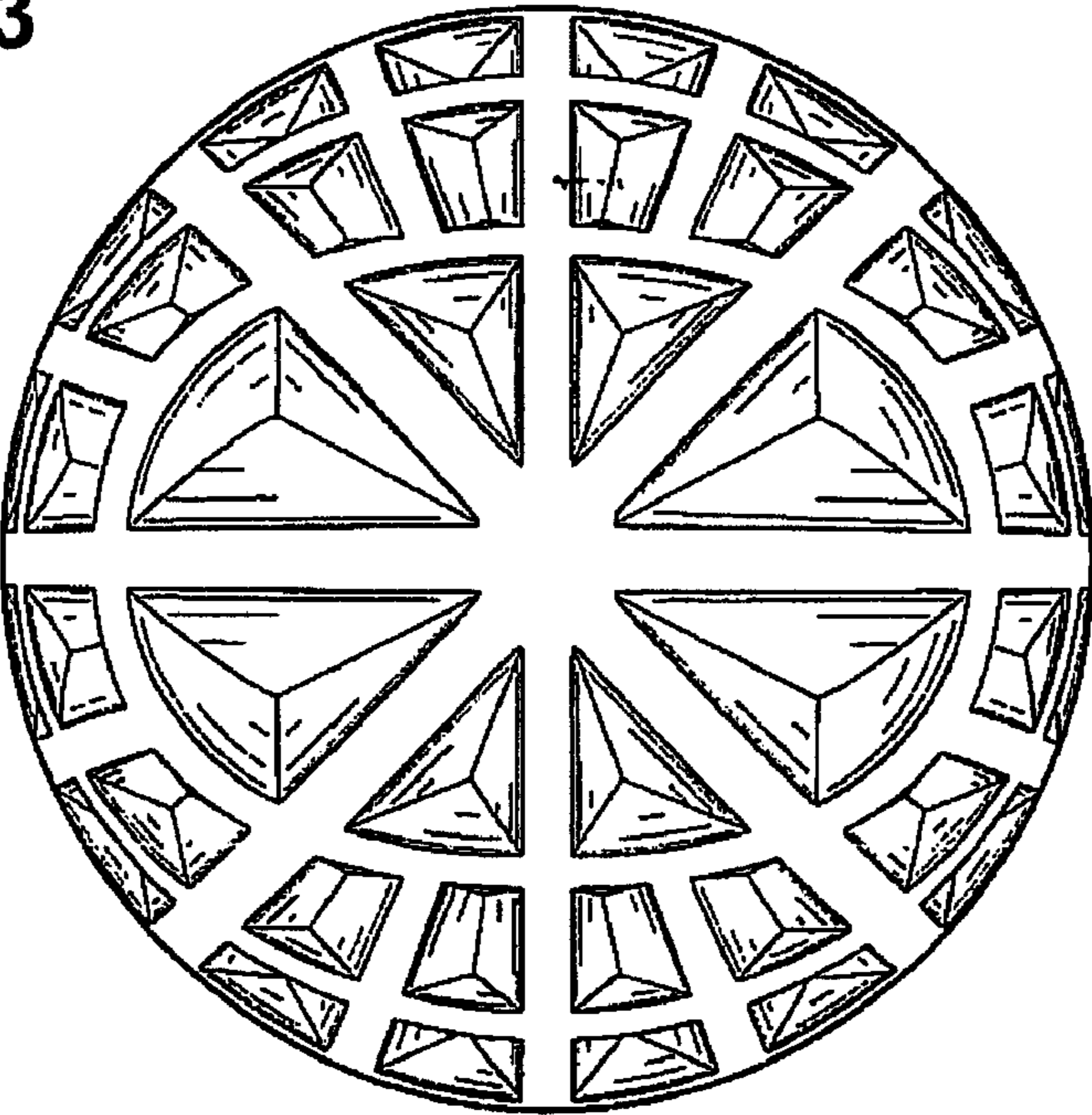

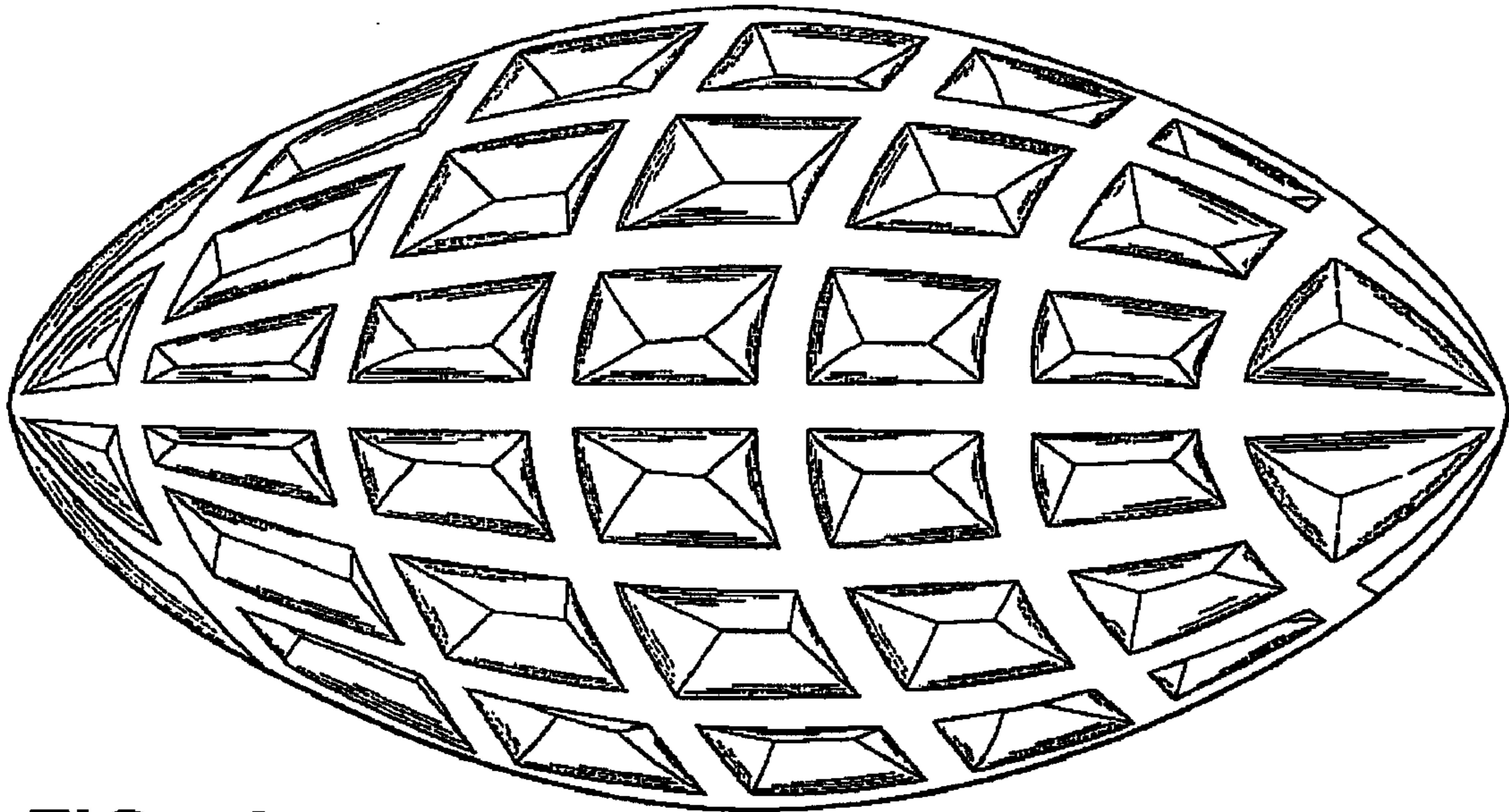
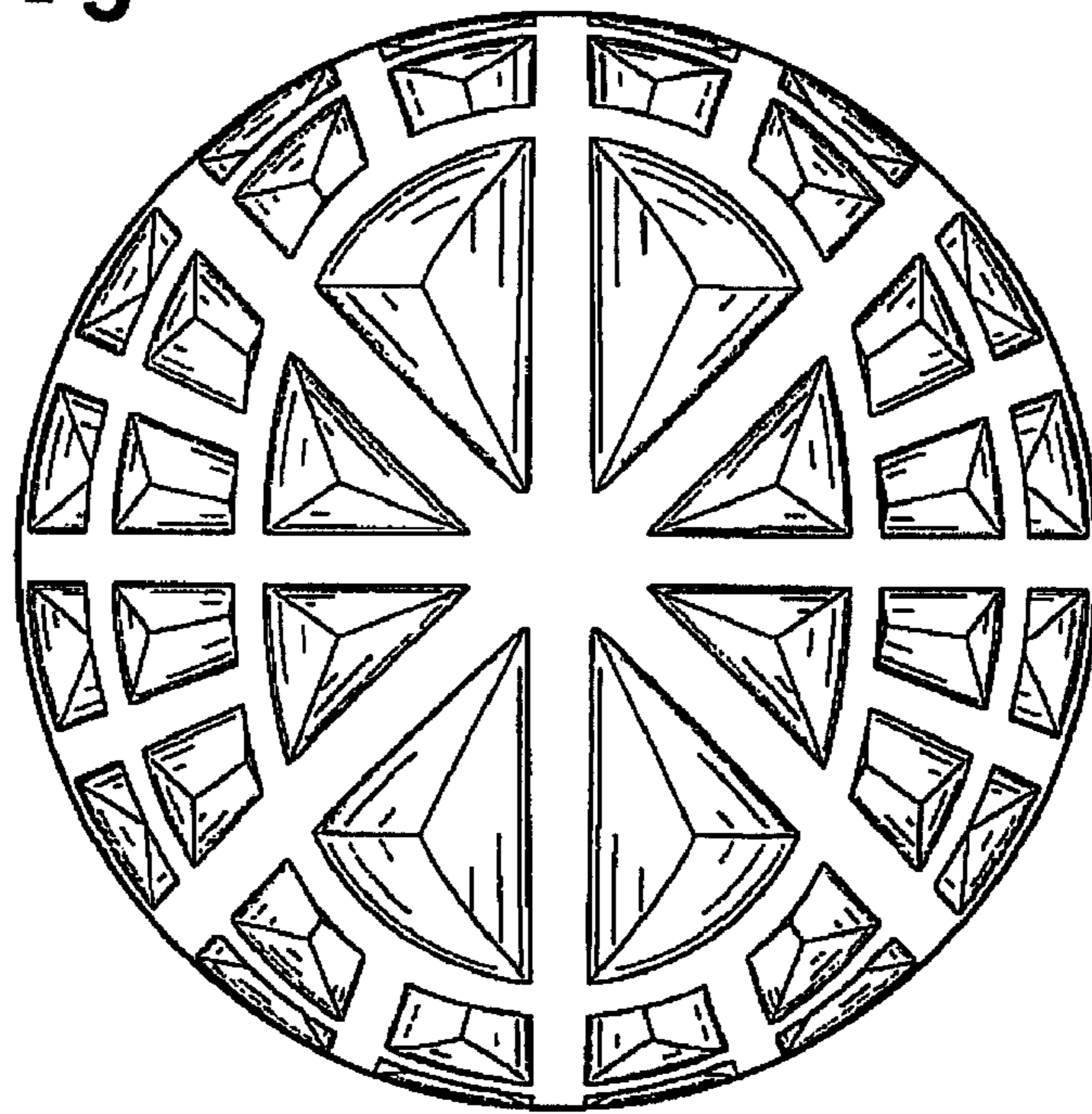

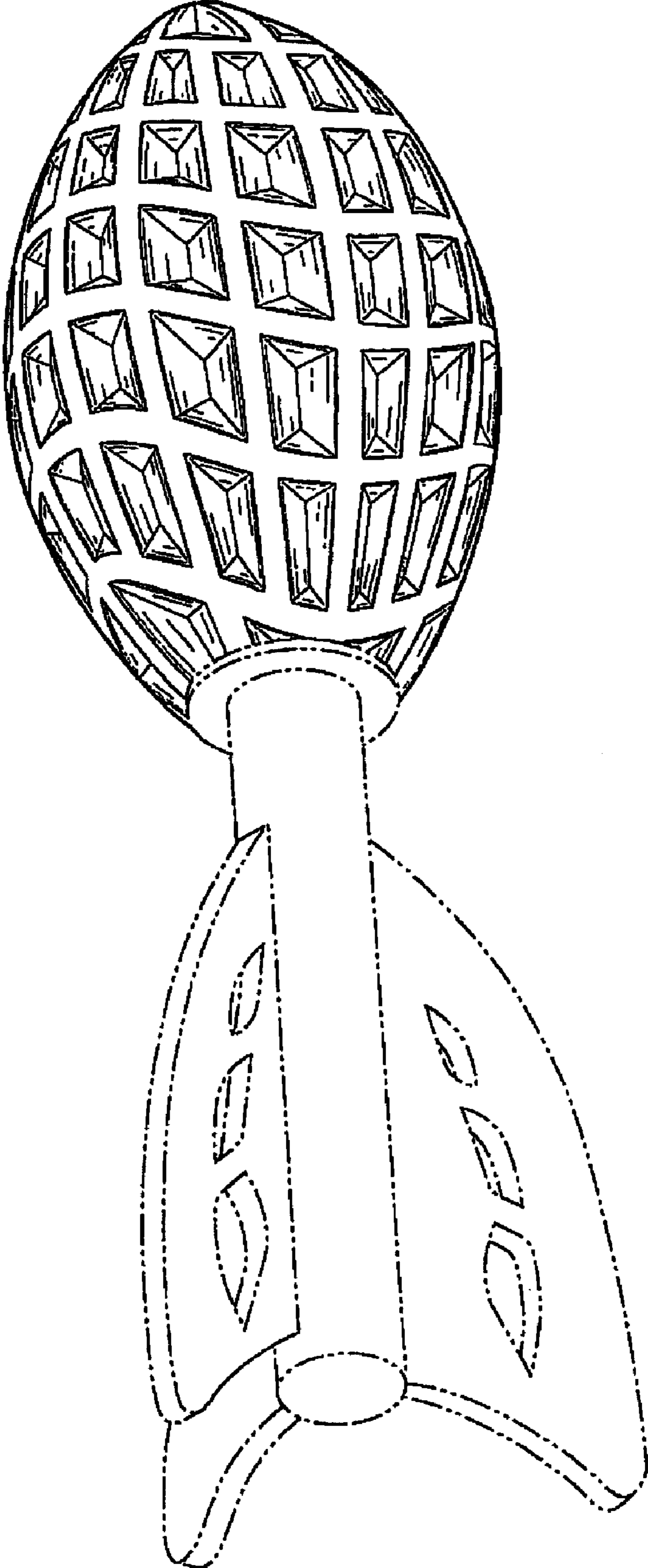
