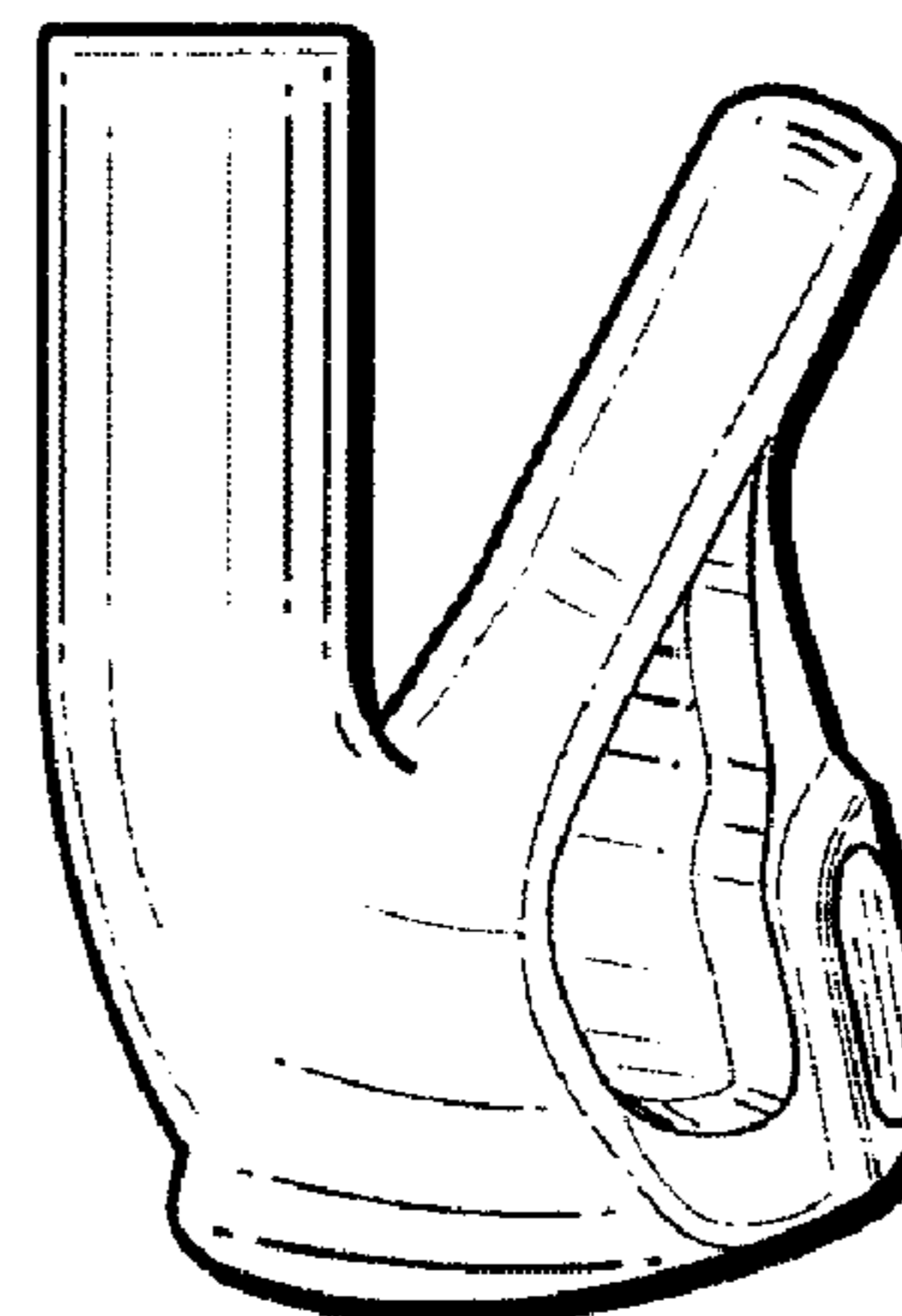
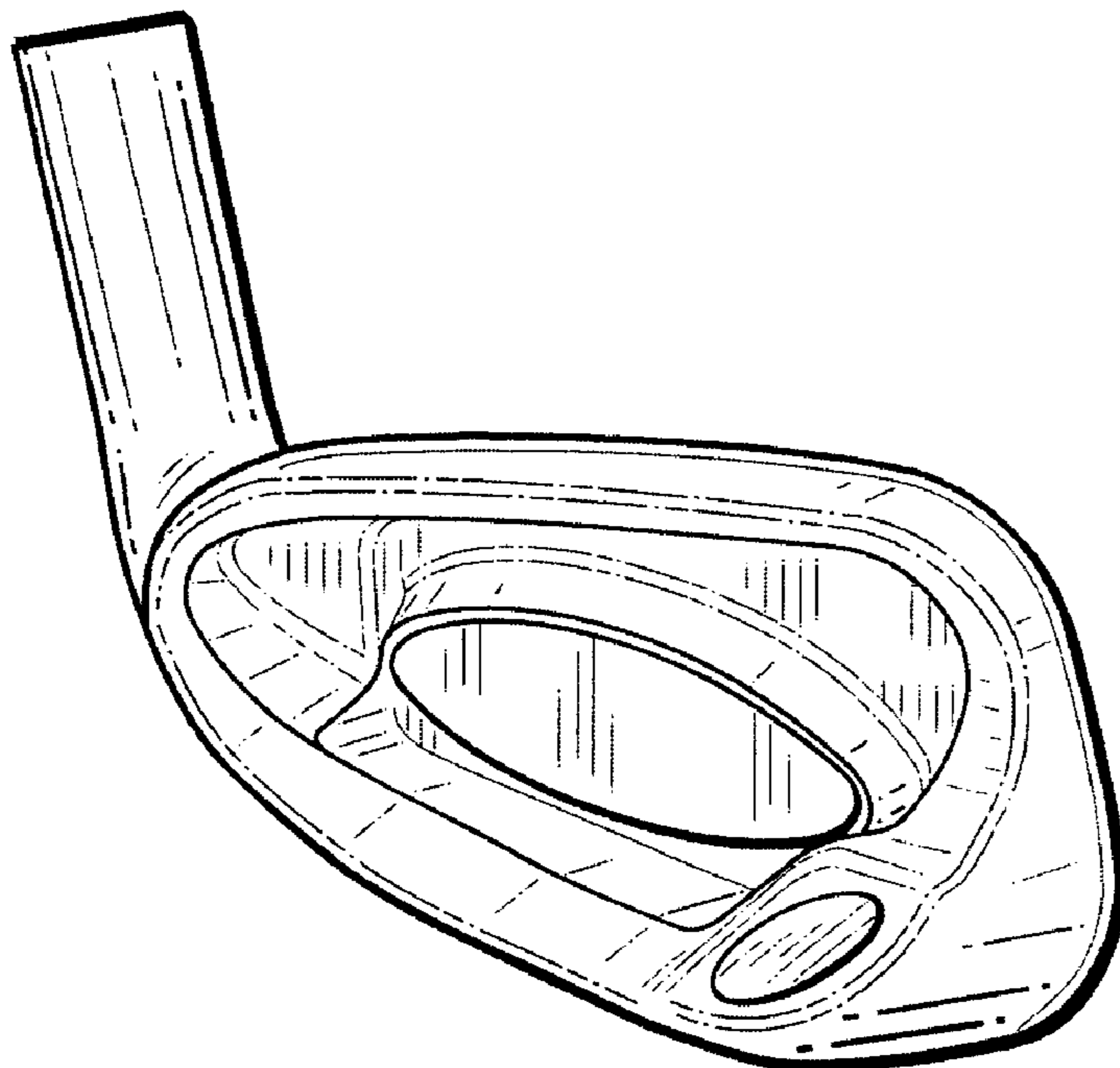

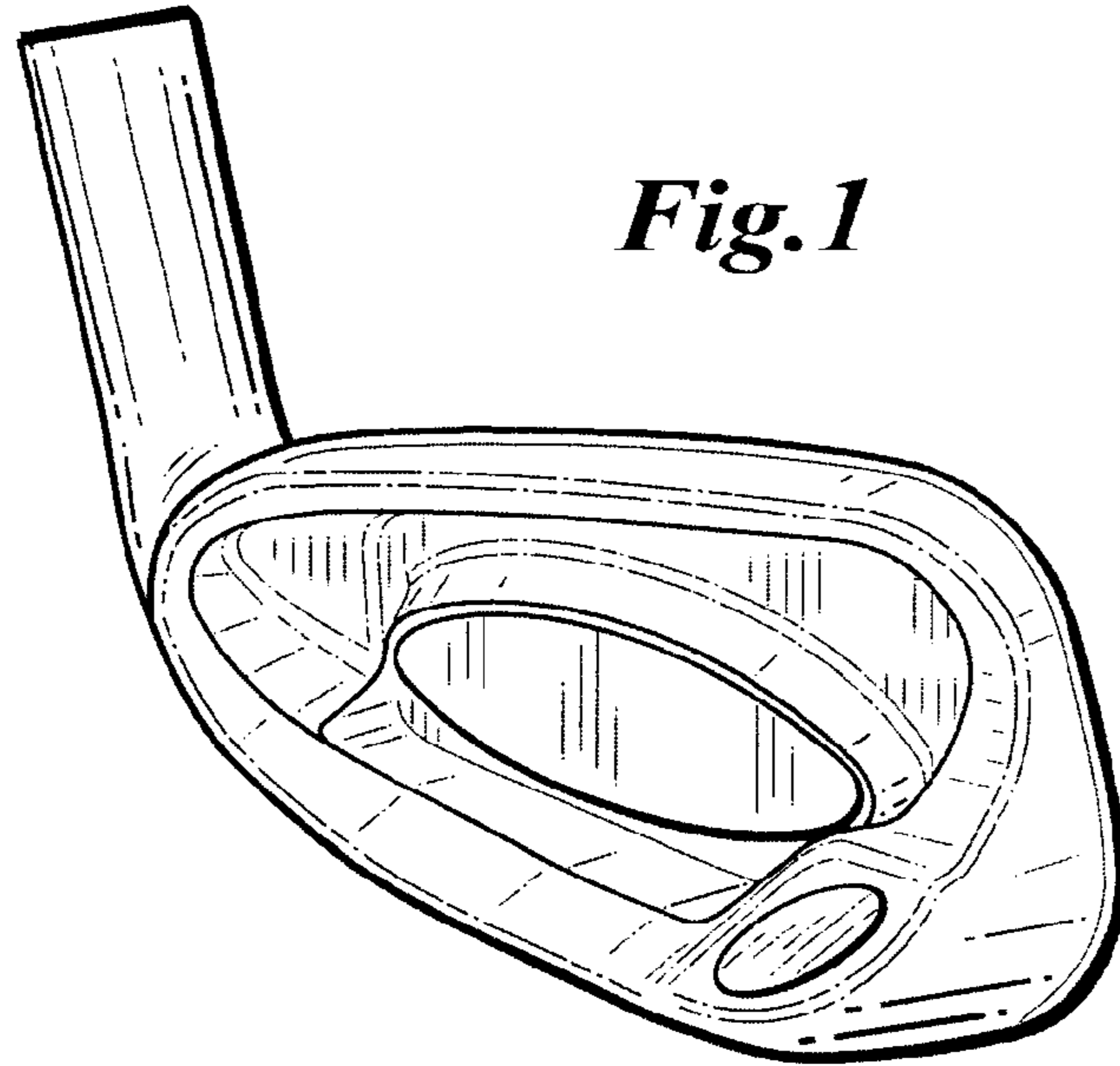
The ornamental design for a golf iron head, as shown and described.

**DESCRIPTION**

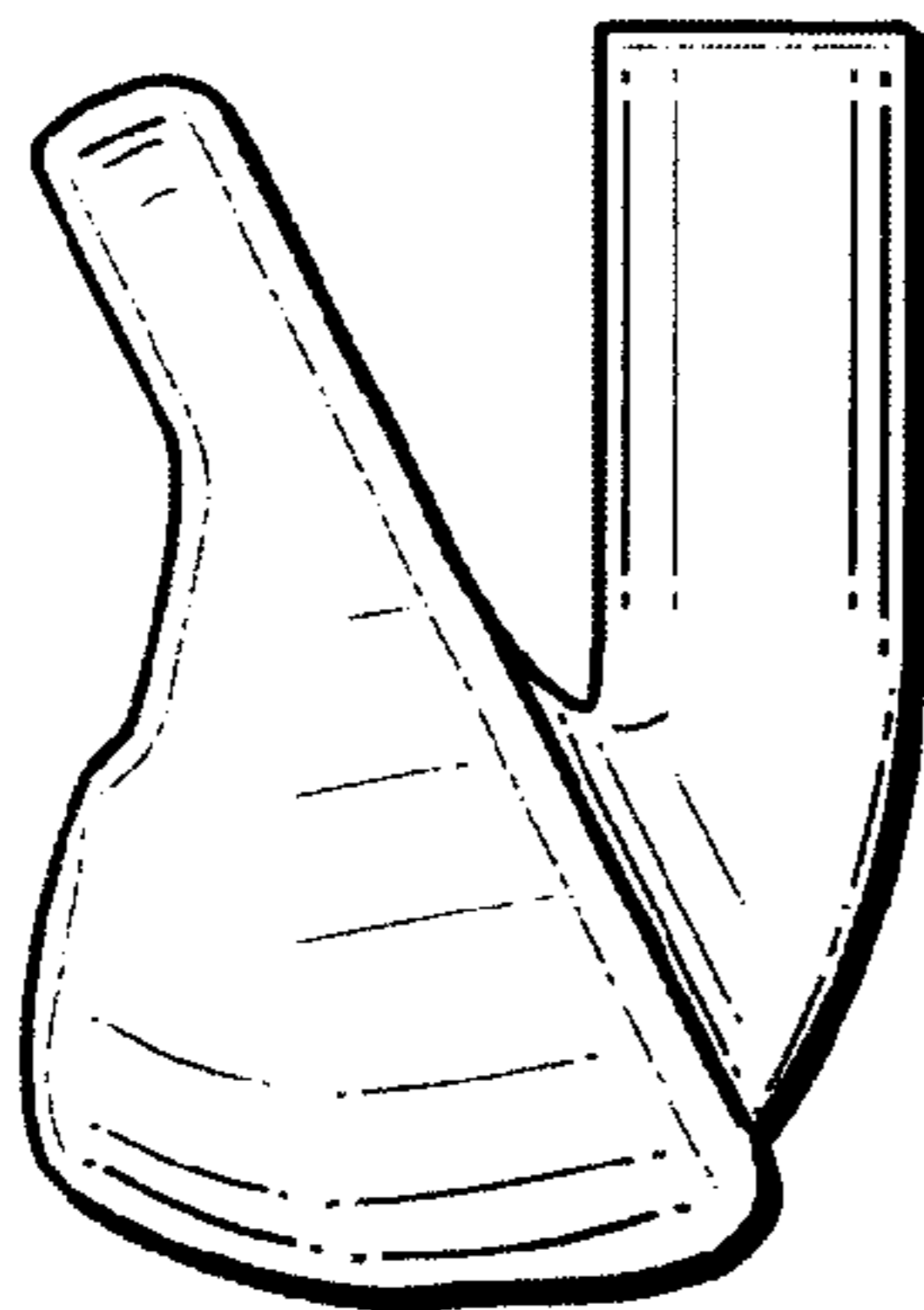
FIG. 1 is a perspective view of a golf iron head showing our new design;

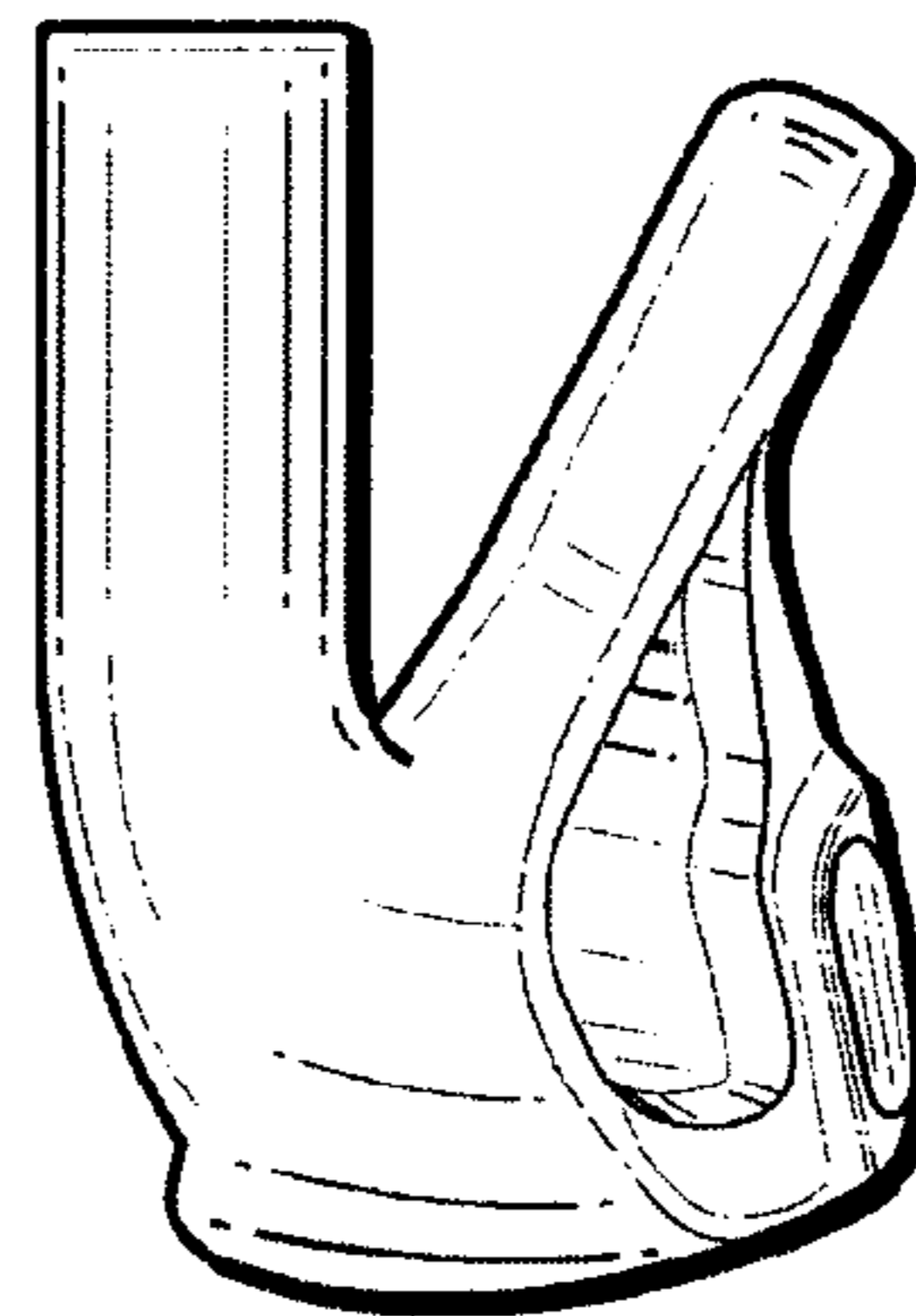




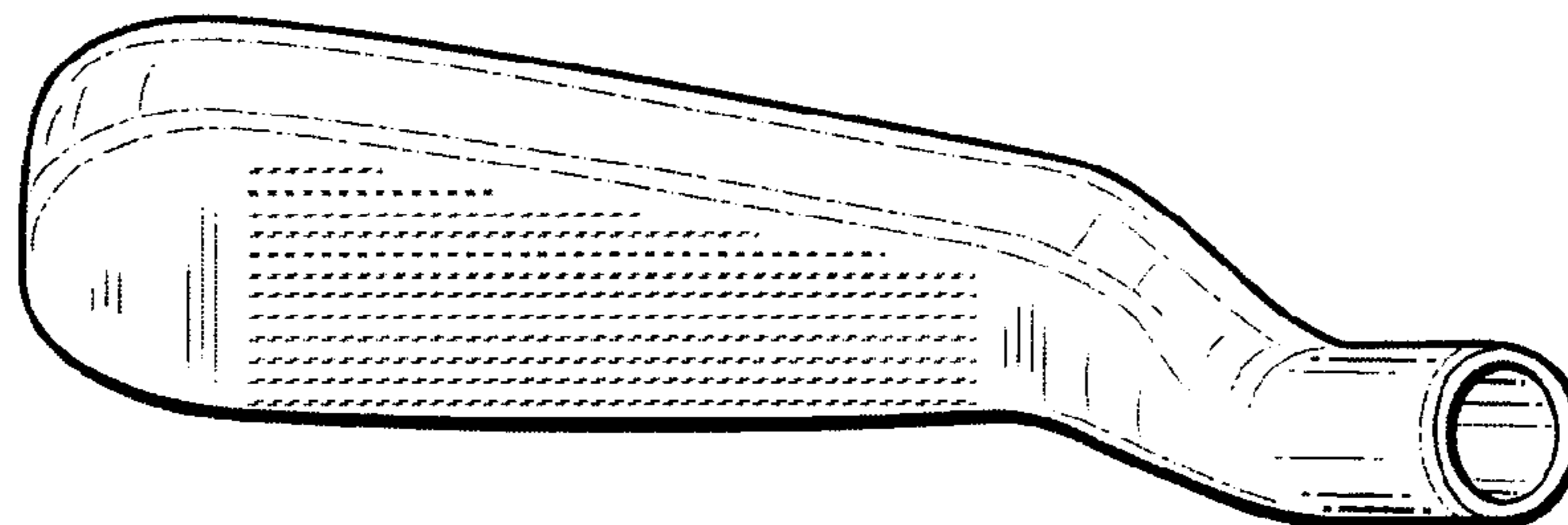

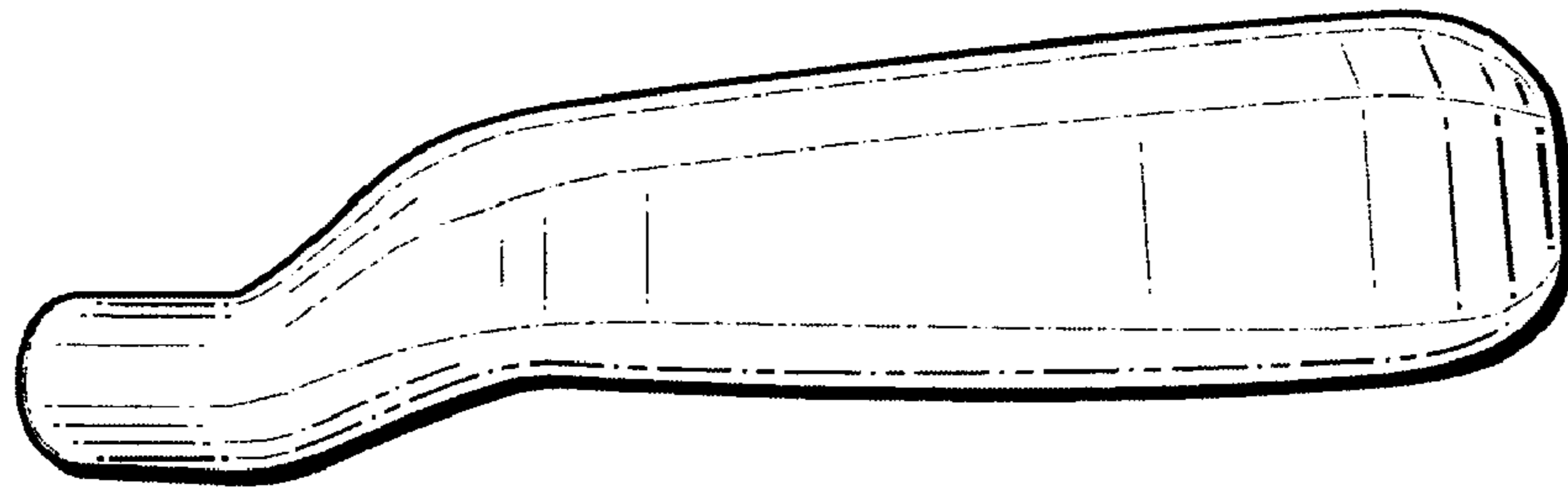

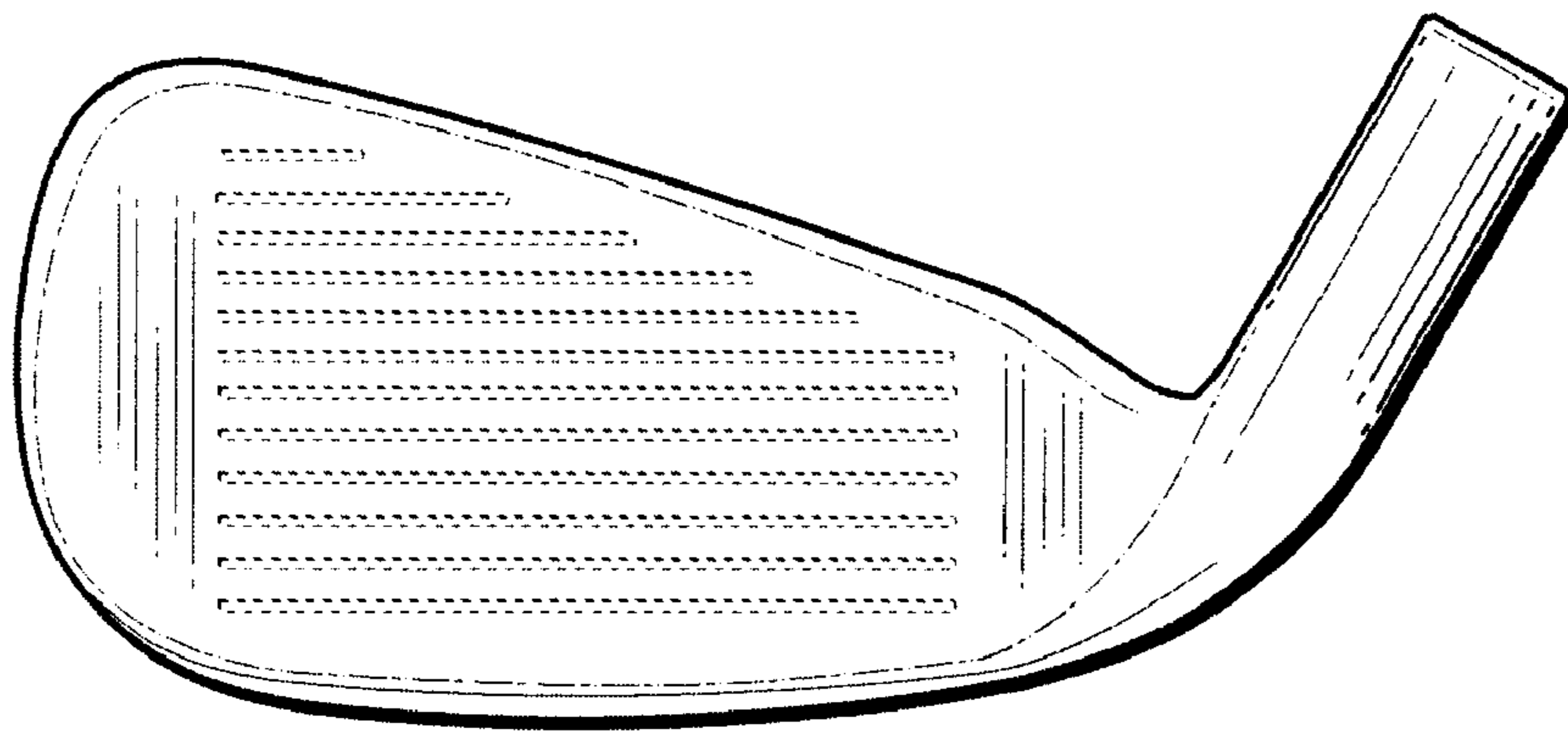

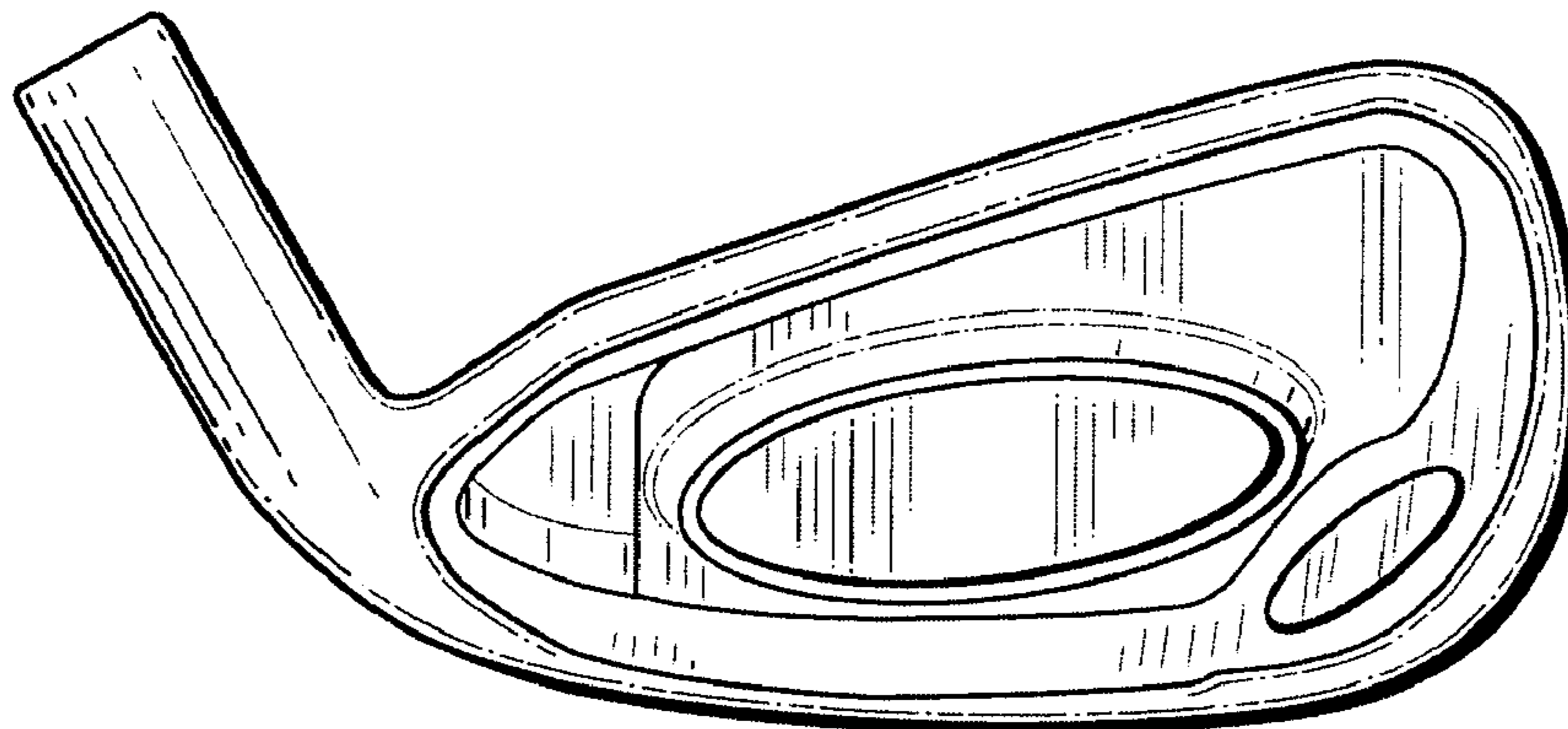
